PROFIT WARNING

This announcement is made by South China Vocational Education Group Company Limited (the “**Company**”, together with its subsidiaries and consolidated affiliated entities, the “**Group**”) pursuant to Rule 13.09(2)(a) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company hereby notifies the shareholders and potential investors of the Company that, based on the preliminary assessment of the information currently available (including but not limited to the unaudited consolidated management accounts of the Group for the year ended 31 December 2025 (“**FY2025**”)), the Group is expected to record loss attributable to owners of the Company of not less than RMB59.4 million for FY2025, as compared to profit attributable to owners of the Company of approximately RMB90.9 million recorded for the year ended 31 December 2024. Such expected loss was mainly attributable to the recognition of an under-provision of corporate income tax from prior years and associated late payment surcharges, alongside the relevant corporate income tax provision for the current year, as a result of tax re-assessment initiated by the local tax authority during FY2025.

Shareholders and potential investors of the Company should note that the information set out in this announcement is based on a preliminary assessment by the Company with reference to the unaudited consolidated management accounts of the Group and other information currently available to the Board, which have not been audited or reviewed by the Company’s auditors or reviewed by the audit committee of the Board. As such, the actual results of the Group for FY2025 may differ from the information disclosed in this announcement. Details of the financial information for FY2025 to be disclosed in the annual results announcement of the Company (which is expected to be published by the end of March 2026) shall prevail.

Shareholders and potential investors of the Company are advised to exercise caution when dealings in the securities of the Company.
