### **CHANGE OF STOCK SHORT NAMES**

To reflect the Change of Company Name, the stock short names for trading in the Shares on the Stock Exchange will be changed from “SINOHOPE TECH” to “BITFIRE GROUP” in English and from “新火科技控股” to “新火集團” in Chinese with effect from 9:00 a.m. on 31 March 2026. The stock code of the Company on the Stock Exchange will remain unchanged as “1611”.
