PROFIT WARNING

This announcement is made by Vision Synergy Holdings Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors (the “**Board**”) of the Company wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that, based on its preliminary assessment of the unaudited consolidated management accounts of the Group for the year ended 31 December 2025 (the “**Reporting Year**”) and the information currently available to the management of the Company, the Group is expected to record a net loss for the Reporting Year in the range from approximately RMB168.0 million to RMB180.0 million as compared with a net loss of approximately RMB1,037.6 million recorded for the year ended 31 December 2024 (the “**Previous Year**”).

Based on the latest information available to the Board, the expected net loss was mainly attributable to (i) the expected gross loss of the Group for the Reporting Year of not less than approximately RMB64.9 million as compared to the gross loss of approximately RMB201.0 million for the Previous Year; (ii) the expected provision for litigation and tax surcharges of the Group for the Reporting Year of not less than approximately RMB65.7 million as compared to the provision for litigation and tax surcharges of approximately RMB141.7 million for the Previous Year; (iii) the expected finance costs of the Group for the Reporting Year of not less than approximately RMB18.9 million as compared to the finance costs of approximately RMB213.5 million for the Previous Year; and (iv) the expected administrative expenses of the Group for the Reporting Year of not less than approximately RMB17.9 million as compared to the administrative expenses of approximately RMB28.5 million for the Previous Year.

Information contained in this announcement is only a preliminary assessment of the Board based on the latest unaudited consolidated management accounts of the Group for the Reporting Year and the information currently available to the Board, which has not been audited or reviewed by the independent auditors or the audit committee of the Company and is still subject to possible adjustments arising from further review. Shareholders and potential investors are advised to read carefully the annual results announcement of the Company for the Reporting Year when it is published.

Shareholders and potential investors are, therefore, advised to exercise caution when dealing in the shares of the Company.
