## **UNAUDITED OPERATING STATISTICS FOR MARCH 2026**

The board of directors (the “**Board**”) of CIFI Holdings (Group) Co. Ltd. (the “**Company**”) hereby announces certain unaudited operating statistics of the Company and its subsidiaries (the “**Group**”) for March 2026 as follows:

- In March 2026, the Group recorded (i) contracted sales (including contracted sales by joint ventures and associated companies) amounted to approximately RMB1.15 billion with contracted GFA of approximately 107,100 sq.m., (ii) contracted average selling price\* of approximately RMB12,200/sq.m., and (iii) contracted sales attributable to the equity owners of the Company of approximately RMB0.74 billion.
- From January to March 2026, the Group recorded (i) aggregated contracted sales (including contracted sales by joint ventures and associated companies) amounted to approximately RMB2.41 billion with contracted GFA of approximately 232,800 sq.m., (ii) contracted average selling price\* of approximately RMB11,300/sq.m., and (iii) contracted sales attributable to the equity owners of the Company of approximately RMB1.30 billion.

The above-mentioned data is unaudited and is based on preliminary internal information of the Group, which may differ from figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Company on an annual or half-yearly basis due to various uncertainties during the process of collating such sales information. As such, the above data is provided for investors’ reference only.
