**REQUEST TO THE LISTING REVIEW COMMITTEE
TO REVIEW THE DECISION OF THE LISTING COMMITTEE
AND
CONTINUED SUSPENSION OF TRADING**

This announcement is made by Greater China Financial Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09 of the Rules (the “**Listing Rules**”) Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

Reference is made to the announcements of the Company dated 21 August 2024, 30 August 2024, 17 September 2024 and 8 April 2025, in relation to, among other things, the decision of the Listing Division on Rule 13.24 of the Listing Rules and the resumption guidance (the “**Resumption Guidance**”) set by the Stock Exchange for the resumption of trading in the shares of the Company (the “**Shares**”); the announcements of the Company dated 29 November 2024, 22 January 2025, 28 February 2025, 28 May 2025, 29 August 2025, 28 November 2025, 12 January 2026 and 2 March 2026, in relation to the quarterly update on resumption progress (collectively, the “**Quarterly Update Announcements**”); and the announcement of the Company dated 31 March 2026, in relation to the decision of the Listing Committee of the Stock Exchange (the “**Listing Committee**”) on the cancellation of the Company’s listing (the “**Decision Announcement**”). Unless otherwise stated, capitalised terms used herein shall have the same meanings as those defined in the Quarterly Update Announcements and the Decision Announcement.

SUBMISSION OF REVIEW REQUEST

The Board hereby announces that after internal discussions and consultations with its professional advisers, the Company lodged a written request with the Listing Review Committee on 10 April 2026, requesting the Decision be referred to the Listing Review Committee for a further and final review pursuant to Rule 2B.06(2) of the Listing Rules.

The Company will make further announcement(s) in due course as required under the Listing Rules regarding any material developments relating to the review by the Listing Review Committee.

CONTINUED SUSPENSION OF TRADING

Trading in the Shares on the Stock Exchange has been suspended with effect from 9:00 a.m. on 2 September 2024 and will remain suspended until further notice. Further announcement(s) will be made by the Company in this respect as and when appropriate and in accordance with the requirements of the Listing Rules.
