This announcement is made by Wisdom Education International Holdings Company Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors of the Company (the “**Board**”) wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that, based on the preliminary review of the unaudited consolidated management accounts of the Group for the six months ended 28 February 2026 (the “**2026 Interim Period**”), an unaudited consolidated net profit of approximately RMB30.5 million of the Group for the 2026 Interim Period is expected to be recorded with compared to the unaudited consolidated net profit of approximately RMB51.6 million of the Group for the six months ended 28 February 2025 (the “**2025 Interim Period**”), and the aforesaid decrease is primarily attributable to the reversal of financial guarantee contracts of approximately RMB8.8 million during the 2026 Interim Period (2025 Interim Period: RMB25.6 million), as well as increase in administrative expenses of approximately RMB3.8 million.

The information in this announcement is only based on the preliminary review and assessment made by the Board with reference to the information currently available to the Company including the unaudited consolidated management accounts of the Group for the 2026 Interim Period, and hence may be subject to further adjustments. The unaudited consolidated management accounts of the Group for the 2026 Interim Period have not yet been finalised or reviewed and audited by the auditor or reviewed by the audit committee of the Company. Details of the financial information and performance of the Group for the 2026 Interim Period will be disclosed in the interim results announcement of the Group for the 2026 Interim Period, which is expected to be published on or around 28 April 2026.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
