The Board is pleased to announce that, on 29 April 2026, the Company held the AGM at which the ordinary resolutions proposed in the AGM Notice were duly passed.

The board of directors (the “**Board**”) of Lee & Man Chemical Company Limited (the “**Company**”) is pleased to announce that, at the Annual General Meeting (the “**AGM**”) held on 29 April 2026, the ordinary resolutions proposed in the notice of the AGM dated 25 March 2026 (the “**AGM Notice**”) were duly passed by the shareholders of the Company (the “**Shareholders**”) present thereat by way of poll voting. Tricor Investor Services Limited acted as the scrutineer for the purpose of vote-taking. All directors of the Company attended the AGM in person or by electronic means.

As at the date of the AGM, the total number of issued Shares of the Company was 825,000,000 Shares. No Shareholders were required to abstain from voting at the AGM. Accordingly, the total number of Shares entitling the Shareholders to attend and vote at the AGM for or against the ordinary resolutions set out in the AGM Notice was 825,000,000.
