Any vote which is not filled or filled wrongly or with unrecognizable writing or not casted will be deemed as having been waived by you and the corresponding vote will be counted as “Abstain”. The number of abstained votes will be counted as the required majority in favor of any resolution proposed and will be counted into the denominator for the purpose of percentage calculation of the voting.
5. This supplemental form of proxy must be signed by you or your attorney duly authorized in writing. In the case of a corporation, the same must be either under its common seal or under the hand of its director(s) or duly authorized attorney(s). If this supplemental form of proxy is signed by an attorney of an H shareholder of the Company, the power of attorney authorizing that attorney to sign or other authorization document must be notarised.

In order to be valid, this supplemental form of proxy together with the power of attorney or other authorization document (if any) must be deposited at the H share registrar of the Company, Computershare Hong Kong Investor Services Limited, the address of which is set out in Note 9 below, not later than 2:00 p.m. on Tuesday, May 19, 2026 (or if the AGM is adjourned, not less than 24 hours before the time fixed for holding of the adjourned AGM).
7. **This supplemental form of proxy is applicable to the supplemental resolution as set out in the supplemental notice of the AGM dated May 5, 2026 and supplements the original form of proxy. This supplemental form of proxy will not affect the validity of the original form of proxy duly completed by you in respect of the resolutions set out in the notice of the AGM dated April 15, 2026. If you have validly appointed a proxy to attend the AGM but do not complete and deliver this supplemental form of proxy, your proxy will be entitled to vote at his/her discretion on the resolutions set out in the supplemental notice of the AGM dated May 5, 2026. If you do not duly complete and deliver the original form of proxy but duly complete and deliver this supplemental form of proxy and validly appoint a proxy to attend and act for you at the AGM, your proxy will be entitled to vote at his/her discretion on the resolutions set out in the notice of the AGM dated April 15, 2026.**
8. Shareholders are entitled to appoint one or more proxies to attend the AGM, but only one of the proxies can be designated to vote at the AGM. A proxy need not be a shareholder of the Company. For the avoidance of doubt, should the proxies being appointed to attend the AGM under each of the original form of proxy and this supplemental form of proxy are different and more than one of the proxies attend the AGM, only the proxy validly appointed under the original form of proxy shall be designated to vote at the AGM.
