VOLUNTARY ANNOUNCEMENT IND APPROVAL BY CHINA CDE FOR MRNA RSV VACCINE

This announcement is made by Ab&B Bio-Tech CO., LTD. JS (the “**Company**” or “**Ab&B Bio-Tech**”, together with its subsidiary, the “**Group**”) on a voluntary basis to inform the shareholders of the Company and potential investors about the latest business advancement of the Group.

The board (the “**Board**”) of directors (the “**Director(s)**”) of the Company is pleased to announce that, following its Investigational New Drug (the “**IND**”) application in the United States (“**U.S.**”) being approved by the U.S. Food and Drug Administration (the “**FDA**”) on November 7, 2025, the Center for Drug Evaluation (the “**CDE**”) of the National Medical Products Administration has approved the IND application of the Group’s self-developed mRNA RSV vaccine candidate.

RSV is a common virus causing respiratory tract infections, with the potential of developing into severe cases like bronchiolitis or pneumonia, particularly among vulnerable populations such as the elderly and individuals with chronic illness. Current management of RSV infection in China relies on broad-spectrum antivirals and symptomatic treatment. Consequently, there is an urgent need for the development of an effective RSV vaccine. mRNA vaccines have demonstrated the capacity to trigger strong cellular immune responses and long-lasting humoral immunity in clinical studies, making them a promising option for protecting elderly and immunocompromised individuals against severe lower respiratory tract infections caused by RSV.
