ESTIMATED FINAL RESULTS
FOR THE YEAR ENDED 31 MARCH 2026**

This announcement is made by the Company pursuant to Rule 13.09(2)(a) of the Listing Rules and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The Board wishes to inform shareholders of the Company and potential investors that the Group expects to record a significant reduction of loss with a loss attributable to equity holders of the Company for the year ended 31 March 2026 in the range of approximately HK\$50 million to HK\$80 million, as compared to a loss of approximately HK\$395 million for the last corresponding year.

Shareholders of the Company and potential investors are advised to exercise caution when dealing in the shares of the Company.

This announcement is made by Chuang's China Investments Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09(2)(a) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

Based on information currently available and the current market condition as at the date of this announcement, the board of directors of the Company (the “**Board**”) wishes to inform shareholders of the Company and potential investors that the Group expects to record a significant reduction of loss with a loss attributable to equity holders of the Company for the year ended 31 March 2026 in the range of approximately HK\$50 million to HK\$80 million, as compared to a loss of approximately HK\$395 million for the last corresponding year. Based on an analysis of the unaudited financial information currently available, the reduction of loss for the year ended 31 March 2026 is principally attributable to (i) the decrease in fair value loss of investment properties of the Group; and (ii) an absence of

impairment provision for properties for/under development and a development site at Anshan, the People's Republic of China classified as deposit of the Group recorded for the last corresponding year.

The Company is in the process of preparing the final results of the Group for the year ended 31 March 2026. The information contained in this announcement is only with reference to the current situation as mentioned above, and based on the preliminary assessment by the Board according to the unaudited consolidated management accounts of the Group for the year ended 31 March 2026 currently available which have not been finalized as at the date of this announcement and have not been reviewed by the Company's auditor. Further details of the financial information of the Group will be disclosed in the final results announcement and the annual report of the Company to be published in accordance with the Listing Rules.

Shareholders of the Company and potential investors are advised to exercise caution when dealing in the shares of the Company.
