Remarks: The total number of issued shares (excluding treasury shares) as at 18 May 2026 was 25,922,334,614 (comprising 4,468,057,752 Class A ordinary shares and 21,454,276,862 Class B ordinary shares).

Xiaomi Corporation (the “Company”) purchased a total of 84,002,600 class B ordinary shares during the period from 27 March 2026 to 24 April 2026 (the “Shares Repurchased”) on the Stock Exchange. All the Shares Repurchased were subsequently cancelled on 19 May 2026 and the number of class B ordinary shares in issue was reduced by 84,002,600 shares as a result of the cancellation accordingly. Upon cancellation of the Shares Repurchased, the weighted voting rights (“WVR”) beneficiaries of the Company, simultaneously reduced their WVR in the Company proportionately by way of converting their class A ordinary shares into class B ordinary shares on a one-to-one ratio pursuant to Rule 8A.21 of the Listing Rules, such that the proportion of shares carrying WVR of the Company shall not be increased, pursuant to the requirements under Rules 8A.13 and 8A.15 of the Listing Rules.
