POLL RESULTS OF ANNUAL GENERAL MEETING HELD ON 22 MAY 2026

References are made to the circular and the notice of annual general meeting (the “**AGM Notice**”) of Guotai Junan International Holdings Limited (the “**Company**”) held on 22 May 2026 (the “**AGM**”), both dated 29 April 2026. At the AGM, a poll was demanded by the chairman of the meeting for voting on all resolutions as set out in the AGM Notice.

As at the date of the AGM, a total of 9,529,944,707 shares of the Company (“**Share(s)**”) and the holders of which (“**Shareholders**”) were entitled to attend and vote at the AGM, and the Company did not hold any treasury shares (including any treasury shares held or deposited with the Central Clearing and Settlement System). There were no Shares entitling the Shareholders to attend and vote only against the resolutions at the AGM. There were no restrictions on any Shareholders to cast votes on any of the resolutions at the AGM. No Shareholder was required to abstain from voting on the resolutions at the AGM.

The Company’s share registrar, Computershare Hong Kong Investor Services Limited, acted as the scrutineer for the vote-taking at the AGM.
