Otherwise, please affix an appropriate stamp. The Change Request Form may also be downloaded from the Company’s website at hke.holdings or the Stock Exchange’s website at www.hkexnews.hk.

If you have elected to access the Corporate Communication(s) by electronic means through the Company’s website but for any reason have difficulty in accessing the relevant Corporate Communication(s) electronically, or wish to receive printed copies, the Company will promptly upon your request in writing send you the printed copies free of charge.
