If the Company does not receive the duly completed Reply Form or any response from you by 6 July 2026 you are deemed to have consented to read the Website Version only. A notification letter of publication of the relevant Website Version on the publication day will be sent by post to shareholders (i) who are deemed to have consented to read the Website Version; or (ii) who have opted to read the Website Version but have not provided a valid email address.

You have the right at any time to change your choice of language and/or means of receipt of Corporate Communications by giving not less than seven days’ notice in writing to the Share Registrar.
