VOLUNTARY ANNOUNCEMENT

This announcement is made by Q Technology (Group) Company Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) on a voluntary basis. Unless otherwise specified, the statistical basis for sales volume of products referred to in this announcement shall be consistent with those set forth in the announcement of the Company dated 11 November 2025.

The board (the “**Board**”) of directors (the “**Director(s)**”) of the Company wishes to announce that the sales volume of major products of the Group and Kunshan Q Tech Microelectronics (India) Private Limited (“**Q Tech India**”), a joint venture of the Company, in May 2026 is as follows:

The MoM and YoY increase in the total sales volume of camera module products for mobile phones was mainly attributable to the Group's increased cooperation share with multiple core customers, including the overseas customers. Meanwhile, sales volume of camera modules and LiDAR products for other fields continued to improve, mainly because the sales volume of the Group's camera modules and LiDAR applied to the Internet of Things (IoT) and smart vehicles both grew significantly year-on-year.

The MoM and YoY decrease in the sales volume of biological recognition module products was mainly attributable to the weak demand in the smartphone market, which was impacted by rising memory prices.
