PROFIT WARNING

This announcement is made by Grandshores Technology Group Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors of the Company (the “**Board**”) wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that based on a preliminary review of the unaudited financial information of the Group for the year ended 31 March 2026 (the “**Year**”), the Group is expected to record a loss for the year of approximately S\$3.0 million to S\$4.0 million for the Year as compared with a loss for the year of approximately S\$1.5 million for the year ended 31 March 2025 (the “**Last Year**”).

The Board considers that the increase in loss was mainly attributable to:

- (i) less tenders were awarded for the integrated building services and the building construction works during the Year;
- (ii) the recognition of loss on fair value changes of digital assets inventories for the Year due to the decrease in Bitcoin price during the Year; and
- (iii) increase in the foreign exchange loss under other gains and losses due to the fluctuation in foreign exchange rate.

As the Group’s annual results for the Year have not yet been finalized, the information contained in this announcement is only a preliminary assessment by the management of the Company which is based on the latest financial information currently available, including but not limited to the Group’s unaudited consolidated management account for the Year, which has not been audited by the independent auditors of the Company nor reviewed by the audit committee of the Board as at the date of this announcement and is subject to adjustment upon further review.

Shareholders and potential investors are advised to read carefully the annual results announcement of the Company for the Year, which is expected to be published by the end of June 2026. Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
