- (f) Shareholders and authorized proxies holding an aggregate of 930,030,810 Shares, representing approximately 61.06% of the total issued share capital of the Company, were present at the AGM.
- (g) There were no shares entitling the holders to attend and abstain from voting in favour of the resolutions at the AGM as set out in rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”).
- (h) No shareholder of the Company was required under the Listing Rules to abstain from voting on the resolutions at the AGM.
- (i) None of the shareholders of the Company have stated their intention in the Company’s circular dated 27 May 2026 to vote against or to abstain from voting on any of the resolutions at the AGM.
- (j) The Company’s Hong Kong branch share registrar, Tricor Investor Services Limited, acted as the scrutineer for the vote-taking at the AGM.
- (k) All directors of the Company attended the AGM in person or by electronic means.
