POSITIVE PROFIT ALERT

This announcement is made by Wonderful Sky Financial Group Holdings Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) pursuant to Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong) and Rule 13.09(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the shareholders of the Company and potential investors that, based on the preliminary assessment of the management accounts of the Group and the information currently available to the Board, the Group expects to record a profit after taxation of not less than HK\$70 million for the year ended 31 March 2026 (the “**Year**”) as compared to a profit after taxation amounted to approximately HK\$41.2 million for the year ended 31 March 2025.

Driven by strong recovery in the Hong Kong IPO market, we achieved a over 30% surge in revenue. Sound fiscal and operational management ensured that the associated rise in direct costs was kept below this trajectory.

Leveraging the continuous enablement of artificial intelligence and the deep optimization of our operational workflows, we realised substantial efficiency gains across the board. This rigorous discipline has delivered a gross profit uplift, reinforcing the strong underlying scalability of our business.

The Company is in the process of finalising the results of the Group for the Year. The information contained in this announcement is only based on management's preliminary assessment of the unaudited consolidated management accounts of the Group and the information currently available, which are subject to finalisation and other potential adjustments, if any, and have not been reviewed by the Company's auditor nor have they been reviewed by the audit committee of the Company. Therefore, the actual results of the Group for the year may differ from the information contained in this announcement.
