1).	On 7 January 2026 (after trading hours), the Company and Pharos Network Technology Limited (the "Subscriber") entered into a subscription and investment agreement. Furthermore, on 12 March 2026 (after trading hours), the Company and the Subscriber further entered into a supplemental subscription and investment agreement (together with the subscription and investment agreement, the "Agreements"). Pursuant to the terms of the Agreements: (i) the Company has conditionally agreed to allot and issue, and the Subscriber has conditionally agreed to subscribe for, a maximum of 183,480,000 new subscription shares (the "Subscription"); and (ii) in consideration of the Subscription, the Company has agreed to make, and the Subscriber has agreed to accept, the Investment as defined in the announcements of the Company dated 8 January 2026 and 12 March 2026 (collectively, the "Announcements").
