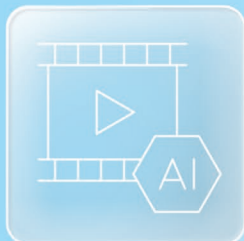

Business Organisation Chart

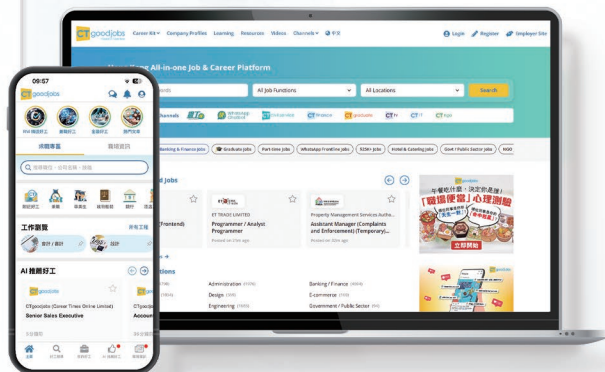

Chairman's Statement

Dear Shareholders,

The rapidly shifting geopolitical environment, escalating trade tensions, high tariffs and ongoing weakness in Hong Kong's consumer spending continued to challenge the local economy in 2025.

In such challenging operating environment, total revenue of the Group for the year ended 31 March 2026, decreased by 10% to HK\$720.6 million. Loss attributable to shareholders for the reporting year, after recognition of the non-cash impairment of Group's certain property, plant and equipment and investment properties of HK\$5.3 million, was HK\$43.0 million. Excluding the non-cash impairment items in both financial years, net results recorded an increase in loss of HK\$7.2 million when compared to the last financial year.

Digitalisation remained the core focus of Group's businesses. Revenue from Group's digital platforms, information and solutions businesses contributed approximately two-third of the Group's total revenue for the financial year under review. With the advancement of technology, Artificial Intelligence (AI) was widely adopted by different industries at a remarkable speed. By integrating the AI applications into our businesses, we will examine how AI optimisation benefits our businesses in user engagement, quality content creation, operational efficiency as well as enhancing our digital capabilities in complex data analytics, user behavior studies, advanced predictive analytics, recommendation engines, and innovative solution creation, which will accelerate the growth of our digital businesses.

The financial news agency, information and solutions segment, the solid contributor of the Group, achieved a moderate increase in profit for the financial year under review. The adoption of AI was rapidly extended to the finance sector, with focus shifting from operational efficiency to customer service, risk management and predictive analysis. This segment, through the continuous advancement of its digital infrastructure and content platform, successfully capturing the market trend of AI and digitalisation in the finance sector, had secured several digital solutions in the areas of banking, securities and derivatives trading, wealth management and property data analysis. The Group will continue its talent and technology input to meet the growing demand in these innovative AI and digital solutions.



Looking ahead, global trade growth is expected to slow down amid the geopolitical complexities, persistent trade tensions, monetary and trade policy uncertainties, as well as the uncertainty surrounding the actual outcome of the scale and duration of the Middle East conflict. Hong Kong economy saw a stable and moderate recovery during the year. Local residential property market exhibited signs of stabilisation and the financial market regained its momentum with strong trading and fund-raising activities. However, the shifts in tourist consumption patterns and the normalisation of Hong Kong residents traveling outbound and spending up north continued to pose challenges to local consumption market. Nevertheless, government's promotion of mega events shall provide some support to consumer sentiment. In such an environment, the Group will closely monitor the global and local economic and political situations, take a cautious and prudent approach in cost control management, operational efficiency and financial discipline.

The Group maintained a sound financial position with no gearing. As at 31 March 2026, cash balance of the Group was approximately HK\$413.3 million. We will continue to maintain disciplined and prudent financial, liquidity and cash flow management. The Board recommends the payment of a final dividend of HK 4.0 cents per share, bringing the total dividend for the financial year ended 31 March 2026 to HK 7.0 cents per share. The Group is determined to maintain a sustainable dividend policy as well as strong liquidity to preserve its strength for strategic business investment and development, and capture growth opportunities across market cycles.

I wish to express my sincere gratitude to our dedicated and reliable colleagues who have exhibited tireless efforts, professionalism and commitment during another challenging year. I also thank my fellow Board members for their unwavering trust, insight and guidance; and our management team for their diligence, contributions, perseverance and concerted efforts. Finally, I would like to extend my utmost appreciation to our readers, viewers, subscribers, customers, suppliers, business partners and investors for their continued trust, support and confidence in us.

Executive Directors

Mr. FUNG Siu Por, Lawrence, GBM, GBS, aged 76, is the Chairman and Chief Executive Officer of the Company. Mr. Fung is a founder of the *Hong Kong Economic Times* ("HKET"). He was also the first Publisher and Chief Editor of *HKET*. Mr. Fung is responsible for the overall strategic direction and development, policy-making and setting corporate missions of the Group. He has over 40 years of entrepreneurial experience in media and publishing, securities trading and computer technology industries. Mr. Fung obtained a Bachelor of Social Science degree from The University of Hong Kong ("HKU") and a Master of Arts degree in Economics from University of Manchester in the United Kingdom. In recognition of Mr. Fung's significant contributions to the media industry, economic development and education development in Hong Kong, Mr. Fung was awarded the Gold Bauhinia Star and the Grand Bauhinia Medal by the Government of the Hong Kong Special Administrative Region in 2003 and 2025 respectively. Mr. Fung is a founder member and a director of Musketeers Education and Culture Charitable Foundation Limited. Mr. Fung was conferred the degree of Doctor of Social Sciences honoris causa by HKU in 2010.



Ms. WONG Ching, aged 52, is the Managing Director, Company Secretary of the Group and the Publisher of *HKET*. Ms. Wong is responsible for formulating the business strategies and the overall management of publishing, recruitment platform and printing services of the Group as well as taking charge of the Group's corporate matters. Ms. Wong has over 20 years of experience in accounting and financial management. Ms. Wong holds a Bachelor degree of Business Administration (majoring in Professional Accountancy) from The Chinese University of Hong Kong and a Bachelor of Laws (LL.B.) degree from University of London. Ms. Wong is a member of The Hong Kong Chartered Governance Institute and a member of the Hong Kong Institute of Certified Public Accountants. Prior to joining the Group in 2000, Ms. Wong had worked with an international audit firm.

Mr. LAU Chi Ming, aged 57, is the Deputy Managing Director of the Company's subsidiaries which engage in the businesses of financial news agency, information and solutions and health product platform. Mr. Lau joined the Group in 2000 and has over 30 years of experience in financial software services and management. While holding several managerial roles across different business units within the Group, Mr. Lau has developed extensive expertise in the development and operational management of securities, derivatives and funds content, securities trading systems, wealth management solutions, and health product platform. Mr. Lau holds a Bachelor degree in Electrical Engineering from Brigham Young University in the United States and a Master degree in Business Administration from The Hong Kong University of Science and Technology.

Ms. HUI Siu Yee, aged 59, is the IT Services Director of the Group and responsible for overseeing the IT development, AI development and advertising technology of Group's digital platforms under the media segment, as well as Group's network and systems. Ms. Hui also takes charge of the business development and management of Group's lifestyle platform as the chief executive officer of the platform. Ms. Hui joined the Group in 2000 and has over 30 years of experience in information technology and business analysis. Prior to joining the Group, she worked for various financial institutions as a consultant. Ms. Hui holds a Bachelor degree in Multidisciplinary Science from Curtin University, Australia.

Non-executive Director

Mr. CHU Yu Lun, aged 75, was appointed as a Non-executive Director in April 2005. He is also a Member of the Company's Audit Committee and Remuneration Committee. Mr. Chu is the founder and Chairman of the Adsale Group. Established in December 1977 in Hong Kong under the name of The Adsale People, the company was registered as Adsale People Limited in 1985. As an international trade media group in the Asia-Pacific region, the Adsale Group's major businesses include organising international trade fairs, publishing international trade journals, e-publications and industry websites. Mr. Chu has extensive experience in the exhibition industry. Mr. Chu received a Master degree in Business Administration at The Chinese University of Hong Kong in 1984 after his Bachelor degree in Science from The University of Hong Kong in 1973. For years, Mr. Chu has taken active participation in social activities personally and on behalf of his companies. He is formerly the Chair of the Global Association of the Exhibition Industry (UFI) Asia Pacific Chapter, currently the Honorary Life President of Hong Kong Exhibition and Convention Industry Association (HKECIA), and has been the Founding President of The Hong Kong University Science Alumni Association Limited and also previously served as Vice-President of Advisory Board on the Master degree in Business Administration program of The Chinese University of Hong Kong. His commitment in the industry granted him an award of "The Top Ten People in China Exhibition Industry 2001 & 2003". Mr. Chu is also a founder member and a director of Musketeers Education and Culture Charitable Foundation Limited. With his valuable contribution to the society and The University of Hong Kong, Mr. Chu received an Honorary University Fellowship from The University of Hong Kong in 2011.

Independent Non-executive Directors

Mr. LO Foo Cheung, JP, aged 76, was appointed as an Independent Non-executive Director in April 2005. He is currently the Chairman of the Company's Remuneration Committee and a Member of the Company's Audit Committee and Nomination Committee. Mr. Lo is the founder and Chairman of FC Packaging Holding Limited, one of the leading can manufacturers in the Greater China. Mr. Lo has extensive experience in the industrial and manufacturing industry in Hong Kong and Mainland China. He is currently the Honorary President of The Chinese Manufacturers' Association of Hong Kong, Honorary Standing Committee Member of The Chinese General Chamber of Commerce, Permanent Honorary Chairman of Jiangmen Association of Enterprises With Foreign Investment, Member of College Board of Directors of Muse College, The Chinese University of Hong Kong (Shenzhen), Honorary Citizen of Guangzhou City, Foshan City and Jiangmen City, Director of Hok Hoi Library, Honorary President of Hong Kong Translation Society and Honorary Vice-Chairman of The Hang Seng University of Hong Kong – Foundation. Mr. Lo previously served as a Member of the Election Committee of the Hong Kong Special Administrative Region ("HKSAR"), Standing Committee Member of the Chinese People's Political Consultative Conference of Heilongjiang Province, Qingdao City, Jiangmen City and Sanshui City, Council Member of Hong Kong Trade Development Council, Council Member of Hong Kong Productivity Council, a Member of the Business Advisory Group, Financial Secretary's Office, HKSAR, Director and Chairman of Finance and Administration Committee of Hong Kong Design Centre, Committee Member of Small and Medium Enterprises Committee of Hong Kong, First Vice-President of The Chinese Manufacturers' Association of Hong Kong and Council Member of the Hong Kong Quality Assurance Agency. Mr. Lo holds a Bachelor degree with honours in Social Science (1970) and a Master degree in Business Administration (1972) from The Chinese University of Hong Kong. Mr. Lo was a winner of the Young Industrialist Award of Hong Kong in 1988.

Mr. O'YANG Wiley, aged 63, was appointed as an Independent Non-executive Director in October 2012. He is currently the Chairman of the Company's Audit Committee and a Member of the Company's Nomination Committee and Remuneration Committee. Mr. O'Yang is a Managing Director of Shanggu Securities Limited ("Shanggu Securities"), a licenced corporation under the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) to carry on type 1 (dealing in securities), type 4 (advising on securities) and type 6 (advising on corporate finance) regulated activities and has extensive experience in the accounting, finance and legal fields. Prior to joining Shanggu Securities, Mr. O'Yang worked for various investment banks, including CMBC International Holdings Limited, a subsidiary of China Minseng Banking Corporation Limited, Kim Eng Securities (Hong Kong) Limited (currently known as MIB Securities (Hong Kong) Limited), a wholly-owned subsidiary of Malayan Banking Berhad, UBS AG, Hong Kong Branch, J.P. Morgan Securities (Asia Pacific) Limited and BNP Paribas Capital (Asia Pacific) Limited and held the positions of Managing Director and Executive Director. Prior to those, he was a Partner of Richards Butler (currently known as Reed Smith Richards Butler), an international law firm. Mr. O'Yang also served as Independent Non-executive Directors of Midea Real Estate Holding Limited, D&G Technology Holding Company Limited, AB Builders Group Limited and Edvantage Group Holdings Limited, all listed on the Hong Kong Stock Exchange, since October 2018, May 2019, June 2019 and February 2022 respectively. Mr. O'Yang graduated from The Chinese University of Hong Kong with a Bachelor of Social Science degree and a Master of Business Administration degree. He is also a fellow member of the Association of Chartered Certified Accountants, a member of the Hong Kong Institute of Certified Public Accountants and a member of The Law Society of Hong Kong.

Mr. SIN Hendrick, MH, JP, aged 51, was appointed as an Independent Non-executive Director in January 2022. He is currently the Chairman of the Company's Nomination Committee. Mr. Sin is a co-founder, an Executive Director and the Vice Chairman of CMGE Technology Group Limited, a company listed on the Hong Kong Stock Exchange and has been a Director and Vice Chairman of CMGE Group Limited since January 2011. Mr. Sin is also the Founding and Managing Partner of China Prosperity Capital Fund, a venture capital company with a primary focus on technology investment. Mr. Sin has over 28 years of experience in corporate management, finance and investment banking. Mr. Sin has been serving as an Independent Non-executive Director of Evergreen Products Group Limited and Tianjin Development Holdings Limited, all listed on the Hong Kong Stock Exchange, since June 2017 and March 2023 respectively. Mr. Sin has been serving as an Independent Non-executive Director of 36 Kr Holdings Inc., a publishing and data company whose shares are listed on the NASDAQ since November 2019. Besides, Mr. Sin was an Independent Non-executive Director of China Tower Corporation Limited, a company listed on the Hong Kong Stock Exchange, between October 2022 and July 2025. Mr. Sin graduated from Stanford University with a Master's degree in Engineering-Economic Systems and Operations Research, and received three Bachelor of Science degrees in Computer Science/Mathematics, Economics and Industrial Management from Carnegie Mellon University. Mr. Sin is (i) the President of the Internet Professional Association, (ii) the Consultant of the Hong Kong Software Industry Association, and (iii) a Member of the Hong Kong Institute of Directors. Mr. Sin has been appointed as a Standing Committee Member of the fourteenth session of Tianjin Municipal's Committee of Chinese People's Political Consultative Conference. Mr. Sin has also been appointed by the Government of HKSAR as an Election Committee Member. Mr. Sin was awarded the Young Industrialist Award of Hong Kong of 2018 by Federation of Hong Kong Industries. Mr. Sin was also awarded Linghang Outstanding Entrepreneur the Guangdong-Hong Kong-Macao Greater Bay Area Award at "Leading 9+2" First Guangdong-Hong Kong-Macao Greater Bay Area Development Forum in March 2021. In addition, Mr. Sin was awarded the InnoStars Award 2021 by Our Hong Kong Foundation in July 2022. Mr. Sin was also awarded the Medal of Honour by the Government of HKSAR in 2021 and has been elected as a deputy of the fourteenth National People's Congress on 15 December 2022.

Corporate Governance

The Board of Directors (the “Board”) was committed to maintain a high level of corporate governance standards and practices. The Company has complied with the provisions set out in the Corporate Governance Code (the “Code Provisions”) contained in Appendix C1 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “Listing Rules”) except as stated and explained below.

Board of Directors

As at 31 March 2026, the Board comprised eight Directors, with three of them being Independent Non-executive Directors, representing more than one-third of the Board.

The composition of the Board reflects a balance of skills, experience and diversity of perspectives appropriate to the requirements of the Company's business. All Directors are aware of their collective and individual responsibilities to shareholders and have exercised their duties with care, skill and diligence for the best interests of the shareholders. Names and biographies of the Directors are set out on pages 12 to 15 under the section headed “Board of Directors” of this Annual Report.

Each of the Executive, Non-executive, and Independent Non-executive Directors has entered into a service contract with the Company and is subject to the rotational retirement and re-election requirements of the Company's Articles of Association and the Code Provisions. Mr. Fung Siu Por, Lawrence (the Chairman and Executive Director of the Company) and Mr. Chu Yu Lun (the Non-executive Director of the Company) have been business partners for years and have common interests in certain companies. Save as disclosed above, none of the Directors has any financial, business, family relationships or any relationships in other material aspects with each other.

Under Part 2 Code C.2.1 of the Code Provisions, the roles of Chairman and Chief Executive Officer (“CEO”) should be separate and should not be performed by the same individual. The division of responsibilities between the Chairman and CEO should be clearly established and set out in writing. However, the Company has appointed Mr. Fung Siu Por, Lawrence as both its Chairman and the CEO. The Board believes that vesting the roles of the Chairman and the CEO in the same person would allow the Company to be more effective and efficient in developing long-term business strategies and execution of business plans. The Board believes that the balance of power and authority is adequately ensured by the operation of the Board, which comprises experienced and high calibre individuals with a substantial number thereof being Non-executive Directors.

The Board is responsible for setting the Group’s strategic direction and overseeing the business performance of the Group while business operations are delegated to qualified management under the supervision of respective Executive Directors. The Board will ensure that the decision and direction made are implemented through the management, and that all significant business matters including but not limited to budgets, business plans, investment decisions, material capital expenditure are subject to the Board’s approval.

Board Diversity Policy

The Board has adopted its own board diversity policy (“Board Diversity Policy”). The Board Diversity Policy aimed to achieve diversity of the Board through consideration of a number of factors, including but not limited to gender, age, cultural and educational background, or professional experience. The Nomination Committee of the Company shall review the Board Diversity Policy as appropriate and make recommendations on any proposed revisions to the Board.

Board appointments will be based on objective criteria having due regard to the benefits of diversity of the Board.

Independence of Independent Non-executive Directors

Each Independent Non-executive Director has submitted to The Stock Exchange of Hong Kong Limited (the “Stock Exchange”) a written confirmation in respect of their independence in accordance with Rule 3.13 of the Listing Rules on their appointment. The Board has also received from each of the Independent Non-executive Directors a confirmation of his independence as required under the Listing Rules. The Board is of the opinion that all Independent Non-executive Directors are independent and appreciates the professional and valuable contributions they made to the Board and the Committees.

The Directors are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the Group.

External Auditor

The Group has appointed PricewaterhouseCoopers as the Group's External Auditor since the financial year 2004/05. Their reporting responsibilities on the Financial Statements are set out in the Independent Auditor's Report of this Annual Report on pages 36 to 41.

During the period under review, the Group has incurred a total fee of HK\$2,690,000 in relation to the audit services provided by PricewaterhouseCoopers for the financial year 2025/26, which was approved by the Audit Committee and the Board. A fee of HK\$332,000 was also paid or payable to PricewaterhouseCoopers for other services.

PricewaterhouseCoopers will retire and offer themselves for re-appointment at the annual general meeting of the Company to be held on 6 August 2026.

The re-appointment of PricewaterhouseCoopers as the External Auditor of the Group has been recommended by the Audit Committee and endorsed by the Board, subject to the approval of shareholders at the forthcoming annual general meeting.

Risk Management and Internal Control

The Board acknowledges that it has overall responsibility for evaluating and determining the nature and extent of the risks it is willing to take in achieving the Group's strategic objectives, and maintaining appropriate and effective risk management and internal control systems. The Board oversees management in the design, implementation and monitoring of the risk management and internal control systems. Such systems are designed to manage rather than to eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss. The Board had received from the management a confirmation on the effectiveness of these systems.

The Group has established an on-going process for identifying, evaluating and managing the significant risks of the Group in the areas of financial, operational and compliance. The Group's business units are responsible for identifying, assessing and monitoring risks associated with their respective units. The results of evaluation will be reported to the management of the Group through internal meetings. The management of the Group is responsible in assessing the impact of the risks identified to the Group and report to the Board on an annual basis.

The Group handles and disseminates inside information with due care. Employees are required to comply with confidentiality terms inside the Staff Handbook. Access to inside information is limited to employees at appropriate level and on need-to-know basis.

The Group maintains its internal audit function which reviews major operating and financial control and risk management system of the Group on an on-going and rotational basis covering all major operations of the Group. The results of the reviews are reported to the management of the Group.

Company Secretary

The Company Secretary is responsible for assisting the Board and respective Board Committees in their proceedings and advising the Board on corporate governance matters. During the year ended 31 March 2026, the Company Secretary has complied with the professional training requirements under the Code Provisions.

Shareholders' Rights and Investor Relation

The Board is committed to upholding shareholders' rights. Shareholders are informed of the Company's performance, operations and developments.

Pursuant to the Articles of Association of the Company, shareholders holding at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings of the Company shall at all times have the right, by written requisition to the Board or the Secretary of the Company, to require an extraordinary general meeting to be called by the Board for the transaction of any business specified in such requisition. Shareholders may put forward proposals at general meetings of the Company in the same manner as set out above. The Board shall arrange the extraordinary general meeting to be held within two months after the deposit of such requisition. If within 21 days of such deposit the Board fails to proceed to convene such meeting, the requisitionists may themselves convene the meeting and reimburse the expenses so incurred from the Company.

Shareholders may propose a person other than a retiring director of the Company for election as a director of the Company at a general meeting by depositing a notice signed by the shareholder (other than the person to be proposed) duly qualified to attend and vote at the meeting for which such notice is given of his intention to propose such person for election and also a notice signed by the person to be proposed of his willingness to be elected at the head office or at the registration office provided that the minimum length of the period, during which such notice(s) are given, shall be at least 7 days and that (if the notices are submitted after the dispatch of the notice of the general meeting appointed for such election) the period for lodgment of such notice(s) shall commence on the day after the dispatch of the notice of the general meeting appointed for such election and end no later than 7 days prior to the date of such general meeting.

General

The global economic and geopolitical environment and local consumer market remained challenging in 2025.

During the financial year ended 31 March 2026, revenue decreased by HK\$83.1 million or 10% over the last financial year to HK\$720.7 million. Loss attributable to owners for the financial year ended 31 March 2026, after recognition of the non-cash impairment of Group's certain property, plant and equipment and investment properties of HK\$5.3 million (2025: HK\$5.2 million), increased by HK\$7.3 million, from HK\$35.7 million to HK\$43.0 million.

Advertising income, mainly contributed by the Group's digital platforms and printed publications, dropped by HK\$64.6 million or 17% to HK\$311.4 million from the last financial year. Although Hong Kong's overall economy saw a moderate recovery for the financial year under review, local consumption market still faced challenges. The continued trend of northbound consumption and outbound travel of Hong Kong residents and shifts in inbound visitor consumption patterns led to the structural changes of local consumption. Advertisers kept cautious in their advertising spending by adjusting their strategies swiftly to accommodate the market conditions. The continued drop of vacancies in Hong Kong job market had also adversely affected the recruitment advertising of the Group. Mobile advertising continued to be the focal point of the advertisers and was the largest contributor to the Group's advertising income.

Circulation income recorded a decrease of HK\$1.9 million or 7% to HK\$28.0 million for the financial year under review.

Service income for the year ended 31 March 2026 declined by 4% from HK\$397.8 million in the preceding financial year to HK\$381.3 million. The Group's service income was mainly contributed by the financial news agency, information and solutions businesses and the printing services of the Group's printing plants. Printing services income reported a drop of 8% for the financial year under review as certain printed titles in the market ceased to be published or relocated their operations outside Hong Kong. Services income from the Group's financial news agency, information and solutions businesses remained stable and reported a slight decrease of 2% when compared to the last financial year.

For the financial year ended 31 March 2026, over 66% of the Group's total revenue was contributed by Group's digital platforms, information and solution businesses, which proved the success of our digitalisation strategy over the years with aim at bringing in sustainable long-term business development.

Operating Costs

Gross profit margin for the year ended 31 March 2026 improved by 1.7 percentage point from 41.9% for the year ended 31 March 2025 to 43.6%. The increase in gross profit margin was mainly driven by effective cost control measures. Management will continue to review the business process, streamline the cost structure as well as re-allocate and optimise the resources to improve efficiencies and effectiveness of Group's operations.

Staff costs, representing approximately 58% of the Group's total operating costs, reduced by HK\$44.0 million or 9% as compared to the last financial year. The general salary increment was partly offset by the decrease of headcount after a business and resources optimisation during the financial year under review.

Content costs which mainly consisted of market data license fees of various exchanges, financial index providers, foreign news agencies and third-party content providers, constituting around 13% of the Group's total operating costs, reduced by 4% as compared to the last financial year. The amount was in line with the market data usage of customers who had subscribed for ET Net securities and derivative quotation services under the financial news agency, information and solutions segment.

Impairment Losses on Non-current Assets

As at 31 March 2026, management had performed an impairment assessment for the carrying amounts of certain property, plant and equipment and investment properties. The impairment assessment was carried out by determining the recoverable amounts of these properties based on the fair values less costs of disposal. The carrying amounts of these properties are written down to their recoverable amounts if the carrying amounts are greater than their estimated recoverable amounts. Management engaged an independent qualified professional valuer to estimate the fair values less costs of disposal of these properties, based on market values in their existing state based on comparable property sale transactions, or market rents and yields applicable to these properties. The assessment resulted in impairment losses on non-current assets of HK\$5.3 million for the financial year under review.

Management Discussion and Analysis

Income Tax Expense

The effective tax rate of the Group for the financial year ended 31 March 2026 and 2025 were -12.6% and -9.0% respectively. The Group was principally subject to the standard profits tax rate of 16.5% which was applicable to companies incorporated in Hong Kong, the Group's major place of operation. The decrease of effective tax rate was mainly caused by a change in the profitability mix of the Group's subsidiaries for the financial year under review.

The management determined the deferred income tax assets for the carry forward of unused tax losses to the extent that it is probable that future taxable profits will be available against which the unused tax losses and unused tax credits can be utilised. The recognition of deferred income tax assets was based on the best knowledge of profit projections of the Group and the extent of the Group's ability to utilise the tax benefits from the tax losses carried forwards in the future.

Loss Attributable to Owners

Loss attributable to owners of the Group, after excluding the non-cash impairment on Group's certain property, plant and equipment and investment properties of HK\$5.3 million (2025: HK\$5.2 million) was HK\$37.7 million, increased by HK\$7.2 million when compared to the last financial year.

Media segment recorded negative operating results. After excluding the non-cash impairment on Group's certain property, plant and equipment and investment properties in both current and last financial years, it recorded a drop of HK\$6.9 million when compared to the last financial year. The increase in loss was primarily attributed to the decrease in recruitment advertising income and printing services income, which partly offset by the cost savings under stringent cost control measures. New and continued investments in technology, talent and innovation have made us more agile and resilient. The Group will continue its investment initiatives in AI ("Artificial Intelligence") and digital platforms with focus on customer experience, value creation, operational efficiency as well as enhancing productivity and digital capabilities to expand our market share in digital advertising across different industries.

Financial news agency, information and solutions segment delivered a net profit of HK\$15.5 million, a modest increase of HK\$0.7 million when comparing to the preceding reporting year. The increase mainly resulted from the effective cost saving through business structure streamlining and resources reallocation. Income contributed by digital financial solutions from banks and securities brokerage remained stable. The Group will continue its talent, innovation and AI technology inputs to meet the rising demand in these innovative AI and digital solutions.

The Group's net current assets as at 31 March 2026 decreased by HK\$50.3 million from HK\$410.4 million to HK\$360.1 million. The decrease was mainly due to the negative operating results of the Group for the financial year under review.

Net cash generated in investing activities was HK\$17.3 million, primarily caused by the decrease in funds placed under short-term bank deposits with maturities of over three months of HK\$15.3 million.

The Group had distributed the final dividend declared for the financial year ended 31 March 2025 and interim dividend for the six months period ended 30 September 2025 amounting to an aggregate total of HK\$34.5 million.

The Group had no gearing (being total interest-bearing liabilities divided by total assets) as at 31 March 2026 and 2025.

As at 31 March 2026, the Group had a cash balance of HK\$413.3 million as compared to HK\$459.8 million as at 31 March 2025. Majority of the cash was placed under short-term deposits with banks in Hong Kong and was held in Hong Kong dollars or in United States dollars. The Group had no material exposure to foreign exchange fluctuations.

The Group has a strong balance sheet and cash position to enable it to meet its business needs, support its strategic business investment and development, and fulfill the dividend payment policy as well as weather the currently challenging operating and economic environment. We will continue to maintain prudent and disciplined financial, liquidity and cash flow management.

Management Discussion and Analysis

Outlook

Digitalisation remained the core focus of Group's businesses. Revenue from Group's digital platforms, information and solutions businesses contributed approximately two-third of the Group's total revenue for the financial year under review. With the advancement of technology, AI was widely adopted by different industries at a remarkable speed. By integrating the AI applications into our businesses, we will examine how AI optimisation benefits our businesses in user engagement, quality content creation, operational efficiency as well as enhancing our digital capabilities in complex data analytics, user behavior studies, advanced predictive analytics, recommendation engines, and innovative solution creation, which will accelerate the growth of our digital businesses.

Looking ahead, global trade growth is expected to slow down amid the geopolitical complexities, persistent trade tensions, monetary and trade policy uncertainties, as well as the uncertainty surrounding the actual outcome of the scale and duration of the Middle East conflict. Hong Kong economy saw a stable and moderate recovery during the year. Local residential property market exhibited signs of stabilisation and the financial market regained its momentum with strong trading and fund-raising activities. However, the shifts in tourist consumption patterns and the normalisation of Hong Kong residents traveling outbound and spending up north continued to pose challenges to local consumption market. Nevertheless, government's promotion of mega events shall provide some support to consumer sentiment.

In such an environment, the Group will closely monitor the global and local economic and political situations, take a cautious and prudent approach in cost control management, operational efficiency and financial discipline. The Group maintained a sound financial position with no gearing. As at 31 March 2026, cash balance of the Group was approximately HK\$413.3 million. The Board recommends the payment of a final dividend of HK 4.0 cents per share, bringing the total dividend for the financial year ended 31 March 2026 to HK 7.0 cents per share. The Group is determined to maintain a sustainable dividend policy as well as strong liquidity to preserve its strength for strategic business investment and development, and capture growth opportunities across market cycles.

Employees

As at 31 March 2026, the Group had 958 employees (31 March 2025: 1,027 employees). The Directors believe that employees are the most valuable assets of the Group and competitive remuneration packages are offered to retain quality staff. Employee benefits include medical insurance, discretionary bonus, provident fund schemes and other staff benefits.

We focused on auditing of the provision for impairment of trade receivables due to the magnitude of the trade receivables, the higher degree of estimation uncertainty and subjectivity in management's judgement involved in determining the expected credit loss allowance of the trade receivables. The inherent risk in relation to the determining of the expected credit loss allowance of the trade receivables is considered significant due to subjectivity of significant assumptions used, and significant judgements involved in selecting data.	We corroborated and validated management's assessment on the expected credit loss allowance of trade receivables based on the correspondence with the customers, independent research on publicly available information and forward-looking information such as macroeconomic factors used in management's assessment. We tested on a sample basis, the accuracy of ageing profile of trade receivables by checking to the related supporting documents. We checked the mathematical accuracy of the calculation of the provision for loss allowance. Based on the above procedures, we found that the estimation and judgement made by management in respect of the expected credit loss allowance for trade receivables were supportable by the available evidence.

1. General information

The Company was incorporated in the Cayman Islands on 15 February 2005 as an exempted company with limited liability under the Companies Act, Chapter 22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands with registered office at Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman KY1-1111, Cayman Islands.

The Company is an investment holding company. The principal activities of its subsidiaries are the printing and publishing of newspapers and magazines and operation of their associated digital businesses; the operation of recruitment advertising and lifestyle platforms; and the provision of electronic financial and property market information services.

The Company's shares are listed on the Main Board of The Stock Exchange of Hong Kong Limited.

These consolidated financial statements are presented in Hong Kong dollars ("HK\$" or "HK dollars"), unless otherwise stated.

2. Basis of preparation

2.1 Compliance with HKFRS and Hong Kong Companies Ordinance

The consolidated financial statements of Hong Kong Economic Times Holdings Limited have been prepared in accordance with HKFRS Accounting Standards ("HKFRSs") as issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA") and in compliance with the disclosure requirements of the Hong Kong Companies Ordinance Cap. 622.

The preparation of the consolidated financial statements in conformity with HKFRSs requires the use of certain critical accounting estimates. It also requires management to exercise its judgement in the process of applying the Group's accounting policies. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the consolidated financial statements are disclosed in note 5.

2.2 Historical cost convention

The consolidated financial statements have been prepared under the historical cost convention.

HKFRS 18 will replace HKAS 1 “Presentation of financial statements”, introducing new requirements that will help to achieve comparability of the financial performance of similar entities and provide more relevant information and transparency to users. - (ii) The line items presented on the primary financial statements might change as a result of the application of the concept of 'useful-structured summary' and the enhanced principles on aggregation and disaggregation.
- (iii) The Group does not expect there to be a significant change in the information that is currently disclosed in the notes because the requirement to disclose material information remains unchanged, however, the way in which the information is grouped might change as a result of the aggregation/disaggregation principles. In addition, there will be significant new disclosures required for:
- management-defined performance measures;
 - a breakdown of the nature of expenses for line items presented by function in the operating category of the consolidated statement of comprehensive income — this breakdown is only required for certain nature of expenses; and
 - for the first annual period of application of HKFRS 18, a reconciliation for each line item in the consolidated statement of comprehensive income between the restated amounts presented by applying HKFRS 18 and the amounts previously presented applying HKAS 1.

The Group expects to apply the new standard from its mandatory effective date of 1 January 2027. Retrospective application is required, and so the comparative information for the financial year ending 31 March 2027 will be restated in accordance with HKFRS 18.

In addition to the above mentioned changes in presentation and disclosures, the Group is in the process of assessing the impact of adopting other new and amended standards and interpretation on its current or future reporting periods and on foreseeable future transactions.

3. Summary of material accounting policy information

The material accounting policies adopted in the preparation of these consolidated financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

3.1 Property, plant and equipment

Buildings comprise mainly offices and factories. All property, plant and equipment are stated at historical cost less accumulated depreciation and impairment losses, if any. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. The carrying amount of any component accounted for as a separate asset is derecognised when replaced. All other repairs and maintenance are charged to the consolidated income statement during the financial period in which they are incurred.

Depreciation on property, plant and equipment is calculated using the straight-line method to allocate their costs over their estimated useful lives, as follows:

The assets' useful lives are reviewed, and adjusted if appropriate, at each balance sheet date.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount (see note 3.3).

Gains and losses on disposals are determined by comparing proceeds with carrying amounts of the relevant assets. These are recognised in the consolidated income statement.

3.2 Investment properties

Investment properties, principally comprising leasehold land and buildings, are held for long-term rental yields, and that are not occupied by the Group.

Investment properties are initially measured at cost, including related transaction costs. Subsequent expenditure is charged to the carrying amount of the asset only when it is probable that future economic benefits associated with the asset will flow to the Group and the cost of the asset can be measured reliably. All other repairs and maintenance costs are expensed in the consolidated income statement during the financial period in which they are incurred.

Investment properties are stated at historical cost less accumulated depreciation and impairment losses, if any. They are depreciated using the straight-line method over their estimated useful lives or over the unexpired periods of the leases, whichever is shorter.

Gains and losses on disposals are determined by comparing proceeds with carrying amounts of the relevant assets. These are recognised in the consolidated income statement.

3.3 Impairment of non-financial assets

Assets that are subject to depreciation or amortisation are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs of disposal and value in use. For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash inflows which are largely independent of the cash inflows from other assets or groups of assets (cash-generating units). Non-financial assets other than goodwill that suffered an impairment are reviewed for possible reversal of the impairment at each balance sheet date.

3.4 Financial assets

3.4.1 Classification

The Group classifies its financial assets in the following measurement categories:

- those to be measured subsequently at fair value (either through other comprehensive income or through profit or loss), and
- those to be measured at amortised cost.

The classification depends on the entity's business model for managing the financial assets and the contractual terms of the cash flows.

For assets measured at fair value, gains and losses will either be recorded in profit or loss or other comprehensive income. For investments in equity instruments that are not held for trading, this will depend on whether the Group has made an irrevocable election at the time of initial recognition to account for the equity investment at fair value through other comprehensive income.

The Group reclassifies debt investments when and only when its business model for managing those assets changes.

3.4.2 Recognition and derecognition

Regular way purchases and sales of financial assets are recognised on trade-date, the date on which the Group commits to purchase or sell the asset. Financial assets are derecognised when the rights to receive cash flows from the financial assets have expired or have been transferred and the Group has transferred substantially all the risks and rewards of ownership.

3.4.3 Measurement

At initial recognition, the Group measures a financial asset at its fair value plus, in the case of a financial asset not at fair value through profit or loss ("FVPL"), transaction costs that are directly attributable to the acquisition of the financial asset. Transaction costs of financial assets carried at FVPL are expensed in profit or loss.

Debt instruments

Subsequent measurement of debt instruments depends on the Group's business model for managing the asset and the cash flow characteristics of the asset. The Group classifies its debt instruments as amortised cost. Assets that are held for collection of contractual cash flows where those cash flows represent solely payments of principal and interest are measured at amortised cost. Interest income from these financial assets is included in finance income using the effective interest rate method. Any gain or loss arising on derecognition is recognised directly in the consolidated income statement. Impairment losses are presented as separate line item in the consolidated income statement.

3.4.4 Impairment

The Group assesses on a forward looking basis the expected credit losses ("ECL") associated with its debt instruments carried at amortised cost. The impairment methodology applied depends on whether there has been a significant increase in credit risk.

For trade receivables, the Group applies the simplified approach permitted by HKFRS 9, which requires expected lifetime losses to be recognised from initial recognition of the receivables.

For other financial assets carried at amortised cost, the loss allowance recognised is based on the 12-month ECL. It is the portion of lifetime expected credit loss that results from default events on a financial instrument that are possible within 12 months after the balance sheet date. However, when there has been a significant increase in credit risk since origination, the allowance will be based on the lifetime ECL.

3.5 Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined using the first-in, first-out (FIFO) method. Net realisable value is the estimated selling price in the ordinary course of business, less the estimated costs of completion and the estimated costs necessary to make the sale.

3. Summary of material accounting policy information (Continued)

3.6 Trade and other receivables

Trade receivables are amounts due from customers for merchandise sold or services performed in the ordinary course of business. If collection of trade and other receivables is expected in one year or less (or in the normal operating cycle of the business if longer), they are classified as current assets. If not, they are presented as non-current assets.

Trade and other receivables are recognised initially at the amount of consideration that is unconditional unless they contain significant financing components, when they are recognised at fair value. The Group holds the trade receivables with the objective of collecting the contractual cash flows and therefore measures them subsequently at amortised cost using the effective interest method. Details about the Group's impairment policies and the calculation of the loss allowance are provided in note 4.1(b)(ii).

3.7 Current and deferred income tax

The income tax expense for the year is the tax payable on the current period's taxable income based on the applicable income tax rate for each jurisdiction adjusted by changes in deferred tax assets and liabilities attributable to temporary differences and unused tax losses.

(a) *Current income tax*

The current income tax charge is calculated on the basis of the tax laws enacted or substantively enacted at the balance sheet date in the countries where the Company and its subsidiaries operate and generate taxable income. Management periodically evaluates positions taken in tax returns with respect to situations in which applicable tax regulation is subject to interpretation and considers whether it is probable that a taxation authority will accept an uncertain tax treatment. The Group measures its tax balances either based on the most likely amount or the expected value, depending on which method provides a better prediction of the resolution of the uncertainty.

(b) *Deferred income tax*

Deferred income tax is provided in full, using the liability method, on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the consolidated financial statements. However, deferred tax liabilities are not recognised if they arise from the initial recognition of goodwill. Deferred income tax is also not accounted for if it arises from initial recognition of an asset or liability in a transaction other than a business combination that at the time of the transaction affects neither accounting nor taxable profit or loss. Deferred income tax is determined using tax rates (and laws) that have been enacted or substantively enacted by the balance sheet date and are expected to apply when the related deferred income tax asset is realised or the deferred income tax liability is settled.

Deferred tax assets are recognised only if it is probable that future taxable profit amounts will be available to utilise those temporary differences and losses.

Deferred tax liabilities and assets are not recognised for temporary differences between the carrying amount and tax bases of investments in foreign operations where the company is able to control the timing of the reversal of the temporary differences and it is probable that the differences will not reverse in the foreseeable future.

Deferred tax assets and liabilities are offset where there is a legally enforceable right to offset current tax assets and liabilities and where the deferred tax balances relate to the same taxation authority. Current tax assets and tax liabilities are offset where the entity has a legally enforceable right to offset and intends either to settle on a net basis, or to realise the asset and settle the liability simultaneously.

Current and deferred tax is recognised in profit or loss, except to the extent that it relates to items recognised in other comprehensive income or directly in equity. In this case, the tax is also recognised in other comprehensive income or directly in equity, respectively.

3.8 Provisions

Provisions are recognised when the Group has a present legal or constructive obligation as a result of past events; it is probable that an outflow of resources will be required to settle the obligation; and the amount has been reliably estimated. Provisions are not recognised for future operating losses.

Where there are a number of similar obligations, the likelihood that an outflow will be required in settlement is determined by considering the class of obligations as a whole. A provision is recognised even if the likelihood of an outflow with respect to any one item included in the same class of obligations may be small.

Provisions are measured at the present value of the expenditures expected to be required to settle the obligation using a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the obligation. The increase in the provision due to passage of time is recognised as finance costs.

3.9 Revenue recognition

Revenue is measured at the fair value of the consideration received or receivable for the rendering of services in the ordinary course of the Group's activities.

If contracts involve the sale of multiple elements, the transaction price will be allocated to each performance obligation based on their relative stand-alone selling price.

The Group recognised revenue as follows:

(a) *Sales of goods*

Circulation income, comprises the sales of newspapers, magazines and books, are recognised at a point in time when control of the products has transferred, being when the products are delivered to the customers, the customer has accepted the products, the collection of the related consideration is probable and there is no unfulfilled obligation that could affect the customer's acceptance of the products.

A receivable is recognised when the goods are delivered as this is the point in time that the consideration is unconditional because only the passage of time is required before the payment is due.

A contract liability is recognised when a customer pays consideration, or is contractually required to pay consideration and the amount is already due, before the Group recognises the related revenue. The Group recognised its contract liabilities as fees in advance in the consolidated balance sheet.

(b) *Provision of services*

Revenue from providing services includes:

- Advertising income is recognised in accordance with the terms of the underlying contract. Income from online advertisements is recognised over time as the advertisements are published, as the customers simultaneously receives and consumes the benefits provided by the Group. Income from advertisements printed and published in newspapers is recognised at a point in time, when the advertising services have been rendered by the Group and acknowledged by the customers;
- Service income derived from the provision of printing services and sales of products, are recognised at point in time when the services are rendered;

(b) *Provision of services (Continued)*

- Service income derived from the provision of information subscription services, solution and other related maintenance services and provision of professional training, are recognised over time when the services are rendered since the customers simultaneously receive and consume benefit provided by the Group.

If the contract includes a monthly fee, revenue is recognised in the amount to which the Group has a right to invoice. Customers are invoiced on a monthly basis and consideration is payable when invoiced.

A contract liability is recognised when a customer pays consideration, or is contractually required to pay consideration and the amount is already due, before the Group recognises the related revenue. The Group recognised its contract liabilities as fees in advance in the consolidated balance sheet.

(c) *Rental income*

Rental income receivable under operating leases is recognised in the consolidated income statement in equal installments over the accounting periods covered by the lease term, except where an alternative basis is more representative of the pattern of benefits to be derived from the leased asset. Lease incentives granted are recognised in the consolidated income statement as an integral part of the aggregate net lease payments receivable. Contingent rentals are recognised as income in the accounting period in which they are earned.

(d) *Finance income*

Finance income is calculated by applying the effective interest rate to the gross carrying amount of a financial asset except for financial assets that subsequently become credit-impaired. For credit-impaired financial assets the effective interest rate is applied to the net carrying amount of the financial asset (after deduction of the loss allowance).

4. Financial risk management

4.1 Financial risk factors

The Group's activities expose it to a variety of financial risks: market risk (including foreign exchange risk and interest rate risk), credit risk and liquidity risk. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance. The Group has not used derivative financial instruments to hedge its risk exposures to changes in foreign currency exchange rates and interest rates.

(a) *Market risk*

(i) Foreign exchange risk

Most of the income and expenditures of the Group are denominated in HK dollars. Certain transactions are denominated in United States dollars ("US dollars") and Renminbi ("RMB"). The value of HK dollars is pegged to that of US dollars and hence, the Group does not have any material foreign exchange exposure in this regard. The Group's exposure to RMB is considered to be minimal, as there are no significant assets and liabilities denominated in RMB.

The Group has not implemented or entered into any type of instruments or arrangements to hedge against currency exchange fluctuations for the year under review. As at 31 March 2026 and 2025, the Group did not have any outstanding hedging instruments.

(ii) Interest rate risk

Financial instruments at variable rates expose the Group to cash flow interest rate risk. Financial instruments at fixed rates expose the Group to fair value interest rate risk.

Except for bank deposits grouped under 'term deposits with original maturities of over three months' and 'cash and cash equivalents' in the consolidated balance sheet, the Group has no other significant interest-bearing assets or liabilities.

Since there is no borrowing in the Group and short-term bank deposits are under short maturity terms, the cash flow interest rate risk is considered to be low.

At 31 March 2026, it is estimated that a general increase/decrease of 50 basis points in interest rates, with all other variables held constant, would decrease/increase the Group's loss for the year by approximately HK\$633,000 (2025: HK\$746,000), in respect of interest income on floating rate bank deposits.

(b) Credit risk

The Group's credit risk arises from its bank deposits, trade receivables and deposits and other receivables.

(i) Risk management

To mitigate the risk arising from cash and cash equivalents, term deposits with original maturities of over three months, the Group places its deposits to certain reputable banks with a minimum rating of "investment grade" ranked by an independent party.

The Group manages its credit risk associated with trade receivables through the application of credit approvals, credit ratings and monitoring procedures.

Credit sales are only made to customers with appropriate credit history or high credit standing while sales to new customers or customers of low credit standing are usually made on an advance payment or cash on delivery basis.

In addition, trade receivables balances are monitored on an ongoing basis and the Group's exposure to bad debts is not significant.

(ii) Impairment of financial assets

Trade receivables of the Group are subject to the ECL model. While cash and cash equivalents, term deposits with original maturities of over three months and other financial assets at amortised cost are also subject to the impairment requirements of HKFRS 9, the identified impairment loss was immaterial.

Trade receivables

The Group applies the HKFRS 9 simplified approach to measuring ECL which uses a lifetime expected loss allowance for all trade receivables. The Group measures the ECL on a combination of both individual and collective basis.

- Measurement of ECL on individual basis

Receivables relating to customers with known financial difficulties or significant doubt on collection of receivables are assessed individually for provision for impairment allowance.

Of the gross carrying amount as at 31 March 2026, HK\$2,011,000 (2025: HK\$2,272,000) were fully impaired.

- Measurement of ECL on collective basis

The Group also estimates the provision for ECL on a collective basis by grouping the trade receivables based on shared credit loss risk characteristics and collectively assessed for likelihood of recovery, taking into account the nature of the customer, and applying ECL rates to respective gross carrying amounts of the receivables.

The ECL rates are based on the payment profiles of customers and the corresponding historical credit losses experienced over the past 3 years. The historical loss rates are adjusted to reflect current and forward-looking information on macroeconomic factors affecting the ability of the customers to settle the receivables.

Impairment losses on trade receivables are presented as 'net impairment losses on financial assets' in the consolidated income statement. When a trade receivable is determined to be uncollectible and non-recoverable due to deregistration or bankruptcy of the debtors or other reasons, it is written off against the allowance account for trade receivables. Subsequent recoveries of amounts previously written off are credited against the same line item.

Cash and cash equivalents, term deposits with original maturities of over three months and other financial assets at amortised cost

For cash and cash equivalents, term deposits with original maturities of over three months and other financial assets at amortised cost, management considers that its credit risk has not increased significantly since initial recognition with reference to the counterparty historical default rate and current financial position. The impairment provision is determined based on the 12-month expected credit losses which is close to zero (2025: same).

(c) Liquidity risk

The Group's policy is to regularly monitor current and expected liquidity level to ensure that it maintains sufficient reserves of cash and cash equivalents to meet its liquidity requirements.

As at 31 March 2026 and 2025, the Group does not have undrawn borrowing facilities.

4.2 Capital management

The Group's objectives when managing capital are to safeguard the Group's ability to continue as a going concern in order to provide returns for owners and benefits for other stakeholders and to maintain an optimal capital structure to reduce the cost of capital.

In order to maintain or adjust the capital structure, the Group may adjust the amount of dividends paid to shareholders, return capital to shareholders or issue new shares.

Consistent with others in the industry, the Group monitors capital on the basis of gearing ratio. This ratio is calculated as total interest bearing liabilities divided by total assets. Total interest bearing liabilities are calculated as total borrowings including current and non-current bank borrowings as shown in the consolidated balance sheet. Total assets are calculated as 'total assets' as shown in the consolidated balance sheet.

As at 31 March 2026 and 2025, the Group had no borrowings.

4.3 Fair value estimation

The carrying amounts of the financial assets of the Group, including cash and cash equivalents, term deposits with original maturities of over three months and trade and other receivables; and financial liabilities including trade and other payables and lease liabilities approximate their fair values due to their short-term maturities. Lease liabilities that are expected to be settled more than 12 months after reporting date are initially measured on a present value basis by discounting the balance to net present value using the Group's incremental borrowing rate.

The fair values less costs of disposal of property, plant and equipment and investment properties are measured by level of the following fair value measurement hierarchy:

- (i) Quoted prices (unadjusted) in active markets for identical assets or liabilities (level 1).
- (ii) Inputs other than quoted prices included within level 1 that are observable for the asset or liability, either directly (that is, as prices) or indirectly (that is, derived from prices) (level 2).
- (iii) Inputs for the asset or liability that are not based on observable market data (that is, unobservable inputs) (level 3).

The fair values of property, plant and equipment and investment properties are determined by using valuation techniques, such as quoted market prices or dealer quotes for similar property, plant and equipment and investment properties, or the income capitalisation method. These valuation techniques maximise the use of observable market data where it is available and rely as little as possible on entity specific estimates. If all significant inputs required to value an asset are observable, the asset is included in level 2.

5. Critical accounting estimates and judgements

Estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

The Group makes estimates and assumptions concerning the future. The resulting accounting estimates will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are addressed below.

(a) Deferred income tax assets

Deferred income tax is determined using tax rates (and laws) that have been enacted or substantively enacted at the balance sheet date and are expected to apply when the related deferred income tax asset is realised or the deferred income tax liability is settled. Deferred income tax assets are recognised to the extent that it is probable that future taxable profit will be available against which the temporary differences can be utilised.

The Group's management determines the deferred income tax assets based on the enacted or substantively enacted tax rates (and laws) and the best knowledge of profit projections of the Group for coming years during which the deferred income tax assets are expected to be utilised. In assessing the amount of deferred income tax assets that need to be recognised, the Group considers future taxable income and ongoing prudent and feasible tax planning strategies. In the event that the Group's estimates of projected future taxable income and benefits from available tax strategies are changed, or changes in current tax regulations are enacted that would impact the timing or extent of the Group's ability to utilise the tax benefits of net operating loss carry forwards in the future, adjustments to the recorded amount of net deferred income tax assets and income tax expense would need to be made. In addition, management will revisit the assumptions and profit projections at the balance sheet date.

(b) Provision for impairment of trade receivables

The Group makes provision for impairment of trade receivables based on assumptions about risk of default and expected loss rates. The Group uses judgement in making these assumptions and selecting the inputs to the impairment calculation, based on the Group's past history, existing market conditions as well as forward-looking estimates at the balance sheet date.

(c) Impairment of non-financial assets

Assets are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amounts may not be recoverable. The recoverable amounts have been determined based on the higher of value-in-use calculations and fair values less costs of disposal. These calculations require the use of judgements and estimates.

(c) Impairment of non-financial assets (Continued)

Management's judgement is required in the area of asset impairment particularly in assessing: (i) whether an event has occurred that may indicate that the related asset values may not be recoverable; (ii) whether the carrying amount of an asset can be supported by the recoverable amount, being the higher of fair value less costs of disposal and net present value of future cash flows which are estimated based upon the continued use of the asset in the business; (iii) the appropriate key assumptions to be applied in preparing cash flow projections including whether these cash flow projections are discounted using an appropriate rate; and (iv) the appropriate market value of an asset to be applied in estimating the fair value less costs of disposal. Changing the assumptions selected by management in assessing impairment, including the discount rates or the growth rate assumptions in the cash flow projections, could materially affect the net present value used in the impairment test and as a result affect the Group's financial condition and results of operations.

29.1 Subsidiaries

29.1.1 Consolidation

Subsidiaries are all entities over which the Group has control. The Group controls an entity when the Group is exposed to, or has rights to, variable returns from its involvement with entity and has the ability to affect those returns through its power over the entity. Subsidiaries are consolidated from the date on which control is transferred to the Group. They are deconsolidated from the date that control ceases. The acquisition method of accounting is used to account for business combinations by the Group (refer to note 29.1.1(a)).

Inter-company transactions, balances and unrealised gains on transactions between group companies are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the transferred asset. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Group.

Non-controlling interests in the results and equity of subsidiaries are shown separately in the consolidated income statement, consolidated statement of comprehensive income, consolidated balance sheet and consolidated statement of changes in equity respectively.

(a) Business combinations

The acquisition method of accounting is used to account for all business combinations, regardless of whether equity instruments or other assets are acquired. The consideration transferred for the acquisition of a subsidiary comprises the:

- fair values of the assets transferred
- liabilities incurred to the former owners of the acquired business
- equity interests issued by the group
- fair value of any asset or liability resulting from a contingent consideration arrangement, and
- fair value of any pre-existing equity interest in the subsidiary.

Identifiable assets acquired and liabilities and contingent liabilities assumed in a business combination are, with limited exceptions, measured initially at their fair values at the acquisition date. The group recognises any non-controlling interest in the acquired entity on an acquisition-by-acquisition basis either at fair value or at the non-controlling interest's proportionate share of the acquired entity's net identifiable assets.

Acquisition-related costs are expensed as incurred.

Where settlement of any part of cash consideration is deferred, the amounts payable in the future are discounted to their present value as at the date of exchange. The discount rate used is the entity's incremental borrowing rate, being the rate at which a similar borrowing could be obtained from an independent financier under comparable terms and conditions. Contingent consideration is classified either as equity or a financial liability. Amounts classified as a financial liability are subsequently remeasured to fair value with changes in fair value recognised in profit or loss.

If the business combination is achieved in stages, the acquisition date carrying value of the acquirer's previously held equity interest in the acquiree is remeasured to fair value at the acquisition date. Any gains or losses arising from such remeasurement are recognised in profit or loss.

(b) Changes in ownership interests

The Group treats transactions with non-controlling interests that do not result in a loss of control as transactions with equity owners of the Group. A change in ownership interest results in an adjustment between the carrying amounts of the controlling and non-controlling interests to reflect their relative interests in the subsidiary. Any difference between the amount of the adjustment to non-controlling interests and any consideration paid or received is recognised in a separate reserve within equity attributable to owners of the Company.

In addition, any amounts previously recognised in other comprehensive income in respect of that entity are accounted for as if the Group had directly disposed of the related assets or liabilities. This may mean that amounts previously recognised in other comprehensive income are reclassified to profit or loss or transferred to another category of equity as specified/permitted by applicable HKFRSs.

29.1.2 Separate financial statements

Investments in subsidiaries are accounted for at cost less impairment. Cost includes direct attributable costs of investment. The results of subsidiaries are accounted for by the Company on the basis of dividend received and receivable.

Impairment testing of the investments in subsidiaries is required upon receiving dividends from these investments if the dividend exceeds the total comprehensive income of the subsidiary in the period the dividend is declared or if the carrying amount of the investment in the separate financial statements exceeds the carrying amount in the consolidated financial statements of the investee's net assets including goodwill.

29.2 Segment reporting

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decision-maker. The chief operating decision-maker, who is responsible for allocating resources and assessing performance of the operating segments, has been identified as the Chief Executive Officer of the Group who makes strategic decisions.

29.3 Foreign currency translation

(a) *Functional and presentation currency*

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The consolidated financial statements are presented in Hong Kong dollars, which is the Company's functional and the Group's presentation currency.

(b) *Transactions and balances*

Foreign currency transactions are translated into the functional currency using the exchange rates at the dates of the transactions. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation of monetary assets and liabilities denominated in foreign currencies at year-end exchange rates are generally recognised in the consolidated income statement.

(c) *Group companies*

The results and financial position of all the group entities (none of which has the currency of a hyperinflationary economy) that have a functional currency different from the presentation currency are translated into the presentation currency as follows:

- (i) assets and liabilities for each balance sheet presented are translated at the closing rate at the date of that balance sheet;
- (ii) income and expenses for each income statement are translated at average exchange rates (unless this average is not a reasonable approximation of the cumulative effect of the rates prevailing on the transaction dates, in which case income and expenses are translated at the rate on the dates of the transactions); and
- (iii) all resulting currency translation differences are recognised in other comprehensive income.

Goodwill and fair value adjustments arising on the acquisition of a foreign entity are treated as assets and liabilities of the foreign entity and translated at the closing rate. Currency translation differences arising are recognised in other comprehensive income.

29.4 Offsetting financial instruments

Financial assets and liabilities are offset and the net amount reported in the consolidated balance sheet when there is a legally enforceable right to offset the recognised amounts and there is an intention to settle on a net basis or realise the asset and settle the liability simultaneously.

29.5 Cash and cash equivalents

For the purpose of presentation in the consolidated cash flow statement, cash and cash equivalents include cash on hand and deposits held at call with banks with original maturities of three months or less are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

29.6 Share capital

Ordinary shares are classified as equity. Incremental costs directly attributable to the issue of new shares or options are shown in equity as a deduction, net of tax, from the proceeds.

29.7 Trade and other payables

Trade and other payables represent liabilities for goods and services provided to the Group prior to the end of financial year which are unpaid. Trade and other payables are presented as current liabilities unless payment is not due within 12 months after the financial year. They are recognised initially at their fair values and subsequently measured at amortised cost using the effective interest method.

29.8 Employee benefits

(a) *Employee leave entitlements*

Employee entitlements to annual leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave as a result of services rendered by employees up to the balance sheet date.

Employee entitlements to sick leave and maternity leave are not recognised until the time of leave.

(b) Long service payments

The Group's net obligation in respect of long service payments to its employees in Hong Kong upon cessation of their employment in certain circumstances under the Hong Kong Employment Ordinance is the amount of future benefits that the employees have earned in return for their services in the current and prior periods.

The obligation is calculated using the projected unit credit cost method, discounted to its present value and reduced by entitlements accrued under the Group's retirement schemes that are attributed to contributions made by the Group. The discount rate is the yield at each balance sheet date of Hong Kong Government's Exchange Fund Notes which have terms to maturity approximating the terms of the related liability. The expected costs of these benefits are accrued over the period of employment using the same accounting methodology as used for defined benefit plans.

The current service cost of the defined benefit plan, recognised in the consolidated income statement in employee benefit expense reflects the increase in the defined benefit obligation results from employee service in the current year, benefit changes, curtailments and settlements.

Past-service costs are recognised immediately in the consolidated income statement.

The interest expenses are calculated by applying the discount rate to the balance of the defined benefit obligation. This cost is included in employee benefit expense in the consolidated income statement.

Actuarial gains and losses arising from experience adjustment and changes in actuarial assumptions are charged or credited to equity in other comprehensive income in the period in which they arise.

(c) Pension obligations

The Group operates defined contribution plans, including a mandatory provident fund scheme ("MPF") in Hong Kong, the assets of which are generally held in separate trustee-administered funds.

In addition, pursuant to the government regulations in Mainland China, the Group is required to contribute an amount to certain retirement benefit schemes for those employees in Mainland China. The local municipal government undertakes to assume the retirement benefits obligations of those employees of the Group. Contributions to these retirement benefits schemes are charged to the consolidated income statement as incurred.

(c) *Pension obligations (Continued)*

A defined contribution plan is a pension plan under which the Group pays fixed contributions into a separate entity. The Group has no legal or constructive obligations to pay further contributions if the fund does not hold sufficient assets to pay all employees the benefits relating to employee service in the current and prior periods.

The Group pays contributions to publicly or privately administered pension insurance plans on mandatory, contractual or voluntary basis. The Group's contributions to the defined contribution retirement plans are expensed as incurred. The Group's contributions to all these plans except for the MPF and the plans in Mainland China are reduced by contributions forfeited by those employees who leave the scheme prior to vesting fully in the contributions. The Group has no further payment obligations once the contributions have been paid. The contributions are recognised as employee benefit expense when they are due. Prepaid contributions are recognised as an asset to the extent that a cash refund or a reduction in the future payments is available.

29.9 Leases

(a) *As a lessee*

The Group leases various properties including offices and workshops. Lease terms are negotiated on an individual basis and contain a wide range of different terms and conditions. The lease agreements do not impose any covenants, but leased assets may not be used as security for borrowing purposes.

Leasehold land is included in right-of-use assets. Leases are recognised as a right-of-use asset (included in property, plant and equipment) and a corresponding liability at the date on which the leased asset is available for use by the Group. Each lease payment is allocated between the liability and finance cost. The finance cost is charged to the consolidated income statement over the lease term so as to produce a constant periodic rate of interest on the remaining balance of the liability for each period. Right-of-use assets are depreciated over the shorter of the assets useful life and the lease terms on a straight-line basis.

29.9 Leases (Continued)

(a) As a lessee (Continued)

Assets and liabilities arising from a lease are initially measured on a present value basis. Lease liabilities include the net present value of the following lease payments:

- fixed payments (including in-substance fixed payments), less any lease incentives receivable;
- variable lease payment that are based on an index or a rate, initially measured using the index or rate as at the commencement date;
- amounts expected to be payable by the Group under residual value guarantees;
- the exercise price of a purchase option if the Group is reasonably certain to exercise that option; and
- payments of penalties for terminating the lease, if the lease term reflects the Group exercising that option.

The lease payments are discounted using the interest rate implicit in the lease, if that rate can be determined, or the Group's incremental borrowing rate.

Right-of-use assets are measured at cost comprising the following:

- the amount of the initial measurement of the lease liability;
- any lease payments made at or before the commencement date, less any lease incentives received;
- any initial direct costs incurred; and
- an estimate of costs to be incurred by the lease in dismantling and removing the underlying asset.

Payments associated with short-term leases are recognised on a straight-line basis as an expense in the consolidated income statement. Short-term leases are leases with a lease term of 12 months or less.

(a) *As a lessee* (Continued)

Extension options are included in the property leases across the Company. These terms are used to maximise operational flexibility in terms of managing contracts. All extension options held are exercisable only by the Company and not by the respective lessor. The Company considers all facts and circumstances that create an economic incentive to exercise an extension option in determining the lease term. The assessment is reviewed if a significant event or a significant change in circumstances occurs which affects the assessment.

(b) *As a lessor*

When an asset is leased out under an operating lease, the asset is included in the consolidated balance sheet based on the nature of the asset. Lease income on operating leases is recognised over the term of the lease on a straight-line basis.

29.10 Dividend distribution

Dividend distribution to the Company's shareholders is recognised as a liability in the Group's and Company's financial statements in the period in which the dividends are approved by the Company's shareholders or directors, where appropriate.

29.11 Related parties

For the purpose of these consolidated financial statements, a party is considered to be related to the Group if the Group has the ability, directly or indirectly, to control the party or exercise significant influence over the party in making financial and operating decisions, or vice versa, or where the Group and the party are subject to common control. Related parties may be individuals (being members of key management personnel, significant owners and/or their close family members) or other entities and include entities which are under the significant influence of related parties of the Group where those parties are individuals.
