PROFIT WARNING

This announcement is made by Goldpac Group Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that based on the currently available preliminary assessment of the unaudited consolidated management accounts of the Company for the six months ended 30 June 2026 (the “**Unaudited Management Accounts**”),

- (i) the Board expects to record a decrease in revenue by approximately 5% to 10% for the six months ended 30 June 2026 as compared to the revenue for the six months ended 30 June 2025 (which was approximately RMB458 million); and
- (ii) the Board expects to record a significant decrease in the profit attributable to the owners of the Company by approximately 110% to 130% for the six months ended 30 June 2026 as compared to the profit attributable to the owners of the Company for the six months ended 30 June 2025 (which was approximately RMB24 million).

The decrease in revenue and the decrease in profit attributable to the owners of the Company for the six months ended 30 June 2026, respectively, was primarily due to factors such as (i) intensified market competition; and (ii) foreign exchange losses resulting from efforts to increase investment in overseas markets and build up foreign exchange reserves, which led to a net loss for the period.

As at the date of this announcement, the Company is still in the process of preparing the interim results of the Group for the six months ended 30 June 2026 and is not able at this time to disclose any further details on the above factors and their impact on the profit attributable to owners of the Company for the period. The information set out above is only based on a preliminary assessment by the Board on the information currently available to it, including the Unaudited Management Accounts, which have not been finalized and not been independently reviewed by the Company's auditor or the Company's audit committee. Shareholders and potential investors of the Company should refer to the interim results of the Company for the six months ended 30 June 2026, which are expected to be published before the end of August 2026.

Shareholders and potential investors of the Company are advised to exercise caution when dealing in the securities of the Company.
