The aforementioned statements are the unaudited and unreviewed individual statements of CICC Wealth Management as the parent company, which do not include the financial data of consolidated subsidiaries of CICC Wealth Management. The parent company's unaudited and unreviewed key financial data of CICC Wealth Management for the six months ended June 30, 2026 as set out in the Interim Financial Statements of CICC Wealth Management is as follows:

As of June 30, 2026, CICC Wealth Management reported the total assets of RMB250,118,640,016.43 and the net assets of RMB30,212,360,067.75; during the first half of 2026, CICC Wealth Management realized the operating revenue of RMB6,139,035,143.09 (including: net fee and commission income of RMB3,642,541,400.03, net interest income of RMB1,175,530,538.91, investment income of RMB854,552,353.29, gains arising from changes in fair value of RMB428,979,895.22), the operating expenses of RMB2,913,836,319.45, the operating profit of RMB3,225,198,823.64, the profit before income tax of RMB3,227,168,442.99 and the net profit of RMB2,387,238,745.49.
