On behalf of the board (the **"Board"**) of directors (the **"Directors"**) of Grand Ming Group Holdings Limited (the **"Company"**), I am delighted to present the annual report of the Company and its subsidiaries (collectively the **"Group"**) for the year ended 31 March 2026 (**"FY 2025/26"**).

RESULTS

For FY 2025/26, the Group recorded a net loss of HK\$349.5 million, as compared to a net loss of HK\$292.1 million for the year ended 31 March 2025 (**"FY 2024/25"**). The increase was mainly attributable to (i) a substantial decrease in the area of residential properties delivered and expiry of a data centre lease; and (ii) decrease in selling expenses as a result of reduced revenue from sales of properties as aforesaid.

DIVIDENDS

No dividend was paid during FY 2025/26.

In view of challenging market conditions, the Board does not recommend payment of a final dividend for FY 2025/26.

本人謹代表佳明集團控股有限公司（「本公司」）董事（「董事」）會（「董事會」）欣然提呈本公司及其附屬公司（統稱「本集團」）截至二零二六年三月三十一日止年度（「2025/26年度」）的年報。

業績

本集團於2025/26年度錄得淨虧損3.495億港元，而截至二零二五年三月三十一日止年度（「2024/25年度」）則錄得淨虧損2.921億港元。淨虧損的升幅主要歸因(i)交付的住宅物業面積大幅減少以及一項數據中心租約屆滿；及(ii)上述物業銷售收益減少導致銷售開支減少。

股息

2025/26年度並無派付任何股息。

鑑於市況充滿挑戰，董事會不建議派付2025/26年度之末期股息。

REVIEW OF OPERATION

Property Development – Hong Kong

Nexus Grand (100% owned)

This site, situated at No. 1 Luen Fat Street, Fanling, the New Territories, is being developed into a 17-storey residential-cum-commercial tower with a two-level underground car park. It provides 90 residential units with commercial shops covering a total gross floor area of approximately 36,000 square feet. The development of this project was completed in December 2025. During the year under review, pre-sales of the residential units commenced, and with a strong market response, all of the residential units were sold and around 99% (in terms of units) were handed over to the buyers with related revenue recognised in FY 2025/26. The remaining sold residential units were also handed over to the buyers subsequently.

The Grands (100% owned)

This residential-cum-commercial project is located at No. 45 Pau Chung Street, To Kwa Wan, Kowloon in close proximity to the MTR To Kwa Wan station. It provides 76 residential units with commercial shops on the ground and first floors covering a total gross floor area of approximately 31,000 square feet. Pre-sales commenced in June 2023 and it was well received by the market with all the residential units being sold. During the year under review, around 32% (in terms of units) of the residential units were handed over to the buyers with related revenue recognised in FY 2025/26 and the remaining sold residential units were also handed over to the buyers subsequently.

The Grand Marine (100% owned)

This residential development project, located at No. 18 Sai Shan Road, Tsing Yi, the New Territories, was completed in March 2022 and offered 776 units with a total gross floor area of approximately 400,000 square feet. Pre-sales commenced in late 2019. Market response was overwhelming with all typical units being sold and only a few special units remain available for sale. During the year under review, four of the special units were sold and one was handed over to the buyer, with the related revenue recognised in FY 2025/26. The remaining sold residential units were also handed over to the buyers subsequently.

North Point project (100% owned)

This project comprises two sites located at No. 66 Fort Street and No. 57 Kin Wah Street, North Point, Hong Kong, with an aggregate gross floor area of approximately 30,000 square feet. The site at No. 57 Kin Wah Street will be developed into a 27-storey residential tower, whilst the site at No. 66 Fort Street will be developed into a single-storey commercial shop. Foundation works have been completed and the project is expected to be completed in or around the first half of 2027.

業務回顧

物業發展－香港

「北映薈」(佔100%權益)

此項目位於新界粉嶺聯發街1號，正發展為一幢17層高的住宅及商業大樓，並設有兩層地下停車場。該項目提供90個住宅單位，連同商業店舖，總樓面面積約36,000平方呎。項目發展已於二零二五年十二月竣工。於回顧年內，住宅單位開始預售，市場反應熱烈，所有住宅單位均已售出，且其中約99%（按單位數目計算）已交付予買家，相關收益已於2025/26年度確認。餘下已售出住宅單位亦於其後交付予買家。

「明雋」(佔100%權益)

此商住項目位於九龍土瓜灣炮仗街45號，鄰近土瓜灣港鐵站，提供76個住宅單位，地下及一樓設有商舖，總樓面面積合計約31,000平方呎。預售期於二零二三年六月開始，市場反應踴躍，全部住宅單位均已售出。回顧年內約32%住宅單位（就數目而言）已交付予買家，相關收益於2025/26年度確認。餘下已售出住宅單位亦於其後交付予買家。

「明翹匯」(佔100%權益)

此住宅發展項目位於新界青衣細山路18號，於二零二二年三月竣工，提供776個住宅單位，總樓面面積約400,000平方呎。預售於二零一九年底開始，項目備受市場追捧，所有標準單位經已售出，僅餘少量特色單位待售。於回顧年內，售出四個特色單位，並已向買家交付其中一個單位，相關收益於2025/26年度確認。餘下已售住宅單位亦已於其後交付予買家。

北角項目(佔100%權益)

此項目包括位於香港北角堡壘街66號和建華街57號兩個地塊，合計總樓面面積約30,000平方呎。位於建華街57號之地盤將發展為一幢27層高的住宅大廈，而堡壘街66號之地盤將發展為一個單層商舖。地基工程經已完成，項目預計於二零二七年上半年或前後完成。

Cristallo (100% owned)

This luxury residential project, situated at No. 279 Prince's Road West, Kowloon, was well received in the market with 16 out of the total of 18 units sold cumulatively. During the year under review, one apartment was sold and was handed over to buyers, with the related revenue recognised in FY 2025/26.

Property Development – Mainland China

The Group's development project in the Mainland China is located at Guangxi-ASEAN Economic and Technological Development Zone, Wuming District, Nanning City, Guangxi Province with a gross floor area of approximately 1,435,000 square feet. It will be developed into a luxury residential project under the theme of leisure and healthy lifestyle, comprising high-rise apartments and villas complemented by commercial and a wellness centre facility. Target customers will be the elderly and retirees and their families. Superstructure works of the highrise apartments and basement construction works for the remaining part of the site are now underway. In response to the continued softness in the Mainland China property market, the Group has decided to extend the construction timeline in anticipation of a market recovery. This approach allows the Group to conserve cash and resume at a time that maximises pricing. The development is expected to extend the completion to around mid of 2027.

Data Centre Premises Leasing

The Group currently owns two data centres, namely iTech Tower 1 and iTech Tower 2. Revenue from its leasing business recorded a decrease by 17.4% year-on-year to HK\$226.5 million, (FY 2024/25: HK\$274.3 million) primarily due to the expiry of a data centre lease during the year under review.

Construction works of the two new data centres in Fanling, the New Territories, namely iTech Tower 3.1 and iTech Tower 3.2, are progressing well. For iTech Tower 3.1, installation of the electrical and mechanical equipment and internal fitting out works are now underway. This data centre delivered its first two phases in December 2025 and recorded HK\$21.5 million in revenue during the year under review. For iTech Tower 3.2, superstructure works are now underway. This development is expected to be completed in phases starting from 2027.

「明寓」(佔100%權益)

此位於九龍太子道西279號之高檔住宅項目銷售理想。項目共18個單位中已累計售出16個。於回顧年內，一個已售出住宅單位已交付予買家，相關收益於2025/26年度確認。

物業發展－中國內地

本集團在中國內地之發展項目位於廣西省南寧市武鳴區廣西－東盟經濟技術開發區，總樓面面積約1,435,000平方呎，將發展為以休閒和健康生活為主題的高檔住宅項目，包括高層公寓、別墅，兼備有商業及康養中心設施，目標客戶將為銀齡和退休人士以及其家屬。高層公寓的上蓋工程及地盤其餘部分的地庫工程現正進行中。因應中國內地房地產市場持續疲弱，本集團決定延長建設時間表，以等待市場復甦。此舉有助本集團節省現金，並在價格最有利時恢復施工。該發展項目預計將完工日期延後至2027年年中左右。

數據中心物業租賃

本集團現時擁有iTech Tower 1及iTech Tower 2兩座數據中心，其租賃業務的收益按年減少17.4%至2.265億港元（2024/25年度：2.743億港元）。主要由於一項數據中心租約於回顧年內屆滿所致。

位於新界粉嶺兩座新數據中心iTech Tower 3.1及iTech Tower 3.2工程進展順利。iTech Tower 3.1的機電設備安裝及內部裝修工程現正進行中。該數據中心的首兩期已於二零二五年十二月交付予租客，並於回顧年內錄得2,150萬港元收益。iTech Tower 3.2的上蓋工程現正進行中，該發展預計於二零二七年起分階段落成。

On 6 January 2026, the Group received an exclusivity agreement and a letter of intent from a potential purchaser regarding the acquisition of two properties in the New Territories, Hong Kong (collectively “**Target Properties**”). The Target Properties are currently owned by Regal Development Limited and Golden Ford Limited, both wholly-owned subsidiaries of the Company. Both the exclusivity agreement and the letter of intent were extended before expiry and have been further extended on 15 June 2026 with the latest expiry date on 3 August 2026. For further details, please refer to the announcements of the Company dated 6 January 2026.

Construction

The Group's construction business consists of the provision of building services as a main contractor in property development projects, as well as the provision of existing building alterations, renovation and fitting-out works services for prominent local developers, public institutions and the Group's companies. As at 31 March 2026, the Group held contracts (inclusive of external customers and the Group's companies) with an aggregate value of approximately HK\$2.05 billion.

OUTLOOK

The current economic landscape remains challenging and highly volatile. While geopolitical tensions and global inflation are easing and the domestic real estate market continues to stabilise, these elements continue to pose considerable uncertainties in the economic outlook. Despite these uncertainties, we remain cautiously optimistic about the medium- to long-term prospects of the property markets in Hong Kong. The Group will focus on the completion and delivery of its current development projects. Besides, we closely monitor the market changes and continue to market the remaining units of The Grand Marine and Cristallo. We also relentlessly focus on managing the Group's financial resources and position, including cash flow generation from our daily operations and the gearing level. In parallel, we will explore refinancing opportunities that will enhance the Group's financial position to pursue a long-term sustainable growth and development. Meanwhile, our development of the North Point Project continues and is expected that the pre-sale of the project and handing over to buyers will commence in the next financial year.

於二零二六年一月六日，本集團接獲一名潛在買家就收購位於香港新界兩項物業（統稱「**目標物業**」）的獨家交易協議及意向書。目標物業目前由本公司兩間全資附屬公司，悅基發展有限公司及金達富有限公司擁有。獨家交易協議及意向書均已在到期前獲得延期，並於二零二六年六月十五日再次延期至最新到期日為二零二六年八月三日。進一步詳情請參閱本公司日期為二零二六年一月六日的公佈。

建築

本集團的建築業務包括以物業發展項目主承建商身份為本地知名發展商、公營機構及本集團之公司提供樓宇建造服務，及為現有樓宇提供改建、翻新及裝修工程。於二零二六年三月三十一日，本集團持有之合約（包括外部客戶及本集團公司）總價值約20.5億港元。

展望

當前經濟格局仍持續充滿挑戰且高度不穩。即使地緣政治緊張局勢及全球通脹正逐步緩和，且本地房地產市場持續穩定，但該些因素對經濟前景仍存在相當大的不確定性。儘管存在各種不明朗狀況，我們對香港房地產市場的中長期前景仍保持審慎樂觀。本集團將專注完成和交付現有發展項目。此外，我們密切關注市場變化，繼續推售「明翹匯」和「明寓」剩餘的單位。我們竭力管理本集團的財務資源及狀況，包括日常業務產生的現金流與資本負債水平，同時探索可以改善本集團財務狀況的再融資機會，以進一步提升本集團的財務狀況，以尋求長遠持續增長和發展。與此同時，我們已開展北角項目的發展，預期該項目將於下個財政年度預售及交付予買家。

On the other hand, we are actively evaluating and pursuing all viable strategies to deleverage the Group's balance sheet, enhance its working capital and reinforce long term financial stability. On 6 January 2026, the Group received an exclusivity agreement and a letter of intent dated 5 January 2026 from a potential purchaser regarding the Target Properties. The Target Properties are currently owned by Regal Development Limited and Golden Ford Limited, respectively, both of which are wholly-owned subsidiaries of the Company. Both the exclusivity agreement and the letter of intent were extended before expiry and have been further extended on 15 June 2026 with the latest expiry date on 3 August 2026. Further details are disclosed in the Company's announcement dated 6 January 2026. While this transaction is subject to further negotiation and execution of a definitive agreement, the Directors believe that if materialised, the disposal would generate net proceeds that would reduce the Group's overall indebtedness.

Operationally, our commitment to our customers remains unwavering. We are working closely with our customer to ensure fulfilment of delivery commitments for iTech Tower 3.1. Simultaneously, discussions with potential customers for iTech Tower 3.2 leasing continued. For our established iTech Tower 1 and 2, we maintain our steadfast commitment to providing dependable services and support to our customers, including ongoing maintenance and upgrades of all critical infrastructure to ensure our facilities continue to meet evolving technological advancements.

I would like to take this opportunity to express my gratitude to the Board for its brilliant leadership, to the Shareholders for their strong support, and to the community for their enthusiastic help, and last but not least, to our staff for their dedicated efforts.

另一方面，本集團正積極評估及推行各種可行策略，以降低資產負債表的槓桿水平、提升營運資金並加強長期財務穩定性。於二零二六年一月六日，本集團接獲一名潛在買家就收購目標物業發出日期為二零二六年一月五日的獨家交易協議及意向書。目標物業目前分別由悅基發展有限公司及金達富有限公司擁有，該兩間公司均為本公司的全資附屬公司。獨家交易協議及意向書均在到期前獲得延期，並於二零二六年六月十五日再次延期至最新到期日為二零二六年八月三日。進一步詳情載於本公司日期為二零二六年一月六日的公佈。雖然該交易須待進一步談判及簽署正式協議後方可作實，惟董事相信，倘落實，出售事項產生所得款項淨額將使本集團減少其整體負債。

在營運方面，我們對客戶的承諾始終堅定不移。我們正與客戶緊密合作，以確保順利交付iTech Tower 3.1的承諾。同時，與潛在客戶就iTech Tower 3.2的租賃事宜持續進行磋商。至於已落成的iTech Tower 1及2，我們堅守為客戶提供可靠服務及支援，包括對所有關鍵基礎設施的維護及升級，以確保設施能夠不斷符合科技發展的最新要求。

MANAGEMENT DISCUSSION AND ANALYSIS

管理層討論及分析

FINANCIAL REVIEW

In FY 2025/26, the Group's consolidated revenue amounted to HK\$868.4 million (FY 2024/25: HK\$1,145.8 million), representing a decrease of 24.2% as compared to FY 2024/25. The consolidated gross profit decreased 83.9% to HK\$53.7 million (FY 2024/25: HK\$332.7 million). The decrease in revenue and gross profit were mainly attributable to a substantial decrease in the area of residential properties delivered and expiry of a data centre lease during the year under review. The gross profit margin also decreased due to write-down of inventories of properties of HK\$45.4 million recognised as the direct costs during the year under the current unfavourable property market in Hong Kong.

Included in the "Other income and gain/(losses), net" was an impairment loss on the property held for own use of HK\$31.0 million, reflecting the current adverse market conditions in the commercial property market.

Operating expenses (inclusive of selling and general and administrative expenses) for the year decreased by 52.4% to HK\$165.5 million (FY 2024/25: HK\$347.6 million), largely because of less property agency commission incurred in relation to decrease in sales of properties.

An unrealised fair value loss on investment properties and investment properties under development of HK\$111.5 million (FY 2024/25: HK\$120.7 million) was recognised in FY 2025/26. The change in fair value was affected by the adjusted future rental income projection derived from the existing tenancies.

Finance costs for the year increased by 11.4% to HK\$107.8 million (FY 2024/25: HK\$96.8 million), primarily due to increase in average interest rate to the bank and other loans and decreased capitalisation in interest to the property development projects during the year.

The Group recorded a net loss of HK\$349.5 million for FY 2025/26, as compared to a net loss of HK\$292.1 million for FY 2024/25. The increase was mainly attributable to a substantial decrease in the area of residential properties delivered and the expiry of a data centre lease, partly offset by a decrease in selling expenses as a result of reduced revenue from sales of properties as aforesaid. Excluding the change in fair value of investment properties, the Group recorded an underlying loss of HK\$238.0 million in FY 2025/26 (FY 2024/25: HK\$171.4 million).

財務回顧

本集團於2025/26年度的綜合收益為8.684億港元(2024/25年度：11.458億港元)，較2024/25年度下跌24.2%。綜合毛利亦減少83.9%至5,370萬港元(2024/25年度：3.327億港元)。收益及毛利減少主要由於回顧年內，交付的住宅物業面積大幅減少以及一項數據中心租約屆滿。毛利率亦有所下降，乃由於在當前香港不利的物業市場下，於年度內確認為直接成本的物業存貨減值4,540萬港元所致。

計入「其他收入及收益／(虧損)淨額」內包括3,100萬港元自用物業的減值虧損，反映了當前商業物業市場的不利市場狀況。

年內營運開支(包括銷售以及一般及行政開支)減少52.4%至1.655億港元(2024/25年度：3.476億港元)，主要由於銷售物業的數量減少令銷售佣金支出亦減少。

於2025/26年度確認之投資物業及發展中投資物業之未實現公平值虧損為1.115億港元(2024/25年度：1.207億港元)。公平值的變動受到現有租約所得的未來租金收入預測的影響。

年內財務成本增加11.4%至1.078億港元(2024/25年度：9,680萬港元)，主要由於年內銀行及其他貸款的平均利率上升，且物業發展項目的利息資本化減少所致。

本集團於2025/26年度錄得淨虧損3.495億港元，(2024/25年度：2.921億港元)。該增幅主要由於交付的住宅物業面積大幅減少以及一項數據中心租約屆滿，惟部分被上述物業銷售收益減少導致銷售開支減少所抵銷。撇除投資物業公平值變動，本集團於2025/26年度錄得基礎虧損2.380億港元(2024/25年度：1.714億港元)。

LIQUIDITY AND FINANCIAL RESOURCES

The Group finances its operations and capital expenditure with internally generated cash flows and through bank borrowings. A variety of credit facilities are maintained which had contracted repayment terms ranging from repayable on demand to about 15.5 years. As at 31 March 2026, the Group had outstanding bank and other loans of approximately HK\$5,401 million (31 March 2025: approximately HK\$5,229 million), all of which were denominated in Hong Kong dollars.

Apart from bank borrowings, there were loans due to Chan HM Company Limited (the Company's ultimate holding company) and Mr. Chan Hung Ming (the chairman and executive director, and controlling shareholder of the Company) amounted to HK\$36.8 million and HK\$544.3 million as at 31 March 2026, respectively. The loan due to Chan HM Company Limited is unsecured, bears interest at the best lending rate for Hong Kong dollars per annum from time to time as quoted by HSBC, and was originally due to mature in late December 2026. During the year, the ultimate holding company has agreed to extend the repayment date from December 2026 to on or before December 2027. Loans obtained from Mr. Chan Hung Ming are unsecured, bears interest at a rate of 3% per annum and are due to mature in April to May 2028. Such loan transactions constituted connected transactions under Chapter 14A of the Listing Rules but are fully exempted from the reporting, announcement, and independent shareholders' approval requirements pursuant to the Listing Rules, because they are conducted on normal commercial terms or better and are not secured by the assets of the Group.

The aforesaid loans from the Company's ultimate holding company and controlling shareholder were used for supplementing the Group's working capital and settling expenditure incurred in the ordinary course of business.

As at 31 March 2026, the Group's gearing ratio (defined as total interest-bearing borrowings divided by shareholders' equity) of the Group was approximately 251.8% (31 March 2025 approximately 213.6%). The current ratio (defined as current assets divided by current liabilities) was 0.22 times (31 March 2025: 0.32 times).

The Group had cash and bank balances (including restricted and pledged deposits) of approximately HK\$159.5 million (31 March 2025: approximately HK\$180.2 million). The cash and bank balances were denominated in Hong Kong dollars and Renminbi. Taking into account the cash generated from operating activities and the available credit facilities from banks and controlling shareholder, the Directors considered that the Group has sufficient working capital for its liquidity requirement.

流動資金及財務資源

本集團透過內部產生的現金流量及銀行貸款撥付營運資金和資本支出。本集團設有多項信貸融資，約定還款期介乎按要求償還至15.5年。於二零二六年三月三十一日，本集團有未償還銀行及其他貸款約54.01億港元（二零二五年三月三十一日：約52.29億港元），全部貸款均為港元。

除銀行貸款外，於二零二六年三月三十一日，尚有貸款應付予Chan HM Company Limited（本公司最終控股公司）及陳孔明先生（本公司主席兼執行董事及控股股東）分別為3,680萬港元及5.443億港元。應付予Chan HM Company Limited之貸款為無抵押，以香港上海匯豐銀行不時公佈的最優惠港元貸款年利率計息，原定於二零二六年十二月底到期。於年內，最終控股公司已同意將還款日期由二零二六年十二月延長至二零二七年十二月或之前償還。向陳孔明先生取得的貸款為無抵押，按年利率3%計息，並於二零二八年四月至五月到期。該等貸款交易根據上市規則第14A章構成關連交易，但根據上市規則獲全面豁免申報、公告及獨立股東批准之規定，因為該等交易乃按正常商業條款或更佳條款進行，且並無以本集團資產作抵押。

上述本公司最終控股公司及控股股東的借款用於補充本集團營運資金及結算正常業務中所發生的支出。

於二零二六年三月三十一日，本集團的資本負債比率（計息借款總額除以股東權益）約251.8%（二零二五年三月三十一日：約213.6%）。流動比率（定義為流動資產除以流動負債）為0.22倍（二零二五年三月三十一日：0.32倍）。

本集團的現金及銀行結餘（包括受限制及已抵押存款）約1.595億港元（二零二五年三月三十一日：約1.802億港元）。現金及銀行結餘以港元及人民幣計值。經計及經營活動產生的現金，以及銀行及控股股東現有可用之信貸額度，董事認為本集團具備足夠營運資金應付其流動資金需求。

INTEREST RATE RISK

The Group's interest rate risk arises primarily from bank borrowings, which bear interest at floating rates. The Group had in place a treasury policy by which the exposure to floating interest rate risk was mitigated by the use of interest rate swaps. As at 31 March 2026, the Group had outstanding interest rate swaps with notional amount of approximately HK\$950 million. These swaps have fixed interest rates ranging from 2.85% to 3.67% per annum and will mature between May 2027 to April 2029.

FOREIGN CURRENCY RISK

The Directors consider that the Group's foreign currency risk is insignificant as substantially all of the Group's transactions are denominated in Hong Kong dollars. The Group has not implemented any foreign currency hedging policy at the moment. However, the management monitors the Group's foreign exchange exposure closely and may consider adopting foreign currency hedging policy in the future depending on the circumstances and the trend of foreign currency.

CHARGE ON ASSETS

As at 31 March 2026, certain assets of the Group with an aggregate carrying amount of approximately HK\$8,285 million were pledged to secure bank and other loans of approximately HK\$5,373 million granted to the Group.

EVENTS AFTER THE REPORTING PERIOD

Save as disclosed in note 37 to the consolidated financial statements, there were no other significant events after the reporting period up to the date of this report.

CAPITAL COMMITMENTS

Save as disclosed in note 31 to the consolidated financial statements, the Group had no other capital commitments as at 31 March 2026.

CONTINGENT LIABILITIES

The Group did not have any material contingent liabilities as at 31 March 2026 and 2025.

MATERIAL ACQUISITIONS AND DISPOSALS OF SUBSIDIARIES AND ASSOCIATED COMPANIES

There was no material acquisition or disposal of subsidiaries and associated companies by the Company during FY 2025/26.

利率風險

資產抵押

於二零二六年三月三十一日，本集團若干合計賬面值約82.85億港元的資產已予抵押，用作擔保本集團約53.73億港元的銀行及其他貸款。

The Group had a total of 157 employees as at 31 March 2026. Total remuneration of employees for FY 2025/26 was approximately HK\$121.8 million. The remuneration policy and packages of the Group's employees are periodically reviewed by making reference to the prevailing market conditions. The components of remuneration packages consist of basic salary, benefits-in-kind, fringe benefits and contributions to mandatory provident funds, discretionary bonuses which are determined according to individual performance of employees. The Group also put in place share option scheme and share award plan for the purpose of retaining, motivating and rewarding the employees.

SIGNIFICANT INVESTMENTS HELD

Except for investments in subsidiaries, the Group did not hold any significant investment in equity interest in any other company during FY 2025/26.

FUTURE PLANS FOR MATERIAL INVESTMENTS AND CAPITAL ASSETS

As at the date of this annual report, the Group did not enter into any agreement in respect of any proposed acquisitions and did not have any future plans relating to material investment or capital assets.

The Board may declare or propose payment of dividends after taking into account a number of factors, including the results of operations, financial conditions, working capital, capital requirement and other factors the Board may deem relevant.

The Company currently, subject to the factors and considerations above, pays dividends twice a year in the form of interim and final dividends. Cash dividends will be paid in Hong Kong dollars. Other distributions, if any, will be paid to Shareholders by any means which the Directors deem legal, fair and practicable.

The Group also pays efforts to build up and maintain good relationships with various commercial banks as the Group's businesses are capital intensive and require on-going funding to maintain continuous growth.

Green office practices are also encouraged in the operation of the Group's businesses, such as double-sided printing and copying, setting up recycling bins, sending and presenting corporate documents or information to the members of the Board in electronic format, and reducing energy consumption by switching off idle lighting and electrical appliances.

DIRECTORS' AND SENIOR MANAGEMENT'S REMUNERATION POLICY

The Directors' remuneration policy comprises primarily a fixed component (in the form of a base salary) and a variable component (which includes discretionary bonus and other merit payments), considering other factors such as their experience, level of responsibility, individual performance, the profit performance of the Group and with reference to market terms.

The remuneration committee of the Company ("**Remuneration Committee**") will meet at least once for each year to discuss remuneration related matters (including the remuneration of Directors and senior management) and review the Group's remuneration policy. It has been decided that Remuneration Committee would make recommendations to the Board on the remuneration packages of individual executive Directors and senior management.

NON-COMPETITION UNDERTAKING BY CONTROLLING SHAREHOLDERS

The Controlling Shareholders had confirmed to the Company of each of their compliance with the non-competition undertakings provided to the Company under the Deed of Non-Competition (as defined in the prospectus of the Company dated 30 July 2013). The independent non-executive Directors have reviewed the status of compliance and confirmed that all the undertakings under the Deed of Non-Competition have been complied with by the Controlling Shareholders.

PENSION SCHEMES

The Group operates a Mandatory Provident Fund Scheme ("**MPF Scheme**") for all its qualifying employees in Hong Kong. Under the rules of the MPF Scheme, the employer and its employees are each required to make contributions to the scheme at rates specified in the rules, and contributions are charged to profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in trustee administered funds independently. There are no forfeited contributions for the MPF Scheme as the Group's employer contributions vest fully with the employees when contributed into the MPF Scheme.

The employees of the Group's subsidiaries which operate in the PRC are required to participate in a central pension scheme (the "**PRC Pension Scheme**") operated by the local municipal government. These subsidiaries are required to contribute a certain percentage of their payroll costs to the PRC Pension Scheme. The contributions are charged to profit or loss as they become payable in accordance with the rules of the PRC Pension Scheme. Under the PRC Pension Scheme, no forfeited contributions will be used by the employers to reduce the existing level of contributions.

COMMITMENT TO CORPORATE GOVERNANCE

The Company acknowledges the importance of good corporate governance practices and procedures, and regards a pre-eminent board of directors, sound internal controls and accountability to all Shareholders as the core elements of its corporate governance principles. The Company endeavours to ensure that its businesses are conducted in accordance with rules and regulations, and applicable codes and standards.

CORPORATE GOVERNANCE CODE

The Company has applied the principles as set out in “Part 2 - Principles of good corporate governance, code provisions and recommended best practices” of the CG Code. In the opinion of the Directors, the Company has complied with all the applicable code provisions as set out in the CG Code throughout FY 2025/26.

BOARD OF DIRECTORS

1. Responsibilities of the Board

The Board is primarily responsible for management of the Group, including the responsibilities of formulating business strategies, directing and monitoring the Group's development. Apart from its statutory responsibilities, the Board is also required to approve the Group's strategic development plan and major investments; review the Group's financial performance; identify principal risks of the Group's business and ensure adequate systems of risk management and internal control. The Board also delegates certain responsibilities to various board committees which have been established by the Board to deal with different aspects of the Company's affairs.

The day-to-day operations and administration are delegated to the management of the Group under the leadership of the executive Directors.

The biographical details of the Directors are set out on pages 34 to 37 of this annual report. There is no financial, business, family or other material/relevant relationship among members of the Board. A list of Directors and their roles and functions has been published on the Company's website.

When identifying suitable candidates for directorship, the Nomination Committee will carry out the selection process by making reference to the skills, experience, education background, professional knowledge, personal integrity and time commitments of the proposed candidates, and also the Company's needs and other relevant statutory requirements and regulations required for the positions. All candidates must be able to meet the standards as set forth in Rules 3.08 and 3.09 of the Listing Rules. A candidate who is to be appointed as an independent non-executive Director should also meet the independence criteria set out in Rule 3.13 of the Listing Rules. Qualified candidates will then be recommended to the Board for approval.

The Board comprises Directors with diverse backgrounds and/or extensive expertise in corporate management, with over 50% of the Directors possessing professional qualifications.

3. Board and Workforce Diversity

The Board has adopted a board diversity policy with the aim of achieving diversity on the Board. The Company recognises the benefits of having a diverse Board, and sees diversity of perspectives at the Board level as essential in achieving a sustainable and balanced development. In designing the Board's composition, board diversity has been considered from a number of aspects, including but not limited to gender, age, educational background, professional experience, skills, knowledge, industry experience and expertise. All Board appointments are based on meritocracy, and candidates will be considered against a variety of criteria, having due regard for the benefits of diversity on the Board.

Currently, the Board has one female director out of seven directors. The Board strives to enhancing gender diversity as and when suitable candidates are identified. The Group advocates a diversified and inclusive workplace, and adheres to the concept of gender equality, and guarantees equal employment opportunities for female employees. As at 31 March 2026, 74% of the Group's employees (including Directors and senior management) were male and 26% were female. The Company considers that gender diversity in respect of the Board and the Group's workforce has been achieved.

董事會由具備多元背景及／或豐富企業管理專業知識的董事組成，逾半董事具備專業資歷。

3. 董事會及員工多元化

董事會已採納董事會多元化政策，務求令董事會更具多元化。本公司確認並深信董事會成員多元化裨益良多，且將董事會層面之多元化視作達致可持續均衡發展的關鍵元素。本公司在設定董事會成員組合時，會從多個方面考慮董事會成員多元化，包括但不限於性別、年齡、教育背景、專業經驗、技能、知識、行業經驗及專門知識。董事會所有委任均以用人唯才為原則，並在考慮人選時以各種標準充分顧及董事會成員多元化的裨益。

目前董事會七名董事中有一名為女性董事。董事會致力物色適當候選人推動性別多元化。本集團提倡多元化及包容的工作場所，並堅持性別平等的理念，保證女性員工獲得平等的應聘機會。於二零二六年三月三十一日，本集團員工（包括董事及高級管理人員）中，男性佔74%及女性佔26%。本公司認為董事會及本集團工作團隊已達至性別多元化。

All the independent non-executive directors are appointed for a specific term of three years and are required to retire by rotation and eligible for re-election at the Company's annual general meeting. The Company has received, from each of the independent non-executive directors, an annual confirmation of his independence pursuant to Rule 3.13 of the Listing Rules. The Company considers that all independent non-executive directors are independent.

The Company has complied with Rule 3.10(1) of the Listing Rules and met the requirement of Rule 3.10A of the Listing Rules of at least one-third of the members of the Board being independent non-executive directors. In addition, Mr. Ho Chiu Yin Ivan, one of the independent non-executive directors, has the appropriate professional qualifications, or accounting or related financial management expertise as required under Rule 3.10(2) of the Listing Rules.

4. Mechanism ensuring sufficient independent views to the Board

The Board recognises Board independence is critical to good corporate governance. The Company has put in place the mechanisms to ensure a strong independence element on the Board, which are summarised below:

Board Composition

The Board endeavours to ensure the appointment of at least three independent non-executive directors and at least one-third of the Board members being independent non-executive directors (or such higher threshold as may be required by the Listing Rules from time to time)

Independence Assessment

The Nomination Committee shall strictly adhere to the nomination policy and the independence assessment criteria as set out in the Listing Rules with regard to the nomination and appointment of independent non-executive directors.

Each independent non-executive director is also required to inform the Company as soon as practicable if there is any change in his own personal particulars that may materially affect his independence.

The Nomination Committee is mandated to assess annually the independence of all independent non-executive directors by reference to the independence criteria as set out in the Listing Rules to ensure that they can continually exercise independent judgement.

All Directors (including independent non-executive directors) are entitled to seek further information and documentation from the management on the matters to be discussed at board meetings. They can also seek assistance from the Company's company secretary and, where necessary, independent advice from external professional advisers at the Company's expense.

All Directors (including independent non-executive directors) shall not vote or be counted in the quorum on any board resolution approving any contract or arrangement in which such director or any of his close associates has a material interest.

The Board had made an annual review on the implementation of the abovementioned mechanisms and was of the view that the abovementioned mechanisms had been satisfactorily implemented.

5. Board and Board Committee Meetings

The Company has received confirmation from each Director that he had sufficient time and attention to the affairs of the Company for the year. The Directors have disclosed to the Company the number and nature of offices they held in Hong Kong or overseas listed public companies or organisations and other significant commitments, with the identity of the public companies and organisations and an indication of the time involved. They are reminded to notify the Company in a timely manner of any changes of such information. All Directors are encouraged to attend the Board meeting and board committee meeting in person. Code provision C.2.1 of the CG Code stipulates that the roles of chairman and chief executive officer should be separate and should not be performed by the same individual.

The chairman and the chief executive officer are currently two separate positions held by Mr. Chan Hung Ming and Mr. Lau Chi Wah respectively with clear distinction in responsibilities.

Mr. Chan Hung Ming, being the chairman, is responsible for the management and leadership of the Board to formulate overall strategies and business development directions for the Group, to ensure that adequate, complete and reliable information is provided to all Directors in a timely manner, and to ensure that the issues raised at the Board meetings are explained appropriately.

Mr. Lau Chi Wah, being the chief executive officer, is responsible for the daily operations of the Group and the implementation of business policies, objectives and plans as formulated and adopted by the Board, and is accountable to the Board for the overall operation of the Group.

CORPORATE GOVERNANCE FUNCTIONS

The Board is responsible for performing the corporate governance duties. Given below are the main corporate governance duties of the Board:

- (i) to develop and review the Company's policies and practices on corporate governance;
- (ii) to review and monitor the training and continuous professional development of the Directors and senior management of the Company;
- (iii) to review and monitor the Company's policies and practices on compliance with legal and regulatory requirements;
- (iv) to develop, review and monitor the code of conduct and compliance manual (if any) applicable to employees of the Group and the Directors; and
- (v) to review the Company's compliance with the CG Code and disclosure in the corporate governance report.

The Board had reviewed the corporate governance matters of the Company for FY 2025/26. The Company had complied with the principles and applicable code provisions of the CG Code.

BOARD COMMITTEES

The Board has established three committees, namely, the Remuneration Committee, Audit Committee and Nomination Committee, for overseeing particular aspects of the Group's affairs and discharging its functions. Sufficient resources are provided to enable the Board committees to undertake their specific role.

1. Remuneration Committee

The Company established the Remuneration Committee on 23 July 2013 with written terms of reference in compliance with the Listing Rules. The terms of reference of the Remuneration Committee are available on the website of the Company and the Stock Exchange. The Remuneration Committee consists of all four independent non-executive directors. The current members are Mr. Tsui Ka Wah (chairperson), Mr. Kan Yau Wo, Mr. Ho Chiu Yin Ivan and Mr. Lee Chung Yiu Johnny.

The primary duties of the Remuneration Committee include, among others, (i) making recommendation to the Board on the remuneration policy and structure for Directors and senior management; (ii) reviewing and approving the management's remuneration proposals with reference to the Board's corporate goal and objective; (iii) making recommendation to the Board on the remuneration packages of executive directors and senior management and remuneration of non-executive directors; and (iv) ensuring none of the Directors determine their own remuneration.

During FY 2025/26, the Remuneration Committee held one meeting. The work of the Remuneration Committee included:

- (i) reviewed the remuneration policy and structure of Directors and senior management;
- (ii) reviewed and recommended the annual emoluments of Directors to the Board for approval; and
- (iii) assessed the performance of executive directors, reviewed and recommended the annual bonus for executive directors to the Board for approval.

Details of remuneration of Directors are set out in note 11 to the consolidated financial statements.

2. Audit Committee

The Company established the Audit Committee on 23 July 2013 with written terms of reference in compliance with the Listing Rules. The terms of reference of the Audit Committee are available on the websites of the Company and the Stock Exchange. The Audit Committee consists of all four independent non-executive directors. The current members are Mr. Ho Chiu Yin Ivan (chairperson), Mr. Tsui Ka Wah, Mr. Kan Yau Wo and Mr. Lee Chung Yiu Johnny. Mr. Ho holds the appropriate professional qualifications as required under Rules 3.10(2) and 3.21 of the Listing Rules.

The primary duties of the Audit Committee include, among others, (i) making recommendation to the Board on the appointment, re-appointment and removal of external auditors; (ii) reviewing the financial statements, risk management and internal control systems; and (iii) overseeing the financial reporting and the effectiveness of the internal control procedures.

During FY 2025/26, the Audit Committee held two meetings. The work of the Audit Committee included:

- (i) reviewed the audited financial statements and annual results announcement for the year ended 31 March 2025;
- (ii) reviewed the unaudited financial statements and interim results announcement for the six months ended 30 September 2025; and
- (iii) reviewed the adequacy and effectiveness of the Group's internal audit function, as well as the risk management and internal controls system.

The Group's audited financial statements and annual results announcement for FY 2025/26 were reviewed by the Audit Committee on 30 June 2026.

The committee members also met in separate session with the external auditor without the presence of executive directors.

3. Nomination Committee

The Company established the Nomination Committee on 23 July 2013 with written terms of reference in compliance with the Listing Rules. The terms of reference of the Nomination Committee are available on the websites of the Company and the Stock Exchange. The Nomination Committee consists of all four independent non-executive directors and one executive director. The current members are Mr. Kan Yau Wo (chairperson), Mr. Tsui Ka Wah, Mr. Ho Chiu Yin Ivan, Mr. Lee Chung Yiu Johnny and Ms. Chan Pui Yin Apple.

The primary duties of the Nomination Committee are to review the structure, size and composition of the Board on regular basis; to identify individuals suitably qualified to become Board members; to assess the independence of independent non-executive directors; and to make recommendations to the Board on the appointment or re-appointment of Directors. In assessing the suitability of a proposed candidate for directorship, the Board will take into account the candidate's qualification (including professional qualifications, skill and knowledge), experience in relation to the Group's businesses and potential contribution that can bring to the Company.

During FY 2025/26, the Nomination Committee held one meeting. The work of the Nomination Committee included:

- (i) reviewed the size, composition and diversity of the Board;
- (ii) assessed the independence of the independent non-executive directors;
- (iii) assessed each director's time commitment and contribution to the board, as well as the director's ability to discharge his or her responsibilities effectively, taking into account professional qualifications and work experience, existing directorships in other listed companies and other significant external time commitments of such director, and other factors or circumstances relevant to the director's character, integrity, independence and experience; and
- (iv) made recommendation to the Board on the re-election of Directors at the annual general meeting.

DIRECTORS' SECURITIES TRANSACTIONS

The Company has adopted the Model Code as set out in Appendix C3 to the Listing Rules as its code of conduct regarding Directors' securities transactions. Having made specific enquiries to all Directors by the Company, all Directors confirmed their compliance with the required standard set out in the Model Code throughout FY 2025/26.

FINANCIAL REPORTING

The Directors acknowledge that it is their responsibility to prepare the financial statements that give a true and fair view of the Group's financial position and of its financial performance and cash flow in accordance with Hong Kong Financial Reporting Standards, the Companies Ordinance (Chapter 622 of the Laws of Hong Kong) and the applicable disclosures provisions of the Listing Rules. The management provides information and explanation to the Board to enable it to make an informed assessment of the financial and other decisions by the Board. Accordingly, appropriate accounting policies are selected and applied consistently, and judgements and estimates made by the management for financial reporting purpose are prudent and reasonable.

The responsibilities of the external auditor for the consolidated financial statements of the Group are set out in the Independent Auditor's Report on pages 53 to 60 of this annual report.

AUDITOR'S REMUNERATION

The remuneration in respect of audit and non-audit services provided by the Company's external auditor to the Group for FY 2025/26 are approximately HK\$1,381,000 (FY 2024/25: HK\$1,453,000) and HK\$25,000 (FY 2024/25: HK\$25,000) respectively. The non-audit services primarily include review of the Company's preliminary result announcement.

RISK MANAGEMENT AND INTERNAL CONTROLS

The Board has the overall responsibility for maintaining a sound and effective system of internal controls and risk management within the Group, and reviewing its operational adequacy and effectiveness through the Audit Committee.

The Board has identified the top risks of the Group and determined how much risk the Board is willing to take to achieve the Group's strategic objectives. The Group's risk management structure matches with the "Three Lines of Defense" model. Each business unit assumes risk management responsibilities as the first line of defense. The middle and back offices, including finance and accounting, company secretarial and human resources departments, set up relevant internal control and management procedures as the second line of defense. They also perform financial, operational and compliance monitoring as well as risk management functions. The internal auditor of the Group (the "Internal Auditor"), as the third line of defense, provides independent and objective assurance on the overall effectiveness of the risk management and internal control system.

財務報告

董事知悉需負責根據香港財務報告準則，香港公司條例（香港法例第622章）及上市規則適用的披露規定編製財務報表，且真實而公平反映本集團之財務狀況、財務表現及現金流量。管理層向董事會提供資料及解釋，讓董事會可就財務及其他決定作出知情評估。因此，選用適當的會計政策，並且貫徹應用，及管理層對財務報告所作的判斷和評估是審慎和合理。

外聘核數師就彼等對本集團綜合財務報表的責任聲明已載於本年報第53至60頁獨立核數師報告內。

核數師酬金

本公司外聘核數師向本集團提供2025/26年度審計與非審計服務的酬金分別約為1,381,000港元（2024/25年度：1,453,000港元）及25,000港元（2024/25年度：25,000港元）。非審計服務主要包括審閱本公司初步業績公佈。

風險管理及內部控制

董事會就維持健全有效之內部監控和風險管理系統承擔整體責任，及透過審核委員會檢討其運作上是否足夠和有效。

董事會已辨識本集團所面對的最大風險，並確定董事會為達致本集團的戰略目標而願意承受的風險水平。本集團之風險管理架構符合「三道防線」模式。第一道防線為各業務單位承擔風險管理責任。包括財務及會計部、公司秘書處及人力資源部的中後台部門作為第二道防線，制定相關的內部控制及管理制度；並執行財務、運作和合規監控。集團內部審計師（「內部審計師」）作為第三道防線，對風險管理及內部監控系統的整體效益提供獨立及客觀的保證。

Each business unit, as risk owners, identifies, evaluates, and monitors its own risks, and reports such risk assessment on a monthly basis. The results of the risk assessments and changes of the risk exposure faced by the Group will be consolidated and presented to the Board at each regularly scheduled meeting.

The Board has established an “ESG working group” which is managed by senior management, and is responsible for implementing the environmental, social and governance (“ESG”) related strategies and targets. In addition, the group periodically reports the ESG-related matters to Board.

The Internal Auditor conducted reviews on systems of risk management and internal controls of the Group over financial, operational and compliance control according to the internal audit plan endorsed by the Audit Committee. During the process of review, the Internal Auditor identified internal control deficiencies and weakness, and proposed recommendations for improvements and remedial actions with management. The results of internal control review and management’s remedial actions have also been reported to the Audit Committee at each regularly scheduled meeting.

The Audit Committee had reviewed the adequacy and effectiveness of the Group’s risk management and internal controls system. The review, which cover all material control areas including financial, compliance and risk management functions, has been carried out annually. During the review, the Audit Committee also considered the adequacy of resources, qualifications and experience of staff of the Group’s accounting and financial reporting function and their training programmes and budgets.

The Board, through the annual review by the Audit Committee and the ESG working group, considers that the Group’s internal control and risk management system for FY 2025/26 is appropriate, effective and adequate. No significant areas of concern that may affect the financial, operational, compliance controls, and risk management functions of the Group have been identified. The systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

INSIDE INFORMATION

The Company has adopted and implemented its own disclosure policy aiming to provide a general guide to Directors and management of the Company in handling of confidential information and/or monitoring of information disclosure pursuant to applicable laws and regulations in compliance with the Listing Rules and SFO.

審核委員會已檢討本集團之風險管理及內部監控系統的適切性和效率。檢討工作每年進行一次，涵蓋所有主要監控範圍，包括財務、合規及風險管理職能。審核委員會亦於檢討期間考慮資源的充足程度、集團會計及財務匯報職能員工的資格和經驗，以及培訓計劃和預算。

經過審核委員會及ESG工作組的年度檢討，董事會認為本集團於2025/26年度的內部監控和風險管理系統是適當、有效和足夠，亦無發現任何可能影響集團財務監控、運作監控、合規監控以及風險管理職能的重要事項。有關制度旨在管理而非消除未能實現業務目標的風險，且只能對重大錯誤陳述或損失提供合理而非絕對的保證。

WHISTLEBLOWING POLICY

The Whistleblowing Policy was adopted by the Company on January 2023. It provides employees and the relevant third parties who deal with the Group (e.g. customers, suppliers, creditors and debtors) with guidance and reporting channels on reporting any suspected improprieties in any matters related to the Group addressed to the chief executive officer. All reported matters will be investigated independently and, all information received from a whistleblower and its identity will be kept confidential.

The Board will regularly review the Whistleblowing Policy and mechanism to improve its effectiveness.

ANTI-CORRUPTION POLICY

The Anti-Corruption Policy was adopted by the Company on January 2023 to ensure the Directors and employees within the Group comply with the Hong Kong Prevention of Bribery Ordinance and other applicable laws and regulations. The policy sets out the integrity and conducts requirements which applies to all Directors and employees of the Group at all levels, and external parties doing businesses with the Group and those acting in an agency or fiduciary capacity on behalf of the Group.

The Board will review the policy from time to time to ensure that it remains appropriate.

CHANGES IN INFORMATION OF DIRECTORS AND CHIEF EXECUTIVE

Pursuant to Rule 13.51B(1) of the Listing Rules, the changes in information of Directors and chief executive of the Company are set out below:

SHAREHOLDER RIGHTS

1. Convening Extraordinary General Meetings ("EGM")

The following procedures for Shareholders to convene an EGM of the Company are prepared in accordance with the Articles:

- (i) One or more Shareholders ("**Requisitionist(s)**") holding, at the date of deposit of the requisition, not less than one tenth of the paid up capital of the Company having the right of voting at general meetings, shall have the right, by written notice, to require an EGM to be called by the directors for the transaction of any business specified in such requisition.
- (ii) Such requisition shall be made in writing to the Board or the company secretary of the Company by post to the Company's headquarters in Hong Kong at 22/F, Railway Plaza, No. 39 Chatham Road South, Tsim Sha Tsui, Kowloon, Hong Kong, or by email to info@grandming.com.hk.

(iv) If the Board fails to proceed to convene the EGM within 21 days of such deposit, the Requisitionist(s) himself (themselves) may do so in the same manner, and all reasonable expenses incurred by the Requisitionist(s) as a result of the failure of the Board shall be reimbursed to the Requisitionist(s) by the Company.

2. Procedures for Putting Forward Proposals at Shareholders' Meetings

(i) Proposal for election of a person other than a Director as a Director:

A shareholder may propose a person other than a retiring director ("**Candidate**") for election as a director at a general meeting by lodging the following documents at the headquarters of the Company in Hong Kong or the Company's branch share registrar and transfer office in Hong Kong, Tricor Investor Services limited, on 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong:

- (a) a written notice ("**Proposal Notice**") of the intention to propose the Candidate for election as a director, which must (i) state the information of the Candidate as required by Rule 13.51(2) of the Listing Rules, which is available on the Stock Exchange's website (www.hkex.com.hk) and (ii) must be signed by Shareholder; and
- (b) a written notice ("**Consent Notice**") by the Candidate, which must (i) indicate his/her willingness to be elected as a director and consent to the publication of his/her personal information as required by Rule 13.51(2) of the Listing Rules; and (ii) must be signed by the Candidate.

The Proposal Notice and the Consent Notice shall be lodged for a period of at least 7 clear days commencing no earlier than the day after the despatch of the notice of the general meeting and ending no later than 7 clear days before the date of such general meeting.

OPINION

We have audited the consolidated financial statements of Grand Ming Group Holdings Limited (the **"Company"**) and its subsidiaries (together the **"Group"**) set out on pages 61 to 159, which comprise the consolidated statement of financial position as at 31 March 2026, and the consolidated statement of profit or loss, the consolidated statement of profit or loss and other comprehensive income, the consolidated statement of changes in equity and the consolidated cash flow statement for the year then ended, and notes to the consolidated financial statements, including material accounting policy information.

In our opinion, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 31 March 2026, and of its consolidated financial performance and its consolidated cash flows for the year then ended in accordance with HKFRS Accounting Standards as issued by the Hong Kong Institute of Certified Public Accountants (**"HKICPA"**) and have been properly prepared in compliance with the disclosure requirements of the Hong Kong Companies Ordinance.

BASIS FOR OPINION

We conducted our audit in accordance with Hong Kong Standards on Auditing (**"HKSAs"**) issued by the HKICPA. Our responsibilities under those standards are further described in the "Auditor's Responsibilities for the Audit of the Consolidated Financial Statements" section of our report. We are independent of the Group in accordance with the HKICPA's "Code of Ethics for Professional Accountants" (the **"Code"**), as applicable to audits of financial statements of public interest entities. We have also fulfilled our other ethical responsibilities in accordance with the Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

意見

我們已審核列載於第61至159頁佳明集團控股有限公司（「**貴公司**」）及其附屬公司（統稱「**貴集團**」）的綜合財務報表，其包括於二零二六年三月三十一日的綜合財務狀況表，以及截至該日止年度的綜合損益表、綜合損益及其他全面收益表、綜合權益變動表和綜合現金流量表，以及綜合財務報表附註（包括重大會計政策資料）。

我們認為，該等綜合財務報表已根據香港會計師公會頒佈的《香港財務報告準則會計準則》真實而公平地反映 貴集團於二零二六年三月三十一日的綜合財務狀況及截至該日止年度的綜合財務表現及綜合現金流量，並已按照香港《公司條例》的披露要求而妥為編製。

意見基礎

MATERIAL UNCERTAINTY RELATED TO GOING CONCERN

We draw attention to note 3(b) in the consolidated financial statements, which indicates that the Group incurred a net loss of HK\$349,498,000 for the year ended 31 March 2026 and as at 31 March 2026, the Group had net current liabilities of HK\$4,591,950,000. These conditions, along with other matters set forth in note 3(b), indicate that a material uncertainty exists that may cast significant doubt on the Group's ability to continue as a going concern. Our opinion is not modified in respect of this matter.

KEY AUDIT MATTERS

Key audit matters are those matters that, in our professional judgement, were of most significance in our audit of the consolidated financial statements of the current period. These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters. In addition to the matter described in the "Material Uncertainty Related to Going Concern" section, we have determined that matters described below to be the key audit matters to be communicated in our report.

Valuation of investment properties and investment properties under development

Investment properties consist of a commercial shop and two data centres whilst investment properties under development consist of two other data centres under construction. As disclosed in note 15 to the consolidated financial statements, the carrying amount of the Group's investment properties and investment properties under development at fair value are amounted to HK\$6,854,000,000 at 31 March 2026, representing 76% of the Group's total assets.

As disclosed in note 15(a) to the consolidated financial statements, an independent firm of qualified professional valuer (the "Valuer") was engaged to perform the valuation. Discounted cash flow method of the income approach, market comparison method and residual method were used to determine the fair value of the investment properties and investment properties under development, respectively. Details of these valuation approaches are disclosed in note 15(a) to the consolidated financial statements. These methods involve the making of assumptions, which involve significant judgements, and estimates applied, including estimated market rental growth rate, occupancy rate, estimated costs of completion, capitalisation rate as well as discount rate.

Related disclosures are included in notes 4(e)(i), 5(a) and 15 to the consolidated financial statements.

有關持續經營的重大不確定性

我們務請垂注綜合財務報表附註3(b)，顯示截至二零二六年三月三十一日止年度 貴集團錄得淨虧損349,498,000港元且於二零二六年三月三十一日， 貴集團的流動淨負債為4,591,950,000港元。該情況連同附註3(b)所述，顯示存在重大不確定性，其可能對 貴集團持續經營的能力構成重大疑慮。我們並無就此事宜發出修訂意見。

關鍵審核事項

關鍵審核事項是根據我們的專業判斷認為對審核本期綜合財務報表最為重要的事項。該等事項是在我們審核整體綜合財務報表及出具意見時進行處理的。我們不會對該等事項提供單獨意見。除「有關持續經營的重大不確定性」一節所述的事項外，我們確定以下所述事項乃本報告中需要溝通的關鍵審計事項。

投資物業及發展中投資物業的估值

投資物業由一間商業店舖及兩座數據中心組成，而發展中投資物業則由另外兩座在建的數據中心組成。誠如綜合財務報表附註15所披露，於二零二六年三月三十一日， 貴集團按公允價值計量的投資物業及發展中投資物業的賬面值為6,854,000,000港元，佔 貴集團總資產的76%。

誠如綜合財務報表附註15(a)所披露， 貴集團已委聘一間獨立的合資格專業估值師行（「估值師」）進行估值。 貴集團分別採用收益法的折現現金流量法、市場比較法及剩餘法，以釐定投資物業及發展中投資物業的公允價值。該等估值方法的詳情載於綜合財務報表附註15(a)。該等方法涉及作出假設，當中應用了重大判斷及估計，包括估計市場租金增長率、出租率、估計落成成本、資本化率以及折現率。

相關的披露包括在綜合財務報表附註4(e)(i)、5(a)和15內。

- assessing the appropriateness and consistency of the use of the valuation methodology with relevant accounting requirements and industry norms;
- using auditor's expert to assist in assessing the valuation methodology and key assumptions used by the Valuer;
- evaluating the reasonableness of key assumptions adopted in the valuation, in particular capitalisation rates, by comparing them with historical rates and available market data;
- performing analysis on the reasonableness of the prospective cash flows input to evaluate the results on the valuation; and
- checking, on a sample basis, the accuracy and relevance of the prospective cash flows input on existing leases by agreeing the rental income and lease terms to the signed lease agreements.

Assessment of net realisable values of properties under development and held for sale

The Group had properties under development and held for sale of approximately HK\$662,288,000 and HK\$351,938,000, respectively, as at 31 March 2026.

The properties under development and held for sale are stated at the lower of cost and net realisable value. The determination of the net realisable values of the properties under development and held for sale of the Group is highly dependent on management's judgments and estimates, including the expected selling prices in the ordinary course of business, the estimated selling expenses and the estimated costs to be incurred to completion.

我們就評估投資物業及發展中投資物業估值之恰當性的審核程序包括：

- 評估估值師的資格、能力和客觀性；

- 採用核數師之專家以協助評估估值師採納的評估方法和主要假設；
- 評估應用於估值之主要假設的合理性，尤其對於資本化率，通過與歷史比率和可用市場數據進行比較；
- 對預期現金流量投入的合理性進行分析，以評估估值結果；及
- 通過將租金收入和租賃條款與已簽署的租賃協議達成一致，以抽樣方式檢查現有租賃輸入的預期現金流量的準確性和相關性。

評估發展中及持有作銷售物業之可變現淨值

於二零二六年三月三十一日，貴集團分別擁有約662,288,000港元的發展中物業及351,938,000港元的持有作銷售物業。

發展中物業及持有作出售物業按成本與可變現淨值兩者中的較低者列賬。貴集團發展中物業及持有作銷售物業的可變現淨值的釐定高度取決於管理層的判斷及估計，包括日常業務過程中的預期售價、估計銷售開支以及預計竣工成本。

We focused on this matter due to the magnitude of the balances involved and the significant accounting judgements and estimates required.

Related disclosures are included in notes 4(i), 5(b) and 16 to the consolidated financial statements.

Our responses:

Our audit procedures in relation to assessing the appropriateness of assessment of net realisable values of properties under development and held for sale included:

- evaluating the competence, capabilities and objectivity of the Valuers;
- assessing the appropriateness and consistency of the use of the valuation methodology with relevant accounting requirements and industry norms;
- using auditor's expert to assist in assessing the valuation methodology and key assumptions used by the Valuers; and
- assessing certain key assumptions and estimates including, among others, (i) the expected selling prices of the properties under development and held for sale by comparing the expected selling prices to, among others, the recent transaction prices for similar properties or the prices of comparable properties; (ii) the estimated selling expenses by comparing the historical average selling expenses to revenue ratio or to other relevant information; and (iii) the estimated costs to be incurred to completion for properties under development by checking the estimated costs against budgets approved by management and examined, on a sample basis, relevant construction contracts and other reliable evidence available.

1. GENERAL INFORMATION

Grand Ming Group Holdings Limited (the “**Company**”) and its subsidiaries (collectively referred to as the “**Group**”) are principally engaged in the business of building construction, property leasing and property development. The Company was incorporated in the Cayman Islands as an exempted company with limited liability on 14 August 2012 under the Companies Law, Cap.22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands. The Company’s shares were listed on the Main Board of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) since 9 August 2013.

The addresses of the registered office and principal place of business of the Company are disclosed in the corporate information to the annual report.

The Company is an investment holding company. The principal activities of its principal subsidiaries are set out in note 28.

- 香港會計師公會於二零二四年七月頒佈《香港財務報告準則第18號——財務報表的呈列報及披露》，將取代《香港會計準則第1號》，這項變動會對包括《香港會計準則第8號——財務報表編製基準》在內的準則作出重大修訂。雖然新準則不影響項目確認及計量，但預期將對綜合財務報表的損益表分類小計、資訊彙總與披露、以及管理層界定的績效計量產生重大影響。

3. BASIS OF PREPARATION

(a) Statement of compliance

The consolidated financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards (“**HKASs**”) and Interpretations (hereinafter collectively referred to as the “**HKFRS Accounting Standards**”) issued by the HKICPA. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on the Stock Exchange (the “**Listing Rules**”) including the disclosure provisions of the Hong Kong Companies Ordinance.

(b) Basis of measurement and going concern basis

The consolidated financial statements have been prepared under the historical cost basis except for certain properties and financial instruments, which are measured at fair values as explained in the accounting policies set out below.

The Group incurred a net loss of \$349,498,000 for the year ended 31 March 2026 and as at 31 March 2026, the Group had net current liabilities of \$4,591,950,000. At 31 March 2026, the Group’s bank and other loans that are repayable on demand or within twelve months after the reporting date amounted to \$5,401,406,000 whilst the Group only had cash and bank balances amounted to \$24,295,000 as of the same date. In assessing the Group’s ability to continue as a going concern and the appropriateness of the use of the going concern basis of accounting to prepare the consolidated financial statements, the directors of the Company (“**Directors**”) gave careful considerations to the future performance and liquidity of the Group based on a cash flow forecast covering 18 months from the end of the reporting period that takes account of the following:

截至二零二六年三月三十一日止年度，本集團錄得淨虧損349,498,000元，且於二零二六年三月三十一日，本集團的流動負債淨額為4,591,950,000元。於二零二六年三月三十一日，本集團須於要求時或於報告日期後十二個月內償還的銀行及其他貸款達5,401,406,000元，而本集團於截至同一日持有的現金及銀行結餘僅為24,295,000元。於評估本集團持續經營的能力以及採用持續經營會計基準編製綜合財務報表的適當性時，本公司董事（「**董事**」）已根據涵蓋報告期末起計十八個月的現金流量預測，審慎考慮本集團的未來表現及流動資金狀況，而該預測已考慮以下各項：

- (i) As at 31 March 2026, the Group was not in compliance with certain financial covenants of banking facilities for which the drawn down aggregated amount was \$4,950,256,000 as of 31 March 2026. Amongst the banking borrowings under these banking facilities, \$2,232,081,000 was originally scheduled for repayment beyond 31 March 2027 in accordance with the loan agreements. Under the relevant bank loan agreements, such non-compliance of covenants results in the aggregate amount of bank borrowings of \$4,950,256,000 becoming immediately due and may be payable upon demand by the banks and may also exercise other rights entitled in the relevant agreements. As at 31 March 2026, no written waivers have been obtained from the banks for the non-compliance. Consequently, the non-current portion of the bank borrowings amounting to \$2,232,081,000, which had the original contractual repayment dates beyond 31 March 2027, was reclassified as current liabilities.

Management had proactively negotiated with the relevant banks to obtain waivers for the Group's non-compliance with the relevant financial covenants as at 31 March 2026. Up to the date of authorisation for issuance of these consolidated financial statements, the Group has successfully obtained waivers on the non-compliance of the relevant financial covenant from the relevant banks in respect of bank borrowings amounting to \$1,873,563,000.

Based on communications with the relevant banks, they have not notified the Group to, and the Directors are not aware of any intention of the relevant banks to withdraw their banking facilities or demand immediate repayment of the outstanding bank borrowings due to non-compliance with the financial covenants and the Group has continued to repay interests and loan principal in accordance with the scheduled repayment dates. Additionally, the Directors believe that these banks would continue to renew the existing banking facilities and make the respective uncommitted banking facilities available to the Group;

- (i) 於二零二六年三月三十一日，本集團未遵守若干銀行融資的財務契約，而於二零二六年三月三十一日，該等銀行融資已提取的總額為4,950,256,000元。在該等銀行融資項下的銀行借款中，按貸款協議原定計劃須於二零二七年三月三十一日之後償還的金額為2,232,081,000元。根據相關銀行貸款協議，該等未遵守契約的情況導致合共4,950,256,000元的銀行貸款變為即時到期，且於銀行要求時可能須予償還，而銀行亦可能行使相關協議項下賦予的其他權利。於二零二六年三月三十一日，本集團尚未就未遵守契約取得銀行的書面豁免。因此，原定合約還款日期在二零二七年三月三十一日之後，金額為2,232,081,000元的銀行貸款非流動部分，已重新分類為流動負債。

管理層已主動與相關銀行進行談判，以就本集團於二零二六年三月三十一日未遵守相關財務契約取得豁免。截至該等綜合財務報表獲准發佈日期，本集團已成功就金額為1,873,563,000元的銀行貸款，自相關銀行取得關於未遵守相關財務契約的豁免。

根據與相關銀行的溝通，彼等並未通知本集團，且董事亦不知悉相關銀行有任何意向因未遵守財務契約而撤銷其銀行融資或要求即時償還未償還的銀行貸款，且本集團已繼續根據預定還款日期償還利息及貸款本金。此外，董事相信該等銀行將繼續期現有銀行融資，並向本集團提供各自的非承諾銀行融資；

- (ii) The Group will continue to monitor its compliance with the covenants of the bank borrowings. The Group remains committed to stringent monitoring of financial covenant adherence across all borrowings. In the event of potential non-compliance, the management will proactively engage lenders to re-negotiate terms or seek waivers to mitigate the risks;
- (iii) The Group is contemplating the potential disposal of certain assets to enhance its liquidity and reduce indebtedness. On 6 January 2026, the Group received an exclusivity agreement and a letter of intent from a potential purchaser regarding the acquisition of two properties in the New Territories, Hong Kong (collectively “**Target Properties**”). The Target Properties are currently owned by Regal Development Limited and Golden Ford Limited, both wholly-owned subsidiaries of the Company. Both the exclusivity agreement and the letter of intent were extended before expiry and have been further extended on 15 June 2026 with the latest expiry date on 3 August 2026. Further details are disclosed in the Company’s announcement dated 6 January 2026;

Should these divestments materialise, the net proceeds will enable the Group to reduce its overall indebtedness and enhance the Group’s working capital;

- (iv) The Directors believe that the Group would generate sustained operating cash flows through rental income from the property leasing segment and sales proceeds from the property development segment. The Group will continue to implement plans and measures to accelerate sales of the remaining completed properties held for sale, and to speed up the collection of rentals;

- (ii) 本集團將繼續監察其遵守銀行貸款契約的情況。本集團仍致力於嚴格監察所有貸款對財務契約的遵守情況。一旦出現潛在未遵守契約的情況，管理層將主動與貸款人接洽，以重新談判條款或尋求豁免，從而降低風險；
- (iii) 本集團正考慮潛在出售若干資產，以提高其流動資金並減少債務。於二零二六年一月六日，本集團接獲一名潛在買家就收購位於香港新界的兩項物業（統稱「**目標物業**」）的獨家交易協議及意向書。目標物業目前由本公司兩間全資附屬公司悅基發展有限公司及金達富有限公司擁有。進一步詳情載於本公司日期為二零二六年一月六日的公佈中披露；

倘該等出售事項落實，所得款項淨額將使本集團減少其整體債務並增加本集團的營運資金；

- (v) The Group is actively discussing with the lenders of certain bank and other loans to refinance its existing borrowings and to obtain additional credit facilities from existing and other lenders as and when needed. As of the date of authorisation for the issuance of these consolidated financial statements, the Group has successfully obtained new additional facilities of \$502,000,000 and refinanced its existing borrowings by \$202,145,000, respectively;
- (vi) As at the date of authorisation for issuance of these consolidated financial statements, the Group has unutilised credit facilities of approximately \$321,281,000 available to support on-going development of its various property development projects. The Directors believe that these credit facilities will remain available, based on the rationale outlined in note 3(b)(i) above; and
- (vii) The Group had property development projects in progress. The pre-sale of these projects are expected to be launched during the forecast period. The Group has already initiated sales and marketing activities and begun with the preparation of the necessary documents for the pre-sale. The Directors are therefore of the view that the property development projects will be able to generate operating cash flow to the Group in the forecast period.

In the opinion of the Directors, taking into account the above plans and measures, the Group will have sufficient working capital to finance its operations and meet its financial obligations as and when they fall due. Accordingly, the Directors consider that it is appropriate to prepare the consolidated financial statements on a going concern basis.

- (v) 本集團正積極與若干銀行及其他貸款的貸款人洽談為其現有借款進行再融資，並於需要時自現有及其他貸款人取得額外信貸融資。截至本綜合財務報表獲授權發佈日期，本集團已分別成功取得502,000,000元的新增額外融資，並為其202,145,000元的現有貸款進行再融資；
- (vi) 截至本綜合財務報表獲授權發佈日期，本集團擁有約321,281,000元的未動用信貸融資，可用於支持各個物業發展項目的持續發展。基於上文附註3(b)(i)所述的理由，董事相信該等信貸融資將維持有效；及
- (vii) 本集團擁有在建物業發展項目。該等項目的預售預計將於預測期內推出。本集團已展開銷售及市場推廣活動，並已著手準備預售所需的必要文件。因此，董事認為，物業發展項目將能夠於預測期內為本集團產生經營現金流。

董事認為，經考慮上述計劃及措施後，本集團將擁有足夠的營運資金以維持其運作並按時履行其財務義務。因此，董事認為按持續經營基準編製綜合財務報表屬適宜之舉。

Notwithstanding the above, the use of the going concern basis depends on successful implementation of the aforementioned plans and measures. There are uncertainties inherently associated with their future outcomes, including (i) successful negotiation with the banks to obtain waivers such that the Group would be able to repay bank borrowings in accordance with the repayment schedules, the unutilised credit facilities would remain available to the Group and the banks would not exercise other rights entitled in the relevant loan agreements; (ii) successful disposal of the Target Properties as contemplated; (iii) sales of the Group's completed properties under the prevailing market conditions can be materialised; (iv) successful and timely agreement with the lenders on the extension of the repayment dates of existing borrowings subject to the Group's financial and liquidity position, and the securing of additional credit facilities from existing and other lenders as and when needed; and (v) successful launch of the pre-sale of the property development project. These conditions indicate the existence of a material uncertainty that may cast significant doubt on the Group's ability to continue as a going concern, and therefore, that it may be unable to realise its assets or discharge its liabilities in the normal course of business.

Should the Group fail to achieve the above plans and measures, it might not be able to continue as a going concern, and adjustments would have to be made to write down the carrying value of the Group's assets to their recoverable amounts, to provide for any further liabilities which might arise, and to reclassify non-current assets and non-current liabilities as current assets and current liabilities, respectively. The effects of these adjustments have not been reflected in these consolidated financial statements.

儘管如此，採用持續經營基準取決於上述計劃及措施的成功實施。該等計劃及措施包含未來發生的事件，存在不確定性，包括：(i)與銀行成功談判以取得豁免，確保現有銀行借款根據還款時間表償還，且未使用的信貸融資繼續可以供本集團使用及將不會因未遵守契約行使相關協議所賦予之其他權利；(ii)按計劃成功出售目標物業；(iii)本集團已落成物業的銷售能在現行市場條件下變現；(iv)根據本集團的財務及流動資金狀況，與貸款人就延長現有借款的還款日期成功且及時達成協議，並於需要時從自現有及其他貸款人取得額外信貸融資；以及(v)成功推出物業發展項目的預售。該等情況顯示存在對本集團持續經營的能力構成重大不確定因素，因此，本集團可能無法在日常業務過程中變現其資產及償還其負債。

倘若本集團未能實現上述計劃及措施，則未必能繼續按持續經營業務基準經營，將需作出調整以將本集團的資產賬面值撇減至其可收回金額，就可能產生的任何進一步負債作出撥備，及將非流動資產及非流動負債分別重新分類為流動資產及流動負債。該等調整的影響尚未在本綜合財務報表內反映。

(c) Functional and presentation currency

The consolidated financial statements are presented in Hong Kong dollars ("HK\$"), which is the same as the functional currency of the Company.

4. ACCOUNTING POLICIES

(a) Basis of consolidation

The consolidated financial statements comprise the financial statements of the Company and its subsidiaries. Inter-company transactions and balances between group companies together with unrealised profits are eliminated in full in preparing the consolidated financial statements. Unrealised losses are also eliminated unless the transaction provides evidence of impairment on the asset transferred, in which case the loss is recognised in profit or loss.

(b) Subsidiaries

A subsidiary is an investee over which the Company is able to exercise control. The Company controls an investee if all three of the following elements are present: (i) power over the investee; (ii) exposure, or rights, to variable returns from the investee, and (iii) the ability to use its power to affect those variable returns. Control is reassessed whenever facts and circumstances indicate that there may be a change in any of these elements of control.

(c) Derivative financial instruments

Derivative financial instruments are initially recognised at fair value on the date on which a derivative contract is entered into and are subsequently remeasured at fair value. Derivatives are carried as assets when the fair value is positive and as liabilities when the fair value is negative.

Any gains or losses arising from changes in fair value of derivatives are taken directly to the statement of profit or loss, except for the effective portion of cash flow hedges, which is recognised in other comprehensive income and later reclassified to profit or loss when the hedged item affects profit or loss (see note 4(d)).

綜合財務報表以港元列報，港元亦與本公司的功能貨幣相同。

綜合財務報表包括本公司及其附屬公司的財務報表。集團實體之間的交易及結餘連同未實現利潤均在編製綜合財務報表時悉數對銷。未實現虧損亦予以對銷，除非交易顯示所轉讓資產出現減值跡象，在此情況下，虧損將於損益內確認。

(b) 附屬公司

附屬公司乃指本公司可對其行使控制權的被投資方。倘以下三項條件均存在：(i)有權控制被投資方的；(ii)對來自被投資方的浮動回報承擔風險或擁有權利及(iii)能行使對被投資方的權力以影響其浮動回報時，本公司即擁有對被投資方的控制權。當事實及情況表明以上條件已經改變，控制權會被重新評估。

(c) 衍生金融工具

衍生金融工具於簽訂衍生工具合約時按公平值作首次確認，並隨後重新計量彼等的公平值。若衍生金融工具之公平值為正數值，均以資產列賬，若為負數值，則確認為負債。

衍生工具公平值變動產生的收益或虧損直接於損益內確認，惟現金流量對沖的有效部分於其他全面收益確認，其後對沖項目在影響損益時重新分類至損益（見附註4(d)）。

Cash flow hedges

Where a derivative financial instrument is designated as a hedge of the variability in cash flows of a recognised asset or liability or a highly probable forecast transaction or the foreign currency risk of a committed future transaction, the effective portion of any gains or losses on remeasurement of the derivative financial instrument to fair value are recognised in other comprehensive income and accumulated separately in equity in the hedging reserve. The ineffective portion of any gain or loss is recognised immediately in profit or loss.

If a hedge of a forecast transaction subsequently results in the recognition of a non-financial asset or non-financial liability, the associated gain or loss is reclassified from equity to be included in the initial cost or other carrying amount of the non-financial asset or liability.

If a hedge of a forecast transaction subsequently results in the recognition of a financial asset or a financial liability, the associated gain or loss is reclassified from equity to profit or loss in the same period or periods during which the asset acquired or liability assumed affects profit or loss (such as when interest income or expense is recognised).

When a hedging instrument expires, or is sold or terminated, or when a hedge no longer meets the criteria for hedge accounting, hedge accounting is discontinued prospectively, any cumulative gain or loss remains in equity at that time is accounted for according to the nature of the underlying transactions (as discussed above) once the hedged cash flow occurs. When a forecast transaction is no longer expected to occur, the cumulative gain or loss that has been reported in equity is reclassified to profit or loss immediately.

現金流量對沖

倘衍生金融工具指定用作已確認資產或負債的現金流量變動、或極其可能發生的預期交易、或已承諾未來交易的外幣風險的對沖，按公平值重新計量衍生金融工具時產生的任何收益或虧損的有效部分會於其他全面收益確認及獨立累計於權益內對沖儲備之中。當中任何收益或虧損的無效部分則即時於損益中確認。

倘預期交易的對沖其後引致需確認非金融資產或非金融負債，相關的收益或虧損會從權益重新分類，並計入非金融資產或負債的初始成本或其他賬面價值。

倘預期交易的對沖其後引致需確認金融資產或金融負債，相關的收益或虧損會從權益重新分類，並於同一期間或於所收購資產或所承擔負債對損益造成影響（例如確認利息收入或支出時）的期間內計入損益。

倘對沖工具到期、或售出或終止，或倘對沖不再符合對沖會計處理的標準時，則對沖會計處理於往後終止應用，任何於權益中累計之收益或虧損會於權益內保留，並於對沖現金流量發生時根據相關交易的性質（如上所述）入賬。若預期交易預計不會發生，權益中累計之收益或虧損隨即重新分類至損益。

(i) *Investment properties and investment properties under development*

Investment properties are land and/or buildings which are owned or held under a leasehold interest (see note 4(f)) to earn rental income and/or for capital appreciation. These include land held for a currently undetermined future use and property that is being constructed or developed for future use as investment property.

Investment properties and investment properties under development are stated at fair value, unless they are still in the course of construction or development at the end of the reporting period and their fair value cannot be reliably measured at that time. Any gain or loss arising from a change in fair value or from the retirement or disposal of an investment property is recognised in profit or loss. Rental income from investment properties is accounted for as described in note 4(m)(iii).

(ii) *Other property, plant and equipment*

Other property, plant and equipment are stated at cost less accumulated depreciation and impairment losses (see note 4(g)).

Gains or losses arising from the retirement or disposal of an item of property, plant and equipment are determined as the difference between the net disposal proceeds and the carrying amount of the item and are recognised in profit or loss on the date of retirement or disposal.

(e) 固定資產

(i) *投資物業及發展中投資物業*

投資物業指根據租賃權益（見附註4(f)）擁有或持有用以賺取租金收入及／或用作資本增值的土地及／或樓宇，包括持作目前尚未確定未來用途的土地及正在建設或開發中以供未來用作投資物業的物業。

投資物業及發展中投資物業按公平值列賬，除非物業於報告期末仍在興建或發展中之公平值於當時無法可靠計量。公平值變動或報廢或出售投資物業產生的任何收益或虧損於損益內確認。投資物業的租金收入乃按附註4(m)(iii)所述方式列賬。

(ii) *其他物業、廠房及設備*

其他物業、廠房及設備按成本減去累計折舊及減值虧損列賬（見附註4(g)）。

報廢或出售物業、廠房及設備項目產生的損益按出售所得款項淨額與該項目賬面值之間的差額釐定，並於報廢或出售日期於損益內確認。

The useful lives, residual value and depreciation method are reviewed, and adjusted if appropriate, at each end of the reporting period. The useful lives are as follows:

(f) Leased assets

Accounting as a lessee

All leases are capitalised in the statement of financial position as right-of-use assets and lease liabilities, except for (i) leases which are short-term leases and/or (ii) leases for which the underlying asset is of low-value. The lease payments associated with those leases have been expensed on straight-line basis over the lease term. The Group accounts for leasehold land and buildings that are held for rental or capital appreciation purpose under HKAS 40 and are carried at fair value. The Group accounts for right-of-use assets related to interests in leasehold land which is held as inventories of properties are carried at the lower of cost and net realisable value.

Accounting as a lessor

The Group has leased out its investment properties to a number of tenants. Rental income from operating leases is recognised in profit or loss on a straight-line basis over the term of the relevant lease. (f) 租賃資產

作為承租人的會計處理

所有租賃 (不論為經營租賃或融資租賃) 須於財務狀況表資本化為使用權資產及租賃負債，惟會計政策為實體提供選擇，可選擇不將(i)屬短期租賃的租賃及／或(ii)相關資產為低價值之租賃進行資本化。本集團訂立的所有租賃均為短期，並選擇不就於開始日期租賃期少於十二個月之租賃確認使用權資產及租賃負債。與該等租賃相關之租賃付款 (如有) 已於租賃期內按直線法支銷。本集團根據香港會計準則第40號按公平值計量以租賃或資本增值為持有目的之租賃土地和建築物。

Internal and external sources of information are reviewed at the end of each reporting period to identify indications that the following assets may be impaired:

- fixed assets (other than properties carried at fair value); and
- investments in subsidiaries in the Company's statement of financial position.

If any such indication exists, the asset's recoverable amount is estimated.

(i) Calculation of recoverable amount

The recoverable amount of an asset is the greater of its fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. Where an asset does not generate cash inflows largely independent of those from other assets, the recoverable amount is determined for the smallest group of assets that generates cash inflows independently (i.e. a cash-generating unit).

(ii) Recognition of impairment losses

An impairment loss is recognised in profit or loss if the carrying amount of an asset, or the cash generating unit to which it belongs, exceeds its recoverable amount. Impairment losses recognised in respect of cash-generating units, are allocated to reduce the carrying amount of the assets in the unit (or group of units) on a pro rata basis, except that the carrying value of an asset will not be reduced below its individual fair value less costs of disposal (if measurable) or value in use (if determinable).

Trade receivables are initially recognised when they are originated. All regular way purchases and sales of financial assets are recognised on the trade date, that is, the date that the Group commits to purchase or sell the asset. All other financial assets are initially recognised when the Group becomes a party to the contractual provisions of the instrument.

A financial asset (unless it is a trade receivable without a significant financing component) is initially measured at fair value plus, for an item not at fair value through profit or loss, transaction costs that are directly attributable to its acquisition or issue. A trade receivable without a significant financing component is initially measured at the transaction price.

Debt instruments

Debt instruments that are held for collection of contractual cash flows where those cash flows represent solely payments of principal and interest are measured at amortised cost. Financial assets at amortised cost are subsequently measured using the effective interest method. Interest income, foreign exchange gains and losses and impairment are recognised in profit or loss. Any gain or loss on derecognition is recognised in profit or loss.

Equity instruments

On initial recognition of an equity investment that is not held for trading, the Group could irrevocably elect to present subsequent changes in the investment's fair value through other comprehensive income ("FVOCI"). This election is made on an investment-by-investment basis. Equity investments at FVOCI are measured at fair value. Dividend income are recognised in profit or loss unless the dividend income clearly represents a recovery of part of the cost of the investments. Other net gains and losses are recognised in other comprehensive income and are not reclassified to profit or loss. All other equity instruments are classified as fair value through profit or loss ("FVTPL"), whereby changes in fair value, dividends and interest income are recognised in profit or loss.

The Group recognises loss allowances for expected credit loss (“ECL”) on trade receivables and other financial assets measured at amortised cost.

ECLs are a probability-weighted estimate of credit losses. Credit losses are measured as the difference between all contractual cash flows that are due to the Group in accordance with the contract and all the cash flows that the Group expects to receive. The shortfall is then discounted at an approximation to the assets’ original effective interest rate.

The Group measures loss allowances for trade receivables using HKFRS 9 simplified approach and has calculated ECLs based on lifetime ECLs. The Group has established a provision matrix that is based on the Group’s historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

For other debt financial assets, ECLs are based on the 12-month ECLs. However, when there has been a significant increase in credit risk since origination, the allowance will be based on the lifetime ECLs.

When determining whether the credit risk of a financial asset has increased significantly since initial recognition and when estimating ECL, the Group considers reasonable and supportable information that is relevant and available without undue cost or effort. This includes both quantitative and qualitative information analysis, based on the Group’s historical experience and informed credit assessment and including forward-looking information.

The Group assumes that the credit risk on a financial asset has increased significantly if it is more than 30 days past due.

本集團就應收賬款及按攤銷成本計量的金融資產的預期信貸虧損（「預期信貸虧損」）確認虧損撥備。

At each reporting date, the Group assesses whether financial assets carried at amortised cost are credit impaired. A financial asset is “credit-impaired” when one or more events that have a detrimental impact on the estimated future cash flows of the financial asset have occurred. Evidence that a financial asset is credit impaired includes the following observable data:

- significant financial difficulty of the debtor;
- a breach of contract such as a default or being more than 90 days past due;
- the restructuring of a loan or advance by the Group on terms that the Group would not consider otherwise;
- it is probable that the debtor will enter bankruptcy or other financial reorganisation; or
- the disappearance of an active market for a security because of financial difficulties.

The Group considers that a default event occurs when: (1) the borrower is unlikely to pay its credit obligations to the Group in full, without recourse by the Group to actions such as realising security (if any is held); or (2) the financial asset is more than 90 days past due.

Loss allowances for financial assets measured at amortised cost are deducted from the gross carrying amount of the assets through a loss allowance account. The gross carrying amount of a financial asset is written off when the Group has no reasonable expectations of recovering a financial asset in its entirety or a portion thereof. However, financial assets that are written off could still be subject to enforcement activities in order to comply with the Group’s procedures for recovery of amounts due.

Financial liabilities at amortised costs are initially measured at fair value, net of directly attributable costs incurred.

These liabilities including trade and other payables, bank and other loans and loans from ultimate holding company and controlling shareholder, are subsequently measured at amortised cost, using effective interest method. The related interest expense is recognised in accordance with the accounting policy for borrowing costs (see note 4(q)).

Gains or losses are recognised in profit or loss when the liabilities are derecognised as well as through the amortisation process.

Equity instruments issued by the Company are recorded at the proceeds received, net of direct issue costs.

The Group generally derecognises a financial asset when the contractual rights to the future cash flows in relation to the financial asset expires.

Inventories are measured at the lower of cost and net realisable value as follows:

(i) **Properties under development**

The cost of properties under development comprises specifically identified cost, including acquisition cost of land, aggregate cost of development, materials and supplies, wages and other direct expenses, an appropriate proportion of overheads and borrowing costs capitalised. Net realisable value represents the estimated selling price less estimated costs of completion and costs to be incurred in selling the properties. On completion, the properties are transferred to properties held for sales.

(ii) **Properties held for sales**

The cost of completed properties for sale comprises the costs of those completed units transferred from properties under development and where applicable, all costs of purchase and other costs incurred in bringing the inventories to their present location and condition. Net realisable value represents the estimated selling price, based on prevailing market conditions, less estimated costs to be incurred in selling the properties.

Salaries, annual bonuses, paid annual leave, contributions to defined contribution retirement plans and the cost of non-monetary benefits are accrued in the year in which the associated services are rendered by employees. Where payment or settlement is deferred and the effect would be material, these amounts are stated at their present values.

Share-based payment transactions

The fair value of services received determined by reference to the fair value of share options granted at the grant date is expensed on a straight-line basis over the vesting period, with a corresponding increase in equity (share option reserve).

At the end of each reporting period, the Group revises its estimates of the number of options that are expected to ultimately vest. The impact of the revision of the estimates during the vesting period, if any, is recognised in profit or loss, with a corresponding adjustment to share option reserve.

At the time when the share options are exercised, the amount previously recognised in share option reserve will be transferred to share capital and share premium. When the share options are forfeited after the vesting date or are still not exercised at the expiry date, the amount previously recognised in share option reserve will be transferred to retained profits.

(k) Income tax

Income tax for the year comprises current tax and movements in deferred tax assets and liabilities. Current tax and movements in deferred tax assets and liabilities are recognised in profit or loss except to the extent that they relate to items recognised in other comprehensive income or directly in equity, in which case the relevant amounts of tax are recognised in other comprehensive income or directly in equity, respectively.

Current tax is the expected tax payable on the taxable income for the year, using tax rates enacted or substantively enacted at the end of the reporting period, and any adjustment to tax payable in respect of previous years.

Deferred tax assets and liabilities arise from deductible and taxable temporary differences respectively. Deferred tax assets also arise from unused tax losses and unused tax credits.

Apart from certain limited exceptions, all deferred tax liabilities and all deferred tax assets, to the extent that it is probable that future taxable profits will be available against which the asset can be utilised, are recognised. Future taxable profits that may support the recognition of deferred tax assets arising from deductible temporary differences include those that will arise from the reversal of existing taxable temporary differences, provided those differences relate to the same taxation authority and the same taxable entity, and are expected to reverse either in the same period as the expected reversal of the deductible temporary difference or in periods into which a tax loss arising from the deferred tax asset can be carried back or forward. The same criteria are adopted when determining whether existing taxable temporary differences support the recognition of deferred tax assets arising from unused tax losses and credits.

The limited exceptions to recognition of deferred tax assets and liabilities are those temporary differences arising from goodwill not deductible for tax purposes, the initial recognition of assets or liabilities that affect neither accounting nor taxable profit (provided they are not part of a business combination) and does not give rise to equal taxable and deductible temporary differences, and temporary differences relating to investments in subsidiaries to the extent that, in the case of taxable differences, the Group controls the timing of the reversal and it is probable that the differences will not reverse in the foreseeable future, or in the case of deductible differences, unless it is probable that they will reverse in the future.

Deferred tax assets and liabilities are not discounted.

Current tax balances and deferred tax balances, and movements therein, are presented separately from each other and are not offset. Current tax assets are offset against current tax liabilities, and deferred tax assets against deferred tax liabilities, if the Group has the legally enforceable right to set off current tax assets against current tax liabilities and the following additional conditions are met:

- in the case of current tax assets and liabilities, the Group or the Company intends either to settle on a net basis, or to realise the asset and settle the liability simultaneously; or
- in the case of deferred tax assets and liabilities, if they relate to income taxes levied by the same taxation authority on either:
 - the same taxable entity; or
 - different taxable entities, which, in each future period in which significant amounts of deferred tax liabilities or assets are expected to be settled or recovered, intend to realise the current tax assets and settle the current tax liabilities on a net basis or realise and settle simultaneously.

- 就即期稅項資產及負債而言，本集團計劃按淨額基準結算或同時變現資產及結算負債；或
- 就遞延稅項資產及負債而言，倘該等資產及負債與同一稅務機關就以下其中一項徵收的所得稅有關：

(l) Provisions and contingent liabilities

Provisions are recognised for other liabilities of uncertain timing or amount when the Group has a legal or constructive obligation arising as a result of a past event, it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditure expected to settle the obligation.

Where it is not probable that an outflow of resources embodying economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of resources embodying economic benefits is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow of resources embodying economic benefits is remote.

(m) Revenue and other income

(i) Revenue from building construction

Revenue is recognised overtime as the Group's performance creates or enhances an asset that the customer controls as the Group performs and is recognised by reference to the stage of completion measured based on the construction works performed, which are certified by an independent professional architect, relative to the remaining construction works promised under the contract. Invoices are issued according to contractual terms and are usually payable within 30 days.

Contract costs are recognised as expenses in the period in which they are incurred.

The Group has elected to apply the practical expedient not to adjust the transaction price for the existence of any significant financing component given the period between the transfer of control of construction service and the payment date is one year or less, whilst retention receivables serves as an assurance that the construction services performed comply with agreed-upon specifications.

當本集團須就已發生之事件承擔法律或推定義務，並因履行該義務預期會導致含有經濟利益之資源外流並可作出可靠之估計時，則需就未明朗之時間性及金額之其他負債確認撥備。當貨幣時間價值重大時，則按預計履行義務所需資源之現值計提撥備。

當含有經濟利益之資源外流之可能性較低，或無法對有關金額作出可靠之估計時，則該義務應披露為或然負債，除經濟利益資源外流之可能性極低者以外。就須視乎某宗或多宗未來事件是否發生才能確定存在與否之潛在負債，亦需披露為或然負債，除經濟利益資源外流之可能性極低者以外。

(m) 收益及其他收入

(i) 樓宇建造之收益

收入隨時間推移確認，因為本集團在履約過程中創建或增強了客戶控制的資產，收入參照履約進度予以確認。履約進度根據獨立專業建築師認證的已完成工程相對於合同項下剩餘承諾工程的比例進行計量。發票按照合同條款開具，信用期通常為30天。

合約成本於其產生的期間內確認為開支。

鑑於建築服務控制權轉移與付款日期之間的時間間隔為一年或以下，且保留應收款作為本集團的主要融資成分，本集團選擇採用簡便實務處理，不調整交易價格。施工服務符合商定的規格。

The Group's construction contracts usually give rise to variable consideration, which arises from variation orders or claims. The Group estimates the amount of consideration to which it will be entitled using the expected value method as the variable consideration usually associated with a range of possible consideration amount. The Group would include an estimate of variable consideration in the transaction price only to the extent that it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognise will not occur when the uncertainty associated with the variable consideration is subsequently resolved. At the end of each reporting period, the Group updates the estimated transaction price (including updating its assessment of whether an estimate of variable consideration is constrained) to represent faithfully the circumstances present at the end of the reporting period and the changes in circumstances during the reporting period and recognise corresponding adjustments as revenue (or reductions of revenue).

(ii) Revenue from sales of properties

Revenue arising from the sale of properties is recognised in the Group's consolidated statement of profit or loss on the basis that control of the property has been passed to the customer during the current accounting period, which is the point in time when the customer has the ability to direct the use of the property and obtain substantially all the benefits of the property. Deposits and instalments received on properties sold prior to the date of revenue recognition are included in the consolidated statement of financial position under contract liabilities.

To the extent that the deposits and instalment received from customers are regarded as providing a significant financing benefit to the Group, revenue recognised under that contract includes the interest accreted on the contract liability under the effective interest method during the period between the payment date and the transfer of control of the property. The discount rate applied is reflective of the rate in a separate financing transaction between the Group and the customer at contract inception. The interest is expensed as accrued unless it is eligible to be capitalised in accordance with note 4(q).

本集團的建造合約通常會產生因變更訂單或索賠而產生的可變對價。作為通常與一系列可能的對價金額相關的可變對價，本集團採用預期值法估計其將有權獲得的對價金額。本集團僅在與可變對價相關的不確定性隨後得到解決後，累計已確認收入金額很可能不會發生重大收入轉回的情況下，才會在交易價格中包含可變對價的估計。在每個報告期末，本集團更新預計交易價格（包括更新對可變對價估計是否受到限制的評估），以真實反映報告期末的情況以及報告期內情況的變化（或減少收入）。

(ii) 銷售物業之收益

出售物業所產生之收益乃根據對物業擁有權之控制權轉移至客戶之基準於本集團綜合損益表中確認，該時點為客戶擁有決定物業用途的能力及獲取物業的所有重大利益時。於收益確認日期前銷售物業所收取得之按金及分期款項已計入綜合財務狀況表之合約負債項下。

如果從客戶收到的定金和分期款項被視為為本集團提供了重大融資利益，則根據該合約確認的收益包括按實際利率法計算的合約負債從付款日至合約履行日期間應計的利息。所採用的折現率反映了本集團與客戶在合約開始時之間的單獨融資交易中的利率。利息以應計費用計入費用，除非符合附註4(q)規定的資本化條件。

(iii) Rental income from operating leases

Rental income receivable under operating leases is recognised in profit or loss in equal instalments over the periods covered by the lease term. Lease incentives granted are recognised in profit or loss as an integral part of the aggregate net lease payments receivable. Contingent rentals are recognised as income in the accounting period in which they are earned.

(iv) Rental related income

For investment property held primarily to earn rental income, the Group enters as a lessor into lease agreements that fall within the scope of HKFRS 16. These agreements include certain services offered to tenants and the Group has determined that these services constitute distinct non-lease components (transferred separately from the right to use the underlying asset) and are within the scope of HKFRS 15. The Group allocates the consideration in the contract to the separate lease and revenue (non-lease) components on a relative stand-alone selling price basis.

The Group arranges for certain services provided to tenants of investment property included in the contract the Group enters into as a lessor, to be provided by third parties. The Group has determined that it controls the services before they are transferred to tenants, because it has the ability to direct the use of these services and obtain the benefits from them. In making this determination, the Group has considered that it is primarily responsible for fulfilling the promise to provide these specified services because it directly deals with tenants' complaints and it is primarily responsible for the quality of the services. In addition, the Group has discretion in establishing the price that it charges to the tenants for the specified services.

(iii) 經營租賃的租金收入

經營租賃之應收租金收入按租賃期以等額分期於損益中確認。所給予的租賃獎勵金額與淨應收租賃付款總額整體在損益中確認。或然租金乃於賺取之會計期間內確認為收入。

(iv) 租金相關收入

對於主要以賺取租金收入為目的的投資物業，本集團作為出租人簽訂了適用香港財務報告準則第16號的租賃協議。這些協議中包含向租戶提供的某些服務，本集團已判定這些服務構成單獨的非租賃組成部分（與使用相關資產的權利分開轉移），並屬於香港財務報告準則第15號的適用範圍。本集團依各項單獨售價的相對比例，將合約對價分攤至單獨的租賃組成部分及收入（非租賃）組成部分。

對於投資物業租約中包含的某些服務，本集團安排由第三方提供給租戶。本集團判定在服務轉移給租戶前已取得控制權，因其有能力主導這些服務的使用並從中獲得利益。在作出此項判定時，本集團已考慮其為提供這些指定服務的主要責任方，因為其直接處理租戶投訴並對服務品質承擔主要責任。此外，本集團對向租戶收取的指定服務費用具有定價自主權。

Therefore, the Group has concluded that it is the principal in providing service. The Group has also concluded that these services represent a series of daily services that are individually satisfied over time because the tenants simultaneously receive and consume the benefits provided by the Group. The Group applied a practical expedient in HKFRS 15 to recognise revenue in an amount to which the Group has the right to invoice since the Group has the right to consideration from a customer in an amount that corresponds directly with the value to the customer of the Group's performance completed to date.

(v) Dividend income

Dividend income from unlisted investments is recognised when the Group's right to receive payment is established.

(vi) Interest income

Interest income is recognised using effective interest method. Interest income on credit-impaired financial assets is calculated based on the amortised cost (i.e. the gross carrying amount less loss allowance) of the financial asset. For non credit-impaired financial assets, interest income is calculated based on the gross carrying amount.

(n) Contract liabilities

Contract liability represents the Group's obligation to transfer goods or services to a customer for which the Group has received consideration (or an amount of consideration is due) from the customer. If the considerations received (including advances received from customers) exceeds the revenue recognised to date under the output method, then the Group recognises a contract liability for the difference.

因此，本集團認定自身為提供相關服務的主要責任人。本集團同時判定，這些服務構成一系列日常服務，隨著時間推移逐步單獨實現，因為租戶在獲取服務的同時即消耗了本集團提供的服務效益。根據香港財務報告準則第15號的實務簡化規定，本集團依照有權開立發票的金額確認收入，因其有權獲得的對價金額與截至目前已完成履約部分對客戶的價值直接對應。

(v) 股息收入

非上市投資所得股息收入於本集團有權收取款項時確認。

(vi) 利息收入

利息收入按實際利率法確認。已發生信用減損的金融資產的利息收入依照該金融資產的攤餘成本(即帳面總額減去損失準備)計算。對於未發生信用減損的金融資產，依照帳面總額計算利息收入。

(n) 合約負債

合約負債是指本集團已向客戶收取對價(或應收對價金額)而向客戶轉移貨品或服務的義務。若收到的對價(包括從客戶收到的預付款)超過依產出法確認的收入，則本集團就差額確認合約負債。

Incremental costs of obtaining a contract, e.g. sales commissions, are capitalised if the costs relate to revenue which will be recognised in a future reporting period and the costs are expected to be recovered. Other costs of obtaining a contract are expensed when incurred.

Capitalised contract costs are stated at cost less accumulated amortisation and impairment losses. Amortisation of capitalised contract costs is recognised in profit or loss when the revenue to which the asset relates is recognised.

(p) Translation of foreign currencies

Foreign currency transactions during the year are translated at the foreign exchange rates ruling at the transaction dates. Monetary assets and liabilities denominated in foreign currencies are translated at the foreign exchange rates ruling at the end of the reporting period.

Exchange differences arising on the settlement of monetary items, and on the translation of monetary items, are recognised in profit or loss in the period in which they arise.

On consolidation, income and expense items of foreign operations are translated into the presentation currency of the Group (i.e. Hong Kong dollars) at the average exchange rates for the year, unless exchange rates fluctuate significantly during the period, in which case, the rates approximating to those ruling when the transactions took place are used. All assets and liabilities of foreign operations are translated at the rate ruling at the end of the reporting period. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity as exchange reserve. Exchange differences recognised in profit or loss of group entities' separate financial statements on the translation of long-term monetary items forming part of the Group's net investment in the foreign operation concerned are reclassified to other comprehensive income and accumulated in equity as exchange reserve.

(o) 合約成本

獲得合約的增量成本，例如如果成本與將在未來報告期間確認的收入相關且預期能夠收回，則銷售佣金應資本化。獲得合約的其他成本在發生時計入費用。

資本化合約成本以成本減去累計攤銷及減損損失列示。當與資產相關的收入得到確認時，資本化合約成本的攤銷在損益中確認。

(p) 外幣換算

年內進行的外幣交易按交易日的匯率換算。以外幣計值的貨幣資產及負債則按報告期末的匯率換算。匯兌收益及虧損於損益內確認。

於結算貨幣項目和換算貨幣項目產生的匯兌差額，在產生期間在損益確認。

合併賬目時，海外業務之收入及開支項目按年內平均匯率換算為本集團之呈列貨幣（即港元），惟倘期內之匯率大幅波動，則採用與進行交易時適用之匯率相約之匯率進行換算。海外業務之所有資產及負債按報告期末適用之匯率換算。所產生之匯兌差額（如有）於其他全面收益確認，並於權益中累計為匯兌儲備。就換算長期貨幣項目（構成本集團於有關海外業務之投資淨額之一部分）於集團實體各自之財務報表之損益賬內確認之匯兌差額，會重新分類為其他全面收益，並於權益內累計為匯兌儲備。

(q) Capitalisation of borrowing costs

Borrowing costs that are directly attributable to the acquisition, construction or production of an asset which necessarily takes a substantial period of time to get ready for its intended use or sale are capitalised as part of the cost of that asset. Other borrowing costs are expensed in the period in which they are incurred.

Capitalisation of borrowing costs is suspended or ceased when substantially all the activities necessary to prepare the asset for its intended use or sale are interrupted or completed.

5. CRITICAL ACCOUNTING JUDGEMENTS AND KEY SOURCES OF ESTIMATION UNCERTAINTY

In the application of the Group's accounting policies, the Directors are required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

(a) Valuation of investment properties and investment properties under development

As described in note 15, investment properties and investment properties under development are stated at fair value based on valuation performed by an independent firm of professional valuer.

In determining the fair value of investment properties and investment properties under development, the valuer has used a method of valuation which involves, inter-alia, certain estimates including appropriate discount rate, capitalisation rate and expected market rental growth rate. In relying on the valuation reports, management has exercised its judgement and is satisfied that the method of valuation is reflective of the current market conditions.

(q) 資本化借貸成本

借貸成本是由一項必須經過較長時期準備方可作擬定用途使用或出售的資產的收購、建設或生產而直接產生並予以資本化為該項資產成本的一部份。其他借貸成本於產生時計入費用。

當符合資本化條件的資產為達到擬定用途或銷售所需的絕大部分準備活動中斷或已完成，將暫停或停止借貸成本資本化。

於應用本集團會計政策時，本公司董事需要就不能從其他來源容易得出之資產和負債的賬面價值作出判斷，估計和假設。估計及相關假設乃基於過往經驗及其他相關因素。實際結果與估計有所差別。

該等估計及相關假設會持續檢討。修訂會計估計時，如有關修訂僅影響修訂估計之期間，則修訂會計估計會於該段期間確認；如修訂影響當期及以後期間，則於修訂期間及以後期間確認。

(a) 投資物業及發展中投資物業的估值

誠如附註15所述，投資物業及發展中投資物業乃基於獨立專業估值師作出的估值按公平值列示。

於釐定投資物業及發展中投資物業公平值時，估值師所採用的估值方法涉及（其中包括）若干估計，包括適當的貼現率、資本化比率及預計未來市場租金增長率。管理層依賴該估值報告時已行使其判斷，並信納估值法已反映當前市況。

(b) Estimated net realisable values of properties under development and held for sale

Management reviews the net realisable value of the Group's properties under development and held for sales at each reporting date. Appropriate write-down to estimated net realisable value is recognised in profit or loss when the carrying amount of the assets exceeds its net realisable value.

In determining whether write-down of properties under development and held for sales is required, the Group takes into consideration the intended use of the properties, the estimated costs of completion and estimated costs necessary to make the sale, the current market environment, the estimated market value of the properties and/or the present value of future cash flows expected to receive. If the market environment/circumstances or estimated costs of completion and estimated costs necessary to make the sale changes significantly, resulting in a decrease in the net realisable value of these properties interest, additional write-down may be required. As at 31 March 2026, the carrying amounts of properties under development and held for sales are \$1,014,226,000 (2025: \$1,482,569,000) (net of accumulated write-down of \$157,584,000 (2025: \$256,173,000)).

(c) Impairment of property, plant and equipment

The Group reviews its property, plant and equipment for indications of impairment at the end of each reporting period according to accounting policies set out in note 4(g). The recoverable amount is estimated based on projections of future cash flows from the assets based on management's assignment of a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset for assets which management considers are likely to be recoverable through continuing use or recent transaction prices of similar assets when they are available and depreciated replacement cost when appropriate for assets which management considers are likely to be recoverable through a sales transaction. If the estimation of recoverable amount is different, any impairment will impact the profit or loss of the Group.

(b) 發展中物業及持作出售物業之估計可變現淨值

管理層於各報告期末審閱本集團發展中物業及持作出售物業的可變現淨值。當資產賬面價值超過其預計可變現淨值時，相應減值差額會計入當期損益，將其賬面價值減至預期可變現淨值。

釐定發展中物業及持作出售物業是否需要撇減時，本集團會考慮此等物業之擬定用途、估計完工成本及估計必要銷售成本、現行市場狀況、此等物業之估計市場價值及／或預期收取之未來現金流量之現值。確認之撇減款額乃估計未來現金流量及估計市價兩者之較高者。如市場環境／情況或估計完成成本有重大轉變，而令該等物業權益之可變現淨值減少，則可能須作出額外撇減虧損。於二零二六年三月三十一日，發展中及持作出售物業的賬面值為1,014,226,000元（二零二五年：1,482,569,000元）（扣除累計撇減157,584,000元（二零二五年：256,173,000元））。

(c) 物業、廠房及設備減值

本集團在每個報告期末根據附註4(g)所載會計政策檢討其物業、廠房及設備是否出現減值跡象。可收回金額依據管理層指定可以反映當時市場對時間價值及資產特定風險之的評估稅前貼現率（用於管理層認為可能通過持續使用收回的資產）或類似資產近期的交易價格及經折舊重置成本（用於管理層認為可能通過銷售交易收回的資產）。若可收回金額的估算出現變動，任何減值將影響本集團的損益。

(d) Going concern

As disclosed in note 3(b), the consolidated financial statements have been prepared on a going concern basis. The appropriateness of using going concern basis is assessed by the management after taking into consideration all relevant available information about the future liquidity and performance of the Group, including the operating cash flow of the Group, the grant of waivers by the banks and availability of the banking facilities in the foreseeable future, successful disposal of the Target Properties. Such assessment involves uncertainties. Actual outcome could differ significantly and hence render the adoption of the going concern basis inappropriate.

6. SEGMENT REPORTING

The Group determines its operating segments based on the reports reviewed by the chief operating decision-maker that are used to make strategic decisions.

The Group has three reportable segments. The segments are managed separately as each business offers different products and services and requires different business strategies. The following summary describes the operations in each of the Group's reportable segments:

- Construction: construction of residential buildings, commercial buildings and data centres
- Property leasing: leasing of data centres and commercial shops
- Property development: development and sale of properties

(d) 持續經營

如附註3(b)所披露，綜合財務報表是在持續經營的基礎上編製的。使用持續經營基準的適當性由管理層在考慮本集團未來流動性和業績的所有相關資訊後評估，包括本集團的經營現金流、銀行授予豁免及在可預見將來取得銀行融資、成功出售目標物業。此等評估存在不確定性。實際結果可能會有很大差異，因此採用持續經營基礎是不合適的。

6. 分部報告

本集團按主要經營決策人依據審閱的報告而作出策略決定來釐定經營分部。

本集團有三個須申報分部。有關分部因各業務提供不同的產品及服務，需要不同的業務策略而作出獨立管理。以下概述闡明本集團各須申報分部的業務：

- 建築：建造住宅樓宇、商業樓宇及數據中心
- 物業租賃：出租數據中心物業及商舖
- 物業發展：發展及銷售物業

Inter-segment transactions are priced with reference to prices charged to external parties for similar transactions. Central income and expenses are not allocated to the operating segments as they are not included in the measure of the segment's result that is used by the chief operating decision-makers for assessment of segment performance. Finance costs are not allocated to segments because financing activities are the responsibility of the Group's central treasury function.

For the purposes of assessing segment performance and allocating resources between segments, the Group's most senior executive management monitors the results, assets and liabilities attributable to each reportable segment on the following bases:

- Segment assets include all tangible, non-current and current assets with the exception of investments in financial assets, current and deferred tax assets and other corporate assets. Segment liabilities include trade payables, accruals and other current and non-current liabilities attributable to the business activities of the individual segments and bank and other loans managed directly by the segment managers.
- Revenue and expenses are allocated to the reportable segments with reference to income generated by those segments and the expenses incurred by those segments or which otherwise arise from the depreciation or amortisation of assets attributable to those segments.

On discovery of the breach of covenants, the Directors informed the lender and requested waiver for the non-compliance of the relevant financial ratios. As at 31 March 2026, no waiver was obtained by the Group from the lenders. Since the lender has not agreed to waive its right to demand immediate payment as at the end of the reporting period, these loans had been classified as a current liability as at 31 March 2026.

29. CAPITAL RISK MANAGEMENT

The Group's primary objectives when managing capital are to safeguard the Group's ability to continue as a going concern in order to fund its construction business and property development and investment projects, provide returns for shareholders and benefits for other stakeholders and to maintain an optimal capital structure to reduce the cost of capital.

The Group actively and regularly reviews and manages its capital structure to maintain a balance between the higher shareholder returns that might be possible with higher levels of borrowings and the advantages and security afforded by a sound capital position, and makes adjustments to the capital structure in light of changes in economic conditions.

29. 資本管理風險

本集團管理資本的主要目標為保障本集團持續經營的能力，為本集團的建築業務以及物業發展和投資項目提供資金、為股東及其他利益相關者提供回報及利益以及維持最佳的資本架構以減低資本成本。

Under the extract terms of the major bank facilities, the Group is required to comply with the following financial covenants:

- consolidated tangible net worth shall not be less than \$1,200,000,000 to \$2,500,000,000;
- the ratio of consolidated net borrowings to consolidated tangible net worth shall not exceed 180% to 220%;
- consolidated EBITDA to consolidated finance charges shall not be less than 2.0 times;
- net gearing ratio shall maintain at or below 1.5 times;
- current ratio shall maintain at or above 0.5 to 1.0 times;
- tangible net worth of certain subsidiaries shall not less than \$700,000,000 to \$800,000,000; and
- EBITDA to finance charges of certain subsidiaries shall not less than 1.8.

The non-compliance of the financial covenants are disclosed in note 21(b).

As at 31 March 2026, the Group's current ratio (defined as current assets divided by current liabilities) was 0.22 times (2025: 0.32 times). The Group's net gearing ratio (defined as total interest-bearing borrowings less cash and bank balances and restricted and pledged deposits and divided by shareholders' equity) was approximately 245.1% (2025: approximately 206.9%).

Exposure to credit, liquidity and interest rate risks arises in the normal course of the Group's business. The Group's exposure to these risks and the financial risk management policies and practices used by the Group to manage these risks are described below.

(a) Credit risk

The Group's credit risk is primarily attributable to cash and bank deposits, financial assets at FVOCI, financial assets at FVTPL, derivative financial instruments and trade and other receivables. The Group maintains a defined credit policy and the exposures to these credit risks are monitored on an ongoing basis.

Cash, including restricted and pledged deposit, are deposited with financial institutions with sound credit ratings and the Group has exposure limit for any single financial institution. Transactions involving derivative financial instruments and debt investments are with counterparties of sound credit standing. Given their high credit ratings, management does not expect any of these financial institutions and counterparties will fail to meet their obligations.

Before entering into construction contracts, assessment of the potential customers is carried out as part of the acceptance procedures for the new contracts.

Regular review and follow-up actions are carried out on overdue amounts of trade receivables from customers which enable management to assess their recoverability and to minimise the exposure to credit risk. Trade receivables are due within 30 days from the date of billing. Normally, the Group does not obtain collateral from customers.

In respect of rental income from leasing properties, rental deposits are held to cover potential exposure to credit risk. An ageing analysis of the receivables is prepared on a regular basis and is closely monitored to minimise any credit risk associated with these receivables. Adequate impairment losses have been made for estimated irrecoverable amounts.

本集團面對的信貨、流動資金及利率風險乃在本集團正常業務過程中產生。本集團面對該等風險以及本集團為管理該等風險所採納的財務風險管理政策及措施如下。

(a) 信貸風險

本集團的信貨風險主要來自現金、銀行存款、按公平值計入其他全面收益之金融資產、按公平值計入損益之金融資產、衍生金融工具以及應收賬款及其他應收款項。本集團訂有明確的信貨政策，並持續監管該等信貨風險。

現金，包括受限制及已抵押存款，乃存放於信貸評級穩健的財務機構，而本集團就任何個別財務機構所承擔的風險有限。涉及衍生金融工具及債務工具的交易是與具良好信貸評級的對手方進行。鑑於彼等具有高信貸評級，管理層預期任何該等財務機構及對手方不會無法履行其責任。

訂立建造合約前，對潛在客戶的評估乃為新合約接納程序的一部分。

本集團對客戶的應收款項逾期金額進行定期檢討及採取跟進措施，使管理層得以評估其可收回性及將信貸風險降至最低水平。貿易應收款項自發票日期起零至三十日內到期。一般而言，本集團不會要求客戶提供抵押品。

就來自物業租賃的租金收入而言，本集團持有租賃按金以應付潛在的信貨風險。本集團定期編製應收款項的賬齡分析並作出密切監控，以將與該等應收款項有關的任何信貸風險降至最低水平。估計不可收回的數額已計提足夠的減值虧損。

At the end of the reporting period, the Group has significant concentration of credit risk in a few customers. In view of their credit standing, good payment record and long-established relationships with the Group, management does not consider the Group's credit risk to be significant. At the end of the reporting period, 38% and 46% (2025: 42% and 44%) of the total trade receivables were due from the Group's largest customer and the five largest customers respectively.

The Group does not provide any other guarantees which would expose the Group to credit risk as at 31 March 2026 and 2025.

Individual credit evaluations are performed on all customers. These evaluations focus on the customer's past history of making payments when due and current ability to pay, and take into account information specific to the customers as well as pertaining to the economic environment in which the customers operate. The Group generally requires customers to settle progress billings and retentions receivable in accordance with contracted terms and other debts in accordance with agreements.

The Group measures loss allowances for trade receivables at an amount equal to lifetime ECLs, which is calculated using a provision matrix. As the Group's historical credit loss experience does not indicate significantly different loss patterns for different customer segments, the loss allowance based on past due status is not further distinguished between the Group's different customer bases

本集團對所有客戶均會進行個別信用評估。此等評估專注於客戶過往的到期支付記錄以及當前的支付能力，或會考慮客戶特定資料以及客戶經營所在地的經濟環境。本集團通常要求客戶根據合約條款結算進度款項及應收保留金及根據協議結算其他債務。

(c) Interest rate risk

The Group is exposed to interest rate risk through the impact of rates changes on interest-bearing borrowings which predominantly bear floating interest rates. The Group monitors closely its interest rate exposure and the level of fixed rate and floating rate borrowings and considers hedging interest rate exposure should the need arise. The Group's interest rate profile as monitored by management is set out in note (ii) below.

The interest rates and terms of repayment of interest-bearing borrowings of the Group are disclosed in notes 21, 23 and 24 to the consolidated financial statements.

(i) Hedging

Interest rate swaps, denominated in Hong Kong dollars, have been entered into to achieve an appropriate mix of fixed and floating rate (mainly Hong Kong Interbank Offer Rate) exposure which was consistent with the Group's policy. At 31 March 2026, the Group had interest rate swaps with a notional principal amount of \$950,000,000 (2025: \$1,520,000,000), which it has designated as cash flow hedges of the interest rate risk inherent in its variable rate bank borrowings. At 31 March 2026 and 2025, the Group did not have any interest rate swaps which were not designated as cash flow hedging instruments.

The swaps will mature over the next two to four years and have fixed swap rates ranging from 2.85% to 3.67% (2025: 2.70% to 3.67%). The net fair value of swaps contracts entered into by the Group at 31 March 2026 was \$10,140,000 (2025: \$1,676,000). These amounts are recognised as derivative financial instruments (see note 22).

At 31 March 2026, it is estimated that a general increase/decrease of 100 basis points in interest rates, with all other variables held constant, would have increased/decreased the Group's loss for the year and decreased/increased total equity by approximately \$34,352,000 (2025: \$31,281,000).

As of 31 March 2026 and 2025, the Group does not have monetary assets and liabilities which are denominated in foreign currencies and thus has no material exposure to foreign currency risk.

Pursuant to an ordinary resolution passed at the annual general meeting of the Company held on 4 August 2023, the Company's new share option scheme (the "**New Scheme**") was adopted. The New Scheme is valid and effective for a term of 10 years commencing on 4 August 2023. Under the New Scheme, the Board may, at its own discretion, grant options to any full-time or part-time employees, executive, officers and directors (including non-executive and independent non-executive directors) of the Company and any of its subsidiaries.

The maximum number of shares in respect of which options may be granted under the New Scheme and any other share option schemes of the Company must not in aggregate exceed 10% of the total number of shares in issue on the date of approval for adoption of the New Scheme, being 142,012,234 shares (the "**Scheme Limit**"). Subject to Shareholders' approval in general meeting, the Board may (i) renew this limit at any time to 10% of the shares in issue as at the date of the approval by the Shareholders in general meeting; and/or (ii) grant options beyond the Scheme Limit to eligible participants specifically identified by the Board.

The total number of shares issuable upon exercise of the options granted under the New Scheme and any other share option schemes of the Company to each eligible participant in any 12-month period shall not exceed 1% of the shares in issue. Any further grant of options is subject to Shareholders' approval in general meeting with such eligible participant and his associates abstaining from voting.

The Petition was filed in relation to the outstanding payments under three invoices totaling an aggregate amount of approximately \$14,740,000 and was scheduled for hearing on 27 May 2026.

Subsequent to the reporting date, on 14 April 2026, GTC reached an agreement on settlement (the "**Settlement Agreement**") with the Petitioner. The Petitioner wrote to the Court on 29 April 2026 to seek leave to withdraw the Petition, and at the hearing of the Court held on 27 May 2026, the Master of the Court made an order granting leave to the Petitioner to withdraw the Petition.
