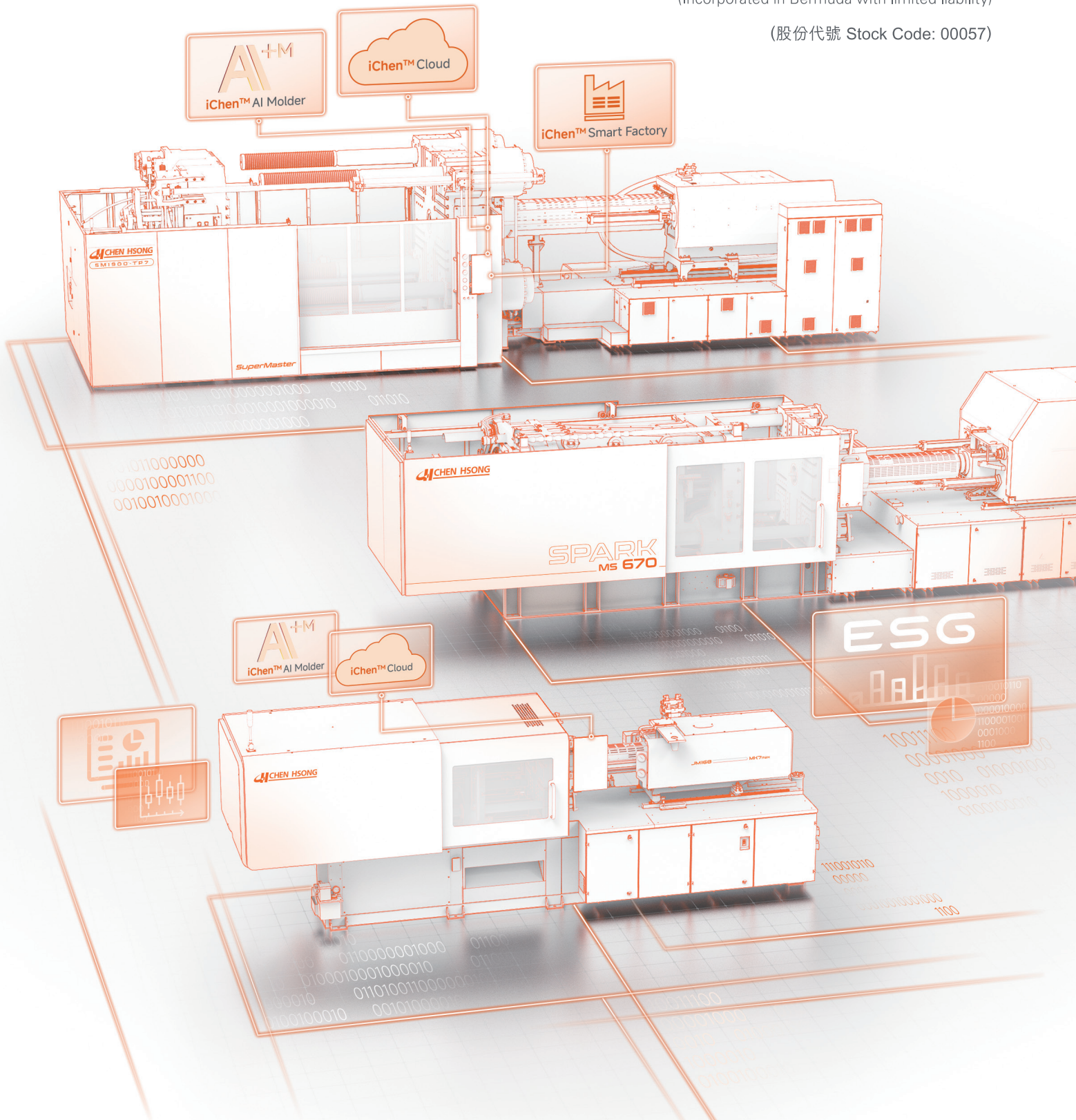

主席報告書

Chairman's Statement

業務回顧

截至二零二六年三月三十一日止財政年度，本集團營業總額為港幣24.65億元（二零二五年：港幣25.95億元），較上一財政年度下跌5%。權益持有人應佔溢利減少24%至港幣1.17億元（二零二五年：港幣1.54億元）。

本財政年度貿易緊張局勢以及地緣政治動盪急劇升級。其中最令人關注的是環球貿易市場出現一波又一波的報復性關稅措施，而美國與伊朗亦於本財年最後一個季度爆發正面軍事衝突。高關稅嚴重影響市場氛圍，令製造商推遲設備投資，直接影響了對我們注塑機的需求。

中國市場表現

國內中小企業在全球不明朗及原材料成本上漲的大環境下紛紛推遲設備採購，導致我們在中國內地和香港市場的業務略為下滑。下游消費品行業復甦慢於預期、信貸條件收緊以及激烈的價格競爭，進一步拖累了大中華區的市場表現。儘管如此，期內我們採取了果斷而積極的措施，推出了一系列專為對價格敏感的客戶而設計的高性價比產品線，成功捍衛我們的市場份額，並紓減業務下滑的幅度。

海外市場穩健

我們在海外市場錄得鼓舞增長，印證了本集團長期堅持擴張國際市場策略的成功。隨著跨國企業在「中國+1」的大趨勢下加快分散供應鏈，我們早期對關鍵新興市場的投資使我們成為客戶值得信賴的合作夥伴，其中越南、印尼、巴西及多個中東非洲市場的增長尤為顯著。

危中有機

我們深信所有風浪都會帶來機遇。全球供應鏈所出現的顛覆為本集團催生了兩個結構性機遇：首先，我們的「iChen Smart Family」平台（包括iChen Cloud、iChen Smart Factory及iChen AI Molder）提供人工智能驅動的模具調校服務，將數十年的專

Business Review

For the financial year ended 31 March 2026, the Group registered a total turnover of HK\$2,465 million (2025: HK\$2,595 million), a decrease of 5% on year-on-year basis. Profit attributable to equity holders decreased by 24% to HK\$117 million (2025: HK\$154 million).

This financial year was marked by an acute escalation of trade tension and geopolitical conflict, most notably the emergence of retaliatory tariff measures for global trade, combined with the outbreak of direct military confrontation between the United States and Iran during the last quarter of the financial year. High tariff measures significantly impacted market sentiment, compelling manufacturers to postpone investment in equipment, which in turn directly affected the demand for our machines.

China Market Performance

Our Chinese Mainland and Hong Kong markets declined slightly, as the domestic small and medium-sized enterprises (SMEs) delayed equipment purchases due to global uncertainty and rising raw material costs. Slower-than-expected recovery in downstream consumer goods sectors, tightening conditions for credit, and intense price competition further weighed on the China market performance. Nevertheless, we took decisive and proactive action by launching a series of cost-effective product lines tailored for price-sensitive customers, enabling us to defend our market share and limit the decline.

Overseas Market Resilience

Our overseas markets sustained an encouraging growth, demonstrating the success of our long-standing international expansion strategy. As multinational corporations accelerated supply chain diversification under the “China + 1” trend, our earlier investments in key emerging markets positioned us as a partner of choice. Growth was particularly strong in Vietnam, Indonesia, Brazil, and several markets in the Middle East and Africa.

Opportunities amid Crisis

We firmly believe that every crisis will bring us opportunities. Disruption to global supply chain has catalyzed two structural opportunities for the Group. Firstly, our “iChen Smart Family” platform (including iChen Cloud, iChen Smart Factory, and iChen AI Molder) provides clients with AI-driven mould setting services that digitalize our decades of

業手藝知識數位化，讓中小企客戶可以選擇適合其規模的方案來推進升級轉型。這正好解決了許多中小企客戶的痛點：他們毋須再繼續被動地「觀望」，現在就可以即時引入先進科技提升其競爭力。這同時亦為本集團創造經常性軟件收入的潛在商機。此外，面對激烈的價格競爭（尤其是中國客戶越趨對價格敏感），我們推出了策略性的成本效益產品線（包括G5系列、MK6.6/D系列、TP7系列和SPARK MS系列），以捍衛本集團的市場份額。同時，我們多年來持續在巴西、印尼、越南等新興市場建立在地據點，亦成功帶動海外銷售顯著增長。

未來展望

展望未來，我們預期地緣政治動盪及貿易保護主義將會持續。儘管如此，二零二六年標誌着中國「十五五規劃」實施的第一年，該規劃聚焦於「先進製造」及培育「新質生產力」，預期將推動國內製造業加快技術升級及設備更新。集團將繼續堅守審慎理財方針，持續投入深圳創新研發中心的建設，並透過海外據點擴大全球佈局。我們無法控制或迴避市場波動而導致的價格競爭，但我們會以務實態度，繼續強化自身業務戰略及管理——專注於創新、成本控制和客戶服務以把握市場機遇。我們深信我們的戰略部署潛力巨大，亦對我們的業務模式及團隊充滿信心。

manual expertise. Combined with our flexible service model, SME clients can power up their production with a fit-for-its-scale solution. This addresses the pain point of many SME clients: they can now access latest technology and enhance their competitiveness promptly without having to “Reluctantly Wait and See” anymore, while creating potential recurring software revenue opportunities for the Group. Secondly, in response to intense price competition (particularly in China where customers increasingly demand cost-effective machines), we strategically launched a series of cost-effective product lines (including the G5 Series, MK6.6/D Series, TP7 Series, and SPARK MS Series), to defend our market share in the price-sensitive segments. Meanwhile, our continuous expansion of local presence in emerging markets like Brazil, Indonesia, and Vietnam has successfully driven significant growth in our overseas sales performance.

Future Prospects

Looking ahead, we anticipate continuing geopolitical volatility and trade protectionism. Nevertheless, 2026 marks the first year of China's 15th Five-Year Plan, which focuses on “Advanced Manufacturing” and the cultivation of “New Quality Productive Forces”, and expects to accelerate technological upgrading and equipment renewal across domestic manufacturing industries. The Group will continue to adhere to prudent financial policy, continue to invest in our Centre for Innovation and Advanced Research in Shenzhen, and expand our global footprint through our overseas market presence. We cannot control or hide from the pricing competition arising from market volatility, but we will stay pragmatic, continue to strengthen our business strategy and management and focus on innovation, cost control, customer service to seize every market opportunity. We see significant potential in our strategic initiatives and have every confidence in the resilience of our business model and the dedication of our team.

Gratitude

On behalf of the Board of Directors, may I extend my heartfelt gratitude to all shareholders, customers, suppliers, business partners, bankers and stakeholders for their long-term support and trust, and to our management team and employees for their efforts and dedication over the years which have been the key to the Group's achievement today.

Management's Discussion & Analysis

業務表現

截至二零二六年三月三十一日止的財政年度，本集團錄得營業總額港幣24.65億元（二零二五年：港幣25.95億元），較去年下降5%。權益持有人應佔溢利下降24%至港幣1.17億元（二零二五年：港幣1.54億元）；每股基本盈利為港幣18.5仙（二零二五年：港幣24.5仙）。董事局建議本財政年度派發末期股息為每股港幣5.3仙（二零二五年：港幣8.0仙）。

全球經濟在本財政年度中經歷重大的結構性變革，由過往的自由貿易與供應鏈全球化，迅速地轉向單邊保護主義。在二零二五年四月份，美國政府對全球絕大部份的國家單方面開徵進口關稅，並與中國掀起了貿易戰，持續的貿易擾動及長期不確定性嚴重打擊了市場信心，全球經濟增長前景黯淡。

不過，在高關稅正式實施前，很多美國客戶為應對高關稅而增加進口以囤積庫存，使多國的出口都有增長、短暫拉動了生產活動。中國正好受惠於此波利好因素。隨著大部份國家其後陸續與美國政府達成關稅協議，出口活動逐漸降溫。受到美國關稅影響，本集團的客戶都開始推遲添置新設備，市場需求明顯減弱，競爭急速白熱化、整體價格水平下滑嚴重，對毛利率構成壓力。

美國的進口關稅情勢在本財政年度的下半年（即二零二六年初）變得峰迴路轉。美國最高法院裁定關稅違法，但各國尚未及慶祝，新的突發事件接踵而來：美國及以色列開展了中東戰事，一時間全球的主要石油產地烽火連天，國際油價急劇飆升，使塑膠原材料價格亦大幅上漲，嚴重打擊了塑料製品行業。

Business Performance

For the financial year ended 31 March 2026, the Group's total turnover declined by 5% to HK\$2,465 million (2025: HK\$2,595 million) as compared with previous year. Profit attributable to equity holders dropped by 24% to HK\$117 million (2025: HK\$154 million) while basic earnings per share declined to HK18.5 cents (2025: HK24.5 cents). The Board recommended the payment of a final dividend of HK5.3 cents (2025: HK8.0 cents) per share for this financial year.

The global economy underwent a significant structural change during the course of this financial year, with protectionism rapidly gaining ground from decades of free trade and globalisation. In April 2025, the USA government unilaterally imposed import tariffs on the vast majority of countries worldwide, as well as escalated a trade war with China. Constant trade tensions, persistent instability and rampant uncertainty severely hampered market confidence, a dark cloud looming over global economic growth.

Nevertheless, many USA customers went on a frantic buying spree, racing to stockpile all sorts of inventory before the import tariffs officially took effect, which led to a brief but remarkable export surge in many countries and a temporary production upswing. China, in particular, benefited greatly from this wave. However, as countries around the world started reaching tariff agreements with the USA, the surge of exports gradually cooled. The Group found its customers beginning to postpone purchasing new equipment, and as market demand weakened, price competition rapidly intensified, putting pressure on margins.

The USA import tariffs took an unexpected and abrupt turn during the second half of this fiscal year — in early 2026, the Supreme Court of USA ruled such tariffs illegal. But before global trade partners could breathe a sigh of relief, new bombshells followed (literally): the USA and Israel started the war in the Persian Gulf, plunging major oil-producing regions within range of tense military conflict and causing international crude oil prices to soar. This in turn led to a rapid spike in the price of plastic resin, with severe impacts upon the plastics processing industry.

更嚴重的後果是霍爾木茲海峽在二零二六年三月初(即本財政年度的最後一個月,傳統的行業旺季)被迫封閉,引致多國的燃料供應緊張,尤其以東南亞為甚。燃料短缺使很多發展中國家的工廠被迫限電停工,而全球海運費用亦隨之飆升,打亂了出口貿易及全球供應鏈的步伐。

總體來說,本集團在本財政年度的上半年得以維持平穩的業績。若以自然年度計算(即一至十二月份),在眾多的市場負面因素影響下,本集團二零二五年營業額相比二零二四年仍錄得接近10%的增長,遠超行業平均。然而,第四季度的連串突發事件,導致全球燃料短缺,使本集團的業務受到不可抗力的打擊。儘管本集團迅速啟動應變方案,控制原材料及運輸成本,但在財政年度的計算方式下,仍不免錄得營業額下降。

市場分析

中國內地經濟受房地產泡沫爆破、地方債務、消費信心低迷及通縮危機等因素影響,仍缺乏增長動力。縱使中國國內生產總值(GDP)增長仍然達到5%,再加上財年初期的一波囤貨訂單,但內需不振、美國關稅壓抑出口等不利因素,使製造業的景氣持續低迷,製造業採購經理指數(PMI)在本財年大多處於收縮區域,生產商投資意欲低迷,國內投資增長於本財政年度中開始插水式下滑,並在下半年加速陷入倒退。

But even more serious was the Strait of Hormuz closure in early March 2026, last month of the Group's financial year and traditional peak season, resulting in fuel shortages in many countries, especially Southeast Asia. Many factories in developing countries were forced to reduce production due to blackouts while global shipping costs soared, disrupting global trade and supply chain.

Overall, the Group managed to maintain flat turnover year-on-year during the first half. On a calendar year basis (i.e. January to December), the Group's revenue in 2025 actually registered nearly 10% growth from 2024, far exceeding industry average amid unfavourable market conditions. Only during the fourth quarter, factors such as sky-rocketing crude oil prices and global fuel shortages contributed to deal a material blow to the Group's normal business activities. Although the Group quickly responded with contingency plans to control raw material and transportation costs, a decline in turnover was still unavoidable under the fiscal year accounting basis.

Market Analysis

Breakdown of turnover, based on the location of customers, for the year ended 31 March 2026 is as follows:

Affected by issues such as the bursting of real estate bubble, local government debt burden, weak consumer confidence, and the deflationary pressure, the domestic economy in Chinese Mainland had been hampered over a long while and still lacks growth momentum. Even though China's Gross Domestic Product (GDP) growth still reached a respectable 5%, together with the surge in stockpiling exports at the beginning of this financial year, eventually weak domestic consumption and stiff USA tariffs led to reduced demand, heavily suppressing the manufacturing sector. The Purchasing Managers' Index (PMI) for Manufacturing remained in contraction territory during most of this financial year, and manufacturers proved wary to invest. In fact, gross domestic investments started plummeting sharply since the middle of this financial year, dipping into negative during the second half.

在本財政年度的下半年，傳統的旺季中發生的中東戰爭，直接導致全球燃料短缺及航運停擺（尤其影響中東及非洲國家）。本集團的中國銷售受到國內消費乏力、美國關稅壓抑出口的雙重打擊，影響尤以中小型客戶為甚，並使市場競爭日趨白熱化。雖然在期內本集團憑藉新產品、新技術及優秀的服務，成功打入一些大型企業，特別是新能源汽車行業，但總體來說，本集團的中國內地及香港營業額仍然較去年倒退11%至港幣16.4億元（二零二五年：港幣18.4億元）。

台灣市場表現相對平穩，儘管主要的出口地（歐美市場）同樣受美國關稅政策影響，惟營業額只下降5%至港幣3,700萬元（二零二五年：港幣3,900萬元）。

在國際市場方面，美國仍然是一枝獨秀，得以維持健康的GDP增長，但代價是其他國家深受地緣衝突、中東戰爭、貿易糾紛、關稅及能源短缺等一系列負面因素影響，幾乎無一倖免。美國的好景氣與其他地區的普遍性經濟增速停滯、通脹上揚、債務利率高據不下及財政赤字惡化等情況，構成巨大落差。受航運中斷和美國關稅影響，全球貿易動力大幅放緩，其中歐洲受到戰禍、關稅、航運及能源等多方面同時夾擊，而東南亞國家則主要面對燃油與電力缺乏，使生產活動持續受壓。

本集團在本財政年度的上半年，受惠於多年的全球網絡佈局、開設區域性子公司及服務中心等投資，於國際市場的增長勢態仍然強勁。惟隨著上述的不利事件接踵而來，加上保護主義抬頭及印度「反傾銷」關稅落實，使本集團在下半年開始舉步維艱，但最終國際市場全年的營業額仍較去年增長10%至港幣7.85億元（二零二五年：港幣7.16億元）。

The Persian Gulf conflict occurred at the traditional peak season during the second half of this financial year, causing global fuel shortages and severe disruptions in ocean freight (in particular those bound for Middle Eastern and African destinations). The Group's turnover in China was hit by a double whammy of weak domestic demand and suppressed exports due to tariffs in the USA, with small-to-medium-sized customers suffering the biggest impact. Market competition became intense, but the Group still successfully penetrated some large enterprises, especially in EV's, with new products, new technologies, and superior service. Nevertheless, the Group's turnover in Chinese Mainland and Hong Kong still declined by 11% year to HK\$1.64 billion (2025: HK\$1.84 billion).

Taiwan market performed comparatively more steady even when its major trading partners (Europe and the USA) were all affected by the USA import tariffs. Total turnover only declined by 5% to HK\$37 million (2025: HK\$39 million).

Internationally, the USA remained the undisputed star with healthy GDP growth but at the cost of many others countries suffering geopolitical conflicts, wars, trade disputes, tariffs, and energy shortages. Almost no country was spared any impact, the economic wellbeing in the USA being a stark contrast to conditions of all other world regions. Affected by shipping disruptions and US tariffs, global trade momentum slowed significantly. Europe, in particular, was hit simultaneously on multiple fronts — wars, tariffs, shipping and energy prices, while Southeast Asian countries primarily faced blackouts due to fuel shortages, severely hampering manufacturing activities.

The Group registered strong growth in international markets during the first half of this financial year, benefiting from years of proactive investments in its global sales network of regional subsidiaries and service centres. However, unfavourable market conditions coupled with rising protectionism and anti-dumping duties in India made the second half much more challenging. In the end, the Group still managed to grow turnover in international markets by 10% to HK\$785 million (2025: HK\$716 million).

新技術及新產品開發

在本財政年度上半年，本集團推出具行業突破性的「AI Molder」智能調機服務，相關詳情已於2025/26中期報告中闡述。

除此以外，本集團成功為某家大型一級汽車零部件供應商交付全套MES平台。該項目聚焦注塑車間核心運營環節，涵蓋設備物聯、生產計劃與調度、質量追溯、物料協同及產品入庫等關鍵業務流程，實現了從工單下達到成品入庫的全流程數字化閉環管理。

通過實時數據採集、生產過程透明化管理與精益生產理念的結合，該平台協助客戶大幅度提升對生產過程的管控能力，優化設備利用效率與質量穩定性，以及改善在製品庫存管理及異常響應效率，進一步增強其交付韌性與成本競爭力。該項目的成功落地，驗證了本集團在複雜製造場景下的數字化運營管理、系統集成及項目交付能力。

Development of New Technologies and New Products

During the first half of this financial year, the Group launched the industry-breaking “AI Molder” intelligent machine-tuning service — an intelligent AI agent assisting in one of the most difficult aspects of plastics injection moulding, details of which had been described in the 2025/26 interim report.

In addition, the Group also successfully implemented a complete MES platform at a major Tier-1 auto-parts supplier. The project focused on core operational aspects of the injection moulding workflow, covering key processes such as IoT connectivity for production equipment, production planning and scheduling, quality tracing, material logistics and product warehousing, and achieved full-process digital closed-loop management from work order issuance to finished product warehousing.

Through combining real-time data acquisition, transparent production process control, and lean manufacturing principles, this platform helped the Group's customer significantly improve their control over the production process, optimise equipment utilisation efficiency and quality stability, and improve work-in-progress inventory management and abnormal response efficiency. It added resilience to the customer's delivery capabilities and raised cost competitiveness. The successful completion of this project showcased the Group's strengths in MES, systems integration and project delivery involving complex manufacturing scenarios.

此外，在本財政年度的下半年，本集團經過仔細的市場調研，也陸續更新了產品線以更貼合市場客戶需求，其中包括：

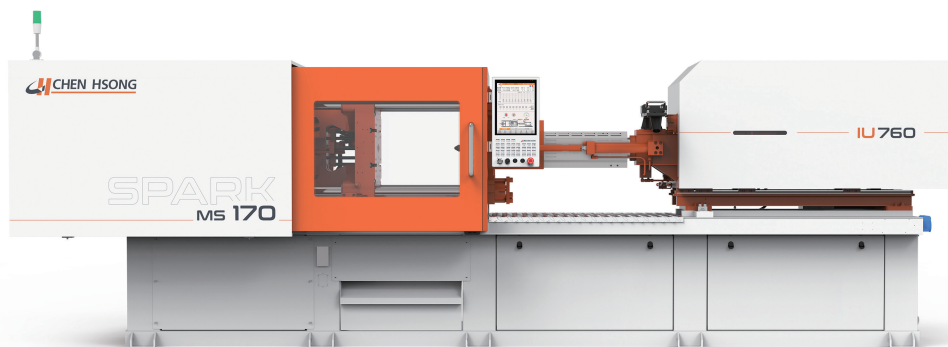
- 全新MK6.6/D機型：取代原來的MK6.6/A、B及C型產品，綜合各產品線優點、提升客戶產能、品質及效益；
- 全新G5（第五代）系列：取代原來的入門級G系列，性價比更高；
- 全新一代TP7大型二板機系列：取代原來的TP系列，性能增強、穩定性全面提升；及
- 全新MS系列經濟型電動機：讓客戶輕鬆投入全電動高質生產力。

本集團計劃於來年全面升級現有的MK6（第六代）產品至MK7（第七代）。除了優化性能外，升級還將提升多種智能及聯網功能，例如「AI Molder」調模助手及「iChen Smart Family」綜合系統，使本集團的客戶無縫地邁進智能生產領域。

Furthermore, during the second half of this financial year, the Group updated its main product lines, after careful market research, to better meet market and customer needs. They include:

- The new MK6.6/D which replaces the original MK6.6/A, B and C models, combining the advantages of each to help enhance customer productivity, quality, and efficiency;
- The new G5 (the fifth generation) series replaces the original entry-level G series, offering even better value for money;
- The new TP7 series of large-tonnage two-platen machines replaces the original TP series, with enhanced performance and improved stability; and
- The new MS series of economical, all-electrics, empowering customers to easily achieve high-quality all-electric productivity.

The Group also plans to upgrade its existing MK6 (the sixth generation) product lines to MK7 (the seventh generation) during the coming financial year. In addition to optimise performance, the upgrades will also include enhanced intelligence and connectivity, such as the “AI Molder” smart moulding assistant and “iChen Smart Family” integrated systems, which enable the Group’s customers to effortlessly add smart manufacturing to their repertoire.

生產產能與成本控制

由於國內以及全球業務環境充滿不確定性，使基礎設備投資意欲持續疲弱。本集團遂聯合國際頂尖的顧問團隊，以積極優化成本效益為目標，加速在各主要生產基地落實「精益生產」改革，包括逐步推行計件制薪酬，激發員工自覺驅動，並已取得初步成果。在產品品質、生產效率及產能利用率等方面亦均有顯著的提升。

與此同時，本集團積極響應國家「新質生產力」戰略，以「數智轉型」為生產基地賦能，搭配自主研发的AIoT與MES平台，分階段實現全設備互聯、並加強投入AI應用（如AI自動回報工時），打造OEE與能耗精細化管理閉環。

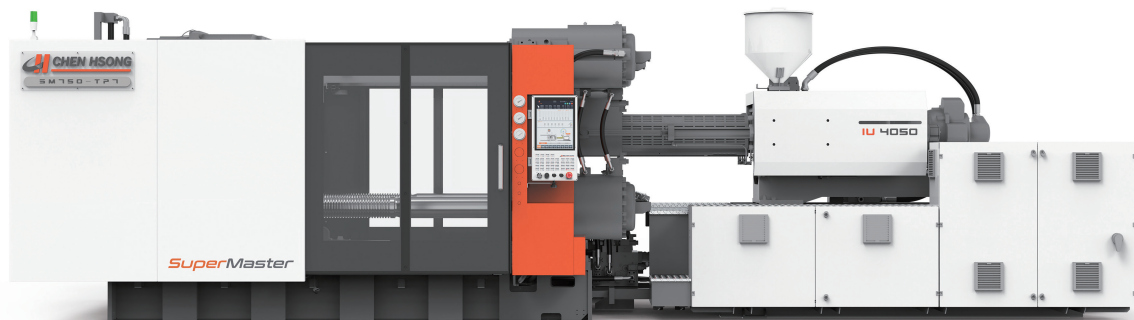
面對激烈的價格競爭，本集團加強供應鏈集採戰略，在關鍵零部件領域建立中長期戰略合作關係，並對瓶頸物料廣泛尋源、全面對標。

Production Capacity and Cost Control

Due to uncertainties in domestic and international business environments, general sentiments remain weak especially with regard to capital investment. The Group thus accelerated adoption of “Lean Manufacturing” reforms at major manufacturing bases, together with a world-leading consultant, with the goal of actively optimising cost-effectiveness. This included the gradual implementation of piece-rate wages that provided better self-initiation and motivation, with encouraging results. Significant improvements were also seen in all areas, including product quality, production efficiency, and capacity utilisation.

At the same time, in a bid to fulfill the national initiative of “New Quality Productivity”, the Group had transformed its major manufacturing facilities by empowering them through “Digital and Intelligent Transformation”, coupled with self-developed AIoT and MES platforms, achieving full equipment connectivity in stages and increasing investment in AI applications (such as AI-automated working hour reporting) to create a closed-loop system for refined OEE and energy consumption management.

In face of fierce price competition, the Group had strengthened its supply chain through a centralised procurement strategy, established medium-to-long-term strategic partnerships for all key components, and expanded extensive sourcing network for mission-critical materials.

財務回顧

流動資金及財務狀況

Financial Review

Liquidity and Financial Conditions

As at 31 March 2026, the Group had net current assets of HK\$2,052 million (2025: HK\$1,998 million). Cash and bank balances (including pledged deposits) amounted to HK\$1,056 million (2025: HK\$667 million), representing an increase of HK\$389 million as compared to last year. As at 31 March 2026, the Group had no bank borrowings (2025: Nil). The Group recorded a net cash position of HK\$1,056 million (2025: HK\$667 million), representing an increase of HK\$389 million as compared to last year.

The gearing ratio of the Group is measured as total borrowings net of cash and bank balances divided by total assets. The Group had a net cash position as at 31 March 2026. As a result, no gearing ratio was presented.

It is the policy of the Group to adopt a consistently prudent financial management strategy, sufficient liquidity is maintained to meet the funding requirements of the Group's capital investments and operations.

Charge on Assets

As at 31 March 2026, bank deposits of certain subsidiaries of the Group in the amount of HK\$243 million (2025: HK\$139 million) were mainly pledged for securing the issuance of bank acceptance notes, recorded in the trade and bills payables, to suppliers. In addition, as at 31 March 2026, bills receivable of a subsidiary of the Group in the amount of HK\$12 million (2025: HK\$149 million) was pledged for securing the issuance of bank acceptance notes, included in the trade and bills payables, to suppliers.

As at 31 March 2026, the Group had capital commitments of HK\$9 million (2025: HK\$22 million), mainly in respect of the construction and upgrading of industrial facilities, the purchases of production equipment in Chinese Mainland, as well as the purchase of warehouse in Europe which are to be funded by internal resources of the Group.

Significant Investments, Acquisitions and Disposals

The Group did not make any significant investments, acquisitions or disposals in relation to its subsidiaries and associated companies during the year ended 31 March 2026.

Future Plans for Material Investments or Capital Assets

As at 31 March 2026, the Group had no specific plan for material investments or capital assets.

Financial Assistance and Guarantees to Affiliated Companies by the Company

As at 31 March 2026, the Company had not provided any financial assistance and guarantees to affiliated companies which is subject to disclosure requirement under Rule 13.22 of the Rules Governing the Listing of Securities (the “Listing Rules”) on The Stock Exchange of Hong Kong Limited (the “Stock Exchange”).

Advance to an Entity Provided by the Company

As at 31 March 2026, the Company had not provided any advance to an entity which is subject to disclosure requirement under Rule 13.20 of the Listing Rules.

資金及外幣風險管理

本集團在資金管理方面，採取穩健的理財策略，資金主要以港元、人民幣、新台幣、美元及歐元持有，並一般以短期或中期存款存放於銀行，作為本集團的流動資金。

本集團亦不時對若干波動較大的外幣風險作出評估，以合適之方法減低有關的風險。

本集團於中國內地有重大投資，並知悉任何人民幣匯率波動將對本集團的淨溢利有所影響。但由於本集團之交易多以人民幣結算，故該匯兌差額對本集團的實際營運及現金流不構成直接影響。

Treasury and Foreign Exchange Risk Management

The Group adopts a prudent approach in managing its funding. Funds, primarily denominated in the Hong Kong Dollar, the Renminbi, the New Taiwanese Dollar, the United States Dollar and the Euro, are generally placed with banks as short or medium term deposits for working capital of the Group.

The Group, from time to time, assesses the risk exposure on certain volatile foreign currencies and manages it in appropriate manner to minimize the risk.

The Group has substantial investments in Chinese Mainland and is aware that any fluctuation of the Renminbi would have an impact on the net profits of the Group. However, since most of the transactions of the Group are conducted with the Renminbi, the exchange differences have no direct impact on the Group's actual operations and cash flows.

Contingent Liabilities

As at 31 March 2026, the Group did not have any significant contingent liabilities (2025: Nil).

Relationship with Customers and Suppliers

It has long been the Group's motto to "Our Customer's Need is Our Command" and to the maximum extent possible the Group puts the interests and needs of our customers as its primary reason of being. This includes providing the Group's customers with the best designed products, and timely and appropriate pre/after-sales services. Similarly, the Group strictly selects high-quality suppliers and views its suppliers not as mere vendors but as strategic partners and important links in its supply chain. It is the Group's procurement policy to maintain good relationship and communications with suppliers based on the principle of mutual trust.

In the end, the ultimate goal of the Group with regards to customers and suppliers is "Win-Win".

環境政策及表現

於本年度內及直至本報告日期，董事局並不知悉存在對本集團業務及營運造成重大影響之適用法律及法規之任何不合規情況。

Environmental Policies and Performance

The Group is committed to enhancing environmental protection, minimizing the impact of its activities on the environment, and complying with applicable environmental laws. The Group has implemented effective Environmental Protection Policy (the "Policy") that enables the Group to making progress in environmental protection.

Under the Policy, the Group focuses on promoting clean production, and strives to making the most efficient use of resources in its operations, and minimizing waste and emission. The Group achieves this aim through actively re-designing its activities and production methods that encourage and promoting recycling of resources, using environmentally-friendly raw materials and reviewing production operations constantly to ensure that the processes are effective and efficient.

The Group enlists its support by engaging and promoting environmental protection among its suppliers and customers and implementing training programmes that raise environmental protection awareness among its employees. Through realistic and achievable key performance targets, the Group measures the impact of its activities on the local environment continuously, and conducts research and explores potential innovative green alternatives that support a green environment.

Compliance with Laws and Regulations

The Group's operations are mainly carried out by the Company's subsidiaries in Chinese Mainland, Hong Kong and Taiwan, while the Company itself is listed on the Stock Exchange. The Group accordingly shall comply with relevant laws and regulations in Chinese Mainland, Hong Kong, Taiwan and the respective places of incorporation of the Company and its subsidiaries.

During the year and up to the date of this report, the Board was unaware of any non-compliance with the relevant laws and regulations that have a significant impact on the business and operations of the Group.

人力資源

於二零二六年三月三十一日，本集團的全職僱員總數約為2,600名(二零二五年：2,700名)。本集團為僱員提供完善之薪酬及福利條件，薪酬維持於具競爭力水平，而僱員之回報取決於其個人表現及本集團業績表現。

於人才培訓方面，本集團透過定期為僱員提供教育、專業培訓及生活輔導等活動，不斷提升員工質素、專業知識水平及團隊精神。

來年展望

展望來年，世界局勢仍然處於極度不穩定的狀態。首先，美國政府大概將會啟動其他措施及貿易壁壘，以圖重構其全球貿易關稅政策。除此以外，中東局勢持續不穩，令原油價格供應持續波動。本集團預料至少來年的上半財政年度仍然會充滿變數，打擊全球投資者與消費者信心，使市場需求疲弱。而價格競爭在供過於求和長期投資意欲薄弱的情況下，亦會異常激烈。

本集團將積極地面對挑戰，以新技術，優化的新產品及優質的客戶服務，來提升市場競爭力，保持運營效率優勢。同時，本集團亦將繼續開源節流以應付價格壓力，並維持穩健的風險管控。

Human Resources

As at 31 March 2026, the Group had approximately 2,600 (2025: 2,700) full-time employees. The Group offers good remuneration and welfare packages to its employees and maintains market-competitive pay levels. Employees are rewarded based on individual as well as the financial performance of the Group.

The Group conducted regular programmes, including comprehensive educational and professional training, and social counselling activities, to its employees to enhance staff quality, standards of professional knowledge and teamwork spirit.

Prospects for the Coming Year

Looking forward, global market conditions will remain highly volatile. The USA government is likely to pile on new policies and trade barriers in an attempt to reassert its global import tariffs strategy. Furthermore, instability in the Persian Gulf will continue to cause big fluctuations in crude oil prices and supply. The Group anticipates high uncertainty at least persisting into the first half of the coming financial year, which will continue to dampen investor and consumer confidence worldwide, and significantly weaken market demand. Price competition is anticipated to be exceptionally fierce given over-supplied and weak market sentiments.

The Group shall actively face these challenges through leveraging new technologies, optimised new product lines as well as improved customer service in order to enhance its market competitiveness and maintain operational efficiency advantages. At the same time, under these circumstances, the Group will remain especially prudent especially with regard to cost control and risk management.

根據守則條文第B.2.2條之規定，每名董事應至少每三年一次輪流退任。董事（除董事局主席外）須至少每三年一次輪流退任，因根據百慕達一九九一年震雄集團有限公司公司法，本公司主席及董事總經理毋須輪流退任。

根據守則條文第C.2.1條之規定，主席與集團總裁的角色應有區分，並不應由一人同時兼任。蔣麗苑女士為本公司董事局主席兼集團總裁。鑒於蔣女士的技能和經驗以及彼長期服務於本集團，該架構可視為適合本集團，並可為本集團提供強大且貫徹的領導力，為業務提供有效及高效的規劃及決策，以及能執行長期業務策略。

CORPORATE GOVERNANCE PRACTICES

The board of directors (the “Director(s)”) of the Company (the “Board”) recognizes the importance of good corporate governance practices in safeguarding the interests of the shareholders of the Company (the “Shareholder(s)”) and enhancing the performance of the Company and its subsidiaries (the “Group”). The Board is committed to maintaining and ensuring a high standard of corporate governance practices. The Board reviews codes of conduct, policies and practices, corporate governance framework and disclosures of this report, from time to time, to improve the Company’s corporate governance practices in respect of the latest developments on all applicable laws, rules and regulations.

COMPLIANCE WITH CORPORATE GOVERNANCE CODE

Throughout the year ended 31 March 2026, the Company has complied with all the code provisions of the Corporate Governance Code (the “CG Code”) as set out in Part 2 of Appendix C1 to the Rules Governing the Listing of Securities (the “Listing Rules”) on The Stock Exchange of Hong Kong Limited (the “Stock Exchange”), except for the following deviations:

Code provision B.2.2 provides that every director should be subject to retirement by rotation at least once every three years. The Directors (except the Chairman of the Board) are subject to retirement by rotation at least once every three years as the Chen Hsong Holdings Limited Company Act, 1991 of Bermuda provides that the chairman and the managing director of the Company are not required to retire by rotation.

Code provision C.2.1 provides that the roles of chairman and chief executive officer should be separate and should not be performed by the same individual. Ms. Lai Yuen CHIANG is the Chairman of the Board and Chief Executive Officer of the Company. Given the skills and experience of Ms. CHIANG and her long term of service with the Group, this structure can be considered appropriate to the Group and can provide the Group with strong and consistent leadership for effective and efficient business planning and decisions, as well as execution of long term business strategies.

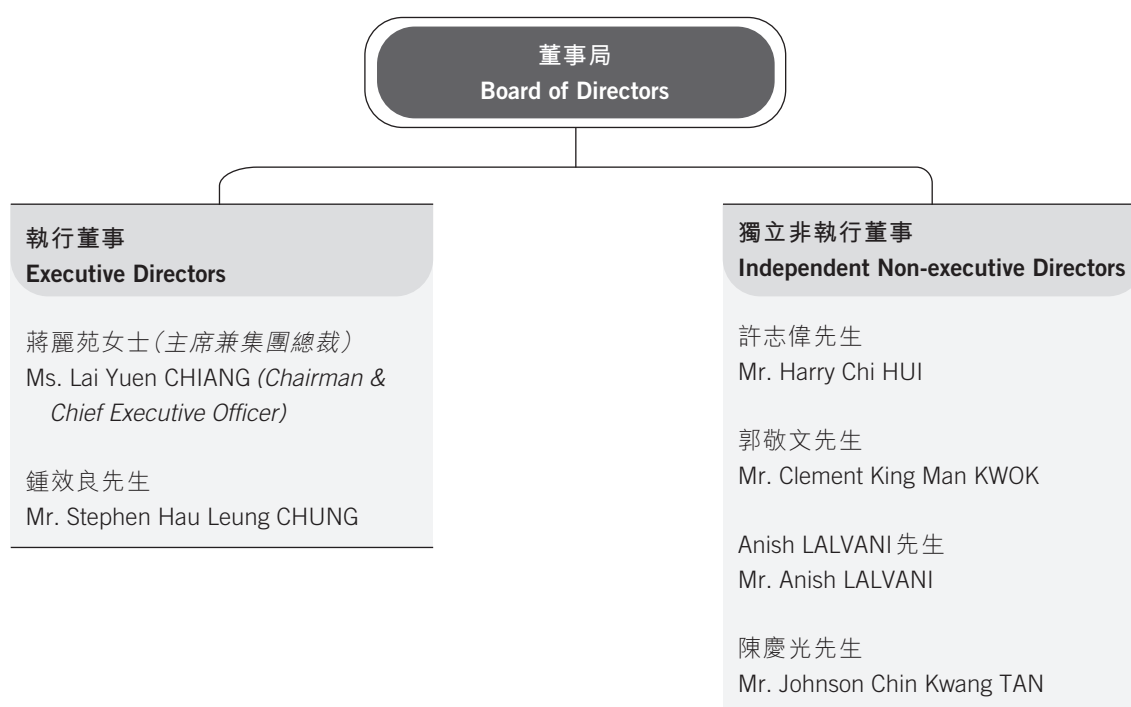

董事局成員多元化政策

董事局於二零二二年十一月採納及修訂董事局成員多元化政策（「該政策」），該政策為達致董事局成員多元化而制訂的方案。該政策摘要如下：

- 於至少每年一次檢討董事局的架構、人數及成員多元化時，提名委員會將考慮多方面的多元化因素，當中包括但不限於性別、年齡、文化及教育背景、專業資格及經驗、技能、知識、任期和行業及區域經驗（「董事局成員多元化準則」），並就任何為配合本公司企業策略而擬對董事局作出的變動提出建議。
- 於物色及提名適當人選為董事局成員時，提名委員會將會考慮董事局成員多元化準則。
- 提名委員會將每年在適當時候檢討該政策的實施，因應最新企業管治準則討論任何或需作出的修訂，再向董事局提出修訂建議，由董事局審查、審批，以確保該政策之有效性。

董事局重視本集團各個層面的多元化（包括性別多元化）。於本報告日期，董事局由六名董事組成，其中一名是女性，比率為16.7%。董事局認為董事局成員性別多元化已達到。董事局的目標是維持現時其女性成員比例的水平，提名委員會將每年審查該目標。

董事局已根據董事局成員多元化準則檢討其架構、人數及成員多元化，並認為目前董事局的組成具多元化，在文化及教育背景、專業資格、經驗、技能及知識方面均保持適當平衡。董事局滿意董事局及各董事委員會的多元化程度，並認為董事局成員多元化政策已於年內有效地實施。

Board Diversity Policy

The Board adopted and revised the Board Diversity Policy (the “Policy”) in November 2022 which sets out the approach to achieve diversity on the Board. The Policy is summarized below:

- In reviewing the structure, size and diversity of the Board at least annually, the Nomination Committee will consider a number of aspects of diversity, including but not limited to gender, age, cultural and educational background, professional qualifications and experience, skills, knowledge, length of service and industry and regional experience (the “Board Diversity Criteria”) and make recommendations on any proposed changes to the Board to complement the Company’s corporate strategy.
- In selection and nomination of qualified individuals to become Board members, the Nomination Committee will consider the Board Diversity Criteria.
- The Nomination Committee will review the implementation of the Policy on an annual basis, as appropriate, discuss any revisions in line with the latest corporate governance standards that may be required, and recommend any such revisions to the Board for review, consideration and approval to ensure the effectiveness of the Policy.

The Board emphasizes diversity (including gender diversity) across all levels of the Group. As at the date of this report, the Board comprises six Directors, one of whom is female, representing 16.7%. The Board considers that gender diversity on the Board has been achieved. The Board targets to maintain the current level of its female representation and this target will be reviewed annually by the Nomination Committee.

The Board has reviewed its structure, size and diversity based on the Board Diversity Criteria and believes that the current Board composition is diverse, with a well-balanced mix of cultural and educational backgrounds, professional qualifications, experience, skills and knowledge. The Board was satisfied with the diversity of the Board and each Board Committee, and considered that the Board Diversity Policy has been effectively implemented during the year.

員工多元化政策

本公司於二零二五年十一月採納員工多元化政策，該政策載述本集團致力於營造一個多元、包容且公平的工作環境，讓所有員工無論其背景如何，均能感受到被重視、尊重，並充分發揮潛能。本集團認為，多元化能推動創新、提升決策質素，並增強服務本集團持份者的能力。

鑑於本集團的業務性質為工業製造公司，業界普遍存在男性員工比例較高的情況。因此，本集團並無就一般員工的性別比例設定任何特定的可計量目標。相反，本集團著重因材施教，甄選適合崗位的人才，同時考慮多方面的多元化因素，包括性別。本集團致力於在所有營運層面維護多元共融，並採取必要措施，確保遵守現行有關員工多元化的規則及規例。

截至二零二六年三月三十一日，本集團員工（不包括本公司的高級管理人員）的性別比例為80.03%男性及19.97%女性，本公司高級管理人員的性別比例為50.0%男性及50.0%女性。鑑於本集團業務及營運性質需要大量技術人員及勞動力，因此本集團相信目前員工性別比例在合理範圍內。本集團將根據實際情況不時檢討該等措施與常規的效用。特別是本集團將持續監控性別比例，並致力於在僱用本集團內所有職位時實現最佳的性別多元化。有關員工性別多元化的詳情，請參閱本公司之「環境、社會及管治報告2025/26」。

Workforce Diversity Policy

The Company adopted the Workforce Diversity Policy in November 2025 which sets out the Group's commitment to fostering a diverse, inclusive and equitable workplace where all employees, regardless of their background, feel valued, respected, and empowered to contribute to their fullest potential. The Group recognizes that diversity drives innovation, enhances decision-making and strengthens the ability to serve the Group's stakeholders.

Considering the business nature of the Group as an industrial manufacturing company, it is common to see a higher proportion of male employees in this industry. Therefore, the Group does not set any specific measurable objectives in respect of the gender ratio for the general workforce. Instead, the Group's focus is on identifying the right person for the right role while taking into account diversity in a range of areas, including gender. The Group remains committed to upholding diversity and inclusion across all aspects of its operations and taking necessary steps to ensure compliance with the prevailing rules and regulations related to workforce diversity.

As at 31 March 2026, the gender ratio in the workforce (excluding the senior management of the Company) of the Group comprised 80.03% male and 19.97% female. The gender ratio in the senior management of the Company comprised 50.0% male and 50.0% female. As the Group's nature of the business and operation requires significant technicians and manual labour, the Group believes that the gender ratio of the current workforce is within a reasonable range. The Group will from time to time review the effectiveness of the measures and practices according to the actual circumstances of the Group. In particular, the Group will continue to monitor the gender ratio aiming at achieving a greater gender diversity in hiring all positions across the Group. Board Independence Policy

本公司深明董事局的獨立性對良好企業管治至關重要。為確保董事局能夠獲得獨立的觀點和意見，董事局採納了董事局獨立性政策，該政策旨在規定適用於董事局及其成員的獨立性要求和標準，詳細說明了在企業治理框架內建立的機制。該政策亦具體列出了董事局在評估每位董事獨立性時所考慮的因素，並確定了將從每位董事收集的資訊以進行此評估。

The Company recognises that the Board independence is critical for good corporate governance. To ensure that the independent views and inputs are available to the Board, the Board adopted the Board Independence Policy which aims to set forth the independence requirements and standards applicable to the Board and its members, detailing the mechanisms established within the corporate governance framework. It also specifies the considerations the Board will take into account when assessing the independence of each Director and identifies the information that will be collected from each Director for this assessment.

The Company has received annual confirmations of independence from each Independent Non-executive Director in accordance with Rule 3.13 of the Listing Rules.

Moreover, the Independent Non-executive Directors do not hold any cross-directorships or have significant links with other Directors through involvement in other companies or entities that could create conflicts of interest in their roles. They are not involved in the daily management of the Company and are free from any relationships or circumstances that could impair their independent judgment.

During the financial year ended 31 March 2026, the Corporate Governance Committee conducted an annual review on behalf of the Board to assess the implementation and effectiveness of the independence mechanisms to ensure that independent views and inputs were available to the Board.

The Nomination Committee and the Board considered that (i) all Independent Non-executive Directors who served during the year were and continued to be independent in accordance with the independence guidelines set out in Rule 3.13 of the Listing Rules, (ii) there were no business or other relationships or circumstances likely to affect the judgment of any Independent Non-executive Directors, and (iii) they continued to provide independent perspectives in Board discussions and strategic oversight.

Considering all circumstances described in this section, the Company considers all of the Independent Non-executive Directors to be independent.

於截至二零二六年三月三十一日止之財政年度內，主席亦與獨立非執行董事舉行一次沒有其他董事出席的會議。

董事局定期會議的議程及會議文件於每次董事局會議日期前至少三天全部送交所有董事。全體董事均有權取得董事局文件及相關資料，及可在適當的情況下尋求獨立專業意見，費用由本公司支付。所有董事可取得公司秘書的意見和享用他的服務，以確保董事局程序和適用之規則及規例均獲得遵守。

根據現行董事局常規，任何涉及主要股東或董事利益衝突的重大交易或事宜，須經由正式召開的實體董事局會議中處理，並要求無重大利益關係的獨立非執行董事出席。任何於交易或事宜擁有重大利益的董事或其緊密聯繫人須在批准該等交易的會議中放棄表決及不獲計入法定人數內。

Board Process

The Board held five meetings throughout the year at approximately quarterly intervals to review the overall strategies and the operating and financial performance of the Group. The Company Secretary assists the Chairman in setting the agenda for Board meetings in consultation with all Directors. Notice of at least 14 days is given to all Directors for all regular Board meetings, and all Directors are given the opportunity to propose matters for discussion on the agenda. Drafts and final versions of minutes of Board meetings are sent to all Directors for comments and records. Minutes of Board meetings with details of matters considered by the Board and decisions reached are kept by the Company Secretary and are available for inspection by the Directors.

During the financial year ended 31 March 2026, the Chairman has also held a meeting with the Independent Non-executive Directors without the presence of other Directors.

The agendas and accompanying board papers for regular Board meetings are sent in full package to all Directors at least three days before the date of each Board meeting. All Directors have access to board papers and related materials and may, in appropriate circumstances, seek independent professional advice at the Company's expense. All Directors have access to the advice and services of the Company Secretary, who ensures that Board procedures and applicable rules and regulations are followed.

According to current Board practice, any material transaction or matter that involves conflicting interests of a substantial shareholder or a Director, are dealt with by a duly convened physical Board meeting, at which Independent Non-executive Directors who have no material interest in the transaction should be present. Any Directors or their close associates with material interests in the transaction or matter shall abstain from voting and will not be counted in the quorum for meetings approving such transactions.

董事局表現評核

董事局每年對其本身的表現以及其委員會和董事的表現進行正式評核，以確保其持續有效地履行職責。該評核通過董事局評核問卷的方式進行。

於截至二零二六年三月三十一日止之財政年度內，本公司編製董事局評核問卷（涵蓋範疇包括董事局及董事委員會的運作架構、業務策略、風險偏好與風險管理，以及監督職能的履行），以收集董事局成員的觀點和意見。董事局表現評核由內部進行。企業管治委員會已審閱董事局評核問卷，並對董事局於履行其管治職責上的表現表示滿意。

培訓及持續專業發展（「持續專業發展」）有助董事掌握與本集團相關的現行趨勢及發展，包括商業、行業特定及創新方面的變化，以及法律與監管事宜，並確保其對上市公司董事之角色、職能及職責所具備之知識及技能與時並進。董事可主動參與持續專業發展，或參加由本公司安排或提供的培訓。董事定期獲簡介有關上市規則、企業管治常規、相關法例之修訂及本公司的業務發展，為使董事瞭解其職責及灌輸新的知識。

Board Performance Evaluation

The Board annually undertakes a formal evaluation of its own performance and that of its committees and Directors to ensure that they continue to perform effectively. The evaluation is conducted by way of Board evaluation questionnaire.

During the financial year ended 31 March 2026, a board evaluation questionnaire, which covers the topics, including Board and Board committees operating framework, business strategy, risk appetite and risk management, and exercise of oversight, was prepared to collect views and comments from Board members. The Board performance evaluation was conducted internally. The Corporate Governance Committee reviewed the Board evaluation questionnaire and was satisfied with the Board's performance in fulfilling its governance responsibilities.

The Company will adopt a new Board performance assessment questionnaire to facilitate the internal evaluation of the Board's performance. The new questionnaire covers a range of topics, including Board composition and skills, Board culture and dynamics, Board practices, quality and timeliness of information to the Board, Board meetings, compliance and training, risk management and internal controls, and stakeholder engagement. The findings of the evaluation will then be analyzed and presented to the Nomination Committee and the Board in aggregate form without attributing specific comments or ratings to individual Board members in order to preserve confidentiality, foster a culture of trust and facilitate candid discussions.

Board Induction and Development

On appointment to the Board, each Director shall receive a comprehensive, formal and tailored induction package covering the Company's constitutional documents, governance policies and procedures of the Company as well as the general, statutory and regulatory obligations of being a Director to ensure that he/she has a proper understanding of the Company's operations and business, and his/her responsibilities under the Listing Rules and other relevant legal and regulatory requirements.

Training and Continuous Professional Development ("CPD") help Directors keep abreast of current trends and developments relevant to the Group, including commercial, industry-specific and innovative changes, as well as legal and regulatory matters and refresh their knowledge and skills on the roles, functions and duties of a listed company director. Directors may undertake CPD on their own initiative or by participating in training arranged or facilitated by the Company. The Directors are regularly briefed on the amendments to or updates on the Listing Rules, corporate governance practices, related regulatory regime and the business development of the Company so as to keep them abreast of their responsibilities and infuse them with new knowledge.

董事責任保險

委任、重選及罷免董事

此外，任何於年內獲董事局委任以填補臨時空缺或增加董事局成員的董事，須履行董事職務直至下屆股東周年大會，並符合資格於該大會上獲重選連任。

根據本公司之細則第109(A)條，除本公司主席及董事總經理外，當時在任三分之一之董事須於本公司股東周年大會上輪流退任及重選連任。許志偉先生及陳慶光先生（獨立非執行董事）將於二零二六年股東周年大會上輪流退任，且彼等均符合資格並願意於該大會上重選連任。

Liability Insurance for Directors

The Company has in force appropriate insurance coverage on directors' and officers' liabilities arising from the Group's business. The Company reviews the extent of insurance coverage on an annual basis.

Appointment, Re-election and Removal of Directors

All the Independent Non-executive Directors are appointed for a term of not more than three years, subject to retirement by rotation and re-election by Shareholders at the annual general meeting of the Company.

In addition, any Directors appointed by the Board during the year, either to fill a casual vacancy or as an addition to the Board, shall hold office until the next annual general meeting, and then shall be eligible for re-election at that meeting.

In accordance with the Bye-law 109(A) of the Company's Bye-laws, other than the Chairman and the managing director of the Company, one-third of the directors for the time being shall retire by rotation, and stand for re-election, at the annual general meeting of the Company. Mr. Harry Chi HUI and Mr. Johnson Chin Kwang TAN, the Independent Non-executive Directors, shall retire by rotation, and being eligible, will offer themselves for re-election at the 2026 AGM.

董事證券交易

主席及集團總裁

蔣麗苑女士作為董事局主席專注於本集團之整體企業發展及高層策略性方針，領導董事局及監督董事局之有效運作。彼同時負責管理本集團的業務、制定政策及企業管理，並在管理層的協助下實施董事局採納的策略和措施。

於本報告日期，蔣麗苑女士為本公司董事局主席兼集團總裁。根據上市規則企業管治守則之守則條文第C.2.1條之規定，主席與集團總裁的角色應有區分，並不應由一人同時兼任。然而，鑒於蔣女士的技能和經驗以及彼長期服務於本集團，該架構可視為適合本集團，並可為本集團提供強大且貫徹的領導力，為業務提供有效及高效的規劃及決策，以及能執行長期業務策略。

Directors' Securities Transactions

The Company has adopted a Code of Conduct regarding Securities Transactions by the Directors (the "Code of Conduct") on terms no less exacting than the required standard as set out in the Model Code for Securities Transactions by Directors of Listed Issuers (the "Model Code") contained in Appendix C3 to the Listing Rules. The Company, after having made specific enquiry of all Directors, confirms that all Directors have complied with the required standard set out in the Code of Conduct and the Model Code throughout the year ended 31 March 2026.

CHAIRMAN AND CHIEF EXECUTIVE OFFICER

During the financial year ended 31 March 2026, Ms. Lai Yuen CHIANG was the Chairman of the Board and the Chief Executive Officer of the Company. The roles of the Chairman and the Chief Executive Officer are defined clearly to ensure the accountability and responsibility with respect to the management of the Company.

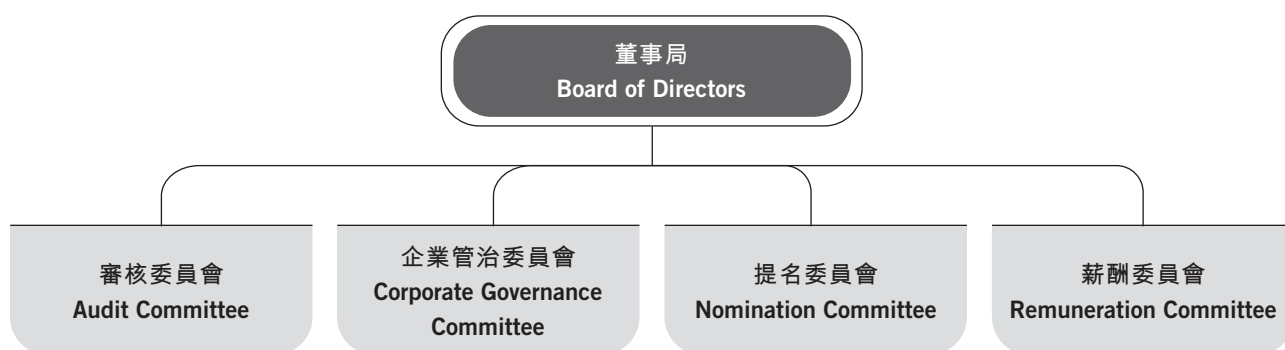
Ms. Lai Yuen CHIANG, being the Chairman of the Board, focuses on overall corporate development and high-level strategic directions of the Group, provides leadership to the Board, and oversees the efficient functioning of the Board. She is also responsible for managing the business of the Group, policy making and corporate management and the implementation of strategies and initiatives adopted by the Board with the support from the management.

As at the date of this report, Ms. Lai Yuen CHIANG is the Chairman of the Board and Chief Executive Officer of the Company. Pursuant to code provision C.2.1 of the CG Code of the Listing Rules, the roles of Chairman and Chief Executive Officer should be separate and should not be performed by the same individual. However, given the skills and experience of Ms. CHIANG and her long term of service with the Group, this structure can be considered appropriate to the Group and can provide the Group with strong and consistent leadership for effective and efficient business planning and decisions, as well as execution of long term business strategies.

The Nomination Committee is responsible for reviewing the structure, size and composition (including the skills, knowledge and experience) of the Board, assisting the Board in maintaining a board skills matrix, and making recommendations on any proposed changes to the Board members to complement the Company's corporate strategy; identifying individuals suitably qualified to become Board members and select or make recommendations to the Board on the selection of individuals nominated for directorships; assessing the independence of Independent Non-executive Directors; making recommendations to the Board on the appointment or re-appointment of Directors and succession planning for Directors; assessing the time commitment and contribution of the Directors to the Board; and supporting the Company's regular evaluation of the Board's performance. The terms of reference of the Nomination Committee, as updated in June 2025, are available on the websites of the Company and the Stock Exchange.

提名政策

Nomination Policy

The Board adopted a Nomination Policy in November 2018 which sets out the criteria and process on the nomination and appointment of Directors. The Board has delegated the relevant selection and appointment of Directors to the Nomination Committee, which identifies suitable qualified candidates to become Board members and recommends them to the Board. In assessing the suitability of a proposed candidate, the Nomination Committee would assess and evaluate the candidate's character and integrity, qualifications, skills, experience, gender and diversity aspects under the Board Diversity Policy that are relevant to the Company's business and corporate strategy, devoting adequate time to effectively carry out their duties, and fulfilment of the independence requirements as set out in Rule 3.13 of the Listing Rules (for Independent Non-executive Directors). After the evaluation, the Nomination Committee nominates the appropriate candidate to the Board for approval and appointment. For any person that is nominated by a Shareholder for election as a director at the general meeting of the Company, the Nomination Committee should evaluate such candidate based on the criteria as set out above to determine whether such candidate is qualified for directorship. Where appropriate, the Nomination Committee should make recommendation to Shareholders in respect of the proposed election of director at the general meeting.

The Nomination Committee had considered and made recommendations to the Board on the nomination of the retiring Directors for re-election at the 2025 annual general meeting in accordance with the nomination criteria and procedures and board diversity criteria as set out in the Nomination Policy and the Board Diversity Policy respectively.

The Board had reviewed the criteria and process on the nomination and appointment of Directors and, considered the Nomination Policy has been effectively implemented during the year.

Directors' Time Commitment

The Directors have demonstrated a strong commitment to the Board affairs and are well aware of the expectation to dedicate sufficient time to the Board affairs.

薪酬委員會

薪酬委員會於二零零五年成立。於本報告日期，薪酬委員會成員包括三名獨立非執行董事許志偉先生、Anish LALVANI先生及陳慶光先生，以及執行董事蔣麗苑女士。Anish LALVANI先生為薪酬委員會主席。

薪酬委員會之主要職責為就董事及高級管理人員之薪酬政策及架構，及就設立正規而具透明度之程序制定薪酬政策，向董事局推薦意見，亦因應企業方針及目標而檢討及制訂本集團執行董事及高級管理人員之薪酬及就獨立非執行董事之薪酬向董事局提出建議。薪酬委員會考慮之因素包括執行董事及高級管理人員之職務和責任及可供比較之公司所支付之薪酬數額。此外，薪酬委員會亦負責審閱及／或批准與上市規則規定的股份激勵計劃有關的事項。薪酬委員會之職權範圍已載於本公司及聯交所之網站上。

Remuneration Committee

The Remuneration Committee was established in 2005. As at the date of this report, the Remuneration Committee comprises three Independent Non-executive Directors, namely Mr. Harry Chi HUI, Mr. Anish LALVANI and Mr. Johnson Chin Kwang TAN, and the Executive Director, Ms. Lai Yuen CHIANG. Mr. Anish LALVANI is the Remuneration Committee Chairman.

The main responsibilities of the Remuneration Committee are to make recommendations to the Board on the policy and structure for the remuneration of Directors and senior management and on the establishment of a set of formal and transparent procedures for its remuneration policy. It also reviews and determines the remuneration packages for Executive Directors and senior management and to make recommendations to the Board on the remuneration for Independent Non-executive Directors of the Group with reference to the corporate goals and objectives. The Remuneration Committee considers factors such as duties and responsibilities of the Executive Directors and senior management and the amount of remuneration paid by comparable companies. In addition, the Remuneration Committee is also responsible for reviewing and/or approving matters relating to the share incentive schemes under the Listing Rules. The terms of reference of the Remuneration Committee are available on the websites of the Company and the Stock Exchange.

Remuneration packages of Executive Directors comprises salary, allowances, performance related bonus and pension scheme contributions. Information about the emoluments of Directors and senior management during the financial year ended 31 March 2026 is set out in notes 9 and 35 to the financial statements of this report.

Remuneration Policy

The Board adopted a Remuneration Policy which aims to recognize that appropriate level of remuneration is crucial to attract, retain and motivate the Directors to run the Company successfully, and to ensure that the Directors' remuneration is appropriate and aligns with the Company's goals, objectives and performance and to enhance the value of Shareholders, through a set of formal and transparent procedures for implementing the Remuneration Policy. Pursuant to the Remuneration Policy, the following key principles have been established for determination of the remuneration and other remuneration related matters of individual Directors:

- Executive Directors' emoluments shall be reviewed annually by the Remuneration Committee and the Board.
- Recommendations shall be made by the Remuneration Committee to the Board for approval of any revision to the Executive Directors' emoluments by reference to his/her position, qualifications, experience, level of responsibilities and the Group's performance and profitability.
- Executive Directors may be eligible to receive discretionary bonus and/or performance bonus and/or guaranteed bonus taking into consideration factors such as market conditions as well as corporate and individual performances.
- The Remuneration Committee shall review and if appropriate, recommend to the Board for approval the grant of share options and/or the award of shares to the Executive Directors under the share option scheme and share ownership scheme (if any) of the Company. Such scheme(s) enables the Executive Directors to obtain an ownership interest in the Company as incentives or rewards for their contribution or potential contribution to the Group.
- Non-executive directors' fees shall be reviewed annually by the Remuneration Committee and the Board.

Adoption of the 2025 Share Schemes

On 20 June 2025, the Remuneration Committee reviewed and made recommendations to the Board for approval on the adoption of the 2025 Share Option Scheme and the 2025 Share Award Scheme (the “2025 Share Schemes”).

The purpose of the 2025 Share Schemes is to enable the Company to grant share options and/or share awards to selected eligible participants as retention incentives or rewards for their contributions to the Group, to attract suitable personnel to enhance the development of the Group and to align the interests of the grantees generally with those of the Shareholders for the benefit of the medium to long term development of the Group.

The share options and share awards granted under the 2025 Share Schemes would be subject to certain vesting conditions and a clawback mechanism.

授出的股份獎勵並無附帶表現目標。薪酬委員會知悉，二零二五年股份獎勵計劃的目的為就合資格參與者對本集團的貢獻為其提供留任激勵或獎勵，吸引合適人才以促進本集團發展，以及使承授人的利益與股東的利益保持一致，有利於本集團的中長期發展。

經考慮上述二零二五年股份獎勵計劃的目的及下列因素後，薪酬委員會認為，就向承授人授出股份獎勵設定表現目標並非必要，且經計及下列因素，有關不設表現目標的授出股份獎勵符合二零二五年股份獎勵計劃的目的：(a)有關承授人在本集團業務中的角色與經驗、其服務本集團的年期及對推動本集團業務的貢獻與投入；(b)承授人過往對本集團作出的貢獻；及(c)有關授出股份獎勵須受歸屬時間表規限，此舉可強化承授人對長期服務本集團的承諾，並有助挽留本集團高質素的僱員。

根據二零二五年股份獎勵計劃，倘承授人出現任何嚴重不當行為，則股份獎勵(不論已歸屬或未歸屬)應於嚴重不當行為發生當日自動註銷(由董事局全權酌情決定，而有關決定對承授人具約束力)，且本公司有權：(i)以零代價向該承授人購回部分或全部已歸屬股份獎勵；及／或(ii)指示承授人向二零二五年股份獎勵計劃的受託人無償退還、轉讓或促使轉讓該等須予購回之已歸屬股份獎勵；及／或(iii)要求該承授人以現金或其他財產向本公司支付任何及全部款項，以代替該承授人自本公司收取的已歸屬股份獎勵。惟倘承授人出現嚴重不當行為，董事局可全權酌情決定不實施或不行使退扣機制下授予的權利，以收回或拒給任何股份獎勵(或其任何部分)。

Grant of Share Awards

The Remuneration Committee had also reviewed and made recommendations to the Board for approval on the grant of Share Awards on 1 December 2025 to eligible participants (the “Grantees”) under the 2025 Share Award Scheme. The Remuneration Committee had considered the matters as set out below:

There is no performance target attached to the Share Awards granted. The Remuneration Committee noted that the purpose of the 2025 Share Award Scheme is to provide eligible participants’ retention incentives or rewards for their contributions to the Group, to attract suitable personnel to enhance the development of the Group and to align the interests of the Grantees generally with those of the Shareholders for the benefit of the medium to long term development of the Group.

Having considered the purpose of the 2025 Share Award Scheme above and the following factors, the Remuneration Committee was of the view that performance targets are not necessary for the grant of Share Awards to the Grantees and such grant of Share Awards without performance targets is in line with the purpose of the 2025 Share Award Scheme taking into account the following factors: (a) those Grantees’ roles and experiences in the Group’s business, length of services to the Group, and contribution and dedication to the promotion of the Group’s business; (b) the Grantee’s past contributions to the Group; and (c) such grant of Share Awards being subject to the vesting schedules which reinforces the Grantees’ commitment to long-term services to the Group and help to retain high-calibre employees in the Group.

Pursuant to the 2025 Share Award Scheme, in the event that the Grantee has committed any serious misconduct, the Share Awards, whether vested or unvested, shall automatically be cancelled as of the date of the commission of serious misconduct, as determined by the Board in its sole discretion and such determination shall be binding on the Grantee, and the Company shall have the right to: (i) repurchase by the Company some or all of the vested Share Awards from such Grantee at no consideration; and/or (ii) direct the Grantee to return, transfer or cause to be transferred such vested Share Awards that are subject to repurchase to the trustee of the 2025 Share Award Scheme at no consideration; and/or (iii) require such Grantee to pay the Company any and all payment in cash or other property in lieu of the vested Share Awards which such Grantee has received from the Company. Provided always that the Board in its absolute discretion may decide not to impose or exercise the rights granted under the clawback mechanism to recover or withhold any Share Awards (or any portion thereof) in the event of serious misconduct committed by the Grantee.

問責性及審核

董事局有責任監督年度財務報表的編製，而董事局會收取每月有關集團表現、財務狀況及前景的最新資料。本公司分別於相關期間結束後三個月及兩個月內刊發其年度及中期業績。

本集團截至二零二六年三月三十一日止之財政年度內的綜合財務報表已由外聘核數師安永會計師事務所審核及經審核委員會審閱。董事確認彼等對編製本集團綜合財務報表負有責任，該等財務報表乃依照法定要求及適用會計準則編製。

外聘核數師就其審核本集團截至二零二六年三月三十一日止年度之綜合財務報表之責任聲明，載於本報告第105至111頁之獨立核數師報告書內。

風險管理及內部監控

本集團知悉其業務和經營的市場潛在若干風險（包括環境、社會及管治風險），在實踐企業目標時，會查證重大風險並為其進行監控，以使能夠達至持續增長和長期股東價值。本集團實施一套全面的風險管理及內部監控系統，其設計是提供合理保證，而非杜絕，重大風險的識別和管理，業務是根據管理層的授權進行，資產得到保障，財務報表準確可靠和可供刊印，以及本集團的活動有遵守適用法律和規例。截至二零二六年三月三十一日止之財政年度內，本集團的風險評估（包括環境、社會及管治風險）以及風險管理及內部監控系統並無重大變更。

風險管理和內部監控程序已與本集團的日常業務和營運融合，其涉及對風險的理解、識別潛在的風險、評估可能產生的後果、確定風險水平、設立適當的緩解措施，以及適當的報告跟進情況。

ACCOUNTABILITY AND AUDIT

Financial Reporting

The Board, which is responsible for overseeing the preparation of annual financial statements, receives monthly updates on the Group's performance, financial position and prospects. The Company publishes its annual and interim results within three months and two months respectively after the relevant period ends.

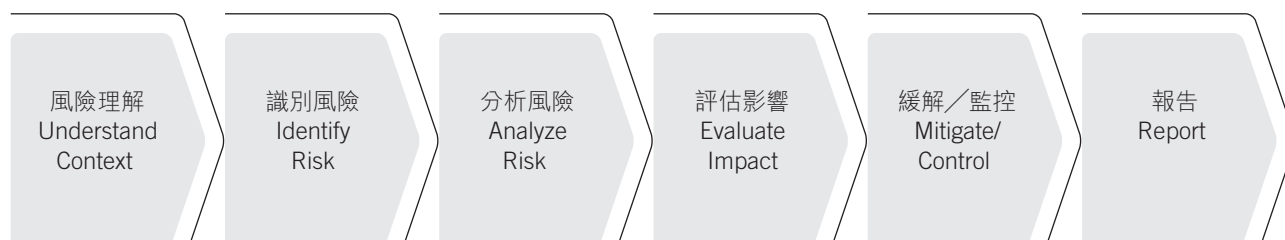
The consolidated financial statements of the Group for the financial year ended 31 March 2026 have been audited by the external auditor, Ernst & Young, and reviewed by the Audit Committee. The Directors acknowledge their responsibility for preparing the consolidated financial statements of the Group which were prepared in accordance with statutory requirements and applicable accounting standards.

A statement by the external auditor regarding the responsibilities for the audit of the consolidated financial statements of the Group for the year ended 31 March 2026 is set out in the Independent Auditor's Report on pages 105 to 111 of this report.

Risk Management and Internal Control

The Group acknowledges certain aspects of risks (including environmental, social and governance risks) are inherent in its businesses and the markets it operates, and in pursuit of its corporate objectives, undertakes to determine and monitor material risks in order to enable sustainable growth and long term Shareholder value. The Group implements a comprehensive risk management and internal control system which is designed to provide reasonable, but not absolute, assurance that significant risks are identified and managed, transactions are executed in accordance with management's authorization, assets are protected, the financial statements are accurate and reliable for publication, and the Group's activities are in compliance with applicable laws and regulations. There have been no significant changes for the financial year ended 31 March 2026 in the Group's assessment of risk (including ESG risks) and the risk management and internal control systems.

The risk management and internal control process is embedded in the Group's daily businesses and operations, which involves understanding the context, identifying potential exposures, assessing the likelihood of consequences, determining the risk level, establishing appropriate mitigating measures and followed by appropriate reporting.

該風險管理及監控系統包含一套組織監控架構，強調責任界定、權力分配和職責分工。風險管治的最高架構為董事局，彼監督及負責該監控系統的運作，確保風險管理及監控系統的足夠和有效性，並瞭解有關系統旨在管理而非消除未能達成業務目標的風險，而且只能就不會有重大的失實陳述或損失作出合理而非絕對的保證。董事局確認彼對本集團風險管理及內部監控方面的責任，並授權風險管理委員會施行監控系統，風險管理委員會成員包括高級及有經驗的管理層。風險管理委員會監督風險管理及監控系統的實施，並為其提供適當的指引和工具，追蹤重大風險和緩解行動，和查証已出現的重大監控缺失或弱點。風險管理委員會委託業務單位和其內部的功能組別執行該風險管理及監控系統。各業務單位均由一名總經理及財務總監領導，其職責是監控業務單位的操作，確保有合適和有效的營運政策、準則和程序，並確保它們的妥善執行。功能組別主管在他們日常決策過程中執行風險評估，並向業務單位主管匯報重大風險。通過與各業務單位和功能組別主管的討論，風險管理委員會透過獨立外聘內部監控顧問協助每年呈送及概括風險評估報告，並與審核委員會商討。

對困難的風險監控事項，本集團可尋求外部專業人員的協助。

於本年度內，本集團已進行整體風險評估、更新風險登記冊，並就風險評估結果與上一年度進行變動分析。未發現重大風險出現重大變動。

The risk management and control system involves an organizational control structure which emphasizes defined lines of duties and responsibilities, delegation of authority and segregation of duties. At the top of the risk governance structure sits the Board who oversees and is responsible for the risk management and control system and ensures its adequacy and effectiveness and acknowledge that such system is designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable but not absolute assurance against material misstatement or loss. The Board acknowledges its responsibility for the Group's risk management and internal control systems and delegates implementation responsibilities of the Control System to the Risk Management Committee which comprises senior and experienced members of management. The Risk Management Committee supervises and facilitates the implementation of the risk management and control system with appropriate guidelines and tools, tracks material risks and mitigating activities, and determines significant control failings or weaknesses that have occurred. The execution of the risk management and control system is entrusted to the Business Units, and within the Business Units, the Functional Groups. Each Business Unit is headed by a General Manager and a Financial Controller whose duties are to control the activities of the Business Unit, ensure appropriate and effective operational policies, standards and procedures are in place and are properly executed. The heads of the Functional Groups exercise risk assessment in their daily decision making processes, escalate and report material risks to the Business Unit heads. Through discussion with the respective Business and Functional Unit heads, the Risk Management Committee as supported by an independent external internal control consultant whom presents and summarizes a Risk Assessment Report annually for discussion with the Audit Committee.

The Group is able to call for assistance from outside professionals to support difficult risk controlling matters.

During the year, the Group conducted an overall risk assessment, updated risk register, and analysed changes in risk assessment result compared to the previous year. No significant change in major risks has been identified.

內幕消息

本公司遵循證券及期貨條例(「證券及期貨條例」)第XIVA部和上市規則的規定，於知悉任何內幕消息後，在合理地切實可行的範圍內，儘快向公眾披露該消息，除非有關消息屬於證券及期貨條例下任何「安全港條文」的範圍。本公司在向公眾全面披露有關消息前，會確保該消息絕對保密。若本公司認為無法保持所需的機密性，或該消息可能已外泄，會即時向公眾披露該消息。本公司致力確保公告中所載的資料不得在某事關重要的事實方面屬虛假或具誤導性，或因遺漏某事關重要的事實而屬虛假或具誤導性，使公眾能平等、適時及有效地取得所披露的內幕消息。

就根據證券及期貨條例及上市規則處理及發放內幕消息而言，本公司已採取不同程序及措施，包括提高本公司內幕消息的保密意識，定期向董事和有關僱員發送禁售期和證券交易限制的通知，以及在需要知情的基礎上向指定人員傳播信息。董事局已制定及修訂內幕消息指引，並將定期作出檢討以確保其相關性及有效性。

外聘審核

董事局任命外聘核數師安永會計師事務所為本集團的財務報表進行獨立法定審核工作。外聘核數師與審核委員會出席會議，以討論和匯報審核的性質及範圍，以及於審核綜合財務報表過程中發現之任何重大內部監控缺失及在審核中的重大發現。

外聘核數師的服務及收費

截至二零二六年三月三十一日止之財政年度，外聘核數師之酬金合共為港幣3,585,000元，其中港幣2,663,000元為審核服務，港幣707,000元為稅務服務及港幣215,000元為其他非審核服務。

Inside Information

The Company complies with the requirements of Part XIVA of the Securities and Futures Ordinance (the “SFO”) and the Listing Rules. The Company discloses inside information to the public as soon as reasonably practicable after any inside information has come to its knowledge unless the information falls within any of the “Safe Harbours” as provided for in the SFO. Before the information is fully disclosed to the public, the Company ensures the information is kept strictly confidential. If the Company believes that the necessary degree of confidentiality cannot be maintained or that confidentiality may have been breached, the Company would immediately disclose the information to the public. The Company is committed to ensure that information contained in announcements are not false or misleading as to a material fact, or false or misleading through the omission of a material fact, to provide for equal, timely and effective access by the public to the inside information disclosed.

To handle and disseminate inside information in accordance with the SFO and the Listing Rules, the Company has taken various procedures and measures, including arousing the awareness to preserve confidentiality of inside information with the Company, sending blackout period and securities dealing restrictions notification to the Directors and relevant employees regularly, and disseminating information to specified persons on a need-to-know basis. The Board established and revised the Inside Information Guidelines and will regularly review to ensure its relevance and effectiveness.

EXTERNAL AUDIT

The Board appoints the external auditor, Ernst & Young, to conduct independent statutory audits of the Group’s financial statements. The external auditor attends meetings with the Audit Committee to discuss and report the nature and scope of the audit, any significant deficiencies in internal control identified during the audit of the consolidated financial statements, and significant findings from the audit.

External Auditor’s Services and Fees

External auditor’s remuneration for the financial year ended 31 March 2026 amounted to a total of HK\$3,585,000, of which HK\$2,663,000 was incurred for audit services, HK\$707,000 for tax-related services and HK\$215,000 for other non-audit services.

董事局透過審核委員會將本集團內部審核職能授予一家獨立專業公司作為外聘內部監控顧問，負責每半年檢討業務單位及／或營運附屬公司的業務流程及營運，就其在工作過程中識別的監控事宜、風險及建議提交報告。外聘內部監控顧問亦設計一套以風險為基礎的方法以進行內部審核，並制定年度內部審核計劃及檢討範圍，覆蓋本集團營運、業務單位的主要活動及程序。該等審核活動的結果會交予審核委員會及業務單位及功能組別主管。內部審核職能會查察審核事務，並於其後跟進，力求妥善實行，並會定期向審核委員會匯報其進展。公司秘書備存所有審核委員會會議之完整會議紀錄。審核委員會會議紀錄的初稿及最終定稿會發送全體委員會成員，以供彼等表達意見及作具紀錄之用。

INTERNAL AUDIT

Audit Committee and Internal Audit

The Board appoints the Audit Committee with clear terms of reference, which comprises Independent Non-executive Directors who are well-experienced in corporate management. The Audit Committee oversees and evaluates the appropriateness and effectiveness of the risk management and control system. It also identifies areas for improvement, reviews the adequacy of resources, staff qualifications and experience, training programmes and budget of the Group's accounting, internal audit and financial reporting functions.

The Board, through the Audit Committee, has delegated the internal audit function of the Group to an independent professional firm which was appointed to act as an external internal control consultant, to conduct semi-annual reviews of the business process and operations of Business Units and/or operating subsidiaries and report findings, risk and recommendations on any control issues identified in the course of their work. The external internal control consultant also developed a risk-based approach for the internal audit and established annual internal audit plan and scope of review, covering major activities and processes of the Group's operations, businesses and Business Units. The results of these audit activities are communicated to the Audit Committee and heads of the Business Units and the Functional Groups. Audit issues are tracked, followed up for proper implementation, and their progress are reported to the Audit Committee periodically. The Company Secretary keeps full minutes of all Audit Committee meetings. Drafts and final versions of minutes of the Audit Committee meetings are sent to all committee members for their comment and records.

2025/26 年度測評

2025/26 Assessment

During the year, the external internal control consultant conducted the review of internal control and risk management systems for certain principal subsidiaries' operation with a view to identifying any gaps in the risk management and control system and making recommendations for improvement. The results of such assessments were submitted to the Audit Committee during the year. No significant control weaknesses were identified or were previously reported but remain unresolved. In addition to the risk management and control system, a Whistleblowing Policy has been put in place allowing employees and others who interact with the Group (e.g., customers, suppliers etc.) to raise their concerns about any suspected misconduct or malpractice within the Group. All reported whistleblowing matters were handled and investigated confidentially and independently.

To adhere to practicing integrity and responsible business ethics, the Anti-Corruption Policy adopted by the Board provides information and guidances to all business units and employees of the Group on how to recognize and deal with corruption and bribery and to handle corporate donation and sponsorship activities of the Group. The Group regularly conducts external and in-house anti-bribery training sessions to enhance the Group's anti-corruption culture, awareness and knowledge. More details in relation to the Whistleblowing Policy and the Anti-Corruption Policy can be found in the "Environmental, Social and Governance Report 2025/26" of the Company. The Whistleblowing Policy together with the Anti-Corruption Policy are to be updated periodically to ensure their relevance and compliance with corporate and regulatory requirements.

Based on the respective assessments, the Board acknowledges that an effective and appropriate risk management and internal control process was in place for the year ended 31 March 2026. The Board considers that the Group's risk management and internal control systems are effective and appropriate for the purpose set out in Principle D2 of the CG Code. The resources (internal and external) for designing, implementing and monitoring the risk management and internal control systems, including, staff qualifications and experience, training programmes and budget of the Company's accounting, internal audit and financial reporting functions as well as those relating to the Company's ESG performance and reporting were adequate. The Group has complied with the risk management and internal control code provisions for the year ended 31 March 2026.

Dividend Policy

The Company has adopted a Dividend Policy in November 2018 to provide Shareholders with sustainable dividends, based on the underlying financial performance of the business in each financial year end. The Company aims to distribute a certain portion of distributable profits to Shareholders, whilst retaining the balance for future business expansion. The Board may declare and pay dividends from time to time, subject to the approval of the Shareholders, where applicable.

When considering the payment of dividend, the Board will take into account, among other matters, distributable profits, cash flow, liquidity and financial position, current and future operations, capital requirements and surplus of the Company, as well as dividends received from the Company's subsidiaries and associates. The payment of dividend is also subject to any restrictions under Bermuda laws and the Company's Bye-laws and any other applicable statutory and regulatory restrictions.

The dividend policy reflects the Company's approach on the financial and cash flow requirements of the Group prevailing at the time of its adoption. The Board may review the policy from time to time and may adopt changes as necessary.

It is confirmed that the dividend decisions made by the Board during the year were made in accordance with the Company's Dividend Policy. There was no material variation in the dividend rate for the interim and final dividends declared by the Board during the year compared to the previous corresponding period.

In addition, a representative of the Company's external auditor is requested to attend the annual general meeting to answer questions about the conduct of the audit, the preparation and content of the auditor's report, the accounting policies and auditor independence. In the case of any special business which is required independent shareholders' approval (e.g., connected transaction), members of the independent Board committee will make an effort to attend the general meeting to address Shareholders' queries.

All resolutions set out in the notice of general meeting put to vote at the meeting were by way of a poll. The procedures for conducting a poll will be explained at the meetings. Independent scrutineer will be engaged to ensure all votes at general meetings are properly counted. The poll results will be published on the websites of the Company and the Stock Exchange.

SHAREHOLDERS' RIGHTS

Convening of Special General Meeting on Requisition

Pursuant to the provisions of the Companies Act 1981 of Bermuda (as amended) (the "Bermuda Companies Act"), shareholders holding not less than one-tenth (10%) of the paid-up share capital of the Company at the date of the deposit of the requisition shall have the right to requisition the Board to convene a special general meeting of the Company. The requisition must state the purposes of the special general meeting, and must be signed by the requisitionist and deposited at the registered office of the Company.

If the Board do not convene a special general meeting within 21 days from the date of the deposit of the requisition, the requisitionist, or any of them representing more than one-half (50%) of the total voting rights of all of them, may themselves convene a special general meeting of the Company.

Putting Forward Proposals at General Meetings

Pursuant to the provisions of the Bermuda Companies Act, shareholders representing not less than one-twentieth (5%) of the total voting rights of all the shareholders having at the date of the requisition a right to vote at general meetings of the Company or of at least 100 shareholders in number of the Company, may put forward any resolution which may properly be moved and is intended to be moved at a general meeting of the Company by sending the requisition together with a statement of not more than 1,000 words with respect to the matter referred to in the proposed resolution must be deposited at the head office and principal place of business of the Company as below not less than six weeks before the general meeting:

本公司之主要業務為投資控股及提供管理服務。

RESULTS AND DIVIDENDS

The Group's results for the year ended 31 March 2026 and the financial position of the Group at that date are set out in the financial statements on pages 112 to 251 of this report.

The Board recommends the payment of a final dividend of HK5.3 cents per ordinary share for the year ended 31 March 2026 (2025: HK8.0 cents per ordinary share), consistent with the Company's Dividend Policy.

Subject to the approval of the Shareholders at the 2026 AGM, the final dividend will be payable on or about 22 September 2026 to Shareholders whose names appear on the register of members of the Company on 8 September 2026, being the record date for determining the entitlement to the final dividend.

The proposed final dividend together with the interim dividend of HK3.6 cents per ordinary share paid on 14 January 2026, make a total dividend of HK8.9 cents per ordinary share for the year.

FIVE-YEAR FINANCIAL SUMMARY

A summary of the results and of the assets, liabilities and non-controlling interests of the Group for the last five financial years is set out on page 255 of this report. This summary does not form part of the audited financial statements of the Group.

INVESTMENT PROPERTIES

The Group's investment properties as at 31 March 2026 were revalued by an independent firm of professionally qualified valuers. The revaluation decrease of HK\$12,940,000 has been recognized in the consolidated income statement. The 2014 Share Option Scheme expired on 23 September 2024, under which no further grant of share options shall be offered. The outstanding share options granted under the 2014 Share Option Scheme continue to be valid and exercisable in accordance with the terms of the 2014 Share Option Scheme.

Under the 2014 Share Option Scheme, the Directors of the Company may, at their discretion, invite any participants to take up share options to subscribe for fully paid ordinary shares in the Company subject to the terms and conditions stipulated therein. Share options granted under the 2014 Share Option Scheme do not confer rights on the holders to dividends or to vote at Shareholders’ meetings.

Notes to Financial Statements

1. 公司及集團資料

震雄集團有限公司(「本公司」)為於百慕達註冊成立之有限公司。本公司之主要營業地點位於香港威非路道18號萬國寶通中心20樓2001室。

於年內，本集團主要從事製造及銷售注塑機及有關產品。

董事認為本公司之最終控股公司為於巴哈馬註冊成立之JTC Private Trust (Bahamas) Limited (前稱Cititrust (Bahamas) Limited)。香港註冊成立之震雄投資有限公司(「震雄投資」)則為本公司之直接控股公司。

主要附屬公司之詳情載於第252至254頁。

2. 會計政策

2.1 編製基準

該等財務報表乃按照香港會計師公會(「香港會計師公會」)頒布之香港財務報告準則會計準則(「香港財務報告準則會計準則」)(包括所有香港財務報告準則(「香港財務報告準則」)、香港會計準則(「香港會計準則」)及詮釋)及香港公司條例之披露要求而編製。除投資物業按公平值計算外，財務報表乃按歷史成本慣例而編製。定額福利資產以預計單位基數精算估值法計量，並於財務報表附註3進一步解釋。財務報表以港幣呈列，除了另有指明，所有金額均以千元(港幣千元)列報。

1. CORPORATE AND GROUP INFORMATION

Chen Hsong Holdings Limited (the “Company”) is a limited liability company incorporated in Bermuda. The principal place of business of the Company is located at Unit 2001, 20th Floor, Citicorp Centre, 18 Whitfield Road, Hong Kong.

During the year, the Group was principally involved in the manufacture and sale of plastic injection moulding machines and related products.

In the opinion of the directors, the Company's ultimate holding company is JTC Private Trust (Bahamas) Limited (formerly known as Cititrust (Bahamas) Limited), a company incorporated in the Bahamas. Chen Hsong Investments Limited (“CH Investments”), a company incorporated in Hong Kong, is the Company's immediate holding company.

Particulars of the principal subsidiaries are set out on pages 252 to 254.

2. ACCOUNTING POLICIES

2.1 BASIS OF PREPARATION

These financial statements have been prepared in accordance with HKFRS Accounting Standards (which include all Hong Kong Financial Reporting Standards (“HKFRSs”), Hong Kong Accounting Standards (“HKASs”) and Interpretations) as issued by the Hong Kong Institute of Certified Public Accountants (“HKICPA”) and the disclosure requirements of the Hong Kong Companies Ordinance. They have been prepared under the historical cost convention, except for investment properties which have been measured at fair value. Defined benefit assets are measured using the projected unit credit actuarial valuation method as further explained in note 3 to the financial statements. These financial statements are presented in Hong Kong dollars (“HK\$”) and all values are rounded to the nearest thousand (HK\$'000) except when otherwise indicated.

2. 會計政策(續)**2.1 編製基準(續)****綜合基準**

綜合財務報表包括本公司及其附屬公司(全部統稱為「本集團」)截至二零二六年三月三十一日止年度之財務報表。附屬公司為本公司直接或間接控制的實體(包括結構性實體)。當本集團對參與投資對象業務的浮動回報承擔風險或享有權利以及能透過對投資對象的權力(如本集團獲賦予現有能力以主導投資對象相關活動的既存權利)影響該等回報時,即取得控制權。

在一般情況下,有一個假設,即大多數投票權形成控制權。倘本公司擁有少於投資對象大多數投票或類似的權利,則本集團於評估其是否擁有對投資對象的權力時會考慮一切相關事實及情況,包括:

- (a) 與投資對象其他投票持有人的合約安排;
- (b) 其他合約安排所產生的權利;及
- (c) 本集團的投票權及潛在投票權。

附屬公司財務報表使用與本公司一致的會計政策按相同申報期編製。附屬公司業績自本集團獲得控制權之日起綜合入賬,直至控制權終止之日為止。

2. ACCOUNTING POLICIES (continued)**2.1 BASIS OF PREPARATION (continued)****Basis of consolidation**

The consolidated financial statements include the financial statements of the Company and its subsidiaries (collectively referred to as the "Group") for the year ended 31 March 2026. A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

Generally, there is a presumption that a majority of voting rights results in control. When the Company has less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- (a) the contractual arrangement with the other vote holders of the investee;
- (b) rights arising from other contractual arrangements; and
- (c) the Group's voting rights and potential voting rights.

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases.

2. 會計政策(續)**2.1 編製基準(續)****綜合基準(續)**

即使會導致非控股權益出現虧損結餘，收益表及其他全面收入的各個組成部分仍會歸屬於本公司權益持有人及非控股權益。所有與本集團成員公司間交易有關的集團內公司間資產及負債、權益、收入、支出及現金流量於綜合賬目時全數抵銷。

倘事實及情況顯示以上所述三項控制元素中的一項或多項元素有變動，則本集團會重新評估其是否擁有投資對象的控制權。倘並無失去控制權，則附屬公司之擁有權權益變動會入賬列為權益交易。

倘本集團失去對附屬公司之控制權，則終止確認該附屬公司之資產(包括商譽)、負債、相關任何非控股權益及匯兌波動儲備，並記錄所保留任何投資之公平值及任何因此於損益產生之盈餘或虧絀。先前於其他全面收入已確認的本集團應佔部分會視乎情況，按倘本集團直接出售相關資產或負債所要求的相同基準重新分類至收益表或保留溢利(如適當)。

2. ACCOUNTING POLICIES (continued)**2.1 BASIS OF PREPARATION (continued)****Basis of consolidation (continued)**

Profit or loss and each component of other comprehensive income are attributed to equity holders of the Company and to the non-controlling interests, even if this results in the non-controlling interests having a deficit balance. All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

If the Group loses control over a subsidiary, it derecognizes the related assets (including goodwill), liabilities, any non-controlling interest and the exchange fluctuation reserve and recognizes the fair value of any investment retained and any resulting surplus or deficit in profit or loss. The Group's share of components previously recognized in other comprehensive income is reclassified to the income statement or retained profits, as appropriate, on the same basis as would be required if the Group had directly disposed of the related assets or liabilities.

2. 會計政策(續)**2.2 會計政策及披露變動**

本集團於本年度的財務報表首次採納香港會計準則第21號之修訂《缺乏可兌換性》。本集團並無提早應用任何尚未生效的其他準則及修訂本。

香港會計準則第21號之修訂指明實體應如何評估一種貨幣是否可兌換為另一種貨幣，以及當缺乏可兌換性時，實體應如何估計計量日的即期匯率。該等修訂要求披露資料使財務報表的使用者能夠了解貨幣不可兌換的影響。由於本集團進行交易的貨幣與海外附屬公司及聯營公司用於換算為本集團呈列貨幣的功能貨幣均可兌換，因此該等修訂對本集團財務報表並無任何影響。

此外，香港會計師公會已就香港財務報告準則第7號、香港財務報告準則第18號、香港會計準則第1號、香港會計準則第8號、香港會計準則第36號及香港會計準則第37號《財務報表中有關不確定因素的披露》的闡釋範例頒佈修訂，在相應香港財務報告準則會計準則中加入闡釋範例。該等範例以氣候相關的例子反映相應香港財務報告準則會計準則中關於在財務報表中報告不確定因素之影響的現有規定。因此，該等修訂並無訂明生效日期或過渡性條文。該等修訂對本集團財務報表並無任何影響。

2. ACCOUNTING POLICIES (continued)**2.2 CHANGES IN ACCOUNTING POLICIES AND DISCLOSURES**

The Group has adopted amendments to HKAS 21 *Lack of Exchangeability* for the first time for the current year's financial statements. The Group has not early adopted any other standard or amendment that has been issued but is not yet effective.

Amendments to HKAS 21 specify how an entity shall assess whether a currency is exchangeable into another currency and how it shall estimate a spot exchange rate at a measurement date when exchangeability is lacking. The amendments require disclosures of information that enable users of financial statements to understand the impact of a currency not being exchangeable. As the currencies that the Group had transacted in and the functional currencies of overseas subsidiaries and associates for translation into the Group's presentation currency were exchangeable, the amendments did not have any impact on the Group's financial statements.

In addition, the HKICPA has issued amendments to Illustrative Examples on HKFRS 7, HKFRS 18, HKAS 1, HKAS 8, HKAS 36 and HKAS 37 *Disclosures about Uncertainties in the Financial Statements*, which added illustrative examples in the corresponding HKFRS Accounting Standards. These examples reflect existing requirements in the corresponding HKFRS Accounting Standards to report the effects of uncertainties in the financial statements using climate-related examples. Therefore, the amendments do not have an effective date or transitional provisions. The amendments did not have any impact on the Group's financial statements.

2. 會計政策(續)**2.3 已頒布但未生效的香港財務報告準則會計準則(續)**

本集團現正就初次採納此等新訂及經修訂之香港財務報告準則會計準則之影響作出評估，惟尚未能確定此等新訂及經修訂香港財務報告準則會計準則會否對其財務表現及財務狀況造成任何重大影響。

3. 重大會計政策**投資聯營公司及合營企業**

聯營公司指本集團持有不少於20%投票權作為長期權益，且對其有影響力之實體。顯著影響力指參與被投資方財務及經營決策之權力，惟並非控制或共同控制有關政策。

合營企業指一種合營安排，對安排擁有共同控制權之訂約方據此對合營企業之資產淨值擁有權利。共同控制指按照合約協定對一項安排所共有之控制，共同控制僅在有關活動要求享有控制權之訂約方作出一致同意之決定時存在。

本集團於聯營公司及合營企業之投資乃按本集團根據權益會計法應佔資產淨值減任何減值虧損於綜合財務狀況表列賬。

The Group is in the process of making an assessment of the impact of these new and amended HKFRS Accounting Standards upon initial application, but is not yet in a position to state whether these new and amended HKFRS Accounting Standards would have any significant impact on its financial performance and financial position.

3. MATERIAL ACCOUNTING POLICIES**Investments in associates and joint ventures**

An associate is an entity in which the Group has a long-term interest of generally not less than 20% of the equity voting rights and over which it has significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee, but is not control or joint control over those policies.

A joint venture is a type of joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the joint venture. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require the unanimous consent of the parties sharing control.

The Group's investments in associates and joint ventures are stated in the consolidated statement of financial position at the Group's share of net assets under the equity method of accounting, less any impairment losses.

3. 重大會計政策(續)**投資聯營公司及合營企業(續)**

任何可能存在差異之會計政策已作出調整使之貫徹一致。本集團佔聯營公司及合營企業收購後業績及其他全面收益分別計入綜合收益表及綜合全面收益表內。此外，變動於聯營公司或合營企業權益直接確認時，本集團於綜合權益變動表確認其任何所佔變動(如適用)。本集團與其聯營公司或合營企業進行交易產生之未變現收益及虧損，將按本集團所佔聯營公司或合營企業之投資比率抵銷，惟未變現虧損證實是由已轉讓資產減值而產生則除外。收購聯營公司或合營企業所產生之商譽列作本集團於聯營公司或合營企業投資之一部分。

倘於聯營公司投資成為於合營企業投資(或於合營企業投資成為於聯營公司投資)，保留權益不予重新計量。相反，投資繼續按權益法列賬。在所有其他情況下，失去對聯營公司之重大影響力或對合營企業之共同控制權後，本集團計量及確認按公平值計量之任何保留投資。失去重大影響力或共同控制權後，聯營公司或合營企業之賬面值與保留投資之公平值及出售所得款項之間之差額於收益表確認。

Adjustments are made to bring into line any dissimilar accounting policies that may exist. The Group's share of the post-acquisition results and other comprehensive income of associates and joint ventures is included in the consolidated income statement and consolidated statement of comprehensive income, respectively. In addition, when there has been a change recognized directly in the equity of the associate or joint venture, the Group recognizes its share of any changes, when applicable, in the consolidated statement of changes in equity. Unrealized gains and losses resulting from transactions between the Group and its associates or joint ventures are eliminated to the extent of the Group's investments in the associates or joint ventures, except where unrealized losses provide evidence of an impairment of the assets transferred. Goodwill arising from the acquisition of associates or joint ventures is included as part of the Group's investments in associates or joint ventures.

If an investment in an associate becomes an investment in a joint venture or vice versa, the retained interest is not remeasured. Instead, the investment continues to be accounted for under the equity method. In all other cases, upon loss of significant influence over the associate or joint control over the joint venture, the Group measures and recognizes any retained investment at its fair value. Any difference between the carrying amount of the associate or joint venture upon loss of significant influence or joint control and the fair value of the retained investment and proceeds from disposal is recognized in the income statement.

3. 重大會計政策(續)**業務合併及商譽**

業務合併乃以購買法入賬。轉讓之代價乃以收購日期的公平值計量，該公平值為本集團轉讓的資產於收購日期的公平值，本集團向被收購方之前擁有人承擔的負債及本集團發行以換取被收購方控制權之股本權益總和。於各業務合併中，本集團選擇是否以公平值或被收購方可識別資產淨值的應佔比例，計量於被收購方屬現時擁有人權益之非控股權益。非控股權益之所有其他部分乃按公平值計量。收購相關成本於產生時列為開支。

當所收購的一系列活動及資產包括一項輸入數據和一個實質流程，且兩者可為創造輸出作出重大貢獻時，本集團確定其已收購一項業務。

當本集團收購業務時，須根據合約條款、收購日期之經濟環境及相關條件對所承擔金融資產及負債進行評估，以適當分類及確認，包括將嵌入式衍生工具與被收購方主合約分開。

倘業務合併分階段進行，先前持有之股本權益應按收購日期公平值重新計量，而任何因此產生的收益或虧損將於收益表或其他全面收益表中確認(如適當)。

收購方將轉讓之任何或然代價於收購日期按公平值確認。分類為資產或負債的或然代價均以公平值計量，而公平值變動將於收益表中確認。分類為權益的或然代價將不會重新計量，且其後結清於權益中入賬。

3. MATERIAL ACCOUNTING POLICIES (continued)**Business combinations and goodwill**

Business combinations are accounted for using the acquisition method. The consideration transferred is measured at the acquisition date fair value which is the sum of the acquisition date fair values of assets transferred by the Group, liabilities assumed by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. For each business combination, the Group elects whether to measure the non-controlling interests in the acquiree at fair value or at the proportionate share of the acquiree's identifiable net assets. All other components of non-controlling interests are measured at fair value. Acquisition-related costs are expensed as incurred.

The Group determines that it has acquired a business when the acquired set of activities and assets includes an input and a substantive process that together significantly contribute to the ability to create outputs.

When the Group acquires a business, it assesses the financial assets and liabilities assumed for appropriate classification and designation in accordance with the contractual terms, economic circumstances and pertinent conditions as at the acquisition date. This includes the separation of embedded derivatives in host contracts of the acquiree.

If the business combination is achieved in stages, the previously held equity interest is remeasured at its acquisition date fair value and any resulting gain or loss is recognized in the profit or loss or other comprehensive income, as appropriate.

Any contingent consideration to be transferred by the acquirer is recognized at fair value at the acquisition date. Contingent consideration classified as an asset or liability is measured at fair value with changes in fair value recognized in the income statement. Contingent consideration that is classified as equity is not remeasured and subsequent settlement is accounted for within equity.

3. 重大會計政策(續)**業務合併及商譽(續)**

商譽按成本進行初始計量，即已轉讓代價、非控股權益之確認金額及本集團先前所持於被收購方之股本權益公平值總額超出所收購可識別資產及所承擔負債之差額。倘總代價及其他項目之總和低於所收購資產淨值之公平值，則於重新評估後之差額會於收益表確認為廉價購買時之收益。

初始確認後，商譽按成本減累計減值虧損計量。商譽每年就減值進行檢討，倘有事件或情況變化顯示賬面值可能出現減值跡象，則進行更為頻密之檢討。本集團於三月三十一日進行年度商譽減值測試。就減值測試而言，業務合併中購入之商譽由收購日期起，被分配到預期將從合併之協同效應中受益之本集團各現金產生單位，不論本集團之其他資產或負債是否被分配到該等單位或單位組別。

減值按對與商譽有關之現金產生單位(現金產生單位組別)可收回金額進行之評估釐定。倘現金產生單位(現金產生單位組別)之可收回金額少於其賬面值，則確認減值虧損。就商譽確認之減值虧損不會於隨後期間撥回。

當商譽分配至現金產生單位(或現金產生單位組別)及出售該單位之某部分業務，則於釐定出售業務之收益或虧損時，與出售業務相關之商譽將包括在該業務之賬面值內。在此情況下出售之商譽將以出售業務和保留之現金產生單位部分相對價值為基礎作計量。

3. MATERIAL ACCOUNTING POLICIES (continued)**Business combinations and goodwill (continued)**

Goodwill is initially measured at cost, being the excess of the aggregate of the consideration transferred, the amount recognized for non-controlling interests and any fair value of the Group's previously held equity interests in the acquiree over the identifiable assets acquired and liabilities assumed. If the sum of this consideration and other items is lower than the fair value of the net assets acquired, the difference is, after reassessment, recognized in the income statement as a gain on bargain purchase.

After initial recognition, goodwill is measured at cost less any accumulated impairment losses. Goodwill is tested for impairment annually or more frequently if events or changes in circumstances indicate that the carrying value may be impaired. The Group performs its annual impairment test of goodwill as at 31 March. For the purpose of impairment testing, goodwill acquired in a business combination is, from the acquisition date, allocated to each of the Group's cash-generating units that are expected to benefit from the synergy of the combination, irrespective of whether other assets or liabilities of the Group are assigned to those units or groups of units.

Impairment is determined by assessing the recoverable amount of the cash-generating unit (group of cash-generating units) to which the goodwill relates. Where the recoverable amount of the cash-generating unit (group of cash-generating units) is less than the carrying amount, an impairment loss is recognized. An impairment loss recognized for goodwill is not reversed in a subsequent period.

Where goodwill has been allocated to a cash-generating unit (or group of cash-generating units) and part of the operation within that unit is disposed of, the goodwill associated with the operation disposed of is included in the carrying amount of the operation when determining the gain or loss on the disposal. Goodwill disposed of in these circumstances is measured based on the relative value of the operation disposed of and the portion of the cash-generating unit retained.

3. 重大會計政策(續)**公平值計量**

本集團於各報告期末按公平值計量投資物業。公平值為於計量日期於與市場參與者之有序交易中因出售資產而收取或因轉讓負債而支付之價格。公平值計量乃基於假設出售資產或轉讓負債之交易於資產或負債之主要市場發生，或如並無主要市場，則於資產或負債之最有利之市場發生。主要或最有利市場須為本集團可進入之市場。資產或負債之公平值乃使用市場參與者會於行使最佳經濟利益對資產或負債進行定價時所使用之假設予以計量。

非金融資產之公平值計量計及市場參與者以最佳方式動用資產或向會以最佳方式動用資產之其他市場參與者出售有關資產，以產生經濟利益之能力。

本集團針對具體情況使用不同估值方法，確保有足夠數據計量公平值，並儘可能利用有關可觀察輸入值及減少使用不可觀察輸入值。

3. MATERIAL ACCOUNTING POLICIES (continued)**Fair value measurement**

The Group measures its investment properties at fair value at the end of each reporting period. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either in the principal market for the asset or liability, or in the absence of a principal market, in the most advantageous market for the asset or liability. The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximizing the use of relevant observable inputs and minimizing the use of unobservable inputs.

3. 重大會計政策(續)**公平值計量(續)**

公平值於財務報表計量或披露之所有資產及負債，乃根據對公平值計量整體而言屬重大之最低層級輸入值分類於公平值層級，載列如下：

- 第一層 – 基於相同資產或負債於活躍市場之報價(未經調整)
- 第二層 – 基於對公平值計量而言屬重大之最低層級輸入值可觀察(不論直接或間接)之估值技巧
- 第三層 – 基於對公平值計量而言屬重大之最低層級輸入值不可觀察之估值技巧

對於按經常性基準於財務報表確認之資產及負債，本集團於各報告期末透過重新評估分類(根據對公平值計量整體而言屬重大之最低層級輸入值)，確定是否於各層級之間發生轉移。

非金融資產減值

倘有跡象顯示出現減值或要求就資產進行年度減值測試(存貨、遞延稅項資產及投資物業除外)，則會估計該資產的可收回金額。可收回金額按資產或現金產出單位的使用價值或其公平值減處置成本(以較高者為準)，並就個別資產而釐定，除非有關資產並無產生在頗大程度上獨立於其他資產或資產組別的現金流入，在此情況下可收回金額就資產所屬的現金產出單位而釐定。

3. MATERIAL ACCOUNTING POLICIES (continued)**Fair value measurement (continued)**

All assets and liabilities for which fair value is measured or disclosed in the financial statements are categorized within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole:

- Level 1 – based on quoted prices (unadjusted) in active markets for identical assets or liabilities
- Level 2 – based on valuation techniques for which the lowest level input that is significant to the fair value measurement is observable, either directly or indirectly
- Level 3 – based on valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable

For assets and liabilities that are recognized in the financial statements on a recurring basis, the Group determines whether transfers have occurred between levels in the hierarchy by reassessing categorization (based on the lowest level input that is significant to the fair value measurement as a whole) at the end of each reporting period.

Impairment of non-financial assets

Where an indication of impairment exists, or when annual impairment testing for an asset is required (other than inventories, deferred tax assets and investment properties), the asset's recoverable amount is estimated. An asset's recoverable amount is the higher of the asset's or cash-generating unit's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs.

3. 重大會計政策(續)**非金融資產減值(續)**

在對現金產出單位進行減值測試時，倘公司資產(如總部大樓)的部分賬面值在合理及一致的基準上進行分配，則將分配至個別現金產出單位，否則將分配至最小現金產出單位組別。

減值虧損僅於資產賬面值超出其可收回金額時予以確認。於評估使用價值時，估計未來現金流量按可反映現時市場評估的貨幣時間值及資產特定風險的除稅前折現率折減至現值。減值虧損於產生期間自收益表中與減值資產功能相符之該等支出類別扣除。減值虧損於其產生期間計入，並於收益表內扣除，除非該資產是以重估值列賬，在此情況下，則減值虧損按該重估資產的有關會計政策入賬。

於每個報告期末會評定是否有跡象顯示之前已確認的減值虧損不再存在或減少。倘出現該等跡象，則會估計可收回金額。過往確認的資產減值虧損(商譽除外)僅會於用以釐定資產可收回金額的估計改變時撥回，惟撥回後的數額不得高於假設過往年度並無就資產確認減值虧損而應有的賬面值(扣除折舊／攤銷後)。減值虧損的撥回於產生期間計入收益表。

In testing a cash-generating unit for impairment, a portion of the carrying amount of a corporate asset (e.g., a headquarters building) is allocated to an individual cash-generating unit if it can be allocated on a reasonable and consistent basis or, otherwise, to the smallest group of cash-generating units.

An impairment loss is recognized only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to the income statement in the period in which it arises in those expense categories consistent with the function of the impaired asset. An impairment loss is charged to the income statement in the period in which it arises, unless the asset is carried at a revalued amount, in which case the impairment loss is accounted for in accordance with the relevant accounting policy for that revalued asset.

An assessment is made at the end of each reporting period as to whether there is an indication that previously recognized impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognized impairment loss of an asset other than goodwill is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation/amortization) had no impairment loss been recognized for the asset in prior years. A reversal of such an impairment loss is credited to the income statement in the period in which it arises.

物業、廠房及設備及折舊

除在建工程以外之物業、廠房及設備乃按成本值減累計折舊及任何減值後入賬。

物業、廠房及設備之成本值包括其購入價及令其達致符合預計用途之操作狀況及付運至使用地點之任何直接應佔費用。在物業、廠房及設備投產後產生之開支，例如維修及保養，通常在產生之期間從收益表中扣除。在符合確認條件之情況下，主要檢修費用將予以資本化，作為一項置換列入資產之賬面值。倘物業、廠房及設備之重要部分需要分期更換，本集團會將該部分確認為擁有特定使用年期及相應地折舊之獨立資產。

Property, plant and equipment and depreciation

Property, plant and equipment, other than construction in progress, are stated at cost less accumulated depreciation and any impairment losses.

The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use. Expenditure incurred after items of property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to the income statement in the period in which it is incurred. In situations where the recognition criteria are satisfied, the expenditure for a major inspection is capitalized in the carrying amount of the asset as a replacement. Where significant parts of property, plant and equipment are required to be replaced at intervals, the Group recognizes such parts as individual assets with specific useful lives and depreciates them accordingly.

3. 重大會計政策(續)**物業、廠房及設備及折舊(續)**

折舊乃以直線法按其估計可使用年期將物業、廠房及設備各個項目之成本攤銷至其剩餘價值計算。為此而採用的主要年率如下：

香港之樓宇	–	按租賃年期
香港以外地區之樓宇	–	十五至六十年
廠房、機器、傢俬及其他設備	–	二至十五年

永久業權土地並無作出折舊撥備。

倘若物業、廠房及設備項目之部分具不同的使用期限，該項目之成本按合理基準分配給各部分，其各部分各自計算折舊。

剩餘價值、可使用年期及折舊方法最少於每個財政年度末審閱及在適當時進行調整。

物業、廠房及設備項目包括任何已初始確認之重要部分乃於出售或當預期使用或出售項目將不產生未來經濟利益時終止確認。於終止確認該資產的年度有關出售或棄用所產生的收益或虧損，為其銷售所得淨額與賬面價之差額。

在建工程按成本值扣除減值列賬及無作出折舊撥備。當工程完成及可供使用後，在建工程將重新適當地按物業、廠房及設備種類分類。

Depreciation is calculated on the straight-line basis to write off the cost of each item of property, plant and equipment to its residual value over its estimated useful life. The principal annual rates used for this purpose are as follows:

Buildings in Hong Kong	–	Over the lease terms
Buildings outside Hong Kong	–	15 to 60 years
Plant, machinery, furniture and other equipment	–	2 to 15 years

Freehold land is not depreciated.

Where parts of an item of property, plant and equipment have different useful lives, the cost of that item is allocated on a reasonable basis among the parts and each part is depreciated separately.

Residual values, useful lives and the depreciation method are reviewed, and adjusted if appropriate, at least at each financial year end.

An item of property, plant and equipment including any significant part initially recognized is derecognized upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss on disposal or retirement recognized in the income statement in the year the asset is derecognized is the difference between the net sale proceeds and the carrying amount of the relevant asset.

Construction in progress is stated at cost less any impairment losses, and is not depreciated. It is reclassified to the appropriate category of property, plant and equipment when completed and ready for use.

3. 重大會計政策(續)**投資物業**

投資物業指持作賺取租金收入及／或資本增值用途(包括使用權資產)。該等物業初始按成本(包括交易成本)列賬。於初始確認後，投資物業乃按反映報告期末之市況的公平值列賬。

投資物業公平值變動產生之收益或虧損於產生年度計入收益表內。

棄用或出售投資物業產生之任何收益或虧損於棄用或出售年度在收益表內確認。

關於投資物業轉撥為自用物業，該物業就其後會計處理之視作成本，為改變用途當日的公平值。倘本集團佔用的物業由自用物業成為投資物業，須根據香港會計準則第16號《物業、廠房和設備》，本集團就自用物業將根據「物業、廠房及設備及折舊」所述的政策；及／或就持有為使用權資產的物業將根據「使用權資產」所述的政策，將該物業入賬，直至更改用途該日為止，而該物業的賬面值及公平值於當日的任何差額，則於資產重估儲備內作為變動入賬。

3. MATERIAL ACCOUNTING POLICIES (continued)**Investment properties**

Investment properties are interests in land and buildings (including right-of-use assets) held to earn rental income and/or for capital appreciation. Such properties are measured initially at cost, including transaction costs. Subsequent to initial recognition, investment properties are stated at fair value, which reflects market conditions at the end of the reporting period.

Gains or losses arising from changes in the fair values of investment properties are included in the income statement in the year in which they arise.

Any gains or losses on the retirement or disposal of an investment property are recognized in the income statement in the year of the retirement or disposal.

For a transfer from investment properties to owner-occupied properties, the deemed cost of a property for subsequent accounting is its fair value at the date of change in use. If a property occupied by the Group as an owner-occupied property becomes an investment property, the Group accounts for such property in accordance with the policy stated under "Property, plant and equipment and depreciation" for owned property and/or accounts for such property in accordance with the policy stated under "Right-of-use assets" for property held as a right-of-use asset up to the date of change in use, and any difference at that date between the carrying amount and the fair value of the property is accounted for as movements in the asset revaluation reserve in accordance with HKAS 16 *Property, Plant and Equipment*.

3. 重大會計政策(續)**無形資產(商譽除外)**

單獨取得的無形資產於初始確認時按成本計量。無形資產的可使用年期評定為有限期或無限期。有限期的無形資產隨後按可使用經濟年期攤銷，於有跡象顯示無形資產可能出現減值時評估減值。有限可使用年期的無形資產的攤銷期及攤銷方法至少於各財政年度末審閱。

技術

購入的技術按成本扣除任何減值虧損列賬，並按五年可使用年期以直線法攤銷。

研究及開發費用

所有研究費用於發生時在收益表中扣除。

集團須展示新產品的研發項目為技術上可行，使該項目的無形資產可以被應用或出售，有意及有能力應用或出售該資產，該資產如何帶來未來經濟利益，有足夠資源完成該資產，以及該研發費用可以可靠地計量，該費用才可資本化及延後列支。否則，產品開發開支於發生時會作列支處理。

3. MATERIAL ACCOUNTING POLICIES (continued)**Intangible assets (other than goodwill)**

Intangible assets acquired separately are measured on initial recognition at cost. The useful lives of intangible assets are assessed to be either finite or indefinite. Intangible assets with finite lives are subsequently amortized over the useful economic life and assessed for impairment whenever there is an indication that the intangible asset may be impaired. The amortization period and the amortization method for an intangible asset with a finite useful life are reviewed at least at each financial year end.

Know-how

Purchased know-how is stated at cost less any impairment losses and is amortized on the straight-line basis over its estimated useful life of 5 years.

Research and development costs

All research costs are charged to the income statement as incurred.

Expenditure incurred on projects to develop new products is capitalized and deferred only when the Group can demonstrate the technical feasibility of completing the intangible asset so that it will be available for use or sale, its intention to complete and its ability to use or sell the asset, how the asset will generate future economic benefits, the availability of resources to complete the project and the ability to measure reliably the expenditure during the development. Product development expenditure which does not meet these criteria is expensed when incurred.

3. 重大會計政策(續)**投資及其他金融資產***初始確認及計量*

金融資產於初始確認時分類為其後按攤銷成本、按公平值計入其他全面收益及按公平值計入損益計量。

於初始確認時，金融資產分類取決於金融資產的合約現金流量特點及本集團管理該等金融資產的業務模式。除並無重大融資成分或本集團已應用可行權宜方法不調整重大融資成分的影響的應收貿易賬款外，本集團初始按公平值加上(倘金融資產並非按公平值計入損益)交易成本計量金融資產。並無重大融資部分或本集團已應用可行權宜方法的應收貿易賬款按照下文「收益確認」所載政策根據香港財務報告準則第15號釐定的交易價格計量。

為使金融資產按攤銷成本或按公平值計入其他全面收益進行分類及計量，需產生純粹為支付本金及未償還本金利息(純粹為支付本金及利息)的現金流量。具有並非純粹支付本金及利息之現金流量的金融資產進行分類及按公平值計量計入損益，且不論業務模式。

3. MATERIAL ACCOUNTING POLICIES (continued)**Investments and other financial assets***Initial recognition and measurement*

Financial assets are classified, at initial recognition, as subsequently measured at amortized cost, fair value through other comprehensive income, and fair value through profit or loss.

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the Group's business model for managing them. With the exception of trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient of not adjusting the effect of a significant financing component, the Group initially measures a financial asset at its fair value, plus in the case of a financial asset not at fair value through profit or loss, transaction costs. Trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient are measured at the transaction price determined under HKFRS 15 in accordance with the policies set out for "Revenue recognition" below.

In order for a financial asset to be classified and measured at amortized cost or fair value through other comprehensive income, it needs to give rise to cash flows that are solely payments of principal and interest ("SPPI") on the principal amount outstanding. Financial assets with cash flows that are not SPPI are classified and measured at fair value through profit or loss, irrespective of the business model.

3. 重大會計政策(續)**投資及其他金融資產(續)***初始確認及計量(續)*

本集團管理金融資產的業務模式指其如何管理其金融資產以產生現金流量。業務模式確定現金流量是否來自收集合約現金流量、出售金融資產、或兩者兼有。按攤銷成本分類及計量的金融資產乃於一項業務模式中以持有該等金融資產以收取合約現金流量為目標而持有，而按公平值分類及計量計入其他全面收益的金融資產則於一項業務模式中以持作收取合約現金流量及持作出售為目標而持有。並非於上述業務模式中持有的金融資產根據按公平值計量計入損益而分類及計量。

買入及出售乃指按照一般市場規定或慣例在一定期間內要求交付資產之金融資產買賣，正常情況下於交易日(即本集團承諾購買或出售該資產之日期)予以確認。

後續計量

其後金融資產之計量根據其分類進行，該等金融資產之分類如下：

按攤銷成本計量的金融資產(債務工具)

按攤銷成本計量的金融資產其後使用實際利率方法計量，並可能受減值影響。當資產終止確認、修訂或減值時，收益及虧損於收益表內確認。

3. MATERIAL ACCOUNTING POLICIES (continued)**Investments and other financial assets (continued)***Initial recognition and measurement (continued)*

The Group's business model for managing financial assets refers to how it manages its financial assets in order to generate cash flows. The business model determines whether cash flows will result from collecting contractual cash flows, selling the financial assets, or both. Financial assets classified and measured at amortized cost are held within a business model with the objective to hold financial assets in order to collect contractual cash flows, while financial assets classified and measured at fair value through other comprehensive income are held within a business model with the objective of both holding to collect contractual cash flows and selling. Financial assets which are not held within the aforementioned business models are classified and measured at fair value through profit or loss.

Purchases or sales of financial assets that require delivery of assets within the period generally established by regulation or convention in the marketplace are recognized on the trade date, that is, the date that the Group commits to purchase or sell the asset.

Subsequent measurement

The subsequent measurement of financial assets depends on their classification as follows:

Financial assets at amortized cost (debt instruments)

Financial assets at amortized cost are subsequently measured using the effective interest method and are subject to impairment. Gains and losses are recognized in the income statement when the asset is derecognized, modified or impaired.

3. 重大會計政策(續)

終止確認金融資產

金融資產(或金融資產之一部分或一組相似金融資產之一部分,如適用)主要在下列情況將被終止確認(例如:從本集團之綜合財務狀況表移除),倘:

- 收取該項資產的所得現金流量之權利經已屆滿;或
- 本集團已將收取該項資產所得現金流量之權利轉讓,但已透過「傳送」安排,將所得現金流量在沒有顯著延緩之情況下,全數付予第三者;及(i)本集團已轉讓該項資產之絕大部分風險及回報;或(ii)本集團並無轉讓或保留該項資產絕大部分風險及回報,但已轉讓該項資產之控制權。

倘本集團已轉讓其收取該項資產所得現金流量之權利或已訂立傳送安排,會評估其有否保留該項資產擁有權的風險及回報,以及其程度。倘其並無轉讓或保留該項資產的絕大部分風險及回報,且並無轉讓該項資產的控制權,本集團繼續按本集團的持續參與程度確認入賬該轉讓資產。於該情況下,本集團亦確認相關負債。已轉讓資產及相關負債乃按反映本集團保留之權利及義務之基準計量。

以對所轉讓資產作出擔保的形式持續參與的資產按資產原有賬面值與本集團應須償還的最高代價金額兩者的較低者計算。

3. MATERIAL ACCOUNTING POLICIES (continued)

Derecognition of financial assets

A financial asset (or, where applicable, a part of a financial asset or part of a group of similar financial assets) is primarily derecognized (i.e., removed from the Group's consolidated statement of financial position) when:

- the rights to receive cash flows from the asset have expired; or
- the Group has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a "pass-through" arrangement; and either (i) the Group has transferred substantially all the risks and rewards of the asset, or (ii) the Group has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

When the Group has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates if, and to what extent, it has retained the risk and rewards of ownership of the asset. When it has neither transferred nor retained substantially all the risks and rewards of the asset nor transferred control of the asset, the Group continues to recognize the transferred asset to the extent of the Group's continuing involvement. In that case, the Group also recognizes an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Group has retained.

Continuing involvement that takes the form of a guarantee over the transferred asset is measured at the lower of the original carrying amount of the asset and the maximum amount of consideration that the Group could be required to repay.

3. 重大會計政策(續)**金融資產減值**

本集團就所有並非按公平值計入損益而持有之所有債務工具確認預期信貸虧損(「預期信貸虧損」)撥備。預期信貸虧損乃基於根據合約到期的合約現金流量與本集團預期收取的所有現金流量之間的差額而釐定，並以原實際利率的近似值貼現。預期現金流量將包括出售所持抵押的現金流量或組成合約條款的其他加強信用之物品。

一般方式

預期信貸虧損分兩個階段確認。就自初始確認起未有顯著增加的信貸風險而言，預期信貸虧損提供予由未來十二個月內可能發生違約事件而導致的信貸虧損(十二個月預期信貸虧損)。就自初始確認起經已顯著增加的信貸風險而言，不論何時發生違約，於餘下風險年期內的預期信貸虧損均須計提虧損撥備(全期預期信貸虧損)。

於各報告日期，本集團評估金融工具的信貸風險自初始確認後是否出現顯著增加。作此評估時，本集團比較金融工具於報告日期出現違約的風險與該金融工具於初始確認日期出現違約的風險，並考慮毋須花費不必要成本或精力即可獲得的合理及有理據的資料，包括過往及前瞻性資料。本集團認為，當合約付款逾期超過三十天時，信貸風險即顯著增加。

3. MATERIAL ACCOUNTING POLICIES (continued)**Impairment of financial assets**

The Group recognizes an allowance for expected credit losses (“ECLs”) for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

General approach

ECLs are recognized in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12 months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information. The Group considers that there has been a significant increase in credit risk when contractual payments are more than 30 days past due.

3. 重大會計政策(續)**金融資產減值(續)****一般方式(續)**

本集團認為，倘合約付款逾期一年，則金融資產視作違約。本集團根據合理及有理據的資料(包括本集團的信貸風險控制慣例及逾期超過九十天之金融資產的過往還款率)，對逾期九十天視作違約的假設作出反駁。然而，在並無計及本集團持有的任何加強信用之物品前，本集團亦可於內部或外部資料顯示本集團不大可能悉數收取尚未償還合約金額時將金融資產視作違約。倘無法合理預期收回合約現金流量，則撇銷金融資產。

按攤銷成本計量之金融資產須根據一般方法進行減值，並於下列計量預期信貸虧損之階段分類，惟如下文所詳述應用簡化方法之應收貿易賬款及應收融資租賃賬款除外。

階段一 – 信貸風險自初始確認以來並無顯著增加，且虧損撥備按等同於十二個月預期信貸虧損之金額計量之金融工具

階段二 – 信貸風險自初始確認以來顯著增加(惟並非已信貸減值之金融資產)，且虧損撥備按等同於全期預期信貸虧損之金額計量之金融工具

階段三 – 於報告日期為已信貸減值(惟並非購買或發起之已信貸減值)，且虧損撥備按等同於全期預期信貸虧損之金額計量之金融資產

3. MATERIAL ACCOUNTING POLICIES (continued)**Impairment of financial assets (continued)****General approach (continued)**

The Group considers a financial asset in default when contractual payments are one year past due. The Group has rebutted the 90 days past due presumption of default based on reasonable and supportable information including the Group's credit risk control practices and the historical recovery rate of financial assets over 90 days past due. However, the Group may also consider a financial asset to be in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group. A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

Financial assets at amortized cost are subject to impairment under the general approach and they are classified within the following stages for measurement of ECLs except for trade receivables and finance lease receivables which apply the simplified approach as detailed below.

Stage 1 – Financial instruments for which credit risk has not increased significantly since initial recognition and for which the loss allowance is measured at an amount equal to 12-month ECLs

Stage 2 – Financial instruments for which credit risk has increased significantly since initial recognition but that are not credit-impaired financial assets and for which the loss allowance is measured at an amount equal to lifetime ECLs

Stage 3 – Financial assets that are credit-impaired at the reporting date (but that are not purchased or originated credit-impaired) and for which the loss allowance is measured at an amount equal to lifetime ECLs

3. 重大會計政策(續)**金融資產減值(續)***簡化方式*

就不含重大融資部分，或當本集團應用可行權宜方法不調整重大融資部分應收貿易賬款，以及應收融資租賃賬款，本集團應用簡化方式計算預期信貸虧損。根據簡化方法，本集團並無追蹤信貸風險之變動，而是基於各報告日期之全期預期信貸虧損確認虧損撥備。本集團已設立建基於歷史信貸虧損經驗之撥備矩陣，並就債務人及經濟環境特定之前瞻性因素作出調整。

金融負債*初始確認及計量*

金融負債於初始確認分類為透過損益賬按公平值列賬之金融負債、貸款及借款或指定於有效對沖中作為對沖工具的衍生工具(視情況而定)。

所有金融負債初始按公平值確認，如屬貸款及借款，則扣除直接應佔之交易成本。

本集團之金融負債包括應付貿易及票據賬款、於其他應付賬款及應計負債內的金融負債以及租賃負債。

3. MATERIAL ACCOUNTING POLICIES (continued)**Impairment of financial assets (continued)***Simplified approach*

For trade receivables that do not contain a significant financing component or when the Group applies the practical expedient of not adjusting the effect of a significant financing component, and finance lease receivables, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognizes a loss allowance based on lifetime ECLs at each reporting date. The Group has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

Financial liabilities*Initial recognition and measurement*

Financial liabilities are classified, at initial recognition, as financial liabilities at fair value through profit or loss, loans and borrowings, or as derivatives designated as hedging instruments in an effective hedge, as appropriate.

All financial liabilities are recognized initially at fair value and, in the case of loans and borrowings, net of directly attributable transaction costs.

The Group's financial liabilities include trade and bills payables, financial liabilities included in other payables and accruals and lease liabilities.

3. 重大會計政策(續)**金融負債(續)****後續計量**

金融負債之後續計量根據其分類進行，該等金融負債之分類如下：

按攤銷成本計量的金融負債(應付及其他應付賬款及借款)

於初始確認後，應付及其他應付以及計息借款其後以實際利率法按攤銷的成本計價，惟折算之影響並不重大者除外，於該情況下則以成本列賬。

如果負債終止確認以及按實際利率進行攤銷程序時，其損益在收益表內確認。

攤銷後的成本於計入收購之任何折讓或溢價後計算，並包括屬實際利率不可分割部分之費用或成本。實際利率攤銷於收益表內確認。

財務擔保合同

本集團作出之財務擔保合同即要求作出付款以償付持有人因特定債務人未能根據債務工具之條款償還到期款項而招致損失之合同。財務擔保合同初始按其公平值確認為負債(就發出該擔保直接應佔之交易成本進行調整)。初始確認後，本集團按以下兩者中之較高者計量財務擔保合同：(i)根據「金融資產減值」所載政策釐定的預期信貸虧損的撥備；及(ii)初始確認之金額減(倘適用)累計確認收入金額。

3. MATERIAL ACCOUNTING POLICIES (continued)**Financial liabilities (continued)****Subsequent measurement**

The subsequent measurement of financial liabilities depends on their classification as follows:

Financial liabilities at amortized cost (trade and other payables, and borrowings)

After initial recognition, trade and other payables and interest-bearing borrowings are subsequently measured at amortized cost, using the effective interest rate method unless the effect of discounting would be immaterial, in which case they are stated at cost.

Gains and losses are recognized in the income statement when the liabilities are derecognized as well as through the effective interest rate amortization process.

Amortized cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortization is included in the income statement.

Financial guarantee contracts

Financial guarantee contracts issued by the Group are those contracts that require a payment to be made to reimburse the holder for a loss it incurs because the specified debtor fails to make a payment when due in accordance with the terms of a debt instrument. A financial guarantee contract is recognized initially as a liability at its fair value, adjusted for transaction costs that are directly attributable to the issuance of the guarantee. Subsequent to initial recognition, the Group measures the financial guarantee contract at the higher of (i) the ECL allowance determined in accordance with the policy as set out in "Impairment of financial assets"; and (ii) the amount initially recognized less, when appropriate, the cumulative amount of income recognized.

3. 重大會計政策(續)

終止確認金融負債

財務負債之責任在已解除或註銷或屆滿時終止確認。

倘現有金融負債為同一貸款人以重大不同條款之負債取代時，或現有負債之條款有重大修改時，有關交換或修改則被視為終止確認原有負債及確認一項新負債，而有關賬面值之差額乃於收益表內確認入賬。

抵銷金融工具

金融資產與金融負債抵銷，而有關淨額當有現時可強制執行之法律權利以抵銷已確認金額且有意按淨額基準結算或變現資產及結清負債時在財務狀況表呈報。

存貨

存貨乃按成本值及可變現淨值之較低者入賬。成本按加權平均法計算，倘為在製品及製成品，則包括直接物料，直接勞工及應分擔之生產費用的部分入賬。可變現淨值乃根據估計售價減去預計直至產品製成及出售貨品所需之任何成本。

3. MATERIAL ACCOUNTING POLICIES (continued)

Derecognition of financial liabilities

A financial liability is derecognized when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognized in the income statement.

Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the statement of financial position if there is a currently enforceable legal right to offset the recognized amounts and there is an intention to settle on a net basis, or to realize the assets and settle the liabilities simultaneously.

Inventories

Inventories are stated at the lower of cost and net realizable value. Cost is determined on the weighted average basis and, in the case of work in progress and finished goods, comprises direct materials, direct labour and an appropriate proportion of overheads. Net realizable value is based on estimated selling prices less any estimated costs to be incurred to completion and disposal.

3. 重大會計政策(續)**現金及現金等價物**

就綜合財務狀況表而言，現金及現金等價物指現金、銀行存款、以及可隨時轉換為已知數額現金，並一般於購入時三個月內到期並承受價值變動風險甚微之短期及高度流通性之存款。

就綜合現金流量表而言，現金及銀行結存包括現金、銀行存款及以上定義之短期存款，扣除須應要求償還之銀行透支，該銀行透支用作為本集團現金管理之一個完整部分。

撥備

由於過往事件而需要承擔現時責任(法定或推定)，而履行該責任很可能導致資源流出，且責任之金額能夠可靠地估計，則確認撥備。

倘折現影響大，確認為撥備之金額為預期履行該責任所需之未來開支於報告期末之現值。倘由於時間流逝導致已折現現值金額增加，則計入收益表之融資成本內。

本集團就若干產品的銷售提供保證。本集團於初始確認該等保證式保證撥備，乃根據銷售量及過往維修及退貨之情況，(適當地)折現至其現值金額。保修相關費用會於每年更改。

3. MATERIAL ACCOUNTING POLICIES (continued)**Cash and cash equivalents**

Cash and cash equivalents in the consolidated statement of financial position comprise cash on hand and at banks, and short-term highly liquid deposits with maturity of generally within three months that are readily convertible into known amounts of cash, subject to an insignificant risk of changes in value and held for the purpose of meeting short-term cash commitments.

For the purpose of the consolidated statement of cash flows, cash and bank balances comprise cash on hands and at banks, and short-term deposits as defined above, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

Provisions

A provision is recognized when a present obligation (legal or constructive) has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate can be made of the amount of the obligation.

When the effect of discounting is material, the amount recognized for a provision is the present value at the end of the reporting period of the future expenditures expected to be required to settle the obligation. The increase in the discounted present value amount arising from the passage of time is included in finance costs in the income statement.

The Group provides for warranties in relation to the sale of certain products. Provisions for these assurance-type warranties granted by the Group are initially recognized based on sales volume and past experience of the level of repairs and returns, discounted to their present values as appropriate. The warranty-related cost is revised annually.

3. 重大會計政策(續)**所得稅**

所得稅包括當期及遞延稅項。與於收益表以外確認項目有關之所得稅在其他全面收益或直接於權益內確認。

即期稅務資產及負債以預期可退回或支付予稅務機關的金額計量，根據報告期末已頒布或實際頒布之稅率（及稅務法例）推算，並計及詮釋及本集團經營所在國家之現行慣例。

在報告期末時，資產與負債的稅基與其在財政報告的賬面值之間的所有暫時性差異，按負債法計提遞延稅項撥備。

所有應課稅暫時性差異均會確認為遞延稅項負債，惟：

- 倘若遞延稅項負債的起因，是由一宗非屬企業合併的交易中初始確認之資產或負債，與及在交易時，對會計溢利或應課稅溢利或虧損均無影響，且不會產生同等之應課稅及可扣減暫時性差，則屬例外；及
- 對於涉及附屬公司及聯營公司之投資的應課稅暫時性差異而言，倘若撥回暫時性差異的時間可以控制，以及該暫時性差異可能不會在可見將來撥回，則屬例外。

3. MATERIAL ACCOUNTING POLICIES (continued)**Income tax**

Income tax comprises current and deferred tax. Income tax relating to items recognized outside the income statement is recognized in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period, taking into consideration interpretations and practices prevailing in the countries in which the Group operates.

Deferred tax is provided, using the liability method, on all temporary differences at the end of the reporting period between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

Deferred tax liabilities are recognized for all taxable temporary differences, except:

- when the deferred tax liability arises from the initial recognition of an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss and does not give rise to equal taxable and deductible temporary differences; and
- in respect of taxable temporary differences associated with investments in subsidiaries and associates, when the timing of the reversal of the temporary differences can be controlled and it is probable that the temporary differences will not reverse in the foreseeable future.

所有可扣減暫時性差異，及未被動用稅項抵免與任何未被動用稅項虧損結轉，均確認為遞延稅項資產。若日後有可能出現應課稅溢利，可用以抵扣該等可扣減暫時性差異、以及未被動用稅項抵免及未被動用稅項虧損結轉，則遞延稅項資產方會確認入賬，惟：

- 倘若有關可扣減暫時性差異的遞延稅項資產的起因，是由一宗非屬企業合併的交易中初始確認資產或負債，而且在交易時，對會計溢利或應課稅溢利或虧損均無影響，且不會產生同等之應課稅及可扣減暫時性差，則屬例外；及
- 對於涉及附屬公司及聯營公司之投資的可扣減暫時性差異而言，只有在暫時性差異有可能在可見將來撥回，而且日後有可能出現應課稅溢利，可用以抵扣該等暫時性差異時，方會確認遞延稅項資產。

遞延稅項資產的賬面值，在每個報告期末予以評估。若不再可能有足夠應課稅溢利用以抵扣相關稅項資產的全部或部分，則扣減遞延稅項資產賬面值。在可能有足夠應課稅溢利用以抵扣相關稅項資產的全部或部分時，則在每個報告期末確認過往不予確認的遞延稅項資產。

Deferred tax assets are recognized for all deductible temporary differences, and the carryforward of unused tax credits and any unused tax losses. Deferred tax assets are recognized to the extent that it is probable that taxable profit will be available against which the deductible temporary differences, and the carryforward of unused tax credits and unused tax losses can be utilized, except:

- when the deferred tax asset relating to the deductible temporary differences arises from the initial recognition of an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss and does not give rise to equal taxable and deductible temporary differences; and
- in respect of deductible temporary differences associated with investments in subsidiaries and associates, deferred tax assets are only recognized to the extent that it is probable that the temporary differences will reverse in the foreseeable future and taxable profit will be available against which the temporary differences can be utilized.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be utilized. Unrecognized deferred tax assets are reassessed at the end of each reporting period and are recognized to the extent that it has become probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be recovered.

3. 重大會計政策(續)**所得稅(續)**

變現資產或清償負債的期間預期適用的稅率，會用作衡量遞延稅項資產及負債，並以報告期末當日已經生效或大致上已經生效的稅率(及稅法)為基準。

僅當本集團有可合法執行權利可將即期稅項資產與即期稅項負債抵銷，且遞延稅項資產與遞延稅項負債與同一稅務機關對同一應稅實體或於各未來期間預期有大額遞延稅項負債或資產需要結算或清償時，擬按淨額基準結算即期稅務負債及資產或同時變現資產及結算負債之不同稅務實體徵收之所得稅相關，則遞延稅項資產與遞延稅項負債可予抵銷。

政府補助款

政府補助款乃於合理確定將會取得該筆補助款及符合所有附帶條件時按公平值確認。當該補助款與開支項目有關時，補助款須有系統地與其擬補償的成本支銷期間內確認為收入。如補助款涉及一項資產，則公平值會計入遞延收入賬，並按有關資產之預期使用年期以每年均等額轉撥至收益表。

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply to the period when the asset is realized or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax assets and deferred tax liabilities are offset if and only if the Group has a legally enforceable right to set off current tax assets and current tax liabilities and the deferred tax assets and deferred tax liabilities relate to income taxes levied by the same taxation authority on either the same taxable entity or different taxable entities which intend either to settle current tax liabilities and assets on a net basis, or to realize the assets and settle the liabilities simultaneously, in each future period in which significant amounts of deferred tax liabilities or assets are expected to be settled or recovered.

Government grants

Government grants are recognized at their fair value where there is reasonable assurance that the grant will be received and all attaching conditions will be complied with. When the grant relates to an expense item, it is recognized as income on a systematic basis over the periods that the costs, for which it is intended to compensate, are expensed. Where the grant relates to an asset, the fair value is credited to a deferred income account and is released to the income statement over the expected useful life of the relevant asset by equal annual installments.

3. 重大會計政策(續)**收益確認***來自客戶合約之收益*

來自客戶合約之收益在貨品轉移至客戶時按反映本集團就交換該等貨品而預期有權換取之代價金額確認。

當合約包含融資部分，就貨品轉移予客戶而為客戶提供重大利益超過一年時，收益按應收金額現值計量，使用合約開始時在本集團與客戶之間訂立的獨立融資交易中反映的貼現率貼現。當合約包含為本集團提供超過一年的重大財務利益的融資部分時，根據合約確認的收益包括根據實際利率法計算的合約負債所附加的利息開支。對於客戶付款與承諾貨品轉移之間的期限為一年或不足一年的合約，交易價格根據香港財務報告準則第15號應用可行權宜方式就重大融資部分的影響不進行調整。此外，倘本集團確認之資產攤銷期為一年或不足一年，本集團已選擇應用可行權宜方法將獲取合同的增量成本於發生時確認為支出。

來自銷售貨品的收益於資產的控制權轉移至客戶時(一般在交付貨品時)確認。

3. MATERIAL ACCOUNTING POLICIES (continued)**Revenue recognition***Revenue from contracts with customers*

Revenue from contracts with customers is recognized when control of goods is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods.

When the contract contains a financing component which provides the customer with a significant benefit of financing the transfer of goods to the customer for more than one year, revenue is measured at the present value of the amount receivable, discounted using the discount rate that would be reflected in a separate financing transaction between the Group and the customer at contract inception. When the contract contains a financing component which provides the Group with a significant financial benefit for more than one year, revenue recognized under the contract includes the interest expense accreted on the contract liability under the effective interest method. For a contract where the period between the payment by the customer and the transfer of the promised goods is one year or less, the transaction price is not adjusted for the effects of a significant financing component, using the practical expedient in HKFRS 15. Furthermore, the Group has elected to apply the practical expedient to recognize the incremental costs of obtaining a contract as an expense when incurred if the amortization period of the asset that the Group otherwise would have recognized is one year or less.

Revenue from the sale of goods is recognized at the point in time when control of the asset is transferred to the customer, generally on delivery of the goods.

收益確認(續)

其他收入

利息收入利用實際利率法以應計基準確認，所用利率為於金融工具之預期年期或更短期間(如適用)內將估計未來現金收款準確折現至金融資產賬面淨額之利率。

租金收入於租賃年內按時間比例基準確認。

融資租賃利息收入利用實際利率法以應計基準確認，所用利率為於融資租賃的淨投資之預期年期或更短期間(如適用)內將估計未來現金收款準確折現至融資租賃的淨投資賬面淨額之利率。

合約負債

合約負債於本集團轉移相關貨品或服務之前收到客戶付款或有關款項到期(以較早者為準)時確認。合約負債於本集團履行合約(即轉讓相關貨品或服務的控制權予客戶)時確認為收益。

Revenue recognition (continued)

Other income

Interest income is recognized on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset.

Rental income is recognized on a time proportion basis over the lease term.

Finance lease interest income is recognized on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the net investment of the finance lease or a shorter period, when appropriate, to the net carrying amount of the net investment of the finance lease.

Contract liabilities

A contract liability is recognized when a payment is received or a payment is due (whichever is earlier) from a customer before the Group transfers the related goods or services. Contract liabilities are recognized as revenue when the Group performs under the contract (i.e., transfers control of the related goods or services to the customer).

3. 重大會計政策(續)

租賃

本集團於合同開始時評估合同是否屬於或包含租賃。倘合同授予權利以代價為換取在一段時間內控制已識別資產的使用，則該合同屬於或包含租賃。

本集團作為承租人

本集團對所有租賃(惟短期租賃及低價值資產租賃除外)採取單一確認及計量方法。本集團確認租賃負債以作出租賃款項，而使用權資產指使用相關資產的權利。

(a) 使用權資產

使用權資產於租賃開始日期(即相關資產可供使用日期)確認。使用權資產按成本減任何累計折舊及任何減值虧損計量，並就重新計量租賃負債作出調整。使用權資產的成本包括已確認的租賃負債金額、已產生的初始直接成本，以及於開始日期或之前作出的租賃款減已收取的任何租賃優惠。使用權資產的成本亦包括拆除及移除相關資產或還原相關資產或其位處的場地之估計成本(如適用)。使用權資產在租期及估計可使用年期(以較短者為準)內按直線法計提折舊如下：

租賃土地	五十至五十二年
物業	二至七年

倘使用權資產符合投資物業的定義，則計入投資物業。相應使用權資產初始按成本計量，其後根據本集團「投資物業」政策按公平值計量。

Leases

The Group assesses at contract inception whether a contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

Group as a lessee

The Group applies a single recognition and measurement approach for all leases, except for short-term leases and leases of low-value assets. The Group recognizes lease liabilities to make lease payments and right-of-use assets representing the right to use the underlying assets.

(a) Right-of-use assets

Right-of-use assets are recognized at the commencement date of the lease (that is the date the underlying asset is available for use). Right-of-use assets are measured at cost, less any accumulated depreciation and any impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognized, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received. Where applicable, the cost of a right-of-use asset also includes an estimate of costs to dismantle and remove the underlying asset or to restore the underlying asset or the site on which it is located. Right-of-use assets are depreciated on a straight-line basis over the shorter of the lease terms and the estimated useful lives of the assets as follows:

Leasehold land	50 to 52 years
Properties	2 to 7 years

When a right-of-use asset meets the definition of investment property, it is included in investment properties. The corresponding right-of-use asset is initially measured at cost, and subsequently measured at fair value, in accordance with the Group's policy for "Investment properties".

3. 重大會計政策(續)**租賃(續)****本集團作為承租人(續)****(b) 租賃負債**

租賃負債於租賃開始日期按租期內作出的租賃款的現值予以確認。租賃款包括固定款項(包括實質固定款項)減任何應收租賃優惠。

於計算租賃款的現值時，倘租賃內所隱含的利率不易釐定，則本集團應用租賃開始日期的增量借款利率計算。於開始日期後，租賃負債金額的增加反映利息的增加，並因支付租賃款項而減少。此外，如租期有任何修改、變化、租賃款項變化(例如租賃款日後因指數或利率變動而出現變動)或購買相關資產的選擇權評估有變，則重新計量租賃負債的賬面值。

(c) 短期租賃及低價值資產租賃

本集團對其物業的短期租賃(即租期為開始日期起計十二個月或以內且不包含購買選擇權的租賃)應用短期租賃確認豁免。其亦將低價值資產租賃的確認豁免應用予被視為低價值的辦公室設備的租賃。

短期租賃及低價值資產租賃的租賃款在租期內按直線法確認為支出。

Lease liabilities are recognized at the commencement date of the lease at the present value of lease payments to be made over the lease term. The lease payments include fixed payments (including in-substance fixed payments) less any lease incentives receivable.

In calculating the present value of lease payments, the Group uses its incremental borrowing rate at the lease commencement date because the interest rate implicit in the lease is not readily determinable. After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made. In addition, the carrying amount of lease liabilities is remeasured if there is a modification, a change in the lease term, a change in lease payments (e.g., a change to future lease payments resulting from a change in an index or rate) or a change in assessment of an option to purchase the underlying asset.

(c) Short-term leases and leases of low-value assets

The Group applies the short-term lease recognition exemption to its short-term leases of properties (that is those leases that have a lease term of 12 months or less from the commencement date and do not contain a purchase option). It also applies the recognition exemption for leases of low-value assets to leases of office equipment that is considered to be of low value.

Lease payments on short-term leases and leases of low-value assets are recognized as an expense on a straight-line basis over the lease term.

3. 重大會計政策(續)**租賃(續)****本集團作為出租人**

本集團作為出租人時，於租賃開始(或租賃變更)時將其每項租賃分類為經營租賃或融資租賃。

本集團並未轉移資產擁有權所附帶的絕大部分風險與回報的租賃歸類為經營租賃。租金收入於租期內按直線法列賬並計入收益表的其他收入。

將相關資產擁有權所附帶的絕大部分風險與回報轉移予承租人的租賃，入賬列作融資租賃。於開始日期，租賃資產的成本按租賃款及相關款項的現值(包括初始直接成本)資本化，及以應收款列示，金額相等於租賃的淨投資。於租賃的淨投資之融資收入按租期內之每期間之固定回報率自收益表中確認。

借貸成本

收購、建造或生產合資格資產(即須花費長時間以達致擬定用途或出售之資產)之直接應佔借貸成本，乃予以資本化作為該等資產之成本部分。該借貸成本於有關資產大致可作擬定用途或出售時停止撥作資本。特定借貸作合資格資產開支因等待作臨時投資而賺取的投資收入須從資本化的借貸成本中扣除。所有其他借貸成本均於產生期間支銷。借貸成本包括實體所產生與借款有關之利息及其他成本。

3. MATERIAL ACCOUNTING POLICIES (continued)**Leases (continued)****Group as a lessor**

When the Group acts as a lessor, it classifies at lease inception (or when there is a lease modification) each of its leases as either an operating lease or a finance lease.

Leases in which the Group does not transfer substantially all the risks and rewards incidental to ownership of an asset are classified as operating leases. Rental income is accounted for on a straight-line basis over the lease terms and is included in other income in the income statement.

Leases that transfer substantially all the risks and rewards incidental to ownership of an underlying asset to the lessee are accounted for as finance leases. At the commencement date, the cost of the leased asset is capitalized at the present value of the lease payments and related payments (including the initial direct costs), and presented as a receivable at an amount equal to the net investment in the lease. The finance income on the net investment in the lease is recognized in the income statement so as to provide a constant periodic rate of return over the lease terms.

Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, i.e., assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalized as part of the cost of those assets. The capitalization of such borrowing costs ceases when the assets are substantially ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs capitalized. All other borrowing costs are expensed in the period in which they are incurred. Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds.

3. 重大會計政策(續)**股息**

末期股息在獲股東於股東大會批准時確認為負債。擬派之末期股息於財務報告書附註披露。由於本公司之組織章程及細則授予董事宣派中期股息之權力，故中期股息可同時獲建議及宣派。因此，中期股息在獲建議及宣派時即時確認為一項負債。

外幣

該等財務報表以港元(乃本公司之功能貨幣)呈列。本集團屬下各公司自行決定其功能貨幣，而各公司的財務報表內之項目均以該功能貨幣計算。本集團屬下各公司列賬之外幣交易首先按交易日期之功能貨幣匯率入賬。於報告期末以外幣為單位之貨幣資產與負債按該日之功能貨幣匯率重新換算。因貨幣結算或換算引起之差額於收益表內確認。根據外幣歷史成本計算之非貨幣項目按初始交易日期之匯率換算。根據外幣公平值計算之非貨幣項目按釐定公平值當日之匯率計算。重新換算按公平值計量之非貨幣項目產生之收益或虧損，按確認該項目的公平值變動之收益或虧損一致之方式處理(即公平值收益或虧損於其他全面收益或收益表內確認之項目之匯兌差額亦分別於其他全面收益或收益表內確認)。

3. MATERIAL ACCOUNTING POLICIES (continued)**Dividends**

Final dividends are recognized as a liability when they are approved by the shareholders in a general meeting. Proposed final dividends are disclosed in the notes to the financial statements. Interim dividends are simultaneously proposed and declared because the Company's Memorandum and Association and Bye-laws grant the directors the authority to declare interim dividends. Consequently, interim dividends are recognized immediately as a liability when they are proposed and declared.

Foreign currencies

These financial statements are presented in HK\$, which is the Company's functional currency. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of the reporting period. Differences arising on settlement or translation of monetary items are recognized in the income statement. Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was measured. The gain or loss arising on translation of a non-monetary item measured at fair value is treated in line with the recognition of the gain or loss on change in fair value of the item (i.e., translation differences on the item whose fair value gain or loss is recognized in other comprehensive income or the income statement is also recognized in other comprehensive income or the income statement, respectively).

3. 重大會計政策(續)**外幣(續)**

為釐定終止確認與預付代價有關的非貨幣資產或非貨幣負債時的相關資產、開支或收入的初始確認匯率，初始交易日期為本集團初始確認因預付代價而產生非貨幣資產或非貨幣負債的日期。倘存在多次付款或預收款項，本集團釐定預付代價各付款或收款交易日期。

若干海外附屬公司、及聯營公司之功能貨幣並非港元。於報告期末，該等公司之資產及負債均按報告期末之匯率換算為港元，而該等公司之收益表按與交易日期之現行匯率相若之匯率換算為港元。匯率差異計入其他全面收益，並於匯兌變動儲備累計，惟歸屬於非控股權益之差額除外。於出售外地營運時，就特定外地營運儲備內之累計金額部分將於收益表確認。

就綜合現金流量表而言，海外附屬公司之現金流量按有關日期之匯率換算為港元。海外附屬公司年內經常產生之現金流量按年內之加權平均匯率換算為港元。

3. MATERIAL ACCOUNTING POLICIES (continued)**Foreign currencies (continued)**

In determining the exchange rate on initial recognition of the related asset, expense or income on the derecognition of a non-monetary asset or non-monetary liability relating to an advance consideration, the date of initial transaction is the date on which the Group initially recognizes the non-monetary asset or non-monetary liability arising from the advance consideration. If there are multiple payments or receipts in advance, the Group determines the transaction date for each payment or receipt of the advance consideration.

The functional currencies of certain overseas subsidiaries and associates are currencies other than the HK\$. As at the end of the reporting period, the assets and liabilities of these entities are translated into HK\$ at the exchange rates prevailing at the end of the reporting period and their income statements are translated into HK\$ at the exchange rates that approximate to those prevailing at the dates of the transactions. The resulting exchange differences are recognized in other comprehensive income and accumulated in the exchange fluctuation reserve, except to the extent that the differences are attributable to non-controlling interests. On disposal of a foreign operation, the cumulative amount in the reserve relating to that particular foreign operation is recognized in the income statement.

For the purpose of the consolidated statement of cash flows, the cash flows of overseas subsidiaries are translated into HK\$ at the exchange rates ruling at the dates of the cash flows. Frequently recurring cash flows of overseas subsidiaries which arise throughout the year are translated into HK\$ at the weighted average exchange rates for the year.

3. 重大會計政策(續)**僱員福利****(a) 退休金計劃**

本集團根據強制性公積金計劃條例設立定額供款之強制性公積金退休福利計劃(「強積金計劃」)予合資格參與該強積金計劃之僱員。供款乃按僱員底薪之若干百分比計算，並於根據強積金計劃之規則應予支付時計入收益表。強積金計劃之資產乃獨立於本集團之資產，並由獨立管理之基金另行持有。本集團之僱主供款于強積金計劃供款後全數歸屬僱員。

強積金計劃生效前，本集團曾設立一個定額供款退休福利計劃(「退休計劃」)，供合資格及選擇參與該計劃之僱員參加。退休計劃與強積金計劃之運作方式相近，惟倘僱員於有權全數收取本集團之僱主供款以前離職，本集團繼後應付之供款可以從遭放棄之有關款項扣減。

本集團在中國內地附屬公司之僱員須參與地方市政府所管理之中央退休金計劃(「中央計劃」)。該等附屬公司須根據其僱員之薪金若干百分比計算，在按中央計劃規定之支付日期向該中央計劃支付供款額，並在有關之期間從收益表中扣除。

3. MATERIAL ACCOUNTING POLICIES (continued)**Employee benefits****(a) Pension schemes**

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme (the “MPF Scheme”) under the Mandatory Provident Fund Schemes Ordinance, for those employees who are eligible to participate in the MPF Scheme. Contributions are made based on a certain percentage of the employees’ basic salaries and are charged to the income statement as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group’s employer contributions vest fully with the employees when contributed into the MPF Scheme.

Prior to the MPF Scheme becoming effective, the Group operated a defined contribution retirement benefit scheme (the “DCRB Scheme”) for those employees who were eligible and had elected to participate in the DCRB Scheme. The DCRB Scheme operates in a similar way to the MPF Scheme, except that when an employee leaves the Group prior to his/her interest in the DCRB Scheme vesting fully, the ongoing contributions payable by the Group would be reduced by the relevant amount of the forfeited employer contributions.

The employees of the Group’s subsidiaries in Chinese Mainland are required to participate in a central pension scheme (the “Central Scheme”) which is operated by the local municipal government. The contributions payable by these subsidiaries to the Central Scheme, which are based on a certain percentage of the salaries of their employees, are charged to the income statement as they become payable in accordance with the rules of the Central Scheme.

3. 重大會計政策(續)**僱員福利(續)****(a) 退休金計劃(續)**

根據台灣勞動基準法所要求，本集團在台灣之附屬公司設立一項撥款定額福利退休金計劃(「舊計劃」)，並須每月向該退休準備金供款，為僱員提供退休及終止服務之福利。該退休準備金由勞工退休準備金監督委員會(「委員會」)管理，並以委員會之名義存入一間經政府批准擔當信託人之金融機構。定額福利計劃的退休金福利成本，乃採用預計單位基數精算估值法計算。

舊計劃所產生之重新計量(包括精算收益及虧損、資產上限之影響(不包括定額福利負債的利息淨額)及計劃資產回報(不包括定額福利負債的利息淨額))，乃即時確認於綜合財務狀況表內，有關計入或扣除自保留溢利之款項於發生期間確認於其他全面收益。重新計量概不於隨後期間重新分類至收益表。

過往服務成本乃於以下日期(以較早者為準)確認於收益表內：

- 計劃修訂或裁減之日；及
- 本集團確認架構重整相關成本之日

As required by the Taiwanese Labour Standard Law, the Group's subsidiaries in Taiwan operate a funded defined benefit pension scheme (the "Old Scheme") and make monthly contributions to the retirement fund to meet employees' retirement and termination benefits entitlements. The fund is administered by the Employees' Retirement Fund Committee (the "Committee") and is deposited under the Committee's name with a government approved financial institution, which acts as the trustee. The cost of providing pension benefits under the defined benefit plan is determined using the projected unit credit actuarial valuation method.

Remeasurements arising from the Old Scheme, comprising actuarial gains and losses, the effect of the asset ceiling (excluding amounts included in net interest on the net defined benefit liability) and the return on plan assets (excluding amounts included in net interest on the net defined benefit liability), are recognized immediately in the consolidated statement of financial position with a corresponding debit or credit to retained profits through other comprehensive income in the period in which they occur. Remeasurements are not reclassified to the income statement in subsequent periods.

Past service costs are recognized in the income statement at the earlier of:

- the date of the plan amendment or curtailment; and
- the date that the Group recognizes restructuring-related costs

利息淨額乃利用折現率將定額福利負債或資產淨額計算。本集團於綜合收益表「銷售成本」，「銷售及分銷支出」及「行政支出」下確認定額福利責任之以下變動：

- 服務成本包括現時服務成本、過往服務成本、裁減之損益及非例行結算；及
- 利息支出或收入淨額

於二零零五年，台灣政府修訂了相關的退休金計劃，於勞工退休金條例中，增加了新的供款性退休金計劃(「新計劃」)，並於二零零五年七月一日生效。根據修訂的退休規則，僱員能按需要選擇加入新計劃或繼續參與舊計劃。本集團在台灣之附屬公司對選擇了新計劃的僱員的責任為自選擇後按每月報酬的所需部分供款予政府指定賬戶，但本集團在台灣之附屬公司仍須負責按舊計劃於二零零五年七月一日前相關服務年期的部分。

(b) 基於股權的支付交易

本公司採納購股權計劃及股份獎勵計劃。集團的僱員(包括董事)為集團提供服務藉以換取股權形式報酬之交易是為「以股權支付交易」。與僱員進行股權結算之交易成本乃參考其於授出日期之公平值計量。購股權之公平值乃由外聘專業合資格估值師採用二項式/布萊克—斯科爾斯期權定價模型釐定，詳情載列於財務報表附註31。股份獎勵之公平值乃按照股份於授予日期之價格而釐定。

Net interest is calculated by applying the discount rate to the net defined benefit liability or asset. The Group recognizes the following changes in the net defined benefit obligation under “cost of sales”, “selling and distribution expenses” and “administrative expenses” in the consolidated income statement:

- Service costs comprising current service costs, past-service costs, gains and losses on curtailments and non-routine settlements; and
- Net interest expense or income

In 2005, the Taiwan government amended the related pension scheme regulations by adding a new contributory pension scheme (the “New Scheme”) in the Labour Pension Act, which became effective on 1 July 2005. According to the amended retirement regulations, the employees can choose to either join the New Scheme or to stay participating with the Old Scheme. The obligation of the Group’s subsidiaries in Taiwan to those employees selecting the New Scheme is to contribute the required portion of the monthly compensation to the government designated account since the election, while the Group’s subsidiaries in Taiwan are still liable under the Old Scheme for the portion pertaining to the service years prior to 1 July 2005.

(b) Share-based payment transactions

The Company operates a share option scheme and a share award scheme. Employees (including directors) of the Group receive remuneration in the form of share-based payment transactions, whereby employees render services in exchange for equity instruments (“equity-settled transactions”). The cost of equity-settled transactions with employees is measured by reference to the fair value at the date at which they are granted. The fair value of share option is determined by an external valuer using a polynomial model, further details of which are given in note 31 to the financial statements. The fair value of share award is determined by the closing share price for the share as of the date of grant of share award.

以股權支付交易的成本連同股價的相應升幅會於達到表現及／或服務條件的期內確認為僱員福利支出。由每個報告期末直至歸屬日就以股權支付交易確認的累計支出反映歸屬期屆滿，以及就本集團有關最終將會歸屬的股本工具數目的最佳估計。每一期間收益表之扣除或計入，指該期間開始和結束時已確認累計支出之變動。

釐定獎勵獲授當日之公平值時，並不計及服務及非市場表現條件，惟在有可能符合條件的情況下，作為本集團對最終將會歸屬的股本工具數目最佳估計之一部分評估。市場表現條件反映於獲授當日之公平值。獎勵之任何其他附帶條件(但不帶有附屬服務要求)視作非歸屬條件。非歸屬條件反映於獎勵之公平值中，除非同時具服務及／或表現條件，否則獎勵即時支銷。

因非市場表現及／或服務條件尚未達到，該獎勵最終未歸屬而不確認任何支出。當獎勵包括市場或非歸屬條件，倘符合所有其他表現及／或服務條件，不論市場或非歸屬條件是否達到要求，該等交易均視作已歸屬。

The cost of equity-settled transactions is recognized in employee benefit expense, together with a corresponding increase in equity, over the period in which the performance and/or service conditions are fulfilled. The cumulative expense recognized for equity-settled transactions at the end of each reporting period until the vesting date reflects the extent to which the vesting period has expired and the Group's best estimate of the number of equity instruments that will ultimately vest. The charge or credit to the income statement for a period represents the movement in the cumulative expense recognized as at the beginning and end of that period.

Service and non-market performance conditions are not taken into account when determining the grant date fair value of awards, but the likelihood of the conditions being met is assessed as part of the Group's best estimate of the number of equity instruments that will ultimately vest. Market performance conditions are reflected within the grant date fair value. Any other conditions attached to an award, but without an associated service requirement, are considered to be non-vesting conditions. Non-vesting conditions are reflected in the fair value of an award and lead to an immediate expensing of an award unless there are also service and/or performance conditions.

For awards that do not ultimately vest because non-market performance and/or service conditions have not been met, no expense is recognized. Where awards include a market or non-vesting condition, the transactions are treated as vesting irrespective of whether the market or non-vesting condition is satisfied, provided that all other performance and/or service conditions are satisfied.

當以股權支付報酬的條件修訂時，會確認最少的支出，猶如條款並無修訂一般之符合獎勵原先條款之水平。此外，倘按修訂日期的計算，任何修訂導致基於股權的支付交易的總公平值有所增加，或對僱員帶來其他利益，則應就該等修訂確認支出。

當以股權支付報酬註銷時，會視作報酬已於註銷當日已歸屬，而報酬尚未確認的任何支出會即時確認。

此包括未符合屬本集團或僱員控制範圍內之非歸屬條款所涉及之購股權。然而，倘註銷的報酬有任何替代的新報酬，並指定為授出當日的替代報酬，則該項註銷及報酬會如上段所述被視為原有報酬的修訂處理。

未行使購股權的攤薄影響會以額外股份攤薄入賬，計算每股盈利。

編製本集團財務報表時，管理層須作出可能影響收益、支出、資產及負債呈報金額及相應披露以及或然負債披露之判斷、估計及假設。此等假設及估計之不確定因素可能導致須於未來為受影響之資產及負債賬面值作出重大調整。

Where the terms of an equity-settled award are modified, as a minimum an expense is recognized as if the terms had not been modified, if the original terms of the award are met. In addition, an expense is recognized for any modification that increases the total fair value of the share-based payment transaction, or is otherwise beneficial to the employee as measured at the date of modification.

Where an equity-settled award is cancelled, it is treated as if it had vested on the date of cancellation, and any expense not yet recognized for the award is recognized immediately.

This includes any award where non-vesting conditions within the control of either the Group or the employee are not met. However, if a new award is substituted for the cancelled award, and is designated as a replacement award on the date that it is granted, the cancelled and new awards are treated as if they were a modification of the original award, as described in the previous paragraph.

The dilutive effect of outstanding options is reflected as additional share dilution in the computation of earnings per share.

4. SIGNIFICANT ACCOUNTING JUDGEMENTS AND ESTIMATES

The preparation of the Group's financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenue, expenses, assets and liabilities, and their accompanying disclosures, and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amounts of the assets or liabilities affected in the future.

於應用本集團之會計政策過程中，管理層已作出下列對財務報表內所確認金額產生最重大影響之判斷(不包括涉及估計者)：

(a) 資產減值

釐定資產有否出現減值或過往導致減值之情況是否不再存在時，本集團須就資產減值範圍作出判斷，特別是評估(1)有否出現可能影響資產價值之事件或影響資產價值之該等事件已不存在；(2)資產賬面值是否獲得日後現金流量現值淨額支持，而日後現金流量按持續使用資產或終止確認估計；及(3)編製現金流量預測所用適合主要假設包括現金流量預測是否以適當比率折現。倘管理層所選用以決定減值水平之假設(包括現金流量預測所用折現率或增長率假設)有變，或對減值測試所用現值淨額構成重大影響。

(b) 分派股息產生之扣繳稅

本集團在決定是否應根據有關稅務管轄權就若干附屬公司所分派之股息計提扣繳稅，乃按支付股息時間而作出判斷。本集團認為，倘若於可預見之未來溢利不獲分派，則毋須計提扣繳稅。

In the process of applying the Group's accounting policies, management has made the following judgements, apart from those involving estimations, which have the most significant effect on the amounts recognized in the financial statements:

(a) Impairment of assets

In determining whether an asset is impaired or the event previously causing the impairment no longer exists, the Group has to exercise judgement in the area of asset impairment, particularly in assessing: (1) whether an event has occurred that may affect the asset value or such event affecting the asset value has not been in existence; (2) whether the carrying value of an asset can be supported by the net present value of future cash flows which are estimated based upon the continued use of the asset or derecognition; and (3) the appropriate key assumptions to be applied in preparing cash flow projections including whether these cash flow projections are discounted using an appropriate rate. Changing the assumptions selected by management to determine the level of impairment, including the discount rates or the growth rate assumptions in the cash flow projections, could materially affect the net present value used in the impairment test.

(b) Withholding taxes arising from the distributions of dividends

The Group's determination as to whether to accrue for withholding taxes arising from the distributions of dividends from certain subsidiaries according to the relevant tax jurisdictions is subject to judgement on the timing of the payment of the dividend. The Group considered that if the profits will not be distributed in the foreseeable future, then no withholding taxes should be provided.

(c) 投資物業和自用物業的劃分

本集團釐定一項物業是否符合投資物業資格，並已制定作出此類判斷的準則。投資物業指為賺取租金或資本升值或兩者兼得而持有的物業。因此，本集團考慮一項物業產生的現金流量是否很大程度上獨立於本集團持有的其他資產。一些物業部分是為賺取租金或資本升值而持有，而另一部分為用於生產或提供貨品或服務或行政用途而持有。倘該等部分可分開出售或根據融資租賃分開出租，則本集團對該等部分獨立列賬。倘該等部分不能分開出售，則只有在為用於生產或提供貨品或服務或行政用途而持有的部分不重大的情況下，該物業方屬投資物業。判斷是對各單項物業作出，以確定配套服務是否如此重要以致物業不符合投資物業的資格。

(d) 融資租賃與經營租賃的劃分

租賃須分類為融資租賃(此租賃轉移擁有權之所有回報及風險大部分，及導致出租人確認應收款)或經營租賃(此租賃導致出租人仍確認租賃資產)。

以下情況一般會將租賃分類為融資租賃：

- 在租賃期屆滿時，租賃將資產的擁有權轉移給承租人；

(c) Classification between investment properties and owner-occupied properties

The Group determines whether a property qualifies as an investment property, and has developed criteria in making that judgement. Investment property is a property held to earn rentals or for capital appreciation or both. Therefore, the Group considers whether a property generates cash flows largely independently of the other assets held by the Group. Some properties comprise a portion that is held to earn rentals or for capital appreciation and another portion that is held for use in the production or supply of goods or services or for administrative purposes. If these portions could be sold separately or leased out separately under a finance lease, the Group accounts for the portions separately. If the portions could not be sold separately, the property is an investment property only if an insignificant portion is held for use in the production or supply of goods or services or for administrative purposes. Judgement is made on an individual property basis to determine whether ancillary services are so significant that a property does not qualify as an investment property.

(d) Classification between finance leases and operating leases

Leases are required to be classified as either finance leases (which transfer substantially all the risks and rewards of ownership, and give rise to the recognition of a receivable by the lessor) or operating leases (which result in the recognition of the leased asset by the lessor).

Situations that would normally lead to a lease being classified as a finance lease include the following:

- the lease transfers ownership of the asset to the lessee by the end of the lease term;

(d) 融資租賃與經營租賃的劃分(續)

- 承租人有購買資產的選擇權，所訂立的購買價格預計將遠低於行使選擇權時的公平值，並於租賃開始日時，就可合理地確定該選擇權將被行使；
- 即使所有權不轉移，但租賃期佔資產使用壽命的大部分；
- 於租賃開始日，最少應付租賃款項的現值幾乎相當於租賃資產的公平值；或
- 租賃資產性質特殊，如果不作較大改造，只有承租人才能使用。

(e) 釐定附有續租選擇權的合同租期的重大判斷

本集團有一張含延期選擇權的租賃合同。本集團運用判斷以評估是否行使選擇權作續租。就此，本集團會考慮產生經濟誘因以使其行使續租的所有相關因素。於開始日期後，倘出現本集團可予控制的重大事項或情況改變，並影響其行使或不行使續租選擇權的能力，則本集團會重新評估租期。

由於該資產對本集團營運構成重要性，本集團將續租期計入物業租賃租期的一部分。該租賃有一個不可撤銷的短期間(即五年)，而倘替代品是不易可得的，則將會對營運造成重大負面影響。

(d) Classification between finance leases and operating leases (continued)

- the lessee has the option to purchase the asset at a price which is expected to be sufficiently lower than the fair value at the date the option becomes exercisable and, at the inception of the lease, it is reasonably certain that the option will be exercised;
- the lease term is for the major part of the economic life of the asset, even if title is not transferred;
- at the inception of the lease, the present value of the minimum lease payments amounts to at least substantially all of the fair value of the leased asset; or
- the leased assets are of a specialized nature such that only the lessee can use them without major modifications being made.

(e) Significant judgement in determining the lease term of a contract with a renewal option

The Group has a lease contract that includes an extension option. The Group applies judgement in evaluating whether or not to exercise the option to renew the lease. That is, it considers all relevant factors that create an economic incentive for it to exercise the renewal. After the commencement date, the Group reassesses the lease term if there is a significant event or change in circumstances that is within its control and affects its ability to exercise or not to exercise the option to renew.

The Group includes the renewal period as part of the lease term for a lease of its property due to the significance of the asset to its operations. The lease has a short non-cancellable period (i.e., five years) and there will be a significant negative effect on operation if a replacement is not readily available.

估計不明朗因素

大有可能導致下一財政年度之資產及負債賬面值須作重大調整之未來主要假設及報告期末之其他主要估計不明朗因素討論如下。

(a) 應收貿易賬款及應收融資租賃賬款預期信貸虧損撥備之估計

本集團利用撥備矩陣計算應收貿易賬款及應收融資租賃賬款之預期信貸虧損。撥備率乃基於多個具有類似虧損模式之客戶分部組別之逾期天數釐定。本集團考慮於報告日期可得的有關過往事項、當前狀況及未來經濟狀況預測之資料。

撥備矩陣初始以本集團觀察所得之歷史違約率為基礎。本集團將校準矩陣，以利用前瞻性資料調整歷史信貸虧損經驗。舉例而言，倘預測經濟狀況預期於來年轉差，導致製造界別違約宗數上升，則會調整歷史違約率。於各報告日期，本集團會更新其觀察所得之歷史違約率，並分析前瞻性估計之變動。

對觀察所得之歷史違約率、預測經濟狀況及預期信貸虧損三者之相互關係之評估屬重大估計。預期信貸虧損之金額易受狀況變動及預測經濟狀況影響。本集團之歷史信貸虧損經驗及對經濟狀況之預測亦未必能反映客戶日後之實際違約情況。有關本集團應收貿易賬款及應收融資租賃賬款的預期信貸虧損的資料分別披露於財務報表附註21及23。

Estimation uncertainty

The key assumptions concerning the future and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are described as below.

(a) Estimation regarding provision for ECLs on trade receivables and finance lease receivables

The Group uses a provision matrix to calculate ECLs for trade receivables and finance lease receivables. The provision rates are based on days past due for groupings of various customer segments that have similar loss patterns. The Group takes into consideration information that is available at the reporting date about past events, current conditions and forecasts of future economic conditions.

The provision matrix is initially based on the Group's historical observed default rates. The Group will calibrate the matrix to adjust the historical credit loss experience with forward-looking information. For instance, if forecast economic conditions are expected to deteriorate over the next year which can lead to an increased number of defaults in the manufacturing sector, the historical default rates are adjusted. At each reporting date, the historical observed default rates are updated and changes in the forward-looking estimates are analyzed.

The assessment of the correlation among historical observed default rates, forecast economic conditions and ECLs is a significant estimate. The amount of ECLs is sensitive to changes in circumstances and forecast economic conditions. The Group's historical credit loss experience and forecast of economic conditions may also not be representative of a customer's actual default in the future. The information about the ECLs on the Group's trade receivables and finance lease receivables is disclosed in notes 21 and 23 to the financial statements, respectively.

(b) 存貨撥備之估計

本集團之管理層定期檢閱陳舊存貨之貨齡分析，此涉及將陳舊存貨項目之賬面值與可變現淨值作比較。另外，本集團之管理層考慮因素包括過往銷售記錄、期末後存貨使用或銷售情況及售價、市場需求、技術變更以及本集團未來存貨的使用或銷售計劃。其目的在於確定有否需要對任何陳舊及滯銷之項目於財務報表計提撥備。此外，亦定期進行人手點算所有存貨，以決定是否需要對任何已辨別之陳舊存貨及次貨計提撥備。於二零二六年三月三十一日的存貨賬面淨值為港幣786,951,000元(二零二五年：港幣788,554,000元)，詳情載列於財務報表附註20。

(c) 商譽減值

本集團至少每年釐定商譽是否減值，對已獲分配商譽之現金產出單位之使用價值作出估計。估計使用價值要求本集團對來自現金產出單位之預期未來現金流量作出估計，亦要選擇合適折現率及增長率計算該等現金流量之現值。於二零二六年三月三十一日，商譽之賬面淨值為港幣51,905,000元(二零二五年：港幣51,905,000元)。減值評估之詳情載列於附註17。

(b) Estimation regarding inventory provision

Management of the Group reviews the inventory ageing analysis on a periodic basis for those aged inventories. This involves comparison of the carrying value of the aged inventory items with the respective net realizable value. In addition, management of the Group considers various factors, including historical sales patterns, post year-end usage or sales and selling prices of inventories, market demand, technological changes and the Group's future plan of usage or sale to ascertain whether provision is required to be made in the financial statements for any obsolete and slow-moving items. Physical counts on all inventories are carried out on a periodic basis in order to determine whether any provision is required to be made in respect of any obsolete and defective inventories identified. The net carrying amount of inventories as at 31 March 2026 was HK\$786,951,000 (2025: HK\$788,554,000), details of which are set out in note 20 to the financial statements.

(c) Impairment of goodwill

The Group determines whether goodwill is impaired at least on an annual basis. This requires an estimation of the value in use of the cash-generating units to which the goodwill is allocated. Estimating the value in use requires the Group to make an estimate of the expected future cash flows from the cash-generating unit and also to choose a suitable discount rate and growth rate in order to calculate the present value of those cash flows. The net carrying amount of goodwill as at 31 March 2026 was HK\$51,905,000 (2025: HK\$51,905,000). More details of the impairment assessment are given in note 17.

5. 經營分部資料

本集團主要從事製造及銷售注塑機及有關產品。就管理而言，本集團根據其客戶所在地分為不同業務單位，有下列三個可報告經營分部：

- (i) 中國內地及香港；
- (ii) 台灣；及
- (iii) 其他海外國家。

管理層會分開監察本集團之經營分部之業績，以就資源分配及表現評估方面作出決定。分部表現乃根據經調整之除稅前溢利而計量之可報告分部溢利來作評估。經調整除稅前溢利與本集團之除稅前溢利計量一致，惟利息收入、未攤分收入及收益、非租賃有關的融資成本、應佔聯營公司溢利減虧損及企業及未攤分支出不計入有關計量中。

分部資產扣除於聯營公司之投資、遞延稅項資產及現金及銀行結存(抵押銀行存款除外)。分部負債扣除應付稅項及遞延稅項負債。

可報告經營分部之間並沒有重大銷售。

5. OPERATING SEGMENT INFORMATION

The Group is principally involved in the manufacture and sale of plastic injection moulding machines and related products. For management purposes, the Group is organized into business units based on the locations of customers and has three reportable operating segments as follows:

- (i) Chinese Mainland and Hong Kong;
- (ii) Taiwan; and
- (iii) Other overseas countries.

Management monitors the results of the Group's operating segments separately for the purpose of making decisions about resource allocation and performance assessment. Segment performance is evaluated based on reportable segment profit, which is a measure of adjusted profit before tax. The adjusted profit before tax is measured consistently with the Group's profit before tax except that interest income, unallocated income and gains, non-lease-related finance costs, share of profits less losses of associates and corporate and unallocated expenses are excluded from such measurement.

Segment assets exclude investments in associates, deferred tax assets and cash and bank balances except pledged bank deposits. Segment liabilities exclude tax payable and deferred tax liabilities.

There are no significant sales between the reportable operating segments.

The recoverable amount of the subsidiaries has been determined based on a value in use calculation using cash flow projections based on financial budgets covering a five-year period. The key assumptions for the value in use calculation include the expected growth rate and discount rate. Changes in revenue and costs are based on management experience and expectations of future changes in the market. The financial budgets are prepared reflecting current and prior years' performance and development expectations. The discount rate applied to the cash flow projections is 8% (2025: 8%) which is before tax and reflects specific risks relating to the relevant subsidiaries. The cash flows beyond the 5-year period are extrapolated using a growth rate of 2% (2025: 2%).

The Group's subsidiaries in Taiwan operate the Old Scheme, covering substantially all of its employees who were recruited by the Taiwanese subsidiaries before the implementation of the Labour Act on 1 July 2005. Under the Old Scheme, the employees are entitled to retirement benefits annually based on an accumulated base point, which is determined based on their years of service, with a maximum of 45 points multiplied by the average monthly salary for the final six months of employment on attainment of a retirement age ranging from 55 to 65.

The Old Scheme requires the Group to make monthly contributions to the retirement fund. The fund is administered by the Committee and is deposited under the Committee's name with a government approved financial institution, which acts as the trustee. The assets held by the trustee are separated from those of the Group. The Committee is responsible for the determination of the investment strategy of the scheme.

The Old Scheme is exposed to interest rate risk, the risk of changes in the life expectancy for pensioners, equity market risk and credit risk.

The most recent actuarial valuations of the plan assets and the present value of the defined benefit obligations were carried out on 31 March 2026 by Greatfine Wealth Management Consulting Inc., a qualified actuary recognized by the Actuarial Institute in Taiwan, using the projected unit credit actuarial valuation method.

The principal actuarial assumptions used as at the end of the reporting period are as follows:

The actuarial valuation showed that the market value of plan assets was HK\$11,724,000 (2025: HK\$11,779,000) and that the actuarial value of these assets represented 211% (2025: 175%) of the benefits that had accrued to qualifying employees. The surplus of HK\$6,176,000 is expected to be cleared over the remaining service period of 12 years.

The Group has tax losses arising in Hong Kong, Chinese Mainland and Taiwan of HK\$258,405,000 (2025: HK\$242,736,000), HK\$48,412,000 (2025: HK\$28,354,000) and HK\$60,896,000 (2025: HK\$45,920,000) respectively, that are available for offsetting against future taxable profits of the companies in which the losses arose. Deferred tax assets have not been recognized in respect of these losses as they have arisen in those companies that have been loss-making for some time and it is not considered probable that taxable profits will be available against which the tax losses can be utilized in the foreseeable future, except for tax losses arising in Hong Kong of HK\$7,454,000 as at 31 March 2025 to the extent that it was probable that future taxable profit would be available against which the unused tax losses could be utilised. Included in unrecognized tax losses are losses of HK\$48,412,000 (2025: HK\$28,354,000) and HK\$60,896,000 (2025: HK\$45,920,000) that will expire within five years and ten years, respectively, from the date the losses arose. Other losses can be carried forward indefinitely.

Pursuant to the New Corporate Income Tax Law, a 10% withholding tax is levied on dividends declared to foreign investors from the foreign investment enterprises established in Chinese Mainland. The requirement was effective from 1 January 2008 and applies to earnings after 31 December 2007. A lower withholding tax rate may be applied if there is a tax treaty between the PRC and the jurisdictions of the foreign investors. For the Group, the applicable rate during the year was 5% or 10%.

In addition, pursuant to Taiwan withholding tax regulations, a 21% (2025: 21%) withholding tax is levied on dividends declared to non-resident shareholders. Therefore, the Group is liable for withholding taxes on dividends distributed by those subsidiaries established in Taiwan in respect of earnings generated.

Share options granted under the 2014 Share Option Scheme do not confer rights on the holders to dividends or to vote at Shareholders’ meetings.

In accordance with the Company Law of Taiwan, Asian Plastic Machinery Company, Limited and Chen Hsong Machinery Taiwan Company, Limited are required to transfer a portion of their profit after tax to a capital reserve, which is non-distributable. When the capital reserve has accumulated to 50% of their capital, up to 50% of the capital reserve may be capitalized. The capital reserve may be utilized at anytime to offset any deficit.

In accordance with the Law of the PRC on Sole Foreign Investment Enterprises and Sino-foreign equity joint venture enterprises, the Company's Chinese Mainland subsidiaries are required to transfer a portion of their profit after tax to the statutory reserve fund, which is restricted as to use, until the accumulated total reaches 50% of their registered capital.

利率風險

外幣風險

本集團的外幣風險源於商業交易、已確認的資產及負債，以及於中國內地、台灣、巴西及荷蘭業務的淨投資。

本集團有外幣交易風險，該等風險源於本集團的大部分銷售及採購交易，是以美元、人民幣及新台幣為交易貨幣。

管理層緊密監控以美元、人民幣及新台幣為交易貨幣的交易及投資於中國內地、台灣、巴西及荷蘭之外幣風險；如有需要，會考慮對沖重大外幣風險。

40. FINANCIAL RISK MANAGEMENT OBJECTIVES AND POLICIES

The Group's principal financial instruments comprise cash and bank balances, pledged bank deposits, trade and bills receivables, finance lease receivables, other receivables, trade and bills payables, other payables, accruals and interest-bearing bank borrowings.

The main risks arising from the Group's financial instruments are interest rate risk, foreign currency risk, credit risk and liquidity risk. The risks associated with these financial instruments and the policies on how to mitigate these risks are set out below. Management manages and monitors these exposures to ensure appropriate measures are implemented in a timely and effective manner.

Interest rate risk

The Group's exposure to the risk of changes in market interest rates relates primarily to the Group's bank loans carrying floating interest rates. The Group monitors its interest rate exposure closely and considers to take measures to reduce significant interest rate exposure, if any.

Foreign currency risk

The Group's foreign exchange risk arises from commercial transactions, recognized assets and liabilities and net investments in operations in Chinese Mainland, Taiwan, Brazil and the Netherlands.

The Group has transactional currency risk exposures. Such risk exposures arise from a substantial portion of the Group's sales and purchases transactions denominated in US\$, RMB and New Taiwanese dollars ("NTD").

Management closely monitors foreign exchange exposure in transactions denominated in US\$, RMB and NTD and its investments in Chinese Mainland, Taiwan, Brazil and the Netherlands and will consider hedging significant foreign currency exposure should the need arise.
