Dear Shareholders,

On behalf of the board (the “**Board**”) of directors (each a “**Director**”) of GoFintech Quantum Innovation Limited (“**GoFintech**” or the “**Company**”, together with its subsidiaries collectively referred to as the “**Group**”), I am pleased to present the annual report of the Group for the year ended 31 March 2026 (the “**Reporting Year**”).

Looking back at the past year, the global macroeconomic environment continued its pattern of structural divergence, with major economies exhibiting asynchronous cycles and an accelerated restructuring of old and new business formats. Geopolitical factors continued to influence cross-border capital flows, supply chain configurations, and asset pricing logic. Against this backdrop, Hong Kong’s local capital market demonstrated firm resilience and renewed dynamism, providing ample room for the Group to explore and expand its business. As a fully-licensed, comprehensive and listed fintech platform based in Hong Kong, backed by the Greater Bay Area, and with a global reach, the Group has taken proactive measures amidst a changing landscape, anchoring on a dual-wheel strategy of “grounding in traditional finance and breaking through with frontier technology”. We are fully accelerating the transition between old and new growth drivers, linking the entire chain of securities brokerage, asset management, and cross-border investment and financing through three main technological innovation streams: quantum security, AI intelligence, and compliant Web3 practices.

During the Reporting Year, the Group announced several milestone achievements in capital operations and compliance licensing, including four core actions: a share placing that raised a total of HK\$1.3 billion; a strategic equity investment in a related equity interest of CSOP Asset Management Limited; the official commencement of the application for a digital asset financial license in Labuan, Malaysia; and advancing the application for a Virtual Asset Trading Platform (VATP) license from the Hong Kong Securities and Futures Commission. Concurrently, the Company was included as an eligible stock for Southbound Trading under Stock Connect, solidifying the Group’s foundation for global compliance and capital strength.

尊敬的各位股東：

本人謹代表國富量子創新有限公司（「**國富量子**」或「**本公司**」，連同其附屬公司統稱「**本集團**」）董事（「**董事**」）會（「**董事會**」），欣然提呈本集團截至二零二六年三月三十一日止年度（「**本報告年度**」）之年度報告。

回顧過去一年，全球宏觀經濟環境延續結構性分化格局，主要經濟體呈現週期交錯、新舊業態加速重構之特徵，地緣政治因素持續牽動跨境資金流向、供應鏈佈局與資產定價邏輯，於此背景下，香港本地資本市場展現出堅定韌性與新生張力，給予本集團業務上探外延充足空間。作為立足香港、背靠大灣區、輻射全球的全牌照綜合性金融科技上市平台，本集團於變局中主動作為，錨定「傳統金融打底、前沿科技破局」雙輪戰略，全力加速新舊動能切換，以量子安全、AI智能化、Web3合規實踐三大科創主線串聯證券經紀、資產管理、跨境投融資全鏈條。

於本報告年度內，集團落地多項里程碑式資本運作與合規牌照佈局事項，包括總額13億港元股份配售融資、戰略入股南方東英資產管理有限公司股權、正式啟動馬來西亞納閩數字資產金融牌照申請、推進香港證監會 VATP 虛擬資產交易平台牌照申請四大核心落地動作，同步獲評納入港股通標的，夯實集團全球化合規與資本實力底座。

During the Reporting Year, all members of the Group maintained strategic focus and worked in concert to consolidate the foundation of its fully-licensed financial services, continuously optimising product and service quality, innovating business processes and models, and making steady progress in areas such as quantum technology, digital assets and hard-tech investments, thereby achieving structural optimisation of our business and solid advancements in key areas. Meanwhile, through capital operations and business integration, the Group optimised its structure and expanded its ecosystem, injecting new impetus into high-quality development.

OVERALL PERFORMANCE

The Group is pleased to announce that it achieved encouraging operating and financial results during the Reporting Year, with continuous optimisation of its revenue structure and steady improvement in profitability. The Group's business models of client-centered fully-licensed financial services demonstrated strong financial resilience. During the Reporting Year, total revenue and fair value changes on investments at fair value through profit or loss in the aggregate amount increased by 138.10% year-on-year to HK\$2,175,113,000; excluding factors such as one-off non-recurring impairment losses, the Group recorded an adjusted EBITDA of up to HK\$598,151,000, an increase of over 11 times from HK\$49,588,000 in the previous reporting year, demonstrating the strong cash-generating capabilities of the Group's core business. Benefiting from the receipt of HK\$1.3 billion from a major placing during the Reporting Year, the Group's capital was effectively replenished, significantly optimising its cash flow and capital structure. This provides stable financial support for market expansion, license applications, and equity investments. On the other hand, the Group has consistently focused on cost reduction and efficiency enhancement, improving operational efficiency and profitability.

於本報告年度內，本集團全體成員保持戰略定力，齊心協力鞏固全牌照金融服務根基，持續優化產品與服務質量，創新業務流程與模式，並在量子科技、數字資產及硬科技投資等領域穩步推進，實現了業務結構的優化調整與關鍵領域的紮實進展。同時，集團通過資本運作與業務整合，優化架構、拓展生態，為高質量發展注入新動能。

整體業績表現

本集團欣然宣佈於本報告年度內取得令人鼓舞的經營及財務業績，收入結構持續優化，盈利能力穩步提升。本集團以客戶為中心的全牌照金融服務業務模式展現出強大的財務韌性。於本報告年度內，總收入及按公平值列入損益賬之投資之公平值變動總額增長138.10%至2,175,113,000港元；倘不計及一次性非經常性減值等因素，集團錄得經調整EBITDA高達598,151,000港元，較上一報告年度的49,588,000港元增長超過11倍，展現出集團核心業務強勁的造血能力。受益於本報告年度13億港元大額配售資金到位，集團資本金得到有效補充，大幅優化現金流與資本結構，為市場開拓、牌照申領、股權投資提供穩定資金支撐。另一方面，本集團一直專注於降本增效、提高運營效率及盈利能力。

The Group has been committed to optimising its balance sheet structure, enhancing capital adequacy and improving asset quality. As at the end of the Reporting Year, the Group's total assets reached HK\$9,128,445,000, representing an increase of 97.92% as compared to the end of the previous reporting year. As at the end of the Reporting Year, the Group's total liabilities amounted to HK\$2,184,396,000, while the debt ratio, defined as total liabilities over total assets, increased from 14.88% as at the end of the previous reporting year to 23.93% as at the end of the Reporting Year. Total equity amounted to HK\$6,944,049,000 as at the end of the Reporting Year, representing an increase of 76.89% from the end of the previous reporting year. As at 31 March 2026, the Group's cash and cash equivalents totaled HK\$435,560,000, maintaining at a healthy and reasonable level.

本集團一直致力於優化資產負債表結構，提升資本充足性和資產質量。於本報告年度末，本集團的總資產達到9,128,445,000港元，相比於上個報告年度末增長了97.92%。於本報告年度末，本集團的總負債為2,184,396,000港元，而債務比率（定義為總負債除以總資產）由上個報告年度末的14.88%上升至本報告年度末的23.93%。於本報告年度末的權益總額為6,944,049,000港元，較上個報告年度末增長了76.89%。截至二零二六年三月三十一日，本集團的現金及現金等值物合計為435,560,000港元，維持在健康合理的水平。

STRATEGY AND OPERATION OF THE GROUP

集團戰略與經營

The Group is keenly aware that the current paradigms of economic growth are rapidly evolving, and technological advancements in artificial intelligence, quantum computing, blockchain, Web 3.0 and other fields are accelerating the restructuring of several industries. Amidst a complex and volatile external environment, the Group maintains strategic focus and confidence, cultivating key niche sectors whilst capitalising on structural opportunities arising from market adjustments, thereby fortifying foundations for the Group's long-term sustainable development.

本集團深切感受到，當前經濟增長的模式正在發生日新月異的變化，人工智能、量子計算、區塊鏈、Web 3.0等領域的技術變革正在加快重構許多行業。面對複雜多變的外部環境，本集團始終保持定力，堅定信心，精耕重要細分領域，牢牢把握市場調整中的結構性機遇，為集團業務的長期可持續發展夯實基礎。

In the area of securities brokerage and margin financing, as the overall trading sentiment in the Hong Kong financial market significantly improved, the Group leveraged its licensing advantages, derived from strong local market presence, and its efficient one-stop integrated financial services platform to accurately capture market rebound opportunities. We actively optimised our client structure and expanded our financing channels. During the Reporting Year, the securities brokerage and margin financing business recorded revenue (including inter-segment revenue) of approximately HK\$119,630,000, a significant increase of approximately 472.83% from approximately HK\$20,884,000 in the previous reporting year, further consolidating the position of the traditional financial segment as the cornerstone of the Group's profit.

在證券經紀及孖展融資領域，隨著香港金融市場整體交投氣氛顯著改善，本集團憑藉深耕本地市場的牌照優勢與高效的一站式綜合金融服務平台，精準捕捉市場反彈機遇。我們積極優化客戶結構、拓寬融資渠道，本報告年度內，證券經紀及孖展融資業務錄得收入（包括分部間收入）約119,630,000港元，較上一報告年度的約20,884,000港元大幅增長約472.83%，進一步鞏固了傳統金融板塊作為集團利潤基石的地位。

In the field of asset management, the Group leveraged its in-depth insight into the opportunities in the capital market, enhanced its business development capabilities in the volatile market by continuously enhancing its capabilities in asset management, sales and services, product offering, compliance and risk control, so as to optimise asset allocation and improve asset returns. The Group's asset management department added a LFP fund and completed the Group's first asset allocation business under the Hong Kong Investment Migration Programme via Discretionary Investment Management Account, as well as a specialised transaction involving the transfer of A shares via a QFI fund through a block trade agreement, strengthening its investment presence in traditional equities and private equity projects, and forming a diversified and synergistic business ecosystem. During the Reporting Year, revenue from the asset management segment significantly increased from HK\$3,900,000 in the previous reporting year to HK\$7,431,000, a significant year-on-year increase of approximately 90.54%; at the same time, the segment loss was also effectively controlled and narrowed.

ANCHORING IN FRONTIER TECHNOLOGY TO FORGE NEW AVENUES FOR DEVELOPMENT

The Group is fully aware that technological innovation serves as the core engine driving its long-term development. As a leading global international financial centre and fintech hub, Hong Kong continues to optimise its digital infrastructure and regulatory environment, and is becoming the preferred location for the integrated development of global fintech and quantum technology. Most importantly, the Hong Kong government is vigorously promoting technological innovation. The Stablecoin Ordinance officially came into effect in August 2025, further refining the regulatory framework. The "Fintech 2030" strategy was launched in November 2025, followed by the release of the Fintech Promotion Blueprint in February 2026, which identifies artificial intelligence, distributed ledger technology and high-performance computing as key areas of focus. Concurrently, flagship projects such as the "Quantum-Ready Index" were initiated to systematically enhance the industry's ability to respond to post-quantum cryptography, opening up broad prospects for market regulation, innovation, and high-quality development.

在資產管理領域，本集團深入洞察資本市場的機遇，於波動市場中提升展業能力，持續打造優質的資產管理能力、銷售服務能力、產品佈局能力和合規風控能力，優化資產配置，提升資產收益。本集團資產管理部門新增LFP基金、完成集團首單香港投資移民專戶基金資產配置業務、完成QFI基金接A股協議轉讓的特色業務，強化傳統股票與股權項目投資佈局，形成多元協同業務生態。本報告年度資產管理分部收入由上一報告年度的3,900,000港元顯著提升至7,431,000港元，同比大幅增長約90.54%；與此同時，分部虧損亦得到有效控制並實現收窄。

錨定前沿科技，開拓發展新空間

本集團深刻認識到，科技創新是驅動本集團實現長遠發展的核心動力。香港作為全球領先的國際金融中心與金融科技樞紐，持續優化數字基礎設施與監管環境，正成為全球金融科技與量子科技融合發展的首選之地。尤為重要的是，香港政府大力推動科技創新，2025年8月《穩定幣條例》正式生效，監管框架日趨完善；2025年11月推出「Fintech 2030」戰略，並於2026年2月發佈《金融科技推廣藍圖》，明確將人工智能、分佈式賬本技術及高性能計算作為重點推進方向，同時啟動「量子準備指數」等旗艦項目，系統性提升行業對後量子密碼學的應對能力，為市場規範、創新與高質量發展開闢了廣闊空間。

During the Reporting Year, the Group achieved a breakthrough in the implementation of its compliance licences: it submitted an application to the Securities and Futures Commission of Hong Kong (the “SFC”) for the change of the controlling shareholder of MaiCapital Limited (“**MaiCapital**”), a wholly-owned subsidiary of our Group’s associate, BA Fintech Lab and formally increased its capital in MaiCapital to 89.34% in April 2026 through capital injection in BA Fintech Lab. MaiCapital holds a Type 9 (asset management) license which enables it to offer VA-related asset management services in compliance with the SFC’s “Terms and Conditions for Licensed Corporations or Registered Institutions which Manage Portfolios that Invest in Virtual Assets”, and will apply for Type 1 (dealing in securities) and Type 7 (providing automated trading services) regulated activity licenses and AMLO licenses under the SFO; the Group simultaneously initiated the digital asset financial license business under the Labuan Financial Services Authority (FSA) in Malaysia, including the application for the provision of digital banking and digital asset trading services, forming a dual-region digital assets compliance footprint in Hong Kong and Southeast Asia, and addressing the compliance gaps in cross-border virtual asset trading, custody, and asset management. On the Web3 front, guided by the strategic principle of “digitalisation of assets and compliance”, the Group achieved a breakthrough from zero to one in the RWA field. In addition, the Group values the development of the industry ecosystem and jointly launched the Hong Kong Virtual Assets Listed Companies Association in August 2025. The association, operating under the principles of “Joint Exploration, Joint Counsel, and Joint Construction”, brings together regulatory intelligence and industry forces to establish a regular communication mechanism with the HKSAR Government and deeply participate in the implementation of the “Policy Declaration on the Development of Digital Assets in Hong Kong 2.0 (香港數字資產發展政策宣言2.0)”, such as promoting the regular issuance of tokenised government bonds and the licensing regime for stablecoins. Admittedly, as the regulatory rules for RWA and virtual assets across various global jurisdictions are still evolving, there is uncertainty regarding the pace of implementation of cross-border tokenisation businesses. Nevertheless, the Group has taken the lead in establishing a pioneering business model in the emerging RWA and “quantum + finance” sectors, unlocking new growth drivers for the Group’s business development.

於本報告年度內，合規牌照落地實現跨越式突破：本集團向香港證券及期貨事務監察委員會（「香港證監會」）提交更改本集團聯營公司 BA Fintech Lab 的全資附屬公司 MaiCapital Limited（「**MaiCapital**」）控股股東的申請，並已於2026年4月透過向 BA Fintech Lab 注資，將其於 MaiCapital 的持股正式增至 89.34%。MaiCapital 持有第9類（提供資產管理）授權牌照，讓其能夠根據證監會《適用於管理投資於虛擬資產的投資組合的持牌法團或註冊機構的條款及條件》提供虛擬資產相關資產管理服務。MaiCapital 將申請證券及期貨條例項下的第1類（證券交易）及第7類（提供自動交易服務）受規管活動牌照以及 AMLO 牌照；同步啟動馬來西亞納閩 FSA 監管下數字資產金融牌照業務，包括提供數字銀行與數字資產交易服務的申報工作，未來將形成香港+東南亞雙區域數字資產合規佈局，補齊跨境虛擬資產交易、托管、資管合規短板；Web3業務層面，圍繞「資產數字化、合規化」戰略方針，在 RWA 領域實現從0到1的突破。此外，集團重視行業生態的建設，於2025年8月聯合發起了香港數字資產上市公司聯合會，聯合會以「共探、共諫、共建」為行動準則，彙聚監管智能與產業力量，與香港特區政府建立常態化溝通機制，深度參與《香港數字資產發展政策宣言2.0》的落地實施，例如推動代幣化政府債券常態化發行、穩定幣發牌制度等。誠然全球各司法轄區 RWA、虛擬資產監管細則仍在迭代，跨境代幣化業務落地節奏存在不確定性，但集團率先在新興 RWA 與量子+金融賽道卡位領先業務模式，挖掘本集團業務發展的全新增長動能。

DEEPENING INVESTMENT LAYOUT TO EMPOWER COMPREHENSIVE BUSINESS UPGRADES

深化投資佈局，賦能業務全面升級

Over the past year, the Company has anchored its actions in the strategic development framework, leveraging capital operations as the engine and business consolidation as the key driver to achieve dual breakthroughs in asset structure optimisation and core competitiveness enhancement. This has injected robust momentum into the Group's high-quality development.

過去一年，本公司立足戰略發展全局，以資本運作為引擎，以業務整合為抓手，實現資產結構優化與核心競爭力提升的雙重突破，為本集團的高質量發展注入強勁動能。

On the capital operations front, while continuing its efficient financing strategy, the Group has actively positioned itself in the frontier hard-tech sector. Leveraging the synergistic advantages of "investment, investment banking and management", the Group has continuously enhanced its investment capabilities and knowledge in areas such as Web 3.0, quantum technology, blockchain and RWA, and has made in-depth deployments across these sectors.

在資本運作層面，本集團在延續高效融資策略的同時，積極佈局前沿硬科技領域。本集團發揮「投資+投行+管理」的聯動優勢，不斷提升在Web 3.0、量子科技、區塊鏈、RWA等領域的投資能力和認知，圍繞這些領域深度佈局。

The Group actively participated in strategic investments in hard technology. During the Reporting Year, it subscribed for 2.475 million shares of Shanghai FourSemi Semiconductor Co., Ltd. at HK\$40 per share, successfully participating in the international placing of Shanghai FourSemi Semiconductor Co., Ltd., a company listed on the Main Board of the Stock Exchange (stock code: 03625), through a strategic placing. This equity investment generated an unrealised gain measured at fair value at the end of the Reporting Year, and the related value change has been presented in the consolidated financial statements of the Group. This effectively strengthens the industrial synergy between quantum technology and frontier technologies such as AI chips and semiconductors. The Group's asset allocation structure has been further diversified, and its overall growth elasticity has been further enhanced.

本集團積極參與硬科技戰略投資，於本報告年度內以每股40港元認購上海傅裡葉半導體股份有限公司247.5萬股，成功以戰略配售方式參與上海傅裡葉半導體股份有限公司（一家於聯交所主板上市的公司（股份代號：03625））國際配售，該筆股權投資於本報告年度末按公允價值計量產生賬面浮盈，相關價值變動已於本集團合併財務報表列示，有效強化量子科技與AI芯片、半導體等前沿技術的產業協同。集團資產配置結構進一步多元化，整體成長彈性進一步提升。

OUTLOOK

Looking forward, the Group will firmly implement the “one body, two wings” strategy, with our full-licence financial business as a solid foundation and “quantum technology + digital assets” as dual-core engines, to actively explore a second growth curve in cutting-edge technologies such as quantum technology, artificial intelligence, and Web3 finance.

Currently, the national “15th Five-Year Plan” has listed quantum technology as the top future industry for forward-looking deployment, and Hong Kong is also leveraging its unique advantage of “relying on the motherland and connecting with the world” to accelerate the establishment of a hub for cutting-edge technology and digital finance in the Asia-Pacific region. We are in a key historical window of opportunity for quantum technology and digital assets to transition from technology R&D to commercial implementation, and from a compliance framework to large-scale application. In the future, GoFintech will drive the Company to gradually move from “infrastructure building” to “commercial realisation”, leveraging ecosystem synergies to achieve further revenue growth and diversification of income sources.

In the new financial year, we will continue to deepen our “platform + ecosystem” strategy to build a more solid industry moat. On the one hand, the Group will rely on the “Hong Kong Virtual Assets Listed Companies Association”, which was initiated and established during the Reporting Year, to continue to play its bridging role as an industry “super-hub” and accelerate the development of the market for Web 3.0 new investment banking and institutional-grade digital financial infrastructure; on the other hand, as a future-oriented strategic extension, in April 2026 we jointly initiated and established the “Quantum Intelligence Industry Alliance (量子智能產業聯盟)” together with top industry-academia-research forces such as the City University of Hong Kong, Origin Quantum, and QuantumCTek. The Group will use this alliance as a core vehicle to focus on the cutting-edge integration of “quantum + intelligence”, actively explore the industrial implementation of quantum encryption and financial intelligence algorithms, and accelerate the transformation of cutting-edge technology into the driving force for the Group's next stage of sustainable development.

展望

展望未來，本集團將堅定實踐「一體兩翼」的戰略，全牌照金融業務為穩固底座，以「量子科技+數字資產」為雙核引擎，主動探索量子科技、人工智能及 Web3 金融等前沿科技的第二增長曲線。

當前，國家「十五五」規劃已將量子科技列為前瞻佈局的未來產業之首，香港亦正憑藉「背靠祖國、聯通世界」的獨特優勢，加速構建亞太區域的前沿科技與數字金融樞紐。我們正身處量子科技與數字資產從技術研發向商業化落地、從合規框架向規模化應用的關鍵歷史窗口期。未來，國富量子將推動公司逐步從「基建築基」走向「商業變現」，發揮生態協同的作用，實現收入的進一步增長和多樣化來源。

在新一財年，我們將繼續深化「平台+生態」的佈局，構築更為堅實的行業護城河。一方面，集團將依託報告年度內發起成立的「香港數字資產上市公司聯合會」，繼續發揮其作為行業「超級樞紐」的橋樑作用，加速開拓 Web 3.0 新投行與機構級數字金融基礎設施的市場；另一方面，作為面向未來的戰略延展，我們已於2026年4月聯合香港城市大學、本源量子、國盾量子等頂尖產學研力量，共同發起成立了「量子智能產業聯盟」。本集團將以該聯盟為核心載體，聚焦「量子+智能」的前沿融合，主動探索量子加密與金融智能算法的產業化落地，加速將前沿科技轉化為集團下一階段可持續發展的動力。

Amidst the race of a thousand sails on the business sea, with the wind in our favour, a single sail rides high. In the new financial year, GoFintech will, with a clearer commercialisation path and a more pragmatic execution pace, deeply unleash the dual ecosystem potential of the “Hong Kong Virtual Assets Listed Companies Association” and the “Quantum Intelligence Industry Alliance (量子智能產業聯盟)”. We will leverage our full-licence financial qualifications and hard technology investment drive, continuously optimise the closed-loop ecosystem of our business segments, and unswervingly follow the development path of “investment driving investment banking, and innovation feeding back into traditional business” to create more certain long-term value for all our shareholders, clients and partners!

RESULTS

For the year ended 31 March 2026 (the “**Reporting Year**”), the Group recorded revenue and fair value changes on investments at fair value through profit or loss in the aggregate amount of approximately HK\$2,175,113,000, representing an increase of approximately 138.10% from approximately HK\$913,545,000 for the year ended 31 March 2025 (the “**Previous Reporting Year**”). The growth was mainly attributable to higher revenue from the money lending business and the trading and supply chain operations business, as well as increased fair value gains on investments at fair value through profit or loss from the equity investment business of the Group.

Though the Group recorded a loss of approximately HK\$2,130,640,000 for the Reporting Year, as compared to the loss of approximately HK\$2,525,000 for the year ended 31 March 2025, the increase in consolidated loss attributable to owners of the Company for the Reporting Year was mainly attributable to the following one-off events:

- (i) the Company entered into a sale and purchase agreement on 31 December 2024 with HK.AI Capital Limited (“**HK.AI**”), formerly known as Wealthink AI-Innovation Capital Limited, a company whose shares are listed on the Main Board of the Stock Exchange (stock code: 1140), for the purchase of 22.50% of the entire issued share capital of CSOP (the “**CSOP Shares**”) at the consideration of HK\$1,110,000,000, which shall be settled by the allotment and issuance of 1,405,063,292 shares of the Company (the “**Consideration Shares**”) at the issue price of HK\$0.79 per share of the Company (the “**Share**”), details of which are set out in the circular of the Company dated 25 June 2025. As at the completion date on 2 January 2026 (the “**Completion Date**”), based on the then closing price of the Share of HK\$2.65 per share, the total cost of the Consideration Shares issued by the Company was approximately HK\$3,723,417,000 while the fair value of the CSOP Shares as at 31 March 2026 measured by an independent professional valuer was approximately HK\$1,298,280,000. The Group recorded an impairment loss arising from the CSOP Acquisition of approximately HK\$2,459,256,000 during the Reporting Year owing to the difference between the total cost of the Consideration Shares issued by the Company after shared results of CSOP and fair value of the Company’s investment in CSOP; and

業績

- (i) 本公司於二零二四年十二月三十一日與華科智能投資有限公司（「**華科智能**」）（英文前稱 Wealthink AI-Innovation Capital Limited，一間其股份於聯交所主板上市的公司，股份代號：1140）訂立買賣協議，以購買南方東英全部已發行股本之22.50%（「**南方東英股份**」），代價為1,110,000,000港元，該代價將透過按發行價每股本公司股份（「**股份**」）0.79港元配發及發行1,405,063,292股本公司股份（「**代價股份**」）結算，有關詳情載於本公司日期為二零二五年六月二十五日之通函。於完成日期（即二零二六年一月二日）（「**完成日期**」），根據股份當時之收市價每股2.65港元，本公司已發行代價股份之總成本約為3,723,417,000港元，而由獨立專業估值師計量之於二零二六年三月三十一日之南方東英股份公平值約為1,298,280,000港元。由於計入南方東英的業績分佔後本公司已發行代價股份之總成本與本公司於南方東英之投資公平值之間存在差額，本集團於本報告年度就南方東英收購事項錄得減值虧損約2,459,256,000港元；及

- (ii) the recognition of the one-off loss of approximately HK\$218,905,000 on dilution of the Company's shareholding in HK.AI from approximately 29.13% to 26.29% following the completion of a new share issuance of HK.AI on 20 November 2025.

Excluding the impact of such losses, the profit attributable to owners of the Company amounted to approximately HK\$547,521,000, achieving a turnaround as compared to that of HK\$2,525,000 loss in the Previous Reporting Year, which was mainly due to (i) the increase in revenue recognized and operating profit generated from the Group's principal businesses, including, among others, the securities brokerage and margin financing businesses and equity investment business as a result of the improved market sentiment of the Hong Kong stock market; (ii) the recognition of net realised and unrealised gains on listed and unlisted equity investments at fair value through profit or loss, particularly in the quantum industry during the Reporting Year; and (iii) the recognition of share of results of associates following completion of the CSOP Acquisition during the Reporting Year.

The basic and diluted loss per share for the Reporting Year were approximately HK28.18 cents as compared to the basic and diluted loss per share of approximately HK0.04 cent for the year ended 31 March 2025.

For a better understanding of our Group's operations, the earning before interest, taxes, depreciation and amortization ("EBITDA") and adjusted EBITDA are detailed as follows:

Adjusted EBITDA was a profit of HK\$598,151,000 for the Reporting Year compared with a profit of HK\$49,588,000 for the year ended 31 March 2025.

BUSINESS REVIEW

Securities brokerage and margin financing

The business of securities brokerage and margin financing is one of the main revenue streams of the Group. During the Reporting Year, the business of securities brokerage and margin financing recorded revenue (including inter-segment revenue) of approximately HK\$119,630,000, representing an increase of approximately 472.83% as compared to the revenue (including inter-segment revenue) of approximately HK\$20,884,000 for the Previous Reporting Year.

The segment profit for the Reporting Year amounted to approximately HK\$3,264,000 (2025: approximately HK\$11,938,000). The decrease in segment profit was mainly attributable to the increase in operating costs during the Reporting Year.

The Group's strategy is to focus on and strengthen existing securities operation and work in close collaboration with our corporate finance business as well as asset management business, in order to provide a one-stop integrated financial services to better serve our institutional and high net worth individual clients.

Corporate finance

The corporate finance market was under a keen competition during the Reporting Year. Segment revenue from corporate finance business was approximately HK\$8,000 (2025: approximately HK\$2,338,000), while the segment loss for the Reporting Year amounted to approximately HK\$1,101,000 (2025: segment profit of approximately HK\$1,517,000). The decrease in revenue during the Reporting Year was mainly due to (i) intense price competition in the industry amid volatile market conditions, with clients adopting a more cautious stance; and (ii) the Group's reallocation of resources to other higher-margin business segments, resulting in a significant decline in new engagements.

業務回顧

證券經紀及孖展融資

證券經紀及孖展融資業務為本集團主要收入來源之一。於本報告年度，證券經紀及孖展融資業務錄得收入（包括分部間收入）約119,630,000港元，較過往報告年度約20,884,000港元收入（包括分部間收入）增加約472.83%。

本報告年度錄得分部溢利約3,264,000港元（二零二五年：約11,938,000港元）。分部溢利減少主要由於本報告年度之營運成本增加。

本集團之策略為專注及鞏固現有證券營運，並與本集團企業融資業務及資產管理業務緊密合作，藉以向機構及高淨值個人客戶提供更優質的一站式綜合金融服務。

企業融資

於本報告年度，企業融資市場競爭激烈。來自企業融資業務之分部收入約為8,000港元（二零二五年：約2,338,000港元），而本報告年度錄得分部虧損約1,101,000港元（二零二五年：分部溢利約1,517,000港元）。於本報告年度收入減少主要由於(i)在市場大幅波動的情況下，行業內價格競爭激烈，且客戶採取了更為謹慎的態度；及(ii)本集團將資源重新分配至利潤率更高的其他業務分部，導致新訂約業務量大幅下降。

Money lending

During the Reporting Year, the money lending market was under intensive competition locally. The Group recorded an interest revenue from money lending business of approximately HK\$29,587,000 (2025: approximately HK\$15,969,000), representing an increase of approximately 85.28% as compared to the year ended 31 March 2025. The segment profit for the Reporting Year amounted to approximately HK\$2,518,000 (2025: approximately HK\$1,724,000). The increase in segment profit during the Reporting Year was mainly attributable to the increase in interest revenue recorded.

Overview

The Group's money lending business is conducted through Fortune Finance Limited ("Fortune Finance"), a licensed money lender under the Money Lenders Ordinance (Chapter 163 of the Laws of Hong Kong) and a wholly-owned subsidiary of the Company.

With funding supported by the Group, Fortune Finance provides money lending services including property mortgages, share mortgages and personal loans. The loan periods range from around 1 to 60 months. The source of clients of Fortune Finance are mainly from referrals and such referrals are sourced from existing clients and the management of the Group. As at 31 March 2026, the client base of Fortune Finance comprises (i) companies engaged in retail and information technology; (ii) individuals engaged in finance, trading and retail sectors; and (iii) companies engaged in investment business (2025: (i) companies engaged in retail and information technology; and (ii) individuals engaged in finance, trading and retail sectors).

放債

於本報告年度，本地放債市場之競爭日趨激烈。本集團錄得放債業務之利息收入約29,587,000港元（二零二五年：約15,969,000港元），較截至二零二五年三月三十一日止年度增加約85.28%。本報告年度分部溢利約為2,518,000港元（二零二五年：約1,724,000港元）。於本報告年度分部溢利增加主要歸因於錄得的利息收入增加。

概覽

本集團透過富強財務有限公司（「富強財務」）開展放債業務，富強財務為香港法例第163章《放債人條例》項下之持牌放債人及本公司之全資附屬公司。

富強財務藉助本集團援助之資金提供放債服務，包括物業按揭、股份抵押及個人貸款。貸款期限介乎約1至60個月。富強財務之客戶主要通過現有客戶及本集團管理層轉介而來。截至二零二六年三月三十一日，富強財務之客戶群包括(i)從事零售及資訊科技之公司；(ii)從事金融、貿易及零售業之個人；及(iii)從事投資業務之公司（二零二五年：(i)從事零售及資訊科技之公司；及(ii)從事金融、貿易及零售業之個人）。

Internal control procedures and credit risk assessment policy

Fortune Finance always takes measures to assess and control risks according to Fortune Finance's credit and operation policy. The credit policy applies to all types of lending businesses, including secured-based lending and unsecured lending. Assessment will be conducted from several aspects including market value of the pledged assets, due diligence of collateral ownership, the loan-to-value ratio, legal background checking on the borrowers, creditability and repayment ability of the borrower (including income sources and existing outstanding debts), and the feasibility of legal execution on the charged assets and/or legal action against the borrower in the event of default.

All loan applications submitted to Fortune Finance are required to go through the assessment and approval procedures by three levels of personnel. A loan application will firstly be assessed and approved by a director of Fortune Finance before being passed to the representative(s) of the risk and compliance departments from the Group for comments. Finally, the loan application is subject to final approval from the executive committee (the "**Executive Committee**") of the Group.

Determination of loan terms

The loan terms are determined based on factors such as:

- purpose of fund usage claimed by the borrower;
- capital liquidity of the borrower;
- current loan terms offered by borrower's existing financing company;
- credibility and repayment history of borrower;
- loan size of the application versus the Group's internal capital resources allocation and planning; and
- other risk factors, if any.

內部監控程序及信貸風險評估政策

富強財務一直依據其信貸及營運政策採取各種措施評估及控制風險。信貸政策適用於所有類型之放債業務，包括有抵押貸款及無抵押貸款。評估將從多個方面進行，包括所抵押資產之市值、對抵押品所有權之盡職審查、貸款價值比率、對借款人之法律背景調查、借款人之信用情況及還款能力（包括收入來源及現有未償還債務），以及在出現違約的情況下依法執行已抵押資產及／或對借款人採取法律行動之可行性。

向富強財務提交之所有貸款申請均須通過三級人員之評估及審批程序。貸款申請首先由富強財務的一名董事評估及批准，然後轉交本集團風險及合規部門的代表徵詢意見。最後，貸款申請須由本集團執行委員會（「**執行委員會**」）最終批准。

釐定貸款條款

貸款條款乃基於以下因素釐定：

- 借款人所述之資金用途；
- 借款人之流動資金情況；
- 借款人現有融資公司提供之現有貸款條款；
- 借款人之信用情況及還款記錄；
- 申請貸款之規模與本集團內部資本資源分配及規劃情況之對比；及
- 其他風險因素（如有）。

Before granting unsecured loans to borrowers, the management of Fortune Finance will primarily consider the asset level of the borrower prior to commencement of internal assessment and approval procedures. Where the borrower is able to demonstrate that its assets are of a sufficient level, the management of Fortune Finance will consider recommending that an unsecured loan be granted. In order to determine whether the assets of a borrower are of a sufficient level, Fortune Finance will primarily take into account, among others, (i) the value of all the assets of the borrower reported by the borrower to Fortune Finance; and (ii) the intended size of the relevant loan. In general, the reported value of the borrower's assets must be sufficient to cover the intended loan. The borrower's ability to repay the loan is also taken into account after considering factors such as the borrower's income source and cash flow. The management of Fortune Finance will consider the assets of the borrower to be at a sufficient level once such requirements are deemed to be satisfied.

The terms of unsecured loans are determined on the same basis as those of secured loans, the factors of which are set out above. Although the terms of unsecured loans are determined on the same basis as those of secured loans, due to the higher risk associated with granting unsecured loans as compared to secured loans (even after taking into account that the borrower of the unsecured loan must have sufficient level of assets), the interest rates of unsecured loans will accordingly be higher than that of secured loans, assuming all other factors being equal. The management of Fortune Finance considers that it is reasonable to determine the terms of unsecured loans and secured loans on the same basis provided that, assuming all other factors being equal, unsecured loans (with the relevant borrower's assets at a sufficient level) are subject to higher interest rates commensurate with their level of risk.

Depending on the asset level of the borrower, a personal guarantee may also be required before an unsecured loan may be granted.

The renewal of loans is subject to the same internal control and assessment procedures (including the provision of relevant documents and assessment and approval by a director of Fortune Finance, the representatives of risk and compliance departments and Executive Committee (if necessary) of the Group) as for the grant of new loans.

向借款人授出無抵押貸款之前，富強財務之管理層於開始內部評估及審批程序前將主要考慮借款人之資產水平。倘借款人能夠證明其資產達到足夠水平，富強財務之管理層將考慮建議授出無抵押貸款。為釐定借款人之資產水平是否足夠，富強財務將主要考慮（其中包括）(i) 借款人向富強財務申報之借款人所有資產之價值；及(ii) 相關貸款之擬定規模。一般而言，借款人資產之申報價值必須足以涵蓋擬定貸款。在慮及借款人之收入來源及現金流量等因素後，亦將借款人償還貸款的能力考慮在內。於借款人被視作符合有關要求後，富強財務之管理層將認為借款人之資產達到足夠水平。

無抵押貸款之條款的釐定基準與有抵押貸款相同，有關因素載於上文。儘管無抵押貸款之條款的釐定基準與有抵押貸款相同，但由於授出無抵押貸款之相關風險高於有抵押貸款（即使已慮及無抵押貸款之借款人必須達到足夠之資產水平），假設所有其他因素相同，無抵押貸款之利率將相應高於有抵押貸款之利率。富強財務之管理層認為，假設所有其他因素相同，考慮到對無抵押貸款（在相關借款人之資產達到足夠水平之情況下）收取與其風險水平相稱之較高利率，故按相同基準釐定無抵押貸款及有抵押貸款之條款屬合理。

視乎借款人之資產水平，於授出無抵押貸款前亦可能需要個人擔保。

重續貸款須遵守與授出新貸款相同之內部監控及評估程序（包括提供相關文件及由富強財務一名董事、風險及合規部門代表及本集團執行委員會（如需）評估及批准）。

Information on loans

As at 31 March 2026, there were a total of five outstanding loans with an aggregate outstanding principal amount of HK\$293,000,000 (before expected credit losses) and interest rates which ranged from 6% to 11% per annum.

As at 31 March 2025, there were a total of four outstanding loans with an aggregate outstanding principal amount of HK\$83,000,000 (before expected credit losses) and interest rates which ranged from 6% to 13% per annum.

Collection of loan receivables

Fortune Finance regularly submits status update reports to the Group's management on a weekly basis for the review of Fortune Finance's total outstanding loan balance, loan due, and collection status of the repayments.

Fortune Finance also has a collection guideline which applies to delinquent accounts. If there is bank transfer failure or an uncleared cheque, Fortune Finance's representative will contact the borrower as soon as possible. If the repayment is in default for 30 days, Fortune Finance will check and confirm the latest outstanding amount of the borrower and appoint legal advisors to issue an official demand letter to the borrower. A copy of the demand letter will also be sent to the guarantor, if applicable. Should the repayment be in default for 90 days, Fortune Finance will further issue a final warning where Fortune Finance will take legal action against the borrower if such defaulted repayment could not be settled within 14 days. All records will be documented and the most updated status will be reported regularly to director(s) of the Group. Any arrangements deviating from the collection guideline are required to be reviewed and approved by the directors of Fortune Finance.

The Group applies general approach in measuring loss allowance for expected credit losses on loan receivables.

The Group granted loans to borrowers with different period of time. As the term loans are normally repaid monthly in instalment amount, they would be past due during the loan period and thus, past due day information is meaningful in assessing if there is significant increase in credit risk during the loan period.

貸款情況

於二零二六年三月三十一日，合共有五筆未償還貸款，未償還本金總額為293,000,000港元（扣除預期信貸虧損前），年利率介乎6%至11%。

於二零二五年三月三十一日，合共有四筆未償還貸款，未償還本金總額為83,000,000港元（扣除預期信貸虧損前），年利率介乎6%至13%。

收回應收貸款

富強財務每週定期向本集團管理層提交最新情況報告，以檢討富強財務未獲償還之貸款結餘總額、到期貸款及還款之收款情況。

富強財務亦設有適用於拖欠款項之收款指引。倘銀行轉賬失敗或支票未獲兌現，富強財務之代表將盡快聯絡借款人。倘拖欠還款達30日，富強財務將核查並確認借款人之最新未償還金額，並委任法律顧問向借款人發出正式催繳函。催繳函副本亦將寄發予擔保人（如適用）。倘拖欠還款達90日，富強財務將進一步發出最終警告：倘有關拖欠還款未能於14日內結清，富強財務將對借款人採取法律行動。所有記錄均將記錄在案，並定期向本集團董事報告最新情況。任何偏離收款指引之安排須由富強財務之董事審閱及批准。

本集團應用一般方法計量應收貸款之預期信貸虧損之虧損撥備。

本集團向借款人授出不同期限之貸款。由於定期貸款通常按月分期償還，故其可能於貸款期逾期，因此，逾期日資料就評估信貸風險於貸款期內是否顯著增加而言具有意義。

In assessing default risk of loan receivables, management considered the following factors:

- collateral ratio (if any);
- amount of actual shortfall;
- delay in repayment;
- responsive to the Group's request in repayment after maturity of loan;
- an actual or expected downgrade of the external or internal credit rating of the borrower;
- existing or forecast adverse changes in business, financial or economic conditions that are expected to cause a significant change in the borrower's ability to meet its debt obligation;
- significant changes in external market indicators of credit risk for a particular financial asset or similar financial assets with similar characteristics; and
- significant changes in the value of the collateral supporting the obligation or credit enhancement, if applicable.

Management classifies loan receivables based on the following:

- Stage 1: For exposures where there has not been a significant increase in credit risk since initial recognition and that are not credit-impaired upon origination.
- Stage 2: For exposures where there has been a significant increase in credit risk since initial recognition but are not credit-impaired. Below are indicators of significant increase in credit risks: (a) if repayment of loan is delayed by borrower; (b) if collateral ratio (if any) is 60% or higher; and (c) responsive to the Group's request for repayment.

於評估應收貸款之違約風險時，管理層已考慮以下因素：

- 抵押品比率（如有）；
- 實際不足額；
- 延遲還款；
- 於貸款到期後對本集團要求還款之回應；
- 借款人外部或內部信貸評級之實際或預期降級；
- 業務、財務或經濟狀況之現有或預期不利變動，而有關變動預期導致借款人履行債務責任之能力發生重大變化；
- 特定金融資產或具有類似特徵之類似金融資產之信貸風險之外部市場指標發生重大變動；及
- 支持有關責任之抵押品之價值或信貸提升措施（倘適用）發生重大變化。

管理層根據以下方式分類應收貸款：

- 第一階段： 信貸風險自初步確認以來並無出現顯著增加以及於產生後並無出現信貸減值之風險。
- 第二階段： 信貸風險自初步確認以來出現顯著增加惟並無出現信貸減值之風險。下列為信貸風險顯著增加之指標：(a) 借款人延遲償還貸款；(b) 抵押品比率（如有）為60%或以上；以及(c) 對本集團還款要求之回應。

Stage 3: Exposures are assessed as credit-impaired when one or more events that have a detrimental impact on the estimated future cash flows of that asset have occurred. Below are events indicating that the balance is credit-impaired:

- (a) The Group makes liquidation call to borrowers to liquidate their securities collateral (if any) to settle the outstanding balances;
- (b) The borrower is not responsive to the Group's request; and
- (c) The Group loses contact with the borrowers.

In assessing default risk of loan receivables, management would make reference to the default rates studies conducted by certain external credit rating agencies. In addition, management would incorporate forward looking economic information through the use of industry trend and experienced credit judgment to reflect qualitative factors.

Asset management

During the Reporting Year, the Group recorded a segment revenue from asset management of approximately HK\$7,431,000 (2025: approximately HK\$3,900,000), representing an increase of approximately 90.54% as compared to 2025. The segment loss for the Reporting Year was approximately HK\$1,360,000 (2025: approximately HK\$1,568,000). The decrease in loss was mainly due to the increase in segment revenue during the Reporting Year.

Equity investment

During the Reporting Year, the Group recorded segment revenue and fair value gains on investments at fair value through profit and loss in the total amount of approximately HK\$422,653,000 (2025: approximately HK\$51,983,000). The segment profit for the Reporting Year amounted to approximately HK\$216,927,000 (2025: approximately HK\$19,311,000). The increase was primarily attributable to a significant rise in the fair value of listed and unlisted investments at fair value through profit or loss during the Reporting Year.

第三階段：當發生會對該資產之估計未來現金流量造成不利影響之一項或多項事件時，則有關風險會被評定為出現信貸減值。顯示結餘出現信貸減值之事件如下：

- (a) 本集團要求借款人平倉，以將證券抵押品（如有）變現以結付未償還結餘；
- (b) 借款人並無回應本集團之要求；及
- (c) 本集團與借款人失去聯絡。

於評估應收貸款之違約風險時，管理層將參考由若干外部信貸評級機構進行之違約率研究。此外，管理層將透過使用行業趨勢及應用經驗信貸判斷為基礎作為前瞻性經濟資料，從而反映定性因素。

資產管理

於本報告年度，本集團於資產管理方面錄得分部收入約7,431,000港元（二零二五年：約3,900,000港元），較二零二五年增加約90.54%。本報告年度分部虧損約為1,360,000港元（二零二五年：約1,568,000港元）。虧損減少主要由於本報告年度分部收入增加所致。

股權投資

於本報告年度，本集團於股權投資方面錄得分部收入及按公平值列入損益賬之投資公平值收益總額約422,653,000港元（二零二五年：總額約51,983,000港元）。本報告年度分部溢利約為216,927,000港元（二零二五年：約19,311,000港元）。有關增加主要歸因於本報告年度按公平值列入損益賬的上市及非上市投資的公平值大幅增加。

In respect of the equity investments, the primary objective would be the prioritisation of long-term investments in sectors of high growth potential, including (1) investment in listed company equities who are engaged in AI-powered consumer electronics and robotics or selling and import businesses (“**Listed Equity Investments**”); (2) investment on a one-stop solution provider dedicated to the industrialization and popularization of quantum computing (“**Quantum Investments**”); and (3) investment in interests of funds of large-scale financial products such as equity index funds and fixed-income instruments (“**Fund Investments**”). By building a diversified portfolio aiming at high-growth sectors (quantum computing, AI-related industries and companies) and scarce assets (artworks and digital currencies), the Group is driving appreciation in the long run and pioneers the next investment frontier.

The overall investment strategy is to systematically identify, evaluate, and capitalize on high-growth opportunities while diligently hedging risks and maintaining rigorous risk controls. With Executive Committee being the core decision-maker for the Group’s investments, its members collaborate with other members of the management to establish a closed-loop governance framework, spanning “investment decisions — execution tracking — risk mitigation — value enhancement”. The Executive Committee was established by the Board in April 2017 with written terms of reference specifying its authorities and duties. It currently comprises the executive Director, C-suites and the relevant department heads of the Company and is chaired by the executive Director. The Executive Committee is primarily responsible for supervising the day-to-day operation of the Group, implementing business strategies made by the Board and making investment decisions within its authorities, etc.

A dedicated investment team comprising finance, compliance, and industry specialists is deployed, with regular training programs to enhance risk identification capabilities. Under the current investment direction, the focus is on technological innovation, to accelerate the conversion of new and existing development drivers for the Group’s businesses and to regularly implement strategic adjustments for business development. The Group accordingly will actively embrace the opportunities brought by innovative technologies such as Web 3.0 and quantum computing, explore technological applications in emerging fields and seize their investment opportunities.

股權投資的主要目標將是優先佈局高增長潛力領域之長線投資，包括：(1)投資於從事人工智能消費電子及機器人或從事銷售及進口業務的上市公司的股權（「**上市股權投資**」）；(2)投資於專注量子計算產業化及普及化的一站式解決方案供應商（「**量子投資**」）；及(3)參與股票指數基金及固定收益工具等大型金融產品的基金權益投資（「**基金投資**」）。本集團透過構建涵蓋高增長板塊（量子計算、人工智能相關行業及公司）及稀缺資產（藝術品、數字貨幣）的多元化組合，致力實現長期資產增值並開拓全新投資疆界。

整體投資策略旨在系統性地發掘、評估及把握高成長機遇，同時嚴謹對沖風險並維持嚴格風控措施。執行委員會是本集團投資的核心決策機構，其成員與其他管理層成員合作建立涵蓋「投資決策 — 執行追蹤 — 風險緩解 — 價值提升」全流程之閉環管治架構。執行委員會乃由董事會於二零一七年四月設立，並制定了書面職權範圍訂明其權力及職責。目前，執行委員會成員包括執行董事、高管層及本公司相關部門主管，並由執行董事擔任主席。執行委員會主要負責監督本集團的日常營運、執行董事會制定的業務策略以及在其職權範圍內作出投資決策等。

本集團已成立由財務、合規及行業方面專才組成的專責投資團隊，並定期進行培訓課程以提升風險識別能力。就現行投資方向而言，重點聚焦科技創新領域，以加速本集團業務的新舊發展動能轉換，並定期實施業務發展策略調整。據此，本集團將積極把握Web 3.0及量子計算等創新技術帶來的機遇，探索新興領域技術應用並捕捉相關投資機遇。

Moreover, on risk management for funds, fund managers establish and maintain effective risk management policies and reporting methodologies, subject to regular review, especially when significant changes occur to the fund or such changes to market conditions, legislation, rules, or regulations may impact the fund's risk exposure. Additionally, the risk management policy for each fund implements a system of limits to monitor and control the relevant risks based on the measures used.

The tenures of investments elaborated above are (1) typically medium to long term horizons for private equity investments with a tenure of 1 year or above, with exit timing calibrated to strategic milestones such as market share dominance and profitability thresholds; or liquidity events such as trade sales and initial public offerings; and (2) for publicly traded equities and index funds, the relevant investments generally serve as short-term liquidity buffers with a tenure not exceeding one year, provided that in rare cases, we may moderately extend the investment period to up to three years, depending on the extent to which the price reflects the underlying value.

Trading and supply chain operations

During the Reporting Year, the Group recorded a segment revenue from trading and supply chain operations of approximately HK\$1,570,972,000 (2025: approximately HK\$819,545,000), representing an increase of approximately 91.69% as compared to 2025. The segment profit for the Reporting Year was approximately HK\$52,000 (2025: segment loss of approximately HK\$294,000). The turnaround from segment loss to segment profit was mainly due to the improvement of profit margin during the Reporting Year.

The trading and supply chain operations business operates based on certain long-term clients, who in turn provide stable operation foundations and income source for the Group. In terms of business model, the Group would firstly conduct market research, where the Group clarifies on the potential customers' need of commodities (as for the Reporting Year, under the trading and supply chain operations business engaged by the Company, bulk commodities such as electrolytic copper and electrolytic nickel have been involved, which serve for energy-provision or heavy

此外，在基金風險管理方面，基金經理制定並維持有效的風險管理政策與匯報機制，並定期進行檢討（尤其是當基金出現重大變動或市場環境、法律、規則或法規的變動可能影響基金風險承擔水平時）。另外，各基金之風險管理政策均會實施限額制度，以根據所採用的措施監察及管控相關風險。

上述投資項目的年期如下：(1) 私募股權投資一般設1年或以上中長期投資期，退出時點按戰略性里程碑（如市佔率優勢及盈利門檻）或流動性事件（如同業出售及首次公開招股）確定；及(2) 上市股票及指數基金相關投資則通常作為不超過1年的短期流動性緩衝配置，但少數情況我們會根據價格反映價值的程度適度延長投資期至不超過3年。

貿易及供應鏈運營

於本報告年度，本集團錄得貿易及供應鏈運營分部收入約1,570,972,000港元（二零二五年：約819,545,000港元），較二零二五年增加約91.69%。本報告年度之分部溢利約為52,000港元（二零二五年：分部虧損約294,000港元）。分部虧損轉為分部溢利主要由於本報告年度利潤率有所改善所致。

貿易及供應鏈運營業務依托若干長期客戶進行運營，該等客戶為本集團提供穩定的運營基礎及收入來源。就業務模式而言，本集團會先進行市場調研，釐清潛在客戶對商品（就本報告年度而言，本公司從事的貿易及供應鏈運營業務涉及電解銅及電解鎳等用於能源供應或重工業用途的大宗商品）的需求，並向供應商索取目標商品的採購報價。於報價過程中，本集團亦會綜合考量價格、品質、交

industry purposes), and seeks suppliers' quotations on target commodities' acquisition. During the price quotation process, the Group would also comprehensively consider factors such as price, quality, delivery period in order to ensure customers' satisfaction. Where applicable, the Group would also provide credit guarantee or guarantee deposit to ensure the stability of the supply chain.

Subsequent to the confirmation of suppliers of commodities, procurement contracts would be executed with suppliers to secure the key terms such as specifications of commodities, quantities, price, delivery period, payment terms, to ensure transparency during the procurement process.

Simultaneously, the Group proactively seeks for buyers with such needs of commodities via market and business development, and negotiates with buyers prior to reaching consensual terms of specifications of commodities, quantities, price, delivery period and payment terms. During negotiations, the Group would conduct due diligence on the potential buyers' credibility to minimize transactional risks of non-payment. Subsequent to receiving from the buyers such payment for commodities acquired, the Group would in exchange provide the ownership documentations to the relevant buyers, which in turn signifying the exchange of ownership and risks.

After the entire transaction is completed, the Group makes account for the revenue according to the relevant accounting principles applicable.

As a whole, the trading and supply chain operations business has four (4) staff members responsible for supply chain operations business, including one management staff with eight (8) years of experience in international supply chain management and trade business. Moreover, such business provides value-adding services such as analysis and forecast regarding market trend, and accordingly provide support for clients to make appropriate and timely procurement decision; besides, the Group, during its operations, offer credit guarantee or guarantee deposit to ensure the stability of the supply chain in order to avoid deal-breaking risks.

貨期等因素以確保客戶滿意度。在適當情況下，本集團亦會提供信用擔保或保證金以確保供應鏈的穩定性。

在確認商品供應商後，本集團將與供應商簽訂採購合約，以明確商品規格、數量、價格、交貨期及付款條款等關鍵條款，從而保障採購過程的透明度。

與此同時，本集團會透過市場及業務拓展積極尋求有此類商品需求的買家，並就商品規格、數量、價格、交貨期及付款條款等與買家進行磋商，以達成雙方同意的條款。在磋商過程中，本集團將對潛在買家的信用狀況進行盡職審查，以盡量降低交易中可能出現的拖欠款項的風險。待收到買家支付的商品採購款後，本集團將相應地向相關買家提供所有權文件，此舉標誌著商品所有權及風險的轉移。

於整個交易完成後，本集團會根據適用的相關會計原則核算收入。

整體而言，貿易及供應鏈運營業務有四(4)名專責人員負責，其中包括一名擁有八(8)年國際供應鏈管理及貿易業務經驗的管理人員。此外，該業務提供包括市場趨勢分析與預測等增值服務，並相應協助客戶制定適時且合宜的採購決策；同時，本集團在運營過程中會視情況提供信用擔保或保證金，以確保供應鏈的穩定性，從而避免交易破裂的風險。

The major customer of the trading and supply chain operations business is a Hong Kong company, and its major supplier is a trading company incorporated in Hong Kong.

Looking forward, the Group's plan is to (i) explore new product categories in the trade, gradually accumulate experience and customer resources through existing product categories, and develop new customers in categories such as electronic products and smart devices to improve the overall gross profit margin of the business; (ii) expand new sectors of trading in terms of commodities for transactions, and simultaneously, expand the scale and scope of the trading business to involve in transactions of derivatives trading such as futures, options and swaps for commodities, so as to achieve further diversification on financial services provision of the Group; and (iii) expand into the trade financing business and merge the trading businesses with the financial services of the Group, thereby updating its business model with more advanced investment products and service model, including the development of financial service products for commodities, so as to provide trade financing solutions for suppliers and customers, promoting the Group's market competitiveness on its existing financial service segments.

Artwork investment

During the Reporting Year, the Group recorded segment loss of approximately HK\$4,366,000 (2025: segment profit of approximately HK\$504,000), which mainly resulted from the fair value loss of the investments in artworks by the Group during the Reporting Year.

As the investment targets are primarily antiques in the form of jade artefacts and ceramic artefacts, the Company has been building, maintaining and constantly improving its internal control and risk management systems and policies for such business since its establishment, especially on the authentication and valuation of artworks, which are of utmost importance to our business. Such protective policies and systems are reflected from the adoption and implementation of a comprehensive set of specific measures at every stage of our art investment business, commencing from screening, authentication and valuation to the continuous monitoring until realisation.

貿易及供應鏈運營業務的主要客戶為一家香港公司，而其主要供應商為一家在香港註冊成立的貿易公司。

展望未來，本集團計劃：(i) 開拓貿易商品新品類，通過現有商品品類業務，逐步積累經驗與客戶資源，向電子產品、智能設備等品類開發新客戶，提高業務整體毛利率；(ii) 拓展大宗商品交易之新領域，並同步擴大貿易業務規模及範圍至涵蓋大宗商品期貨、期權、掉期等衍生工具之交易領域，進一步多元化本集團金融服務；及(iii) 擴展至貿易融資業務，並將貿易業務與本集團金融服務相結合，透過開發大宗商品金融服務產品等更高階投資產品及服務模式，革新業務模式，為供應商及客戶提供貿易融資解決方案，提升本集團在現有金融服務領域之市場競爭力。

藝術品投資

於本報告年度，本集團錄得分部虧損約4,366,000港元（二零二五年：分部溢利約504,000港元），主要源自本集團於本報告年度的藝術品投資的公平值虧損。

由於投資目標主要為玉器及陶器類古董藝術品，自開展該業務以來，本公司持續建立、維持並不斷完善內部監控及風險管理系統及政策，尤重藝術品鑑定及估值，其對我們的業務至關重要。該等保障政策及制度體現於我們於藝術品投資業務各階段，包括從篩選、鑑定、估值至持續監察直至變現，所採納及實施的一套有針對性的綜合措施。

The artwork investment business of the Company starts with sales from private collectors, and the sales opportunities with them have been made available to the Company as it leverages the industry experience and connections of its art appraisal and valuation team (the “**Art A&V Team**”) and external industry experts. The Company will conduct due diligence on the relevant vendors of the artworks including making enquiry and conducting available public searches of the artwork documentation to prove ownership, authenticity and value of the artworks. Upon an initial confirmation of investment with a favourable reply on the above, we will utilise our long-term collaborating Art A&V Team to check on the authenticity of the artworks to be acquired every time before any investment decision is made. The Company’s internal team of three (3) staff members (the “**Internal Art Investment Team**”) will then decide (i) whether to proceed with the relevant investments; and (ii) whether a discount will be required.

Subsequent to the investments made on the relevant artworks, the Company also devotes plenty of resources to establishing solid internal control and risk management systems to monitor risks concerning possible deterioration of value of artworks, and has put in place stringent procedures and policies in continuous appraisal of investments. The Internal Art Investment Team will collaborate with the Art A&V Team to monitor the conditions and value of the artworks on a bi-annual basis. Upon the Art A&V Team reporting the latest conditions to the Internal Art Investment Team, the latter will communicate with the Board on such conditions and decide whether sales of the artworks are required to realise such investments and recognise the profit derived thereunder.

The Company adopts a long-term investment approach for the artworks, artefacts and antiques (such as jade, ceramics and collectibles), with an aim to optimise divestment opportunities aligning with market cycles and long-term potential and foreseeable asset appreciation (owing to their scarcity and their own unique culture value and long-term appreciation potential), and thereby bringing value and benefits to the Company and its Shareholders as a whole from the acquired assets’ value appreciation. On top of that, the Company’s development strategy to enter the cultural and creative industries is to leverage its subsidiaries’ capacities in conducting licensed activities under the SFO and the Group’s professional teams to establish service systems for art auctions, financing, and real-world asset (“**RWA**”) tokenization as blockchain-powered solutions, thereby expanding into the high value-added cultural finance markets.

本公司藝術品投資業務始於私人藏家銷售，本公司憑藉其藝術品鑑定估值團隊（「**藝術品鑑估團隊**」）及外部行業專家的業界經驗及人脈網絡，得以知曉此等銷售資訊。本公司會對藝術品相關賣家進行盡職調查，包括查詢及對藝術品文件進行可行的公開搜尋，以證明藝術品的所有權、真偽及價值。在初步確認投資並就上述事宜獲得有利回覆後，在作出任何投資決定前，我們每次均會利用我們的長期合作藝術品鑑估團隊核查擬收購藝術品的真偽。本公司由三(3)名員工成員組成的內部團隊（「**內部藝術品投資團隊**」），負責決定(i)是否進行相關投資；及(ii)是否需要價格折讓。

完成相關藝術品投資後，本公司亦投入大量資源建立嚴謹的內部監控及風險管理系統，以監察藝術品價值貶損風險，並實施嚴格程序及政策持續評估投資。內部藝術品投資團隊將與藝術品鑑估團隊每半年協作監察藝術品狀況及價值。根據藝術品鑑估團隊向內部藝術品投資團隊提交之最新狀況報告，後者將向董事會匯報並決定是否需出售藝術品以變現投資及確認由此產生的利潤。

本公司對藝術品、工藝品及古董（包括玉器、瓷器及收藏品）採取長期投資策略，旨在通過把握市場週期與長期增值潛力以及可預見的資產增值（源於其稀缺性、獨特文化價值及長期升值潛力），優化退資時機，從而通過所收購資產的增值為本公司及全體股東創造價值與收益。除此之外，本公司進軍文創領域的發展策略是依託附屬公司從事證券及期貨條例項下受規管活動之能力及本集團專業團隊，借助區塊鏈技術，構建藝術品拍賣、融資及現實世界資產（「**RWA**」）代幣化的服務體系，從而拓展高附加值的文化金融市場。

CAPITAL STRUCTURE

As at 31 March 2026, the nominal value of the total issued share capital of the Company was approximately HK\$1,030,385,261.40, comprising 10,303,852,614 Shares of the Company of HK\$0.10 each.

The Group actively and regularly reviews and manages its capital structure and makes adjustments to the capital structure in light of changes in economic conditions. For the licensed subsidiaries of the Group, the Group ensures each of them maintains a liquid capital level that is adequate to support the level of activities with a sufficient buffer to accommodate increases in liquidity requirements arising from potential increases in the level of business activities. During the Reporting Year, all the licensed subsidiaries of the Group complied with the liquid capital requirements under the Securities and Futures (Financial Resources) Rules (Cap. 571 sub. leg. N of the Laws of Hong Kong) (“**Securities and Futures (Financial Resources) Rules**”).

CAPITAL RISK MANAGEMENT

The Group manages its capital to ensure that entities in the Group will be able to continue as a going concern while maximising the return to Shareholders through the optimisation of the debt and equity balances.

The capital structure of the Group consists of debt, which includes lease liabilities, cash and cash equivalents and equity attributable to owners of the Company, which comprises issued share capital and reserves.

The Directors review the capital structure regularly. As part of the review, the Directors consider the cost of capital and the risks associated with each class of capital, and take appropriate actions to adjust the Group’s capital structure. The overall strategy of the Group remains unchanged during the years ended 31 March 2026 and 2025.

For certain subsidiaries of the Company, they are regulated by the Securities and Futures Commission (the “**SFC**”) of Hong Kong and are required to comply with certain minimum capital requirements according to the rules of SFC. Our management monitors, on a

daily basis, the subsidiaries' liquid capital level to ensure they meet the minimum liquid capital requirements in accordance with the Securities and Futures (Financial Resources) Rules. The range of liquid capital is from HK\$100,000 to HK\$3,000,000 or 5.00% of their total adjusted liabilities, whichever is higher.

There was no non-compliance by the Group's members with the capital requirements imposed by the respective regulators during the years ended 31 March 2026 and 2025.

LIQUIDITY AND FINANCIAL RESOURCES AND GEARING RATIO

During the Reporting Year, the Group mainly financed its operations by cash generated from operating activities and proceeds from fund raising activities.

As at 31 March 2026, the Group's current assets and current liabilities were approximately HK\$4,255,834,000 (as at 31 March 2025: approximately HK\$841,714,000) and approximately HK\$2,169,807,000 (as at 31 March 2025: approximately HK\$678,890,000) respectively, while the current ratio was about 1.96 times (as at 31 March 2025: 1.24 times).

As at 31 March 2026, the Group's aggregate cash and cash equivalents amounted to approximately HK\$435,560,000 (as at 31 March 2025: approximately HK\$92,186,000), of which approximately 94.24% was denominated in HK\$ (as at 31 March 2025: approximately 80.07%), approximately 2.64% was denominated in United States dollars ("USD") (as at 31 March 2025: approximately 9.83%), approximately 3.11% was denominated in Renminbi ("RMB") (as at 31 March 2025: 10.00%), and approximately 0.01% was denominated in SGD (as at 31 March 2025: approximately 0.10%), representing 10.23% (as at 31 March 2025: approximately 10.95%) of total current assets.

During the Reporting Year, no financial instruments were used for hedging purposes. As at 31 March 2026, the gearing ratio, measured on the basis of total borrowings (including borrowings and lease liabilities) as a percentage of equity attributable to owners of the Company, was approximately 7.55% (as at 31 March 2025: approximately 10.97%). The debt ratio, defined as total debts over total assets, was approximately 23.93% (as at 31 March 2025: 14.88%).

SIGNIFICANT INVESTMENT

As at 31 March 2026, the Group held investments at fair value through profit or loss of approximately HK\$1,842,915,000 (as at 31 March 2025: approximately HK\$585,942,000), with net gains on investments at fair value through profit or loss of approximately HK\$422,436,000 (2025: approximately HK\$50,145,000).

As at 31 March 2026, none of the individual underlying investments of the above-mentioned investments constitutes 5% or more of the total assets of the Group.

INVESTMENTS IN ASSOCIATES

The Group has significant investments in HK.AI and CSOP, each being an associate of the Group.

HK.AI Capital Limited

HK.AI is a company listed on the Main Board of the Stock Exchange (stock code: 1140) as an investment company regulated under Chapter 21 of the Listing Rules. HK.AI and its subsidiaries (collectively, the “**HK.AI Group**”) are principally engaged in investment holding activities in Hong Kong and the PRC, with the involvement of investment in a diversified portfolio of global investments with respect to both listed and private enterprises.

On 18 October 2024, Marvel Champion Investment Limited, a wholly-owned subsidiary of the Company, completed the acquisition of 2,751,339,130 shares of HK.AI, upon which, (i) the Company has been beneficially interested in 3,064,454,515 shares of HK.AI, representing approximately 29.13% equity interest in HK.AI; and (ii) HK.AI has become an associate of the Group.

The carrying amount of the investment in HK.AI as at 31 March 2026 was approximately HK\$1.93 billion, representing approximately 21.13% of the Group's total assets as at 31 March 2026.

During the year ended 31 March 2026, the Group recognised share of profit and other comprehensive income of HK.AI in the amount of approximately HK\$31,852,000 and HK\$36,457,000, respectively. No dividend from HK.AI was received during the Reporting Year.

重大投資

於聯營公司之投資

本集團於華科智能及南方東英有重大投資，每間公司均為其聯營公司。

華科智能投資有限公司

作為上市規則第21章項下受規管的投資公司，華科智能為一間於聯交所主板上市之公司（股份代號：1140）。華科智能及其附屬公司（統稱「**華科智能集團**」）主要於香港及中國從事投資控股活動，並參與投資於涉及上市及私營企業之分散化全球投資組合。

於二零二四年十月十八日，本公司之全資附屬公司滿冠投資有限公司完成收購華科智能之2,751,339,130股股份，於完成後，(i)本公司實益擁有3,064,454,515股華科智能股份，約佔華科智能29.13%股權；及(ii)華科智能成為本集團之聯營公司。

於二零二六年三月三十一日於華科智能的投資賬面值為約19.3億港元，佔本集團於二零二六年三月三十一日的總資產約21.13%。

截至二零二六年三月三十一日止年度，本集團分別確認分佔華科智能的溢利及其他全面收入約為31,852,000港元及36,457,000港元。本報告年度內並無自華科智能收取股息。

CSOP Asset Management Limited

CSOP is a limited liability company incorporated in Hong Kong and licensed by the Hong Kong Securities and Futures Commission to carry out Type 1 (dealing in securities), Type 4 (advising on securities) and Type 9 (asset management) regulated activities. CSOP manages private and public funds and provides investment advisory services to Asian and global investors, with a dedicated focus on China investing. It is committed to providing investors with a flexible and efficient asset allocation tool through simple, transparent and innovative products.

On 31 December 2024, the Company entered into a sale and purchase agreement with HK.AI to acquire 60,000,000 shares of CSOP, representing 22.50% of the entire issued share capital of CSOP, at a total consideration of HK\$1,110,000,000, satisfied by the allotment and issuance of 1,405,063,292 Shares of the Company at approximately HK\$0.79 per share under a specific mandate. Completion of the CSOP Acquisition took place on 2 January 2026, following which CSOP became an associate of the Group.

The carrying amount of the investment in CSOP as at 31 March 2026 was HK\$1,298,280,000 (after recognition of an impairment allowance of HK\$2,459,256,000), representing approximately 14.22% of the Group's total assets as at 31 March 2026.

During the Reporting Year, the Group recognised share of profit and other comprehensive expense of CSOP in the amount of approximately HK\$35,361,000 and HK\$1,243,000, respectively.

OUTLOOK

Looking ahead, the Group will leverage its solid foundation in integrated financial services to focus on the dual-driver strategy of digital assets and quantum technology. It will further explore the integration and synergistic development of finance with cutting-edge technology fields such as Web3, quantum technology, and artificial intelligence. By capitalizing on Hong Kong's advantages as an international financial centre and the opportunities arising from national policies on technological innovation, the Group aims to drive high-quality development across its businesses into a new phase.

南方東英資產管理有限公司

南方東英是一家於香港註冊成立的有限公司，並獲香港證券及期貨事務監察委員會發牌可從事第1類（證券交易）、第4類（就證券提供意見）及第9類（資產管理）受規管活動。南方東英管理私募及公募基金，並為亞洲及全球投資者提供投資諮詢服務，且致力專注於中國投資領域。該公司致力於通過簡單、透明及創新的產品，為投資者提供靈活高效的資產配置工具。

於二零二四年十二月三十一日，本公司與華科智能訂立買賣協議，以總代價1,110,000,000港元收購南方東英60,000,000股股份，佔南方東英全部已發行股本的22.50%。該代價將通過根據特別授權，按每股約0.79港元配發及發行本公司1,405,063,292股股份的方式支付。南方東英收購事項已於二零二六年一月二日完成，其後南方東英成為本集團的聯營公司。

於二零二六年三月三十一日，對南方東英投資的賬面值為1,298,280,000港元（於確認減值撥備2,459,256,000港元後），佔本集團於二零二六年三月三十一日總資產約14.22%。

於本報告年度，本集團確認應佔南方東英溢利及其他全面開支金額分別約為35,361,000港元及1,243,000港元。

展望

展望未來，本集團將以綜合金融服務的堅實基礎為依托，聚焦數字資產與量子科技雙輪驅動戰略，並進一步探索金融與Web3、量子科技、人工智能等前沿科技領域的融合與協同發展，把握香港國際金融中心優勢及國家科技創新政策機遇，推動各項業務邁向新階段的高質量發展。

Rooted in Hong Kong and aligning with the broader national landscape. Against the backdrop of the release of the national “15th Five-Year Plan” and the HKSAR Government’s proactive and comprehensive alignment with the nation’s “15th Five-Year Plan Outline” through the preparation of Hong Kong’s first official five-year plan, the Group is advancing the cross-boundary integration of its four core pillars: finance, technology and innovation, arts and trade. We are committed to building a secure foundation with new financial infrastructure, unlocking corporate growth through an integrated ecosystem, and forging a next-generation cross-border, cross-sector technology and investment platform, sharing in the prosperity of the nation and the region.

In the financial services sector, the Group will comprehensively deepen its innovative financial service system, which is characterized by the synergy of multiple licenses, empowerment by new financial infrastructure, and full-lifecycle support for clients. We will efficiently integrate the licences (Types 1, 4, 6, 9) granted by the Hong Kong Securities and Futures Commission and cross-border business qualifications (QFI, CIBM, QDIE, QFLP and Bond Connect), adhering to the core logic of “investment driving investment banking” to foster innovation within comprehensive financial services. In the quantum technology sector, the Group will continue to focus on the commercialisation of quantum technology and the implementation of industrial applications. Adhering to the core philosophy of “driving investment banking business through investment and nurturing traditional finance with innovation”, the Group will steadily expand its capital scale, strengthen risk control and corporate governance, and fully leverage Hong Kong’s unique advantages as an international financial hub and “super connector”. In active response to the national quantum technology development strategy and the call for the construction of the Guangdong-Hong Kong-Macao Greater Bay Area, the Group is committed to creating long-term sustainable value for its shareholders, clients, partners and society, and to driving the Group towards higher-quality development.

On 31 December 2024, the Company as the purchaser and HK.AI as the vendor entered into a sale and purchase agreement, pursuant to which the Company has conditionally agreed to purchase and HK.AI has conditionally agreed to sell 60,000,000 shares of CSOP, representing 22.50% of the entire issued share capital of CSOP, at the consideration of HK\$1,110,000,000, which shall be settled by the allotment and issuance of 1,405,063,292 shares of the Company at the issue price of approximately HK\$0.79 per share under the specific mandate to be sought by the Company at the extraordinary general meeting of the Company.

The approval of the CSOP Acquisition, the sale and purchase agreement and the transactions contemplated thereunder by the shareholders of the Company (the “**Shareholders**”) was obtained at the extraordinary general meeting of the Company convened and held on 15 July 2025.

The CSOP Acquisition was completed on 2 January 2026.

On 9 April 2025, the Company entered into a placing agreement with Fortune (HK) Securities Limited (the “**Placing Agent**”), pursuant to which the Placing Agent has conditionally agreed to procure, on a best effort basis, no less than six placees, who and whose ultimate beneficial owners (where applicable) will be independent third parties, to subscribe (the “**2025 Placing**”) for up to a maximum of 372,923,749 new shares at the placing price of HK\$1.12 per new share. Completion of the 2025 Placing took place on 25 April 2025.

On 25 April 2025, the Company announced that a total of 231,500,000 placing shares (the “**2025 Placing Shares**”) have been successfully placed by the Placing Agent to no less than six placees at the placing price of HK\$1.12 per 2025 Placing Share, representing approximately 3.01% of the issued share capital of the Company as enlarged by the allotment and issue of the 2025 Placing Shares immediately upon the completion of the 2025 Placing on 25 April 2025.

The gross proceeds from the 2025 Placing received by the Group amounted to HK\$259.28 million and the net proceeds (after deduction of relevant expenses) received by the Company under the 2025 Placing was approximately HK\$256.60 million.

MAJOR TRANSACTION — ARTWORK ACQUISITION TRANSACTIONS

Reference is made to the announcement dated 31 October 2025 and the circular dated 23 February 2026 in relation to, among other things, the twenty-eight artwork acquisition transactions (the “**Artwork Acquisition Transaction(s)**”) entered into during the period from 22 January 2025 to 4 September 2025, between the purchaser (a wholly-owned subsidiary of the Company) and the sellers (each of the sellers (and its ultimate beneficial owner, as the case may be) is an Independent Third Party). Pursuant to those transactions, a consideration in the aggregate amount of approximately HK\$829.67 million was paid for the artworks involved, which had been funded by internal resources of the Group.

On a standalone basis, all of the applicable percentage ratios (as defined under Rule 14.07 of the Listing Rules) in respect of each of the Artwork Acquisition Transactions were less than 5%, and accordingly each transaction does not constitute a notifiable transaction of the Company under Chapter 14 of the Listing Rules and was therefore not subject to any disclosure requirements under the Listing Rules.

However, since the Artwork Acquisition Transactions comprise the artworks and the RWA-relevant businesses of the Group and together lead to substantial involvement by the listed issuer in a business activity which did not previously form part of the listed issuer’s principal business activities, the Artwork Acquisition Transactions, which are all conducted within a period of twelve months, shall be aggregated under Rule 14.23(4) of the Listing Rules.

Due to an inadvertent oversight, the Company failed to promptly comply with the reporting, announcement, circular and shareholders’ approval requirements under Chapter 14 of the Listing Rules regarding the Artwork Acquisition Transactions. The Company would like to stress that regardless of the transactions contemplated under the Artwork Acquisition Transactions, the non-disclosure of such transactions in compliance with the disclosure requirements under Rules 14.34, 14.38A and 14.40 of the Listing Rules, had been wholly unintentional as the Company genuinely held the belief that all those transactions were not required to be aggregated under the Listing Rules.

然而，由於藝術品收購交易涉及藝術品及本集團的RWA相關業務，共同導致上市發行人大量參與一項業務，而該業務以往並不屬於上市發行人主要業務的一部分，根據上市規則第14.23(4)條，所有於十二個月期間內進行的藝術品收購交易應合併計算。

由於無心之失，本公司未能就藝術品收購交易及時遵守上市規則第14章項下申報、公告、通函及股東批准之規定。本公司謹此強調，儘管進行了藝術品收購交易項下擬進行交易，惟未遵守上市規則第14.34條、第14.38A條及第14.40條之披露規定披露該等交易，純屬無心之失，此乃由於本公司當時篤信所有該等交易毋須根據上市規則予以合併計算。

- (a) as the first line for artwork investment, the Group has an internal team of staff with three members to decide whether or not to proceed with making a particular artwork investment. Such team has diversified experiences regarding artwork investment, varying from experiences on management, investments, authentication and valuation of different artworks, antiques and artefacts, including Mr. Wang Tao, Mr. Ding Wenchang and Ms. Yan Sinuo (details of these members may be referred from the announcement dated 31 October 2025). Among the above members, Mr. Ding Wenchang and Ms. Yan Sinuo have both become special correspondents with the finance department of the Company such that any potential artwork investment will be promptly communicated and kept track of, and all necessary calculations on applicable percentage ratios as defined under Rule 14.07 of the Listing Rules will be made to see if disclosure is required on a standalone basis;

- (e) relevant internal training sessions have been regularly arranged for all the Directors and senior management/relevant personnel of the Company and its subsidiaries to explain the relevant requirements under Chapter 14 of the Listing Rules on a quarterly basis so as to cover all such Directors and senior management/relevant personnel newly joining the Group from time to time; and
- (f) the business and financial departments at the subsidiary level have also been notified to promptly report the implementation of the transactions to the Board in order to ascertain whether there will be any implications under Chapter 14 of the Listing Rules.

MATERIAL ASSET IMPAIRMENTS

The Group recorded an impairment loss arising from the CSOP Acquisition of approximately HK\$2,459,256,000 during the Reporting Year.

重大資產減值

於報告年度，本集團錄得因南方東英收購事項產生之減值虧損約2,459,256,000港元。

Circumstances that Led to the Impairment

The reasons for, and the events and circumstances, leading to the recognition of the impairment, are set out as follows:

- (i) On 31 December 2024, the Company entered into a sale and purchase agreement with HK.AI to acquire 60,000,000 shares of CSOP, representing 22.50% of the entire issued share capital of CSOP, at a total consideration of

HK\$1,110,000,000, which shall be satisfied by the allotment and issuance of 1,405,063,292 Shares of the Company at approximately HK\$0.79 per Share under a specific mandate. Completion of the CSOP Acquisition took place on 2 January 2026 (the “**Acquisition Date**”), following which CSOP became an associate of the Group.

(ii) Investment in an associate is accounted for in the consolidated financial statements of the Group by the equity method and is initially recognised at cost. Identifiable assets and liabilities of the associate in an acquisition are measured at their fair values at the acquisition date. The excess of the cost of acquisition over the Group's share of the net fair value of the associate's identifiable assets and liabilities is recorded as goodwill. The goodwill is included in the carrying amount of the investment and is tested for impairment together with the investment at the end of each reporting period when there is objective evidence that the investment is impaired. Any excess of the Group's share of the net fair value of the identifiable assets and liabilities over the cost of acquisition is recognised in consolidated profit or loss.

(ii) 於聯營公司的投資按權益法於本集團綜合財務報表入賬，並初步按成本確認。於一項收購中可識別的聯營公司資產及負債按其於收購日期的公平值計量。收購成本超出本集團應佔聯營公司可識別資產及負債的公平值淨值的差額入賬列作商譽。商譽計入投資的賬面值，並於有客觀證據顯示投資出現減值時於各報告期末連同投資一併進行減值測試。本集團應佔可識別資產及負債的公平值淨值超出收購成本的任何差額於綜合損益中確認。

(iii) HKAS28.26 stated that “the concepts underlying the procedures used in accounting for the acquisition of a subsidiary are also adopted in accounting for the acquisition of an investment in an associate or a joint venture”. HKFRS3.37 stated that “the consideration transferred in a business combination shall be measured at fair value, which shall be calculated as the sum of the acquisition-date fair values of the assets transferred by the acquirer, the liabilities incurred by the acquirer to former owners of the acquiree and the equity interests issued by the acquirer”. Hence, the acquisition cost of the CSOP Acquisition amounted to HK\$3,723,417,000, which was calculated based on the issue of 1,405,063,292 consideration Shares of the Company and the Company's closing share price of HK\$2.65 per Share as at the Acquisition Date (i.e. 2 January 2026), which is 3.35 times when compared with the issue price at HK\$0.79 per share according to the aforesaid sale and purchase agreement.

(iii) 香港會計準則第28號第26段指出「就收購附屬公司進行會計處理時所用程序之相關概念，亦適用於就收購於聯營公司或合營企業之投資進行會計處理」。香港財務報告準則第3號第37段指出「於業務合併中所轉讓之代價須按公平值計量，其計算方式為買方所轉讓資產、買方向被收購方前擁有人所承擔之負債及買方所發行股權於收購日期之公平值之總和」。因此，南方東英收購事項之收購成本為3,723,417,000港元，乃根據本公司發行1,405,063,292股代價股份及本公司股份於收購日期（即二零二六年一月二日）之收市價每股2.65港元計算，為根據上述買賣協議之發行價每股0.79港元之3.35倍。

- (iv) The Group's share of an associate's post-acquisition profits or losses is recognised in consolidated profit or loss, and its share of the post-acquisition movements in reserves is recognised in the consolidated reserves. The cumulative post-acquisition movements are adjusted against the carrying amount of the investment. Since acquisition, the Group has recognised its share of CSOP's profits of HK\$35,361,000 and an exchange loss arising from the translation of CSOP's foreign operations of HK\$1,242,000, respectively. At 31 March 2026, the carrying amount of the Group's interest in CSOP was approximately HK\$3,757,536,000 (i.e. HK\$3,723,417,000 + HK\$35,361,000 – HK\$1,242,000).
- (iv) 本集團應佔聯營公司之收購後溢利或虧損於綜合損益中確認，而其應佔收購後儲備變動則於綜合儲備內確認。累計收購後變動就投資之賬面值作出調整。自收購以來，本集團已分別確認其應佔南方東英溢利35,361,000港元及因換算南方東英海外業務產生之匯兌虧損1,242,000港元。於二零二六年三月三十一日，本集團於南方東英之權益賬面值約為3,757,536,000港元（即3,723,417,000港元+35,361,000港元–1,242,000港元）。
- (v) According to the Group's accounting policy and HKAS 36, the carrying amount of the interest in an associate is tested for impairment at the end of each reporting period when there is objective evidence that the associate is impaired. If the recoverable amount of an associate is estimated to be less than its carrying amount, the carrying amount of the interest in an associate is reduced to its recoverable amount. An impairment loss is recognised immediately in profit or loss. In the opinion of the Directors, impairment loss on interest in an associate of approximately HK\$2,459,256,000 should be recognised as the recoverable amount of the associate is estimated to be less than its carrying amount. The carrying amount of the interest in the associate is approximately HK\$3,757,536,000. The recoverable amount of the interest in the associate is approximately HK\$1,298,280,000 which is reference to the valuation report prepared by BMI Appraisals Limited, an independent professional valuer. Hence, impairment loss on interest in an associate of approximately HK\$2,459,256,000 (i.e. HK\$3,757,536,000 – HK\$1,298,280,000) is recognised.
- (v) 根據本集團之會計政策及香港會計準則第36號，當有客觀證據顯示聯營公司已減值時，須於各報告期末對於聯營公司之權益賬面值進行減值測試。若聯營公司之可收回金額估計低於其賬面值，則將於聯營公司之權益賬面值撇減至其可收回金額。減值虧損即時於損益確認。董事認為，由於該聯營公司之可收回金額估計低於其賬面值，故應確認於聯營公司之權益之減值虧損約2,459,256,000港元。於該聯營公司之權益賬面值約為3,757,536,000港元。於該聯營公司之權益之可收回金額約為1,298,280,000港元，此乃參考獨立專業估值師漢華評值有限公司編製之估值報告。因此，已確認於聯營公司之權益減值虧損約2,459,256,000港元（即3,757,536,000港元–1,298,280,000港元）。

Details of Business Valuation for the CSOP Acquisition

The aforesaid recoverable amount of the interest in CSOP is determined by reference to the fair value of 22.50% of the entire issued share capital of CSOP as at 31 March 2026, which amounted to HK\$1,298,280,000, as stated in the valuation report prepared by BMI Appraisals Limited, an independent professional valuer.

Valuation method and reason for using that method

(i) Valuation method adopted

The market approach, specifically the guideline public company method (the “**GPC Method**”) was applied to measure the fair value of 22.50% of the entire issued share capital of CSOP as at two separate valuation dates (i.e. 2 January 2026 and 31 March 2026). Three valuation multiples were used for reconciliation: enterprise value-to-earnings before interest, taxes, depreciation and amortization (“**EV/EBITDA**”) multiple, price-to-earnings (“**P/E**”) multiple, and price-to-asset under management (“**P/AUM**”) multiple, derived from selected listed comparable asset management firms. A discount for lack of marketability (“**DLOM**”) of 20.43% was further adjusted to reflect the illiquid nature of CSOP’s private equity interest.

(ii) Reasons for adopting the market approach

- (a) The method utilises observable trading multiples from publicly listed peer asset management enterprises, which provides objective market-based pricing benchmarks suitable for fair value measurement under HKFRS impairment testing requirements.
- (b) A sufficient pool of comparable listed asset management companies across multiple jurisdictions was identified, with complete publicly available share price and financial data to compute reliable EV/EBITDA, P/E and P/AUM average multiples as at two separate valuation dates (i.e. 2 January 2026 and 31 March 2026).

誠如獨立專業估值師中和邦盟評估有限公司編製之估值報告所述，上述於南方東英之權益之可收回金額乃參考南方東英全部已發行股本22.50%於二零二六年三月三十一日之公平值釐定，金額為1,298,280,000港元。

估值方法及採用該方法之理由

(i) 採納之估值方法

為計量於南方東英全部已發行股本22.50%於兩個獨立估值日期（即二零二六年一月二日及二零二六年三月三十一日）之公平值，已應用市場法，具體為可資比較上市公司法（「**可資比較上市公司法**」）。為進行對賬，已採用三種估值倍數：企業價值相對未計利息、稅項、折舊及攤銷前盈利（「**EV/EBITDA**」）倍數、市盈率（「**P/E**」）倍數，以及市價相對資產管理規模（「**P/AUM**」）倍數，均源自選定之上市可資比較資產管理公司。為反映南方東英私募股權之非流動性，已進一步作出20.43%之缺乏市場流通性之折讓（「**DLOM**」）調整。

(ii) 採納市場法之理由

- (a) 該方法利用來自上市同業資產管理企業之可觀察交易倍數，為香港財務報告準則減值測試規定下之公平值計量提供客觀及以市場為基礎之定價基準。

Price multiples

For valuations of CSOP, the valuer adopted the average of EV/EBITDA, P/E and P/AUM multiple in assessing CSOP as it is an asset management company which has a stable profitability. Thus, using EV/EBITDA and P/E multiple is commonly used for companies which are continuously profitable. The valuer also adopted P/AUM multiple to consider the effect of the size of asset management company as the difference between AUM of comparable companies differs greatly.

EV is calculated using the following formula:

$$EV = \text{Market Cap} + PE + MI + ST\ Debt + LT\ Debt - \text{Cash}$$

EV = enterprise value

Market Cap = market capitalization

價格倍數

就南方東英之估值，估值師於評估南方東英時已採用EV/EBITDA、市盈率及P/AUM倍數之平均值，原因為南方東英為具有穩定盈利能力之資產管理公司。而EV/EBITDA及市盈率倍數通常用於評估持續盈利的公司。此外，由於可資比較公司的資產管理規模差異甚大，估值師亦採用P/AUM倍數以計及資產管理公司規模的影響。

In applying the EV/EBITDA multiple, the average of the EV/EBITDA multiples of the Comparable Companies was multiplied by the EBITDA of CSOP as at the dates of valuation to determine the EVs of CSOP.

The calculated EVs of CSOP was then adjusted by subtracting the total debt, preferred equity and minority interest and adding back the cash and cash equivalents to determine the equity values of CSOP.

As CSOP is unlikely to undergo public offering and shares of CSOP are unlikely to be listed in any major stock exchange or be marketable in any over-the-counter market in the near future, the ownership interest in CSOP is not readily marketable. However, the price multiples adopted in the valuations were calculated from public listed companies, which represent marketable ownership interest; values calculated using such price multiple, therefore, represent the marketable interest. Thus, DLOM was adopted to adjust such marketable interest values to non-marketable interest values. The valuer adopted 20.43% as the DLOM for the valuations of CSOP.

- (a) The EV/EBITDA, P/E and P/AUM multiples were calculated based on real-time public trading prices and published financial data of 8 listed peer asset management enterprises across multiple jurisdictions as at each valuation date. Outlier figures flagged with asterisks were excluded when computing the average multiples to avoid skewed valuation benchmarks.
- (b) The GPC Method was selected as the core valuation technique, grounded on observable market pricing data from comparable industry players, which serves as objective market evidence for fair value measurement under HKFRS impairment testing requirements.
- (c) The exclusion of income approach inputs (projected cash flow, discount rate, growth rate) was on the basis that such figures depend heavily on highly subjective long-term forecasts and discretionary assumptions, which would introduce excessive estimation uncertainty to the valuation conclusion.

Explanation on any changes in valuation method used or inputs or assumptions

There were no changes in valuation method or significant changes in the valuation inputs or assumptions applied for the two separate valuation dates (i.e. 2 January 2026 and 31 March 2026).

RISK MANAGEMENT

The Group has properly put in place credit management policies which cover the examination of the approval of client's trading and credit limits, regular review of facilities granted, monitoring of credit exposures and the follow up of credit risks associated with overdue debts. The policies are reviewed and updated regularly.

FOREIGN CURRENCY FLUCTUATION

During the Reporting Year, the Group mainly used Hong Kong dollars in its business transactions. The Board considers that the Group's foreign currency exposure is insignificant.

HUMAN RESOURCES

As at 31 March 2026, the Group had 86 employees in total (2025: 62 employees). The related employees' costs for the Reporting Year amounted to approximately HK\$65,179,000 (2025: approximately HK\$70,985,000). The Group remunerated employees based on the industry practice and individual's performance. Staff benefits include contributions to retirement benefit scheme, medical allowance and other fringe benefits. In addition, the Group maintains the share award scheme for the purpose of providing incentives and rewards to eligible participants based on their contributions.

The eligibility of any of the above classes of participants to the grant of any option shall be determined by the Board from time to time and on a case-by-case basis, subject to the Board's opinion as to, among others, their contribution or potential contribution to the development and growth of the Group or invested entity.

3. TOTAL NUMBER OF SHARES AVAILABLE FOR ISSUE UNDER THE 2021 SHARE OPTION SCHEME AND THE PERCENTAGE OF THE ISSUED SHARES THAT IT REPRESENTS AS AT THE DATE OF THIS ANNUAL REPORT

As approved by the Shareholders at the annual general meeting of the Company held on 2 September 2021 (the "2021 AGM"), the scheme limit of the 2021 Share Option Scheme permits the Company to grant share options for up to 91,530,788 Shares, representing (i) 10% of the total number of Shares in issue as at the date of the 2021 AGM; and (ii) 0.89% of the total number of Shares in issue as at the date of this annual report.

4. MAXIMUM ENTITLEMENT OF EACH PARTICIPANT

Unless approved by the Shareholders, the total number of Shares issued and to be issued upon exercise of the share options granted to any grantee (including both exercised and outstanding share options) in any 12-month period up to the date of grant shall not exceed 1% of the Shares then in issue.

Where any grant of share options to a substantial shareholder of the Company or an independent non-executive Director, or any of their respective associates, would result in the Shares issued and to be issued upon exercise of all share options already granted and to be granted (including options exercised, cancelled and outstanding) to such person in the 12-month period exceed 0.1% of the Shares then in issue and with an aggregate value in excess of HK\$5 million, the proposed grant shall be approved by the Shareholders.

During the extraordinary general meeting of the Company convened and held on 29 May 2024, the Shareholders resolved to terminate the 2021 Share Option Scheme, upon which no further share options may be granted but the provisions of the 2021 Share Option Scheme will remain in force and effect to the extent necessary to give effect to the exercise of any share option granted prior to its termination or otherwise as may be required in accordance with the provisions of the 2021 Share Option Scheme. Accordingly, the share options granted under the 2021 Share Option Scheme prior to the termination shall continue to be valid and exercisable in accordance with the rules of the 2021 Share Option Scheme.

11. 終止二零二一年購股權計劃

股東已於二零二四年五月二十九日召開及舉行之本公司股東特別大會上決議終止二零二一年購股權計劃，據此不得進一步授出購股權，惟為使於終止前授出的任何購股權可有效行使或根據二零二一年購股權計劃的條文規定可能需要的情況下，二零二一年購股權計劃的條文將仍具有效力及作用。因此，於終止前根據二零二一年購股權計劃授出的購股權將繼續有效，並可根據二零二一年購股權計劃的規則行使。

SHARE AWARD SCHEME

The Shareholders resolved to adopt the share award scheme of the Company (the “**Share Award Scheme**”) during the extraordinary general meeting convened and held on 29 May 2024. A summary of the Share Award Scheme is set out below:

1. PURPOSE OF THE SHARE AWARD SCHEME

The purpose of the Share Award Scheme is to recognise and acknowledge the contributions which the eligible participants of the Share Award Scheme (the “**Eligible Participants**”) have made or may make to the Group, with the view to achieving the following principal objectives: (i) to provide the Company with a flexible means of remunerating, incentivising, retaining, rewarding, compensating and/or providing benefits to the Eligible Participants; (ii) to align the interests of the Eligible Participants with those of the Company and Shareholders by providing such Eligible Participants with the opportunity to acquire proprietary interests in the Company and becoming Shareholders, so as to optimise their performance and efficiency for the benefit of the Group and particular in its fulfilment of strategic targets; (iii) to encourage the Eligible Participants to contribute to the long-term growth, performance and profitability of the Company and to enhance the value of the Company and its Shares for the benefit of the Company and Shareholders as a whole; and (iv) attracting and retaining or otherwise maintaining ongoing business relationships with the Eligible Participants whose contributions are, or, will or are expected to be, beneficial to the Group.

股份獎勵計劃

股東於二零二四年五月二十九日召開及舉行之股東特別大會上決議批准採納本公司股份獎勵計劃(「**股份獎勵計劃**」)。股份獎勵計劃之概要載列如下：

1. 股份獎勵計劃目的

股份獎勵計劃旨在表彰及認可股份獎勵計劃之合資格參與者(「**合資格參與者**」)對本集團已作出或可能作出的貢獻，以達致下列主要目的：(i) 為本公司提供靈活的方式，以便向合資格參與者提供報酬、激勵、挽留、獎勵、補償及／或福利；(ii) 通過向合資參與者提供獲得本公司所有權權益及成為股東的機會，使彼等的利益與本公司及股東的利益一致，從而激勵彼等盡力為本集團利益而提升表現及效率，特別是在實現本集團戰略目標方面；(iii) 鼓勵合資格參與者為本公司的長期增長、表現及盈利能力作出貢獻，並為本公司及股東的整體利益提高本公司及其股份的價值；及(iv) 吸引及挽留對本集團作出積極貢獻或將會或預期對本集團有積極貢獻的合資格參與者，或以其他方式與彼等維持持續業務關係。

2. PARTICIPANTS OF THE SHARE AWARD SCHEME

The Eligible Participants shall comprise: (i) any employee of the Company, Director (including independent non-executive Directors) or officer of the Company or any of its subsidiaries (including persons who are granted Share Award under the Share Award Scheme as an inducement to enter into employment contracts with the respective company of the Group (each such person being an “**Employee Participant**”); (ii) any employee, director or officer of the Affiliate (each such person being a “**Related Entity Participant**”); and (iii) any service providers whom the Board or the committee of the Board (the “**Committee**”), in its sole discretion, determines that have contributed or will contribute to the Group (each such person being a “**Service Provider Participant**”).

3. TOTAL NUMBER OF SHARES AVAILABLE FOR ISSUE UNDER THE SHARE AWARD SCHEME

The total number of Shares which may be issued pursuant to the Share Award Scheme is 541,093,796 Shares, representing (i) approximately 8.55% of the entire issued share capital (excluding treasury shares) as at the date of the extraordinary general meeting of the Company convened and held on 29 May 2024; and (ii) approximately 5.25% of the entire issued share capital (excluding treasury shares) as at the date of this annual report.

The total number of Shares which may be issued pursuant to award of Shares (the “**Share Awards**”) granted to Service Provider Participants is 63,262,458 Shares, being not more than 1% of the entire issued share capital (excluding treasury shares) as at the date of this annual report.

2. 股份獎勵計劃參與者

3. 股份獎勵計劃下可發行的股份總數

根據股份獎勵計劃可發行的股份總數為541,093,796股，佔(i)於本公司於二零二四年五月二十九日召開及舉行的股東特別大會日期全部已發行股本（不包括庫存股）的約8.55%；及(ii)於本年報日期全部已發行股本（不包括庫存股）的約5.25%。

根據授予服務提供商參與者的股份獎勵（「**股份獎勵**」）可發行的股份總數為63,262,458股，即不超過於本年報日期全部已發行股本（不包括庫存股）的1%。

4. MAXIMUM ENTITLEMENT OF EACH PARTICIPANT UNDER THE SHARE AWARD SCHEME

The total number of Shares issued and to be issued in respect of all options and awards (including Share Awards granted to each Eligible Participant pursuant to the Share Award Scheme, excluding any options and Share Awards lapsed in accordance with the terms of the Share Award Scheme) in any 12-month period up to and including the date of such grant shall not in aggregate exceed 1% of the entire issued share capital (excluding treasury shares) at the relevant time unless approved by the Shareholders (the "Individual Limit").

Pursuant to Rule 17.04(1) of the Listing Rules, any grant of Share Award to any Director, chief executive or substantial shareholder of the Company, or any of their respective associates under the Share Award Scheme or any other share schemes of the Company or any of its subsidiaries shall be subject to the prior approval of the independent non-executive Directors of the Company (excluding any independent non-executive Director who or whose associate is the grantee of the Share Award), or if required by the Listing Rules, the Remuneration Committee.

Pursuant to Rule 17.04(2) of the Listing Rules, Shareholders' approval is required at a general meeting where any grant of Awarded Shares to a Director (other than an independent non-executive Director) or chief executive of the Company, or any of his/her associates that would result in the Shares issued and to be issued in respect of the Share Award granted to such person under the Share Award Scheme and all other share schemes (excluding any Share Award lapsed in accordance with the terms of the Share Award Scheme) in any 12-month period up to and including the date of such grant, representing in aggregate over 0.1% of the issued share capital of the Company (excluding treasury shares).

Pursuant to Rule 17.04(3) of the Listing Rules, Shareholders' approval is required at a general meeting where any grant of Awarded Shares to an independent non-executive Director or a substantial shareholder of the Company, or any of his/her/its associates that would result in the Shares issued and to be issued in respect of all options and Share Award granted to such person under the Share Award Scheme and all other share schemes (excluding any options and Share Award lapsed in accordance with the terms of the Share Award Scheme) in any 12-month period up to and including the date of such grant, representing in aggregate over 0.1% of the issued share capital of the Company (excluding treasury shares).

5. GRANT AND ACCEPTANCE OF SHARE AWARD

The Board or the Remuneration Committee may determine in its absolute discretion and on a case-by-case basis and specify in a letter to the grantee in respect of the grant of Share Award (the **"Award Letter"**), inter alia, (i) the amount payable on acceptance of the Share Award; and (ii) the period within which any such payments must be made, being the issue price for the Share Award.

Unless otherwise specified in the Award Letter, the grantee shall have ten business days from the date of grant to accept the Share Award by giving written notice of their acceptance to the Company, together with remittance in favour of the Company of any consideration payable upon grant of the Share Award. To the extent that a Share Award is not accepted within the time specified in the Award Letter or pursuant to the Scheme Rules (as defined below), it shall be deemed to have been irrevocably declined and shall automatically lapse.

5. 授出及接納股份獎勵

Subject to the satisfaction of all vesting conditions applicable to each grantee of Share Awards (the “**Grantee**”), the Awarded Shares held by the trustee appointed by the Company for the administration of the Share Award Scheme (the “**Trustee**”) on behalf of such Grantee shall vest in such Grantee in accordance with the applicable vesting schedule as set out in the Award Letter to the Grantee, and the Trustee shall cause the Awarded Shares to be transferred to such Grantee in accordance with the rules of the Share Award Scheme (the “**Scheme Rules**”).

The Share Award granted under the Share Award Scheme shall be held for not less than 12 months before being vested on the Eligible Participant save and except to certain exceptional circumstances in accordance with Scheme Rules. The Board believes that this aligns with the Listing Rules and purpose of the Share Award Scheme.

7. AMOUNT PAYABLE ON ACCEPTANCE OF THE SHARE AWARDS AND THE PERIOD WITHIN WHICH PAYMENTS SHALL BE MADE

A nominal amount of HK\$1.00 is payable on application or acceptance of the Share Awards, which is payable within ten (10) Business Days upon grant of the Share Awards.

6. 股份獎勵計劃下授出獎勵的歸屬期

待適用於各股份獎勵承授人(「**承授人**」)的所有歸屬條件達成後,本公司就管理股份獎勵計劃委任的受託人(「**受託人**」)代表該承授人持有的獎勵股份將根據承授人的獎勵函所載的適用歸屬時間表歸屬予該承授人,而受託人應根據股份獎勵計劃的規則(「**計劃規則**」)安排將獎勵股份轉讓予該承授人。

根據股份獎勵計劃授出的股份獎勵須持有不少於12個月,方可歸屬予合資格參與者,惟根據計劃規則規定的若干特殊情況除外。董事會認為,此舉符合上市規則及股份獎勵計劃的目的。

7. 接納股份獎勵須繳付之金額及須繳付之期限

申請或接納股份獎勵時須繳付1.00港元的象徵性金額,該款項須於授出股份獎勵後的十(10)個營業日內繳付。

8. BASIS OF DETERMINING THE AMOUNT PAYABLE ON ACCEPTANCE OF THE SHARE AWARDS

Given that only a nominal value is payable, the basis of determining such amount on application or for the acceptance of the Share Award is not applicable. The Awarded Shares shall be issued and allotted at par value to the Trustee under the terms of the Share Award Scheme by utilising the funds allocated by the Board out of the Company's resources.

9. REMAINING LIFE OF THE SHARE AWARD SCHEME

Subject to early termination, the Share Award Scheme shall be valid and effective for a period of 10 years (the "**Scheme Period**") commencing on its adoption date of 3 June 2024. After the Scheme Period, no further Share Awards may be granted, but the Scheme Rules shall remain in full force and effect to the extent necessary to give effect to any Share Award made before the expiry of such period. Share Awards granted during the Scheme Period, but which remain outstanding and have not lapsed as at the expiry of the Scheme Period, shall continue to be valid in accordance with their terms of grant notwithstanding the expiry of the Scheme Period.

9. 股份獎勵計劃的剩餘期限

The Company's commitment to the highest standards of corporate governance is driven by the Board which, led by the Chairlady, assumes overall responsibility for the governance of the Company, taking into account the interests of the Shareholders, the development of its businesses and the changing external environment.

The Company believes that good corporate governance is fundamental to ensuring that the Company is well managed in the interests of all of its Shareholders.

The Company has adopted the code provisions of the Corporate Governance Code (the “**CG Code**”) as set out in Appendix C1 to the Listing Rules.

No incident of non-compliance of such policy by the employees was noted by the Company during the year ended 31 March 2026.

The Board takes the responsibility to oversee internal controls and risk management systems and to review the effectiveness of such systems, monitoring the performance of the senior management and determining the policy for corporate governance. The Board also gives clear directions as to the powers delegated to the senior management for the day-to-day operation, business strategies and administrative functions of the Group.

The Company has received from each of its independent non-executive Directors an annual confirmation of independence as required under Rule 3.13 of the Listing Rules. The Company considers that all independent non-executive Directors are independent.

The biographical details of all existing Directors are set out in the section headed "BIOGRAPHICAL DETAILS OF DIRECTORS AND SENIOR MANAGEMENT" of this annual report. Save as disclosed in that section, none of the Directors has any relationship (including financial, business, family or other material/relevant relationship(s)) with other Board members.

OPERATION OF THE BOARD

The Board is provided with relevant information concerning matters to be brought for its decision. Regular board meetings are held at approximately quarterly intervals and at least 14 days' notice will be given to the Directors before each board meeting is held. Board papers are dispatched to the Directors at least 3 days prior to the meetings.

Directors have to declare their interests before the meetings in accordance with the Articles of Association. Directors who are considered to have a conflict of interest or material interests in the proposed transactions or issues to be discussed will not be counted towards the quorum of the meeting and are required to abstain from voting on the relevant resolutions.

The Company maintains the minutes of the board meetings for inspection by Directors.

There is a clear division of responsibilities between the Board and the Executive Committee of the Group (the "**Executive Committee**"). Decisions on important matters are reserved to the Board, while decisions on the Group's general operations are delegated to the Executive Committee. Important matters include, but are not limited to, major acquisitions and disposals, connected transactions, annual budgets, approval of annual and interim results, other significant operational and financial matters and those affecting the Group's strategic policies.

董事會之運作

董事會獲提供將提呈董事會決議之事宜之相關資料。定期董事會會議大約每季度舉行一次，而董事於各董事會會議召開前至少十四日獲發會議通知。董事會會議文件則於會議舉行前最少三日發送予董事。

董事須按照章程細則於會議前申報利益。被認為於建議交易或將予討論之事宜中存在利益衝突或擁有重大權益之董事，將不被計入會議法定人數，並須就相關決議案放棄投票。

本公司備存董事會會議之會議紀錄以供董事查閱。

董事會與本集團執行委員會（「**執行委員會**」）之間之職責有清晰劃分。重要事宜留待董事會決策，而本集團一般營運則由執行委員會決定。重要事項包括但不限於重大收購及出售、關連交易、年度預算、審批年度及中期業績、其他重大之營運及財務事宜以及影響本集團之策略性政策之事宜。

RESPONSIBILITIES, ACCOUNTABILITIES AND CONTRIBUTIONS OF THE BOARD AND MANAGEMENT

The Board should assume responsibility for leadership and control of the Company and is collectively responsible for promoting the success of the Company by directing and supervising its affairs.

The Board directly, and indirectly through its committees, leads and provides direction to the management by laying down strategies and overseeing their implementation, monitors the Group's operational and financial performance, and ensures that sound internal control and risk management systems are in place.

All Directors, including independent non-executive Directors, have brought a wide spectrum of valuable business experience, knowledge and professionalism to the Board for its efficient and effective functioning. The independent non-executive Directors are responsible for ensuring a high standard of regulatory reporting of the Company and providing a balance in the Board for bringing effective independent judgement on corporate actions and operations. Independent non-executive Directors are invited to serve on the Audit Committee, the Remuneration Committee and the Nomination Committee.

All Directors have full and timely access to all the information of the Company and may, upon request, seek independent professional advice in appropriate circumstances, at the Company's expenses for discharging their duties to the Company.

According to the code provision under the CG Code requiring directors to disclose the number and nature of offices held in public companies or organisations and other significant commitments as well as their identity and the time involved to the Company, the Directors update the Company regarding offices held in public companies and organisations, and other significant commitments on a regular basis.

The Board reserves for its decisions on all major matters relating to the approval and monitoring of policy matters, overall strategies and budgets, internal control and risk management systems, material transactions (in particular those that may involve a conflict of interest), financial information, appointment of directors and other significant financial and operational matters of the Company. Responsibilities relating to implementing decisions of the Board, directing and coordinating the daily operations and management of the Company are delegated to the management.

董事會及管理層之職責、問責情況及貢獻

所有董事（包括獨立非執行董事）為董事會高效及有效運作提供了廣泛而寶貴之業務經驗、知識及專長。獨立非執行董事負責確保本公司監管報告之高標準，並於董事會中提供平衡，以就企業行動及營運提供有效的獨立判斷。獨立非執行董事獲邀加入審核委員會、薪酬委員會及提名委員會。

所有董事均可全面且及時查閱本公司之所有資料，並可於適當情況下要求尋求獨立專業意見以履行彼等對本公司之職責，費用由本公司承擔。

根據企業管治守則項下規定董事須向本公司披露彼等於公眾公司或組織擔任之職位數目及性質與其他重大承擔，以及彼等之身份及所涉及之時間之守則條文，董事定期就彼等於公眾公司或組織擔任之職位及其他重大承擔向本公司提供最新資料。

董事會對本公司所有重要事項保留決策權，其涉及批准及監察政策事項、整體策略及預算、內部監控及風險管理系統、重大交易（特別是可能涉及利益衝突之交易）、財務資料、董事委任及本公司之其他重要財務及營運事項。有關執行董事會之決策、指導及協調本公司日常營運及管理之職責則授權管理層處理。

DIRECTOR INDUCTION AND CONTINUOUS PROFESSIONAL DEVELOPMENT**董事入職培訓及持續專業發展**

Newly appointed Directors are provided with briefings and orientation on their legal and other responsibilities as a Director and the role of the Board.

Dr. Liang Jinxiang (appointed on 14 August 2025) had confirmed that, on 13 August 2025, he obtained legal advice from a firm of solicitors qualified to advise on Hong Kong law as regards the requirements under the Listing Rules that are applicable to him as a director of a listed issuer and the possible consequences of making a false declaration or giving false information to the Stock Exchange and he understood his obligations as a director of a listed issuer pursuant to Rule 3.09D of the Listing Rules.

During the year ended 31 March 2026, the Company provided training on updates to legal and regulatory regime to the Directors on 28 November 2025, covering the topics of (i) directors' general duties; (ii) information disclosure; (iii) notifiable transactions; (iv) connected transactions; (v) directors' dealings in securities; and (vi) disclosure of interests. Besides, individual Directors who had participated in other continuous professional training organised by professional bodies and/or government authorities also provided the Company with their records of continuous professional development. Such training records were kept by the Company.

CHAIRMAN/CHAIRLADY AND CHIEF EXECUTIVE OFFICER

Code Provision C.2.1 of the CG Code states that the roles of chairman and chief executive should be separate and should not be performed by the same individual. Prior to 28 October 2025, the position of the Chairman is held by Mr. CHAN Kin Sang. Mr. CHAN resigned as an independent non-executive Director and the Chairman due to his decision to retire, and Ms. SUN Qing was appointed as the Chairlady with effect from 28 October 2025. The role of the Chief Executive Officer of the Company was performed jointly by Mr. YUAN Tianfu and Mr. ZHANG Huachen during the Reporting Year, while it has been performed solely by Mr. YUAN Tianfu since 27 April 2026.

主席及首席執行官

企業管治守則之守則條文第C.2.1條訂明，主席與行政總裁的角色應有區分，並不應由一人同時兼任。於二零二五年十月二十八日前，主席一職由陳健生先生擔任。陳先生因決定退任而辭任獨立非執行董事及主席，及孫青女士已獲委任為主席，自二零二五年十月二十八日起生效。於本報告年度內，本公司首席執行官的角色由袁天夫先生及張華晨先生共同承擔，而自二零二六年四月二十七日起由袁天夫先生獨自承擔。

The Chairman/Chairlady is responsible for taking the lead in formulating the overall strategies and policies of the Group. He/she ensures that the Board functions effectively and all material issues of the Company are discussed in a timely manner. The Chairman/Chairlady also leads the Board to establish good corporate governance policies and procedures for the Group as a whole.

REMUNERATION COMMITTEE

The Remuneration Committee was established in October 2005. It currently comprises three independent non-executive Directors, namely Mr. CHIU Kung Chik (chairman of the Remuneration Committee), Dr. LIANG Jinxiang and Ms. LUI Mei Ka, and one executive Director, namely Ms. SUN Qing. The terms of reference of the Remuneration Committee were revised on 29 November 2023 and are aligned with the provisions set out in the CG Code. The main duties of the Remuneration Committee are as follows:

- (a) to make recommendations to the Board on the Company's policy and structure for all Directors and senior management's remuneration and on the establishment of a formal and transparent procedure for developing remuneration policy;
- (b) to review and approve the management's remuneration proposals with reference to the Board's corporate goals and objectives;
- (c) to make recommendations to the Board on the remuneration packages of individual executive Directors and senior management. This should include benefits in kind, pension rights and compensation payments, including any compensation payable for loss or termination of their office or appointment;
- (d) to make recommendations to the Board on the remuneration of non-executive Directors;
- (e) to consider salaries paid by comparable companies, time commitment and responsibilities and employment conditions elsewhere in the Group;

Remuneration of Directors and senior management is recommended by the Remuneration Committee and approved by the Board with reference to their qualifications, experience, duties and responsibilities within the Company and the prevailing market conditions.

董事及高級管理人員之薪酬由薪酬委員會經參考彼等各自之資歷、經驗、於本公司之職責及責任以及現行市況提出建議，並由董事會批准。

NOMINATION COMMITTEE

The Nomination Committee was established in December 2007. It currently comprises one executive Director, namely Ms. SUN Qing (chairlady of the Nomination Committee), and three independent non-executive Directors, namely Dr. LIANG Jinxiang, Mr. CHIU Kung Chik and Ms. LUI Mei Ka. The terms of reference of the Nomination Committee were revised on 29 February 2012 and are aligned with the provisions set out in the CG Code.

The main duties of the Nomination Committee are as follows:

- (a) to review the structure, size and composition (including the skills, knowledge and experience) of the Board at least annually, assist the Board in maintaining a board skills matrix, and make recommendations on any proposed changes to the Board to complement the Company's corporate strategy;
- (b) to identify individuals suitably qualified to become members of the Board and may select individuals nominated for directorship;
- (c) to assess the independence of the independent non-executive Directors;
- (d) to make recommendations to the Board on the appointment or re-appointment of Directors and succession planning for Directors, in particular the chairman and the chief executive; and
- (e) to support the Company's regular evaluation of the Board's performance.

The Nomination Committee identifies and nominates qualified individuals to the Board for consideration. All newly appointed Directors are subject to re-election by the Shareholders at the AGM or at the next following general meeting of the Company immediately following their appointments pursuant to the Articles of Association. In considering the new appointments or re-nomination of Directors, the Nomination Committee will base its decisions on attributes such as integrity, industry experience and professional and technical skills together with the ability to devote sufficient time and capacity to carry out their duties effectively and responsibly.

提名委員會之主要職責如下:

- (a) 至少每年檢討董事會的架構、人數及組成(包括技能、知識及經驗),協助董事會維持董事會才識組合並向董事會就配合本公司的公司策略而擬作出的變動提出建議;
- (b) 物色具備合適資格可擔任董事的人士,並挑選被提名人士出任董事;
- (c) 評核獨立非執行董事的獨立性;
- (d) 就董事委任或重新委任以及董事(尤其是主席及行政總裁)繼任計劃向董事會提出建議;及
- (e) 支持本公司定期評估董事會表現。

提名委員會物色及提名合資格人士供董事會作考慮。所有新獲委任之董事均須根據章程細則於股東週年大會或於緊隨其獲委任後之本公司下次股東大會上經股東重選。於考慮新委任或重新提名董事時,提名委員會乃根據誠信、行業經驗、專業與技術技能等屬性,連同投入足夠時間及精力以有效及盡責地履行其職責的能力,作出決定。

During the year ended 31 March 2026, the Nomination Committee held three meetings to discuss and deal with the following major matters:

- to review the structure, size and composition of the Board;
- to review and assess the independence of the independent non-executive Directors;
- to discuss the list of Directors who are subject to retirement by rotation at the annual general meeting of the Company and make recommendations to the Board on their re-election as Directors;
- to review the effectiveness of the terms of reference of the Nomination Committee;
- to consider the changes of Directors, senior management and Board committee members and make recommendations to the Board thereon; and
- to review the implementation and effectiveness of the Board Diversity Policy of the Company for 2025–2026, and set the gender diversity objectives at the Board level and the Group-wide employee level.

NOMINATION POLICY

A nomination policy was adopted by the Company in November 2018 (the “**Nomination Policy**”) which sets out the selection criteria and nomination procedures in identifying and recommending candidates as Directors for the Board’s consideration. In assessing the suitability of a proposed candidate for directorship, the Nomination Committee will take into account (i) the Company’s actual needs, (ii) the candidate’s skills and professional experience that are complementary to the other members of the Board, and (iii) the diversity of the Board, including but not limited to gender, age, cultural and educational background, etc.

The Nomination Committee will review the Nomination Policy from time to time and discuss any revisions required, and will recommend such revisions to the Board for consideration and approval.

BOARD DIVERSITY POLICY

The Company recognizes and embraces the benefits of diversity of its Board members. It had adopted a Board Diversity Policy (the “Policy”) in August 2013. All Board appointments will be based on meritocracy and competence. The ultimate decision will be based on merits and contributions that the selected candidates will bring to the Board.

In order to achieve a diversity of perspectives amongst the structure, size and composition of the Board, when making the recommendations to the Board for appointment or re-appointment of Directors, the Nomination Committee will take into account certain objective criteria such as gender, age, cultural and educational background, ethnicity, professional experience, skills and knowledge, and length of service, etc. Besides, it will also take into account factors based on the Company’s business model and specific needs from time to time.

In addition, the Policy is reviewed annually to ensure its effectiveness. The Nomination Committee will discuss any revisions that may be required, and recommend any such revisions to the Board for consideration and approval.

The Board is composed of members of different genders to maintain an appropriate balance of diversity. All appointments of Directors will be considered against measurable objectives for the benefits of diversity on the Board with a view to developing a pipeline of potential successors to the Board to maintain gender diversity. For the year ended 31 March 2026, the proportion of male and female members of the Board was approximately 66.7% and 33.3% respectively, achieving gender diversity on the Board. The Company’s current goal is to maintain the proportion of female members on the Board at the current level at least and will strive to increase the proportion of female directors to achieve an appropriate balance of gender diversity.

As at 31 March 2026, the proportion of male and female in the workforce of the Company was approximately 52.33% and 47.67% respectively. The Company will also ensure that there is gender diversity when recruiting staff at mid to senior level and provide such staff with more appropriate on-the-job training so that the Company will have a pipeline of female senior management and potential successors to the Board in the near future.

董事會成員多元化政策

本公司認同並深信董事會成員多元化對本公司裨益良多。本公司於二零一三年八月採納董事會成員多元化政策（「該政策」）。董事會所有委任均以用人唯才為原則，並將按選定候選人之長處及可為董事會帶來之貢獻而作最終決定。

為使董事會在架構、人數及組成方面更多元化，提名委員會就委任或重新委任董事而向董事會提出建議時，將會考慮多個客觀因素，包括性別、年齡、文化及教育背景、種族、專業經驗、技能、知識及服務年資等。此外，委員會亦會不時根據本公司的商業模式及特殊需要等作考慮。

此外，該政策每年進行檢討，以確保其行之有效。提名委員會將會討論任何或需作出之修訂，並向董事會提出修訂建議供其考慮及審批。

董事會由不同性別的成員組成，維持適當的多元化平衡。董事的所有委任將考慮有關董事會多元化裨益的可計量目標，旨在培養潛在的董事會繼任者以維持性別多元化。於截至二零二六年三月三十一日止年度，董事會男性及女性成員的比例分別約為66.7%及33.3%，就董事會而言已達致性別多元化。本公司目前的目標是將董事會女性代表的佔比至少維持在現有水平，並將致力提升女性比例以實現性別多元化的適當平衡。

於二零二六年三月三十一日，本公司僱員中男性及女性員工的比例分別約為52.33%及47.67%。本公司亦將確保於中高級員工招聘中促進性別多元化，並為他們提供更合適的在職培訓，從而於不久將來建立女性高級管理人員及董事會潛在繼任者的人才儲備。

BOARD INDEPENDENCE EVALUATION

The Company has established a Board Independence Evaluation Mechanism which sets out the processes and procedures to ensure a strong independent element on the Board, which allows the Board effectively exercises independent judgment to better safeguard Shareholders' interests.

The objectives of the evaluation are to improve Board effectiveness, maximise strengths, and identify the areas that need improvement or further development. The evaluation process also clarifies what actions the Company needs to take to maintain and improve the Board's performance, for instance, addressing individual training and development needs of each Director.

Pursuant to the Board Independence Evaluation Mechanism, the Board will conduct annual review on its independence. The Board Independence Evaluation Report will be presented to the Board which will collectively discuss the results and the action plan for improvement, if appropriate.

During the year ended 31 March 2026, the Board reviewed the implementation and effectiveness of the Board Independence Evaluation Mechanism and the results were satisfactory.

AUDIT COMMITTEE

The Audit Committee was established in April 2001 and currently comprises three independent non-executive Directors, namely Mr. CHIU Kung Chik (chairman of the Audit Committee), Dr. LIANG Jinxiang and Ms. LUI Mei Ka. The terms of reference of the Audit Committee were revised on 30 December 2015 and are aligned with the provisions set out in the CG Code. The main duties of the Audit Committee are as follows:

Relationship with the Company's auditor

- (a) to be primarily responsible for making recommendations to the Board on the appointment, re-appointment and removal of the external auditor, and to approve the remuneration and terms of engagement of the external auditor, and any questions of its resignation or dismissal;

In March 2012, the Board has established a Shareholders communication policy and a Shareholders’ guide is in place to ensure that Shareholders are provided with ready, equal and timely access to balanced and understandable information about the Group. The policy is uploaded on the Company’s website and has been regularly reviewed during the year to ensure its effectiveness.

The Company’s website has become the primary platform of communication between the Company and the Shareholders. The investor relations section of the website is kept under regular review by the Company to ensure that information related to Shareholders is disseminated in an accurate and timely manner. During the year ended 31 March 2026, the Company convened one annual general meeting and three extraordinary general meetings. Members of the Board and Board committees also attended the general meetings of the Company to answer relevant questions raised at the meetings. Separate resolutions were proposed at general meetings for any significant separate issues.

股東權利

PROPOSING A CANDIDATE FOR ELECTION AS A DIRECTOR AT THE GENERAL MEETINGS OF THE COMPANY

Pursuant to Article 120 of the Articles of Association, no person, other than a retiring Director, shall, unless recommended by the Board for election, be eligible for election to the office of Director at any general meeting, unless notice in writing of the intention to propose that person for election as a Director, signed by a Shareholder (other than the person to be proposed for election as a Director) duly qualified to attend and vote at the meeting for which such notice is given, and a notice in writing signed by that person of his willingness to be elected shall have been lodged at the registration office. The minimum length of the period during which such notices are given shall be at least seven days, commencing no earlier than the day after the dispatch of the notice of the general meeting appointed for such election and ending no later than seven days prior to the date of such general meeting.

To include a resolution relating to other matters in a general meeting, Shareholders are requested to follow the requirements and procedures as set out in section 615 of the Companies Ordinance (Chapter 622 of the laws of Hong Kong). The relevant Shareholders' Guide has also been published on the Company's website.

General meetings shall also be convened on the written requisition of any two or more members of the Company deposited at the principal office of the Company in Hong Kong or, in the event the Company ceases to have such a principal office, the registered office specifying the objects of the meeting and signed by the requisitionists, provided that such requisitionists held as at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company which carries the right of voting at general meetings of the Company. General meetings may also be convened on the written requisition of any one member of the Company which is a recognised clearing house (or its nominee) deposited at the principal office of the Company in Hong Kong or, in the event the Company ceases to have such a principal office, the registered office specifying the objects of the meeting and signed by the requisitionist, provided that such requisitionist held as at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company which carries the right of voting at general meetings of the Company.

If the Board does not within 21 days from the date of deposit of the requisition proceed duly to convene the meeting, the requisitionist(s) themselves or any of them representing more than one-half of the total voting rights of all of them, may convene the general meeting in the same manner, as nearly as possible, as that in which meetings may be convened by the Board provided that any meeting so convened shall not be held after the expiration of three months from the date of deposit of the requisition, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to them by the Company.

DIVIDEND POLICY

A dividend policy was adopted by the Company in November 2018 (the “**Dividend Policy**”) which sets out the guideline for distribution of dividends to the Shareholders. The Dividend Policy aims to strike a balance between the Shareholders' interests and the Company's capital requirement for business operation and development needs. The recommendation of the payment of any dividend is subject to the absolute discretion of the Board, and any declaration of final dividend will be subject to the approval by the Shareholders at the annual general meeting.

In proposing any dividend payout, the Board will take into account, inter alia, the Group's financial results and liquidity, its business strategies and development plans, as well as other factors that the Board may consider appropriate.

The Board will review the Dividend Policy from time to time and may exercise its sole and absolute discretion to update, amend and/or modify the Dividend Policy at any time as it deems fit and necessary.

RISK MANAGEMENT AND INTERNAL CONTROL

風險管理及內部監控

The Company has an internal audit function. Board acknowledges its responsibility for establishing and maintaining sound and effective risk management and internal control systems, and for determining the nature and extent of risk it is willing to take in pursuing business objectives of the Group. Yet, such risk management and internal control systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable but not absolute assurance against material misstatement or loss.

本公司設有內部審核職能。董事會確認其有責任設立及維持健全及有效的風險管理及內部監控系統，及釐定本集團達致業務目標時所願意承受的風險性質及程度。然而，該等風險管理及內部監控系統旨在管理而非消除未能達成業務目標的風險，並僅可就不會有重大失實陳述或損失作出合理而非絕對的保證。

The Company has a risk management policy in place to formalize the procedures in identifying, evaluating and monitoring the risks which may be encountered by the Group in the course of business. By tackling the risks in a systematic way, the Board believes that the same can be minimized or under control at a reasonable level.

本公司已制定一套風險管理政策，以規範識別、評估及監控本集團在業務過程中可能遇到的風險的程序。透過系統性方法處理風險，董事會相信該等風險可降至最低或控制在合理水平。

The process used to identify, evaluate and manage significant risks are as follows:

1. each business unit/department identifies the risks that encountered or may be encountered by them in the course of business/operation;
2. business units/departments compile a list of risks which contains the following information for every single risk identified by them: (a) risk classification; (b) contents of risk; (c) measures taken; (d) risk ranking; and (e) recommendations to deal with such risk, and email this list to the Executive Committee and the Compliance and Risk Management Department (the “**CRM Department**”) for review and assessment;
3. the Executive Committee and the CRM Department discuss, assess and determine whether further action is required to be taken against the identified risks or whether such risks should be reported to the Board;
4. if reporting to the Board is required, the Company Secretary will send the materials to the Board for discussion and revert the Board’s decision to the relevant business unit/department for action/follow up.

Besides, internal control measures and/or procedures have also been designed and implemented for safeguarding the Group's assets against unauthorized use or disposal, maintaining proper accounting records, and monitoring the compliance with the applicable laws, rules and regulations.

The Company has a CRM Department to monitor the overall risk management and compliance issues of the Group on an on-going basis. Quarterly reports on compliance, risk management and internal control issues of the Group will be prepared by the CRM Department and tabled before the regular Audit Committee and Board meetings for review and discussion. The Company also approved the establishment of the Investment Decision and Risk Management Committee on 28 April 2023 and the adoption of the Measures and Procedures for Investment Decision and Risk Management. The Investment Decision and Risk Management Committee is specifically responsible for investment decision-making and risk management matters under the guidance of the Executive Committee. The Investment Decision and Risk Management Committee meets regularly or when necessary to consider matters relating to risk management and make decisions. Modifications and improvements on the existing risk management and internal control policies will be carried out from time to time as required.

The CRM Department carries out reviews of the risk management and internal control systems of the Group or specific business segments of the Group, having regard to specific corporate and fundraising exercises that have taken place and the applicable regulatory and independence requirements on an annual basis. The Company's reviews have not revealed systemic deficiencies of medium risk or above. The results of the review were submitted by the CRM Department to the Audit Committee for their consideration. The Board, based on the review of the Audit Committee, confirmed the effectiveness and adequacy of risk management and internal control systems of the Group.

The Audit Committee also considers the adequacy of resources, qualifications and experience of staff of the Group's accounting and financial reporting function, as well as their training programmes and budgets.

Hence, the Board considers that the existing risk management and internal control systems of the Group are effective and adequate to meet its needs in its current business environment.

此外，本公司亦已設計及實施內部監控措施及／或程序，以確保本集團的資產不會在未經授權的情況下被使用或處置，保存適當的會計記錄，以及監控及遵守適用法律、規則及規例。

本公司已設立合規與風險管理部持續監控本集團的整體風險管理及合規事宜。有關本集團合規、風險管理及內部監控事宜的季度報告將由合規與風險管理部編製，並在定期審核委員會及董事會會議上提呈，以供審議及討論。本公司亦於二零二三年四月二十八日批准設立投資決策及風險管理委員會，並通過採納《投資決策及風險管理辦法和議事程序》。投資決策及風險管理委員會在執行委員會指導下具體負責投資決策及風險管理事務。投資決策及風險管理委員會定期或於需要時召開會議審議風險管理相關事宜並做出決策。現有的風險管理及內部監控政策將按需要不時進行修訂及完善。

合規與風險管理部每年檢討本集團或本集團特定業務分部之風險管理及內部監控系統的成效。該等檢討充分顧及所進行的特定企業活動及集資活動以及適用監管規定及獨立性規定。本公司進行的檢討中均未發現中等或以上風險的系統性缺陷。檢討結果已由合規與風險管理部呈遞審核委員會以供其考慮。董事會基於審核委員會之檢討，確認本集團之風險管理及內部監控系統的有效性及充分性。

審核委員會亦考慮本集團在會計及財務匯報職能方面之資源、員工資歷及經驗是否足夠，以及員工所接受之培訓課程及有關預算是否充足。

因此，董事會認為，本集團現有的風險管理及內部監控系統為有效及足夠可滿足其於當前業務環境中的需求。

Notwithstanding the Board's overall confirmation on the effectiveness of the Group's risk management and internal control systems, the Board notes the incident relating to the non-compliance with Chapter 14 of the Listing Rules in connection with the series of Artwork Acquisition Transactions completed during the period from January 2025 to September 2025. The Group has formulated and rolled out a comprehensive set of remedial measures to strengthen pre-transaction compliance assessment, transaction aggregation review, internal reporting workflows and relevant staff training, details of which are set out in the section headed "MAJOR TRANSACTION — ARTWORK ACQUISITION TRANSACTIONS" on pages 46 to 48 of this annual report.

The Board has been monitoring the ongoing implementation progress of these remedial measures, including the operation of the dedicated internal artwork investment review team, enhanced collaboration between finance, company secretarial and legal teams, formation of the transactional compliance team under the Audit Committee, and enhanced reporting obligations for subsidiary departments. To elevate regulatory awareness across the Group, training sessions covering the Listing Rules requirements governing notifiable transactions were delivered to Directors, senior management and relevant personnel of the Company and its subsidiaries in October 2025, January 2026 and May 2026.

The Group will continue to organise quarterly internal training covering Chapter 14 of the Listing Rules, together with ongoing regulatory training for Directors, senior management and all relevant staff including new joiners to deepen their comprehension of Listing Rules obligations. The Group will also conduct periodic reviews to ensure such measures remain robust and effective to prevent recurrence of similar compliance oversights in respect of future investment transactions.

INSIDE INFORMATION DISCLOSURE POLICY

To ensure timely, fair, accurate and complete disclosure of inside information and for compliance with the applicable laws and regulations, an updated policy on handling the inside information has been approved by the Board in August 2017, pursuant to which, the Company has taken a series of procedures to identify and preserve the confidentiality of the price sensitive information and to disclose the same to the public in a timely manner, if required. All staff are also required to observe the code of ethical standards stated in Staff Handbook to keep non-public information confidential.

董事會一直監察該等補救措施的持續實施進度，包括專責內部藝術品投資審閱團隊的運作、加強財務、公司秘書及法律團隊之間的協作、於審核委員會下成立交易合規團隊，以及加強附屬公司部門的報告責任。為提高本集團整體的監管意識，本集團已於二零二五年十月、二零二六年一月及二零二六年五月為本公司及其附屬公司的董事、高級管理層及相關人員舉辦培訓課程，內容涵蓋規管須予公佈的交易的上市規則規定。

本集團將繼續舉辦涵蓋上市規則第14章的季度內部培訓，連同為董事、高級管理層及所有相關員工（包括新入職員工）提供持續的監管培訓，以加深彼等對上市規則責任的理解。本集團亦將進行定期檢討，以確保該等措施維持穩健有效，避免就未來投資交易再次發生類似的合規疏忽。

內幕消息披露政策

The Company continues to pursue a proactive policy of promoting investor relations and communication by maintaining regular meetings with institutional Shareholders, fund managers and analysts through different means including meetings, presentations and correspondence. In an effort to enhance communications with the Shareholders and investors, the Company maintains a website (www.290.com.hk) to disseminate information relating to the latest business developments and all corporate announcements.

The annual general meeting is a valuable forum for the Board to communicate directly with the Shareholders. No less than 21 days' notice in writing will be distributed to all Shareholders prior to the annual general meeting. The circular of the annual general meeting sets out the details of each proposed resolution and other relevant information. Separate resolutions are proposed at the general meetings of the Company on each substantially separate issue, including the election of individual Directors. Shareholders have the opportunity to participate and vote in general meetings and are informed of the rules and voting procedures that govern the general meeting.

The 2025 annual general meeting of the Company was held at Units No. 4102-06, 41/F, COSCO Tower, 183 Queen's Road Central, Hong Kong. All Directors attended the 2025 annual general meeting. The external auditor of the Company, ZHONGHUI ANDA, also attended the 2025 annual general meeting to answer questions raised by the Shareholders.

Having considered the various existing channels of communication and the feedbacks from the Shareholders, investors and analysts, the Board considers that the Shareholders' communication policy has been properly implemented and effective during the year ended 31 March 2026.

OVERVIEW

GoFintech Quantum Innovation Limited (“**GoFintech**” or the “**Company**”, together with its subsidiaries collectively referred to as the “**Group**”) is pleased to present its Environmental, Social and Governance Report (the “**ESG Report**”), which summarised the environmental, social and governance (“**ESG**”) initiatives and accomplishments for the year ended 31 March 2026 (the “**Reporting Year**” or “**2026**”).

Founded in 2002, GoFintech is an investment holding company and its subsidiaries are principally engaged in securities brokerage and margin financing, corporate finance, money lending, asset management, equity investment, investment immigration business, trading and supply chain operations business and investments in artworks. The Group’s operations are located primarily in Hong Kong with offices in Mainland China.

ESG investing has been moving mainstream as climate-related risks reshape the principles of investment decisions. As a significant player in China’s financial market, GoFintech has been vigilant on those trends and the impacts that may assert on its business.

BOARD STATEMENT

The board of directors of the Company (the “**Board**”) is pleased to present the ESG Report of the Group, which reviews the Group’s ESG initiatives, plans, performance, as well as its sustainable development in respect of environmental protection, labour practices, business operations, supply chain management and other ESG issues for the Reporting Year. As a responsible corporation, the Group views ESG commitment as part of its responsibilities and is committed to incorporating ESG considerations into its decision-making process.

概覽

國富量子創辦於二零零二年，為投資控股公司，其附屬公司主要從事證券經紀及孖展融資、企業融資、放債、資產管理、股權投資、投資移民業務、貿易及供應鏈營運業務及藝術品投資。本集團的業務主要位於香港，並於中國內地設有辦事處。

環境、社會及管治投資因氣候相關風險重塑投資決策原則而漸趨主流。作為中國金融市場的重要參與者，國富量子一直對該等趨勢以及可能對其業務造成的影響保持警惕。

董事會聲明

THE ESG GOVERNANCE STRUCTURE

The Group has applied a top-down approach to manage its ESG and climate-related issues, with the Board having overall responsibility for the Group's ESG strategies, reporting, and the oversight and management of these matters. The Board reviews and confirms annually the Group's ESG and climate-related risks and opportunities, performance, progress made against goals and targets, management approaches, strategies, priorities of material ESG issues, and related policies. The Board also ensures the effectiveness of ESG and climate-related risk management and internal control mechanisms. In carrying out these responsibilities, assistance is provided by the Group's designated personnel from the business and functional departments, as well as ESG professionals, ensuring that the Board is equipped with the necessary skills, experience, and knowledge to oversee the Group's ESG strategy.

The Group's designated personnel from the business and functional departments facilitate the Board's oversight of ESG and climate-related issues. They are responsible for managing the Group's ESG and climate-related policies and performance, monitoring ESG and climate-related risks and opportunities, the effectiveness of the ESG management systems, and identifying and prioritising the Group's ESG and climate-related issues. They also propose and recommend to the Board on the Group's ESG and climate-related strategies, priorities, goals and targets, and report the relevant ESG and climate-related matters to the Board annually. More governance practice on ESG and climate-related issues are described in the section headed "Climate-related Disclosure".

環境、社會及管治的治理架構

本集團採用自上而下的方針管理其環境、社會及管治以及氣候相關事宜，董事會對本集團的環境、社會及管治策略、報告以及對該等事宜的監督及管理負有全面責任。董事會每年審閱並確認本集團的環境、社會及管治以及氣候相關風險及機遇、表現、目標及達標的進度、管理方式、策略、重大環境、社會及管治事宜的優先事項及相關政策。董事會亦確保環境、社會及管治以及氣候相關風險管理及內部控制機制的有效性。為履行該等職責，本集團業務及職能部門的指定人員以及環境、社會及管治方面的專業人士會提供協助，確保董事會具備監督本集團環境、社會及管治策略所需的技能、經驗及知識。

本集團業務及職能部門指定人員協助董事會監督環境、社會及管治以及氣候相關事宜。彼等負責管理本集團的環境、社會及管治以及氣候相關政策及表現、監測環境、社會及管治以及氣候相關風險及機遇、環境、社會及管治管理體系的有效性，以及識別本集團環境、社會及管治以及氣候相關事宜並進行優次排序。彼等亦就本集團的環境、社會及管治以及氣候相關策略、優先事宜、目的及目標向董事會提出建議，並每年向董事會報告環境、社會及管治以及氣候相關事宜。有關環境、社會及管治以及氣候相關事宜的更多管治常規於「氣候相關披露」一節中闡述。

REPORTING SCOPE

The reporting scope of this ESG Report is in line with the annual report, covering all the Group's business operations, including subsidiaries in Hong Kong and Mainland China. The Group's business segments include securities brokerage and margin financing, corporate finance, money lending, asset management, equity investment, investment immigration business, trading and supply chain operations business and investments in artworks. The business segments represent all of the Group's revenue for the Reporting Year. To align with the ongoing business expansion, the Group will make efforts to broaden the scope of disclosure when necessary. This will be achieved by enhancing the data collection process across multiple operational locations.

The content including data in preparing this ESG Report is primarily based on the internal policies and documents as well as information provided by various key stakeholders.

REPORTING FRAMEWORK

This ESG Report serves to provide details of the Group's ESG policies and practices of its business in Hong Kong and Mainland China, which has been prepared and compiled in accordance with the Environmental, Social and Governance Reporting Code (the “**ESG Reporting Code**”) set out in the Appendix C2 to the Rules Governing the Listing of Securities (the “**Listing Rule**”) on Main Board of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”).

Information relating to the Group's corporate governance practices is set out in the “Corporate Governance Report” of the annual report.

During preparation of this ESG Report, the Group has applied the following reporting principles of the ESG Reporting Code.

報告範圍

本環境、社會及管治報告的報告範圍與年報一致，涵蓋本集團所有業務營運，包括香港及中國內地的附屬公司。本集團的業務分部包括證券經紀及孖展融資、企業融資、放債、資產管理、股權投資、投資移民業務、貿易及供應鏈運營業務及藝術品投資。該等業務分部涵蓋本集團於本報告年度的全部收入。隨著業務不斷擴張，本集團將在必要時努力擴大披露範圍。這將通過加強多個運營地點的數據收集流程來實現。

本環境、社會及管治報告的內容（包括所用數據）主要基於內部政策及文件，以及各主要持份者提供的資料。

報告框架

本環境、社會及管治報告旨在提供有關本集團於香港及中國內地業務的環境、社會及管治政策及慣例詳情，乃根據香港聯合交易所有限公司（「**聯交所**」）主板證券上市規則（「**上市規則**」）附錄C2所載的《環境、社會及管治報告守則》（「**環境、社會及管治報告守則**」）編製。

有關本集團企業管治常規的資料載於年報「企業管治報告」一節。

於編製本環境、社會及管治報告過程中，本集團已應用環境、社會及管治報告守則所載的下列匯報原則。

Materiality: Materiality assessment was conducted to identify and prioritise material ESG issues during the Reporting Year, thereby adopting the confirmed material ESG issues as the focus for the preparation of this ESG Report. The materiality of ESG issues was reviewed and confirmed by the Board and senior management of the Group. Details of materiality of ESG issues are described in the section headed “Stakeholders Engagement” and “Materiality Assessment” under aspect “ESG Practice”.

Quantitative: The standards and methodologies used in the calculation of relevant data in this ESG Report, as well as the applicable assumptions were disclosed. The key performance indicators (“KPIs”) are supplemented by explanatory notes to establish benchmarks where feasible.

Consistency: The preparation approach of this ESG Report was substantially consistent with the ESG report of previous year and explanations were provided regarding data with changes in the scope of disclosure and calculation methodologies.

This ESG Report has undergone the internal review process of the Group’s management and has been approved by the Board.

ESG PRACTICE

THE GROUP’S APPROACH

GoFintech started the ESG journey from its own operations to ensure full compliance with all applicable laws and regulations, and aim at becoming a leading player in the sector. During the Reporting Year, the Group’s Chief Executive Officer (“CEO”) and Financial Controller (“FC”) continued to take lead in exploring ESG practices. The Group made commitments in two areas:

- 1) Continue green operations within GoFintech
- 2) Anticipate and address the Group’s stakeholders’ concerns

一致性: 本環境、社會及管治報告的編製方式與上一年度環境、社會及管治報告的編製方式基本一致，並已對披露範圍及計算方法有變化的數據作出解釋。

本環境、社會及管治報告已通過本集團管理層的內部審查程序並經董事會批准。

環境、社會及管治慣例

本集團的方針

國富量子由自身營運著手其環境、社會及管治事宜，以確保全面遵守所有適用法律及法規，並致力成為行業領先者。於本報告年度，本集團的首席執行官（「**首席執行官**」）及財務總監（「**財務總監**」）繼續帶領本集團探索環境、社會及管治的慣例。本集團就以下兩個方面作出承諾：

- 1) 繼續國富量子的綠色經營
- 2) 預測及處理本集團持份者的關注事宜

In addition, the Group understands that climate change is posing imminent impacts on the environment and the communities in which the Group operates. In order to mitigate climate change, enhance decarbonisation and respond to the Group stakeholders' concerns, the Group has set targets related to greenhouse gas ("GHG") emissions, waste management and energy consumption. The targets were approved by the Board and the progress towards these targets will be reviewed by the management, and the result of the review is reported to the Board annually. The Group will continue to work on environmental protection and minimising its carbon footprint in order to achieve long-term sustainability. Details of the targets are mentioned in the sections headed "Climate-related Disclosure", "Air Emissions", "Waste Management" and "Energy Consumption" under aspect "Environmental".

Stakeholders Engagement

Stakeholders are the interest groups who are involved in the Group's business and have significant impact on the Group's success. GoFintech applied the following principles to assess its stakeholders and their importance during the Reporting Year:

- Impact on the viability of the Group's business model
- Impact on the efficiency and reputation of the Group
- Impact on the direction and quality of the Group's decision-making

Having two decades' development, the Group appreciates the importance of effective communication with external and internal parties. The Group has built channels in its daily operation to understand views and expectations of its stakeholders, who are customers, employees, shareholders, government and regulatory authorities, suppliers and the community.

Materiality Assessment

Materiality assessment is a process of identifying and assessing the ESG issues that are important to the Group's business and its stakeholder. With the assistance of the Group's management and the designated personnel, a list of material ESG issues has been identified.

Factors such as business strategic objectives and policies, industrial standards and legal and regulatory responsibilities have been taken into consideration for identifying the Group's material ESG issues, covering environmental protection, climate change, operating practices, employment and labour practices.

重要性評估

重要性評估是識別及評估對本集團業務及其持份者具重要性的環境、社會及管治議題的過程。在本集團管理層及指定人員的協助下，本集團已識別出一系列重大環境、社會及管治事宜。

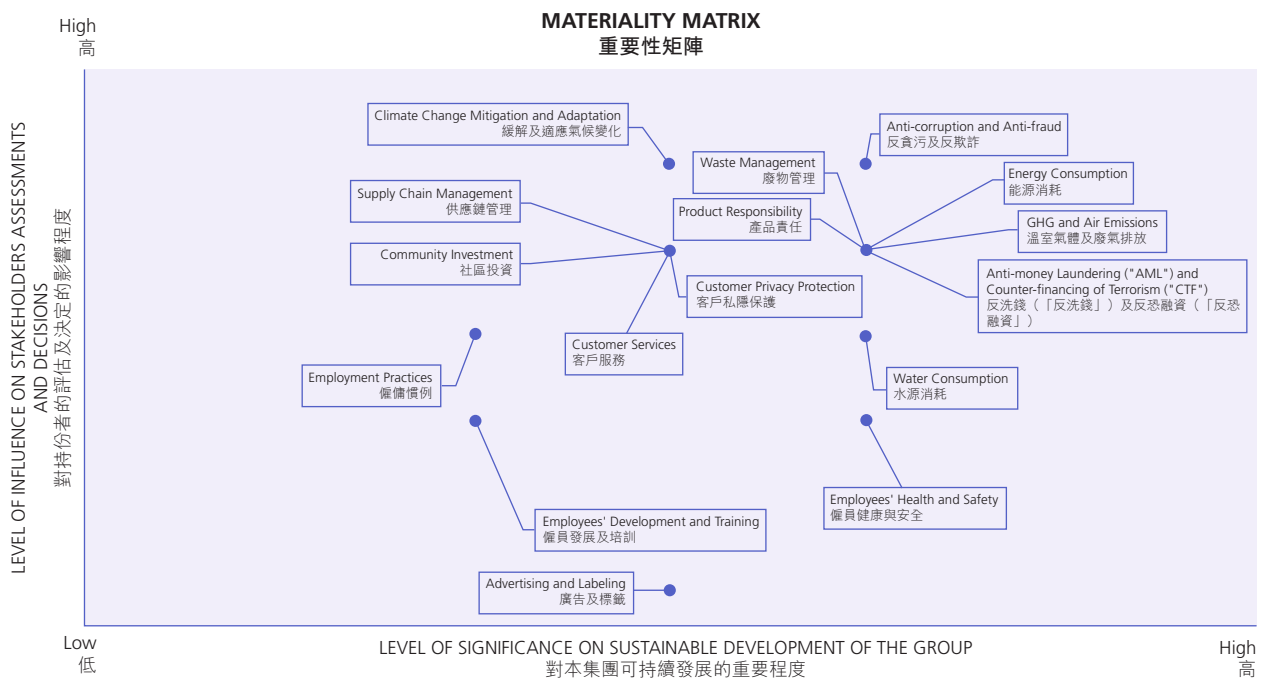
業務策略目標及政策、行業標準、法律及監管責任等因素在識別本集團重大環境、社會及管治事宜時已納入考慮當中，涵蓋環境保護、氣候變化、營運慣例、僱傭及勞工常規。

To prioritise the identified material ESG issues, the Group conducted a materiality assessment survey during the Reporting Year. Employees of different business units and departments were invited to evaluate the significance of the identified ESG issues to the Group's stakeholders and its businesses. Based on the results of the survey, the Group compiled the materiality matrix.

The results of the materiality assessment were reviewed by the Group's management, and approved by the Board. The materiality matrix below mapped out the identified material ESG issues and their respective level of importance on their influence on stakeholders and significance on the sustainable development of the Group. Those material ESG issues reflected are compared against GoFintech's own strategic and operational focus to produce a series of aligned priorities.

During the Reporting Year, the Group confirmed that it has established appropriate and effective management policies and internal control systems for ESG and climate-related issues and confirmed that the information disclosed in the ESG Report complies with the “comply or explain” provisions of the ESG Reporting Code.

SUSTAINABLE BUSINESS OPERATIONS

As a financial institution, GoFintech provides services to a wide range of corporate and private clients who trust it to bring financial solutions and grow their assets and wealth. The Group is committed to the quality of its products and customer services throughout its operations. The Group has also developed a series of internal policies and procedures with regular updates to ensure strict compliance.

During the Reporting Year, the Group was not aware of any material non-compliance with relevant laws and regulations in relation to product responsibility and product quality, including health and safety, advertising, labelling and privacy matters relating to its products and services provided as well as methods of redress. Such laws and regulations include but are not limited to the Securities and Futures Ordinance (“SFO”) of Hong Kong, Companies Ordinance of Hong Kong, Trade Descriptions Ordinance of Hong Kong, the Personal Data (Privacy) Ordinance of Hong Kong, the Law of the People’s Republic of China on the Protection of Consumer Rights and Interests, the Product Quality Law of the People’s Republic of China, the Patent Law of the People’s Republic of China, and the Advertising Law of the People’s Republic of China.

可持續業務營運

作為一所金融機構，國富量子為各類公司及私人客戶提供服務，彼等信任其能提供金融解決方案並增加彼等之資產及財富。在整個營運過程中，本集團致力於提升產品及客戶服務質量。本集團亦已制定一系列內部政策及程序，並定期進行更新以確保嚴格遵守相關法律及法規。

於本報告年度，本集團並無發現在產品責任及產品質量方面有任何嚴重違反相關法律及法規的情況，包括與本集團所提供的產品及服務有關的健康與安全、廣告、標籤及私隱事宜以及補救方法。該等法律及法規包括但不限於《香港證券及期貨條例》（「《證券及期貨條例》」）、《香港公司條例》、《香港商品說明條例》、《香港個人資料（私隱）條例》、《中華人民共和國消費者權益保護法》、《中華人民共和國產品質量法》、《中華人民共和國專利法》及《中華人民共和國廣告法》。

The Group has been awarded the ‘ESG Outstanding Impact Enterprise’, while Mr. ZHANG Huachen, co-CEO of the Group has been awarded the “ESG Outstanding Leader” by the Global Commercial Newspapers Union in the Reporting Year, which demonstrated our commitments and efforts to sustainability.

於本報告年度，本集團獲全球商報聯盟頒發「ESG卓越影響力企業」，而本集團聯席首席執行官張華晨先生獲頒發「ESG卓越領軍人物」，彰顯我們對可持續發展的承諾及努力。



PRODUCT RESPONSIBILITY

Product quality starts with product safety, which is at the core of the Group's commitment to all clients. The Group has placed great importance on due diligence and risk monitoring processes in product planning and on-going management. Product reliability is the next layer of quality assurance initiative. It is conducted by a set of check and balance processes amongst various professional teams. As the health and safety risks involved in the Group's services are not material, it is not applicable to disclose the product recall procedure or the percentage of total products sold or shipped subject to recalls for safety and health reasons.

產品責任

產品質量始於產品安全，其為本集團對所有客戶承諾的核心。本集團高度重視產品規劃及持續管理過程中的盡職調查及風險監控流程。質量保證的更深一層為產品可靠性，乃由不同專業團隊之間的一系列制衡流程來實現。由於本集團服務涉及的健康及安全風險不大，因此不適用披露產品回收程序或已售或已運送產品總數中因安全與健康理由而須回收的百分比。

At operation level, senior officers are assigned to supervise the daily operation to ensure compliance with the Group's internal policies and risk control management requirements. If the Group is aware of any fraudulent or non-compliance cases including but not limited to fraudulent GoFintech corporate website, mobile apps and WeChat group that could lead to fraud or any loss of the Group's customers, the Group will report immediately to the Hong Kong Police and police authorities in Mainland China, and file a brief with relevant regulators if feasible. Meanwhile, the Group will make public announcement through external engagement channels exposing such fraudulent acts in order to protect its reputation and the interest of customers.

CUSTOMER SERVICES

GoFintech aspires to provide the best customer experience as it can in product variety, product quality and customer communications. The Group believes in providing quality advice and insights to customers and has established a dedicated team of professionals with diverse experience and in-depth knowledge of its services. They offer valuable counsel to customers across the Group's major service offerings.

The Group's customer service quality assurance measure is guided by the principle of transparency. The role of quality reviewers was established many years ago with the designated duty of overseeing the process of customer service, including assessing service quality through telephone tapes on sample check basis.

In addition, the Group actively seeks customer feedback on a regular basis and closes gaps where possible, as it believes feedback is a valuable mechanism for building a stronger customer-oriented corporate culture. Complaints Handling Procedure is one of the internal policies, providing detailed processes to follow when dealing with customers' complaints. A variety of customer communication channels were set up, such as telephone hotlines and dedicated email addresses. Both are made prominently on the client statements to ensure customers are aware of those channels for their opinions. Once a complaint has been received, the Group will investigate the complaint received competently, diligently and impartially, and also offer appropriate redress or remedial action accordingly. During the complaint investigation, the client will be kept informed of the investigation progress when appropriate. During the Reporting Year, the Group have not received any material complaints (for the year ended 31 March 2025 ("2025"): nil).

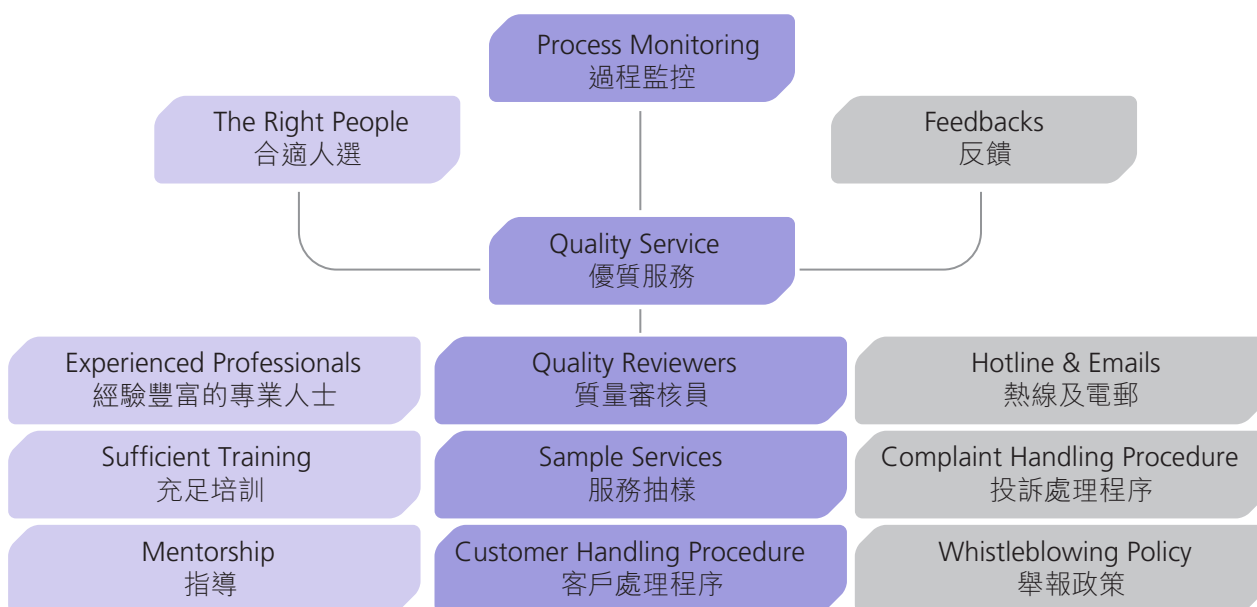
在營運層面，本集團委派高級人員監督日常經營，以確保遵守本集團的內部政策以及風險控制管理規定。倘本集團獲悉任何欺詐或違規案件，包括但不限於偽冒國富量子企業網站、手機應用程式及微信群等可能導致欺詐或本集團客戶損失的情況，本集團將立即向香港警方及中國內地警方報告，並在可行的情況下向相關監管機構將案由存檔。同時，本集團亦會通過外部參與渠道公開揭露該類欺詐行為，以保護本集團聲譽及客戶利益。

客戶服務

國富量子希望在產品種類、產品質量及客戶溝通方面為客戶提供最佳體驗。本集團堅信為客戶提供優質建議及見解的重要性，並已建立一支由專業人士組成的專業團隊，彼等具豐富經驗及對本集團的服務有深入了解，能就本集團各主要服務產品為客戶提供寶貴建議。

本集團的客戶服務質量保證措施遵循透明性原則。本集團已設立質量審核員職位多年，其職責為監督客戶服務過程，包括抽樣聆聽電話錄音，評估服務質量。

此外，本集團定期主動尋求客戶反饋，並於許可的情況下化解疑慮，因為其認為反饋乃為寶貴機制，能幫助建立並強化以客為本的企業文化。投訴處理程序為內部政策之一，為處理客戶投訴提供詳細流程，供員工遵守。本集團已建立各類客戶溝通渠道，例如電話熱線及專用電郵地址，兩者均於客戶聲明中顯著列明，以確保客戶了解可供表達意見的渠道。一旦收到投訴，本集團將稱職、盡責及公正地調查收到的投訴，並相應地提供適當的糾正或補救措施。在投訴調查期間，本集團會適時告知客戶調查進展。於本報告年度，本集團並無接獲任何重大投訴（截至二零二五年三月三十一日止年度（「二零二五年度」）：無）。



CUSTOMER PRIVACY PROTECTION AND CYBER SECURITY

客戶私隱保護及網絡安全

Customer's data privacy is handled with utmost care at GoFintech and is the most important commitment the Group has made to its clients. The Group had developed Privacy Policy to comply with the applicable data protection laws and regulations, including but not limited to Personal Data (Privacy) Ordinance of Hong Kong. It also ensures that appropriate technical measures are put in place to protect the personal data against any unauthorised use or access.

The Group has established a system whereby all data is categorised, while authorisation on usage, filing, editing and access is clearly defined. In principle, staff only access client personal data on a need-to-know basis when opening and maintaining client's account. The head of legal department is also the Group's Information Security Officer with the responsibility to ensure the relevance and the enforcement of the Privacy Policy.

國富量子以最謹慎的方式處理客戶資料隱私，此乃本集團對客戶作出的最重要承諾。本集團已制定私隱政策，以遵守資料保護的適用法律及法規，包括但不限於《香港個人資料（私隱）條例》。該政策亦確保已採取適當的技術措施保護個人資料，防止未經授權的使用或訪問。

本集團已建立可對所有資料進行分類的系統，同時明確規定使用、存檔、編輯及訪問的授權條件。原則上，員工僅於開立及維護客戶賬戶時，才可根據需要查閱客戶的個人資料。法律部門的負責人亦是本集團的資訊安全官，負責確保私隱政策的適切性及執行。

As a business continuity strategy, extra network security measures have been taken when some of the Group's employees had to work from home. It covered remote access policy and procedures upgrade, intrusion detection systems and monitoring, virus and malware protection, vulnerability management, incident response planning, and patch management.

During the Reporting Year, the Group was not aware of any received complaints in relation to breaches of customer privacy, losses or misuse of client data. The Group will review its data protection measures regularly to ensure its effectiveness.

INTELLECTUAL PROPERTY RIGHTS AND RESPONSIBLE MARKETING

GoFintech treasures the trust that its clients put into its advice and service, and the Group has never taken it for granted. The Group appreciates that ample competition helps improve the quality of product and service and benefits customers at large. Therefore, the Group advocates fair competition and follows best practice in product and service marketing activities. As a company providing financial services, the Group does not consider advertising and labelling as a material ESG issue for it. In the Group's dealings with its clients, information provided should be complete, true, accurate, clear, and comply with all relevant laws and regulations regarding the proper advertising, including but not limited to Trade Descriptions Ordinance of Hong Kong.

The Group respects the intellectual property rights and strives to protect intellectual property rights of its own. On the other hand, the Group equally respects the intellectual property rights of the others. All software installed by the Group is purchased through legitimate sources. During the Reporting Year, the Group was not aware of any cases of infringement of intellectual property rights.

作為一項業務連續性策略，本集團於部分員工必須在家工作時採取額外的網絡安全措施，該等措施涵蓋遙距訪問政策及程序升級、入侵檢測系統及監控、病毒及惡意軟件防護、漏洞管理、意外應對計劃以及修補程式管理等。

於本報告年度，本集團並未收到任何有關侵犯客戶私隱、遺失或濫用客戶資料的投訴。本集團將定期檢討數據保護措施以確保其有效性。

知識產權及負責任營銷

國富量子珍視客戶對本集團的建議及服務的信任，從未將其視為理所當然。本集團意識到充分競爭有助於提高產品及服務質量，從而令整體客戶受益。因此，本集團提倡公平競爭，並在產品及服務營銷活動中遵循最佳慣例。作為一家提供金融服務的公司，本集團認為廣告及標籤對其而言並不屬重大的環境、社會及管治事宜。在本集團與客戶交易時，所提供的資料應為完整、真實、準確、清晰，並遵守有關恰當宣傳的所有法律及法規，包括但不限於《香港商品說明條例》。

本集團尊重知識產權，並致力保障自身的知識產權。另一方面，本集團同樣尊重他人的知識產權。本集團安裝的所有軟件均透過合法途徑購買。於本報告年度，本集團未發現任何侵犯知識產權的情況。

SUPPLY CHAIN MANAGEMENT

As a financial service provider, the Group's suppliers are mainly general office supplies providers. In order to provide a fair assessment of suppliers' selection, the Group has adopted relevant policies and evaluated needed services based on a combination of capability, efficiency, competitiveness and reputation of the suppliers before entering into the contractual agreements. If any inconsistency is found between the Group's requirements and their act, the Group will suspend the cooperation until improvement is made.

During the Reporting Year, the Group has engaged a total of 23 major suppliers (2025: 22), all of which have gone through the aforementioned procurement practices of the Group.

In view of green supply chain management, the Group strives to engage suppliers who incorporate the consideration of environmental and social risks into their supply chain management. The Group periodically evaluates and monitors the performance of its suppliers to ensure their compliance with laws and regulations relating to environmental and social policies, service standards, contract conditions and quality provisions. Any non-compliance with relevant environmental and social laws and regulations discovered by the designated personnel from the Group will be promptly reported to the management. Corrective action plan will be carried out to remediate the identified risk in a timely manner. The supplier who continuously fails to meet the Group's requirement could be subject to termination of supplier contract.

供應鏈管理

作為金融服務提供商，本集團的供應商主要為一般辦公用品供應商。為公平評估供應商篩選，本集團已採納相關政策並在訂立合約協議前會根據供應商的能力、效率、競爭力及聲譽等綜合因素評估所需的服務。如發現供應商之行為與本集團要求有所衝突，本集團將暫停合作直至其作出改善。

於本報告年度，本集團共委聘23家主要供應商（二零二五年度：22家），均經過本集團上述採購慣例確定。

按地區劃分的主要供應商數目如下：

在綠色供應鏈管理方面，本集團致力委聘將環境及社會風險納入供應鏈管理的供應商。本集團定期評估及監察其供應商的表現，以確保供應商遵守有關環境及社會政策、服務標準、合約條件及質量規定的法律及法規。本集團指定人員倘發現任何不符合相關環境及社會法律及法規的行為，將及時向管理層報告。本集團將實施糾正措施計劃，以及時糾正已識別的風險。對於持續未能滿足本集團要求的供應商，或會終止供應商合約。

The Group attaches importance to the environmental impacts of the purchased goods and services. More environmentally friendly products or services should be procured by the Group when it is feasible, to minimise negative impacts on the environment and human health, and conserve natural resources. The Group will provide the necessary guidance to its suppliers and service providers on how to implement good environmental and social practices throughout the supply chain engagement process.

The Group will review the above measures regularly to ensure its effectiveness.

BUSINESS ETHICS AND PRACTICE

The Group advocates an operating environment of fairness and a corporate culture of integrity and honesty. Employees, senior management and directors are guided with the Group's principles of business ethics and integrity.

ANTI-CORRUPTION AND ANTI-FRAUD

GoFintech has zero tolerance towards any form of corruption, bribery, forgery, extortion, conspiracy, embezzlement and collusion. Anti-corruption policies and procedures are crystalised in both Code of Conduct and Employee Handbook to drive both mind-set and behavioural change. Head of Compliance and Risk Management Department leads all related work streams from policy setting to enforcement.

All employees are required to act in full compliance with all anticorruption related internal policies, laws and regulations, including but not limited to Prevention of Bribery Ordinance of Hong Kong and the Company Law and Criminal Law of the People's Republic of China. Anti-corruption training is mandatory for all employees including the directors. The Group strives to provide internal and external anti-corruption and corporate governance training and related training materials for its employees and directors annually. During the Reporting Year, the Group has provided anti-corruption training materials for all directors and employees for their self-study. In addition, 1 Continuous Professional Training ("CPT") course was provided to directors and employees. The course was a 1.5-hour seminar covering topic of AML, attended by 2 directors and 5 employees.

本集團重視所採購商品及服務對環境的影響。本集團在可行的情況下會採購更環保的產品或服務，以盡量減少對環境及人類健康的負面影響，保護自然資源。本集團將就如何於供應鏈參與過程中實施良好的環境及社會慣例，為其供應商及服務商提供必要指導。

本集團將定期檢討上述措施以確保其有效性。

商業道德及常規

本集團提倡公平的營商環境及誠信正直的企業文化。僱員、高級管理層及董事均遵循本集團的商業道德及誠信原則。

反貪污及反欺詐

國富量子對任何形式的貪污、賄賂、偽造、勒索、串謀、挪用公款及勾結行為採取零容忍態度。操守準則及員工手冊中均明確規定反貪污政策及程序，以促進心態及行為的轉變。合規與風險管理部主管負責由政策制定至執行的所有相關工作流程。

全體僱員均須完全遵守與反貪污有關的所有內部政策、法律及法規，包括但不限於《香港防止賄賂條例》以及《中華人民共和國公司法》及《中華人民共和國刑法》。包括董事在內的所有僱員均須接受反貪污培訓。本集團力求每年為其僱員及董事提供內部和外部反貪污及企業管治培訓以及相關培訓材料。於本報告年度，本集團已為全體董事及僱員提供反貪污培訓材料，供彼等自學。此外，本集團為董事及僱員提供1個持續專業培訓（「持續專業培訓」）課程。兩名董事及五名僱員參加了1.5小時的反洗錢研討會。

The Group's operation policy requires:

1. No confidential commercial information of the Group shall be disclosed, discussed and shared with third parties for personal interest.
2. All employees are prohibited to give and accept personal, commercial, regulatory or contractual advantage, by using the excuse of work or the authority granted from the Group.
3. If any misconducts are found and proven, the Group will apply disciplinary actions in accordance with set policies.

AML AND CTF

GoFintech has taken AML and CTF as one of the most imperative compliance requirements. The Group has established AML and CTF Policy and Prevention of Bribery and Conflict of Interest Handling Guideline with updates on a compliance tool used by the Group during the Reporting Year to ensure that all business operations comply with relevant laws and regulations. The Group also formulated relevant policies and measures including customer acceptance policies, customer due diligence process, ongoing monitoring, and customer and transaction record keeping preventing any breaches throughout the transaction.

The Group also regularly conducts internal training relating to AML and CTF procedures and recent updates on relevant regulation and other topics related to licensed regulated activities. The compliance training provided up-to-date information regarding AML and CTF, including but not limited to the regulatory framework, stakeholders' roles and responsibilities, procedure and importance of conducting customer due diligence, and the transaction monitoring system. By doing so, the Group ensures its employees are equipped with sufficient knowledge and awareness, regarding AML and CTF, therefore, minimising the risk of relevant breaches.

本集團的營運政策規定：

1. 不得為個人利益向第三方披露、討論及分享本集團的機密商業資料。
2. 禁止所有僱員利用其職務便利或本集團授予的權力，給予及接受個人、商業、監管或合約方面的好處。
3. 倘發現並證實任何不當行為，本集團將按照既定政策採取紀律行動。

反洗錢及反恐融資

國富量子將反洗錢和反恐融資視為最重要的合規規定之一。本集團已設立反洗錢及反恐融資政策及防止貪污及利益衝突處理指引，並於本報告年度更新本集團使用的合規工具，以確保所有業務經營遵守相關法律及法規。本集團亦已制定相關政策及措施，包括客戶接納政策、客戶盡職調查流程、持續監控，以及客戶及交易記錄存置，從而預防交易過程中出現任何違規情況。

本集團亦定期就反洗錢及反恐融資程序、相關條例的近期更新及有關許可受規管活動的其他議題進行內部培訓。合規培訓提供有關反洗錢及反恐融資的最新資料，包括但不限於監管框架、持份者的角色及責任、進行客戶盡職調查的程序與重要性，以及交易監控系統。通過這些培訓，本集團確保僱員具備反洗錢及反恐融資的足夠知識及警覺，從而降低相關違規的風險。

WHISTLEBLOWING MECHANISM

GoFintech formulated a whistleblowing system for employees and external parties to report any suspected irregularities or doubts on misconduct. Such report will be raised to the Group by post or email in confidence and anonymity. Upon receiving the report, the Group will conduct the investigation in a fair and impartial way for every report. If there is any evidence of illegal conduct or breach of laws and regulations, it shall be referred to the relevant public or regulatory bodies such as the Hong Kong Police Force, the Independent Commission against Corruption, the Securities and Futures Commission, or relevant regulatory body. Disciplinary actions would be adopted once the guilty or misconduct is proven. The Group is committed to protecting the identity of whistleblowers and retaliation against them. Related practices are reviewed regularly to ensure their effectiveness.

During the Reporting Year, there were no concluded legal cases regarding corruptive practices brought against the Group or its employees, and no reports were received through the Group's whistleblowing channels. Also, the Group has not identified any material non-compliance with relevant laws and regulations in Hong Kong and Mainland China including but not limited to Prevention of Bribery Ordinance of Hong Kong, the Company Law of the People's Republic of China and Criminal Law of the People's Republic of China.

舉報機制

國富量子已制定舉報制度，供僱員及外部人士舉報任何涉嫌違規行為或疑似不當行為。此類舉報將以保密及匿名方式通過郵寄或電郵向本集團提出。接獲舉報後，本集團將以公平公正的方式對每宗舉報進行調查。倘有證據顯示非法行為或違反法律及法規，將轉交相關公共或監管機構處理，如香港警務處、廉政公署、證券及期貨事務監察委員會或相關監管機構。任何犯罪或不當行為一經證實，將採取紀律行動。本集團致力保護舉報人的身份並保護其免遭報復。本集團定期檢討相關常規以確保其有效性。

於本報告年度，並無對本集團或其僱員提出並已審結的貪污訴訟案件，亦無透過本集團的舉報渠道接獲任何舉報。此外，本集團並未發現任何嚴重違反香港及中國內地相關法律及法規的情況，包括但不限於《香港防止賄賂條例》、《中華人民共和國公司法》及《中華人民共和國刑法》。

EMPLOYMENT

THE GROUP'S TALENT POLICY

Talents have long been recognised as one of the major competitive strengths in financial industry, and GoFintech has continued its investment to attract and retain talents. The Group has established the Employee Handbook which builds a holistic and harmony system for employment practice, covering compensation and dismissal, recruitment and promotion, working hours, rest periods, equal opportunity, diversity, anti-discrimination, and other benefits and welfare.

The Group is committed to promoting equal opportunities and diversity in recruitment. The Group's hiring, appraisal and promotion policies are merit-based regardless of individual's gender orientation, racial background, age, religion, marital status and so on, and relevant processes are clear and transparent.

During the Reporting Year, the Group has not identified any material non-compliance with relevant laws and regulations including but not limited to Employment Ordinance of Hong Kong, Minimum Wage Ordinance of Hong Kong, Bill of Rights Ordinance of Hong Kong, Sex Discrimination Ordinance of Hong Kong, Disability Discrimination Ordinance of Hong Kong, Family Status Discrimination Ordinance and Race Discrimination Ordinance of Hong Kong, Occupational Safety and Health Ordinance of Hong Kong, Employees' Compensation Ordinance of Hong Kong, the Labour Law of the People's Republic of China and the Labour Contract Law of the People's Republic of China that would have a significant impact on the Group.

The Group recognises its employees' qualifications, experience and work performance by offering attractive remuneration packages. In order to retain talents, remuneration packages are reviewed annually and bonuses are paid each year, according to work performance, seniority and contribution to the Group, to recognise employees' hard work throughout the year.

僱傭

本集團的人才政策

人才一直被認為是金融業的主要競爭優勢之一，而國富量子亦繼續投放資源吸引及挽留人才。本集團已制定員工手冊，為僱傭慣例構建一個整體和諧的體系，其中涵蓋薪酬與解僱、招聘與晉升、工作時間、假期、平等機會、多元化、反歧視以及其他福利待遇等方面。

在招聘方面，本集團致力促進平等機會及多元化。本集團的招聘、考核及晉升政策均是基於個人表現，而不論個人的性取向、種族背景、年齡、宗教及婚姻狀況等，且相關流程均清晰透明。

於本報告年度，本集團並未發現任何嚴重違反相關法律及法規的情況，包括但不限於《香港僱傭條例》、《香港最低工資條例》、《香港人權法案條例》、《香港性別歧視條例》、《香港殘疾歧視條例》、《香港家庭崗位歧視條例》、《香港種族歧視條例》、《香港職業安全及健康條例》、《香港僱員補償條例》、《中華人民共和國勞動法》及《中華人民共和國勞動合同法》等對本集團可能有重大影響的法律及法規。

本集團提供具吸引力的薪酬待遇作為對僱員資歷、經驗及工作表現的認同。為留住人才，本集團每年檢討薪酬待遇，並根據工作表現、資歷及對本集團的貢獻發放花紅以表彰僱員一年來的努力。

The promotion of employees depends on their performance, working ability, intrinsic potential, and the needs of the Group's entities. The basis and process for management to determine promotion, transfer and demotion of employees are clearly defined to protect the interest of both the employees and the Group. Only with the appropriate approval, the relevant actions can be carried out.

員工的晉升取決於其表現、工作能力、內在潛力以及本集團各公司的需求。管理層決定員工晉升、調動及降級的依據及流程均有明確規定，從而保障員工與本集團的利益。相關行動只有在取得應有的批准後才可進行。

Employment termination of employees is arranged in accordance with relevant laws and regulations. Unreasonable dismissal under any circumstances is strictly prohibited, dismissal will be based on appropriate and lawful grounds supported by internal policies of the Group. During the Reporting Year, the Group's overall turnover rate was approximately 58.11%¹ (2025: approximately 46.51%). The employee turnover rate by gender, age group, and geographical region was as follows:

STAFF BENEFIT AND WELL-BEING

The Group has formulated policies in determining the working hours and rest periods for employees following local employment laws and regulations. In addition to the statutory benefits, such as paid annual leave, maternity leave, paid sick leave and marriage leave, the Group continues to offer employees with casual Fridays, festival gifts, training subsidy, qualification allowance, travel and overtime allowance. Qualified members were also offered housing allowance under the Group's Staff Residential Rental Subsidy programme.

The Group offers a variety of communications means with the staff, for instance, weekly all-staff meeting and management meeting. During the Reporting Year, an all-staff-meeting was held as a conclusion for the years 2025–2026. In addition, the Group's Townhall Meeting is held regularly. All these channels effectively cascade the Group's policies and principles throughout the organisation.

DIVERSITY, EQUAL OPPORTUNITIES AND ANTI-DISCRIMINATION

To maintain an embracing and collaborative workplace culture, the Group provides equal opportunities in all aspects of employment and ensures the workplace is free from discrimination, physical or verbal harassment against any individual because of race, religion, colour, gender, physical or mental capability, age, place of origin, marital status, and sexual orientation. The Group also strives to ensure that complaints, afflictions and concerns, including whistleblowing, are dealt with promptly and confidentially. The Group has zero tolerance for sexual harassment or abuse in the workplace in any form.

EMPLOYEES' HEALTH AND SAFETY

Due to the office-based operation, the Group does not involve significant safety risks. Nevertheless, the Group does not overlook the responsibility to safeguard employees' health and safety. The Group has formulated various management requirements in accordance with relevant occupational health and safety laws and regulations. The relevant health and safety measures and response plans are clearly stated in the Employee Handbook.

員工福利及福祉

本集團已根據當地僱傭法律及法例制定政策以釐定員工的工作時數及假期。除有薪年假、產假、有薪病假及婚假等法定福利外，本集團繼續為員工提供星期五休閒日、節日禮品、培訓補貼、資歷津貼、差旅津貼及加班津貼。此外，根據本集團「員工住房租金補貼」計劃，符合條件的員工亦可享有住房補貼。

本集團與員工以多種方式進行溝通，例如每週一次的全體員工會議及管理層會議。於本報告年度，本集團舉行全體員工會議，對二零二五年度至二零二六年度進行總結。此外，本集團定期舉行全員大會。所有該等渠道能有效地將本集團的政策及原則傳播至整個組織。

多元化、平等機會及反歧視

為了維持包容及協作的工作文化，本集團就僱傭所有方面提供平等機會，並確保所有人士在職場不會因種族、宗教、膚色、性別、身體或精神狀況、年齡、出生地、婚姻狀況及性取向而遭受歧視、身體或語言騷擾。本集團亦致力確保相關投訴、困擾及疑慮（包括舉報）均得到及時及保密地處理。本集團絕不容忍任何形式的職場性騷擾或欺凌行為。

僱員健康與安全

本集團業務經營主要在辦公室進行，故不涉及重大的安全風險。儘管如此，本集團並不忽視其保障員工健康及安全的責任。本集團已根據相關職業健康及安全的法律及法規制定多項管理要求。員工手冊已明確規定相關的健康與安全措施以及應對計劃。

Acknowledging the relatively longer time spent in front of computers as the reality of financial industry practitioners, the Group has provided protective equipment and furniture, such as ergonomic chairs and lightings, to help relieve body stiffness and eye stress. Regular breaks during the day with desk-side stretch exercise have always been encouraged. The management team will continue to seek feedback from the staff on the support needed from the Group so that the staff can be more focused and well-motivated to deliver first-class service to customers.

The Group adhered to placing the health and safety of employees as its top priority, therefore the relevant precautionary measures remained the same as the previous years. The Group provided highly sought-after protective measures for staff, such as face masks and sanitising packages, through its overseas network. The Group also made flexible work arrangements including home office for its staff on the basis of no compromise on customer service quality.

Sanitising measures were put in place in offices when employees returned to work. Employees' body temperatures were also taken regularly, and the Group issued a policy to arrange employees to go for immediate medical treatment should their body temperature exceed 37.3°C at Group's expense where necessary. The Group will review the relevant measures regularly to ensure their effectiveness.

During the Reporting Year, the Group was not aware of any material non-compliance with health and safety-related laws and regulations, including but not limited to Occupational Safety and Health Ordinance of Hong Kong, Employees Compensation Ordinance of Hong Kong, the Labour Law of the People's Republic of China, the Law of the People's Republic of China on the Prevention and Control of Occupational Diseases that would have a significant impact on the Group. In the past three years (including the Reporting Year), the Group did not record any cases of work-related fatalities. In addition, the Group did not record any work-related injuries or losses in working days due to work-related injuries during the Reporting Year (2025: nil).

考慮到金融從業人員長時間在電腦前工作的實際情況，本集團提供了防護設備及家具，例如符合人體工學原理的椅子及照明裝置，以幫助放鬆身體及舒緩眼睛疲勞。本集團一直鼓勵員工定時休息，日間亦可在辦公桌旁做伸展運動。管理團隊將繼續就需要本集團提供的支援，徵詢員工意見，從而使員工能夠更加專注並更有動力地為客戶提供一流的服務。

本集團堅持將僱員的健康與安全放在首位，因此相關預防措施與往年相同。本集團透過其海外網絡為員工提供了急需的防護裝備，例如口罩及消毒包。本集團亦在不影響客戶服務質量的基礎上，為員工作出靈活的工作安排，包括在家辦公。

員工復工後，辦公室已採取清潔消毒措施。員工亦須定期檢查體溫，本集團公佈政策，倘員工體溫超過攝氏37.3度，則安排立即就醫，必要時由本集團承擔費用。本集團將定期檢討相關措施以確保其有效性。

於本報告年度，本集團並未發現任何嚴重違反健康及安全相關法律及法規的情況，包括但不限於《香港職業安全及健康條例》、《香港僱員補償條例》、《中華人民共和國勞動法》及《中華人民共和國職業病防治法》等可能對本集團有重大影響的法律及法規。於過去三年（包括本報告年度），本集團並無錄得任何因工死亡事故。另外，本集團於本報告年度並無錄得任何工傷或因工傷造成的工作日損失（二零二五年度：無）。

EMPLOYEES' DEVELOPMENT AND TRAINING**僱員發展及培訓**

The level of professionalism of GoFintech's team is its building block. The Group holds that principle and enables continued professional training of staff as such that they will play to their strength and deliver high-quality performance. The Group encourages staff to participate in external seminars and industrial events to keep abreast of industry challenges and best practices, at the same time, the Group offers internal trainings in areas of legal, compliance, business ethics and other licensed regulated activities. The Group also offers subsidies on external training programmes, licence fees and qualification allowance.

國富量子的基石是其團隊的專業水平。本集團秉承此原則，持續對員工進行專業培訓，使彼等發揮自身實力，實現高質量的表現。本集團鼓勵員工參加外部研討會及業內活動，以了解業內挑戰及最佳慣例，同時，本集團提供法律、合規、商業道德及其他許可受規管活動方面的內部培訓。本集團亦就外部培訓課程、牌照費用及資歷津貼提供補貼。

To ensure employees' professionalism and the service quality provided, the Group regularly conducts internal trainings relating to AML and CTF procedure, recent updates on relevant regulations and other topics related to licensed regulated activities. The Group also provides cyber security training to its employees, in order to prevent any relevant incident leading to customers' or the Group's loss or threat. Employees were taught to conduct the best practice and the procedure of timely response in case of any breaches.

為確保僱員的專業性及所提供的服務質素，本集團定期舉辦內部培訓，內容涉及反洗錢及反恐融資程序、相關條例的近期更新及與許可受規管活動有關的其他主題。本集團亦為員工提供網絡安全培訓，旨在防止任何導致顧客或本集團遭受損失或威脅的相關事件。員工亦獲得最佳常規以及發生違規情況時的及時應對程序方面的相關指導。

During the Reporting Year, the Group recorded approximately 24.03%³ (2025: approximately 25.00%) of trained employees, with an average of approximately 2.02⁴ (2025: approximately 1.90) training hours per employee.

LABOUR STANDARDS

Prevention of Child and Forced Labour

In strict compliance with relevant local labour laws and regulations, the Group prohibits hiring child labour and requires verifying the age of applicants during the recruitment process. The Group strictly follows the internal policies, in which all staff are required to sign employment contract before employment to safeguard legal rights of both parties. Furthermore, employees of the Group work overtime on a voluntary basis to prevent any breaches of labour standards. Any punishments, management methods and behaviours involving verbal abuse, physical punishment, physical abuse, oppression, sexual harassment against its employees are prohibited for any reasons. The Group also conducts regular reviews and inspections to prevent any child labour or forced labour in operation. If the case of child labour is found, it will be dealt with in the light of the circumstances, including terminating the employment contracts of the child labour and reporting to legal authorities. For the case of forced labour, the Group will terminate the employment contracts of the staff who are responsible for the cause of the case. The measures will be reviewed regularly to ensure their effectiveness.

During the Reporting Year, the Group has not identified any material non-compliance with relevant laws and regulations relating to child and forced labour, including but are not limited to Employment Ordinance of Hong Kong and the Labour Law of the People's Republic of China that would have a significant impact on the Group.

WORKING ENVIRONMENT

The Group has implemented different policies to govern the impact on the environment of its operations. To enhance working efficiency, the Group is committed to providing employees with a comfortable and green workplace. Office areas are inspected regularly to ensure that a good working environment is maintained. Once the Group has found problems within the workplace, precautionary measures will be promptly taken to minimise the potential harm to employees. In addition, the Group cleans air-conditioning systems regularly. Inspections of indoor air quality have been conducted, and the results have consistently been satisfactory, with no remediation required.

勞工準則

防止童工及強制勞工

本集團嚴格遵守當地相關勞工法律及法規，嚴禁僱用童工，並在招聘過程中要求核實應聘者的年齡。本集團嚴格遵守內部政策，所有職員於任職前必須簽訂僱傭合約以保障雙方的合法權益。此外，本集團僱員超時工作均在自願性基礎上進行，以防止違反勞工準則。本集團亦禁止以任何理由對員工進行辱罵、體罰、身體暴力、壓迫、性騷擾等懲罰措施、管理方法及行為。本集團亦定期進行檢查及審查，以防止發生任何童工及強制勞工的情況。倘發現僱用童工，將按具體情況處理，包括終止童工的僱傭合約及向法律機關報告。對於強制勞工的情況，本集團將終止對該事件的起因負有責任的員工的僱傭合約。本集團將定期檢討該等措施以確保其有效性。

於本報告年度，本集團並未發現任何嚴重違反與童工及強制勞工有關的法律及法規的情況，包括但不限於《香港僱傭條例》以及《中華人民共和國勞動法》等可能對本集團有重大影響的法律及法規。

工作環境

本集團已實施多項不同的政策，以管理其營運對環境的影響。為提升工作效率，本集團盡力為僱員提供舒適、綠色的工作場所。本集團會定期檢查辦公場所，確保維持良好的工作環境。一旦發現工作場所存在問題，本集團會迅速採取預防性措施，務求盡量減少對員工的潛在傷害。此外，本集團定期清潔空調系統。室內空氣質素檢測已完成而結果持續令人滿意，無需採取補救措施。

COMMUNITY INVESTMENT

The Group's business itself does not create a significant direct impact on or engagement with the community in neither environmental nor social aspects. However, the Group believes that contribution to social causes and development of local communities is part of its corporate social responsibility. It has upheld the principle of corporate social responsibility throughout its operations and implemented policy to maintain its community investment.

During the Reporting Year, the Group denoted a total of HK\$2 million to the family of the firefighter hero Ho Wai Ho and to the Hong Kong Fire Services Department Welfare Fund. Moreover, the Group has co-organised the 4th "SpinQ Cup" Quantum Computing Challenge in January 2026. The competition attracted over a thousand participants from more than 200 universities and enterprises across over 10 countries and regions worldwide. It also innovatively introduced engaging tracks such as "Quantum Chess", effectively promoting the popularisation of quantum knowledge.

社區投資

本集團的業務本身在環境及社會方面均不會對社區產生重大的直接影響，亦不會與社區產生重大的直接聯繫。然而，本集團認為對社會事業及當地社區發展作出貢獻為其企業社會責任的一部分。本集團在整個營運過程中秉持企業社會責任的原則，並實施保持社區投資的政策。

於本報告年度，本集團向消防英雄何偉豪的家人及香港消防處福利基金合共捐贈2百萬港元。此外，本集團於二零二六年一月協辦了第四屆「量旋杯」量子計算挑戰賽。本次賽事吸引了來自全世界超過10個國家及地區的200多所大學及企業的逾千名參賽者。賽事亦創新性地引入「量子象棋」等趣味環節，有效推動了量子知識的普及。



The Group will continue focusing on social participation and community investment, especially related to labour needs and health, and continue to encourage the employees to actively participate in charitable activities and voluntary services coordinated by nonprofit organisations. The Group believes that promoting awareness of corporate social responsibilities among staff would not just help society and business in general, but more about their personal growth. The Group welcomes opportunities of sponsorship or partnership for charity events, and organising volunteer work to support vulnerable groups in Hong Kong.

ENVIRONMENTAL

The Group is committed to building an environmentally friendly corporation image. It pursues to minimise resource consumption and adopts environmentally friendly practices across the business with the relevant environmental protection policies set for the Group's business operations. The Group provides financial products and services to a wide range of corporate clients and individual customers. For the Group's staff to carry out daily work, the Group rents office spaces which have been furnished with office equipment. The Group uses electricity, water and waste management services provided by the leased premises. Due to the office-based business nature, the Group's daily operation has limited environmental impact.

However, the Group proactively implements emissions reduction and energy conservation measures to achieve efficient use of resources, enhancing its sustainability development. Various initiatives have been implemented throughout its operations such as minimising the use of paper and reducing water consumption. Through active monitoring and managing the use of resources, the Group aims to reduce its carbon footprints as well as its operating cost.

During the Reporting Year, the Group has not identified any material non-compliance with relevant laws and regulations relating to air and GHG emissions, discharges into water and land, and generation of hazardous and non-hazardous waste that would have a significant impact on the Group. The relevant laws and regulations include but are not limited to Air Pollution Control Ordinance of Hong Kong, Waste Disposal Ordinance of Hong Kong, the Environmental Protection Law of the People's Republic of China, the Law of the People's Republic of China on the Prevention and Control of Environmental Pollution by Solid Waste.

本集團將繼續注重參與社會及社區投資，尤其是與勞工需求及健康相關的領域，並繼續鼓勵員工積極參與慈善活動以及由非牟利組織協調的義工服務。本集團認為，提升員工企業社會責任的意識不僅有利於社會與企業，同時亦有助促進員工的個人成長。本集團歡迎任何贊助或合作開展慈善活動的機會，並組織義工活動支持香港的弱勢群體。

環境

本集團致力於建立環保企業形象，力求將資源消耗減到最低，並於整個業務中採納環保慣例，已為本集團業務營運制定相關的環保政策。本集團為眾多企業客戶及個人客戶提供金融產品及服務。為方便本集團的員工開展日常工作，本集團租用配置辦公設備的辦公場所。本集團使用租賃場所提供的電、水及廢物管理服務。由於以辦公室工作為主的業務性質，本集團的日常營運對環境的影響有限。

然而，本集團積極實施減排及節能措施，以有效使用資源，促進自身的可持續發展。本集團在整個營運過程中實施了多項舉措，如盡量減少紙張的使用及減少用水。透過積極監控及管理資源的使用，本集團旨在減少碳足跡以及降低營運成本。

於本報告年度，本集團在廢氣及溫室氣體排放、向水及土地的排污以及產生有害及無害廢物等方面，並未發現任何嚴重違反相關法律及法規並可對本集團造成重大影響的情況。相關的法律及法規包括但不限於《香港空氣污染管制條例》、《香港廢物處置條例》、《中華人民共和國環境保護法》及《中華人民共和國固體廢物污染環境防治法》。

CLIMATE-RELATED DISCLOSURE

Governance

The Group considers climate-related risks and opportunities in its strategy development, business planning, and day-to-day operations, including decisions on major transactions. The Group identifies these risks and opportunities through its regular materiality assessments and risk review processes. As with other material risks, the Group applies a consistent risk management and internal control mechanisms to evaluate and manage relevant risks and opportunities. To support oversight, the Group's designated personnel receive inputs from functional departments and consolidate these inputs to report material climate-related issues and developments to the Board annually.

Also, the Group has set a short-term GHG emissions target. However, climate-related performance metrics have not been incorporated into the Group's remuneration policies. To further its climate commitment, the Group will continue to explore the feasibility of establishing a long-term climate-related or carbon neutralisation target as part of the Group's transition plan and monitor developments in ESG and climate-related issues to boost its ESG performance.

Strategy

The Group recognises that climate change has been affecting its business operations and the Group faces both physical and transition risks. The Group ensures that its assets and operations are prepared to withstand or respond to expected climate impacts. The Group has initiated a climate change assessment with reference to the Task Force on Climate-related Financial Disclosures ("TCFD") framework to identify and mitigate the potential climate-related risks that may arise from its business operations. At the same time, the potential climate-related opportunities have also been identified. In alignment with the PRC on "Carbon Peaking and Carbon Neutrality China's Plans and Solutions" the Group has established defined time horizons to enable a comprehensive assessment of climate-related risks and opportunities, comprising short-term (within the next Reporting Year), medium-term (by 2030), and long-term (by 2060). The potential climate-related risks and opportunities mainly stem from the following dimensions:

氣候相關披露

管治

本集團在制定策略、業務規劃及日常經營(包括有關主要交易的決策)的過程中,會考慮氣候相關的風險及機遇。本集團透過定期開展重要性評估及風險審視流程,識別該等風險及機遇。本集團採用與其他重大風險相一致的風險管理及內部監控機制來評估及管理相關風險及機遇。為支持監督工作,本集團的指定人員每年接收來自職能部門的意見,然後匯總該等意見,以向董事會報告重要的氣候相關事宜及發展情況。

此外,本集團已設定短期溫室氣體排放目標。然而,氣候相關的表現指標尚未納入本集團的薪酬政策。為進一步踐行氣候承諾,本集團將繼續探討設立長期氣候相關或碳中和目標的可行性,並將其作為本集團轉型計劃的一環,同時監測環境、社會及管治以及氣候相關事宜的發展情況,以提升其環境、社會及管治表現。

策略

本集團認識到氣候變化已對其業務營運產生影響,且本集團面臨物理及轉型風險。本集團確保其資產及營運能承受或應對預期的氣候影響。本集團已參照氣候相關財務披露工作小組("TCFD")框架展開氣候變化評估,從而識別及減緩其業務營運可能產生的潛在氣候相關風險。同時,潛在的氣候相關機遇亦已被識別。為響應中國的「碳達峰碳中和規劃與方案」,本集團已設定明確的時間範圍,以便對氣候相關風險及機遇進行全面評估,包括短期(於下個報告年度內)、中期(二零三零年前)及長期(二零六零年前)。潛在氣候相關風險及機遇主要源自於以下各方面:

Physical Risks

Climate change leads to the increase of extreme weather events, such as typhoons, storms and heavy rainfall from short-term to long-term. These events may potentially disrupt the daily operations of the Group by causing damages to power grid and communication infrastructure, which raising operation costs. Additionally, they can impede employees' ability to work or commute, leading to injuries. Consequently, the Group may experience partial halt or even permanent cessation of business operations, which expose the Group to risks associated with reduced revenue and higher operational costs from negative impacts on workforce.

To better manage the above physical risks, the Group has formulated emergency plan which is reviewed regularly to respond to such events, including procedures to approach typhoons and black rainstorms. The relevant procedures and measures are outlined in the Employee Handbook. When it is anticipated that extreme weather events will happen, the senior management will react according to the plans and communicate with the employees about the work arrangements to ensure staff safety and operational continuity.

Transition Risks

Climate change can lead to market volatility, affecting asset valuations and investment returns. Shifts in consumer preferences toward sustainable products can disrupt markets and impact investment portfolios. It is believed that the effect on asset valuations and investment returns and the shift in consumer preferences would expect to occur from short-term to long-term, which would threaten the strand existing assets and erode revenue stream if the transition risks are not handled properly.

As a mitigation, the Group has planned to implement advanced risk assessment tools to evaluate climate-related impacts on assets and investments. This includes scenario analysis and stress testing for better decision-making. It is also part of the Group's strategy to diversify investment portfolios to include a mix of assets less susceptible to climate-related market volatility, such as low-carbon and climate-resilient investments. In addition, the Group will regularly train employees and adopt internal policies and processes to align with market trends and regulatory standards.

物理風險

從短期到長期而言，氣候變化導致颱風、風暴及暴雨等極端天氣事件發生的頻率增加。極端天氣可能會對電網及通訊基礎設施造成破壞，從而可能擾亂本集團的日常營運，增加運營成本。此外，極端天氣可能會妨礙僱員開展工作或通勤，導致僱員受傷。因此，本集團的業務營運可能會部分暫停甚至永久終止，使本集團面臨因勞動力受到負面影響而導致的收入減少及營運成本上升的相關風險。

為把上述物理風險管理得更好，本集團已制定應對此類事件的應急計劃並定期進行檢討，當中包括應對颱風及黑色暴雨的程序。相關程序及措施於員工手冊中載列。當預計會發生極端天氣事件時，高級管理層將根據計劃作出行動，並與員工溝通工作安排，以確保人員安全及營運持續性。

轉型風險

氣候變化可引致市場波動，影響資產估值及投資回報。消費者偏好轉向可持續產品，或會擾亂市場並影響投資組合。本集團認為，從短期至長期而言，資產估值及投資回報預計將受到影響，且消費者偏好將發生轉變。倘若轉型風險未獲得妥善處理，可能使現有資產面臨擱淺威脅，並使收入來源受到侵蝕。

為緩解此類風險，本集團計劃採用先進的風險評估工具，以評估氣候相關因素對資產及投資的影響，包括透過情境分析及壓力測試提升決策效能。此舉亦屬本集團分散投資組合策略之一環，旨在納入較不易受氣候相關市場波動影響的多類資產，如低碳投資及氣候韌性投資。此外，本集團將定期培訓員工並採納內部政策與流程，以緊貼市場趨勢及符合監管標準。

The Group anticipates that there will be more stringent climate legislation and regulations to support the global vision of carbon neutrality in the medium-term and long-term. From a listed company's perspective, the Group acknowledges the stricter requirements of climate-related disclosures. One example is the update of the Stock Exchange's ESG reporting framework in respect of disclosures regarding significant climate-related issues. The Group's business operations may be materially and adversely affected under the stricter environmental laws and regulations if it fails to comply with the laws and regulations as applicable to its businesses from time to time. Negative publicity may also arise due to failure to meet the compliance requirements for climate change, and the need to comply with increasingly stringent environmental laws, regulations and disclosure requirements might lead to an increase in the Group's compliance costs.

In response to the policy and legal risks as well as the reputation risks, the Group regularly monitors existing and emerging trends, policies and regulations relevant to climate and be prepared to alert the top management where necessary to avoid cost increments, non-compliance fines or reputational risks due to delayed response.

Opportunities

ESG investing has been moving mainstream as climate-related risks reshape the principles of investment decisions. As a significant player in China's financial market, the Group will grasp the opportunities arising from the emerging trend of green finance. During the Reporting Year, the Group allocated HK\$1 million towards a green deposit of which the funds will be used to finance and/or refinance an eligible green project. Moving forward, the Group remains committed to actively supporting climate-friendly endeavours by facilitating the development and innovation of climate-friendly products and technologies.

本集團預計在中長期將會有更嚴格的氣候法例及法規以支持全球碳中和的願景。本集團深知，就上市公司而言，對氣候相關資料披露的規定更為嚴格。其中一個例子就是聯交所更新了有關重大氣候相關事宜披露的環境、社會及管治報告框架。在更嚴格的環境法律及法規背景下，倘本集團未能遵守不時適用於其業務的法律及法規，本集團的業務營運可能會因而受到重大不利影響。未能滿足氣候變化的合規要求亦可能產生負面輿論，而遵守日益嚴格的環境法律、法規及披露要求或會導致本集團合規成本增加。

為應對政策及法律風險以及聲譽風險，本集團定期監測與氣候有關的現有及新出現的趨勢、政策及法規，並於必要時即時提醒最高管理層，以避免因反應遲緩而導致的成本增加、不合規罰款或聲譽風險。

機遇

環境、社會及管治投資因氣候相關風險重塑投資決策原則而漸趨主流。作為中國金融市場重要參與者，本集團將把握綠色金融新興趨勢衍生的機遇。於本報告年度，本集團劃撥1,000,000港元作為綠色存款，相關資金將投放於合資格綠色項目的融資及／或再融資。未來，本集團將繼續積極支持氣候友善型項目，推動氣候友善型產品和技術的開發與創新。

Even though the Group's business model and value chain do not currently face significant and concentrated climate-related risks and opportunities, the Group regularly monitors related risks that may affect its operations and strives to grasp any related opportunities. Where such issues are identified, we will conduct corresponding risk assessments and develop appropriate mitigation measures. These findings can inform both current operations and anticipated evolutions in our business model, with allocation of necessary resources to address climate-related risks and capitalise on emerging opportunities. The assessment would also allow us to estimate the anticipated financial effect and quantifying the effects and changes on the financial position.

The Group is at an early stage in assessing its climate resilience, with uncertainty regarding the extent and timing of potential impacts. Its capacity to adapt over time is supported by the operational and planning flexibility inherent in its current business model. The Group intends to explore climate-related scenario analysis that is appropriate to its circumstances, including scenarios aligned with the latest international climate agreements. This will support enhanced understanding, monitoring and disclosure of climate-related risks and opportunities through ongoing risk assessments in the future.

Risk Management

Climate-related risks are managed as part of the Group's overall risk management framework, alongside other risk categories such as strategic, financial, compliance and operational risks. The assessment incorporates key risk management processes to ensure that principal corporate risks are appropriately identified, thoroughly evaluated, and effectively managed and monitored.

In identifying and assessing risks, the Group's risk management process considers both the likelihood and potential impact of each risk. Likelihood is assessed based on historical data and information reasonably available to the Group during the reporting year. Impact is evaluated with reference to factors including financial loss, legal implications, corporate reputation, environmental safety and business operations. The combined assessment of likelihood and impact is then used to categorise risks by severity. Higher-level risks and the corresponding mitigation measures are reported annually to management and the Board.

儘管本集團的業務模式及價值鏈目前並未面臨重大及集中的氣候相關風險及機遇，但本集團定期監測可能影響其運營的相關風險，並努力把握任何相關機遇。倘識別出該等問題，我們將進行相應的風險評估並制定適當的緩解措施。該等發現可為我們當前的運營及業務模式的預期變化提供指引，並分配必要資源以應對氣候相關風險及利用新出現的機遇。該評估亦將使我們能夠估計預期的財務影響，並量化對財務狀況的影響及變動。

本集團對其氣候適應能力的評估尚處於早期階段，潛在影響的程度及時間仍存在不確定性。本集團當前業務模式所具備的運營與規劃靈活性，為其隨時間推移不斷進行適應的能力提供了有力支撐。本集團計劃探索開展適合自身情況的氣候相關情景分析，其中包括與最新國際氣候協定相契合的情景。這將有助本集團於未來透過持續的風險評估，加強對氣候相關風險及機遇的了解、監控及披露。

風險管理

除策略、財務、合規及經營風險等其他風險類別外，本集團將氣候相關風險作為本集團整體風險管理框架的一部分進行管理。該評估納入關鍵風險管理流程，以確保主要企業風險得到適當識別、全面評估以及有效管理及監控。

在識別及評估風險時，本集團的風險管理流程會考慮發生每項風險的可能性及潛在影響。可能性乃根據過往數據及本集團於報告年度合理可得的資料進行評估。影響乃參考包括財務損失、法律影響、企業聲譽、環境安全及業務經營在內的因素進行評估。然後，本集團將對可能性及影響的綜合評估用於按嚴重程度對風險進行分類。較高級別的風險及相應的緩解措施會每年報告予管理層及董事會。

Metrics and Targets

The major sources of the Group's GHG emissions include direct GHG emissions (Scope 1) from petrol consumed by company-owned vehicles, energy indirect GHG emissions (Scope 2) from purchased electricity consumption in offices, and other indirect GHG emissions (Scope 3) from paper waste disposed at landfill (Category 5: Waste Generated in Operations) and employees' air business travels (Category 6: Business Travel).

The Group adopts an operational control approach in calculating its GHG emissions, as this method captures emissions from operations over which the Group has the authority to establish and implement operational policies. Scope 2 GHG emissions are calculated using a location-based approach.

To minimise the environmental impacts of GHG emissions from the Group's business operations, the Group has set a target to reduce its GHG emissions intensity (tCO₂e/employee) by 2026, using the year ended 31 March 2024 ("2024") as the baseline year (2024: 2.75 tCO₂e/employee).

During the Reporting Year, the Group's total GHG emissions intensity was approximately 0.67 tCO₂e/employee, which has decreased by approximately 75.64% compared to the target baseline. The reduction was mainly attributable to effective GHG emissions management. Hence, the Group achieved its target.

Since the period of the target has ended, the Group sets a new target to reduce its GHG emissions intensity (tCO₂e/employee) by the year ended 31 March 2028 ("2028"), using 2026 as the baseline year (2026: 0.67 tCO₂e/employee). The target is applied across the whole entity and covers Scope 1, Scope 2 and Scope 3 GHG emissions. It mainly includes carbon dioxide, methane and nitrous oxide. Meanwhile, the Group will enhance its targets by leveraging international agreements, obtaining third-party validation, and adopting a sectoral decarbonisation approach.

指標與目標

本集團溫室氣體排放的主要來源為公司自有車輛消耗汽油產生的直接溫室氣體排放(範圍1)、辦公室外購電力消耗產生的能源間接溫室氣體排放(範圍2)以及堆填區廢紙處理(第5類:營運產生的廢物)及僱員航空商務差旅(第6類:商務差旅)產生的其他間接溫室氣體排放(範圍3)。

本集團採用運營控制法計算其溫室氣體排放,因為此方法涵蓋了本集團有權制定及實施運營政策的各項業務所產生的排放量。範圍2溫室氣體排放採用基於地域的方法進行計算。

為最大限度地減少本集團業務營運產生的溫室氣體排放對環境的影響,本集團已訂立目標,以截至二零二四年三月三十一日止年度(「二零二四年度」)作為基準年度(二零二四年度:2.75噸二氧化碳當量/僱員),於二零二六年度前減低其溫室氣體排放密度(噸二氧化碳當量/僱員)。

於本報告年度,本集團的總溫室氣體排放密度為每名僱員約0.67噸二氧化碳當量,與目標基準水平相比減少約75.64%。該減少主要歸因於行之有效的溫室氣體排放管理。因此,本集團實現了目標。

由於目標期限已屆滿,本集團設定了新目標,以二零二六年度作為基準年度(二零二六年度:0.67噸二氧化碳當量/僱員),於截至二零二八年三月三十一日止年度(「二零二八年度」)前降低其溫室氣體排放密度(噸二氧化碳當量/僱員)。該目標適用於整個集團,並涵蓋範圍1、範圍2及範圍3的溫室氣體排放。其主要包括二氧化碳、甲烷及一氧化二氮。同時,本集團將通過藉助國際協定、獲取第三方驗證及採用行業脫碳方法來提升其目標。

The Group will continue to monitor its GHG emissions, implement relevant measures and reduce its GHG emissions intensity progressively. The result would be reviewed by the Board annually, in order to achieve the target of reducing GHG emission intensity by 2028. Also, more GHG reduction measures are described in the section headed "Air Emissions" under aspect "Environmental".

The Group has implemented policies to manage GHG emissions from its operations. Meanwhile, the Group seeks to educate its staff members to increase office environmental awareness. More energy conservation measures are described in the section headed “Energy Consumption” under aspect “Environmental”.

The Group is committed to disclosing the amount and percentage of assets or business activities exposed to climate-related transition risks and physical risks, as well as those aligned with climate-related opportunities, where such information is available. During the Reporting Year, the Group did not apply an internal carbon price or utilise carbon credits. Looking ahead, the Group will seek opportunities to strengthen its data capabilities and monitor developments in market and regulatory conditions, with a view to disclosing such information in the future.

AIR EMISSIONS

The major source of the Group's GHG and air emissions is company-owned vehicles. The Group has taken the following measures to minimise the GHG and air emissions from its business operations:

- Choose the shortest route when vehicles are travelling between the Group's operating locations and destinations to reduce consumption of fuel;
- Turn off engines for idling vehicles;
- Conduct regular vehicle maintenance to ensure efficient use of fuel; and
- Encourage employees to hold video conference call.

In order to further strengthen the management of company-owned vehicles, the Group has formulated a comprehensive Vehicle Usage Management Methods to ensure the efficient and responsible use of the vehicles. Key commitments include but are not limited to:

- Strict usage principles: Company vehicles are strictly limited to official business only, and all expenses must be approved and centrally managed.
- Standardised procedures: Use of company vehicles requires prior application and approval, ensuring vehicles are only used for essential business needs.
- Daily and scheduled maintenance: Vehicles undergo daily inspections, monthly checks, and regular maintenance, ensuring optimal vehicle condition and fuel efficiency, which helps reduce emissions.

The Group has adopted various vehicle control measures to minimise the pollutants emitted during its business operation that are described above in this section. Through these measures, the Group demonstrates its commitment to reducing fuel consumption and vehicle emissions, aligning with its broader ESG objectives.

廢氣排放

本集團溫室氣體及廢氣排放的主要來源為公司自有車輛。本集團已採取以下措施，以盡量減低業務營運的溫室氣體及廢氣排放：

- 開車往來本集團的經營地點與目的地時，選擇最短的路線以節省燃油；
- 停車熄匙；
- 定期保養車輛，確保有效使用燃料；及
- 鼓勵僱員舉行視像會議。

為進一步加強公司自有車輛管理，本集團已制定全面的《車輛使用管理辦法》，以確保高效及負責任地使用車輛，核心承諾包括但不限於：

- 嚴格使用原則：公司車輛僅限於公務用途，所有開支須經審批並統一管理。
- 標準化程序：用車須事先申請及獲批，確保僅用於必要公務需求。
- 日常與定期保養：執行每日檢查、月度檢驗及定期維護，保障車輛最佳狀態及燃油效益，從而減少排放。

本集團已採納多項車輛管控措施，以盡量減少本節上文所述業務營運過程中排放的污染物。透過此等措施，本集團彰顯其致力減少油耗及車輛排放的承諾，契合更廣泛的環境、社會及管治目標。

Due to the increased usage of vehicles from operational needs, the Group's total air emissions have increased during the Reporting Year as compared to 2025 due to the increased usage of vehicles. The Group's air emissions performance was as follows:

SEWAGE DISCHARGE

Due to the Group's minimal water consumption in its daily operation, there were no significant water discharges during the Reporting Year. Moreover, the management office of the building exclusively handles water supply and discharge, making it impractical to provide water withdrawal and discharge data or sub-metering specifically for the Group as an individual occupant. More water conservation measures are described in the section headed "Water Consumption" under aspect "Environmental".

WASTE MANAGEMENT

Hazardous Waste

In view of the Group's business nature, the Group did not generate a material amount of hazardous waste during the Reporting Year. Where it is required to handle hazardous waste, the Group will independently store and transport the hazardous waste to third-party professionals for safe and legal processing.

Non-hazardous Waste

The non-hazardous waste generated by the Group is mainly office paper from daily business operations. During 2025, the Group has set target to maintain the total non-hazardous waste disposal intensity (tonnes/employee) at the level of 0.02 tonnes/employee for 2026. To achieve the target, the Group has taken various measures to minimise the environmental impact and promote "green office" concept. In particular, the Group promotes "think before you print" attitude in order to encourage paperless offices by facilitating the use of electronic means for communication such as intranet, email, internal workflow system to reduce printing and paper copies. Moreover, the reduction measures for other kinds of waste include:

- Set up recycling bins to collect recyclable products; and
- Encourage employees to reduce the use of one-off products.

During the Reporting Year, the Group's total non-hazardous waste disposal intensity was approximately 0.01 tonnes/employee, which stayed the same with 2025 due to effective reduction measures. Hence, the Group achieved its target.

廢物管理

有害廢物

鑒於本集團的業務性質，本集團於本報告年度並無產生大量有害廢物。於需要處理有害廢物時，本集團會將有害廢物獨立儲存及運送給第三方專業機構以進行安全合法的處理。

無害廢物

本集團產生的無害廢物主要為日常業務營運中的辦公用紙。於二零二五年度，本集團已制定目標，在二零二六年度將總無害廢物棄置密度（噸／僱員）維持在每名僱員0.02噸的水平。為達致該目標，本集團已採取多種措施減低對環境的影響並提倡「綠色辦公」的理念。本集團特別提倡「複印前三思」理念，鼓勵無紙化辦公，推廣使用電子通訊方式，例如內聯網、電郵、內部工作流程系統等，減少打印及影印。此外，其他類型廢棄物的減廢措施包括：

- 放置回收箱收集可回收產品；及
- 鼓勵員工減少使用一次性產品。

於本報告年度，由於採取了有效的減廢措施，本集團的總無害廢物棄置密度約為每名僱員0.01噸，與二零二五年度持平。因此，本集團實現了目標。

Since the period of the target has ended, the Group sets a new target to maintain the total non-hazardous waste disposal intensity (tonnes/employee) by the year ended 31 March 2027 ("2027"), using 2024 as the baseline year (0.02 tonnes/employee). The Group will continue to monitor the amount of non-hazardous waste it generates and implement relevant measures so as to reduce its non-hazardous waste intensity progressively.

ENERGY CONSUMPTION

能源消耗

The major sources of the Group's energy consumption were direct energy consumption from petrol consumed by company-owned vehicles and indirect energy consumption from purchased electricity used in the offices. To minimise the environmental impacts of energy consumption from the Group's business operations, the Group has set target to reduce the total energy consumption intensity (kWh/employee) by 2026, using 2024 as the baseline year (2024: 8,694.14 kWh/employee).

本集團能源消耗的主要來源為公司自有車輛消耗汽油產生的直接能源消耗以及辦公室耗用的外購電力產生的間接能源消耗。為將本集團業務營運過程中的能源消耗對環境的影響減至最小，本集團已制定目標，以二零二四年度作為基準年度（二零二四年度：8,694.14千瓦時／僱員），於二零二六年度前降低總能源消耗密度（千瓦時／僱員）。

To achieve the target, the Group has implemented company-owned vehicles management methods as described in the section headed "Air Emissions" to reduce its energy consumption by company-owned vehicles. In addition, the Group encourages employees to establish energy-saving habits at offices and has also implemented various energy-saving measures including:

- Replace lighting control system with light emitting diode ("LED") bulbs;
- Maintain indoor temperature at 25.5°C;
- Conduct regular maintenance to avoid excessive electricity usage;
- Use electronic devices in energy-saving mode where possible;
- Lower the brightness of the monitor screen;
- Switch off the monitors during lunch hours; and
- Turn off the light when leaving the offices.

During the Reporting Year, the Group's total energy consumption intensity was approximately 1,012.63 kWh/employee, which has decreased by approximately 88.35% compared to the baseline year. The main reason for the reduction was the effective energy-saving measures. Hence, the Group has achieved its target.

Since the period of the target has ended, the Group sets a new target to maintain the total energy consumption intensity (kWh/employee) by 2028, using 2026 as the baseline year (2026: 1,012.63 kWh/employee). The Group will continue to monitor its energy consumption and implement relevant measures, reducing its energy consumption intensity progressively.

WATER CONSUMPTION

水源消耗

As the Group operates in office premises of which both the water supply and discharge are solely controlled by the building's management office, there is no issue in sourcing water that is fit for purpose. The provision of water withdrawal and discharge data or sub-meter for the Group as an individual occupant is not available, therefore target setting for water efficiency is not applicable. The Group's water consumption is minimal. Yet, the Group promotes water-saving practices in the workplace by encouraging its employees to reduce water use in order to raise awareness on water conservation, including:

- Assessing the competence, independence and integrity of the external valuers engaged by the Company;
- Obtaining the external valuation reports and meeting with the external valuers to discuss and challenge the valuation process, methodologies used and market evidence to support significant judgments and assumptions applied in the valuation model;
- Checking key assumptions and input data in the valuation model to supporting evidence;
- Checking arithmetical accuracy of the valuation model; and
- Assessing the disclosure of the fair value measurement in the consolidated financial statements.

NOTES TO THE CONSOLIDATED FINANCIAL STATEMENTS

1. GENERAL INFORMATION

GoFintech Quantum Innovation Limited (the “**Company**”) was incorporated in the Cayman Islands as an exempted company with limited liability. The address of its registered office is Suite 102, Cannon Place, P.O. Box 712, North Sound Rd., George Town, Grand Cayman, KY1-9006, Cayman Islands. The address of its principal place of business is Units No. 4102-06, 41/F, COSCO Tower, 183 Queen’s Road Central, Hong Kong. The Company’s shares are listed on the Main Board of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”).

The Company is an investment holding company. The principal activities of the subsidiaries of the Company are set out in note 18 to the consolidated financial statements.

2. ADOPTION OF NEW AND REVISED HKFRS ACCOUNTING STANDARDS

In the current year, the Company and its subsidiaries (collectively referred to as the “**Group**”) have adopted all the new and revised HKFRS Accounting Standards issued by the Hong Kong Institute of Certified Public Accountants (the “**HKICPA**”) that are relevant to its operations and effective for its accounting year beginning on 1 April 2025. HKFRS Accounting Standards comprise Hong Kong Financial Reporting Standards (“**HKFRS**”); Hong Kong Accounting Standards; and Interpretations. The adoption of these new and revised HKFRS Accounting Standards did not result in significant changes to the Group’s accounting policies, presentation of the Group’s consolidated financial statements and amounts reported for the current year and prior years.

The Group has not applied the new and revised HKFRS Accounting Standards that have been issued but are not yet effective. The Group has already commenced an assessment of the impact of these new and revised HKFRS Accounting Standards but is not yet in a position to state whether these new and revised HKFRS Accounting Standards would have a material impact on its results of operations and financial position.

1. 一般資料

國富量子創新有限公司(「**本公司**」)於開曼群島註冊成立為一家受豁免有限公司。註冊辦事處地址為 Suite 102, Cannon Place, P.O. Box 712, North Sound Rd., George Town, Grand Cayman, KY1-9006, Cayman Islands。主要營業地點地址為香港皇后大道中183號中遠大廈41樓4102-06室。本公司股份於香港聯合交易所有限公司(「**聯交所**」)主板上市。

本公司為投資控股公司。本公司附屬公司之主要業務載於綜合財務報表附註18。

2. 採納新訂及經修訂香港財務報告準則會計準則

於本年度，本公司及其附屬公司(統稱「**本集團**」)已採納香港會計師公會(「**香港會計師公會**」)頒佈之與本集團業務相關並於二零二五年四月一日開始之會計年度生效之所有新訂及經修訂香港財務報告準則會計準則。香港財務報告準則會計準則包括所有香港財務報告準則(「**香港財務報告準則**」)、香港會計準則及詮釋。採納該等新訂及經修訂香港財務報告準則會計準則並無導致本集團之會計政策、本集團綜合財務報表之呈列以及本年度及過往年度呈報之金額出現重大變動。

本集團並無應用已頒佈但尚未生效之新訂及經修訂香港財務報告準則會計準則。本集團已開始評估該等新訂及經修訂香港財務報告準則會計準則之影響，惟尚未能確定該等新訂及經修訂香港財務報告準則會計準則會否對其經營業績及財務狀況構成重大影響。

3. MATERIAL ACCOUNTING POLICIES

These consolidated financial statements have been prepared in accordance with HKFRS Accounting Standards issued by the HKICPA, accounting principles generally accepted in Hong Kong and the applicable disclosures required by the Rules Governing the Listing of Securities on the Stock Exchange (the “**Listing Rules**”) and by the Hong Kong Companies Ordinance.

These consolidated financial statements have been prepared under the historical cost convention, as modified by investments and derivative which are carried at their fair values.

The preparation of consolidated financial statements in conformity with HKFRS Accounting Standards requires the use of certain key assumptions and estimates. It also requires the directors to exercise its judgements in the process of applying the accounting policies. The areas involving critical judgements and areas where assumptions and estimates are significant to these consolidated financial statements, are disclosed in note 4 to the consolidated financial statements.

The material accounting policies applied in the preparation of these consolidated financial statements are set out below.

CONSOLIDATION

The consolidated financial statements include the financial statements of the Company and its subsidiaries made up to 31 March. Subsidiaries are entities over which the Group has control. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. The Group has power over an entity when the Group has existing rights that give it the current ability to direct the relevant activities, i.e. activities that significantly affect the entity's returns.

3. 重大會計政策

此等綜合財務報表乃根據香港會計師公會頒佈之香港財務報告準則會計準則、香港公認會計原則以及聯交所證券上市規則(「**上市規則**」)及香港《公司條例》之適用披露規定編製。

此等綜合財務報表乃根據歷史成本慣例編製，並就若干按公平值列賬之投資及衍生工具作出修訂。

編製符合香港財務報告準則會計準則之綜合財務報表須使用若干主要假設及估計。董事亦須於應用會計政策之過程中作出判斷。涉及重大判斷之範疇以及假設及估計對此等綜合財務報表而言屬重大之範疇於綜合財務報表附註4披露。

編製該等綜合財務報表應用的重大會計政策載列如下。

綜合賬目

綜合財務報表包括本公司及其附屬公司截至三月三十一日之財務報表。附屬公司為本集團對其擁有控制權的實體。當本集團因參與實體業務而承擔可變動回報的風險或享有可變動回報，且有能力透過向實體施加權力而影響該等回報時，則本集團控制該實體。當本集團的現有權利使其現時能夠主導相關活動(即對實體之回報有重大影響力的活動)時，則本集團對該實體擁有權力。

When assessing control, the Group considers its potential voting rights as well as potential voting rights held by other parties, to determine whether it has control. A potential voting right is considered only if the holder has the practical ability to exercise that right.

Subsidiaries are consolidated from the date on which control is transferred to the Group. They are de-consolidated from the date the control ceases.

The gain or loss on the disposal of a subsidiary that results in a loss of control represents the difference between (i) the fair value of the consideration of the sale plus the fair value of any investment retained in that subsidiary and (ii) the Company's share of the net assets of that subsidiary plus any remaining goodwill relating to that subsidiary and any related accumulated foreign currency translation reserve.

Intragroup transactions, balances and unrealised profits are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the asset transferred. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Group.

綜合賬目 (續)

在評估控制權時，本集團會考慮其潛在投票權以及其他人士持有的潛在投票權，以釐定其是否擁有控制權。潛在投票權僅在持有人有實際能力行使該權利時，方會予以考慮。

附屬公司自控制權轉移至本集團之日起開始綜合入賬。自本集團喪失控制權之日起終止綜合入賬。

出售附屬公司（導致失去控制權）的收益或虧損指以下兩項的差額：(i) 出售代價的公平值加上於該附屬公司保留的任何投資的公平值及(ii) 本公司應佔該附屬公司的資產淨值加上與該附屬公司有關的任何剩餘商譽及任何相關累計外幣換算儲備。

集團內公司間的交易、結餘及未變現溢利予以對銷。除非交易提供所轉讓資產減值的證據，否則未變現虧損亦予以對銷。如有必要，為保持與本集團採納的政策一致，附屬公司的會計政策已做修改。

ASSOCIATES

Associates are entities over which the Group has significant influence. Significant influence is the power to participate in the financial and operating policy decisions of an entity but is not control or joint control over those policies. The existence and effect of potential voting rights that are currently exercisable or convertible, including potential voting rights held by other entities, are considered when assessing whether the Group has significant influence. In assessing whether a potential voting right contributes to significant influence, the holder's intention and financial ability to exercise or convert that right is not considered.

Investment in an associate is accounted for in the consolidated financial statements by the equity method and is initially recognised at cost. Identifiable assets and liabilities of the associate in an acquisition are measured at their fair values at the acquisition date. The excess of the cost of acquisition over the Group's share of the net fair value of the associate's identifiable assets and liabilities is recorded as goodwill. The goodwill is included in the carrying amount of the investment and is tested for impairment together with the investment at the end of each reporting period when there is objective evidence that the investment is impaired. Any excess of the Group's share of the net fair value of the identifiable assets and liabilities over the cost of acquisition is recognised in consolidated profit or loss.

The Group's share of an associate's post-acquisition profits or losses is recognised in consolidated profit or loss, and its share of the post-acquisition movements in reserves is recognised in the consolidated reserves. The cumulative post-acquisition movements are adjusted against the carrying amount of the investment. When the Group's share of losses in an associate equals or exceeds its interest in the associate, including any other unsecured receivables, the Group does not recognise further losses, unless it has incurred obligations or made payments on behalf of the associate. If the associate subsequently reports profits, the Group resumes recognising its share of those profits only after its share of the profits equals the share of losses not recognised.

3. 重大會計政策 (續)

聯營公司

聯營公司指本集團對其有重大影響力的實體。重大影響力指有權參與實體的財務及經營政策決策，但並非對該等政策擁有控制權或共同控制權。於評估本集團是否有重大影響力時，會考慮目前可行使或可轉換的潛在投票權（包括其他實體持有的潛在投票權）的存在及影響。於評估潛在投票權是否有重大影響力時，不會考慮持有人行使或轉換該權利的意向及財務能力。

於聯營公司的投資按權益法於綜合財務報表入賬，並初步按成本確認。於一項收購中可識別的聯營公司資產及負債按其於收購日期的公平值計量。收購成本超出本集團應佔聯營公司可識別資產及負債的公平值淨值的差額入賬列作商譽。商譽計入投資的賬面值，並於有客觀證據顯示投資出現減值時於各報告期末連同投資一併進行減值測試。本集團應佔可識別資產及負債的公平值淨值超出收購成本的任何差額於綜合損益中確認。

本集團應佔聯營公司之收購後溢利或虧損於綜合損益中確認，而其應佔收購後儲備變動則於綜合儲備內確認。累計收購後變動就投資之賬面值作出調整。倘本集團應佔聯營公司虧損等於或超過其於聯營公司的權益（包括任何其他無抵押應收款項），則本集團不會確認進一步虧損，除非本集團已產生責任或代表聯營公司付款。倘該聯營公司其後錄得溢利，則本集團僅於其應佔溢利足以彌補其未確認之應佔虧損後方會恢復確認其應佔溢利。

The gain or loss on the disposal of an associate that results in a loss of significant influence represents the difference between (i) the fair value of the consideration of the sale plus the fair value of any investment retained in that associate and (ii) the Group's share of the net assets of that associate plus any remaining goodwill relating to that associate and any related accumulated foreign currency translation reserve. If an investment in an associate becomes an investment in a joint venture, the Group continues to apply the equity method and does not remeasure the retained interest.

Unrealised profits on transactions between the Group and its associates are eliminated to the extent of the Group's interests in the associates. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the asset transferred. Accounting policies of associates have been changed where necessary to ensure consistency with the policies adopted by the Group.

Reciprocal interests in the Company held by an associate

One of the Group's associates holds equity interests in the Company ("Reciprocal Interests") and accounts for the Reciprocal Interests as investments at fair value through profit or loss. All income of this associate arising from the Reciprocal Interests is eliminated before the Group accounts for this associate using equity method. In addition, the Group treats its effective interest in the Reciprocal Interests held by this associate as share buy back and reduces the Group's equity and investment in this associate accordingly.

聯營公司(續)

出售聯營公司(導致失去重大影響力)的收益或虧損指以下兩項的差額:(i)出售代價的公平值加上於該聯營公司保留的任何投資的公平值及(ii)本集團應佔該聯營公司的資產淨值加上與該聯營公司有關的任何剩餘商譽及任何相關累計外幣換算儲備。倘於一間聯營公司的投資變成於一間合營企業的投資,則本集團繼續採用權益法且不會重新計量保留權益。

本集團與其聯營公司之間交易的未變現溢利以本集團於聯營公司的權益為限予以對銷。除非交易提供所轉讓資產減值的證據,否則未變現虧損亦予以對銷。聯營公司的會計政策已作出必要的調整,以確保與本集團所採納的政策一致。

一間聯營公司持有之本公司互惠權益

本集團一間聯營公司持有本公司股權(「互惠權益」),並將互惠權益入賬列為按公平值列入損益賬之投資。於本集團以權益法將該聯營公司入賬前,該聯營公司產生自互惠權益之所有收入均予以對銷。此外,本集團將其於該聯營公司所持互惠權益之實際權益視為股份購回,並相應削減本集團於該聯營公司之權益及投資。

FOREIGN CURRENCY TRANSLATION

(a) Functional and presentation currency

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the **"functional currency"**). The consolidated financial statements are presented in Hong Kong dollars (**"HK\$"**), which are the Company's functional and presentation currency.

(b) Transactions and balances in each entity's financial statements

Transactions in foreign currencies are translated into the functional currency on initial recognition using the exchange rates prevailing on the transaction dates. Monetary assets and liabilities in foreign currencies are translated at the exchange rates at the end of each reporting period. Gains and losses resulting from this translation policy are recognised in profit or loss.

Non-monetary items that are measured at fair values in foreign currencies are translated using the exchange rates at the dates when the fair values are determined.

When a gain or loss on a non-monetary item is recognised in other comprehensive income, any exchange component of that gain or loss is recognised in other comprehensive income. When a gain or loss on a non-monetary item is recognised in profit or loss, any exchange component of that gain or loss is recognised in profit or loss.

(c) Translation on consolidation

The results and financial position of all the Group entities that have a functional currency different from the Company's presentation currency are translated into the Company's presentation currency as follows:

- (i) Assets and liabilities for each statement of financial position presented are translated at the closing rate at the date of that statement of financial position;
- (ii) Income and expenses are translated at average exchange rates (unless this average is not a reasonable approximation of the cumulative effect of the rates prevailing on the transaction dates, in which case income and expenses are translated at the exchange rates on the transaction dates); and
- (iii) All resulting exchange differences are recognised in the exchange reserve.

On consolidation, exchange differences arising from the translation of the net investment in foreign entities and of borrowings are recognised in the exchange reserve. When a foreign operation is sold, such exchange differences are recognised in consolidated profit or loss as part of the gain or loss on disposal.

PROPERTY AND EQUIPMENT

Property and equipment are stated at cost less accumulated depreciation and impairment losses.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. All other repairs and maintenance are recognised in profit or loss during the period in which they are incurred.

Depreciation of property and equipment is calculated at rates sufficient to write off their cost less their residual values over the estimated useful lives on a straight-line basis. The principal annual rates are as follows:

The residual values, useful lives and depreciation method are reviewed and adjusted, if appropriate, at the end of each reporting period.

The gain or loss on disposal of equipment is the difference between the net sales proceeds and the carrying amount of the relevant asset, and is recognised in profit or loss.

LEASES

Leases are recognised as right-of-use assets and corresponding lease liabilities when the leased assets are available for use by the Group. Right-of-use assets are stated at cost less accumulated depreciation and impairment losses. Depreciation of right-of-use assets is calculated at rates to write off their cost over the shorter of the asset's useful life and the lease term on a straight-line basis. The principal useful lives of office premises and warehouse is 2 to 3 years.

Right-of-use assets are measured at cost comprising the amount of the initial measurement of the lease liabilities, lease payments prepaid, initial direct costs and the restoration costs. Lease liabilities include the net present value of the lease payments discounted using the interest rate implicit in the lease if that rate can be determined, or otherwise the Group's incremental borrowing rate. Each lease payment is allocated between the liability and finance cost. The finance cost is charged to profit or loss over the lease term so as to produce a constant periodic rate of interest on the remaining balance of the lease liability.

Payments associated with short-term leases and leases of low-value assets are recognised as expenses in profit or loss on a straight-line basis over the lease terms. Short-term leases are leases with an initial lease term of 12 months or less. Low-value assets are assets of value below United States dollars ("US\$") 5,000.

INTANGIBLE ASSETS

Cryptocurrencies purchased and held by the Group through third-party custodian service providers mainly include Bitcoins, which is accounted for as intangible assets under the cost model. The Group has ownership of and control over the cryptocurrencies held and employs third party custodian service provider to securely store them. The cryptocurrencies held by the Group are considered to have an indefinite life. Accordingly, they are not subject to amortisation and are tested annually for impairment, or more frequently if events or changes in circumstances indicate that they might be impaired.

Club membership with indefinite useful life is stated at cost less any impairment losses. Impairment is reviewed annually or when there is any indication that intangible assets has suffered an impairment loss.

INVESTMENTS IN ARTWORKS

Artworks, including porcelain and collectible Chinese arts, which are held for long-term investment purposes and not traded in the ordinary course of business are initially measured at cost. Subsequent to initial recognition, investments in artworks purposes are stated at fair value with gains and losses from the change in fair value recognised in the statement of profit or loss.

本集團透過第三方託管服務商購入及持有的加密貨幣主要包括比特幣，該加密貨幣按成本模式作為無形資產入賬。本集團對所持加密貨幣擁有所有權及控制權，並聘用第三方託管服務商安全儲存該等貨幣。本集團持有的加密貨幣被視為具有無限年期，因此毋須進行攤銷，但須每年進行減值測試；倘發生事件或情況變化顯示可能出現減值，則進行更頻密的減值測試。

具無限可使用年期之會籍按成本減任何減值虧損列賬。無形資產每年或於有跡象顯示發生減值虧損時進行減值檢討。

藝術品投資

藝術品（包括持作長期投資目的且並非於日常業務過程中交易的瓷器及具收藏價值的中國藝術品）初始按成本計量。初步確認後，藝術品投資按公平值列賬，公平值變動產生的收益及虧損於損益表中確認。

Financial assets and financial liabilities are recognised in the statement of financial position when the Group becomes a party to the contractual provisions of the instruments.

Financial assets are derecognised when the contractual rights to receive cash flows from the assets expire; the Group transfers substantially all the risks and rewards of ownership of the assets; or the Group neither transfers nor retains substantially all the risks and rewards of ownership of the assets but has not retained control on the assets. On derecognition of a financial asset, the difference between the asset's carrying amount and the sum of the consideration received is recognised in profit or loss.

Financial liabilities are derecognised when the obligation specified in the relevant contract is discharged, cancelled or expires. The difference between the carrying amount of the financial liability derecognised and the consideration paid is recognised in profit or loss.

Financial assets are recognised and derecognised on a trade date basis where the purchase or sale of an asset is under a contract whose terms require delivery of the asset within the timeframe established by the market concerned, and are initially recognised at fair value, plus directly attributable transaction costs except in the case of investments at fair value through profit or loss. Transaction costs directly attributable to the acquisition of investments at fair value through profit or loss are recognised immediately in profit or loss.

- the assets are held within a business model whose objective is to hold assets in order to collect contractual cash flows; and
- the contractual terms of the assets give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

They are subsequently measured at amortised cost using the effective interest method less loss allowance for expected credit losses.

Investments at fair value through profit or loss are subsequently measured at fair value with any gains or losses arising from changes in fair values recognised in profit or loss. The fair value gains or losses recognised in profit or loss are net of any interest income and dividend income. Interest income and dividend income are recognised in profit or loss.

LOSS ALLOWANCES FOR EXPECTED CREDIT LOSSES

The Group recognises loss allowances for expected credit losses (“ECL”) on financial assets at amortised cost. ECL are the weighted average of credit losses with the respective risks of a default occurring as the weights.

At the end of each reporting period, the Group measures the loss allowance for a financial instrument at an amount equal to the ECL that result from all possible default events over the expected life of that financial instrument (“lifetime ECL”) for trade receivables and contract assets, or if the credit risk on that financial instrument has increased significantly since initial recognition.

If, at the end of the reporting period, the credit risk on a financial instrument (other than trade receivable and contract assets) has not increased significantly since initial recognition, the Group measures the loss allowance for that financial instrument at an amount equal to the portion of lifetime ECL that represents the ECL that result from default events on that financial instrument that are possible within 12 months after the reporting period.

The amount of ECL or reversal to adjust the loss allowance at the end of the reporting period to the required amount is recognised in profit or loss as an impairment gain or loss.

CASH AND CASH EQUIVALENTS

For the purpose of the consolidated statement of cash flows, cash and cash equivalents represent cash at bank and on hand, demand deposits with banks and other financial institutions, and short-term highly liquid investments which are readily convertible into known amounts of cash and subject to an insignificant risk of change in value.

FINANCIAL LIABILITIES AND EQUITY INSTRUMENTS

Financial liabilities and equity instruments are classified according to the substance of the contractual arrangements entered into and the definitions of a financial liability and an equity instrument under HKFRS Accounting Standards. An equity instrument is any contract that evidences a residual interest in the assets of the Group after deducting all of its liabilities. The accounting policies adopted for specific financial liabilities and equity instruments are set out below.

金融負債及股本工具

金融負債及股本工具乃根據所訂立合約安排之實質內容及香港財務報告準則會計準則項下金融負債及股本工具之定義分類。股本工具乃證明於本集團扣減所有負債後之資產中擁有剩餘權益之任何合約。就特定金融負債及股本工具採納之會計政策載於下文。

BORROWINGS

Borrowings are initially recognised at fair value, net of transaction costs incurred, and subsequently measured at amortised cost using the effective interest method.

Borrowings are classified as current liabilities unless the Group has an unconditional right to defer settlement of the liability for at least 12 months after the reporting period.

TRADE AND OTHER PAYABLES

Trade and other payables are initially recognised at fair value and subsequently measured at amortised cost using the effective interest method unless the effect of discounting would be immaterial, in which case they are stated at cost.

DERIVATIVE FINANCIAL INSTRUMENTS

Derivatives are initially recognised and subsequently measured at fair value with any gains or losses arising from changes in fair values recognised in profit or loss.

EQUITY INSTRUMENTS

Equity instruments issued by the Company are recorded at the proceeds received, net of direct issue costs.

借款

借款初步按公平值扣除所產生之交易成本確認，並其後以實際利率法按攤銷成本計算。

除非本集團擁有無條件權利，可將負債之償還日期遞延至報告期後至少十二個月，否則借款被分類為流動負債。

貿易及其他應付款項

貿易及其他應付款項初步按公平值確認，其後採用實際利率法按攤銷成本計量，惟倘貼現影響並不重大，則按成本列賬。

衍生金融工具

衍生工具初步按公平值確認，其後按公平值計量，而公平值變動產生的任何收益或虧損於損益確認。

股本工具

本公司發行的股本工具按已收所得款項(扣除直接發行成本)入賬。

REVENUE FROM CONTRACTS WITH CUSTOMERS

Revenue is measured based on the consideration specified in a contract with a customer with reference to the customary business practices and excludes amounts collected on behalf of third parties. For a contract where the period between the payment by the customer and the transfer of the promised product or service exceeds one year, the consideration is adjusted for the effect of a significant financing component.

The Group recognises revenue when it satisfies a performance obligation by transferring control over a product or service to a customer. Depending on the terms of a contract and the laws that apply to that contract, a performance obligation can be satisfied over time or at a point in time. A performance obligation is satisfied over time if:

- the customer simultaneously receives and consumes the benefits provided by the Group's performance;
- the Group's performance creates or enhances an asset that the customer controls as the asset is created or enhanced; or
- the Group's performance does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

If a performance obligation is satisfied over time, revenue is recognised by reference to the progress towards complete satisfaction of that performance obligation. Otherwise, revenue is recognised at a point in time when the customer obtains control of the product or service.

收入乃根據與客戶訂立的合約所訂明的代價並參考常規商業慣例計量，且不包括代表第三方收取的金額。對於客戶付款與轉移承諾產品或服務之間的期間超過一年的合約，會就重大融資部分的影響對代價作出調整。

當本集團將產品或服務的控制權轉移給客戶，從而履行了履約責任時，就會確認收入。根據合約條款及適用於該合約的法律，履約責任可隨著時間的推移或於某一時間點履行。倘符合以下條件，則履約責任隨時間履行：

- 客戶同時取得並消耗本集團履約所帶來的利益；
- 本集團的履約創建或提升了客戶在資產被創建或提升時控制的資產；或
- 本集團的履約未創建對本集團具有替代用途的資產，而本集團具有可強制執行的權利收取至今已履約部分的款項。

倘履約責任隨時間達成，則收入乃參考完全達成履約責任的進度確認。否則收入於客戶取得產品或服務控制權的時間點確認。

OTHER REVENUE

Interest income is recognised using the effective interest method.

Dividend income is recognised when the shareholders' rights to receive payment are established.

EMPLOYEE BENEFITS

(a) Employee leave entitlements

Employee entitlements to annual leave and long service leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave and long service leave as a result of services rendered by employees up to the end of the reporting period.

Employee entitlements to sick leave and maternity leave are not recognised until the time of leave.

(b) Pension obligations

The Group operates a Mandatory Provident Fund ("MPF") under the Mandatory Provident Fund Schemes Ordinance, for those employees who are eligible to participate in the MPF Scheme. Contributions are made based on a percentage of the employee's basic salaries and charged to the consolidated statement of profit or loss and other comprehensive income when employees have rendered service entitling them to the contributions. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme.

利息收入採用實際利率法確認。

股息收入於股東收取付款的權利確定時確認。

僱員福利

(a) 僱員應享假期

僱員應享年假及長期服務休假於僱員應享有假期時確認。已就截至報告期末因僱員提供服務而產生的年假及長期服務休假的估計負債計提撥備。

僱員應享病假及產假於休假時方予以確認。

(b) 退休金責任

本集團根據強制性公積金(「強積金」)計劃條例，為合資格參加強積金計劃之僱員設立強積金。本集團根據有關僱員之基本薪金之一定百分比作出供款，並於僱員提供服務而有權享有供款時在綜合損益及其他全面收益表中扣除。強積金計劃之資產與本集團之資產分開，由獨立管理之基金持有。本集團對強積金計劃作出之僱主供款於繳款時乃全數歸屬有關僱員。

(b) Pension obligations (Continued)

Pursuant to the regulations of the relevant authorities in the People's Republic of China ("PRC"), the subsidiaries of the Company in PRC participate in local municipal government retirement benefit scheme (the "Scheme") whereby the subsidiaries are required to contribute to the Scheme to fund the retirement benefits of the eligible employees. Contributions made to the Scheme are calculated based on certain percentages of the applicable payroll costs as stipulated under the requirement in the PRC. The relevant authorities of the PRC are responsible for the entire pension obligations payable to the retired employees. The only obligation of the Group with respect to the Scheme is to pay the ongoing required contribution under the Scheme.

SHARE-BASED PAYMENTS

The Group issues equity-settled share-based payments to certain director and employees.

Equity-settled share-based payments to director and employees are measured at the fair value (excluding the effect of non market-based vesting conditions) of the equity instruments at the date of grant. The fair value determined at the grant date of the equity-settled share-based payments is expensed on a straight-line basis over the vesting period, based on the Group's estimate of shares that will eventually vest and adjusted for the effect of non market-based vesting conditions.

(b) 退休金責任 (續)

根據中華人民共和國(「中國」)相關機構之法規，本公司在中國之附屬公司參與地方市政府退休福利計劃(「該計劃」)，據此，附屬公司須為該計劃供款以資助合資格僱員之退休福利。為該計劃作出之供款乃根據中國有關規定所要求之適用薪金之若干百分比計算。中國之相關機構負責應付予退休僱員之全部退休金責任。本集團就該計劃之唯一責任為根據該計劃持續作出所需供款。

股份支付

本集團向若干董事及僱員作出以權益結算的股份支付。

向董事及僱員作出的以權益結算的股份支付乃按股本工具於授出日期的公平值(不計及非市場歸屬條件的影響)計量。以權益結算的股份支付於授出日期釐定的公平值乃根據本集團對最終歸屬股份的估計，於歸屬期內按直線法支銷，並就非市場歸屬條件的影響作出調整。

When the share options are exercised, the amount previously recognised in share-based payment reserve will be transferred to share capital and share premium. When the share options are forfeited or lapsed after the vesting date or are still not exercised at the expiry date, the amount previously recognised in share-based payment reserve will be transferred to retained profits/accumulated losses.

BORROWING COSTS

All borrowing costs are recognised in profit or loss in the period in which they are incurred.

GOVERNMENT GRANTS

A government grant is recognised when there is reasonable assurance that the Group will comply with the conditions attaching to it and that the grant will be received.

TAXATION

Income tax represents the sum of the current tax and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit recognised in profit or loss because it excludes items of income or expense that are taxable or deductible in other years and it further excludes items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

政府補助

當能夠合理地保證本集團將符合政府補助的附帶條件以及將會得到補助時，便會確認政府補助。

稅務

所得稅指即期稅項與遞延稅項的總和。

即期應付稅項乃根據年內的應課稅溢利計量。應課稅溢利與於損益內確認的溢利不同，原因為其不包括於其他年度的應課稅收入項目或可扣稅開支項目，亦不包括毋須課稅或不可扣稅的項目。本集團的即期稅項負債乃按於報告期末已頒佈或實質上已頒佈的稅率計算。

Deferred tax is recognised on differences between the carrying amounts of assets and liabilities in the financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences and deferred tax assets are recognised to the extent that it is probable that taxable profits will be available against which deductible temporary differences, unused tax losses or unused tax credits can be utilised. Such assets and liabilities are not recognised if the temporary difference arises from goodwill or from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries and associates, and interests in joint ventures, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax is calculated at the tax rates that are expected to apply in the period when the liability is settled or the asset is realised, based on tax rates that have been enacted or substantively enacted by the end of the reporting period. Deferred tax is recognised in profit or loss, except when it relates to items recognised in other comprehensive income or directly in equity, in which case the deferred tax is also recognised in other comprehensive income or directly in equity.

The measurement of deferred tax assets and liabilities reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income taxes levied by the same taxation authority and the Group intends to settle its current tax assets and liabilities on a net basis.

SEGMENT REPORTING

Operating segments and the amounts of each segment item reported in the consolidated financial statements are identified from the financial information provided regularly to the Group's most senior executive management for the purpose of allocating resources and assessing the performance of the Group's various lines of business.

Individually material operating segments are not aggregated for financial reporting purposes unless the segments have similar economic characteristics and are similar in respect of the nature of products and services, the nature of productions processes, the type or class of customers, the methods used to distribute the products or provide the services, and the nature of the regulatory environment. Operating segments which are not individually material may be aggregated if they share a majority of these criteria.

IMPAIRMENT OF ASSETS

Intangible assets that have an indefinite useful life or not yet available for use are reviewed annually for impairment and are reviewed for impairment whenever events or changes in circumstances indicate the carrying amount may not be recoverable.

Cryptocurrencies purchased and held by the Group have been assessed based on each type of cryptocurrencies for impairment testing. The Group carries out their impairment testing by comparing the recoverable amounts of cryptocurrencies to their carrying amounts. An impairment loss will be recognised when the recoverable amount is lower than the carrying amount, while a gain will not be recognised even when the recoverable amount is higher than the carrying amount. A gain will only be recognised if the impairment loss is recovered or the cryptocurrency is disposed of, assuming the proceeds from disposal at that time is higher than its carrying amount.

At the end of each reporting period, the Group reviews the carrying amounts of its tangible and intangible assets except investments and receivables to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of any impairment loss. Where it is not possible to estimate the recoverable amount of an individual asset, the Group estimates the recoverable amount of the cash generating unit to which the asset belongs.

Recoverable amount is the higher of fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset.

對具有無限可使用年期或尚未可供使用的無形資產進行年度減值測試，並在事件或情況變化表明賬面值可能無法收回時進行減值測試。

本集團所購入及持有的加密貨幣根據類別進行減值測試。本集團透過比較加密貨幣的可收回金額與其賬面值進行減值測試。當可收回金額低於賬面值時，須確認減值虧損，而即使可收回金額高於賬面值，亦不會確認收益。僅於減值虧損獲轉回或出售加密貨幣（假設當時出售所得款項高於其賬面值）時，方會確認收益。

於各報告期末，本集團檢討其有形及無形資產（投資及應收款項除外）的賬面值，以釐定是否有任何跡象顯示該等資產出現減值虧損。倘存在任何減值跡象，則估計資產的可收回金額，以釐定減值虧損的程度。倘無法估計單項資產的可收回金額，本集團會估計該項資產所屬現金產生單位的可收回金額。

可收回金額為公平值減出售成本後金額與使用價值兩者中的較高者。評估使用價值時，估計日後現金流量按可反映金錢時間價值及資產特定風險的現時市場評估的稅前折現率折現至其現值。

If the recoverable amount of an asset or cash-generating unit is estimated to be less than its carrying amount, the carrying amount of the asset or cash-generating unit is reduced to its recoverable amount. An impairment loss is recognised immediately in profit or loss, unless the relevant asset is carried at a revalued amount, in which case the impairment loss is treated as a revaluation decrease.

Where an impairment loss subsequently reverses, the carrying amount of the asset or cash-generating unit is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined (net of amortisation or depreciation) had no impairment loss been recognised for the asset or cash-generating unit in prior years. A reversal of an impairment loss is recognised immediately in profit or loss, unless the relevant asset is carried at a revalued amount, in which case the reversal of the impairment loss is treated as a revaluation increase.

PROVISIONS AND CONTINGENT LIABILITIES

Provisions are recognised for liabilities of uncertain timing or amount when the Group has a present legal or constructive obligation arising as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditures expected to settle the obligation.

Possible obligations, whose existence will only be confirmed by the occurrence or non occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow is remote.

EVENTS AFTER THE REPORTING PERIOD

Events after the reporting period that provide additional information about the Group's position at the end of the reporting period or those that indicate the going concern assumption is not appropriate are adjusting events and are reflected in the consolidated financial statements. Events after the reporting period that are not adjusting events are disclosed in the notes to the consolidated financial statements when material.

撥備及或然負債 (續)

倘經濟利益外流之可能性較低，或無法對有關金額作出可靠估計，則會將相關責任披露為或然負債，惟若經濟利益外流之可能性極低則除外。倘本集團可能須承擔之責任須視乎未來會否發生某項或多項事件而定，則亦會披露為或然負債，惟經濟利益外流之可能性極低則除外。

報告期後事項

報告期後發生的事件，如提供有關本集團於報告期末之狀況的額外資料或顯示持續經營假設並不適當，則屬於調整事項，並於綜合財務報表內反映。報告期後發生的不屬於調整事項的事件如屬重大，則於綜合財務報表附註中披露。

4. KEY SOURCES OF ESTIMATION UNCERTAINTY

The key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are discussed below.

(A) FAIR VALUE OF INVESTMENTS

In the absence of quoted market prices in an active market, the directors estimate the fair value of the Group's certain investments at fair value through profit or loss, details of which are set out in notes 6 and 20 to the consolidated financial statements, by considering information from a variety of sources, including the latest published financial information, the historical data on market volatility as well as the price and industry and sector performance of the Group's investments at fair value through profit or loss.

(B) IMPAIRMENT LOSS FOR BAD AND DOUBTFUL DEBTS

The Group makes impairment loss for bad and doubtful debts based on assessments of the recoverability of receivables, including the current creditworthiness and the past collection history of each debtor. Impairments arise where events or changes in circumstances indicate that the balances may not be collectible. The identification of bad and doubtful debts requires the use of judgement and estimates. Where the actual result is different from the original estimate, such difference will impact the carrying value of receivables and doubtful debt expenses in the year in which such estimate has been changed.

4. 估計不明朗因素之主要來源

下文討論於報告期末有關未來之主要假設及估計不確定因素之其他主要來源，該等假設及來源具有導致下一個財政年度資產及負債賬面值大幅調整的重大風險。

(A) 投資之公平值

在活躍市場並無市場報價的情況下，董事透過考慮各種來源的資料（包括最新公佈的財務資料、市場波動的歷史數據以及本集團按公平值列入損益賬之投資的價格及相關行業與分部表現），估算本集團按公平值列入損益賬之若干投資的公平值，詳情載於綜合財務報表附註6及20。

(B) 呆壞賬之減值虧損

本集團根據對應收款項可收回性的評估（包括各債務人當前的信用度及過往收款記錄），對呆壞賬計提減值虧損。倘事件或情況變動顯示餘額可能無法收回，則會出現減值。識別呆壞賬須運用判斷及估計。倘實際結果有別於原先估計，則有關差額將影響估計發生變動當年的應收款項賬面值及呆賬支出。

(C) ESTIMATION OF FAIR VALUE OF INVESTMENTS IN ARTWORKS

Investments in artworks are revalued at the end of the reporting period by independent professional qualified valuer. Such valuations were based on certain assumptions, which are subject to uncertainty and might materially differ from the actual results. In making the estimation, market information of investments in artworks of the comparable model is considered.

(D) CRYPTOCURRENCIES

Accounting of cryptocurrencies HKFRS Accounting Standards do not specifically address accounting for cryptocurrencies. Accordingly, for the preparation of the annual report, management needs to apply judgment in determining appropriate accounting policies based on the facts and circumstances of the Group's acquisition and holding of cryptocurrencies. Given the Group's purpose for holding cryptocurrencies, management considered that cryptocurrencies purchased and held by the Group should be accounted for as indefinite lived intangible assets accounted for under the cost model. In determining fair values used for impairment tests, management needs to apply judgment to identify the relevant available markets for trading of cryptocurrencies, and to consider accessibility to and activity within those markets in order to identify the principal cryptocurrency markets to ascertain the respective fair market values.

(C) 藝術品投資之公平值估計

藝術品投資於報告期末由獨立專業合資格估值師重新估值。有關估值乃基於若干假設作出，該等假設具有不確定性，可能與實際結果存在重大差異。在進行估計時，會考慮可資比較型號的藝術品投資的市場資料。

(D) 加密貨幣

香港財務報告準則會計準則並無有關加密貨幣會計處理的具體規定。因此，為編製年度報告，管理層需運用判斷，根據本集團購入及持有加密貨幣的事實與情況釐定適當會計政策。基於本集團持有加密貨幣之目的，管理層認為本集團購入及持有的加密貨幣應按成本模式作為具不確定使用年期的無形資產入賬。在釐定減值測試所用的公平值時，管理層需運用判斷以識別相關加密貨幣交易市場，並考慮市場可進入性及活躍度，從而確定主要加密貨幣市場以釐定相應公允市值。

4. KEY SOURCES OF ESTIMATION UNCERTAINTY (Continued)

(E) IMPAIRMENT LOSS ON INVESTMENTS IN ASSOCIATES

Investments in associates are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount of the assets exceeds its recoverable amount. The recoverable amount is determined with reference to the fair value less costs of disposal. Where the fair value less costs of disposal are less than expected or there are unfavourable events and change in facts and circumstance which result in revision of fair value less costs of disposal, a material impairment loss may arise.

5. FINANCIAL RISK MANAGEMENT

The Group's activities expose it to a variety of financial risks: foreign currency risk, price risk, credit risk, liquidity risk and interest rate risk. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

(I) FOREIGN CURRENCY RISK

The Group has minimal exposure to foreign currency risk as most of its business transactions, assets and liabilities are principally denominated in the functional currencies of the Group entities. The Group currently does not have a foreign currency hedging policy in respect of foreign currency transactions, assets and liabilities. The Group will monitor its foreign currency exposure closely and will consider hedging significant foreign currency exposure should the need arise.

As HK\$ is pegged to US\$, the Group does not expect any significant movements in the US\$/HK\$ exchange rates. In the opinion of the Directors, the foreign currency sensitivity analysis does not give additional value in view of insignificant movement in the US\$/HK\$ exchange rates.

(E) 於聯營公司的投資之減值虧損

於聯營公司的投資於有事件或情況變動顯示其賬面值超出其可收回金額時，會進行減值審閱。可收回金額乃經參考公平值減出售成本釐定。倘公平值減出售成本低於預期，或倘發生不利事件及事實與情況變動而導致公平值減出售成本須予修訂，則可能產生重大減值虧損。

5. 財務風險管理

本集團之業務活動面臨多種財務風險：外匯風險、價格風險、信貸風險、流動資金風險及利率風險。本集團之整體風險管理計劃側重於金融市場的不可預測性，力求盡可能減少對本集團財務表現的潛在不利影響。

(I) 外匯風險

由於本集團大部分業務交易、資產及負債主要以本集團實體之功能貨幣計值，故本集團面臨之外匯風險甚微。本集團目前並無針對外幣交易、資產及負債的外匯對沖政策。本集團將密切監察外匯風險，並於有需要時考慮對沖重大外匯風險。

由於港元與美元掛鈎，故本集團預期美元／港元並無任何重大匯率變動。董事認為，鑒於美元／港元匯率之變動並不重大，外幣敏感度分析不會產生額外價值。

(I) FOREIGN CURRENCY RISK (Continued)

As at 31 March 2026, if HK\$ had weakened/strengthened five per cent against Renminbi (“RMB”) with all other variables held constant, loss for the year would have been HK\$20,787,000 (2025: HK\$2,800,000) higher/lower.

(II) PRICE RISK

The Group is exposed to price risk in respect of investments and cryptocurrencies held by the Group, that are classified in the consolidated statement of financial position as investments at fair value through profit or loss and intangible assets, respectively. The Group is not exposed to commodity price risk.

As at 31 March 2026, if the fair value of the investments at fair value through profit or loss had been 5% higher/lower, loss for the year would have been HK\$76,866,000 (2025: HK\$24,463,000) lower/higher.

As at 31 March 2026, if the fair value of cryptocurrencies had been 5% higher, loss for the year would have been nil lower. If the fair value of cryptocurrencies had been 5% lower, loss for the year would have been HK\$430,000 (2025: HK\$1,804,000) higher.

(III) CREDIT RISK

The Group’s maximum exposure to credit risk for the components of the consolidated statement of financial position at 31 March 2026 and 2025 is the carrying amount of financial assets as disclosed in note 5(vi) to the consolidated financial statements.

(I) 外匯風險 (續)

於二零二六年三月三十一日，倘港元兌人民幣（「人民幣」）貶值／升值5%，而其他所有變量保持不變，則年度虧損將增加／減少20,787,000港元（二零二五年：2,800,000港元）。

(II) 價格風險

本集團就所持有的投資及加密貨幣而承受價格風險，該等投資及加密貨幣在綜合財務狀況表中分別分類為按公平值列入損益賬之投資及無形資產。本集團並無承受商品價格風險。

於二零二六年三月三十一日，倘按公平值列入損益賬之投資之公平值上升／下跌5%，年度虧損將減少／增加76,866,000港元（二零二五年：24,463,000港元）。

於二零二六年三月三十一日，倘加密貨幣之公平值上升5%，年度虧損不會因而減少。倘加密貨幣之公平值下跌5%，則年度虧損將增加430,000港元（二零二五年：1,804,000港元）。

(III) 信貸風險

本集團就於二零二六年及二零二五年三月三十一日綜合財務狀況表各部分承受之最高信貸風險為綜合財務報表附註5(vi)所披露之金融資產賬面值。

In order to minimise the credit risk, the management of the Group has delegated a team responsible for determination of credit limits, credit approvals and other monitoring procedures to ensure that follow-up action is taken to recover overdue debts. In addition, the management of the Group reviews the recoverable amount of each debtor at the end of the reporting period to ensure that adequate ECL are made for irrecoverable amounts. In this regard, the management of the Group considers that the Group's credit risk is significantly reduced.

1 Regulatory deposits, contract assets, other receivables and deposits

The credit risk is limited based on historical settlement records and past experience. The Group has assessed that the ECL of these financial assets are not material under the 12-month expected loss method. Thus no ECL (2025: nil) has been recognised during the year ended 31 March 2026.

2 Investments at fair value through profit or loss and bank balances and cash

The credit risks of investments at fair value through profit or loss and bank balances and cash are considered to be insignificant because the counterparties are banks and financial institutions with high credit ratings assigned by international credit-rating agencies.

為降低信貸風險，本集團管理層已委派一支小組負責釐定信貸額度、信貸批核及進行其他監控程序，以確保採取跟進措施收回逾期債項。此外，本集團管理層於報告期末審閱各項應收賬款之可收回金額，以確保就不可收回金額作出足夠之預期信貸虧損撥備。就此，本集團管理層認為本集團之信貸風險已顯著減低。

1 法定按金、合約資產、其他應收款項及按金

根據過往結算記錄及過往經驗，信貸風險有限。本集團已按12個月預期虧損模式評估該等金融資產的預期信貸虧損並不重大。因此截至二零二六年三月三十一日止年度並無確認預期信貸虧損(二零二五年：無)。

按公平值列入損益賬之投資以及銀行結餘及現金信貸風險被視為並不重大，乃由於交易對手為獲國際信貸評級機構授予高信貸評級的銀行及金融機構。

The credit risks of trade receivables from Hong Kong Securities Clearing Company Limited ("HKSCC") are considered to be insignificant because the counterparties had high credit rating and are governed by regulators including the Hong Kong Monetary Authority and the Hong Kong Securities and Futures Commission. The risk of default in repayment of these debtors are considered to be minimal by the directors and no ECL provision were made for these debtors.

The credit risks of trade receivables from the cash clients are considered to be insignificant because the counterparties had sufficient pledged securities, the risk of default in repayment of these debtors are considered to be minimal by the directors and no ECL provision were made for these debtors.

4 Loan receivables and trade receivables from margin clients

The Group's impairment requirements are based on an ECL model. The Group assesses the ECL for loan receivables and trade receivables from margin clients individually and measures the ECL equal to 12-month ECL, unless when there has been a significant increase in credit risk since initial recognition, the Group recognises lifetime ECL.

4 應收貸款及應收孖展客戶之貿易賬款

本集團的減值規定乃基於預期信貸虧損模型。本集團單獨評估應收貸款及應收孖展客戶之貿易賬款之預期信貸虧損，並按相等於十二個月預期信貸虧損之金額計量預期信貸虧損，惟若自初步確認以來信貸風險顯著增加，則本集團會確認存續期預期信貸虧損。

The credit risk on substantial portion of loan receivables and trade receivables from margin clients are limited because significant amount of balances are secured by the pledged listed securities and certain property units and the counterparties have no historical default record. The directors expect that the general economic conditions will not significantly changed for the 12 months' after the end of the reporting period.

It is the Group's policy that all customers who wish to obtain loans from the group are subject to management review. Receivable balances are monitored on an ongoing basis.

The Group considers a broader range of information when assessing credit risk and measuring ECL, including past events, current conditions, reasonable and supportable forecasts that affect the expected collectability of the future cash flows of the instrument.

In applying this forward-looking approach, a distinction is made between:

- financial instruments that have not deteriorated significantly in credit quality since initial recognition or that have low credit risk ("Stage 1"); and
- financial instruments that have deteriorated significantly in credit quality since initial recognition and whose credit risk is not low ("Stage 2").

4 應收貸款及應收孖展客戶之貿易賬款（續）

大部份應收貸款及應收孖展客戶之貿易賬款相關信貸風險有限，乃由於大多數結餘由已抵押上市證券及若干物業單位作抵押，且交易對手並無過往違約記錄。董事預期報告期末後十二個月整體經濟狀況將不會發生重大變動。

本集團之政策為所有有意獲取本集團貸款之客戶，均須接受管理層審查。應收款項餘額持續受監管。

本集團於評估信貸風險及計量預期信貸虧損時考慮較大範圍的資料，包括過往事件、當前條件及影響工具未來現金流量預期可收回性之合理有據的預測。

採用該前瞻法時，須對下列各項作出區分：

- 由初步確認以來其信貸質量未顯著惡化或信貸風險較低之金融工具（「第一階段」）；及
- 由初步確認以來其信貸質量顯著惡化且其信貸風險不低之金融工具（「第二階段」）。

"Stage 3" would cover financial assets that have objective evidence of impairment at the end of the reporting period.

"12-month ECL" are recognised for the Stage 1 category while "lifetime ECL" are recognised for the Stage 2 category.

Measurement of the ECL is determined by a probability-weighted estimate of credit losses over the expected life of the financial instrument.

For trade receivables (excluded margin financing), the Group applies a simplified approach in calculating ECL and recognises a loss allowance based on lifetime ECL at the end of each reporting period. These are the expected shortfalls in contractual cash flows, considering the potential for default at any point during the life of the financial assets. In calculating the ECL, the Group established a provision matrix that is based on its historical credit loss experience and external indicators, adjusted for forward-looking factors specific to the debtors and the economic environment.

To measure the ECL, trade receivables (excluded margin financing) and contract assets have been grouped based on the days past due. The contract assets relate to unbilled work in progress and have substantially the same risk characteristics as the trade receivables for the same types of contracts. The Group has therefore concluded that the ECL rates for trade receivables (excluded margin financing) are a reasonable approximation of the loss rates for the contract assets.

The Group measures the loss allowance on other financial assets measured at amortised cost (including regulatory deposits, loan receivables, margin financing receivables, other receivables and deposits and bank balances) equal to 12-month ECL, unless when there has been a significant increase in credit risk since initial recognition, the Group recognises lifetime ECL. The assessment of whether lifetime ECL should be recognised is based on significant increase in the likelihood or risk of default occurring since initial recognition.

In assessing whether the credit risk has increased significantly since initial recognition, the Group compares the risk of default occurring on the financial assets at the end of the reporting period with the risk of default occurring on the financial assets at the date of initial recognition. In making this assessment, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort.

本集團計量按攤銷成本計量之其他金融資產(包括法定按金、應收貸款、孖展融資應收賬款、其他應收款項以及按金及銀行結餘)的虧損撥備等於十二個月預期信貸虧損，惟若自初步確認以來信貸風險顯著增加，本集團則確認存續期預期信貸虧損。評估是否確認存續期預期信貸虧損乃基於自初步確認以來發生違約的可能性或風險是否顯著增加。

本集團於評估信貸風險自初步確認以來有否顯著增加時，將報告期末金融資產發生違約的風險與初步確認日期金融資產發生違約的風險進行比較。於作出此項評估時，本集團考量合理有據的定量及定性資料，包括無需過多成本或努力即可獲得的歷史經驗及前瞻性資料。

In particular, the following information is taken into account when assessing whether credit risk has increased significantly:

- an actual or expected significant deterioration in the financial instrument's external (if available) or internal credit rating;
- significant deterioration in external market indicators of credit risk, e.g. a significant increase in the credit spread, the credit default swap prices for the debtor;
- existing or forecast adverse changes in business, financial or economic conditions those are expected to cause a significant decrease in the debtor's ability to meet its debt obligations;
- an actual or expected significant deterioration in the operating results of the debtor; and
- an actual or expected significant adverse change in the regulatory, economic, or technological environment of the debtor that results in a significant decrease in the debtor's ability to meet its debt obligations.

Irrespective of the outcome of the above assessment, the Group presumes that the credit risk has increased significantly since initial recognition when contractual payments are more than 30 days past due, unless the Group has reasonable and supportable information that demonstrates otherwise.

無論上述評估結果如何，倘合約款項已逾期逾30天時，本集團推定信貸風險自初步確認以來大幅增加，惟本集團有合理及支持性之資料證實情況並非如此，則另作別論。

Despite the foregoing, the Group assumes that the credit risk on a debt instrument has not increased significantly since initial recognition if the debt instrument is determined to have low credit risk at the end of each reporting period. A debt instrument is determined to have low credit risk if it has a low risk of default, the borrower has strong capacity to meet its contractual cash flow obligations in the near term and adverse changes in economic and business conditions in the longer term may, but will not necessarily, reduce the ability of the borrower to fulfil its contractual cash flow obligations.

For internal credit risk management, the Group considers an event of default occurs when contractual payment are 90 days past due, unless the Group has reasonable and supportable information to demonstrate that a more lagging default criterion is more appropriate. In certain cases, the Group may also consider a financial asset is default when information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collateral held by the Group).

(IV) LIQUIDITY RISK

The Group's policy is to regularly monitor current and expected liquidity requirements to ensure that it maintains sufficient reserves of cash to meet its liquidity requirements in the short and longer term.

就內部信貸風險管理而言，本集團認為倘合約付款逾期超過90日，則出現違約事件，除非本集團擁有合理及有理據支持的資料顯示較寬鬆的違約標準更為適用，則另當別論。於若干情況下，當內部產生或從外部來源所得資料顯示，債務人不大可能向其債權人（包括本集團）支付全數款項（不計及本集團持有的任何抵押品）時，本集團亦認為金融資產已發生違約。

(V) INTEREST RATE RISK

The Group is exposed to cash flow interest rate risk in relation to certain trade receivables and bank balances — general. It is the Group's policy to keep its assets and liabilities at floating rate of interests so as to minimise the fair value interest rate risk.

The Group's cash flow interest rate risk is mainly relating to the fluctuation of Hong Kong prime rate ("prime rate") and Hong Kong Interbank Offered Rate ("HIBOR") arising from the Group's interest bearing financial instruments.

As at 31 March 2026, if the interest rate had been 100 basis points higher/lower, the Group's loss for the year would have been HK\$603,000 (2025: HK\$2,694,000) lower/higher, arising mainly as a result of higher/lower interest revenue on certain trade receivables from margin clients and bank balances — general.

The Group provides securities dealing and brokerage, placing and underwriting services. Commission income from securities dealing and brokerage, placing and underwriting services is recognised at a point in time on the execution date of the trades at a certain percentage of the transaction value of the trades executed and the relevant placing and underwriting are completed.

The Group provides advisory services for asset management, equity investment and corporate finance services which included advisory services and sponsor services.

Depending on the nature of the services and the contract terms, the revenue for advisory service is recognised over time based on the services transferred to customers up to date if one of the following criteria is met:

- The customers simultaneously receive and consume the benefits provided by the Group;
- The Group's performance creates and enhances an asset that the customers control as the asset is created and enhanced; or
- The Group's performance does not create an asset with an alternative use and the Group has a right to payment at an amount that reasonably compensates it for its performance completed to date at all times throughout the contract.

Otherwise, the revenue for advisory service is recognised at a point in time when the service is completed.

The Group treats all sponsor services promised in the contract as a single performance obligation. In determining the timing of satisfaction of the performance obligation, the Group examines its services on contract basis and considers that it has a right to payment at an amount that reasonably compensates it for its performance completed to date at all times throughout the contract.

Sponsor services are recognised over time during the course of the work performed by the Group, with reference to the time incurred compared with the time budget, which depict the Group's performance towards satisfying the performance obligation.

REVENUE FROM TRADING AND SUPPLY CHAIN OPERATIONS BUSINESS

The Group sells commodities to the customers. Sales are recognised when control of the products has transferred, being when the products are delivered to a customer, there is no unfulfilled obligation that could affect the customer's acceptance of the products and the customer has obtained legal titles to the products.

Sales to customers are normally made with credit terms within 30 days.

A receivable is recognised when the products are delivered to the customers as this is the point in time that the consideration is unconditional because only the passage of time is required before the payment is due.

OTHERS

The Group primarily provides investment immigration services and auction services. Investment immigration service income is recognised when the services are rendered. Auction services income is recognised based on the commission or service fees charged when the auction is successfully concluded and the related services are rendered. In each case, income is recognized only when there are no unfulfilled obligations that could affect the customer's acceptance of the services.

- (2) The corporate finance segment engages in the provision of corporate finance services;
- (3) The money lending segment engages in the provision of money lending in Hong Kong;
- (4) The asset management segment engages in the provision of asset management and advisory services to professional investors;
- (5) The equity investment segment engages in the management of financial investments;
- (6) The trading and supply chain operations segment engages in sales of commodities; and
- (7) The artworks investment segment engages in acquisition of porcelain and collectible arts for long-term investment purpose.

The discount rates used were 11.93–14.39 (2025: 11.93–14.39) per cent. Other key assumptions for the value in use calculation related to the estimation of cash inflows and outflows which include budgeted sales and budgeted net profit margin. This estimation is determined based on the unit's past performance and management's expectation for the market development.

CAPITAL RISK MANAGEMENT

The Group manages its capital to ensure that entities in the Group will be able to continue as a going concern while maximising the return to shareholders through the optimisation of the debt and equity balances. The Group's overall strategy remains unchanged from prior years.

The capital structure of the Group consists of cash and cash equivalents, lease liabilities and equity attributable to owners of the Company, comprising issued share capital and reserves.

As at 31 March 2026, the Group's total debt incurred (including borrowings and lease liabilities) were HK\$523,940,000 (2025: HK\$430,562,000), representing a gearing ratio of 7.55% (2025: 10.97%). Gearing ratio is calculated based on total debt divided by the total equity at the end of the reporting period.

The Directors of the Company review the capital structure regularly. As part of this review, the Directors of the Company consider the cost of capital and the associated risks with each class of capital, and take appropriate actions to adjust the Group's capital structure.

For certain subsidiaries of the Company, they are regulated by Securities and Futures Commission ("SFC") and are required to comply with certain minimum capital requirements according to the rules of SFC. Management monitors, on a daily basis, the subsidiaries' liquid capital to ensure it meets the minimum liquid capital requirement in accordance with the Securities and Futures (Financial Resources) Rules, the range of liquid capital is from HK\$100,000 to HK\$3,000,000 or 5% of their total adjusted liabilities, whichever is higher. The required information is filed with SFC on a monthly and semi-annual basis.

There is no non-compliance of the capital requirements imposed by the respective regulators during both years.
