POSITIVE PROFIT ALERT

This announcement is made pursuant to Rule 13.09 of the Listing Rules and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the SFO.

Based on a preliminary assessment of the management accounts of the Group, the Board wishes to inform the shareholders of the Company and potential investors that the Group is expected to record an increase in consolidated net profit attributable to the owners of the Company to approximately HK\$47.4 million for the six months ended 30 June 2026, as compared with the published consolidated net profit attributable to the owners of the Company of HK\$39.7 million for the same corresponding period in 2025.

Shareholders of the Company and potential investors should exercise caution when dealing in shares of the Company.

This announcement is made by Pak Fah Yeow International Limited (the “Company”, together with its subsidiaries, the “Group”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “Listing Rules”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) (the “SFO”).

Based on a preliminary assessment of the management accounts of the Group, the board of directors (the “Board”) of the Company wishes to inform the shareholders of the Company and potential investors that the Group is expected to record a increase in consolidated net profit attributable to the owners of the Company to approximately HK\$47.4 million for the six months ended 30 June 2026, as compared with the published consolidated net profit attributable to the owners of the Company of HK\$39.7 million for the same corresponding period in 2025.

The Board considers that such expected increase in net profit is mainly attributable to an increase in total revenue of approximately HK\$6.3 million which improved the Group’s overall profitability; and a significant decrease in the unrealised fair value loss on the Group’s investment properties to approximately HK\$0.1 million, as compared with an unrealised fair value loss of HK\$7.1 million for the same corresponding period in 2025 based on updated professional valuations.

The unrealised fair value loss is non-cash in nature and will have no effect on the operating cash flow of the Group. The overall financial position of the Group remains healthy.

The information contained in this announcement is only based on a preliminary assessment performed by the Board with reference to the Group's management accounts and information currently available to the Company and has not been reviewed by the Company's auditor and the audit committee, and may be subject to amendments.

The interim results announcement of the Company for the six months ended 30 June 2026 is expected to be published by the end of August 2026.
