Reference is made to the announcement of Capital Realm Financial Holdings Group Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) dated 29 June 2026 and 30 June 2026 in relation to, amongst other things, (i) the delay in the publication of audited annual results announcement for the year ended 31 March 2026; (ii) possible delay in dispatch of 2026 Annual Report; (iii) postponement of the board meeting; and (iv) suspension of trading (the “**Announcements**”). Unless the context otherwise requires, terms used in this announcement shall have the same meanings as those defined in the Announcements.

FUTHER DELAY IN PUBLICATION OF THE ANNUAL RESULTS

As disclosed in the Announcements, additional time is required for the Company to provide to the Auditor information, among others, in relation to the professional valuation reports of unlisted equity securities, promissory notes and investment deposits held as at 31 March 2026 for the preparation of the Annual Results. It is expected that the Annual Results Announcement would be published by the end of August 2026. The Board will make further announcements at appropriate times.

DELAY IN DESPATCH OF ANNUAL REPORT

Pursuant to Rule 13.46(1) of the Listing Rules, the Company is required to despatch the 2026 Annual Report to the Shareholders not more than four (4) months after the end of the financial year of the Company (i.e. on or before 31 March 2026). Due to the delay in the publication of the Results Announcement, the dispatch of the 2026 Annual Report will be delayed. The delay in despatch of the 2026 Annual Report, will constitute non-compliance with Rule 13.46(1) of the Listing Rules. The expected date of despatch of the 2026 Annual Report will be announced as and when appropriate.

FURTHER POSTPONEMENT OF THE BOARD MEETING

Due to the aforesaid delay in publication of the Annual Results, the Board Meeting will be further postponed. The Board will make further announcement(s) as and when appropriate to inform the Shareholders of (i) the date of the Board Meeting; and (ii) the date of the publication of the Annual Results and the despatch of the 2026 Annual Report.

CONTINUED SUSPENSION OF TRADING

At the request of the Company, trading in the Company's shares on the Stock Exchange has been suspended with effect from 9:00 a.m. on Thursday, 2 July 2026 and will remain suspended until further notice.

Shareholders of the Company and potential investors are advised to exercise caution in dealing in the securities of the Company.
