(1) Upon maturity of the loan, all of the principal amount and accrued interest (the “Accrued Amount”) shall be repaid in full by way of (i) automatic and mandatory conversion into Class B Ordinary Shares at the final offer price at HKD3.99, subject to a 9.9% shareholding threshold of CARIAD Estonia AS (“CARIAD”) in the Company’s then issued share capital, and (ii) cash, if there is any remaining Accrued Amount after conversion of the loan. The aforementioned 9.9% shareholding threshold can be removed only if agreed by the Company and CARIAD Estonia AS. For details, please refer to the prospectus dated 16 October 2024. On 22 July 2026, the Company entered into an amendment agreement with CARIAD to amend the convertible loan agreement, pursuant to which the Company will early repay the convertible loan and redeem the conversion rights held by CARIAD thereunder.
