Remarks: The total number of issued shares (excluding treasury shares) as at 6 August 2026 was 25,842,127,167 (comprising 4,443,616,133 Class A ordinary shares and 21,398,511,034 Class B ordinary shares).

Xiaomi Corporation (the “Company”) purchased a total of 83,625,000 class B ordinary shares during the period from 3 June 2026 to 17 July 2026 (the “Shares Repurchased”) on the Stock Exchange. All the Shares Repurchased were subsequently cancelled on 11 August 2026 and the number of class B ordinary shares in issue was reduced by 83,625,000 shares as a result of the cancellation accordingly. Upon cancellation of the Shares Repurchased, the weighted voting rights (“WVR”) beneficiaries of the Company, simultaneously reduced their WVR in the Company proportionately by way of converting their class A ordinary shares into class B ordinary shares on a one-to-one ratio pursuant to Rule 8A.21 of the Listing Rules, such that the proportion of shares carrying WVR of the Company shall not be increased, pursuant to the requirements under Rules 8A.13 and 8A.15 of the Listing Rules.
