**ANNOUNCEMENT  
PROFIT WARNING**

This announcement is made by Hygieia Group Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provision (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the shareholders and potential investors of the Company that, based on a preliminary assessment by the management of the Group on the unaudited consolidated management accounts of the Group for the six months ended 30 June 2026 (the “**Period**”), the Company expects to record a significant decline in the Group’s profit for the Period by approximately more than 35% as compared to the same period in 2025. The decline was primarily attributable to the decrease in receipts of government grants on employment credit from the Singapore Government and increase in labour-related expenses.

The information contained in this announcement is only based on a preliminary assessment by the management of the Group on the unaudited consolidated management accounts of the Group for the Period, which is yet to be finalised and has not yet been reviewed by the Company's auditors or the audit committee of the Company. Further details of the Company's performance will be disclosed when the interim results of the Company for the Period are announced. Despite the expected decline in the Group's profit for the Period due to the reasons mentioned above, the management considered that the position of the Group remains sound and healthy and the management is positive on the long-term prospect of the Group.
