ANNOUNCEMENT ON THE COMPLETION OF THE ISSUANCE OF 2026 TIER 2 CAPITAL NOTES (SERIES 5) (BOND CONNECT)

With the approvals of relevant regulatory authorities, the issuance of Industrial and Commercial Bank of China Limited (the “**Bank**”) 2026 Tier 2 Capital Notes (Series 5) (Bond Connect) (the “**Notes**”) in National Interbank Bond Market has recently been completed.

The Notes issued are of a size of RMB60 billion, and the tranche is 10 years fixed-rate notes with conditional redemption right by the issuer at the end of the fifth year, and the interest rate is 1.81%.

The proceeds from the issuance of the Notes after deducting offering related expenses will be used to boost the tier 2 capital of the Bank in accordance with the applicable laws and the approvals by the competent authorities.
