On 11 February 2026 and 13 July 2026, the Exchange gave HSBC consent under Rule 10.06(3) for the issue of new contingent convertible securities, where such issuances would occur within a period of 30 days after any purchase of Shares made under the Buyback on the Hong Kong Stock Exchange and the UK Venues respectively as announced on 5 August 2026. Subject to the aforementioned consent, the moratorium period shall be up to the date as stated above.
