PROFIT WARNING

This announcement is made by Lai Si Enterprise Holding Limited 黎氏企業控股有限公司 (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that based on a preliminary review of the Group’s unaudited consolidated management accounts for the period ended 30 June 2026 and information currently available to the Board, the Group is expected to record an unaudited consolidated loss attributable to the Shareholders in a range of approximately MOP13.0 million to MOP15.0 million as compared to the unaudited consolidated profit attributable to the Shareholders of approximately MOP1.1 million for the period ended 30 June 2025.

The Board considers that the loss making situation was mainly attributable to (1) significant decrease in revenue for the period ended 30 June 2026 of not less than 35.0% as compared with MOP111.2 million for the period ended 30 June 2025, which was mainly due to weak demand in the market and delay in a government project progress; (2) gross profit margin was diminished due to weak demand; (3) provision on financial and contract assets of approximately MOP1.2 million increase after management consideration and (4) provision of diminution of investment property reduced MOP2.1 million.

As the Company is still in the process of finalising the financial results of the Group for the period ended 30 June 2026, the information contained in this announcement is only based on the Board's preliminary assessment of the Group's unaudited consolidated management accounts which have not been audited or reviewed by the Company's auditors and the audit committee of the Company, and may be subject to adjustments. Actual unaudited financial results of the Group to be published may be different from what is contained in this announcement. As such, the above information is provided for the shareholders' and potential investors' reference only. The Shareholders and potential investors are advised to read carefully in the interim results announcement of the Company which is expected to be published on 27 August 2026.
