PROFIT WARNING

This announcement is made by NVC International Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09(2)(a) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors of the Company (the “**Board**”) wishes to update the shareholders of the Company (the “**Shareholders**”) and potential investors that, based on its latest preliminary assessment of the Group’s unaudited consolidated management accounts and other information currently available to the Board, it is expected that (i) the Group will record a net profit of no more than approximately US\$1.10 million for the six months ended 30 June 2026 (the “**Period**”) as compared to the net profit of approximately US\$15.20 million for the six months ended 30 June 2025 (the “**Corresponding Period**”); and (ii) the profit attributable to the owners of the Company will decrease to not more than approximately US\$1.00 million for the Period, as compared to approximately US\$15.20 million for the Corresponding Period.

The Board considers that the anticipated decrease in the net profit for the Period was mainly because of (i) the increase in share of net losses in the associates from approximately US\$0.57 million to approximately US\$4.24 million for the Period; and (ii) the shift of other gains and losses from net gain to net losses, which was primarily attributable to (a) the net foreign exchange gain/losses, which shifted from approximately US\$4.70 million for the Corresponding Period to net foreign exchange losses of approximately US\$2.60 million for the Period, and (b) the decrease in net gains of fair value of financial assets from approximately US\$3.60 million for the Corresponding Period to approximately US\$0.80 million for the Period.

The Company is still in the process of finalising the results of the Group for the Period. The information contained in this announcement is based solely on the Board's preliminary assessment of the information currently available to it, including the unaudited consolidated management accounts of the Group for the Period, and is not based on any financial data or information that has been audited or reviewed by the auditor or the audit committee of the Company, and is subject to finalisation and adjustments. Details of the Group's financial performance for the Period will be disclosed in the interim results announcement of the Company for the Period, which will be published by the end of August 2026. Shareholders and potential investors should read carefully such results announcement when it is issued.

Shareholders and potential investors of the Company are advised to exercise caution when dealing in the securities of the Company.
