CLARIFICATION ANNOUNCEMENT IN RELATION TO THE BOOK CLOSURE PERIOD FOR THE ANNUAL GENERAL MEETING

The Company would like to clarify that the paragraph in relation to the book closure period for the AGM as disclosed in Note (4) of the AGM Notice and the Book Closure Period Announcement shall be amended as follows:

“The register of members will be closed from Tuesday, 15 September 2026 to Friday, 18 September 2026, both days inclusive, during which period no transfer of shares will be registered. In order to qualify for attendance of at the meeting, all completed transfer forms accompanied by the relevant share certificates must be lodged with the Company’s branch share registrar in Hong Kong, Tricor Investor Services Limited, at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong no later than 4:30 p.m. on **Monday, 14 September 2026.**”

Saved as disclosed and clarified above, all information set out in the Circular, AGM Notice and the Book Closure Period Announcement remains unchanged. This clarification announcement is supplemental to and should be read in conjunction with the Circular, AGM Notice and the Book Closure Period Announcement. The form of proxy for use by shareholders at the AGM will remain valid for the AGM.
