POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 28 AUGUST 2026

At the annual general meeting (“AGM”) of HKC International Holdings Limited (the “Company”) held on 28 August 2026, all the proposed resolutions as set out in the Notice of AGM dated 22 July 2026 were voted on by poll.

As at the date of the AGM, the total number of issued shares of the Company was 233,499,610 shares, which was the total number of shares entitling the holders to attend and vote for or against all the resolutions at the AGM. There were no shares entitling the shareholders to attend and abstain from voting in favour of the resolutions at the AGM as set out in Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited. No shareholders were required to abstain from voting on any of the resolutions proposed at the AGM.

The Company’s branch share registrar in Hong Kong, Union Registrars Limited, was appointed as the scrutineer at the AGM for the purpose of vote-taking. The poll results were as follows:
