If the Company does not receive the duly completed and signed Reply Form or any response in writing indicating any objection from you by 28 September 2026, and until you inform the Company by reasonable prior notice in writing to the Hong Kong Branch Share Registrar at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong or by email to 213-ecom@vistra.com, you are deemed to have consented to receive the Website Version of all future Corporate Communications, and a notification of the publication of the Corporate Communications on the Company’s website will be sent to you in the future.

You are entitled at any time by reasonable prior notice in writing to the Company c/o the Hong Kong Branch Share Registrar at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong or by email to 213-ecom@vistra.com to change your choice of means of receipt and/or language of future Corporate Communications.
