This announcement is made by HC Group Inc. (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09(2)(a) of the Rules Governing the Listing of Securities (the “**Listing Rules**”) on The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

References are made to the Company’s announcements dated 17 March 2026, 23 March 2026, 23 June 2026 and 30 June 2026 in relation to, among others, the delay in publication of the Company’s financial results for the year ended 31 December 2025 (the “**2025 Results**”) and suspension of trading.

DELAY IN PUBLICATION OF THE 2026 INTERIM RESULTS

Pursuant to Rule 13.49(6) of the Listing Rules, the Company is required to publish the preliminary announcement in respect of its interim financial results for the six months ended 30 June 2026 (the “**2026 Interim Results**”) not later than two months after the end of the relevant financial period (i.e. on or before 31 August 2026).

As the audit work in respect of the 2025 Results is currently in progress, the Company expects that the 2025 Results will likely impact the preparation of the 2026 Interim Results. In view of the audit progress in respect of the 2025 Results, the Company considers that it will not be able to publish the 2026 Interim Results on or before 31 August 2026. The Company will finalise the 2026 Interim Results as soon as practicable following the publication of the 2025 Results.

CONTINUED TRADING SUSPENSION

At the request of the Company, trading in the shares of the Company on the Stock Exchange has been suspended with effect from 9:00 a.m. on 18 March 2026 pending the publication of the 2025 Results, and will remain suspended until the fulfilment of the resumption guidance issued by the Stock Exchange.

Shareholders and potential investors are advised to exercise caution when dealing in the securities of the Company.
