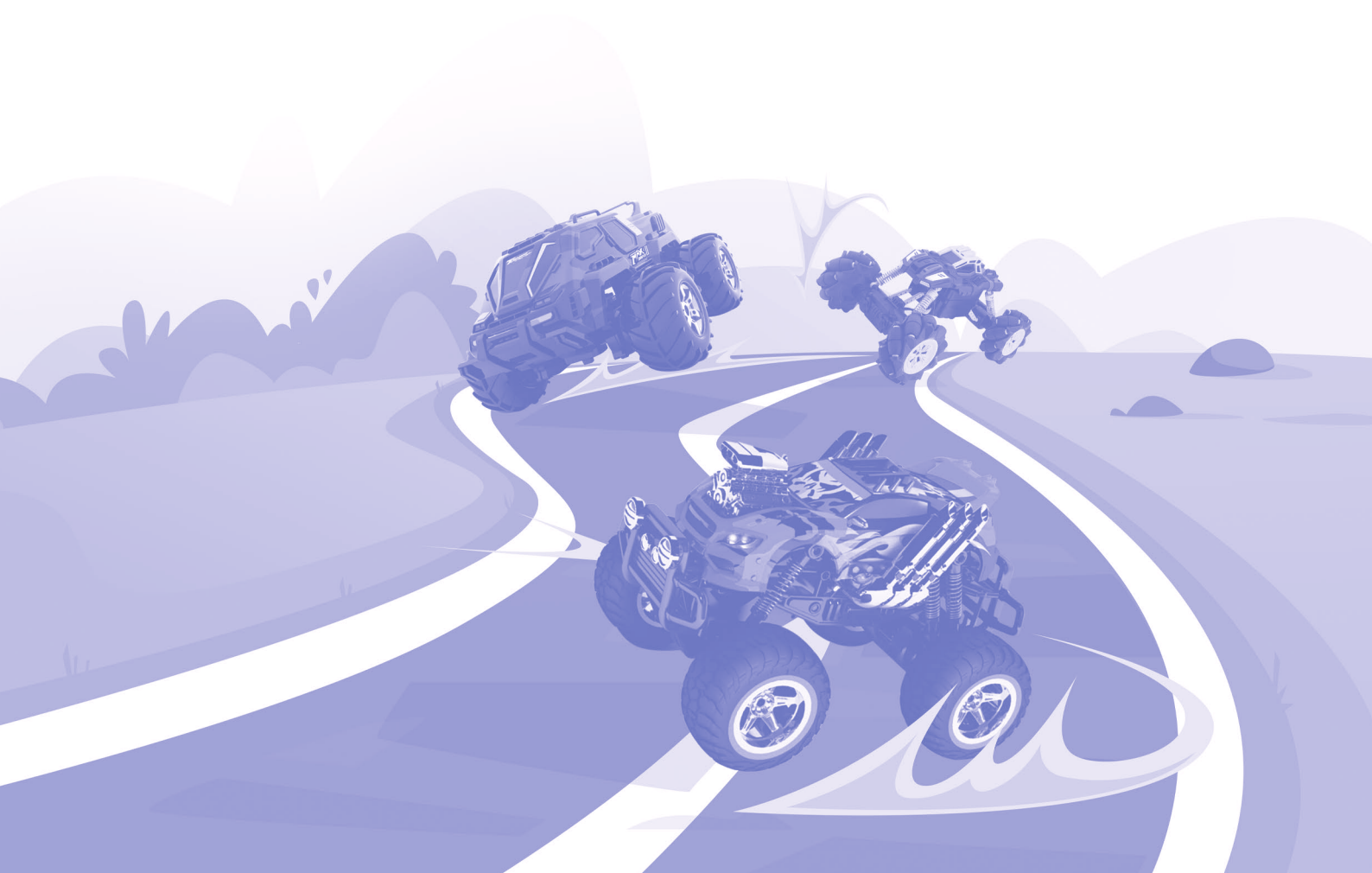

MANAGEMENT DISCUSSION AND ANALYSIS

管理層討論及分析

BUSINESS AND FINANCIAL REVIEW

Jiutai Digital Technology Holdings Limited (the “**Company**”) (formerly known as “Kidztech Holdings Limited”) and its subsidiaries (collectively, the “**Group**”) are principally engaged in the design, development, manufacture and sale of high-quality smart toy vehicles, smart interactive toys and traditional toys as well as integrated financial services.

Revenue

The Group’s total revenue increased by approximately 76.8% from approximately RMB68.9 million for the six months ended 30 June 2025 to approximately RMB121.9 million for the six months ended 30 June 2026. During the six months ended 30 June 2026, the increase in revenue was primarily attributable to improvement of smart toy vehicles business and the new additional integrated financial services segments with high profitable revenue. Details of revenue by aggregated type are set out in note 4 to the condensed consolidated financial statements as set out in this interim report.

Smart toys

Smart toy vehicles

The Group’s smart toy vehicles mainly comprise full function radio controlled toy vehicles, which are manufactured in different scales. During the six months ended 30 June 2026, the Group’s smart toy vehicles are mostly “kidztech” brand products and co-branded products collectively released by the Company and renowned automobile manufacturers. The Group also manufactures under overseas customers’ brands on original equipment manufacturing (“**OEM**”) and original design manufacturing (“**ODM**”) bases.

To reinforce long-term competitiveness and enhance its research and development capabilities, the Group acquired a suite of software copyrights during the period, notably including the Smart Toy Electric Remote Control Vehicle Management System, Smart Vehicle Navigation System, and Driving Data Management System.

業務及財務回顧

九泰數智科技控股有限公司(前稱奇士達控股有限公司)(「**本公司**」)及其附屬公司(統稱「**本集團**」)主要設計、開發、製造及銷售高品質智能車模、智能互動式玩具及傳統玩具以及綜合金融服務。

收益

本集團總收益由截至二零二五年六月三十日止六個月的約人民幣68.9百萬元增加約76.8%至截至二零二六年六月三十日止六個月的約人民幣121.9百萬元。截至二零二六年六月三十日止六個月，收益增長主要得益於本集團在智能車模業務錄得增長；及新增綜合金融服務板塊的業務錄得高利潤收益。按產品類型合併劃分的收益詳情載列於本中期報告所載簡明綜合財務報表附註4。

智能玩具

智能車模

本集團的智能車模主要包括全功能無線電遙控車模，該等產品按不同比例生產。於截至二零二六年六月三十日止六個月，本集團的智能車模大部分為「奇士達」品牌產品和本公司與知名汽車製造商推出的聯合品牌產品。本集團亦通過原設備製造(「**OEM**」)及原設計製造(「**ODM**」)模式以海外客戶的品牌製造產品。

為鞏固長期競爭力及加強研發能力，本集團於期內收購一系列軟件著作權，主要包括智能玩具電動遙控車管理系統、智能車輛導航系統及駕駛數據管理系統。

These software copyrights enable real-time electronic control, intelligent path planning, and telemetry data tracking across the Group's product lines. By applying these technologies to its "kidztech" brand and co-branded wireless radio-controlled vehicles, the Group elevates user interaction, optimizes product performance, ensuring the Group remains highly competitive in the evolving smart toy market.

During the six months ended 30 June 2026, the Group's revenue from sales of smart toy vehicles increased by approximately 20.2% from approximately RMB68.9 million for the six months ended 30 June 2025 to approximately RMB82.9 million for the six months ended 30 June 2026 mainly attributable to the enhancement of the product function.

Smart interactive toys

The Group's smart interactive toys are mainly produced and sold for under the "kidztech" brand, and comprise smart interactive playsets, activity toys and musical toys, and some of these toys which play music and contain play features are intended to stimulate the sensory development of children. As a result of the Group's business development policy adjustment, during the first half of 2026, the Group did not record any revenue from smart interactive toys (for the six months ended 30 June 2025: nil).

Traditional toys

Traditional toys include traditional toy vehicles, traditional educational toys, dolls and other traditional toys such as outdoor and sport as well as infant toys.

During the period, the Group did not record any revenue from traditional toys (for the six months ended 30 June 2025: nil). In light of the quiet domestic retail market and low profit margins in the PRC, the Group suspended the production and sales of traditional toys until the market conditions improve.

該等軟件著作權使本集團各產品線能夠實現實時電子控制、智能路徑規劃及遙測數據追蹤。透過將該等技術應用於其「奇士達」品牌及聯名無線遙控車產品，本集團可提升用戶互動體驗、優化產品性能，確保本集團在不斷發展的智能玩具市場中保持高度競爭力。

截至二零二六年六月三十日止六個月，本集團來自智能玩具車模銷售的收入較截至二零二五年六月三十日止六個月的約人民幣68.9百萬元增長約20.2%至截至二零二六年六月三十日止六個月的約人民幣82.9百萬元，主要由於產品功能的提升。

智能互動式玩具

本集團的智能互動式玩具產品主要以「奇士達」玩具品牌生產和出售，包括智能互動式玩具套裝、活動玩具及音樂玩具，部分玩具可播放音樂並具有播放功能，旨在激發兒童感官發育。由於本集團業務發展政策調整，於二零二六上半年，本集團沒有從智能互動玩具品類錄得任何收入(截至二零二五年六月三十日止六個月：零)。

傳統玩具

傳統玩具包括傳統玩具車、傳統教育玩具、玩偶及其他如戶外及體育以及嬰兒玩具等傳統玩具。

期內，本集團並未錄得來自傳統玩具的任何收入(截至二零二五年六月三十日止六個月：無)。鑑於中國境內零售市場低迷及利潤率低，本集團暫停傳統玩具的生產及銷售，直至市場狀況改善為止。

Brands

The Group's smart toys and traditional toy products are (i) branded with its "kidztech" brand; (ii) co-branded with renowned automobile manufacturers, popular entertainment characters featured in animated television series or motion pictures or toy brand owner; or (iii) branded under its overseas customers brands, which mainly represent the products manufactured by the Group on ODM and OEM bases and the products sold to its customers branded under their respective brands.

The Group believes that co-branding with other famous brands allows the Group to leverage on the marketing benefits of the internationally renowned brands to expediently gain consumer awareness, and recognition of authenticity, and to establish creditability and market acceptance from the mass market. The Group will continue to seek for opportunities to collaborate with other famous brands in order to increase the marketability of its products.

Integrated Financial Services

During the period, the Group, through its non-wholly-owned subsidiary, engaged in the provision of integrated financial services in Hong Kong, including insurance brokerage and related integrated financial services. For the six months ended 30 June 2026 (the "**Period**"), the Group recorded revenue of approximately RMB17.7 million (for the six months ended 30 June 2025: nil).

During the period, the Group proactively entered into business cooperation agreements with several well-known financial institutions, with a view to expanding its client base and enriching its product portfolio. The Group is committed to providing comprehensive insurance brokerage and financial advisory services, covering matching and follow-up of personal and corporate risk protection solutions, cross-border asset allocation, family wealth succession, and corporate risk management advice. These are complemented by corporate advisory services, tax planning and premium family value-added services, offering customers a one-stop risk management and asset allocation solution.

品牌

本集團的智能玩具、傳統玩具產品為(i)「奇士達」品牌的產品；(ii)與知名汽車製造商、動畫電視劇集或電影所塑造的流行娛樂角色或玩具品牌擁有人推出的聯合品牌的產品；或(iii)使用我們海外客戶的品牌(主要指本集團以ODM及OEM模式製造的產品)的產品，以及售予客戶使用客戶各自品牌的產品。

本集團相信與其他知名品牌的共享品牌使本集團能夠利用國際知名品牌的營銷優勢，以方便地獲得消費者的青睞、對正品的認可，並在大眾市場上建立信譽及市場接受度。本集團將繼續尋求與其他知名品牌合作的機會，以提升其產品的市場流通性。

綜合金融服務

期內本集團透過非全資附屬公司開展綜合金融服務，提供包括於香港提供保險經紀及相關綜合金融服務。於截至二零二六年六月三十日止六個月(「**期內**」)，錄得收入約人民幣17.7百萬元(截至二零二五年六月三十日止六個月：無)。

期內，本集團積極與多家知名金融機構訂立業務合作協議，藉此擴大客戶群體並豐富產品組合。本集團致力提供全方位保險經紀及財務顧問服務，涵蓋個人與企業風險保障之方案匹配及跟進、跨區域資產配置、家族財富傳承及企業風險管理建議，並協同企業諮詢、稅務規劃及高端家族增值服務，為客戶打造一站式風險管理與資產配置方案。

Gross profit and gross profit margin

The Group's gross profit increased by approximately 405.9% from approximately RMB3.9 million for the six months ended 30 June 2025 to approximately RMB19.9 million for the six months ended 30 June 2026, which was mainly attributable to gross profit margin from the sales of toy cars improved, benefiting from enhanced product features and the new addition of an integrated financial services of brokerage commission income for the amount of RMB9.3 million. The Group's gross profit margin significantly increased to approximately 16.3% for the six months ended 30 June 2026 from approximately 5.7% for the six months ended 30 June 2025.

Loss for the period

The Group recorded net loss of approximately RMB63.4 million for the six months ended 30 June 2026, representing an increase of loss of approximately RMB48.3 million or 321.4% when compared to the loss of approximately RMB15.0 million for the six months ended 30 June 2025. An increase in loss of the Group was mainly attributable to an increase of the net impairment losses on trade receivables of approximately RMB41.1 million during the period.

Selling expenses

The Group's selling expenses were approximately RMB122,000 for the six months ended 30 June 2026 (for the six months ended 30 June 2025: nil), which was mainly attributable to the provision of integrated financial services.

Administrative expenses

The Group's administrative expenses increased by approximately 352.9% from approximately RMB6.9 million for the six months ended 30 June 2025 to approximately RMB31.1 million for the six months ended 30 June 2026, which was mainly attributable to an increase in operating costs for integrated financial services, as well as professional and consulting fees.

毛利及毛利率

本集團的毛利由截至二零二五年六月三十日止六個月的約人民幣3.9百萬元增加至截至二零二六年六月三十日止六個月的約人民幣19.9百萬元，加幅約405.9%，主要是玩具汽車銷售的毛利率有所改善，受惠於產品功能升級及新增綜合金融服務的經紀佣金收入增加約人民幣9.3百萬元所致。本集團的毛利率由截至二零二五年六月三十日止六個月的約5.7%大幅上升至截至二零二六年六月三十日止六個月的約16.3%。

本期間虧損

本集團於截至二零二六年六月三十日止六個月錄得淨虧損約人民幣63.4百萬元，較截至二零二五年六月三十日止六個月之虧損約人民幣15.0百萬元增加虧損約人民幣48.3百萬元或321.4%。本集團之虧損有所增加乃主要由於期內貿易應收款項減值虧損淨額增加約人民幣41.1百萬元所致。

銷售開支

本集團截至二零二六年六月三十日止六個月的銷售開支約為人民幣122,000元(截至二零二五年六月三十日止六個月：無)，該開支主要源自提供綜合金融服務。

行政開支

本集團行政開支由截至二零二五年六月三十日止六個月的約人民幣6.9百萬元增加約352.9%至截至二零二六年六月三十日止六個月的約人民幣31.1百萬元，乃主要是新增綜合金融服務的營運支出增加，以及專業及諮詢費用的增加所致。

Net impairment losses on trade receivables

The Group's net impairment losses on trade receivable was approximately RMB41.1 million for the six months ended 30 June 2026, representing an increase of losses of approximately RMB34.5 million or 516.5% when compared to the loss for the six month ended 30 June 2025 of approximately RMB6.7 million. It was mainly due to the lifetime expected loss provision for trade receivables increased during the period. For details, please refer to note 12 to the condensed consolidated financial statements as set out in this interim report.

Taxation

The Group had no taxable profit for the six months ended 30 June 2026 (for the six months ended 30 June 2025: nil). Details are set out in note 6 to the condensed consolidated financial statement as set out in this interim report.

Liquidity and financial resources

As at 30 June 2026, the gearing ratio, which represents the Group's total borrowings divided by total equity, was approximately 114.4% (31 December 2025: approximately 61.2%). As at 30 June 2026, the Group's total borrowings were approximately RMB186.2 million (31 December 2025: approximately RMB133.3 million) and the total equity was approximately RMB162.8 million (31 December 2025: approximately RMB217.7 million). The total borrowings represent the outstanding loans of the Group.

The current ratio, which is calculated based on the total current assets at the respective dates divided by the total current liabilities at the respective dates, was approximately 1.1 as at 30 June 2026 (31 December 2025: approximately 1.2); whereas the quick ratio, which is calculated based on the total current assets (excluding inventories) at the respective dates divided by the total current liabilities at the respective dates, was approximately 1.0 as at 30 June 2026 (31 December 2025: approximately 1.1).

As at 30 June 2026, the Group's cash and cash equivalents amounted to approximately RMB55.1 million (31 December 2025: approximately RMB7.5 million).

貿易應收款項減值虧損淨額

本集團的貿易應收款項減值虧損淨額截至二零二六年六月三十日止六個月的約人民幣41.1百萬元較截至二零二五年六月三十日止六個月的虧損約人民幣6.7百萬元增加虧損約人民幣34.5百萬元或516.5%，主要由於本期間貿易應收款項全期預期虧損撥備增加所致。詳情載列於本中期報告所載簡明綜合財務報表附註12。

稅項

截至二零二六年六月三十日止六個月，本集團沒有應納稅項利潤(截至二零二五年六月三十日止六個月：無)。詳情載列於本中期報告所載簡明綜合財務報表附註6。

流動資金及財務資源

於二零二六年六月三十日，本集團的資本負債比率(即本集團的借貸總額除以權益總額)約為114.4%(二零二五年十二月三十一日：約61.2%)。於二零二六年六月三十日，本集團的借貸總額約人民幣186.2百萬元(二零二五年十二月三十一日：約人民幣133.3百萬元)及權益總額約人民幣162.8百萬元(二零二五年十二月三十一日：約人民幣217.7百萬元)。借貸總額代表本集團之尚未償還貸款。

流動比率乃按相關日期的總流動資產除以相關日期的總流動負債計算。於二零二六年六月三十日，本集團的流動比率約為1.1(二零二五年十二月三十一日：約1.2)。速動比率乃按相關日期的總流動資產(不包括存貨)除以相關日期的總流動負債計算。於二零二六年六月三十日，本集團的速動比率約為1.0(二零二五年十二月三十一日：約1.1)。

於二零二六年六月三十日，本集團的現金及現金等價物為約人民幣55.1百萬元(二零二五年十二月三十一日：為約人民幣7.5百萬元)。

In June 2026, the Company issued a promissory note with a principal amount of HK\$46,000,000, bearing interest at 18% per annum and with a maturity of two years, to an independent third party.

Working capital

The Group's trade receivables decreased by approximately RMB68.5 million or approximately 29.6% from approximately RMB231.0 million as at 31 December 2025 to approximately RMB162.5 million as at 30 June 2026, which was mainly due to the improvement of debt collection from individual customers and an increase of net impairment loss on trade receivables during the period.

The Group's prepayment and other receivables increased by approximately RMB3.5 million or approximately 3.9% from approximately RMB89.3 million as at 31 December 2025 to approximately RMB92.8 million as at 30 June 2026 which was mainly attributable to an increase in prepayment during the period.

The Group's trade and other payables increased by approximately RMB15.4 million or approximately 11.3% from approximately RMB135.9 million as at 31 December 2025 to approximately RMB151.3 million as at 30 June 2026. The increase in trade and other payables was mainly attributable to the expansion of the Group's business operations during the period.

Bank and other borrowings

As at 30 June 2026, the bank and other borrowings, amounting to approximately RMB140.1 million (31 December 2025: approximately RMB133.3 million), were repayable with fixed interest rate 2.25% to 18.00%. The bank and other borrowings are predominantly denominated in RMB. The weighted average effective interest rate as at 30 June 2026 was approximately 7.9% (31 December 2025: approximately 7.9%).

於二零二六年六月，本公司向一名獨立第三方發行本金額為46,000,000港元的承兌票據，年利率為18%，期限為兩年。

營運資金

本集團的貿易應收款項由於二零二五年十二月三十一日的約人民幣231.0百萬元減少約人民幣68.5百萬元或約29.6%至二零二六年六月三十日的約人民幣162.5百萬元，主要由於本期間個別顧客欠款回收有所改善及貿易應收款項減值虧損淨額增加所致。

本集團的預付款項及其他應收款項由二零二五年十二月三十一日的約人民幣89.3百萬元增加約人民幣3.5百萬元或約3.9%至二零二六年六月三十日的約人民幣92.8百萬元，主要由於於本期間預付款增加所致。

本集團的貿易及其他應付款項由二零二五年十二月三十一日的約人民幣135.9百萬元增加約人民幣15.4百萬元或約11.3%至二零二六年六月三十日的約人民幣151.3百萬元。貿易及其他應付款項的增加主要由於本集團期內業務規模擴大所致。

銀行及其他借款

Business Review and Outlook

Deepening physical industry and asset-light operations

In response to the rapidly changing market environment, the Group's existing IP toy and electronic products businesses will fully focus on an asset-light operating model to maintain high strategic flexibility and market responsiveness. To enhance product value efficiently, the Group has reinforced its research and development by acquiring strategic software copyrights, such as intelligent remote control vehicle management and navigation interactive systems. Integrating these software copyrights into our Smart Toy Vehicles upgrades overall product performance and user interaction while maintaining an agile cost structure. Such initiatives have resulted in a material improvement in the gross profit margin of the smart toy vehicles business during the period.

With the rising global demand for emerging IP and sports trendy toy products, the Group will continue leveraging its technology and design strengths to accelerate product innovation, expand into overseas markets, and bolster the competitiveness and profit resilience of its physical businesses.

Expanding integrated financial services and AI technology empowerment

In the meanwhile, the Group will continue to expand its integrated financial services business in Hong Kong by providing insurance brokerage solution matching, claims follow-up and customised financial advisory services, and deepen its cooperation with renowned financial institutions, so as to create new profit growth drivers. In addition, the Group actively promotes the commercial application of fintech and artificial intelligence (AI). During the period, the Group entered into a non-legally binding memorandum of understanding with Fano Labs Limited to jointly develop AI models and Agent solutions for financial services scenarios, with a commitment to achieving deep integration of technology and industry practices. It is expected that the cooperation will promote business innovation, improve operational efficiency, cultivate new growth drivers, and further enhance the overall technological capability of the Group. For further details, please refer to the Company's announcement dated 14 July 2026.

Looking ahead, leveraging the three-pillar synergistic development model of "physical industry + integrated financial services + technological innovation", complemented by the strategic deployment of high-end AI and green technology, the Group will continue to optimise its product and service portfolio to enhance its overall competitive strength, with a commitment to creating long-term and sustainable value for Shareholders.

深化實體產業與輕資產營運

為應對瞬息萬變的市場環境，本集團現有的IP玩具及電子產品業務將全面聚焦於輕資產營運模式，以保持高度的策略靈活性及市場應變能力。為高效提升產品價值，本集團已透過收購策略性軟件著作權（如智能遙控車輛管理及導航互動系統）加強研發工作。將該等軟件著作權整合到我們的智能車模中，可提升整體產品性能及用戶互動體驗，同時保持靈活的成本結構。有關舉措令智能車模業務於期內的毛利率實現顯著提升。

隨著全球對新興IP及運動潮流玩具產品的需求日益增長，本集團將繼續發揮其技術及設計優勢，加快產品創新、拓展海外市場，並增強其實體業務的競爭力及盈利韌性。

拓展綜合金融服務與AI科技賦能

與此同時，本集團將持續拓展香港綜合金融服務業務，提供保險經紀方案匹配、理賠跟進及定製化財務顧問服務，並深化與知名金融機構之合作，構建全新盈利增長點。此外，本集團積極推動金融科技及人工智能(AI)的商業應用，於本期間與Fano Labs Limited訂立一份不具法律約束力之諒解備忘錄，共同研發適用於金融服務場景的AI模型及智能體(Agent)解決方案，致力實現技術與行業實務深度融合。預期該合作可促進業務創新、改善營運效率、培育新增長動能，並進一步強化本集團整體技術實力。有關進一步詳情，請參閱本公司日期為2026年7月14日之公告。

Significant investments, material acquisitions and disposal of subsidiaries

The Group did not have any significant investments, material acquisitions and disposal of subsidiaries, associates and joint ventures for the six months ended 30 June 2026, provided that the Group completed an acquisition of 70% equity in Fortune Union Capital Management Limited (合盈資本管理有限公司) (“**Fortune Union**”) at the consideration of HK\$2.49 million. Fortune Union, a company incorporated in Hong Kong, holds a valid insurance brokerage license, and is primarily engaged in provision of insurance brokerage and relevant financial services. All applicable percentage ratio in relation to the acquisition is below 5%, it does not constitute a notifiable transaction of the Company under Chapter 14 of the Listing Rules.

Future plans for material investments and capital assets

As at 30 June 2026, the Group did not have any other plans for material investments and capital assets save as disclosed in this interim report. The Group has taken initial steps into the integrated financial business to diversify our business portfolio through the following strategic acquisitions of Fortune Union.

Capital structure

The capital structure of the Group is mainly based on the equity attributable to the shareholders of the Company (the “**Shareholders**”) (including share capital and reserves). As at 30 June 2026, the total number of issued ordinary shares of the Company (the “**Shares**”) was 874,386,800 with a par value of HK\$0.001 each (31 December 2025: 749,476,800 shares).

For details, please refer to note 15 to the condensed consolidated statements as set out in this interim report.

Pledge of assets

As at 30 June 2026, certain bank and other borrowings of the Group were secured by property, plant and equipment. Details of which are set out in note 14 to the condensed consolidated financial statements as set out in this interim report.

Contingent liabilities

The Group did not have any significant contingent liability as at 30 June 2026 (31 December 2025: nil).

Capital commitments

As at 30 June 2026, the Group had an aggregate capital commitment of approximately RMB6.7 million (31 December 2025: approximately RMB8.8 million).

Financial management and treasury policy

The financial risk management of the Group is the responsibility of the Group's treasury function at its head office. The Group adopted prudent funding and treasury management policies while maintaining an overall healthy financial position. The Group's source of funding was raised by cash generated from operating activities and bank borrowings. The Group's treasury policies mainly include managing capital liquidity and yield to safeguard the healthy development of the principal businesses of the Group. The Group regularly reviews its major funding positions to ensure that it has adequate financial resources in meeting its financial obligations. The Group is from time to time considering various alternatives including but not limited to financial institution borrowings, non-financial institution borrowings, bonds issuance, etc.

Foreign exchange exposure

The Group's operating subsidiaries incorporated in Hong Kong operates with most transactions being settled in US dollars ("USD"), except for certain transactions which are denominated in Hong Kong dollars ("HK\$") or other currencies. The functional currency of these subsidiaries is USD. The Group's operating subsidiaries incorporated in the PRC operate in the PRC and their functional currency is Renminbi ("RMB"). As at 30 June 2026, foreign exchange risk arose mainly from certain intra-group transactions and balances of the operating subsidiaries in the PRC which are denominated in USD and the accrual of the Listing expenses which are denominated in HK\$. The Directors consider that no significant foreign exchange risk exists for the Group. The Group currently does not have a foreign currency hedging policy in respect of foreign currency transactions, assets and liabilities. The Group did not use any financial instruments for hedging purposes.

外匯風險

EMPLOYEES, REMUNERATION POLICIES AND PENSION SCHEMES

As at 30 June 2026, the Group had 28 (31 December 2025: 26) full-time employees, of which, 14 of them were in Hong Kong and the rest of them were stationed in Shantou and Shenzhen, the PRC.

The remuneration packages offered by the Group to its employees include salaries, accidental insurance and allowances, depending on their job nature. Bonuses are generally discretionary and based in part on employee performance and in part on the overall performance of the Group's business. The Group has implemented training programmes for its employees to meet different job requirements, such as training on production procedures for its staff at its production department. It is believed that these initiatives have contributed to the increased productivity of employees of the Group. The Group has also adopted a share scheme to reward, among others, its employees for their contribution to the Group (the “**Share Scheme**”), details of which are set out in the section headed “Share Scheme” below of this interim report.

As required by the relevant PRC laws and regulations, the Group has participated in housing fund and various employee social security plans that are organised by applicable local municipal and provincial governments, including housing, pension, medical, work-related injury and unemployment benefit plans, under which contributions were made at specified percentages of the salaries of its employees. Bonuses are generally discretionary and based in part on employee performance and in part on the overall performance of its business.

The Group has arranged for its employees in Hong Kong to join the Mandatory Provident Fund Scheme (the “**MPF Scheme**”) managed by an independent trustee. Under the MPF Scheme, the Group’s company in Hong Kong (the employer) and its employees make monthly contributions to the scheme at 5% of the employees’ earnings as defined under the Mandatory Provident Fund legislation. The monthly contributions of each of the Group’s companies and its employees are subject to a cap of HK\$1,500 and thereafter contributions are voluntary.

The Group’s contributions to the defined contribution scheme are expensed as incurred and not reduced by contributions forfeited by those employees who leave the plans prior to vesting fully in the contributions.

BUSINESS OUTLOOK

With the aim of further developing its business and continuing its growth and also taking into account the development of the current situation and the material changes in the global geopolitics environment as well as the international order, the Group will implement the following strategies:

- continue to prioritise and focus on overseas market by (i) maintaining and strengthening relationship with its existing direct overseas customers; and (ii) staying alert to new outbreaks, while expanding the customer base and continuing to prioritise and focus on Chinese market;
- continue to strengthen, expand and diversify its customer base by focusing on (i) the Hong Kong and PRC Export – Oriented Wholesalers; and (ii) the PRC retailers;
- improve its production efficiency and effectively control costs through outsourced part of production progress to suppliers/sub-contractors, whilst maintaining high standards of product quality and competitiveness;
- allocate more resources to expand sales of domestic and Asian markets;
- continue to expand Hong Kong’s integrated financial services by providing insurance brokerage solutions, claims follow-up, and customized financial advisory services, while deepening cooperation with leading financial institutions to create new sources of profit growth;

1. General Information

Jiutai Digital Technology Holdings Limited (formerly known as “Kidztech Holdings Limited”) (the “**Company**”) was incorporated in the Cayman Islands on 25 October 2019 as an exempted company with limited liability under the Companies Law of the Cayman Islands. The address of its registered office is Cricket Square, Hutchins Drive, PO Box 2681, Grand Cayman, KY1-1111, Cayman Islands. The Company’s shares were listed on the Main Board of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) on 18 March 2020.

The Company is an investment holding company and its subsidiaries (together, “**the Group**”) are principally engaged in manufacturing and sales of toys as well as provision of integrated financial service.

2. Basis of Preparation

These condensed consolidated financial statements have been prepared in accordance with Hong Kong Accounting Standard 34 “Interim Financial Reporting” issued by the Hong Kong Institute of Certified Public Accountants (the “**HKICPA**”) and the applicable disclosures required by the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

These condensed consolidated financial statements should be read in conjunction with the 2025 annual financial statements. The accounting policies and methods of computation used in the preparation of these condensed consolidated financial statements are consistent with those used in the annual financial statements for the year ended 31 December 2025.

HKFRSs comprise Hong Kong Financial Reporting Standards; Hong Kong Accounting Standards; and Interpretations. The adoption of these new and revised HKFRSs did not result in significant changes to the Group’s accounting policies, presentation of the Group’s financial statements and amounts reported for the current and prior periods.

The Group has not applied the new HKFRS Accounting Standards that have been issued but are not yet effective. The application of these new HKFRSs will not have material impact on the financial statements of the Group.

4. Revenue and Segment Information

The Group is principally engaged in (i) manufacturing and sales of toy cars; (ii) sales of electronic products; and (iii) integrated financial services

For management purpose, the Group is organised based on its business activities. The Group determines its operating segments based on these business activities that are regularly reviewed by the chief operating decision maker, i.e. the executive directors of the Company, for the purpose of resources allocation and performance assessment.

Share Scheme

2020 Share Option Scheme

The Company conditionally adopted the 2020 Share Option Scheme on 13 February 2020, so as to grant options to selected participants as incentives or rewards for their contribution to the Group. Given that the Directors are entitled to determine any performance targets to be achieved as well as the minimum period that an option must be held before an option can be exercised on a case by case basis, and that the exercise price of an option cannot in any event fall below the price stipulated in the Listing Rules or such higher price as may be fixed by the Directors, it is expected that grantees of an option will make an effort to contribute to the development of the Group to bring about an increased market price of the Shares in order to capitalise on the benefits of the options granted.

The Directors may, at their absolute discretion, grant options to any of the following classes of participants: (a) any employee (whether full-time or part-time, including any executive director but excluding any non-executive director) of the Company, any of the subsidiaries or any entity (the **“Invested Entity”**) in which any member of the Group holds an equity interest (**“Eligible Employee”**); (b) any non-executive directors (including independent non-executive directors) of the Company, any of the subsidiaries or any Invested Entity; (c) any supplier of goods or services to any member of the Group or any Invested Entity; (d) any customer of any member of the Group or any Invested Entity; (e) any person or entity that provides research, development or other technological support to any member of the Group or any Invested Entity; (f) any shareholder of any member of the Group or any Invested Entity or any holder of any securities issued by any member of the Group or any Invested Entity; (g) any adviser (professional or otherwise) or consultant to any area of the business or business development of any member of the Group or any Invested Entity; and (h) any other groups or classes of participants who have contributed or may contribute by way of joint venture, business alliance or other business arrangement to the development and growth of the Group.

2025 Share Scheme

The purpose of the 2025 Share Scheme is to provide the Company with a flexible means of, attracting, remunerating, incentivising, retaining, rewarding, compensating and/or providing benefits to eligible participants through aligning the interests of eligible participants with those of the Company and shareholders of the Company by providing them with an opportunity to become shareholders of the Company, and thereby, encouraging eligible participants to contribute to the long-term growth, performance and profits of the Company and to enhance the value of the Company and the shares of the Company (the “**Shares**”) for the benefit of the Company and Shareholders as a whole.

Awards (the “**Awards**”) under the 2025 Share Scheme may take the form of a share option or a share award, which can be funded by Shares or an equivalent value determined by prevailing market prices.

As at the date of this report, no trustee has been appointed to administer and implement the 2025 Share Scheme. The Listing Committee of the Stock Exchange has approved the listing of and granted permission to deal in the Shares to be allotted and issued pursuant to the Awards.

Eligible participants

Eligible participants of the 2025 Share Scheme are determined by the scheme administrator of the 2025 Share Scheme from time to time to be eligible to participate as grantees under the scheme, and shall fall under the below category:

- Employee participant, being an employee (whether full-time or part-time), Director (excluding independent non-executive Director) or officer of the Group on the date of grant of the share options or share awards.

Therefore, as at 30 June 2026, 62,456,400 (representing approximately 7.14% of our total issued share capital (excluding treasury shares) as at the date of this report) new Shares were available for issue under the scheme mandate.

Exercise period

The scheme administrator of the 2025 Share Scheme may determine in its absolute discretion the exercise period for any award of share options and/or share awards and such period shall be set out in the award letter to be issued to the grantee. However, the exercise period for any award of share options shall not be longer than 10 years from the date of grant.

Vesting period

The scheme administrator of the 2025 Share Scheme may determine the vesting period and specify such period in the award letter to be issued to the grantee. The vesting period may not be for a period less than 12 months from the date of grant, except in limited circumstances set out in the Scheme Rules. These circumstances may only apply to employee participants and are consistent with the scenarios contemplated in FAQ13-No.12 issued by the Stock Exchange, including where:

Number of Shares underlying Awards available for grant

The aggregate number of Shares underlying all grants made or to be made pursuant to the 2025 Share Scheme was 62,456,400. No Shares underlying Awards have been granted under the 2025 Share Scheme since the adoption of the 2025 Share Scheme. It follows that, as at 1 January 2026 and 30 June 2026, there were 62,456,400 Shares remaining to be available for grant under the scheme mandate under the 2025 Share Scheme.

No share options or share awards have been granted or agreed to be granted, exercised, cancelled, expired or lapsed under the 2025 Share Scheme as at the date of this report.

Remaining life of the 2025 Share Scheme

The 2025 Share Scheme was approved and adopted by the Company during the annual general meeting of the Company on 30 June 2025. The term of the 2025 Share Scheme is 10 years commencing on the date of adoption unless terminated earlier. It follows that, the remaining life of the 2025 Share Scheme is approximately 8 years and 10 months.

The board (the “**Board**”) of Directors has resolved not to declare an interim dividend for the six months ended 30 June 2026 (corresponding period in 2025: nil).

Corporate Governance

The Group is committed to maintaining high standards of corporate governance to safeguard the interests of the Shareholders and to enhance corporate value and accountability of the Company. During the six months ended 30 June 2026, the Company has applied the principles and complied with all applicable code provisions of the Corporate Governance Code in Appendix C1 (the “**CG Code**”) to the Listing Rules, save and except the deviation as follows:

Pursuant to code provision C.2.1 of the CG Code, the roles of chairman and chief executive should be separate and should not be performed by the same individual. Mr. Yu Huang is currently the chairman of the Board and the chief executive officer of the Group. Mr. Yu Huang has been responsible for the overall management of the Group since the establishment of the Group. The Board believes that the current structure enables us to make and implement business decision swiftly and effectively which promotes the Group’s development in line with other strategies and business direction. The Board considers that the balance of power and authority, accountability and independent decision-making under the present arrangement will not be impaired because of the diverse background and experience of the executive Directors, non-executive Director and independent non-executive Directors. Further, the audit committee of the Company (the “**Audit Committee**”), which consists of all independent non-executive Directors, has free and direct access to the Company’s external auditors and independent professional advisers when it considers necessary. Therefore, the Directors consider that the deviation from code provision C.2.1 of the CG Code is appropriate in such circumstance. In order to maintain good corporate governance and to fully comply with code provision C.2.1 of the CG Code, the Board will regularly review the need to appoint different individuals to perform the roles of chairman of the Board and chief executive separately.

As disclosed in the announcement of the Company dated 23 December 2021, on 23 December 2021, the Company entered into a loan agreement (the “**Loan Agreement**”) with a licensed money lender in Hong Kong under the Money Lenders Ordinance (the “**Lender**”) for the principal amount of HK\$30,000,000 (the “**Loan**”). The Loan has a term of one year from its drawdown date subject to the terms of the Loan Agreement. To the best of the knowledge, information and belief of the Directors, having made all reasonable enquiries, the Lender is a third party independent of the Company and its connected persons (as defined in the Listing Rules).

Pursuant to the Loan Agreement, the Company has covenanted that it will procure Mr. Yu Huang, a controlling shareholder of the Company, among others, not to sell, transfer or otherwise dispose of his equity interests in the Company and its subsidiaries or associated companies or any part thereof or create any encumbrance over his equity interests or any part thereof unless with the prior written consent of the Lender. A breach of such covenant will constitute an event of default, upon the occurrence of which, all outstanding amounts under the Loan Agreement shall become immediately due and payable.

As disclosed in the announcement of the Company dated 16 September 2022, the Company entered into the first supplemental agreement to the Loan Agreement with the Lender on 16 September 2022 pursuant to which, among others, Top Synergy Y&C Limited (“**Top Synergy**”), the controlling shareholder of the Company: (i) has charged 100,000,000 Shares in favour of the Lender as security for the Loan; and (ii) covenanted to at all time directly hold and be beneficially interested in not less than 206,746,667 Shares. The principal of HK\$30,000,000 had been drawn and shall become due and payable on 22 December 2022.

On 16 December 2022, the Company entered into the second supplemental agreement to the Loan Agreement with the Lender, pursuant to which the repayment date of the Loan was extended to 23 March 2023. On 13 October 2023, Top Synergy further charged 24,000,000 Shares in favour of the Lender as additional security to maintain the percentage of the pledged shares following completion of the placing of the new Shares on 23 August 2023. On 12 June 2025, the Company further entered into the third supplemental agreement to the Loan Agreement with the Lender, pursuant to which the parties agreed that the total outstanding principal amount of HK\$13,223,850 shall be fully repaid by six installments on or before 31 March 2025.

As at 30 June 2026, Top Synergy held approximately 20.56% of the total issued share capital of the Company. Top Synergy was owned as to approximately 94.79% by Mr. Yu Huang and as to approximately 5.21% by Ms. Chen Cheng, the spouse of Mr. Yu Huang, respectively.

As at the date of this interim report, the Company has repaid HK\$5,067,018 and the amount of HK\$8,156,832 remained outstanding under the Loan Agreement.
