POLL RESULTS OF THE 2026 ANNUAL GENERAL MEETING HELD ON 1 SEPTEMBER 2026

The Board is pleased to announce that all the resolutions as set out in the notice of the 2026 AGM dated 7 August 2026 were duly passed by the Shareholders by way of poll at the 2026 AGM held on 1 September 2026.

References are made to the circular (the “**Circular**”) and the notice (the “**Notice**”) of 2026 annual general meeting (the “**2026 AGM**”) of Sterling Group Holdings Limited (the “**Company**”) both dated 7 August 2026. Unless otherwise specified, capitalised terms used herein have the same meanings ascribed to them in the Circular and the Notice.

The Board is pleased to announce that all the resolutions as set out in the Notice were duly passed by the Shareholders by way of poll at the 2026 AGM held on 1 September 2026.

As at the date of the 2026 AGM, the total number of issued Shares was 41,472,000 Shares, which was the total number of Shares entitling the holders to attend and vote for or against the resolutions proposed at the 2026 AGM. There were no Shares entitling the holders to attend and abstain from voting in favour of the resolutions at the 2026 AGM as set out in Rule 13.40 of the Listing Rules and no Shareholders were required under the Listing Rules to abstain from voting at the 2026 AGM. No Shareholder has stated his/her intention in the Circular to vote against or to abstain from voting on any of the proposed resolutions at the 2026 AGM.

Tricor Investor Services Limited, the Hong Kong branch share registrar and transfer office of the Company, acted as the scrutineer for the vote-taking at the 2026 AGM. The poll results in respect of all the resolutions proposed at the 2026 AGM are as follows:
