BUSINESS REVIEW AND MARKET PROSPECT

The Group is a renowned manufacturer and supplier of low-voltage electrical power distribution and control devices in Hong Kong, Macau and Mainland China. The Group recorded a profit of approximately HK\$502,000 for the six months ended 30 June 2026 as compared to the profit of approximately HK\$723,000 for the six months ended 30 June 2025. This decrease was mainly attributable to a slight decrease in revenue and higher selling and distribution expenses.

During the reporting period, the construction and engineering sectors across Hong Kong, Macau, and Mainland China navigated a demanding operating landscape. Structural deficits in skilled labor and prolonged supply chain volatility collectively extended project delivery timelines and compressed operational margins across the industry.

To ease these systemic pressures, the Hong Kong government implemented labor importation schemes to bolster the local workforce. Concurrently, major public infrastructure developments such as the Northern Metropolis, demonstrate a strategic commitment to driving regional economic growth and establishing a sustainable pipeline of future construction and engineering tenders.

In response to these complex market conditions, the Group prioritised financial resilience and operational discipline to protect its balance sheet and cash flows. Managing risk proactively remains a core priority, particularly as the broader global economy faces persistent headwinds. Rising geopolitical friction, trade barriers, inflation, and slowing global growth continue to impact capital markets and temper short-term business sentiment.

Notwithstanding these macroeconomic uncertainties, the Group's strategic focus on optimizing shareholder returns remains unchanged. By broadening our business capabilities and pursuing disciplined expansion into high-growth, adjacent sectors, we are actively mitigating concentrated industry risks. This diversified approach positions the Group to capture emerging opportunities, strengthen our market leadership, and deliver sustainable, long-term capital appreciation.

業務回顧及市場前景

本集團為香港、澳門及中國內地知名的低壓配電及電力控制裝置製造商及供應商。本集團於截至二零二六年六月三十日止六個月錄得溢利約502,000港元，而截至二零二五年六月三十日止六個月錄得溢利約723,000港元。此減少主要是由於收益微跌以及銷售及分銷開支增加所致。

於報告期內，香港、澳門及中國內地的建築及工程界別均面對嚴峻的經營環境。熟練勞工的結構性短缺及供應鏈長期波動，共同導致整個行業的項目交付時間延長，並壓縮營運利潤率。

為紓緩此等系統性壓力，香港政府實施了輸入勞工計劃，以增強本地勞動力。與此同時，北部都會區等大型公共基礎設施開發項目展現了推動區域經濟增長及建立未來建築和工程招標可持續供應的策略性承諾。

為應對這些複雜的市場狀況，本集團優先考慮財務韌性及營運紀律，以保障其資產負債表及現金流量。主動管理風險仍然是核心優先事項，尤其鑒於全球經濟面臨持續逆風。地緣政治摩擦加劇、貿易壁壘、通脹及全球經濟增長放緩，持續影響資本市場並抑制短期商業信心。

儘管面對該等宏觀經濟不明朗因素，本集團優化股東回報的策略重點維持不變。透過擴闊我們的業務能力及尋求審慎擴張至高增長及相關行業，我們正積極減輕行業集中風險。此多元化策略使本集團能夠把握新興機遇、鞏固我們的市場領導地位，並實現可持續的長期資本增值。

FINANCIAL REVIEW

Revenue

The Group's revenue decreased slightly by approximately HK\$0.4 million, from approximately HK\$68.9 million for the six months ended 30 June 2025 to approximately HK\$68.5 million for the six months ended 30 June 2026.

Cost of Sales

The Group's cost of sales amounted to approximately HK\$50.5 million for the six months ended 30 June 2026, representing a slight decrease of approximately HK\$0.2 million from approximately HK\$50.7 million for the six months ended 30 June 2025. The decrease in cost of sales corresponded to the decline in revenue. Cost of sales mainly comprised of costs of raw materials and staff costs, which accounted for approximately 69.5% and 20.8% respectively of the Group's total cost of sales for the six months ended 30 June 2026 (six months ended 30 June 2025: approximately 67.1% and 19.2% respectively).

Gross Profit

The Group's gross profit decreased from approximately HK\$18.2 million during the six months ended 30 June 2025 to approximately HK\$17.9 million during the six months ended 30 June 2026.

Other income, gains and losses (net)

The Group's other income, gains and losses (net) decreased slightly from approximately HK\$1.0 million for the six months ended 30 June 2025 to approximately HK\$0.9 million for the six months ended 30 June 2026. The amount of other income was mainly attributable to (i) agency fee income of approximately HK\$0.7 million and (ii) bank interest income of approximately HK\$0.4 million being recorded during the six months ended 30 June 2026.

Selling and distribution expenses

The Group's selling and distribution expenses increased from HK\$1.9 million during the six months ended 30 June 2025 to approximately HK\$2.3 million during the six months ended 30 June 2026. The rise in distribution expenses was primarily driven by escalating transportation costs, which were impacted by rising fuel prices and inflationary pressures across the logistics sector. The Group continues to implement the cost saving measures in order to minimise the unnecessary transportation cost.

財務回顧

收益

本集團的收益由截至二零二五年六月三十日止六個月的約68.9百萬港元輕微下跌約0.4百萬港元至截至二零二六年六月三十日止六個月的約68.5百萬港元。

銷售成本

本集團於截至二零二六年六月三十日止六個月的銷售成本為約50.5百萬港元，較截至二零二五年六月三十日止六個月的約50.7百萬港元輕微減少約0.2百萬港元。銷售成本的減少與收益的下降一致。銷售成本主要包括原材料成本及員工成本，於截至二零二六年六月三十日止六個月分別佔本集團銷售成本總額約69.5%及20.8%（截至二零二五年六月三十日止六個月：分別約67.1%及19.2%）。

毛利

本集團的毛利由截至二零二五年六月三十日止六個月的約18.2百萬港元減少至截至二零二六年六月三十日止六個月的約17.9百萬港元。

其他收入、收益及虧損（淨額）

本集團之其他收入、收益及虧損（淨額）由截至二零二五年六月三十日止六個月的約1.0百萬港元輕微減少至截至二零二六年六月三十日止六個月的約0.9百萬港元。其他收入的金額主要歸因於截至二零二六年六月三十日止六個月錄得(i)約0.7百萬港元的代理費收入以及(ii)約0.4百萬港元的銀行利息收入。

銷售及分銷開支

本集團的銷售及分銷開支由截至二零二五年六月三十日止六個月的1.9百萬港元增加至截至二零二六年六月三十日止六個月的約2.3百萬港元。分銷開支增加主要由於運輸成本不斷上漲，而運輸成本則受燃料價格上升及整個物流業的通脹壓力所影響。本集團將持續實施成本節約措施，以盡量減少不必要的運輸成本。

Administrative and other expenses

The Group's administrative and other expenses decreased by approximately HK\$72,000, from approximately HK\$15.8 million for the six months ended 30 June 2025 to approximately HK\$15.7 million for the six months ended 30 June 2026.

Finance costs

The Group's finance costs increased from approximately HK\$73,000 for the six months ended 30 June 2025 to approximately HK\$90,000 for the six months ended 30 June 2026, which was due to an increase in interest expenses on lease liabilities.

Taxation

The Group recorded an income tax expense of approximately HK\$291,000 and HK\$685,000 for the six months ended 30 June 2026 and 2025, respectively.

Profit for the period attributable to the owners of the Company

As a result of the slight decrease in revenue and the increase in selling and distribution expenses, the net profit attributable to owners of the Company decreased to approximately HK\$502,000 for the six months ended 30 June 2026, compared to approximately HK\$723,000 for the corresponding period in 2025.

行政及其他開支

本集團的行政及其他開支由截至二零二五年六月三十日止六個月的約15.8百萬港元減少約72,000港元至截至二零二六年六月三十日止六個月的約15.7百萬港元。

融資成本

本集團的融資成本由截至二零二五年六月三十日止六個月的約73,000港元增加至截至二零二六年六月三十日止六個月的約90,000港元，乃由於租賃負債的利息開支增加所致。

稅務

本集團於截至二零二六年及二零二五年六月三十日止六個月分別錄得所得稅開支約291,000港元及685,000港元。

本公司擁有人應佔期內溢利

由於收益微跌以及銷售及分銷開支增加，本公司擁有人應佔純利由二零二五年同期的約723,000港元減至截至二零二六年六月三十日止六個月的約502,000港元。

LIQUIDITY, FINANCIAL RESOURCES AND CAPITAL STRUCTURE

The Group has financed its operations primarily through cash inflows from operating activities and proceeds received from the Listing. As at 30 June 2026, the Group had cash and cash equivalents of approximately HK\$68.7 million (31 December 2025: approximately HK\$75.3 million).

As at 30 June 2026, the working capital (current assets less current liabilities) and total equity attributable to owners of the Group were approximately HK\$144.2 million (31 December 2025: approximately HK\$147.6 million) and approximately HK\$174.8 million (31 December 2025: approximately HK\$174.2 million) respectively.

Gearing ratio (calculated based on the interests bearing liabilities, which excluded lease liabilities, divided by the total equity as at the respective end of period and multiplied by 100%) as at 30 June 2026 was nil (31 December 2025: nil).

During the reporting period, there was no change in Company's share capital.

CURRENCY RISK

The Group has minimal exposure to foreign currency risk as most of its business transactions and assets and liabilities are principally denominated in the functional currencies of the relevant group entities. As such, the Group currently does not have any foreign currency hedging policy in respect of foreign currency transactions and assets and liabilities as the Group's risk in foreign exchange is insignificant. However, the Group will continue to monitor closely its exposure to currency movement and take proactive measures.

INTEREST RATE RISK

The Group is exposed to fair value interest rate risk in relation to lease liabilities. The Group is exposed to cash flow interest rate risk through the impact of rate changes on interest bearing financial assets and liabilities, mainly interest-bearing bank balances at variable interest rates. The Group currently does not have an interest rate hedging policy. However, the management of the Group will consider hedging significant interest rate risk should the need arise.

流動資金、財務資源及資本架構

本集團主要透過經營活動所得現金流入及自上市籌集所得款項為營運提供資金。於二零二六年六月三十日，本集團的現金及現金等價物約為68.7百萬港元（二零二五年十二月三十一日：約75.3百萬港元）。

於二零二六年六月三十日，營運資金（流動資產減流動負債）及本集團擁有人應佔權益總額分別約為144.2百萬港元（二零二五年十二月三十一日：約147.6百萬港元）及約174.8百萬港元（二零二五年十二月三十一日：約174.2百萬港元）。

於二零二六年六月三十日的資產負債比率（按計息負債（不包括租賃負債）除以各期末的權益總額並乘以100%計算）為零（二零二五年十二月三十一日：零）。

於報告期間內，本公司股本並無變動。

貨幣風險

本集團所面臨外幣風險甚微，因其大部分業務交易以及資產及負債乃主要以相關集團實體的功能貨幣計值。因此，由於本集團之外匯風險輕微，本集團目前並無就外幣交易及資產及負債制定任何外幣對沖政策。然而，本集團將繼續緊密監察其貨幣變動風險及採取積極措施。

利率風險

本集團面臨與租賃負債有關的公平值利率風險。本集團面對因計息金融資產及負債（主要為按浮動利率計息的銀行結餘）的利率變動影響產生的現金流量利率風險。本集團現時並無利率對沖政策。然而，本集團管理層在有需要時會考慮對沖重大利率風險。

The Group's cash flow interest rate risk is mainly concentrated on the fluctuation of interest rates on bank balances.

SIGNIFICANT INVESTMENTS HELD, MATERIAL ACQUISITION OR DISPOSALS

Save as disclosed in this report, there were no significant investments held, nor any material acquisitions or disposals of subsidiaries or associates during the six months ended 30 June 2026.

PLEDGE OF ASSETS

As at 30 June 2026 and 31 December 2025, the Group's banking facilities were secured by corporate guarantees provided by the Company for unlimited amounts and certain leasehold land and buildings. There was no other pledge of assets as at 30 June 2026 and 31 December 2025.

FUTURE PLAN FOR MATERIAL INVESTMENT AND CAPITAL ASSETS

Save as disclosed in this report and in the prospectus of the Company dated 27 April 2018 (the "**Prospectus**"), the Group does not have other plans for material investments and capital assets for the six months ended 30 June 2026 and up to the date of this report.

CAPITAL COMMITMENT

There was no significant capital commitment of the Group outstanding as at 30 June 2026 (31 December 2025: nil).

The Group had no material contingent liabilities as at 30 June 2026 (31 December 2025: nil).

EVENTS AFTER THE REPORTING PERIOD

There have been no material events occurring after the reporting period and up to the date of this report.

INTERIM DIVIDEND

The Board does not recommend the payment of an interim dividend to shareholders of the Company (the “**Shareholders**”) for the six months ended 30 June 2026 (six months ended 30 June 2025: nil).

EMPLOYEES AND REMUNERATION POLICY

The Group had 228 full-time employees as at 30 June 2026 (31 December 2025: 225), among which 52 and 176 (31 December 2025: 52 and 173) were stationed in Hong Kong and Mainland China, respectively. Most of the Group's employees were factory workers in Mainland China. The total staff costs (including fees, salaries and other allowance, and retirement benefit scheme contributions) for the six months ended 30 June 2026 were approximately HK\$19.7 million (six months ended 30 June 2025: approximately HK\$17.0 million). The remuneration policy and package of the Group's employees were periodically reviewed. Apart from retirement benefit scheme contributions, salary increment and discretionary bonuses may be awarded to employees according to the assessment of individual performance. The remuneration policy in place as at 30 June 2026 was in line with the current legislation in the relevant jurisdictions, market conditions and performance of the staff and the Group.

中期股息

於截至二零二六年六月三十日止六個月，董事會不建議向本公司股東（「股東」）派付中期股息（截至二零二五年六月三十日止六個月：無）。

僱員及薪酬政策

於二零二六年六月三十日，本集團有228名全職僱員（二零二五年十二月三十一日：225名），當中52名及176名（二零二五年十二月三十一日：52名及173名）分別駐守香港及中國內地。本集團大多數僱員為中國內地的工廠工人。截至二零二六年六月三十日止六個月的員工成本總額（包括袍金、薪金及其他津貼以及退休福利計劃供款）為約19.7百萬港元（截至二零二五年六月三十日止六個月：約17.0百萬港元）。本集團定期檢討僱員薪酬政策及待遇。除退休福利計劃供款外，本集團或會根據個人表現評核而向僱員加薪及酌情授予花紅。於二零二六年六月三十日已實施的薪酬政策符合相關司法權區的現行法例、市況以及員工及本集團的表現。

USE OF PROCEEDS FROM THE LISTING

The shares of the Company (the “Shares”) have been listed on the Stock Exchange since 11 May 2018 (the “Listing Date”). Net proceeds from the Listing were approximately HK\$75.0 million (after deducting the underwriting commission and other listing expenses in connection to the Listing (the “Net Proceeds”)), which was different from the estimated net proceeds of HK\$89.7 million as disclosed in the Prospectus. The difference of HK\$14.7 million has been adjusted in the same manner and in the same proportion to the use of proceeds as shown in the Prospectus. According to the announcement of the Company on 16 August 2022 and 28 September 2023 (the “Announcements”), the Board has resolved to change the proposed use of the unutilised net proceeds.

An analysis of the amounts utilised up to 30 June 2026 is set out below:

上市所得款項用途

本公司股份（「股份」）自二零一八年五月十一日（「上市日期」）起於聯交所上市。上市所得款項淨額為約75.0百萬港元（於扣除與上市有關的包銷佣金及其他上市開支後）（「所得款項淨額」），與招股章程所披露的估計所得款項淨額89.7百萬港元不同。差額14.7百萬港元已按招股章程呈列的所得款項用途以相同方式及比例作出調整。根據本公司於二零二二年八月十六日及二零二三年九月二十八日刊發的公告（「該等公告」），董事會已決議變更未動用所得款項淨額的建議用途。

USE OF PROCEEDS FROM THE LISTING

The unutilised Net Proceeds of approximately HK\$1.5 million as at 30 June 2026 is placed with a licensed bank in Hong Kong and is expected to be applied in accordance with the planned use as previously disclosed by the Company in the Prospectus and the Announcements. The Group intends to utilise the remaining Net Proceeds for the planned use on or before 31 December 2026.

Save as disclosed above, the Board currently has no intention to change the planned use of the Net Proceeds as disclosed in the Prospectus and the Announcements.

1. GENERAL AND BASIS OF PREPARATION

The Company was incorporated and registered as an exempted company with limited liability on 15 March 2017 under the Companies Law of the Cayman Islands and its shares were listed on the Main Board of The Stock Exchange of Hong Kong Limited (the “Stock Exchange”) on 11 May 2018 (the “Listing”). The addresses of the Company’s registered office and the principal place of business are Windward 3, Regatta Office Park, PO Box 1350, Grand Cayman, KY1-1108, Cayman Islands and Unit 5, 4th Floor, Chai Wan Industrial City Phase II, No. 70 Wing Tai Road, Hong Kong, respectively. The Company’s immediate and ultimate holding companies are Unique Best Limited and WAN Union Limited, respectively, which were companies incorporated in the British Virgin Islands.

The principal activity of the Company is investment holding and its subsidiaries are primarily engaged in sales and manufacturing of low-voltage electrical power distribution and control devices.

During the reporting period, the Group made sales of mobile phones and determined that, in substance, it acted as an agent in these transactions. Consequently, the resulting agency fee income has been recognised and included as part of other income.

The condensed consolidated financial statements for the six months ended 30 June 2026 have been prepared in accordance with Hong Kong Accounting Standards 34 “Interim Financial Reporting” issued by the Hong Kong Institute of Certified Public Accountants (“HKICPA”) as well as with the applicable disclosure requirements of Appendix D2 to the Rules Governing the Listing of Securities on the Stock Exchange (the “Listing Rules”).

The condensed consolidated financial statements are presented in Hong Kong dollars (“HK\$”), which is also the functional currency of the Company.

Certain comparative figures in the condensed consolidated financial statements have been reclassified to conform to current year’s presentation.

1. 一般事項及編製基準

本公司之主要業務為投資控股，其附屬公司主要從事銷售及製造低壓配電及電力控制裝置。

於報告期內，本集團銷售手機並釐定其實質上於該等交易中擔任代理人。因此，所產生之代理費收入已予確認，並計入其他收入。

Revenue represents amounts received and receivable for the sales of low-voltage electrical power distribution and control devices, less discounts, if any, during the period.

The executive Directors, being the chief operating decision makers (the “CODM”), regularly review revenue analysis by product types, including primarily low-voltage switchboard, local motor control panel, motor control centre, electrical distribution board and control box and electrical parts and replacements, and by location of delivery to customers. The CODM considered the operating activities of sales of low-voltage electrical power distribution and control devices as a single operating segment. Other than revenue analysis, the CODM reviews the profit or loss for the period of the Group as a whole to make decisions about performance assessment and resource allocation. The operation of the Group constitutes one single operating segment under HKFRS 8 “Operating Segments” and accordingly, no separate segment information is prepared. No segment assets and liabilities are presented as the CODM does not regularly review segment assets and liabilities.
