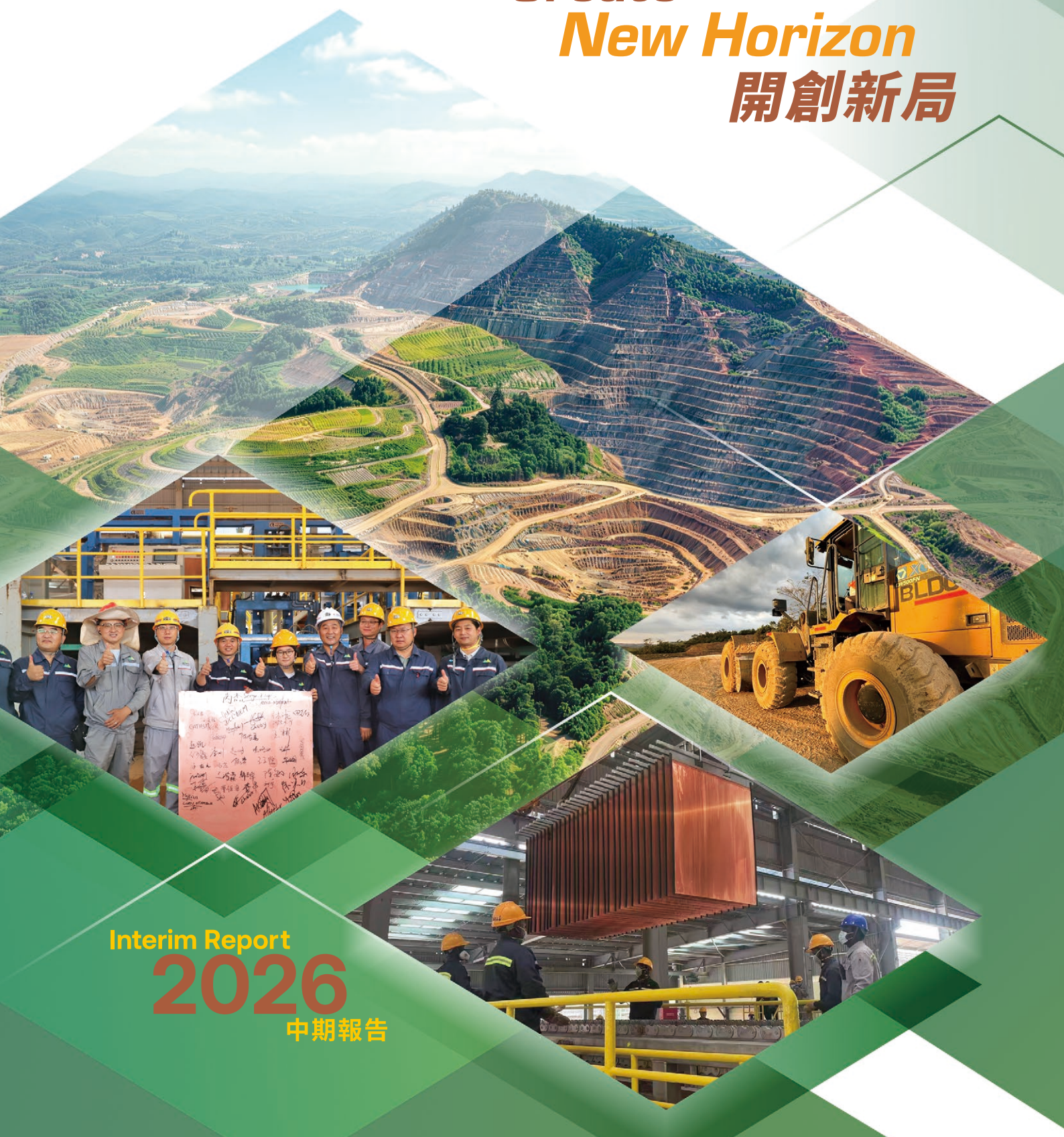

For the six months ended 30 June 2026 ("2026 1H"), the Group's mining operations include three operating mines (Ruashi Mine, Kinsenda Mine and Musonoi Mine), one advanced exploration project (Lubembe Project) and one mine leased out under finance lease agreement (Chibuluma South Mine (including Chifupu Deposit)).

Ruashi Mine's overall copper production decreased by 49%, from 12,765 tonnes for the six months ended 30 June 2025 ("2025 1H") to 6,484 tonnes in 2026 1H. Copper production in 2026 1H comprised 3,694 tonnes of copper content in copper cathode (2025 1H: 2,301 tonnes) and 2,790 tonnes of copper content in copper sulphide concentrate (2025 1H: 10,464 tonnes).

Ruashi礦場的整體銅產量由截至二零二五年六月三十日止六個月（「二零二五年上半年」）的12,765噸減少49%至二零二六年上半年的6,484噸。二零二六年上半年產出的銅包括含銅量3,694噸（二零二五年上半年：2,301噸）的電解銅及含銅量2,790噸（二零二五年上半年：10,464噸）的硫化銅精礦。

Overall cobalt production increased by 244%, from 71 tonnes in 2025 1H to 244 tonnes in 2026 1H.

整體鈷產量由二零二五年上半年的71噸增加244%至二零二六年上半年的244噸。

Copper cathode production for 2026 1H amounted to 3,694 tonnes, representing an increase of 61% compared with 2,301 tonnes in 2025 1H. Production in 2025 1H was affected by a strategic temporary suspension of the SX-EW system from January 2025 to mid-May 2025, following instability in power supply from the national grid to Ruashi Mine, which resulted in lower copper cathode output in 2025 1H.

二零二六年上半年電解銅產量達3,694噸，較二零二五年上半年的2,301噸增長61%。二零二五年上半年的產量受國家電網供應Ruashi礦場的電力不穩定而自二零二五年一月起至二零二五年五月中旬策略性暫時停止SX-EW系統影響，導致二零二五年上半年的電解銅產量下降。

In 2026 1H, copper cathode production remained relatively modest at 3,694 tonnes, primarily due to continued instability in power supply from the national grid in the surrounding area, lower ore grades, and repair and maintenance works at the acid plant.

二零二六年上半年，電解銅產量仍相對低迷，為3,694噸，乃主要由於周邊地區國家電網供電持續不穩定、礦石品位降低及製酸廠進行維修保養工程所致。

Mining Operational Review

Ruashi Mine processed 172,429 tonnes of mixed ore through the flotation plant in 2026 1H (2025 1H: 327,464 tonnes), producing 19,034 tonnes of copper sulphide concentrate for third-party sales (2025 1H: 42,983 tonnes). Copper recovery to concentrate was 79.0% (2025 1H: 89.5%).

Ruashi Mine produced 2,790 tonnes of copper content in copper sulphide concentrate in 2026 1H, a decrease of 7,674 tonnes as compared to 10,464 tonnes in 2025 1H. The flotation plant remained stable during the first four months of 2026 1H, notwithstanding certain constraints, including limited power supply and lower feed grade. Subsequently, flotation plant was temporarily suspended as sales and offtake terms of copper sulphide concentrate are being finalized.

Ruashi mined 182,472 tonnes of ore in 2026 1H, 7% lower than the 196,169 tonnes mined in 2025 1H.

In 2026 1H, Ruashi Mine processed 29,312 tonnes of flotation tailings through the magnetic separation plant (2025 1H: nil). This yielded 21,025 tonnes of magnetic separation concentrate, which were subsequently fed to the leach plant (2025 1H: nil).

Leach feed processed in 2026 1H was mainly sourced from the Ruashi Mine stockpiles. Leach feed processed in 2026 1H totalled 274,415 tonnes, 131% higher than the 118,852 tonnes processed in 2025 1H. The lower feed in 2025 1H was due to the strategic temporary suspension of the SX-EW system from January 2025 to mid-May 2025.

The average copper feed grade in 2026 1H was 2.25%, 22% lower than 2.90% in 2025 1H.

Copper recovery rate was 59.79% in 2026 1H compared to 61.89% in 2025 1H. The decrease was primarily attributable to lower feed grades, higher reagent consumption and power supply constraints affecting operational continuity.

In 2026 1H, Ruashi Mine produced 244 tonnes of cobalt contained in cobalt hydroxide, representing a 244% increase compared to 71 tonnes in 2025 1H. In response to regional power instability, as well as export restrictions and quotas introduced by the DRC Government, cobalt output was strategically curtailed during 2026 1H to prioritize resource allocation toward copper production.

Ruashi礦場於二零二六年上半年經浮選工廠處理172,429噸(二零二五年上半年：327,464噸)混合礦石，生產出19,034噸(二零二五年上半年：42,983噸)供第三方銷售的硫化銅精礦。銅精礦回收率為79.0%(二零二五年上半年：89.5%)。

於二零二六年上半年，Ruashi礦場生產含銅量2,790噸的硫化銅精礦，較二零二五年上半年的10,464噸減少7,674噸。儘管面臨電力供應有限及入廠品位下降等若干限制，二零二六年上半年前四個月的浮選工廠仍保持穩定。其後，浮選工廠已暫時停止，乃由於硫化銅精礦銷售及承購條款仍在敲定中。

Ruashi於二零二六年上半年開採了182,472噸礦石，較二零二五年上半年開採的196,169噸減少7%。

於二零二六年上半年，Ruashi礦場通過磁性分離工廠處理29,312噸浮選尾礦(二零二五年上半年：零)。這產出21,025噸磁性分離精礦，其後輸入浸出廠(二零二五年上半年：零)。

二零二六年上半年處理的浸出進料乃主要源自Ruashi礦場之礦石堆。二零二六年上半年處理的浸出進料總計274,415噸，較二零二五年上半年處理的118,852噸上升131%。二零二五年上半年的入廠量較低乃由於SX-EW系統自二零二五年一月起至二零二五年五月中旬策略性暫時停止。

二零二六年上半年平均銅入廠品位為2.25%，較二零二五年上半年的2.90%下降22%。

二零二六年上半年的銅回收率為59.79%，而二零二五年上半年則為61.89%。下降乃主要由於入廠品位較低、試劑消耗量較高及影響營運持續性的電力供應限制。

於二零二六年上半年，Ruashi礦場生產含鈷量244噸的氫氧化鈷，較二零二五年上半年生產的71噸上升244%。為應對區域電力不穩定性，以及剛果(金)政府實施的出口限制及配額，於二零二六年上半年策略性調降鈷產量以優先投放資源於銅的生產。

Ruashi Mine sent 495 tonnes of copper sulphide concentrates for tolling during 2026 1H (2025 1H: 7,307 tonnes). Tolling concentrate processed during 2026 1H was 4,136 tonnes (2025 1H: 1,161 tonnes) with a metal content of 1,112 tonnes (2025 1H: 243 tonnes), and the recovery rate was 90%. Tolling cathode tons sold in 2026 1H was 1,001 tonnes (2025 1H: 219 tonnes).

The average cobalt feed grade was 0.27% in 2026 1H, compared to 0.28% in 2025 1H. Cobalt recovery was 33% for the 2025 1H, primarily reflecting lower cobalt solubility in the feed ores, persistent power supply constraints, and circuits that were not yet fully optimized following the restart of operations. Cobalt operations at Ruashi Mine had previously been suspended throughout 2025 until resuming in November 2025.

Cobalt sales were 349 tonnes in 2026 1H, constrained by prevailing export quotas and production limitations; No cobalt sales were recorded in 2025 due to the government-imposed export ban. The average realized cobalt price for the period was US\$54,559 per tonne, primarily reflecting stronger prevailing market conditions.

Ruashi Mine main mining license (PE578) was renewed in 2021 for a period of 15 years and will expire in September 2036.

The capital expenditure of Ruashi Mine for 2026 1H was US\$276,000 (2025 1H: US\$1.2 million).

Ruashi礦場於二零二六年上半年委託加工495噸(二零二五年上半年：7,307噸)硫化銅精礦。二零二六年上半年處理的委託加工精礦為4,136噸(二零二五年上半年：1,161噸)，金屬含量為1,112噸(二零二五年上半年：243噸)，回收率為90%。二零二六年上半年銷售的委託加工電解銅為1,001噸(二零二五年上半年：219噸)。

二零二六年上半年平均鈷入廠品位為0.27%，而二零二五年上半年則為0.28%。二零二五年上半年鈷回收率為33%，主要反映入廠礦石的鈷溶解度較低、持續的供電限制及營運重啟後流程尚未完全優化。Ruashi礦場的鈷業務先前已於二零二五年全年暫停，直至二零二五年十一月方才恢復。

受現行出口配額及產能限制規限，二零二六年上半年的鈷銷量為349噸；由於政府實施的出口禁令，二零二五年並未錄得任何鈷銷量。期內平均實現鈷價為每噸54,559美元，主要反映現行市場條件走強。

Ruashi礦場的主要採礦許可證(PE578)已於二零二一年重續15年，且將於二零三六年九月屆滿。

二零二六年上半年Ruashi礦場的資本開支為276,000美元(二零二五年上半年：1.2百萬美元)。

Kinsenda Mine ranks one of the world's highest grade copper deposits and has good access to infrastructure, with a single-lane road connecting the mine to the regional highway 20 km to the west of the site. The current mine life is 9.5 years and there exists substantial additional ore resources that could extend mine life to 20 years and beyond.

Kinsenda Mine reported 3% lower copper production at 14,684 tonnes in 2026 1H as compared to 15,139 tonnes in 2025 1H. This was attributable to a transformer failure which resulted in a power outage in 2026 1H and Kinsenda Mine had to deploy additional diesel generators to support its major mining and dewatering operations.

The ore grade for 2026 1H at 5.13% was 13% higher as compared to 4.55% during 2025 1H. Kinsenda mine suspended some low-grade stopes due to energy constraints and focused operations on high grade areas during 2026 1H to catch up on production.

Plant throughput in 2026 1H of 308,403 tonnes were 13% lower as compared to 2025 1H at 356,499 tonnes, primarily due to the transformer failure leading to a temporary halt for grid electricity supply.

Plant overall recovery rate of 92.7% in 2026 1H was 0.6% lower than that of 93.3% in 2025 1H, driven by higher field oxide ratio and the transformer failure in 2026 1H.

The average realised copper price at Kinsenda Mine was US\$11,969 per tonne for 2026 1H and was 45% higher than that of US\$8,276 per tonne for 2025 1H, due to increase in copper price.

Kinsenda's main mining licence (PE101) was renewed in 2021 for a period of 15 years and will expire in October 2036.

In 2026 1H, Kinsenda Mine incurred US\$18.4 million in capital expenditure, with major investment focused on the expansion and upgrade of the electricity substation alongside ongoing mine development and infrastructure works.

Kinsenda礦場是全球最高品位的銅礦床之一，貫接道路基建之情況良好（有一條單行道連接礦場至礦區西部20公里的區域高速公路）。現礦場壽命為9.5年，且其含大量新增礦石資源可將礦場壽命延長至20年及以上。

Kinsenda礦場於二零二六年上半年之銅產量為14,684噸，較二零二五年上半年的15,139噸低3%。此乃由於變壓器故障，導致二零二六年上半年發生停電及Kinsenda礦場須增用柴油發電機，以支援其主要採礦及排水作業。

二零二六年上半年礦石品位為5.13%，較二零二五年上半年的4.55%上升13%。Kinsenda礦場因能源限制暫停部分低品位採場，並於二零二六年上半年將營運重點轉向高品位礦區以追捕產量。

二零二六年上半年工廠入礦量為308,403噸，較二零二五年上半年的356,499噸下降13%，乃主要由於導致電網供電暫時中斷的變壓器故障所致。

於二零二六年上半年的廠房整體回收率為92.7%，較二零二五年上半年的93.3%下降0.6%，受二零二六年上半年的礦石氧化率較高及變壓器故障驅動。

Kinsenda礦場於二零二六年上半年的平均實現銅價為每噸11,969美元，較二零二五年上半年每噸8,276美元上升45%，乃由於銅價上漲所致。

Kinsenda的主要採礦許可證(PE101)已於二零二一年重續15年，且將於二零三六年十月屆滿。

於二零二六年上半年，Kinsenda礦場產生資本開支18.4百萬美元，主要投資集中於變電站的擴建及升級連同持續進行的礦體開發及基礎設施工程。

The Musonoi Mine commenced operations in November 2025.

Musonoi Mine produced 17,046 tonnes of copper content in cathode for 2026 1H.

For 2026 1H, the copper leach feed grade was 22.17%, leach feed throughput was 88,005 tonnes, and the plant's overall recovery rate was 87.35%. Musonoi Mine is still building circuit inventory within the production circuit.

Musonoi Mine produced 4,101 tonnes of cobalt content in cobalt hydroxide. The cobalt leach feed grade was 7.07% and cobalt recovery was 65.87%.

The realized price for copper was US\$12,573 per tonne. No cobalt sales in 2026 due to the cobalt export quota pending to be agreed with the DRC State for Musonoi Mine. The local management in the DRC and South Africa are trying every endeavor to negotiate with the DRC government for granting the quota the soonest, according to the prevailing government measures.

Exploration Review

In January 2021, the Group undertook a drilling program to collect beneficiation samples across the orebody for further beneficiation test work and to update the resource model, and a geotechnical drilling program to verify the ground condition of the designed pit shell eastern slope. During the first 6 months of 2021, a total of 20 diamond drillholes were drilled over 6,592.36m of which 5,048.20m were used for geological and beneficiation purposes and 1,544.16m for geotechnical characterization.

Musonoi礦場於二零二五年十一月開始營運。

Musonoi礦場於二零二六年上半年生產銅含量17,046噸的電解銅。

於二零二六年上半年，銅入廠浸出液品位為22.17%，入廠浸出液入礦量為88,005噸，及工廠整體回收率為87.35%。Musonoi礦場仍於生產流程內建立在製品存貨。

Musonoi礦場生產含鈷量4,101噸的氫氧化鈷。鈷入廠浸出液品位為7.07%，而鈷回收率為65.87%。

實現銅價為每噸12,573美元。由於Musonoi礦場的鈷出口配額尚待與剛果（金）政府達成協議，二零二六年並無鈷銷售。根據現行政府措施，剛果（金）及南非的當地管理層正竭盡全力與剛果（金）政府磋商，以期盡快獲授配額。

勘探回顧

於二零二一年一月，本集團開展了一項鑽探計劃，以收集整個礦體的選礦樣品，以進行進一步的選礦測試工作並更新資源模型，及一項岩土鑽探計劃，以核實指定邊界範圍東坡的地面情況。二零二一年前六個月共鑽探20個金剛石鑽孔，總長度超過6,592.36米，其中5,048.20米用於地質和選礦目的，1,544.16米用於岩土工程特徵分析。

Mining Operational Review

採礦業務回顧

All boreholes were surveyed using differential global positioning system (GPS) by Siteke Dior Geodesique (SDG) professional surveyors from Lubumbashi, utilizing a Differential GPS (Datum WSG84 and Projection UTM-S35). During April to August 2021, a total of 1,164 samples including certified reference materials (CRMs) were submitted to a laboratory in Zambia for chemical analysis and 86 samples for density assay. A total of 844 samples were sent to ENFI for beneficiation test work and 53 duplicate pulp samples were submitted to another independent laboratory in Johannesburg, South Africa (referee laboratory) for inter-laboratory comparisons.

Mineral resource model was updated in 2021 with the effective date for mineral resource estimation of 31 December 2021 and has upgraded a portion of Inferred Mineral Resources category to Indicated Mineral Resources category.

Taking reducing the strip ratio and enhancing the floatation recovery as the major factors to optimize the BFS result, in 2022, the Group carried out the open pit slope angle optimize calculation as well as several trial beneficiation tests on samples extracted. The Group will further evaluate the different mining scenarios and methodologies options for concentrator and processing.

MINE LEASED OUT UNDER FINANCE LEASE AGREEMENT

Chibuluma South Mine (including Chifupu Deposit)

Operational Review

Chibuluma South Mine (including Chifupu Deposit) and the processing plant were leased to an independent third party since December 2020 in order to realise the remaining value of the mining assets.

The Group is entitled to an one-off lease payments together with monthly royalty payment based on the volume of copper payable sold from Chifupu Deposit at a rate dependent on the prevailing market copper price.

The lessee produced and sold 3,122 tonnes of payable copper (2025 1H: 1,971 tonnes) and the Group had recorded a royalty income of US\$3.9 million (2025 1H: US\$1.37 million) for 2026 1H.

礦產資源模型已於二零二一年更新，礦產資源量估算的生效日期為二零二一年十二月三十一日，並將部分推斷礦產資源種類升級至控制礦產資源種類。

將減少採剝比率及提高浮選回收作為優化BFS結果的主要因素，於二零二二年，本集團進行了露天礦坡角優化計算及對抽取樣本進行若干試驗性選礦檢測。本集團將進一步評估不同的採礦方案以及選礦廠及冶煉廠的方法選擇。

Chibuluma南礦場 (包括Chifupu礦床) 及選礦廠自二零二零年十二月開始出租予一名獨立第三方，以實現採礦資產的剩餘價值。

本集團有權收取一次性之租賃款項及月度礦權使用費，有關費用乃根據自Chifupu礦床出售的銅礦量按當時市場銅價計算得出。

承租人於二零二六年上半年生產及出售3,122噸銅礦 (二零二五年上半年：1,971噸)，本集團錄得礦權使用費3.9百萬美元 (二零二五年上半年：1.37百萬美元)。

Management Discussion and Analysis

管理層討論及分析

BUSINESS REVIEW

JCI and its subsidiaries are principally engaged in (i) the mining of non-ferrous metals, primarily copper and cobalt, in the DRC and Zambia; and (ii) the trading of Mineral and Metal Products in Hong Kong.

The Group recorded a profit attributable to Shareholders for the six months ended 30 June 2026 ("2026 1H") of US\$47.8 million, compared with that of US\$5.5 million for the six months ended 30 June 2025 ("2025 1H"). The significant increase in profit attributable to Shareholders for the 2026 1H was driven by the rise in revenue from copper products which is resulted from both the increase in market copper price and expanded production and overall sales volume after the commissioning of Musonoi Mine. However, the increase in profit was partially offset by the increase in mining and processing cost, as well as depreciation, amortisation and interest expenses, which were no longer capitalized following the Musonoi Mine's commissioning. Additionally, the profit was impacted by an impairment loss on value-added tax ("VAT") recoverable and the DRC super profits tax triggered by the significant increase in copper price in 2026 1H.

The average benchmark LME copper price for 2026 1H was US\$13,088 per tonne, representing a 39% increase as compared to that of US\$9,432 per tonne for 2025 1H. Copper prices reached unprecedented levels during 2026 1H, rising above US\$13,000 per tonne in January 2026 and maintained a steady upward trend to close at US\$13,341 per tonne at the end of June 2026.

The average MB cobalt price for 2026 1H was US\$25.56 per pound (US\$56,350 per tonne*), representing a 94% increase as compared to that of US\$13.16 per pound (US\$29,013 per tonne*) for 2025 1H. Cobalt price recovered in 2026 due to the cobalt export quota system imposed by the DRC government in October 2025.

Mining Operations

The Group has majority control over three operating mines in Africa, which are (i) Ruashi Mine, a copper and cobalt mine located in Lubumbashi, capital of Haut Katanga Province of the DRC; (ii) Musonoi Mine, a copper and cobalt mine situated at the outskirts of Kolwezi, capital of Lualaba Province of the DRC, approximately 360km Northwest of Lubumbashi city; and (iii) Kinsenda Mine, a copper mine located in Haut Katanga Province, the DRC. The Group also has interest over a copper mine located in Zambia which has been leased out under a finance lease agreement (Chibuluma South Mine (including Chifupu Deposit)).

業務回顧

金川國際及其附屬公司主要從事(i)於剛果(金)及贊比亞開採有色金屬，主要為銅及鈷；及(ii)於香港進行礦產品及金屬產品貿易。

本集團於截至二零二六年六月三十日止六個月(「二零二六年上半年」)錄得股東應佔溢利47.8百萬美元，而截至二零二五年六月三十日止六個月(「二零二五年上半年」)則為5.5百萬美元。二零二六年上半年股東應佔溢利大幅增加乃由於市場銅價上漲及Musonoi礦場投產後產能擴大及整體銷量提升導致銅產品收益增加所致。然而，溢利增加乃部分被採礦及冶煉成本以及折舊、攤銷及利息開支(於Musonoi礦場投產後不再資本化)增加所抵銷。此外，溢利受可收回增值稅(「增值稅」)之減值虧損及二零二六年上半年銅價大幅上漲觸發的剛果(金)超額利潤稅所影響。

於二零二六年上半年，倫敦所銅平均基準價為每噸13,088美元，較二零二五年上半年之平均基準價每噸9,432美元上升39%。銅價於二零二六年上半年創下歷史新高，二零二六年一月份升至每噸13,000美元以上，並維持穩步上漲趨勢，於二零二六年六月底收盤報每噸13,341美元。

於二零二六年上半年，金屬導報鈷平均價為每磅25.56美元(每噸56,350美元*)，較二零二五年上半年之平均價每磅13.16美元(每噸29,013美元*)上升94%。鈷價於二零二六年因剛果(金)政府於二零二五年十月實施鈷出口配額制度而回升。

採礦業務

本集團對非洲三個營運礦場擁有多數控制權，分別為(i)位於剛果(金)上加丹加省省會盧本巴希之銅鈷礦Ruashi礦場；(ii)位於剛果(金)盧阿拉巴省省會科盧韋齊郊區的銅鈷礦Musonoi礦場，距盧本巴希市西北約360公里；及(iii)位於剛果(金)上加丹加省之銅礦Kinsenda礦場。本集團亦持有贊比亞的一個銅礦場(即包括Chifupu礦床在內的Chibuluma南礦場)的權益，其已以融資租賃協議方式租出。

In 2026 1H, the Group produced 38,214 tonnes of copper (2025 1H: 27,904 tonnes) and 4,345 tonnes of cobalt (2025 1H: 71 tonnes) and sold 36,083 tonnes of copper (2025 1H: 26,050 tonnes) and 349 tonnes of cobalt (2025 1H: nil).

Copper production was 37% higher in the 2026 1H at 38,214 tonnes as compared to the 2025 1H at 27,904 tonnes. The increase in production was mainly due to the commencement of operation at Musonoi Mine in November 2025, partially offset by the lower production at Ruashi Mine.

Ruashi Mine's copper production in 2026 1H at 6,484 tonnes was 49% lower as compared to 2025 1H at 12,765 tonnes. Production included 2,790 tonnes (2025 1H: 10,464 tonnes) of copper content in copper sulphide concentrate and 3,694 tonnes of copper cathode (2025 1H: 2,301 tonnes).

Copper cathode production for 2026 1H amounted to 3,694 tonnes, representing an increase of 61% compared with 2,301 tonnes in 2025 1H. Production in 2025 1H was affected by a strategic temporary suspension of the SX-EW system from January 2025 to mid-May 2025, following instability in power supply from the national grid to Ruashi Mine, which resulted in lower copper cathode output in 2025 1H.

In 2026 1H, copper cathode production remained relatively modest at 3,694 tonnes, primarily due to continued instability in power supply from the national grid in the surrounding area, lower ore grades, and repair and maintenance works at the acid plant.

Ruashi Mine produced 2,790 tonnes of copper sulphide concentrate in 2026 1H, a decrease of 7,674 tonnes as compared to 10,464 tonnes in 2025 1H. The flotation plant remained stable during the first four months of 2026 1H, notwithstanding certain constraints, including limited power supply and lower feed grade. Subsequently, flotation plant was temporarily suspended to align production with inventory level while sales and offtake terms of copper sulphide concentrate are being finalized.

Kinsenda Mine reported 3% lower copper production at 14,684 tonnes in 2026 1H as compared to 15,139 tonnes in 2025 1H. This was attributable to a transformer failure which resulted in a power outage in 2026 1H and Kinsenda Mine had to deploy additional diesel generators to support its major mining and dewatering operations.

Musonoi Mine started production in November 2025. Musonoi Mine produced 17,046 tonnes of copper cathode in 2026 1H (2025 1H: nil). Musonoi Mine recorded relatively higher production, driven by higher feed grades and increased plant throughput in 2026 1H.

於二零二六年上半年，本集團生產38,214噸銅（二零二五年上半年：27,904噸）及4,345噸鈷（二零二五年上半年：71噸），並出售36,083噸銅（二零二五年上半年：26,050噸）及349噸鈷（二零二五年上半年：無）。

銅產量於二零二六年上半年為38,214噸，較二零二五年上半年的27,904噸高37%。產量增加乃主要由於Musonoi礦場於二零二五年十一月開始營運，惟部分被Ruashi礦場產量降低所抵銷。

Ruashi礦場的銅產量於二零二六年上半年為6,484噸，較二零二五年上半年的12,765噸低49%。產量包括硫化銅精礦中含銅量2,790噸（二零二五年上半年：10,464噸）及3,694噸電解銅（二零二五年上半年：2,301噸）。

二零二六年上半年電解銅產量達3,694噸，較二零二五年上半年的2,301噸增長61%。二零二五年上半年的產量受國家電網供應Ruashi礦場的電力不穩定而自二零二五年一月起至二零二五年五月中旬策略性暫時停止SX-EW系統影響，導致二零二五年上半年的電解銅產量下降。

二零二六年上半年，電解銅產量仍相對低迷，為3,694噸，乃主要由於周邊地區國家電網供電持續不穩定、礦石品位降低及製酸廠進行維修保養工程所致。

於二零二六年上半年，Ruashi礦場生產2,790噸硫化銅精礦，較二零二五年上半年的10,464噸減少7,674噸。儘管面臨電力供應有限及入廠品位下降等若干限制，二零二六年上半年前四個月的浮選工廠仍保持穩定。其後，浮選工廠已暫時停止以使產量與存貨水平保持一致，同時將敲定硫化銅精礦銷售及承購條款。

Kinsenda礦場於二零二六年上半年之銅產量為14,684噸，較二零二五年上半年的15,139噸低3%。此乃由於變壓器故障，導致二零二六年上半年發生停電及Kinsenda礦場須增用柴油發電機，以支援其主要採礦及排水作業。

Musonoi礦場於二零二五年十一月投產。Musonoi礦場於二零二六年上半年電解銅產量為17,046噸（二零二五年上半年：無）。受惠於二零二六年上半年入廠品位提升及工廠入礦量增加，Musonoi礦場的產量相對較高。

Management Discussion and Analysis

The Group also has control over Lubembe Project, a copper project in exploration stage. The project is located in Haut Katanga Province of the DRC.

Trading of Mineral and Metal Products

The trading contracts of Mineral and Metal Products of the Group were completed in 2024. There was no revenue for the trading of Mineral and Metal Products in 2026 1H (2025 1H: nil). Currently, the Group is actively exploring trade opportunities and business areas that align with the Group's strategic growth objectives.

FINANCIAL REVIEW

The Group's operating results for 2026 1H are a consolidation of the results from the operating mines in the DRC and Zambia and the trading of Mineral and Metal Products in Hong Kong.

Revenue

The revenue for the Group's operations for 2026 1H was US\$460.2 million, representing an increase of 152% compared to US\$182.4 million for 2025 1H. Reasons for the increase in revenue for 2026 1H are discussed below.

The Group sold 36,083 tonnes of copper content contained in copper cathode and copper concentrate for 2026 1H (2025 1H: 26,050 tonnes of copper content contained in copper cathode, copper concentrate and direct shipping ore).

The copper sales volume of Ruashi Mine for 2026 1H was 4,817 tonnes and 51% lower as compared to 9,867 tonnes for 2025 1H. Copper cathode sales for 2026 1H was 4,817 tonnes, representing a 112% increase as compared to that for 2025 1H of 2,277 tonnes. There were no sales for copper contained in copper sulphide concentrate (2025 1H: 3,524 tonnes) and sulphide ore (2025 1H: 4,066 tonnes) in 2026 1H.

Musonoi Mine commenced commercial production in November 2025. Musonoi Mine sold 16,336 tonnes of copper cathode in 2026 1H.

Kinsenda Mine sold 14,930 tonnes for 2026 1H representing a decrease of 8% from 16,183 tonnes for 2025 1H due to the transformer failure and lower production throughput during 2026 1H.

Ruashi Mine sold 349 tonnes of cobalt in 2026 1H while no cobalt sales in 2025 1H. The relatively low cobalt hydroxide volume sold as compared to its volume produced is mainly due to the cobalt export quota pending to be agreed with the DRC State for Musonoi Mine. The local management in the DRC and South Africa are trying every endeavor to negotiate with the DRC government for granting the quota the soonest, according to the prevailing government measures.

Copper revenue from mining operations for 2026 1H was US\$441.2 million, representing an increase of 142% as compared to 2025 1H of US\$182.4 million. The increase was primarily attributable to higher copper cathode sales volumes from Musonoi Mine, together with a significant rise in copper prices. The average benchmark LME copper price for 2026 1H was US\$13,088 per tonne, representing a 39% increase as compared to that for 2025 1H of US\$9,432 per tonne. The average price realized of copper for 2026 1H was US\$12,226 per tonne which was 75% higher than that of 2025 1H at US\$7,001 per tonne.

The Group generated US\$19.0 million in cobalt revenue from mining operations in 2026 1H (2025 1H: nil). The average MB cobalt price for 2026 1H was US\$25.56 per pound (US\$56,350 per tonne*) representing a 94% increase compared to US\$13.16 per pound (US\$29,013 per tonne*) in 2025 1H. The average cobalt hydroxide coefficient increased from 68.7% in 2025 1H to 99.44% in 2026 1H.

於二零二六年上半年，本集團售出含銅量36,083噸電解銅及銅精礦（二零二五年上半年：含銅量26,050噸電解銅、銅精礦及直運礦石）。

Ruashi礦場於二零二六年上半年的銅銷量為4,817噸，較二零二五年上半年的9,867噸下跌51%。於二零二六年上半年，電解銅銷量為4,817噸，較二零二五年上半年的2,277噸增加112%。於二零二六年上半年，並無錄得於硫化銅精礦（二零二五年上半年：3,524噸）及硫化礦石（二零二五年上半年：4,066噸）內的含銅量銷量。

Musonoi礦場於二零二五年十一月投入商業生產，並於二零二六年上半年銷售電解銅16,336噸。

Kinsenda礦場於二零二六年上半年銷售14,930噸，較二零二五年上半年的16,183噸減少8%，此乃由於變壓器故障及二零二六年上半年產量下降所致。

Ruashi礦場於二零二六年上半年售出349噸鈷，而二零二五年上半年則無鈷銷售。相較於其產量，氫氧化鈷的銷售量相對較低，乃主要由於Musonoi礦場的鈷出口配額尚待與剛果（金）政府達成協議。根據現行政府措施，剛果（金）及南非的當地管理層正竭盡全力與剛果（金）政府磋商，以期盡快獲授配額。

於二零二六年上半年，來自採礦業務的銅收益為441.2百萬美元，較二零二五年上半年的182.4百萬美元增加142%。增長乃主要由於Musonoi礦場的電解銅銷量增加連同銅價大幅上漲所致。於二零二六年上半年，倫敦金所銅平均基準價為每噸13,088美元，較二零二五年上半年的每噸9,432美元增加39%。二零二六年上半年銅平均實現售價為每噸12,226美元，較二零二五年上半年的每噸7,001美元高75%。

本集團於二零二六年上半年產生來自採礦業務的鈷收益19.0百萬美元（二零二五年上半年：無）。於二零二六年上半年，金屬導報鈷平均價為每磅25.56美元（每噸56,350美元*），較二零二五年上半年的每磅13.16美元（每噸29,013美元*）上升94%。氫氧化鈷平均係數由二零二五年上半年的68.7%增長至二零二六年上半年的99.44%。

There was no revenue from the trading of Mineral and Metal Products in 2026 1H (2025 1H: nil) due to the completion of the trading contracts in 2024. Currently, the Group is actively exploring trade opportunities and business areas that align with the Group's strategic growth objectives.

Cost of Sales

Cost of sales represents the costs associated with the production of copper and cobalt from the Group's mining operations and the purchase cost for the trading of Mineral and Metal Products. The major components of cost of sales are as follows:

Cost of sales for the Group's mining operations was US\$265.6 million for 2026 1H, representing an increase of 99% as compared to US\$133.5 million for 2025 1H.

於二零二六年上半年，本集團採礦業務的銷售成本為265.6百萬美元，較二零二五年上半年的133.5百萬美元增加99%。

The increase in mining costs in 2026 1H was primarily attributable to the commencement of production at Musonoi Mine, an underground mine with relatively higher mining costs, similar to Kinsenda Mine. In addition, higher diesel consumption and energy costs in Kinsenda Mine due to the reliance on diesel generators to maintain underground dewatering, ventilation and hoisting operations during the period of transformer failure.

二零二六年上半年的採礦成本增加乃主要由於Musonoi礦場（一座採礦成本較高且與Kinsenda礦場類似的地下礦場）開始投產。此外，變壓器故障期間需仰賴柴油發電機維持地下排水、通風及提升作業，導致Kinsenda礦場柴油消耗量增加及能源成本上升。

The increase in processing costs in 2026 1H was primarily attributable to the continued decline in ore grades at Ruashi Mine, which resulted in lower feed grades and higher acid consumption in the leaching system; higher prices for key consumables, especially diesel, sulphur and sulphuric acid, led to the increase in processing costs; the temporary suspension of the SX-EW system in 2025 1H in Ruashi Mine reduced processing power and reagent consumption in 2025 1H and the transformer failure in Kinsenda Mine. The increase was further driven by the commencement of operations at Musonoi Mine as its processing cost were first time fully recorded in 2026 1H.

Depreciation of property, plant and equipment and amortisation of mineral rights increased by 52% and 53% respectively, primarily due to the commencement of production at Musonoi Mine triggering the cessation of depreciation capitalisation in previous period.

Royalty Payment

Royalty payment increased from US\$10.3 million in 2025 1H to US\$27.1 million in 2026 1H which was mainly due to the increase in sale of copper in Musonoi Mine and the sale of cobalt in Ruashi Mine.

Gross Profit

The gross profit of the Group increased by US\$129 million from US\$38.5 million in 2025 1H to US\$167.5 million in 2026 1H, primarily due to the rise in revenue from copper products which is resulted from both the increase in market copper price and expanded production and thus overall sales volume after the commissioning of Musonoi Mine, which is partially offset by the increase in the mining and processing cost, as well as the depreciation and amortisation in relation to Musonoi Mine.

Net Finance Costs

Gross interest expenses increased by 9% from US\$23.4 million for 2025 1H to US\$25.6 million for 2026 1H due to the increase in other borrowings and loan from intermediate holding companies, offset by the decrease in market interest rates and the repayment of bank borrowings. The Musonoi project loans interest ceased capitalisation from November 2025 as Musonoi Mine commenced commercial production which significantly increased the finance costs recognised in profit or loss in 2026 1H.

二零二六年上半年的冶煉成本增加乃主要由於Ruashi礦場的礦石品位持續下降，導致入廠品位下降及浸出系統的酸耗增加；關鍵耗材價格上漲，尤其是柴油、硫磺和硫酸，導致冶煉成本上升；Ruashi礦場於二零二五年上半年暫時停止SX-EW系統降低了二零二五年上半年的冶煉能源及溶劑消耗及Kinsenda礦場發生變壓器故障。Musonoi礦場於二零二六年上半年首次全面開始營運並錄得冶煉成本，進一步推動成本增加。

物業、廠房及設備折舊以及礦產權攤銷分別增加52%及53%，乃主要由於Musonoi礦場開始投產引致上一期間的折舊資本化終止。

礦權使用費

礦權使用費由二零二五年上半年的10.3百萬美元增加至二零二六年上半年的27.1百萬美元，主要由於Musonoi礦場的銅銷售及Ruashi礦場的鈷銷售增加所致。

毛利

本集團的毛利由二零二五年上半年的38.5百萬美元增加129百萬美元至二零二六年上半年的167.5百萬美元，乃主要由於市場銅價上漲及Musonoi礦場投產後產能擴大及整體銷量提升導致銅產品收益增加所致，惟部分被採礦及冶煉成本以及與Musonoi礦場有關的折舊及攤銷增加所抵銷。

淨財務成本

利息開支總額由二零二五年上半年的23.4百萬美元增加9%至二零二六年上半年的25.6百萬美元，乃由於其他借款及中間控股公司貸款增加，被市場利率下降及償還銀行借款所抵銷所致。由於Musonoi礦場已展開商業生產，Musonoi項目貸款利息自二零二五年十一月起停止資本化，致使於二零二六年上半年於損益確認的財務成本大幅增加。

The other income, other gains and losses decreased by US\$5.7 million compared with 2025 1H was mainly due to the recognition of the impairment loss on VAT recoverable of US\$6.7 million (2025 1H: nil) which was arrived at after critical assessment on various aspects regarding the likelihood of recovering the historical long outstanding VAT owed by the DRC government to most mining companies, offset by the increase in the royalty income under finance lease agreement from Chibuluma South Mine as the copper price increased.

Selling and distribution costs increased by 60% from US\$14.2 million for 2025 1H to US\$22.7 million for 2026 1H, primarily attributable to the increase in copper sale from Musonoi Mine and cobalt sales from Ruashi Mine which led to the increase in clearing costs.

Administrative Expenses

Administrative expenses increased by US\$4.4 million from US\$3.1 million in 2025 1H to US\$7.5 million in 2026 1H, which was mainly attributable to Musonoi Mine's administrative cost recorded in 2026 1H, the legal and professional fee incurred for progressing the resumption works and the two voluntary cash partial offers raised by two offerors during 2026 1H.

Income Tax Expense

The Group is subject to taxes in Hong Kong, the DRC, Zambia and South Africa due to its business operations in these jurisdictions. An income tax expense of US\$47.8 million was derived in 2026 1H as compared to US\$9.7 million in 2025 1H. The increase in income tax expense was mainly due to the increase in profit before tax in 2026 1H and the provision of the DRC super profits tax triggered by the significant increase in copper price in 2026 1H.

所得稅開支

Profit for the Period

As a result of the above, the Group recorded a consolidated profit after income tax of US\$61.0 million for 2026 1H as compared to that of consolidated profit after income tax of US\$6.4 million for 2025 1H.

Profit Attributable to Shareholders

The Group recorded a profit attributable to the Shareholders amounted to US\$47.8 million for 2026 1H as compared to that of profit attributable to the Shareholders of US\$5.5 million for 2025 1H. The increase of profit attributable to Shareholders for the 2026 1H was driven by the rise in revenue from copper products which is resulted from both the increase in market copper price and expanded production and thus overall sales volume after the commissioning of Musonoi Mine. However, the increase in profit was partially offset by the increase in the mining and processing cost, as well as depreciation and amortisation and interest expenses, which were no longer capitalized upon the Musonoi Mine's commissioning. Additionally, the profit was impacted by an impairment loss on VAT recoverable and the DRC super profits tax triggered by the significant increase in copper price in 2026 1H.

Non-IFRS Financial Measure

C1 cash cost

The term "C1 cash cost" is a non-IFRS performance measure included in this "Management Discussion and Analysis" and is prepared on a per tonne of copper sold basis. The term C1 cash cost does not have any standardised meaning prescribed by IFRS Accounting Standards and therefore may not be comparable to similar measures presented by other mining companies. C1 cash cost is a common performance measure in the copper mining industry and is prepared and presented herein on a basis consistent with industry standard definitions. C1 cash costs include all mining and processing costs, mine site overheads, realisation costs through to refined metal and off-mine costs.

The C1 cash cost increased 42% from US\$3,881 per tonne for 2025 1H to US\$5,494 per tonne for 2026 1H. The increase in C1 cash cost was mainly due to the higher mining and processing costs in 2026 1H as mentioned in the analysis in relation to above "Total cost of sales" section.

Liquidity and Financial Resources

As at 30 June 2026, the Group had bank balances and cash (including bank deposits) of US\$257.4 million as compared to US\$171.2 million as at 31 December 2025.

As at 30 June 2026, the Group had total bank borrowings, overdrafts and other borrowings of US\$480.7 million (31 December 2025: US\$492.2 million) in which the bank borrowings, overdrafts and other borrowings of US\$196.4 million (31 December 2025: US\$181.9 million) are due within one year, bank borrowings of US\$261.6 million (31 December 2025: US\$266.5 million) are due within two to five years and bank borrowings of US\$22.7 million (31 December 2025: US\$43.8 million) are due over five years.

As at 30 June 2026, the Group had loans from related companies of US\$309.7 million (31 December 2025: US\$301.1 million), of which US\$4.4 million (31 December 2025: US\$3.5 million) are due within one year and US\$305.3 million (31 December 2025: US\$297.6 million) are due within two to five years.

The gearing ratio of the Group as at 30 June 2026 was 41.3%. The decrease was due to the stronger operating cash flow generated when compared to 50.0% as at 31 December 2025. Gearing ratio is defined as net debt over total equity, and net debt is derived from total borrowings (including amount due to related companies and bank overdrafts) less bank balances and cash (including bank deposits).

For the six months ended 30 June 2026, the Group financed its operations with loan facilities provided by bank and other borrowings, borrowings from related companies and internally generated cash flows.

Material Acquisitions and Disposals of Investments

On 29 June 2026, the Company announced that the transfer of 5% of the issued shares of Kinsenda to the DRC State at nil consideration pursuant to the requirements of the DRC Mining Code (revised in 2018) in connection with the renewal of Kinsenda's mining permit was approved.

As at 30 June 2026, the transfer had not been completed. Completion remains subject to, among other matters, finalisation of certain amendments to the articles of association of Kinsenda and completion of the necessary documentation and arrangements with the DRC State. Accordingly, no change in the Group's shareholding interest in Kinsenda had been recognised as at 30 June 2026.

Upon completion of the transfer, Kinsenda will remain an indirect non-wholly owned subsidiary of the Company and the Group's effective interest in Kinsenda will decrease from 77% to 72%.

For further details, please refer to the announcement of the Company dated 29 June 2026.

Save as disclosed above, there was no material acquisition or disposal of subsidiaries, associates and joint ventures during the six months ended 30 June 2026.

Significant Capital Expenditures

During the six months ended 30 June 2026, the Group acquired property, plant and equipment amounting to US\$20.8 million (2025 1H: US\$56.7 million) for the Group's mining operations.

Top-Up Placing of Existing Shares and Subscription of New Shares under General Mandate

Pursuant to a top-up placing and subscription agreement (the "Top-Up Placing and Subscription Agreement") entered into by the Company dated 13 March 2025, a placing of 630,000,000 existing shares of the Company held by a substantial shareholder of the Company, was completed on 17 March 2025 at HK\$0.628 per Share to not less than six independent placees. Subsequently on 25 March 2025, the Company issued 630,000,000 new shares at HK\$0.628 per Share to the same substantial shareholder of the Company under the general mandate. The above placing or issue price of HK\$0.628 per share represented a discount of approximately 13.97% to the closing price of HK\$0.730 per Share as quoted on the Stock Exchange on 12 March 2025, being the last full trading day immediately prior to the date of the Top-Up Placing and Subscription Agreement. Independent Forensic Investigation

On 28 March 2025, the Share trading of the Company was suspended as a result of delay in publication of annual results for the year ended 31 December 2024 due to additional works focused on matters primarily concerning an allegation on certain payments of Ruashi SAS over the past few years, which required further investigation (the “Allegation”).

An independent forensic accountant was appointed on 16 April 2025 to conduct an independent forensic investigation.

Any matters identified through the independent forensic investigation that were relevant to the financial statements have been appropriately reflected in the condensed consolidated financial statements or disclosed in prior periods, where applicable.

Internal Control Review

An internal control consultant was appointed to conduct an internal control review ("IC Review") in August 2025.

The Board, based on finding of the IC Review as set out in the announcement dated 3 June 2026, agreed with the findings and recommendations of the IC Review, and are satisfied that the Company has adopted and/or implemented (if appropriate) all recommendations made by the internal control consultant in the IC Review.

Details of Charges on the Group's Assets

As at 30 June 2026, none of the Group's assets were pledged or subject to encumbrance to secure general banking facilities granted to the Group.

Details of Contingent Liabilities

As at 30 June 2026, the Group did not have any significant contingent liabilities.

Foreign Exchange Risk Management

The reporting currency of the Group is US\$ and the functional currencies of subsidiaries of the Group are mainly US\$. The Group is also exposed to currency change in HK\$, ZAR, CDF and ZMW. Given the exchange rate peg between HK\$ and US\$, the Group is not exposed to significant exchange rate risk of HK\$. The Group's significant assets are located in the DRC, Zambia and South Africa and the Group is exposed to fluctuation in CDF, ZMW and ZAR. The Group monitors its exposure to foreign currency exchange risk on an on-going basis.

PROSPECT

During the first half of 2026, global copper prices demonstrated an overall upward trajectory, commencing the period at US\$12,500 per tonne and trading predominantly within a range of US\$12,000 per tonne to US\$13,600 per tonne. Over the six-month period, the average benchmark copper price reached US\$13,088 per tonne. This positive price performance was driven primarily by widespread mine supply disruptions, resilient Chinese demand alongside trade tariff uncertainties, and constrained sulphuric acid availability for SX-EW leaching operations. Despite short-term macroeconomic fluctuations, these compounding factors sustained structural tightness across the global value chain, maintaining benchmark prices at historically elevated levels throughout the first half of the year.

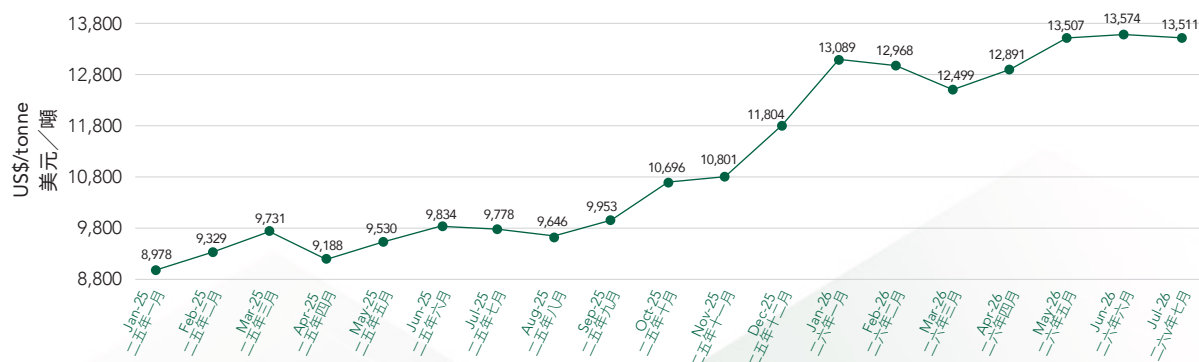
On the demand side, global consumption is anchored by the clean energy transition, electric vehicle adoption, and expanding artificial intelligence data center infrastructure. Global power grid expansion and reinforcement represent the single largest long-term demand catalyst, requiring substantial copper intensity to connect decentralized renewables and charging networks. On the supply side, the mining industry faces severe structural bottlenecks, including declining global ore grades, long development lead times and escalating capital intensity. Compounded by operational disruptions and processing constraints across key producing regions, primary mine supply is struggling to keep pace.

展望

於二零二六年上半年，全球銅價整體呈現上升趨勢，期內初始價格為每噸12,500美元及主要於每噸12,000美元至每噸13,600美元之間買賣。於六個月期間，平均基準銅價達每噸13,088美元。銅價表現向好主要受多項因素推動，包括礦山供應廣泛受阻、中國需求保持韌性及貿易關稅不確定性，以及SX-EW浸出作業所需硫酸受限。儘管短期宏觀經濟波動，上述多重因素共同令全球價值鏈持續呈現結構性緊張，並使基準銅價於上半年維持於歷史高位水平。

需求方面，全球銅消費主要受清潔能源轉型、電動車普及及人工智能數據中心基礎設施擴張所支撐。全球電力網絡擴建及強化為長期需求增長的最大單一推動因素，因連接分散式可再生能源及充電網絡需要大量銅資源。供應方面，採礦行業正面臨嚴重的結構性瓶頸，包括全球礦石品位下降、開發週期延長以及資本密集度上升。加上主要產區受到營運中斷及加工限制，原生礦山供應難以維持。

Looking ahead, copper prices are expected to remain firmly supported by a widening structural supply deficit. While short-term macroeconomic volatility and tariff policies may induce interim price fluctuations, the fundamental imbalance between expanding global electrification demand and constrained primary mine supply establishes a solid price foundation, supporting a positive long-term trajectory.

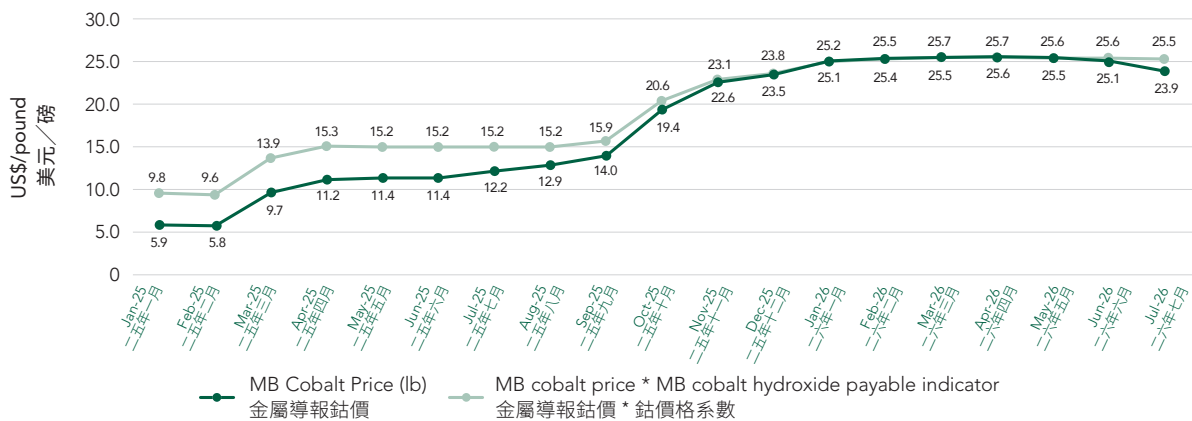
The global cobalt market demonstrated robust pricing stability through the first half of 2026, driven primarily by tightening structural supply constraints. Cobalt metal prices appreciated steadily from approximately US\$24.25 per pound at the start of the year to US\$25.60 per pound by mid-year, while cobalt hydroxide payables maintained exceptionally high levels near 100%. Cobalt export quotas in the DRC restricted global supply and forced buyers to rapidly draw down inventory outside the region, driving up market prices. The persistent supply restrictions and ongoing inventory depletion will continue to underpin market tightness and support favorable pricing fundamentals.

Global demand for cobalt remains firmly anchored in long-term structural trends, primarily driven by the global transition toward clean energy, electric vehicle fleet expansion, and the development of grid-scale energy storage systems. Electric vehicle battery deployment continues to serve as the principal catalyst for consumption, with battery applications accounting for the vast majority of incremental market growth.

二零二六年上半年，全球鈷市場價格表現保持穩健，主要受結構性供應收緊所推動。鈷金屬價格由年初約每磅24.25美元穩步上升至年中每磅25.60美元，而氫氧化鈷計價系數維持於接近100%的極高水平。剛果（金）鈷出口配額收緊全球供應，促使買家迅速消耗該地區以外的庫存，從而推高市場價格。持續的供應限制及庫存不斷下降將繼續支撐市場供應緊張及利好價格基本面。

全球鈷需求仍牢牢植根於長期結構性趨勢，主要受全球清潔能源轉型、電動車車隊擴張以及電網級儲能系統發展所帶動。電動車電池應用持續為消費的主要增長動力，而電池應用佔增量市場的絕大部分。

Global cobalt prices will be driven by the DRC export quotas constraining global supply against expanding demand from electric vehicles, AI infrastructure, and strategic stockpiling. As surplus inventories deplete, this structural deficit underpins a firm and supporting price for cobalt.

The Group aims to become a world-class mineral corporation, with the recent commencement of commercial production at the Musonoi Mine in November 2025, its third operating mine in the DRC. The mine's primary products include copper cathode, cobalt hydroxide, and calcine sand, which are expected to contribute significantly to the Group's economic growth and bring benefits to Shareholders.

全球鈷價走勢將受剛果（金）出口配額限制全球供應，以及電動車、人工智能基礎設施及戰略儲備所帶動的需求增長共同影響。隨著過剩庫存消耗，該結構性缺口將為鈷價提供堅實支撐。

本集團旨在成為世界級礦產企業。近期，本集團於二零二五年十一月在剛果（金）的第三個營運礦場 Musonoi 礦場開始進行商業生產。該礦場的主要產品包括電解銅、氫氧化鈷及焙砂，預計該等產品將大幅助力本集團的經濟增長並為股東帶來效益。

Since the Group's business spans over different regions and countries, our overseas businesses are therefore susceptible to the stability of and changes in the local government policies, social and economic environments, and international relations. If there are any material adverse changes in the aforesaid factors, our business, financial condition and operating results may be adversely affected. We endeavor to closely monitor the aforesaid situation and promptly adjust our strategies in response thereto.

Also, with the continuous support of JCG and prudent strategic planning of the Board, the Group remains confident that the performance of the Group will overcome such unfavorable market conditions and create values for the stakeholders of the Company. We will continue to improve our quality and efficiency and strive to continuously reduce production costs.

EMPLOYEES

As at 30 June 2026, the Group had 1,697 (30 June 2025: 1,691) permanent workers and 4,575 (30 June 2025: 3,678) contractor's employees. Employees of the Group receive competitive remuneration packages including salary and medical and other benefits. Key staff may also be entitled to performance bonuses, grant of share option and share award of the Company.

DIVIDEND

The Board has resolved not to declare any interim dividend for the six months ended 30 June 2026 (six months ended 30 June 2025: Nil).

- (i) On 18 December 2020, Ruashi SAS, a 70% owned subsidiary of the Company and the owner of the Musonoi Project, entered into a facility agreement (the “**Ruashi Facility Agreement**”) with a bank in relation to a term loan facility in an amount of US\$350,000,000 for financing the development and construction of Musonoi Project. The final repayment date of the term loan facility will be the date falling 10 years from the date of the first utilisation of such facility, which had taken place on 11 June 2021. Utilisation should take place within 48 months from the date of the Ruashi Facility Agreement.

Pursuant to the Ruashi Facility Agreement, the term loan facility may be cancelled and all the outstanding amounts may become immediately due and payable if (i) JCG (as guarantor), the controlling shareholder of the Company, ceases directly or indirectly to own and control 55% of the issued shares capital of the Company or the control of the Company; (ii) the State-owned Assets Supervision and Administration Commission of Gansu Province ceases directly or indirectly to legally or beneficially own and control 51% of the issued share capital of JCG; or (iii) the Company ceases directly or indirectly to own 75% of the issued share capital of Ruashi SAS or the control of Ruashi SAS except where the issued share capital of Ruashi SAS or any part thereof is required to be transferred or sold down to comply with the requirements of the applicable mining legislation of the DRC in connection with or arising from the renewal of the exploitation permit under the project in Kolwezi, Lualaba Province of the DRC provided that, however, after the renewal of the exploitation permit, the Company still directly or indirectly owns and controls 70% of Ruashi’s SAS issued share capital.

- (iv) On 9 June 2025, Ruashi SAS, has signed a banking facility agreement with a bank for a term loan facility in an aggregate principal amount of up to US\$200,000,000 for a term of 10 years. The loan shall be used for financing the deep processing development and construction of the Musonoi Project owned by Ruashi SAS. Pursuant to the facility agreement, the loan may be cancelled and all the outstanding amounts may become immediately due and payable if JCG ceases directly or indirectly to legally and beneficially own and control 55% of the issued shares of the Company.

(5) The maximum entitlement of each participant

No awarded share shall be granted to any participant if, at the relevant time of grant, the aggregate of the number of relevant shares granted to such participant in any 12-month period would exceed 1% of the total number of shares in issue at such time, unless such grant has been duly approved, by ordinary resolution of the shareholders in general meeting in accordance with Chapter 17 of the Listing Rules.

(5) 每名參與人士可獲授權益上限

倘於相關授出時，於任何十二個月期間向該參與人士授出的相關股份總數超過當時已發行股份總數的1%，則不得向任何參與人士授出激勵股份，除非該授出已根據上市規則第十七章獲股東於股東大會上通過普通決議案正式批准。

(6) Grant and vesting period of awarded shares

Subject to the terms of the 2024 Share Incentive Scheme, the Board shall be entitled but shall not be bound at any time within the period of 10 years after 26 June 2024 to make an offer to any participant, taking into account such factors as the Board may at its discretion consider appropriate. The Board may in its absolute discretion specify such conditions as it thinks fit when making an offer to a participant (including, without limitation, as to performance criteria which must be satisfied by the participant and/or the Company and/or its subsidiaries, before the awarded shares may be vested), provided that such conditions shall not be inconsistent with any other terms and conditions of the 2024 Share Incentive Scheme and the Listing Rules.

Subject to the specific circumstances as set out in the 2024 Share Incentive Scheme, the minimum vesting period for all awarded shares is 12 months.

(7) Payment on acceptance of awarded shares and the basis of determining the purchase price of shares awarded

The awarded shares shall be granted to the participants at nil consideration unless otherwise decided by the Board. The purchase price of the awarded shares (if any) shall be such price which shall be determined by the Board from time to time based on considerations such as the prevailing closing price of the shares, the purpose of the grant of the awarded shares and the characteristics and profile of the participants.

(8) The remaining life of the 2024 Share Incentive Scheme

Subject to any early termination determined by the Board in accordance with the rules of the 2024 Share Incentive Scheme, the 2024 Share Incentive Scheme is valid and effective for a term of 10 years commencing on its adoption date (i.e. 26 June 2024 to 25 June 2034). The remaining life of the 2024 Share Incentive Scheme was approximately eight years (as of 30 June 2026).

The Audit Committee's primary duties include review of the effectiveness of the Group's financial reporting process, internal control and risk management systems, overseeing the audit process and performing other duties as may be assigned by the Board from time to time. The Audit Committee is provided with sufficient resources to perform its duties, including support, as necessary, from the internal audit function of the Group, the external auditor, legal counsel, regulatory compliance and management, in examining all matters relating to the Group's adopted accounting principles and practices, and in reviewing all material financial, operational and compliance controls. The Group's unaudited interim financial statements and the interim report for the six months ended 30 June 2026 have been reviewed by the Audit Committee.

1. GENERAL

Jinchuan Group International Resources Co. Ltd. (the “**Company**”) is a public limited company incorporated in the Cayman Islands and its shares are listed on The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”). Its ultimate holding company is 金川集團股份有限公司 (Jinchuan Group Co., Ltd*) (“**JCG**”), a state-owned enterprise established in the PRC. The address of registered office and the principal place of business of the Company are disclosed in the “Corporate Information” section of the interim report.

The Company is an investment holding company. The principal activities of the Company and its subsidiaries (collectively referred to as the “**Group**”) are mining operations and the trading of Mineral and Metal Products.

The condensed consolidated financial statements are presented in United States dollars (“**US\$**”), which is also the functional currency of the Company.

2. BASIS OF PREPARATION

The condensed consolidated financial statements have been prepared in accordance with the International Accounting Standard (“**IAS**”) 34 “Interim Financial Reporting” issued by the International Accounting Standards Board (“**IASB**”) as well as with the applicable disclosure requirements of Appendix D2 to the Rules Governing the Listing of Securities on the Stock Exchange (the “**Listing Rules**”).

3. PRINCIPAL ACCOUNTING POLICIES

The condensed consolidated financial statements have been prepared on the historical cost basis except for certain financial instruments, which have been measured at fair values, as appropriate.

In preparing the condensed consolidated financial statements, the Directors have given careful consideration to the future liquidity of the Group, in light of the fact that the Group recorded net current liabilities of approximately US\$13.6 million as at 30 June 2026 (31 December 2025: US\$68.4 million). In assessing the Group’s ability to continue as a going concern, the Directors have considered cash flow forecasts covering a period of not less than twelve months from the date of approval of these condensed consolidated financial statements, taking into account internally generated funds, available banking facilities and the ongoing financial support from the Group’s intermediate holding company, which has confirmed its continued financial support.

As at 30 June 2026, and up to the date of this report, the transfer had not been completed. Completion remains subject to, among other matters, finalisation of certain amendments to the articles of association of Kinsenda and completion of the necessary documentation and arrangements with the DRC State.

Accordingly, no change in the Group's shareholding interest in Kinsenda had been recognised as at 30 June 2026.

Upon completion of the transfer, Kinsenda will remain an indirect non-wholly owned subsidiary of the Company and the Group's effective interest in Kinsenda will decrease from 77% to 72%.
