MANAGEMENT DISCUSSION AND ANALYSIS

管理層討論及分析

2026年上半年，中遠海運國際（香港）有限公司（「中遠海運國際」或「本公司」）及其附屬公司（統稱「本集團」）的權益持有人應佔溢利為485,637,000港元（2025年：487,223,000港元），同比下跌0.3%，而每股基本及攤薄盈利為33.13港仙（2025年：33.24港仙），同比下跌0.3%。跌幅主要是由於財務收益及匯兌收益淨額減少所致。

財務回顧

收入

截至2026年6月30日止六個月，本集團的收入為2,092,450,000港元（2025年：1,934,118,000港元），同比上升8%。核心業務航運服務業的收入為2,092,431,000港元（2025年：1,928,259,000港元），同比上升9%，佔本集團收入近乎100%（2025年：99.7%），主要由於塗料、保險顧問及船舶設備及備件的分部收入上升所致。一般貿易的分部收入為19,000港元（2025年：5,859,000港元），同比下跌100%，佔本集團收入近乎0%（2025年：0.3%）。

毛利及毛利率

截至2026年6月30日止六個月，本集團的毛利為516,793,000港元（2025年：498,803,000港元），同比上升4%，主要由於保險顧問的分部收入上升及船舶設備及備件分部毛利上升所致。整體毛利率為25%（2025年：26%），同比下跌1個百分點，主要由於塗料分部受美伊戰爭局勢影響，原材料及運輸成本上漲令毛利率下跌所致。

During the first half of 2026, profit attributable to equity holders of COSCO SHIPPING International (Hong Kong) Co., Ltd. ("COSCO SHIPPING International" or the "Company") and its subsidiaries (collectively the "Group") was HK\$485,637,000 (2025: HK\$487,223,000), decreased by 0.3% year-on-year, while the basic and diluted earnings per share was 33.13 HK cents (2025: 33.24 HK cents), decreased by 0.3% year-on-year. The decrease was mainly due to the decrease in finance income and net exchange gains.

FINANCIAL REVIEW

Revenue

For the six months ended 30 June 2026, the Group's revenue was HK\$2,092,450,000 (2025: HK\$1,934,118,000), increased by 8% year-on-year. Revenue from the core business of shipping services was HK\$2,092,431,000 (2025: HK\$1,928,259,000), increased by 9% year-on-year, and accounted for nearly 100% (2025: 99.7%) of the Group's revenue, mainly due to the increase in revenues from coatings, insurance brokerage and marine equipment and spare parts segments. Revenue from general trading segment was HK\$19,000 (2025: HK\$5,859,000), decreased by 100% year-on-year, and accounted for nearly 0% (2025: 0.3%) of the Group's revenue.

Gross Profit and Gross Profit Margin

For the six months ended 30 June 2026, the Group's gross profit was HK\$516,793,000 (2025: HK\$498,803,000), increased by 4% year-on-year, mainly due to the increase in revenue from insurance brokerage segment and the increase in gross profit of marine equipment and spare parts segment. The overall gross profit margin was 25% (2025: 26%), decreased by 1 percentage point year-on-year, mainly due to the impact of the U.S.-Iran war, where rising raw materials and transportation costs led to a decline in gross profit margin of coatings segment.

管理費收益

截至2026年6月30日止六個月，來自本公司就中遠海運（香港）有限公司（「香港中遠海運」）及其附屬公司（與本集團及Piraeus Port Authority S.A. 有關者除外）的日常業務營運及管理所提供管理服務的管理費收益為40,583,000港元（2025年：42,277,000港元），同比下跌4%，主要由於與香港中遠海運及其上述附屬公司有關的行政及一般費用減少所致。

其他收益及利得 — 淨額

截至2026年6月30日止六個月，其他收益及利得 — 淨額為74,551,000港元（2025年：63,560,000港元），同比上升17%，主要由於貿易應收款減值撥備撥回淨額增加所致，但另一方面，匯兌收益淨額減少抵銷了部份升幅。

銷售、行政及一般費用

截至2026年6月30日止六個月，銷售、行政及一般費用為347,473,000港元（2025年：354,277,000港元），同比下跌2%，主要由於僱員福利費用減少所致。

經營溢利

本集團的經營溢利為284,454,000港元（2025年：250,363,000港元），同比上升14%，主要由於收入及毛利增加所致。

財務收益

財務收益（主要為本集團於銀行存款的利息收益）為97,087,000港元（2025年：112,872,000港元），同比下跌14%，主要由於存款利率下跌所致。

財務成本

財務成本（主要為租賃負債、短期借貸利息費用及其他財務支銷）為773,000港元（2025年：726,000港元），同比增加6%。

Management Fee Income

For the six months ended 30 June 2026, management fee income arising from the provision of management services by the Company in relation to the day-to-day business operations and management of COSCO SHIPPING (Hong Kong) Co., Limited (“COSCO SHIPPING (Hong Kong)”) and its subsidiaries (other than those relating to the Group and Piraeus Port Authority S.A.) was HK\$40,583,000 (2025: HK\$42,277,000), decreased by 4% year-on-year, mainly due to the decrease in administrative and general expenses related to COSCO SHIPPING (Hong Kong) and its subsidiaries mentioned above.

Other Income and Gains — Net

For the six months ended 30 June 2026, other income and gains — net was HK\$74,551,000 (2025: HK\$63,560,000), increased by 17% year-on-year, mainly due to the increase in net reversal of provision for impairment of trade receivables, which was partly offset by a decrease in net exchange gains.

Selling, Administrative and General Expenses

For the six months ended 30 June 2026, selling, administrative and general expenses was HK\$347,473,000 (2025: HK\$354,277,000), decreased by 2% year-on-year, mainly due to the decrease in employee benefit expenses.

Operating Profit

The Group's operating profit was HK\$284,454,000 (2025: HK\$250,363,000), increased by 14% year-on-year, mainly due to the increase in revenue and gross profit.

Finance Income

Finance income, which primarily represented interest income on the Group's bank deposits, was HK\$97,087,000 (2025: HK\$112,872,000), decreased by 14% year-on-year, mainly due to the decrease in interest rates of deposits.

Finance Costs

Finance costs, which primarily represented interest expenses on lease liabilities, short-term borrowings and other finance charges, was HK\$773,000 (2025: HK\$726,000), increased by 6% year-on-year.

應佔合營企業溢利

本集團應佔合營企業的溢利為175,419,000港元(2025年:178,709,000港元)。該項目主要包括應佔中遠佐敦船舶塗料(香港)有限公司(「中遠佐敦」)的溢利163,675,000港元(2025年:171,319,000港元)以及應佔常熟耐素生物材料科技有限公司(「常熟耐素」)的溢利9,348,000港元(2025年:5,612,000港元)，有關金額已計入塗料分部內。

應佔聯營公司溢利

本集團應佔聯營公司的溢利為3,493,000港元(2025年:8,616,000港元)。該項目主要包括應佔浙江四兄繩業有限公司(「浙江四兄繩業」)的溢利2,335,000港元(2025年:6,144,000港元)，有關金額已計入一般貿易分部內。

本公司權益持有人應佔溢利

本公司權益持有人應佔溢利為485,637,000港元(2025年:487,223,000港元)，同比下跌0.3%。

財務資源及流動資金

於2026年6月30日，本公司權益持有人應佔股本及儲備增加1%至8,055,778,000港元(於2025年12月31日:7,941,705,000港元)。於2026年6月30日，本集團的現金及存款總額(包括受限制銀行存款5,757,000港元)為6,053,845,000港元(於2025年12月31日:5,816,862,000港元，包括受限制銀行存款5,536,000港元)。期內，本集團提取短期借貸淨額人民幣10,441,000元(約12,021,000港元)(2025年同期:無)。於2026年6月30日，本集團的貿易相關信貸總額為353,153,000港元(於2025年12月31日:342,492,000港元)，其中65,407,000港元(於2025年12月31日:49,993,000港元)已被動用。負債比率(即借貸總額佔總資產比例)為0.11%(於2025

Share of Profits of Joint Ventures

The Group's share of profits of joint ventures was HK\$175,419,000 (2025: HK\$178,709,000). This item primarily represented the share of profits of Jotun COSCO Marine Coatings (HK) Limited ("Jotun COSCO") of HK\$163,675,000 (2025: HK\$171,319,000) and 常熟耐素生物材料科技有限公司 (Nasurfar Biomaterial Technology (Changshu) Co., Ltd.*) ("Nasurfar Changshu") of HK\$9,348,000 (2025: HK\$5,612,000), which were included in the coatings segment.

Share of Profits of Associates

The Group's share of profits of associates was HK\$3,493,000 (2025: HK\$8,616,000). This item primarily represented the share of profit of 浙江四兄繩業有限公司 (Zhejiang Four Brothers Rope Co., Ltd.*) ("Zhejiang Four Brothers Rope") of HK\$2,335,000 (2025: HK\$6,144,000), which was included in the general trading segment.

Profit Attributable to Equity Holders of the Company

Profit attributable to equity holders of the Company was HK\$485,637,000 (2025: HK\$487,223,000), decreased by 0.3% year-on-year.

FINANCIAL RESOURCES AND LIQUIDITY

As at 30 June 2026, capital and reserves attributable to the Company's equity holders increased by 1% to HK\$8,055,778,000 (as at 31 December 2025: HK\$7,941,705,000). As at 30 June 2026, total cash and deposits (including restricted bank deposits of HK\$5,757,000) of the Group was HK\$6,053,845,000 (as at 31 December 2025: HK\$5,816,862,000, including restricted bank deposits of HK\$5,536,000). During the period, the Group had net drawdown of short-term borrowings in the amount of RMB10,441,000 (approximately HK\$12,021,000) (for the same period of 2025: nil). As at 30 June 2026, total trading related facilities of the Group amounted to HK\$353,153,000 (as at 31 December 2025: HK\$342,492,000), of which HK\$65,407,000 (as at 31 December 2025: HK\$49,993,000) had been utilised. The gearing ratio, which represented total borrowings over total assets, was 0.11% (as at 31 December 2025: nil). As at 30 June 2026, the Group had net cash (represented by total non-current bank deposits, restricted bank

年12月31日：無)。於2026年6月30日，本集團擁有淨現金(即非流動銀行存款、受限制銀行存款及流動存款以及現金及現金等價物總額，減短期借貸)為6,041,824,000港元(於2025年12月31日：5,816,862,000港元)。本集團根據風險、回報及流動性的適度平衡，投資於多樣化且穩健及保守的金融產品，當中包括隔夜存款、定期存款及離岸定期存款，以提高本集團的財務收益，並同時確保現金可適時用以應付本集團的承擔及需要。期內，本集團現金回報率為3.27%(2025年同期：3.75%)。本集團並沒有使用任何金融工具作利率對沖用途。

財務風險管理

本集團主要在香港、中華人民共和國(「中國」)及海外營運，須承擔所持外幣(主要為人民幣及美元)產生的外匯風險。外匯風險來自商業交易及已確認的資產及負債。本集團通過定期評估其營運的附屬公司所面對的外幣風險管理其外匯風險，並將於需要時考慮使用遠期外匯合約對沖風險。本集團嚴格控制使用衍生金融工具。此外，於中國兌換人民幣為外幣受到中國政府所頒佈的外匯管制規則及規例所限制。

僱員

於2026年6月30日，除合營企業及聯營公司以外，本集團有805名(於2025年12月31日：808名)僱員，其中202名(於2025年12月31日：205名)為香港僱員。期內，包括董事酬金及公積金的僱員福利費用總額為252,290,000港元(2025年同期：253,458,000港元)。僱員薪酬乃根據其表現及經驗而釐定。薪酬待遇包括參考市場狀況和個別表現而釐定的薪金及酌情年終花紅。期內，所有香港僱員均已參加強制性公積金計劃或認可的職業退休計劃。

deposits and current deposits and cash and cash equivalents, net of short-term borrowings) of HK\$6,041,824,000 (as at 31 December 2025: HK\$5,816,862,000). To enhance the Group's finance income and to ensure availability of cash at appropriate times to meet the Group's commitments and needs, the Group, on the basis of balancing risk, return and liquidity, invested in a mixture of stable and conservative financial products, including overnight deposits, term deposits and offshore fixed deposits. During the period, return on the Group's cash was 3.27% (for the same period of 2025: 3.75%). The Group had no financial instruments for interest rate hedging purposes.

FINANCIAL RISK MANAGEMENT

The Group principally operates in Hong Kong, the People's Republic of China (the "PRC") and overseas, and is exposed to foreign exchange risk arising from foreign currencies held, mainly Renminbi and U.S. dollars. Foreign exchange risk arises from commercial transactions and recognised assets and liabilities. The Group manages its foreign exchange exposure by regularly reviewing the foreign currency exposure of its operating subsidiaries and will consider hedging exposure by foreign exchange forward contracts when the need arises. The Group exercises stringent control over the use of derivative financial instruments. In addition, the conversion of Renminbi into foreign currencies in the PRC is subject to the rules and regulations of foreign exchange controls promulgated by the government of the PRC.

EMPLOYEES

As at 30 June 2026, excluding those in joint ventures and associates, the Group had 805 (as at 31 December 2025: 808) employees, of whom 202 (as at 31 December 2025: 205) were Hong Kong employees. During the period, total employee benefit expenses, including directors' emoluments and provident funds, were HK\$252,290,000 (for the same period of 2025: HK\$253,458,000). Employees were remunerated on the basis of their performance and experience. Remuneration packages include salary and a year-end discretionary bonus, which are determined with reference to market conditions and individual performance. During the period, all Hong Kong employees participated in the Mandatory Provident Fund Scheme or recognised occupational retirement schemes.

於2020年4月28日，本公司根據股票期權激勵計劃向本公司若干董事及本集團若干僱員授予合共23,830,000份股票期權，可按每股2.26港元的價格認購合共23,830,000股本公司股份（「股份」）。待若干條件達成後，該等股票期權可於2022年4月28日至2026年4月27日分批行使。

於2020年10月6日，本公司根據股票期權激勵計劃向本集團若干僱員授予合共2,460,000份股票期權，可按每股2.184港元的價格認購合共2,460,000股本公司股份。待若干條件達成後，該等股票期權可於2022年10月6日至2026年10月5日分批行使。

於2021年4月7日，本公司根據股票期權激勵計劃向本集團若干僱員授予合共1,370,000份股票期權，可按每股2.72港元的價格認購合共1,370,000股本公司股份。待若干條件達成後，該等股票期權可於2023年4月7日至2027年4月6日分批行使。

上述各批股票期權可於下述期間內行使：
(a) 33.3%股票期權可由各授予日起24個月（滿兩週年）後的首個交易日起至各授予日起36個月的最後一個交易日當日止行使；
(b) 33.3%股票期權可由各授予日起36個月（滿三週年）後的首個交易日起至各授予日起48個月的最後一個交易日當日止行使；
及(c) 33.4%股票期權可由各授予日起48個月（滿四週年）後的首個交易日起至各授予日起72個月的最後一個交易日當日止行使。

The share option incentive scheme of the Company was adopted by the shareholders of the Company (the “Shareholder(s)”) at the special general meeting of the Company on 9 April 2020 (the “Share Option Incentive Scheme”).

The Company granted an aggregate of 23,830,000 share options to certain directors of the Company and certain employees of the Group to subscribe for a total of 23,830,000 shares of the Company (the “Share(s)”) at a price of HK\$2.26 per share on 28 April 2020 under the Share Option Incentive Scheme. Subject to the fulfillment of the relevant conditions, these share options granted are exercisable from 28 April 2022 to 27 April 2026 in batches.

The Company granted an aggregate of 2,460,000 share options to certain employees of the Group to subscribe for a total of 2,460,000 shares of the Company at a price of HK\$2.184 per share on 6 October 2020 under the Share Option Incentive Scheme. Subject to the fulfillment of the relevant conditions, these share options granted are exercisable from 6 October 2022 to 5 October 2026 in batches.

The Company granted an aggregate of 1,370,000 share options to certain employees of the Group to subscribe for a total of 1,370,000 shares of the Company at a price of HK\$2.72 per share on 7 April 2021 under the Share Option Incentive Scheme. Subject to the fulfillment of the relevant conditions, these share options granted are exercisable from 7 April 2023 to 6 April 2027 in batches.

Each batch of the above share options is exercisable within the periods stated as follows: (a) 33.3% of the share options will be exercisable commencing on the first trading day after the expiration of the 24-month period (the second anniversary) from the respective dates of grant and ending on the last trading day of the 36-month period from the respective dates of grant; (b) 33.3% of the share options will be exercisable commencing on the first trading day after the expiration of the 36-month period (the third anniversary) from the respective dates of grant and ending on the last trading day of the 48-month period from the respective dates of grant; and (c) 33.4% of the share options will be exercisable commencing on the first trading day after the expiration of the 48-month period (the fourth anniversary) from the respective dates of grant and ending on the last trading day of the 72-month period from the respective dates of grant.

中期股息

本公司董事會（「董事會」或「董事」）宣派截至2026年6月30日止六個月的中期股息每股33港仙（2025年：33港仙），將於2026年9月25日向於2026年9月17日名列本公司股東名冊（「股東名冊」）上的股東派付。

為確定股東獲派付中期股息的資格，將於2026年9月14日至2026年9月17日（包括首尾兩天）暫停股東名冊登記，在此期間將暫停辦理本公司的股份過戶登記手續。為符合資格獲派付截至2026年6月30日止六個月的中期股息，所有過戶文件連同有關股票必須於2026年9月11日下午4時30分前，送達本公司股份過戶登記香港分處卓佳證券登記有限公司登記，地址為香港夏慤道16號遠東金融中心17樓。

業務營運回顧

2026年上半年，美國關稅和貿易政策的不確定性持續發酵，中東地緣衝突（尤其霍爾木茲海峽通航受阻）顯著加劇，全球金融市場經歷劇烈震盪，環球經濟下行風險未見消退。

全球造船業自2021年起進入的新一輪景氣週期仍在延續，2026年上半年市場較去年同期出現顯著反彈。據克拉克森資料，全球新船訂單共1,644艘，合137,505,226載重噸，按載重噸計同比大增125%，創歷史同期最高水準。替代燃料船舶方面，據挪威船級社(DNV)替代燃料洞察平台資料，2026年上半年全球共成交137艘替代燃料船舶訂單，較2025年同期的155艘有所下降，其中液化天然氣雙燃料船仍為主流（73艘），液化石油氣／乙烷動力船訂單顯著增長至55艘，而甲醇、氨等新興替代燃料訂單則近乎枯竭。

INTERIM DIVIDEND

The board of directors of the Company (the “Board” or the “Director(s)”) has declared an interim dividend of 33 HK cents (2025: 33 HK cents) per share for the six months ended 30 June 2026 which will be payable on 25 September 2026 to the Shareholders whose names appear on the register of members of the Company (the “Register of Members”) on 17 September 2026.

For the purpose of ascertaining the Shareholders’ entitlement to the interim dividend, the Register of Members will be closed from 14 September 2026 to 17 September 2026, both days inclusive, during which no transfer of shares of the Company will be registered. In order to qualify for the interim dividend for the six months ended 30 June 2026, all transfer documents accompanied by the relevant share certificate(s) must be lodged with the Company’s branch share registrar and transfer office in Hong Kong, Tricor Investor Services Limited at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong for registration not later than 4:30 p.m. on 11 September 2026.

REVIEW OF BUSINESS OPERATIONS

In the first half of 2026, lingering uncertainties surrounding U.S. tariff and trade policies continued to weigh on markets, while geopolitical tensions in the Middle East — particularly disruptions to shipping through the Strait of Hormuz — intensified significantly. Global financial markets experienced sharp volatility, and downside risks to the global economy showed no signs of abating.

The global shipbuilding industry has been in an upward cycle since 2021 and saw a notable rebound in the first half of 2026 compared with the same period last year. According to Clarksons data, global new ship orders totaled 1,644 vessels, equivalent to 137,505,226 deadweight tonnages (“DWT”), representing a year-on-year surge of 125% in DWT terms — the highest level for any first-half period on record. In terms of alternative-fuel vessels, data from Det Norske Veritas (DNV)’s Alternative Fuel Insights platform show that a total of 137 alternative-fuel ship orders were placed globally in the first half of 2026, down from 155 in the same period of 2025. Liquefied Natural Gas (LNG) dual-fuel vessels remained the dominant choice (73 vessels), while orders for Liquefied Petroleum Gas (LPG)/ethane-powered vessels rose significantly to 55. In contrast, orders for emerging alternative fuels such as methanol and ammonia were nearly nonexistent.

儘管新造船訂單結構有所變化，但在新造船交付仍處於景氣週期的背景下，本集團核心業務航運服務業仍保持穩健運營。本公司已積極推進船舶設備及備件供應業務與航運服務科技業務的深度融合，通過數位技術賦能拓展低碳服務場景，以應對行業綠色轉型帶來的結構性機遇。

1. 核心業務 — 航運服務業

本集團核心業務航運服務業主要包括船舶貿易代理服務、保險顧問服務、船舶設備及備件供應、塗料生產和銷售及航運服務科技等。

期內，來自本集團航運服務業的收入為2,092,431,000港元（2025年：1,928,259,000港元），同比上升9%。航運服務業的所得稅前溢利為440,812,000港元（2025年：410,991,000港元），同比上升7%。主要是由塗料、保險顧問及船舶設備及備件等分部的強勁表現所帶動。

1.1 船舶貿易代理服務

本集團的船舶貿易代理服務業務主要從事為航運企業提供船舶建造、買賣和租賃的代理服務。

期內，本集團來自船舶貿易代理的分部收入為97,747,000港元（2025年：97,791,000港元），基本持平。分部所得稅前溢利為70,067,000港元（2025年：81,809,000港元），同比下跌14%。主要是新造船交付的船型結構有所改變，佣金率有所下降。

Despite shifts in the composition of newbuilding orders, and against the backdrop of a still-strong delivery cycle for new ships, the Group's core shipping services business maintained stable operations. The Company has proactively advanced the deep integration of its marine equipment and spare parts supply business with its shipping services technology operations, leveraging digital technologies to expand low-carbon service scenarios and capitalise on the structural opportunities arising from the industry's green transition.

1. Core Business — Shipping Services

The Group's core shipping services business mainly include ship trading agency services, insurance brokerage services, supply of marine equipment and spare parts, production and sale of coatings and intelligent shipping services, etc..

During the period, revenue from the Group's shipping services amounted to HK\$2,092,431,000 (2025: HK\$1,928,259,000), representing a year-on-year increase of 9%. Profit before income tax from shipping services reached HK\$440,812,000 (2025: HK\$410,991,000), up 7% year-on-year, which was mainly due to strong performance in the segments of coatings, insurance brokerage and marine equipment and spare parts.

1.1 Ship Trading Agency Services

The Group's ship trading agency services business is principally engaged in the provision of agency services relating to shipbuilding, ship trading and chartering for shipping enterprises.

During the period, revenue from the ship trading agency segment of the Group was HK\$97,747,000 (2025: HK\$97,791,000), remaining flat. Segment profit before income tax was HK\$70,067,000 (2025: HK\$81,809,000), down 14% year-on-year. This was mainly due to the change of vessel type and structure of newbuild vessel resulting in a decrease in commission rates.

期內，本集團的新造船交付量共29艘（2025年：22艘），累計1,282,166載重噸（2025年：1,192,700載重噸）。代理新造船訂單共71艘（2025年：58艘），累計6,143,700載重噸（2025年：4,102,000載重噸）。另外，代理二手船買賣共11艘（2025年：10艘），累計540,400載重噸（2025年：483,185載重噸）。

1.2 保險顧問服務

本集團的保險顧問服務業務主要經營水險及非水險的保險及再保險仲介業務，包括為國內外客戶提供風險評估與分析、擬定保險及再保險計劃、商討承保、審核保單、案件理算、理賠等專業保險顧問服務，並收取服務佣金。

期內，本集團來自保險顧問的分部收入為149,924,000港元（2025年：119,639,000港元），同比上升25%。分部所得稅前溢利為111,676,000港元（2025年：83,841,000港元），同比上升33%，主要受惠於大型船舶交付量顯著增長帶動船殼險、保賠險佣金收入上升，以及成功拓展新的非水險業務。

1.3 船舶設備及備件供應

本集團的船舶設備及備件供應業務主要是從事現有船舶及新造船的設備、備件和可供海上、離岸、岸站及陸地使用的無線通訊系統、衛星通訊及導航系統設備的銷售和安裝，船舶物料供應以及船舶航修業務。業務網絡覆蓋香港、上海和北京等城市，以及日本、新加坡、德國和美國等國家。

During the period, the Group's total number of newbuild vessels deliveries was 29 (2025: 22), aggregating 1,282,166 DWT (2025: 1,192,700 DWT). A total number of 71 (2025: 58) newbuild vessels have been ordered, aggregating 6,143,700 DWT (2025: 4,102,000 DWT). In addition, the sale and purchase of a total of 11 (2025: 10) second-hand vessels were recorded, aggregating 540,400 DWT (2025: 483,185 DWT).

1.2 Insurance Brokerage Services

The Group's insurance brokerage services business is primarily engaged in the insurance and reinsurance intermediary services of marine and non-marine insurance, including the provision of professional insurance brokerage services such as risk assessment and analysis, designing insurance and reinsurance programmes, discussing insurance coverage, reviewing insurance policies, claims adjustment and claims handling for domestic and international customers, and receive service commissions.

During the period, revenue from the insurance brokerage segment of the Group was HK\$149,924,000 (2025: HK\$119,639,000), up 25% year on-year. Segment profit before income tax was HK\$111,676,000 (2025: HK\$83,841,000), up 33% year-on-year. This was mainly due to the increase in commission income from hull and protection & indemnity (P&I) insurance, driven by the notable growth in deliveries of mega vessels, as well as successful expansion of new non-marine insurance businesses.

1.3 Supply of Marine Equipment and Spare Parts

The Group's supply of marine equipment and spare parts business is principally engaged in the sale and installation of equipment and spare parts for existing and newbuild vessels, as well as equipment of radio communications systems, satellite communications and navigation systems for ships, offshore facilities, coastal stations and land users; marine materials supply and voyage repair. Its business network covers cities such as Hong Kong, Shanghai and Beijing and countries such as Japan, Singapore, Germany and the United States, etc..

期內，本集團來自船舶設備及備件的分部收入為909,221,000港元（2025年：886,183,000港元），同比上升3%。分部所得稅前溢利同比上升4%至56,003,000港元（2025年：54,103,000港元）。該板塊的表現在關稅相關貿易爭端緩和後趨於穩定。

1.4 塗料生產和銷售

本集團的塗料業務主要包括集裝箱塗料、工業用重防腐塗料和船舶塗料的生產和銷售。中遠關西塗料化工(珠海)有限公司(「中遠關西(珠海)」)、中遠關西塗料(上海)有限公司(「中遠關西塗料(上海)」)及中遠關西塗料化工(上海)有限公司(「中遠關西(上海)」)(統稱「中遠關西公司」)均為本公司的非全資附屬公司。持有工廠的中遠關西(珠海)及中遠關西塗料(上海)主要從事塗料的生產和銷售，而中遠關西(上海)主要從事塗料銷售。本公司與跨國塗料供應商挪威佐敦集團各持有50%股權的合營企業中遠佐敦，主要從事船舶塗料的生產和銷售。本公司持有33%股權的常熟耐素主要從事研發、生產及銷售生物材料應用產品，包括表面活性劑、塗料原材料及添加劑，以及樹脂改性劑等。

期內，本集團來自塗料的分部收入為933,460,000港元（2025年：822,892,000港元），同比上升13%。分部所得稅前溢利為217,924,000港元（2025年：204,138,000港元），同比上升7%。

During the period, revenue from the supply of marine equipment and spare parts segment of the Group was HK\$909,221,000 (2025: HK\$886,183,000), up 3% year-on-year. Segment profit before income tax was HK\$56,003,000 (2025: HK\$54,103,000), up 4% year-on-year. The segment's performance stabilised following the easing of tariff-related trade disputes.

1.4 Production and Sale of Coatings

The coating business of the Group primarily includes the production and sale of container coatings, industrial heavy-duty anti-corrosion coatings and marine coatings. COSCO Kansai Paint & Chemicals (Zhuhai) Co., Ltd. ("COSCO Kansai (Zhuhai)"), 中遠關西塗料(上海)有限公司 (COSCO Kansai Paint (Shanghai) Co., Ltd.*) ("COSCO Kansai Paint (Shanghai)") and 中遠關西塗料化工(上海)有限公司 (COSCO Kansai Paint & Chemicals (Shanghai) Co., Ltd.*) ("COSCO Kansai (Shanghai)") (collectively "COSCO Kansai Companies") are non-wholly owned subsidiaries of the Company. COSCO Kansai (Zhuhai) and COSCO Kansai Paint (Shanghai), which have their own plants, are principally engaged in the production and sale of coatings, while COSCO Kansai (Shanghai) is primarily engaged in the sale of coatings. Jotun COSCO, a 50/50 joint venture formed by the Company and Jotun A/S, Norway, an international coatings supplier, is principally engaged in the production and sale of marine coatings. Nasurfar Changshu, in which the Company held 33% equity interest, is principally engaged in the research and development, production and sales of biomaterial application products, including surfactants, coating raw materials and additives, as well as resin modifiers, etc..

During the period, revenue from the coatings segment of the Group was HK\$933,460,000 (2025: HK\$822,892,000), up 13% year-on-year. Segment profit before income tax was HK\$217,924,000 (2025: HK\$204,138,000), up 7% year-on-year.

集裝箱塗料方面，銷量隨著市場份額提升。期內，集裝箱塗料銷售量同比大增29%至37,060噸（2025年：28,723噸）。

工業用重防腐塗料（含車間底漆）銷售量為10,810噸（2025年：11,167噸），同比下跌3%。國內工業用重防腐塗料的市場格局正迎來從「量」到「質」的關鍵轉型期，本集團將繼續力爭高端市場以維持競爭力。

船舶塗料方面，中遠佐敦的船舶塗料銷售量為78,615,000升（約相等於106,130噸）（2025年：69,186,000升（約相等於93,401噸）），同比上升14%。其中，新造船塗料銷售量為58,494,000升（2025年：48,719,000升），同比上升20%；維修保養塗料銷售量為20,121,000升（2025年：20,467,000升），同比下降約2%。期內，本集團應佔中遠佐敦溢利為163,675,000港元（2025年：171,319,000港元），同比下跌4%，主要由於大宗商品市場波動，生產成本大幅攀升，但通過謹慎的成本管理措施，相關影響已得到較大程度的緩解。

期內，本集團應佔常熟耐素溢利為9,348,000港元（2025年：5,612,000港元），同比上升67%，顯著增長主要受蓬勃發展的船舶塗料和集裝箱塗料板塊支持，環氧稀釋劑和樹脂改質劑的需求強勁；以及常熟耐素與中遠關西公司和中遠佐敦之間的協同效應有所增強。

For container coatings, sales volume has increased, accompanied by a growing market share. During the period, the sales volume of container coatings surged by 29% year-on-year to 37,060 tonnes (2025: 28,723 tonnes).

The sales volume of industrial heavy-duty anti-corrosion coatings (including workshop primer) down 3% year-on-year to 10,810 tonnes (2025: 11,167 tonnes). The domestic industrial heavy-duty anti-corrosion coatings market is currently undergoing a critical transition from “quantity” to “quality”. The Group will continue to strive for a foothold in the high-end market in order to maintain its competitiveness.

For marine coatings, the sales volume of Jotun COSCO's marine coatings amounted to 78,615,000 litres (equivalent to approximately 106,130 tonnes) (2025: 69,186,000 litres (equivalent to approximately 93,401 tonnes)), up 14% year-on-year. Among them, the sales volume of coatings for newbuild vessels reached 58,494,000 litres (2025: 48,719,000 litres), up 20% year-on-year. The sales volume of coatings for repair and maintenance was 20,121,000 litres (2025: 20,467,000 litres), down approximately 2% year-on-year. During the period, the Group's share of profit from Jotun COSCO was HK\$163,675,000 (2025: HK\$171,319,000), down 4% year-on-year. Production costs surged due to volatile commodity markets, but the impact was largely mitigated through prudent cost management measures.

During the period, the Group's share of profit from Nasurfar Changshu was HK\$9,348,000 (2025: HK\$5,612,000), up 67% year-on-year. The significant increase was mainly due to the strong demand for epoxy diluent and resin modifier, supported by the thriving marine coatings and container coatings sectors, and reinforced by enhanced synergies with COSCO Kansai Companies and Jotun COSCO.

1.5 航運服務科技

本集團的航運服務科技業務致力為航運產業的全生命週期中提供綠色低碳數智化解決方案。於2023年，本公司與中遠海運科技股份有限公司（「中遠海運科技」）合資成立中遠海運綠色數智船舶服務有限公司（「中遠海運船服」），其中本公司持有51%的股權。中遠海運船服主要從事船舶數智化解決方案的開發與應用。於2026年1月5日，本公司、中遠海運科技及中遠海運船服訂立增資協議（「增資協議」），據此本公司及中遠海運科技應按以下方式向中遠海運船服繳付新增出資：(a)本公司將其持有的遠通海運設備服務有限公司（「遠通公司」）（本公司全資附屬公司）全部100%股權轉讓予中遠海運船服；及(b)中遠海運科技向中遠海運船服轉讓SMART SAILING平台（中遠海運科技推出的SMART SAILING平台，為中遠海運科技設計開發的科技產品）並作出現金出資人民幣213,010,416元。中遠海運船服增資完成後，本公司於中遠海運船服的股權將由51%增加至80%，而中遠海運科技於中遠海運船服的股權將由49%減少至20%；有關詳情已於本公司日期為2026年1月5日的公告及日期為2026年2月13日的通函內披露。有關增資協議及其項下擬進行交易的決議已於2026年3月

1.5 Intelligent Shipping Services

The Group's intelligent shipping services business is committed to providing green, low-carbon, digital and intelligent solutions throughout the full life cycle of the shipping industry. In 2023, the Company and 中遠海運科技股份有限公司 (COSCO SHIPPING Technology Co., Ltd.*) ("COSCO SHIPPING Technology") jointly established 中遠海運綠色數智船舶服務有限公司 (COSCO SHIPPING Smart-Sailing Marine Solutions Co., Ltd.*) ("COSCO SHIPPING Smart-Sailing"), in which the Company held 51% equity interest. COSCO SHIPPING Smart-Sailing is principally engaged in the development and application of digital and intelligent solutions for vessels. On 5 January 2026, the Company, COSCO SHIPPING Technology and COSCO SHIPPING Smart-Sailing entered into the capital increase agreement ("Capital Increase Agreement"), pursuant to which the Company and COSCO SHIPPING Technology shall make additional capital contribution to COSCO SHIPPING Smart-Sailing in the following manner: (a) the Company shall transfer all its 100% equity interests in Yuantong Marine Service Co. Limited ("Yuantong") (a wholly-owned subsidiary of the Company) to COSCO SHIPPING Smart-Sailing; and (b) COSCO SHIPPING Technology shall transfer the SMART SAILING Platform (the SMART SAILING Platform launched by COSCO SHIPPING Technology, being technological products designed and developed by COSCO SHIPPING Technology) and make a cash contribution of RMB213,010,416 to COSCO SHIPPING Smart-Sailing. Upon completion of the capital increase of COSCO SHIPPING Smart-Sailing, the Company's equity interests in COSCO SHIPPING Smart-Sailing will increase from 51% to 80% whereas COSCO SHIPPING Technology's equity interests in COSCO SHIPPING Smart-Sailing will decrease from 49% to 20%, details of which were disclosed in the announcement of the Company dated 5 January 2026 and the circular of the Company dated 13 February 2026. The resolution of Capital Increase Agreement and the transactions contemplated thereunder was voted for by all the Shareholders presented at the special general

12日的本公司股東特別大會獲出席股東全數贊成通過。中遠海運船服目前正根據中國法律規定進行向中遠海運船服轉讓遠通公司股權的境外直接投資備案手續。

期內，本集團來自航運服務科技的分部收入為2,079,000港元（2025年：1,754,000港元）。分部所得稅前虧損為14,858,000港元（2025年：所得稅前虧損12,900,000港元）。該虧損主要由於中遠海運船服仍處於初創投入和產品研發階段。

meeting of the Company held on 12 March 2026. COSCO SHIPPING Smart-Sailing is now undergoing the process of overseas direct investment (ODI) filing in accordance with the PRC laws in respect of the transfer of the equity interests in Yuantong to the COSCO SHIPPING Smart-Sailing.

During the period, revenue from the segment of intelligent shipping services of the Group was HK\$2,079,000 (2025: HK\$1,754,000), and the segment loss before income tax amounted to HK\$14,858,000 (2025: loss before income tax of HK\$12,900,000). The loss was mainly resulted from the fact that COSCO SHIPPING Smart-Sailing was still at the stage of start-up investment and the research and development of products.

2. 一般貿易

本集團的一般貿易業務主要從事瀝青的貿易、倉儲、加工、供應及其他綜合性貿易。

期內，本集團來自一般貿易的分部收入為19,000港元（2025年：5,859,000港元），反映正逐步退出瀝青業務。分部所得稅前溢利為8,400,000港元（2025年：15,113,000港元）。

期內，本集團應佔浙江四兄繩業的溢利為2,335,000港元（2025年：6,144,000港元），同比下跌62%。主要由於化工原材料價格上漲所致。

2. General Trading

The Group's general trading business is principally engaged in the trading, storage, processing, and supply of asphalt and other comprehensive trading.

The Group's general trading segment generated revenue of HK\$19,000 during the period (2025: HK\$5,859,000), reflecting its gradual withdrawal from the asphalt business. Segment profit before income tax amounted to HK\$8,400,000 (2025: HK\$15,113,000).

During the period, the Group's share of profit from Zhejiang Four Brothers Rope amounted to HK\$2,335,000 (2025: HK\$6,144,000), down 62% year-on-year, largely as a result of the substantial escalation in chemical raw materials prices.

其他

茲提述本公司分別於2024年11月14日、2025年3月26日、2025年8月27日及2026年3月25日刊發的公告，本公司間接全資附屬公司Sinfeng Marine Services Pte. Ltd. (新峰航運服務有限公司*) (「新峰公司」) 於2024年11月7日收到第三方商業銀行在新加坡共和國高等法院普通庭 (「新加坡法院」) 提起的訴訟。該案於2026年3月3日至6日及3月9日至13日開庭審理，此後，雙方根據新加坡法院指示已提交結案陳詞，新加坡法院留待判決。截至本報告日期，新峰公司仍在等待判決。根據評估，該訴訟對本集團的整體業務或日常營運並無重大不利影響，且該訴訟對本集團並無重大財務影響。

展望

展望2026年下半年，全球宏觀經濟環境仍然複雜多變。國際貨幣基金組織 (「IMF」) 於2026年7月發佈的《世界經濟展望》將2026年全球經濟增長預測下修至3.0%，較其2026年4月預測值下調0.1個百分點。全球經濟正受到兩股相反力量的拉扯：中東衝突推高能源價格、擾亂供應鏈與全球貿易；AI浪潮則帶動科技投資與需求持續擴張，部分抵銷地緣衝突帶來的負面衝擊。通膨方面，IMF將2026年全球通膨預測由4.4%上修至4.7%，顯示通膨降溫進展已有停滯跡象。全球貿易量增長率預計將從2025年的4.1%降至2026年的2.6%。同時，美國關稅政策正從臨時性工具轉向更具法律穩定性的301條款和232條款框架，未來數月法定有效關稅稅率預計將穩定在9%至10%，惟政策不確定性仍在醞釀積累，對出口導向型國家的經濟活動構成壓力。

Others

Reference is made to the announcements of the Company dated 14 November 2024, 26 March 2025, 27 August 2025 and 25 March 2026 respectively, Sinfeng Marine Services Pte. Ltd. ("Sinfeng"), an indirect wholly-owned subsidiary of the Company was on 7 November 2024 served with a claim lodged by a third party commercial bank against Sinfeng at the General Division of the High Court of the Republic of Singapore ("Singapore Court"). The trial hearing took place from 3 to 6 March, and 9 to 13 March 2026. Thereafter, parties' closing submission were made in accordance with directions given by the Singapore Court. The Singapore Court has reserved its judgment. As at the date of this report, Sinfeng is awaiting the judgment. Based on the assessment, the litigation has no material adverse impact on the business or daily operations of the Group as a whole and has no significant financial impact on the Group.

PROSPECTS

Looking ahead to the second half of 2026, the global macroeconomic environment remains complex and volatile. In July 2026 "World Economic Outlook" update, the International Monetary Fund ("IMF") downgraded its global growth forecast for 2026 to 3.0%, a 0.1 percentage point reduction from its April 2026 projection. The global economy is being pulled in two opposing directions: escalating conflicts in the Middle East are driving up energy prices and disrupting supply chains and global trade, while the AI boom continues to fuel technology investment and demand expansion, partially offsetting the negative shocks from geopolitical tensions. On the inflation front, the IMF revised its 2026 global inflation forecast upward to 4.7% from 4.4%, indicating that disinflation progress has stalled. Global trade volume growth is projected to moderate from 4.1% in 2025 to 2.6% in 2026. Meanwhile, U.S. tariff policies are transitioning from temporary measures toward a more legally durable framework under Section 301 and Section 232 provisions. Statutory effective tariff rates are expected to stabilise in the 9% to 10% range in the coming months, though policy uncertainty continues to build, exerting pressure on economic activity in export-oriented countries.

造船市場方面，2026年上半年中國船廠承接1,183艘、約3,150萬修正總噸(CGT)，佔全球市場約72%，接單量較去年同期翻倍成長，穩居全球造船龍頭地位。當前全球船廠產能利用率已處於高位，主流船廠訂單已接到2029年，克拉克森新船造價指數收報185.44點，接近歷史峰值（97%分位）。在船塢資源緊張、交付週期延長和新船價格高企的背景下，船東觀望情緒逐步顯現。

從產業發展邏輯看，全球造船業景氣週期的核心驅動因素未發生根本性轉變。地緣衝突與貿易摩擦正加速重塑全球貿易格局，碳中和目標推動能源結構轉型，海運貿易結構及航線佈局將隨之調整。本集團預期，隨著國際海事組織(IMO)監管框架於2026年10月逐步明朗、環保技術路徑日益清晰，船東推遲的船隊更新計劃有望逐步釋放，為行業創造新的需求空間。

在此背景下，中遠海運國際將緊扣航運綠色低碳數字智能轉型主線，聚焦「數智船舶服務平台」和「船用新能源平台」兩大發展賽道，全力打造科技型航運服務公司。本集團正進行船舶設備及備件供應業務和航運服務科技業務的深度融合，促進數字技術賦能和創新集成式數位解決方案落地，全面推動綠色低碳理念融入現有業務全流程當中。同時，推進上海吉遠綠色能源有限公司項目的建設，目前該項目預計將於2027年投產。

On the shipbuilding front, Chinese shipyards secured 1,183 vessels in the first half of 2026, approximately 31.5 million Compensated Gross Tonnage (CGT), accounting for roughly 72% of the global market — more than double the volume from the same period last year — cementing China's dominant position as the world's leading shipbuilding nation. Current global shipyard capacity utilization remains at elevated levels, with major yards' order books already filled through 2029. The Clarksons Newbuilding Price Index closed at 185.44 points, approaching historical peak levels (97th percentile). Against a backdrop of tight dock space, extended delivery schedules, and high newbuild prices, a wait-and-see attitude is gradually emerging among shipowners.

From an industry development perspective, the fundamental drivers of the global shipbuilding upcycle have not undergone any fundamental shift. Geopolitical conflicts and trade frictions are accelerating the reshaping of global trade patterns, while carbon neutrality goals are driving the energy transition, which will in turn reshape maritime trade structures and shipping route configurations. The Group anticipates that as the International Maritime Organisation (IMO) regulatory framework gradually clarifies toward October 2026 while environmental technology pathways become increasingly well-defined, shipowners are likely to progressively unlock their deferred fleet renewal plans which creates new demand headroom.

Against this backdrop, COSCO SHIPPING International will closely align with the core theme of the shipping industry's green, low-carbon, digital, and intelligent transformation, focusing on two major development trajectories — the “Digital Intelligent Ship Service Platform” and the “Marine New Energy Platform” — as it strives to build a technology-driven shipping services enterprise. The Group is advancing the deep integration of its marine equipment and spare parts supply business with its shipping services technology operations through implementation of digital technology enablement and innovative intelligent shipping services business and push forward the green and low carbon concept integration across the entire processes of the existing businesses. Meanwhile, the construction of the project of 上海吉遠綠色能源有限公司 (Shanghai JOYFuel Green Energy Co., Ltd.*) is being advanced. Currently, the project is expected to be put into production in 2027.

受惠於造船業交付高峰期延續，預期本集團核心業務航運服務業有望維持穩健增長。我們將密切關注宏觀經濟變化，持續推動降本增效，靈活調控營運策略。此外，本集團之多元業務佈局具備良好的跨週期互補效應，預期將有效平滑產業波動，促進核心航運服務業平穩且可持續地發展。

2026年是「十五五」規劃開局之年，隨著新造船訂單集中交付，運力大規模釋放將為本集團航運服務業業務量帶來可觀增長機會，存量船隊的數智化及綠色改裝需求亦將創造全新增量市場。中遠海運國際將積極對接國家戰略與行業趨勢，加速推進科技創新體系建設，致力於在「十五五」期間實現跨越式發展，努力為股東持續創造價值。

Riding on the sustained peak delivery cycle in the shipbuilding sector, the Group anticipates steady growth in its core shipping services business. We will remain vigilant to changes in the macroeconomic environment, persist in our cost-reduction and efficiency-improvement efforts, and stay flexible in fine-tuning our operations. Furthermore, the Group's diversified business mix offers robust cross-cycle complementarity, which is expected to effectively mitigate sector fluctuations and underpin the stable and sustainable development of our core shipping services.

The year 2026 marks the inaugural year of the "15th Five-Year Plan" period. As newbuilding orders enter a concentrated delivery phase, the large-scale release of tonnage will bring substantial growth opportunities for the Group's shipping services business volume. At the same time, demand for digital intelligence upgrades and green retrofits of the existing fleet will create entirely new incremental markets. COSCO SHIPPING International will proactively align with national strategies and industry trends, accelerate the development of its technological innovation system, and strive to achieve leapfrog growth during the "15th Five-Year Plan" period, remaining committed to delivering sustained value creation for its shareholders.

1 一般資料

中遠海運國際(香港)有限公司(「本公司」)及其附屬公司(統稱「本集團」)主要從事提供航運服務及一般貿易。

COSCO SHIPPING itself is a state-owned enterprise established and controlled by the PRC government, which also owns a significant portion of the productive assets in the PRC. In accordance with HKAS 24 (Revised), government-related entities and their subsidiaries, directly or indirectly controlled, jointly controlled or significantly influenced by the PRC government are defined as related parties of the Group. On that basis, related parties include COSCO SHIPPING, its subsidiaries (other than the Group) and associates, other state-owned enterprises and their subsidiaries directly or indirectly controlled by the PRC government, and other entities and corporations in which the Company is able to control or exercise significant influence and key management personnel of the Company and COSCO SHIPPING as well as their close family members.

For the purpose of the related party transaction disclosures, the directors believe that it is meaningful to disclose the related party transactions with group companies of the ultimate holding company for the interests of financial statements’ users, although certain of those transactions which are individually or collectively not significant, and are exempted from disclosure upon adoption of HKAS 24 (Revised). Mr. Kwong Che Keung, Gordon ("Mr. Kwong"), the late Independent Non-executive Director, has entered into a letter of appointment with the Company on 29 May 2026 for a term commencing from 29 May 2026 to the conclusion of the 2028 annual general meeting of the Company.

Mr. Jiang, Simon X., the Independent Non-executive Director, retired as the independent non-executive director of PetroChina Company Limited (listed in Hong Kong, Shanghai and New York) in June 2026.

Mr. Ma Xianghui, the ex-Non-executive Director, has entered into a letter of appointment with the Company on 29 May 2026 for a term commencing from 29 May 2026 to the conclusion of the 2028 annual general meeting of the Company. The above-mentioned letter of appointment is subject to termination by either party giving one month's prior notice in writing or such other shorter notice period as may be agreed by both parties.

企業管治

維持高水平企業管治一直為本公司的首要任務之一。透過董事會有效適時披露資料，及積極推行投資者關係計劃，將有助達致此目標。本公司將繼續實行多項措施，進一步加強企業管治及整體風險管理。

董事會相信，本公司於截至2026年6月30日止六個月內一直遵守上市規則附錄C1所載企業管治守則（「企業管治守則」）內的所有守則條文，惟(A)前任非執行董事馬向輝先生因其他公務安排而未能出席於2026年3月12日舉行之本公司股東特別大會（「股東特別大會」）及前任非執行董事馬向輝先生及獨立非執行董事蔣小明先生因其他公務安排而未能出席於2026年5月29日舉行之本公司股東週年大會（「股東週年大會」），與企業管治守則C.1.5的守則條文有所偏離；(B)董事會主席與董事總經理的角色現由朱昌宇先生同一人士擔任，與企業管治守則C.2.1的守則條文有所偏離。儘管馬向輝先生未能出席股東特別大會，及馬向輝先生及蔣小明先生未能出席股東週年大會，然而，參與股東大會的董事會成員能夠回答股東提問，以確保與股東有效溝通。彼等在股東大會後與主席及／或高級管理層進行了溝通，以討論股東之反饋，旨在更全面及平衡地理解股東觀點。儘管董事會主席與董事總理由同一人士擔任，但董事會認為：(i)所有董事均意識到並承諾履行其作為董事的受信責任，其中包括，以本公司的裨益和最佳利益行事；(ii)權力權限的平衡是由董事會的運作來確保；及(iii)本公司的整體戰略及其他主要業務，財務和運營政策乃透過於董事會和本公司高級管理層層面進行詳細討論後共同制定，故董事會主席與董事總經理的角色由同一人士擔任並不會損害董事會與本公司管理層之間的權力權限平衡。截至2026年6月30日止六個月，除以上所述者外，並無其他事項與企業管治守則有所偏離。本公司致力持續按最佳應用標準檢視及提高本公司的企業管治水平。

CORPORATE GOVERNANCE

Maintaining high standards of corporate governance has always been one of the Company's priorities. This is achieved through an effective, timely disclosure of information by the Board and a proactive investor relations programme. The Company will continue to implement measures in order to further strengthen its corporate governance and overall risk management.

The Board believed that the Company has complied with all the code provisions of the Corporate Governance Code (the "CG Code") set out in Appendix C1 to the Listing Rules during the six months ended 30 June 2026, except that (A) Mr. Ma Xianghui, the ex-Non-executive Director, was unable to attend the special general meeting of the Company held on 12 March 2026 (the "SGM") due to other business commitment and Mr. Ma Xianghui, the ex-Non-executive Director and Mr. Jiang, Simon X., the Independent Non-executive Director were unable to attend the annual general meeting of the Company held on 29 May 2026 (the "AGM") due to other business commitment, which deviated from the code provision C.1.5 of the CG Code; (B) the roles of the Chairman of the Board and the Managing Director are currently performed by the same individual, Mr. Zhu Changyu, which deviated from the code provision C.2.1 of the CG Code. Despite the absence of Mr. Ma Xianghui at the SGM and Mr. Ma Xianghui and Mr. Jiang, Simon X. at the AGM, those Board members who participated at the general meetings were available to answer questions from the Shareholders to ensure an effective communication with the Shareholders and they communicated with the Chairman and/or the senior management of the Company to discuss feedback received from the Shareholders after the general meetings in a bid to develop better and balanced understanding of the views of the Shareholders. Although the roles of the Chairman of the Board and the Managing Director are performed by the same individual, the Board believes that the roles of the Chairman of the Board and the Managing Director of the Company being performed by the same individual will not impair the balance of power and authority between the Board and the management of the Company, given that: (i) all the Directors are aware of and undertake to fulfil their fiduciary duties as Directors, which require, among others, that he/she acts for the benefit and in the best interests of the Company; (ii) the balance of power and authority is ensured by the operations of the Board; and (iii) the overall strategy and other key business, financial and operational policies of the Company are made collectively after thorough discussion at both the Board and senior management of the Company. Save as mentioned above, there is no other matter deviated from the CG Code during the six months ended 30 June 2026. The Company aims to continually review and enhance its corporate governance practices in light of best practices.

獨立非執行董事、本公司審核委員會（「審核委員會」）主席、薪酬委員會、提名委員會及企業管治委員會成員鄭先生於2026年7月6日離世。鄭先生身故後，本公司獨立非執行董事人數、審核委員會成員人數及其資格組成均未符合上市規則第3.10及3.21條的規定，且本公司提名委員會的組成也未符合上市規則第3.27A條的規定。為遵守上市規則第3.10、3.21及3.27A條之規定，本公司致力在實際可行之情況下，盡快物色合適人選以委任為獨立非執行董事、審核委員會成員及本公司提名委員會成員，以符合上市規則第3.11、3.23及3.27C條的規定，並將於適當時候進一步公佈。

鄭先生身故後，審核委員會由兩名獨立非執行董事組成。審核委員會的主要職責包括審閱會計政策及監督本公司的財務申報；監察內部及外聘核數師的工作表現；檢討及評核財務申報、風險管理及內部監控系統的成效；確保遵守適用法定會計及申報規定。審核委員會已與本公司管理層討論內部監控及財務申報事宜。獨立外聘核數師已根據香港會計師公會頒佈的香港審閱準則第2410號「由實體的獨立核數師執行中期財務資料審閱」審閱未經審計簡明綜合中期財務資料。審核委員會已審閱未經審計簡明綜合中期財務資料及本公司2026年中期報告。

Mr. Kwong, the Independent Non-executive Director, chairman of audit committee ("Audit Committee"), member of remuneration committee, nomination committee and corporate governance committee of the Company, passed away on 6 July 2026. Following the passing away of Mr. Kwong, the number of independent non-executive directors of the Company, the number of members of Audit Committee and the qualification composition of the aforesaid do not meet the requirement under Rules 3.10 and 3.21 of the Listing Rules, and the composition of nomination committee of the Company does not meet the requirements under Rule 3.27A of the Listing Rules. In order to comply with Rules 3.10, 3.21 and 3.27A of the Listing Rules, the Company is endeavoring to identify suitable candidate(s) to be appointed as an independent non-executive director, a member of Audit committee and a member of nomination committee of the Company as soon as practicable in order to comply with the requirements of Rules 3.11, 3.23 and 3.27C of the Listing Rules and will make further announcement as and when appropriate.

After the passing away of Mr. Kwong, the Audit Committee is comprised of two Independent Non-executive Directors. The main duties of the Audit Committee include reviewing the accounting policies and overseeing the Company's financial reporting; monitoring the performance of both the internal and external auditors; reviewing and examining the effectiveness of the financial reporting, the risk management and internal control systems; ensuring compliance with applicable statutory accounting and reporting requirements. The Audit Committee has discussed the internal controls and financial reporting matters with management of the Company. The independent external auditor has reviewed the Unaudited Condensed Consolidated Interim Financial Information in accordance with Hong Kong Standard on Review Engagements 2410, "Review of Interim Financial Information Performed by the Independent Auditor of the Entity" issued by the Hong Kong Institute of Certified Public Accountants. The Audit Committee has reviewed the Unaudited Condensed Consolidated Interim Financial Information and the 2026 interim report of the Company.
