BUSINESS REVIEW

The Group has been actively advancing its business strategic transformation, focusing on three core business areas, namely credit guarantee, financial asset management and commercial banking, with the aim of forging a differentiated competitive advantage and achieving high-quality development. In line with this business strategic transformation, the Group's operations are divided into four business segments, namely the credit guarantee segment, the financial asset management segment, the commercial banking segment and the others.

CREDIT GUARANTEE SEGMENT

The credit guarantee business comprises two main categories, namely financing guarantee and non-financing guarantee. Leveraging the Group's professional risk assessment framework and nationwide regional service network, the segment provides credit enhancement services to micro, small and medium-sized enterprises ("**MSMEs**") to reduce their capital tie-up, thereby effectively supporting the development of the real economy. In respect of financing guarantee business, the Group primarily provides loan guarantees for MSMEs and individually-owned businesses to banks and other financial institutions, assisting them in securing necessary credit support. In respect of non-financing guarantee business, the Group has actively expanded its business in performance guarantee, bid guarantee and other related services, providing comprehensive support across sectors such as construction, tendering and procurement. These services help clients enhance their commercial creditworthiness, meet contractual performance obligations and reduce actual capital occupation, thereby lowering financing costs. For the six months ended 30 June 2026 (the "**first half of 2026**"), the credit guarantee segment recorded a profit before taxes of RMB71.4 million, representing an increase of RMB9.8 million as compared with RMB61.6 million for the six months ended 30 June 2025 (the "**corresponding period of 2025**"). This increase was primarily attributable to the decrease in operating expenses. In the first half of 2026, the credit guarantee segment recorded operating expenses of RMB39.9 million, representing a decrease of RMB17.0 million, or 29.9% as compared with RMB56.9 million in the corresponding period of 2025. The Group strictly implemented its budget management system in respect of expense management and strengthened the approval procedures for various administrative and general expenses. Particular emphasis has been placed on reducing travel, hospitality and marketing expenses related to non-core businesses, whilst idle assets and inefficient lease contracts have been streamlined and restructured. Furthermore, following the flattening of the organisational structure, the relevant labour costs have been optimised appropriately.

業務回顧

本集團積極推進業務戰略轉型，聚焦於信用擔保、金融資產管理、民營銀行三大核心業務領域，力爭塑造差異化競爭優勢、實現高質量發展。圍繞業務戰略轉型，本集團包括四大業務分部，分別是信用擔保分部、金融資產管理分部、民營銀行分部以及其他分部。

信用擔保分部

信用擔保業務，涵蓋融資擔保與非融資擔保兩大類別，依托本集團專業的風險評估體系和遍佈全國的區域化服務網絡，為廣大中小微企業客戶提供增信服務，降低對資金的耗用，以切實支持實體經濟發展。融資擔保業務方面，本集團主要為中小微企業、個體工商戶等向銀行等金融機構提供貸款擔保，協助其獲得必要的信貸支持；在非融資擔保方面，本集團積極拓展履約保函、投標保函等業務，廣泛服務於工程建設、交易投標及採購等場景，助力客戶提升商業信用、滿足合同履約要求，減少實際資金佔用以節約融資成本。截至2026年6月30日止六個月期間（「**2026年上半年**」），信用擔保分部稅前利潤為人民幣71.4百萬元，較截至2025年6月30日止六個月期間（「**2025年同期**」）稅前利潤人民幣61.6百萬元，增加人民幣9.8百萬元。主要是源於營運支出的減少，2026年上半年，信用擔保分部營運支出為人民幣39.9百萬元，較2025年同期人民幣56.9百萬元，減少人民幣17.0百萬元，降幅29.9%。本集團在費用管理方面嚴格執行預算管理制度，強化了各項行政及一般開支的審批流程。重點縮減了非核心業務相關的差旅、招待及市場推廣費用，並對閒置資產及低效租賃合約進行了清理與重組。此外，隨著組織架構的扁平化調整，相關人力成本亦得到合理優化。

Credit guarantee segment – Financing guarantee – Business expansion and products

The Group's financing guarantee business comprises traditional financing guarantee and bond guarantee. Traditional financing guarantee services primarily provide third-party joint and several liability guarantees to facilitate financing from banks and other nonbank financial institutions for key target groups of inclusive finance, such as small and medium-sized enterprises ("SMEs"), individually-owned businesses and the "agriculture, rural areas and farmers" sector. Bond guarantee services primarily involve the issuance of irrevocable letters of guarantee with joint and several liability for issuers of bonds in the public market, which effectively enhance the issuers' credit ratings, lower their financing costs and bolster investor confidence in the capital markets.

In the first half of 2026, the total default payments made by the Group on behalf of defaulting clients in relation to its financing guarantee business was RMB13.7 million, representing a decrease of RMB10.8 million or 44.1% as compared with RMB24.5 million made in the corresponding period of 2025. In the first half of 2026, the default rate of the financing guarantee business was 0.3% (corresponding period of 2025: 0.7%), remaining relatively stable.

2026年上半年，本集團融資擔保業務為違約客戶支付的代償款項總額為人民幣13.7百萬元，與2025年同期代償款項人民幣24.5百萬元相比，減少人民幣10.8百萬元，降幅44.1%。2026年上半年，融資擔保業務代償率為0.3%（2025年同期：0.7%）。融資擔保業務代償率水平保持穩定。

In line with our prudent valuation framework, we consistently maintain adequate provisions for outstanding financing guarantees based on historical default data and the characteristics of the existing portfolio. As at 30 June 2026, the provision rate for the Group's financing guarantee business was 1.2% (31 December 2025: 1.4%).

Credit guarantee segment – Non-financing guarantee – Business expansion and products

The Group's non-financing guarantee business comprises electronic guarantee and offline guarantee services. The electronic guarantee business represents an innovative guarantee service model introduced by the Group in response to the trend towards digital transformation, designed to support the efficient development of the real economy. Leveraging its online and intelligent electronic guarantee platform, this business provides end-to-end online processing services for a wide range of non-financing guarantee needs, including bid guarantees and performance guarantees. Clients can submit applications online, receive real-time approvals, apply electronic signatures and obtain legally binding guarantee instruments instantly through the system, significantly shortening processing time, reducing transaction costs and enhancing the efficiency of fund utilization. Electronic guarantees are widely used in areas such as construction projects, procurement activities and public resource trading. They serve as an effective alternative to traditional paper-based guarantee instruments and security deposits, helping to improve the business environment and lower clients' financing costs by replacing "cash deposits" with "guarantee instruments". The Group has established systematic connectivity with public resource trading platforms, financial institutions and key enterprises, and continuously refines its risk control models and data verification mechanisms. This ensures transaction security while driving the upgrading of the Group's guarantee services towards greater convenience, standardization and environmental sustainability.

信用擔保分部－非融資擔保－業務拓展及產品

本集團非融資擔保業務包括電子保函和線下保函。電子保函業務是本集團順應數字化轉型趨勢、服務實體經濟高效發展的創新擔保服務模式。該業務依托線上化、智能化的電子保函平台，為投標保函、履約保函等各類非融資性擔保需求提供全流程在線辦理服務。客戶可通過系統快速申請、實時審批、電子簽章並即時出具具有法律效力的保函，大幅縮短辦理週期、降低交易成本、提升資金使用效率。電子保函廣泛應用於工程建設、物資採購、公共資源交易等領域，有效替代傳統紙質保函和保證金，助力優化營商環境，以「保函」替代「資金」，降低客戶融資成本。本集團通過與公共資源交易平台、金融機構及核心企業進行系統對接，持續完善風控模型與數據驗證機制，在保障交易安全的同時，推動擔保服務向便捷化、標準化、綠色化方向升級。

In the first half of 2026, the total default payments made by the Group on behalf of defaulting clients in relation to its non-financing guarantee business was RMB4.4 million (corresponding period of 2025: RMB0.6 million), with the default rate of the non-financing guarantee business remaining at a relatively low level.

In line with our prudent valuation framework, we consistently maintain adequate provisions for outstanding non-financing guarantees based on historical default data and the characteristics of the existing portfolio. As at 30 June 2026, the provision rate for the Group's non-financing guarantee business was 0.2% (31 December 2025: 0.2%).

FINANCIAL ASSET MANAGEMENT SEGMENT

The Group's financial asset management business is primarily conducted through Liaoning Fu'an Financial Asset Management Co., Ltd. ("Fu'an Asset"). As a licensed local asset management company, Fu'an Asset remains committed to its core mission of mitigating regional financial risks. It adopts a non-performing asset management business model centered on asset acquisition and disposal, whereby it acquires non-performing assets in bulk from financial institutions (including banks and consumer finance companies) and realizes returns through specialized collection, litigation for recovery, debt negotiation and restructuring. Fu'an Asset's operations are divided into two business lines based on client categories: (i) the retail loan business, which primarily involves the acquisition and disposal of non-performing personal loan portfolios; and (ii) the corporate business, which primarily involves the acquisition and disposal of non-performing assets originated from financial institutions.

2026年上半年，本集團非融資擔保業務為違約客戶支付的代償款項總額為人民幣4.4百萬元（2025年同期：人民幣0.6百萬元），非融資擔保業務代償率保持在較低水平。

我們始終堅持審慎的估值體系，結合歷史代償信息、以及存量業務特徵，針對尚未到期的非融資擔保業務計提充足的準備金。截至2026年6月30日，本集團非融資擔保業務撥備率為0.2%（2025年12月31日：0.2%）。

金融資產管理分部

本集團金融資產管理業務主要由遼寧富安金融資產管理有限公司（「富安資管」）開展。富安資管作為持牌地方資產管理公司，堅守區域金融風險化解核心使命，採用資產收購處置為主的不良資產管理業務模式，通過批量收購銀行、消費金融公司等金融機構的不良資產，依托專業化清收、訴訟追償、債務協商重組等方式實現資產處置收益。富安資管按客戶對象類別劃分成兩條業務線：(i)以個人貸款不良資產包收購處置為主的個貸業務；(ii)以金融機構不良資產收購處置為主的對公業務。

In the first half of 2026, the financial asset management segment recorded a gain on fair value changes of non-performing assets of RMB14.5 million (corresponding period of 2025: RMB1.2 million).

COMMERCIAL BANKING SEGMENT

In 2016, the Company, together with six domestic institutions, jointly established Chongqing Fumin Bank Co., Ltd. ("Fumin Bank"). The Company contributed RMB900.0 million in equity capital to Fumin Bank, representing a 30.0% equity interest, making it the largest shareholder of Fumin Bank. With a development vision of becoming "a new driving force in industry-finance integration and a trusted partner in the ecosystem", and guided by a digital-driven strategy, Fumin Bank leverages its leading financial technology capabilities, robust big data intelligent risk management framework, mature digital human capital expertise, and efficient internet-based open operating model. Anchored in industrial supply chain and industrial retail scenarios, Fumin Bank has charted a development trajectory of steady progress with sustained quality enhancement. As at 30 June 2026, Fumin Bank had total assets of RMB68,789.7 million (31 December 2025: RMB64,693.0 million), and total liabilities of RMB63,179.1 million (31 December 2025: RMB59,186.2 million). In the first half of 2026, Fumin Bank recorded a net profit of RMB101.1 million (corresponding period of 2025: RMB325.0 million).

民營銀行分部

於2016年，本公司與境內六家機構共同發起設立重慶富民銀行股份有限公司（「富民銀行」）。本公司對富民銀行股權出資人民幣900.0百萬元，佔股比例30.0%，為富民銀行第一大股東。富民銀行以「產融新動能、生態好夥伴」為發展願景，以「數字驅動」為引領，依托領先的金融科技能力、穩健的大數據智能風控體系、成熟的數字化人力資本能力和高效的互聯網開放運營模式，錨定「產業供應鏈場景」和「產業零售」場景，走出了穩中有進、穩中提質的發展曲線。截至2026年6月30日，富民銀行資產總額為人民幣68,789.7百萬元（2025年12月31日：人民幣64,693.0百萬元），負債總額為人民幣63,179.1百萬元（2025年12月31日：人民幣59,186.2百萬元）。2026年上半年，富民銀行實現淨利潤人民幣101.1百萬元（2025年同期：人民幣325.0百萬元）。

OTHERS

This segment represents the managerial functions of the headquarters and other business lines and operational results that cannot be completely categorized into any of the above segments. In the first half of 2026, this segment recorded a loss before tax of RMB99.3 million (corresponding period of 2025: RMB104.2 million).

With the objective of “integrating functions and enhancing efficiency”, the Group has continuously strengthened the integration of various functions, especially the mid-and-back offices, to enhance operating efficiency and reduce operating costs. All business segments and their branches focus on customer development and risk management, while the headquarter focuses on the establishment of a unified service system covering human resources, financial management, fund raising and utilization, administrative services, and construction of the information system, and provides targeted services to the business segments and their branches.

FINANCIAL REVIEW

Net guarantee and consulting fee income

The Group’s guarantee and consulting fee income was derived from its financing guarantee business (mainly including traditional financing guarantee and bond guarantee) and non-financing guarantee business (mainly including project performance guarantee and electronic bid guarantee). In the first half of 2026, the Group recorded net guarantee and consulting fee income of RMB77.5 million, representing a decrease of RMB21.9 million or 22.0% as compared with RMB99.4 million in the corresponding period of 2025. The decrease was primarily attributable to macroeconomic headwinds, and downturn in the business climate of certain industries, which dampened corporate demand for financing and contract performance, reduced customers’ appetite for new guarantees or renewal of guarantees, and shrunk the overall scale of guarantee business. Consequently, guarantee business income experienced a downward trend.

其他分部

本集團以「職能整合、提升效率」為目標，不斷加強職能部門尤其是中後台職能部門的整合，以提升運營效率，降低運營成本。各業務分部及其分支機構主要專注於客戶拓展及風險管理，總部則主要專注於建立統一的服務體系，包括人力資源、財務管理、資金募集及運用、行政服務、信息系統建設等，並有針對性地向業務分部及其分支機構提供服務。

財務回顧

擔保及諮詢費淨收入

本集團擔保及諮詢費收入來源於以傳統融資擔保和債券擔保為主的融資擔保業務，以及以工程履約擔保、電子投標保函為主的非融資擔保業務。2026年上半年，本集團擔保及諮詢費淨收入為人民幣77.5百萬元，與2025年同期擔保及諮詢費淨收入人民幣99.4百萬元相比，下降人民幣21.9百萬元，降幅22.0%，主要源於宏觀經濟承壓、部分行業景氣度下行，導致企業融資及履約需求減弱，客戶新增及續保意願下降，整體擔保業務發生規模下降，致使擔保業務收入呈下降態勢。

Net interest and handling fee expense

In the first half of 2026, the Group recorded net interest and handling fee expense of RMB53.3 million (corresponding period of 2025: RMB72.0 million). In the first half of 2026, the average scale of the Group's interest-bearing borrowings decreased compared with the corresponding period of 2025, and the related interest and handling fee expenses therefrom decreased correspondingly. During the first half of 2026, the Group entered into supplemental agreements with certain creditors in respect of its existing indebtedness, successfully reducing the applicable interest rates on such debts. As a result, the Group's finance costs for the six months ended 30 June 2026 decreased compared to the corresponding period in 2025. The Group will continue to optimize its debt structure, strengthen fund coordination and cost control, so as to enhance overall efficiency in the use of funds.

Reversal of provision for guarantee losses

The provision for guarantee losses is an estimate of sufficient provision for credit guarantee made by the Group based on the asset quality of its guarantee portfolio and past experience. The Group vigorously developed online standardized, automated, batch-based, and low-risk credit guarantee products. In the first half of 2026, the Group reversed the provision for guarantee losses of RMB27.2 million (corresponding period of 2025: RMB28.2 million), after a prudent assessment of the current risk profile of the Group's credit guarantee product portfolio, taking into account historical records of default payments and recoveries with respect to the Group's credit guarantee business over the years.

Impairment losses

In the first half of 2026, Group's impairment losses amounted to RMB1.5 million, representing a decrease of RMB0.3 million as compared with impairment losses of RMB1.8 million in the corresponding period of 2025. The Group's provisions for impairment losses on various assets decreased substantially, reflecting the stabilization in the overall credit quality of its asset portfolio and continued enhancement of its risk resilience.

利息及手續費淨支出

2026年上半年，本集團利息及手續費淨支出為人民幣53.3百萬元（2025年同期：人民幣72.0百萬元）。2026年上半年，本集團計息借款的平均規模較2025年同期有所下降，其所產生的利息及手續費支出相應減少。2026年上半年，本集團已與若干債權人就現有債務達成補充協議，成功下調相關債務的適用利率，致使本集團2026年上半年的利息支出較2025年同期有所下降。本集團將持續優化債務結構，加強資金統籌與成本管控，以提升整體資金使用效率。

轉回擔保賠償準備金

擔保賠償準備金主要根據本集團擔保組合資產質量及過往經驗，對信用擔保業務而言足夠的撥備水平的估計。本集團大力發展在線標準化、自動化、批量化的低風險信用擔保產品。結合歷年來本集團信用擔保業務實際代償及回收情況，2026年上半年，本集團對當前信用擔保產品組合風險狀況進行審慎評估後，轉回擔保賠償準備金人民幣27.2百萬元（2025年上半年：人民幣28.2百萬元）。

資產減值損失

2026年上半年，本集團資產減值損失為人民幣1.5百萬元，較2025年同期減值損失人民幣1.8百萬元，減少人民幣0.3百萬元。本集團各項資產減值損失計提規模大幅減少，反映出資產組合整體信用狀況趨於穩定，風險抵禦能力持續增強。

Operating expenses

The Group continued to deepen its cost optimization management, proactively reduced various non-essential expenditures, and effectively enhanced resource utilization efficiency through the implementation of a refined expense control mechanism. In the first half of 2026, the Group's operating expenses totaled RMB84.9 million, representing a decrease of RMB25.7 million or 23.2% from RMB110.6 million in the corresponding period of 2025. The operating expenses continued downward trend, primarily benefiting from the steady implementation of workforce structure optimization initiatives, which significantly reduced related labour costs such as staff remuneration and social insurance contributions. Looking ahead, the Group will further strengthen its focus on cost-effectiveness, while safeguarding core business operations and talent pipeline development, so as to drive continuous improvement in operational efficiency.

Share of profits of associates

In the first half of 2026, the Group's share of profits of associates amounted to RMB27.9 million, representing a decrease of RMB70.5 million or 71.6% as compared with RMB98.4 million for the corresponding period of 2025. The Group's share of profit of associates was primarily derived from Fumin Bank. For details of the operations of Fumin Bank, please refer to the relevant section on page 12 of this report.

CAPITAL STRUCTURE, LIQUIDITY AND FINANCIAL RESOURCES

Capital structure

As at 30 June 2026, our share capital was RMB4,600.0 million, comprising 3,430,000,000 domestic shares and 1,170,000,000 H shares, each with a face value of RMB1.00.

本集團持續深化成本優化管理，主動壓降各類非必要開支，並通過推進費用精細化管控機制，有效提升資源使用效率。2026年上半年，本集團營運支出為人民幣84.9百萬元，較2025年同期營運支出為人民幣110.6百萬元，下降人民幣25.7百萬元，降幅23.2%。營運支出延續下降趨勢，主要得益於人員結構優化舉措的穩步推進，帶動職工薪酬及社會保險等相關人力成本顯著減少。未來，集團將在保障核心業務運營與人才梯隊建設的前提下，進一步強化成本效益導向，推動運營效能持續提升。

聯營企業投資收益

2026年上半年，本集團共錄得聯營企業投資收益人民幣27.9百萬元，較2025年同期聯營企業投資收益人民幣98.4百萬元，減少人民幣70.5百萬元，降幅71.6%。本集團聯營企業投資收益主要來源於富民銀行，有關富民銀行的經營詳細情況，請參閱本報告第12頁相應章節。

資本架構

Liquidity and capital resources

We finance our working capital and other capital requirements principally with capital contributions from shareholders, bank borrowings, cash inflows from operating activities and proceeds from our initial public offering. Our liquidity and other capital requirements are primarily related to default payments, restricted bank deposits, and other working capital needs.

As at 30 June 2026, we had cash and cash equivalents of RMB168.2 million (31 December 2025: RMB187.9 million), which were mainly denominated in Renminbi. During the six months ended 30 June 2026, the Group did not use any financial instrument for hedging purpose.

INDEBTEDNESS

As at 30 June 2026, we had RMB2,801.6 million (31 December 2025: RMB2,792.4 million) of outstanding interest bearing debts (including interest-bearing borrowings and financial assets sold under repurchase agreements) in total, all of which were denominated in Renminbi and bore interest at fixed rates ranging from 2.8% to 15.0% (31 December 2025: 2.8% to 15.0%) per annum.

流動資金及資本資源

我們主要以股東的股權出資、銀行借款、經營產生的現金流入及首次公開募股所得款項就營運資金及其他資本要求提供資金。我們的流動資金及資本要求主要與支付違約付款、維持於銀行存放保證金及其他營運資金需求有關。

截至2026年6月30日，我們的現金及現金等價物為人民幣168.2百萬元（2025年12月31日：人民幣187.9百萬元），主要以人民幣計值。截至2026年6月30日止六個月期間，本集團並無利用任何金融工具作對沖用途。

OFF-BALANCE SHEET ARRANGEMENTS

We are a party to contracts with off-balance sheet risks in the ordinary course of our credit guarantee business. The contractual amount reflects the extent of our involvement in credit guarantee and our maximum exposure to credit loss. As at 30 June 2026, we had outstanding credit guarantee of RMB20,423.1 million (31 December 2025: RMB22,950.6 million).

Save as disclosed above, we have no other off-balance sheet arrangements.

DEBT-TO-CAPITAL RATIO

As at 30 June 2026, the Group's debt-to-capital ratio was 74.5% (31 December 2025: 74.6%). The debt-to-capital ratio was calculated by total interest-bearing debts divided by the sum of total interest-bearing debts and total equity, including non-controlling interests.

FOREIGN EXCHANGE RISK EXPOSURE

The Group's exposure to foreign exchange risk is insignificant as most of its transactions are settled in Renminbi.

The amounts claimed in respect of principal, interest and related costs have been recognised as liabilities in the Group's financial statements based on the original contracts and relevant judgments, mediation agreements or management's best estimate. Where proceedings are still before the court/on appeal, any amounts in excess of those recognised cannot presently be estimated reliably.

AUDIT COMMITTEE AND REVIEW OF INTERIM RESULTS

The unaudited consolidated interim financial information for the six months ended 30 June 2026 and this interim report have been reviewed by the Audit Committee. This interim financial report has been prepared in accordance with the applicable disclosure provisions of the Listing Rules, including compliance with Hong Kong Accounting Standard 34, Interim financial reporting, issued by the Hong Kong Institute of Certified Public Accountants (the “HKICPA”).

The Audit Committee has discussed with the directors and management the matters relating to the going concern basis. Accordingly, no area or basis of disagreement between the Audit Committee and management is required to be disclosed.

As at 30 June 2026, the Group’s current liabilities exceeded its current assets, certain interest-bearing borrowings were overdue. As at 30 June 2026, the Group’s cash and cash equivalents amounted to RMB168,150,000 only.

As of the date of this report, the Company and certain of its subsidiaries were defendants in 13 litigations and arbitrations; such litigations and arbitrations arose from the Group’s various ordinary business operations, with an aggregate claim amount of approximately RMB1,093,000,000. And any additional liabilities that may be determined would further reduce the Group’s available financial resources.

The above overdue interest-bearing borrowings, litigations and arbitrations indicate that multiple material uncertainties exist that may cast significant doubt on the Group’s ability to continue as a going concern. In view of such circumstances, the directors of the Company have given careful consideration to the future liquidity and performance of the Group and its available sources of financing in assessing whether the Group will have sufficient financial sources to continue as a going concern. The following plans and measures are formulated to mitigate the liquidity pressure, to improve the financial position of the Group, and to remediate the overdue repayments to the lender:

針對持續經營基準事項，審計委員會與董事會、管理層進行了討論；審核委員會與董事會、管理層之間並無任何須予披露的分歧範疇或分歧依據。

於2026年6月30日，本集團的流動負債超過流動資產，部分計息借款處於逾期狀態。本集團於2026年6月30日的現金及現金等價物僅為人民幣168,150,000元。

截至本報告日期，本公司及其若干附屬公司為13宗訴訟及仲裁之被告；該等訴訟及仲裁因本集團各項常規業務而產生，訴訟金額合共約人民幣1,093,000,000元。且任何可能被裁定之額外負債將進一步減少本集團之可用財務資源。

上述逾期的計息借款、訴訟及仲裁顯示存在多項重大不確定因素，可能對本集團的持續經營能力構成重大疑慮。鑑於上述情況，本公司董事會於評估本集團是否將有足夠財務資源持續經營時，已審慎考慮本集團未來的流動資金及表現，以及可利用的融資來源。為緩解流動資金壓力、改善本集團的財務狀況，以及補救向貸款人逾期還款事宜，已制定下列計劃及措施：

- (i) The directors of the Company consider that the obligation to repay the overdue interest-bearing borrowings is established; The Group has also been conducting negotiations with various creditors on renewal and extension for repayments of the overdue borrowings.
 - (ii) The Group will endeavor to renew or extend existing borrowings with scheduled repayment dates within one year as and when needed. The Group will also actively negotiate with the banks and financial institutions to secure new financing sources.
 - (iii) The Group has actively adjusted its internal organisational structure, and strengthened product research and development, with the aim of continuously meeting customer needs and creating sustained value for customers. The Group will speed up the collection of sales proceeds.
 - (iv) The Group has optimized its personnel structure and implemented a new remuneration and performance scheme to motivate the team to proactively engage in business development to enhance operational efficiency.
 - (v) The Group has actively communicated with creditors and strives to reach debt settlement agreements, comprehensively reviews and reduces various nonstrategic expenses, enhances the management of recovery for compensated/overdue businesses, and evaluates existing assets in light of strategic planning and market conditions to carry out restructuring, all with the aim of comprehensively improving working capital reserves.
- (i) 本公司董事會認為，各項逾期的計息借款的償還義務確實成立，本集團亦一直與各家債權人就逾期借款的續期及延長還款期限進行磋商。
 - (ii) 本集團將於有需要時，盡力將一年內到期的現有借款進行續期或延期。本集團亦將積極與銀行及金融機構磋商，以爭取新的融資來源。
 - (iii) 本集團已積極調整內部組織架構，並加強產品研發，以期持續滿足客戶需求及為客戶創造持續價值。本集團將加快銷售回款速度。
 - (iv) 本集團已優化其人員架構，並實施新的薪酬及績效計劃，以激勵團隊積極拓展業務，從而提升營運效率。
 - (v) 本集團已與債權人積極進行溝通，並努力達成債務和解協議，全面檢討及削減各項非策略性開支，加強對已代償／逾期業務的追收管理，並因應策略規劃及市場情況評估現有資產以進行重組，所有此等措施均旨在全面提升營運資金儲備。

The directors of the Company have reviewed the Group's cash flow projections prepared by management, which cover a period of not less than twelve months from reporting date. They are of the opinion that, taking into account the above-mentioned plans and measures, the Group will have sufficient working capital to finance its operations and to meet its financial obligations as and when they fall due within twelve months from reporting date. Accordingly, the directors of the Company are satisfied that it is appropriate to prepare the consolidated financial statements on a going concern basis.

Notwithstanding the above, significant uncertainties exist as to whether the Group is able to achieve its plans and measures as described above. Whether the Group will be able to continue as a going concern would depend upon the following:

- (i) the successful negotiations with various creditors in respect of the legal proceedings and the repayment arrangements;
- (ii) the successful and timely implementation of the plans to accelerate the sale, speed up the collection of outstanding sales proceeds and other receivables, and control costs so as to generate adequate net cash inflows; and
- (iii) the successful obtaining of additional new sources of financing as and when needed.

Should the Group be unable to achieve the above mentioned plans and measures and operate as a going concern, adjustments would have to be made to write down the carrying values of the Group's assets to their recoverable amounts, to provide for any further liabilities which might arise, and to reclassify non-current assets and non-current liabilities as current assets and current liabilities, respectively. The effects of these adjustments have not been reflected in these consolidated financial statements.

CORPORATE GOVERNANCE

The Company is committed to maintaining high standards of corporate governance and has steered its development and protected the interests of its shareholders in an enlightened and open manner.

The Board comprises one executive Directors, three non-executive Directors, four independent non-executive Directors and one employee Director. The Board has adopted the code provisions (the “Code Provisions”) of the Corporate Governance Code as set out in Appendix C1 to the Listing Rules. For the six months ended 30 June 2026, the Company has complied with the Code Provisions.

On 10 September 2026, the Company appointed Mr. Xie Cheng as a non-executive Director and Mr. Liu Haowen as an independent non-executive Director. Except as disclosed in this report, no other significant event took place subsequent to 30 June 2026 up to the date of this report.

1 BASIS OF PREPARATION

This interim financial report has been prepared in accordance with the applicable disclosure provisions of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited, including compliance with Hong Kong Accounting Standard (HKAS) 34, *Interim financial reporting*, issued by the Hong Kong Institute of Certified Public Accountants (“HKICPA”). It was authorised for issue on 17 September 2026.

The interim financial report has been prepared in accordance with the same accounting policies adopted in the 2025 annual financial statements, except for the accounting policy changes that are expected to be reflected in the 2026 annual financial statements. Details of any changes in accounting policies are set out in Note 2.

The preparation of an interim financial report in conformity with HKAS 34 requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets and liabilities, income and expenses on a year to date basis. Actual results may differ from these estimates.

This interim financial report contains condensed consolidated financial statements and selected explanatory notes. The notes include an explanation of events and transactions that are significant to an understanding of the changes in financial position and performance of the Group since the 2025 annual financial statements. The condensed consolidated interim financial statements and notes thereon do not include all of the information required for a full set of financial statements prepared in accordance with HKFRS Accounting Standards (which include all Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards (“HKASs”) and Interpretations) issued by the HKICPA.

The interim condensed consolidated financial statements are presented in Renminbi (“RMB”) and rounded to the nearest RMB’000, unless otherwise stated. These condensed consolidated financial statements are unaudited.

1 編製基礎

本中期財務報告乃根據香港聯合交易所有限公司證券上市規則適用披露條文，並按照香港會計師公會（「香港會計師公會」）頒佈之香港會計準則（香港會計準則）第34號中期財務報告之規定而編製。本中期財務報告已於2026年9月17日獲授權刊發。

本公司編製本中期財務報告所採用的會計政策與本公司於2025年年度財務報表所採用者一致，惟預期於2026年年度財務報表內反映之會計政策變動除外。此等會計政策變動之詳情載於附註2。

按照香港會計準則第34號編製之中期財務報告，需要管理層作出判斷、估計及假設，此舉會影響會計政策之應用以及按截至報告日期為止基準呈報之資產及負債、收入及支出之金額。實際結果可能有別於該等估計。

本中期財務報告載有簡明合併財務報表及經選取的說明附註。該等附註對自2025年度財務報表以來，對理解本集團財務狀況及經營業績變動具有重要意義的事件及交易作出說明。簡明合併中期財務報表及其附註並未包含根據香港會計師公會頒佈之香港財務報告準則會計準則（包括所有香港財務報告準則、香港會計準則（「香港會計準則」）及詮釋）編製整套財務報表所需的全部資料。

本中期簡明合併財務報表以人民幣（「人民幣」）列報，除另有說明外，金額均四捨五入至人民幣千元。該等簡明合併財務報表未經審計。

The interim financial report has not been audited, but has been reviewed by the audit committee of the Company (the “**Audit Committee**”).

Going concern basis

As at 30 June 2026, the Group's current liabilities exceeded its current assets, certain interest-bearing borrowings were overdue and the Company. As at the same date, the Group's cash and cash equivalents amounted to RMB168,150,000 only.

Up to the approval date of these condensed consolidated financial statements, the Company and certain of its subsidiaries were defendants in 13 litigations and arbitrations; such litigations and arbitrations arose from the Group's various ordinary business operations, with an aggregate claim amount of approximately RMB1,093,000,000, and any additional liabilities that may be determined would further reduce the Group's available financial resources.

The above conditions indicate that multiple material uncertainties exist that may cast significant doubt on the Group's ability to continue as a going concern.

In view of such circumstances, the directors of the Company have given careful consideration to the future liquidity and performance of the Group and its available sources of financing in assessing whether the Group will have sufficient financial sources to continue as a going concern. The following plans and measures are formulated to mitigate the liquidity pressure, to improve the financial position of the Group, and to remediate the overdue repayments to the lender:

- (i) The directors of the Company consider that the obligation to repay the overdue interest-bearing borrowings is established; The Group has also been conducting negotiations with various creditors on renewal and extension for repayments of the overdue borrowings.

持續經營基準

於2026年6月30日，本集團的流動負債超過流動資產，部分計息借款處於逾期狀態。於同日，本集團的現金及現金等價物僅為人民幣168,150,000元。

截至本合併財務報告批准日，本公司及其若干附屬公司為13宗訴訟及仲裁之被告，該等訴訟及仲裁因本集團各項常規業務而產生，訴訟金額合共約人民幣1,093,000,000元。且任何可能被裁定之額外負債將進一步減少本集團之可用財務資源。

上述情況表明，存在多項重大不確定性，可能對本集團持續經營的能力產生重大疑慮。

鑑於上述情況，本公司董事於評估本集團是否將有足夠財務資源持續經營時，已審慎考慮本集團未來的流動資金及表現，以及可利用的融資來源。為緩解流動資金壓力、改善本集團的財務狀況，以及補救向貸款人逾期還款事宜，已制定下列計劃及措施：

- (i) 本公司董事認為，各項逾期的計息借款的償還義務確實成立，本集團亦一直與各家債權人就逾期借款的續期及延長還款期限進行磋商。

- (ii) The Group will endeavor to renew or extend existing borrowings with scheduled repayment dates within one year as and when needed. The Group will also actively negotiate with the banks and financial institutions to secure new financing sources.
- (iii) The Group has actively adjusted its internal organisational structure, and strengthened product research and development, with the aim of continuously meeting customer needs and creating sustained value for customers. The Group will speed up the collection of sales proceeds.
- (iv) The Group has optimized its personnel structure and implemented a new remuneration and performance scheme to motivate the team to proactively engage in business development to enhance operational efficiency.
- (v) The Group has actively communicated with creditors and strives to reach debt settlement agreements, comprehensively reviews and reduces various nonstrategic expenses, enhances the management of recovery for compensated/overdue businesses, and evaluates existing assets in light of strategic planning and market conditions to carry out restructuring, all with the aim of comprehensively improving working capital reserves.

- (ii) 本集團將於有需要時，盡力將一年內到期的現有借款進行續期或延期。本集團亦將積極與銀行及金融機構磋商，以爭取新的融資來源。
- (iii) 本集團已積極調整內部組織架構，並加強產品研發，以期持續滿足客戶需求及為客戶創造持續價值。本集團將加快銷售回款速度。
- (iv) 本集團已優化其人員架構，並實施新的薪酬及績效計劃，以激勵團隊積極拓展業務，從而提升營運效率。
- (v) 本集團已與債權人積極進行溝通，並努力達成債務和解協議，全面檢討及削減各項非策略性開支，加強對已代償／逾期業務的追收管理，並因應策略規劃及市場情況評估現有資產以進行重組，所有此等措施均旨在全面提升營運資金儲備。

The directors of the Company have reviewed the Group's cash flow projections prepared by management, which cover a period of not less than twelve months from reporting date. They are of the opinion that, taking into account the above-mentioned plans and measures, the Group will have sufficient working capital to finance its operations and to meet its financial obligations as and when they fall due within twelve months from reporting date. Accordingly, the directors of the Company are satisfied that it is appropriate to prepare the consolidated financial statements on a going concern basis.

Notwithstanding the above, significant uncertainties exist as to whether the Group is able to achieve its plans and measures as described above. Whether the Group will be able to continue as a going concern would depend upon the following:

- (i) the successful negotiations with various creditors in respect of the legal proceedings and the repayment arrangements;
- (ii) the successful and timely implementation of the plans to accelerate the sale, speed up the collection of outstanding sales proceeds and other receivables, and control costs so as to generate adequate net cash inflows; and
- (iii) the successful obtaining of additional new sources of financing as and when needed.

Should the Group be unable to achieve the above mentioned plans and measures and operate as a going concern, adjustments would have to be made to write down the carrying values of the Group's assets to their recoverable amounts, to provide for any further liabilities which might arise, and to reclassify non-current assets and non-current liabilities as current assets and current liabilities, respectively. The effects of these adjustments have not been reflected in these consolidated financial statements.

Refers to the group's equity investment in commercial banks.

(a) Segment results, assets and liabilities

For the purposes of assessing segment performance and allocating resources between segments, the Group's senior executive management monitors the results, assets and liabilities attributable to each reportable segment on the following bases:

Segment assets include all tangible, intangible assets and current assets with the exception of deferred tax assets. Segment liabilities include all liabilities managed directly by the segments with the exception of deferred tax liabilities.

Revenue and expenses are allocated to the reportable segments with reference to revenue generated by those segments and the expenses incurred by those segments or which otherwise arise from the depreciation or amortization of assets attributable to those segments.

Internal charges and transfer prices are determined with reference to market rates and have been reflected in the performance of each segment.

(iv) General reserve

Pursuant to relevant regulations, the subsidiaries engaged in credit guarantee business are required to set aside a general reserve through appropriations of profit after tax according to 10% of its profit after as determined under the Accounting Standard for Business Enterprise and other relevant requirements issued by the Ministry of Finance of the PRC after making good prior year's accumulated loss to cover potential losses against their assets.

While subsidiaries engaged in providing a range of loan and services to the small sized and micro enterprises ("SME enterprises") are required to set aside a general reserve through appropriations of profit after tax according to a certain provision ratio of the ending balance of gross risk-bearing assets to cover potential losses against their assets. In principal, the general reserve balance should not be lower than 1.0% of the ending balance of gross risk-bearing assets.

The inputs used in valuation techniques include risk-free and benchmark interest rates, credit spreads and foreign exchange rates. 以公允價值計量的金融工具當有可靠的市場報價時採用市場報價作為公允價值。當沒有可靠的市場報價時須要採用估值技術，比如通過對比其他類似的金融資產、現金流折現、期權定價等，採用的參數包括無風險利率、基準利率、信用點差及匯率。當使用現金流折現法時，管理層會盡最大的努力儘量準確地估計現金流，折現率則參考類似的金融產品。

本集團擁有一隻由財務經理領導之團隊，負責就金融工具（包括非上市債務工具、上市及非上市的股本證券和不良資產包）進行估值。該團隊直接向財務總監及審計委員會報告。載有公允價值計量變動分析之估值報告乃由團隊於各中期及年度報告日期編製，並由財務總監審閱及批准。團隊就估值過程及結果每年與財務總監及審計委員會進行兩次討論，以與報告日期保持一致。

23 MATERIAL LITIGATION

Up to the approval date of these condensed consolidated financial statements, the Company and certain subsidiaries were defendants in 13 legal proceedings and arbitrations arising from their factoring, guarantee, asset-management and finance-leasing businesses, with claims totalling approximately RMB1,093 million. The amounts claimed in respect of principal, interest and related costs have been recognised as liabilities in these financial statements based on the original contracts and relevant judgments, mediation agreements or management's best estimate. Where proceedings are still before the court/on appeal, any amounts in excess of those recognised cannot presently be estimated reliably.

24 EVENTS AFTER THE REPORTING PERIOD

Except for the material litigation, the Group has no other material subsequent events requiring disclosure. Details of the Group's material litigation are set out in Note 23 to the condensed consolidated financial statements.
