BUSINESS REVIEW

In the first half of 2026, the global economy continued to undergo structural adjustments, and the overall recovery remained sluggish. Affected by changes in international tariffs, geopolitical tensions, and intensifying domestic market competition, compounded by continued weakness in the domestic consumer market, uncertainty surrounding industry transformation driven by the evolution of artificial intelligence technology, and increasingly fierce competition in the implementation of AI applications, enterprises faced significantly higher costs for R&D, operations, and technology deployment. Combined with structural inflation and pressure from fixed costs, the recovery in industry demand fell short of expectations, and corporate profitability came under widespread pressure. The Group faced multiple operational challenges, including weak consumer demand, divergent demand patterns, increased difficulty in controlling costs, and intensifying market competition.

Based on the complex external environment described above, the Group, under the guidance of the Board, has actively strengthened its risk management and market responsiveness to address changes in market competition and technological transformations within the industry. The Group strived to maintain the stable operation of the online game business, explored the product structure of electronic commerce, prudently sought breakthroughs, steadily explored the layout and development of innovative and transformative businesses, integrated existing resources, solidified operational management, appropriately pursued investment opportunities based on careful evaluation, and steadily promoted innovative development.

In the first half of 2026, the Group recorded a total revenue of approximately RMB50.7 million, representing a decrease of 34.9% compared to the same period of last year.

業務回顧

二零二六年上半年，全球經濟持續結構調整，整體復甦乏力。受國際關稅變動、地緣政治緊張、國內市場競爭加劇影響，疊加國內消費市場持續疲軟、人工智能技術迭代帶來行業變革不確定性，同時AI場景應用落地競爭日趨白熱化，大幅推高企業研發、運營及技術落地成本，再疊加結構性通脹與剛性成本壓力，行業需求修復不及預期，企業盈利普遍承壓。本集團面臨消費市場需求疲軟、需求分化、成本管控難度加大、市場競爭持續升級等多重經營挑戰。

基於上述複雜的外部環境，本集團在董事會的指導下，積極加強風險管理和市場應變能力以應對市場競爭及行業技術變革的變化。本集團努力維持網絡遊戲業務的平穩運行，探索電子貿易產品結構，審慎尋求突破，穩步探索創新轉型業務的佈局和開發，整合現有資源，夯實經營管理，在審慎評估的前提下，適度尋求投資機會，穩步推動創新發展。

二零二六年上半年，本集團錄得總收入共計約人民幣50.7百萬元，較去年同期減少34.9%。

Revenue. Revenue decreased by approximately 34.9% to RMB50.7 million for the six months ended 30 June 2026 from RMB78.0 million for the six months ended 30 June 2025. The following table sets forth the Group's revenue by segment for the six months ended 30 June 2026 and 2025:

- Revenue generated from the Group's game business decreased by approximately 7.9% to RMB5.1 million for the six months ended 30 June 2026 from RMB5.5 million for the six months ended 30 June 2025. Such decrease was primarily attributable to the fact that the Group's two games "凡人修真2" and "醉西遊" have entered into the mature stage of their lifecycles and generated less revenue than the previous year.
- Revenue generated from the Group's electronic device and semiconductor business decreased by approximately 38.1% to RMB44.9 million for the six months ended 30 June 2026 from RMB72.5 million for the six months ended 30 June 2025. Revenue generated from the electronic device and semiconductor business decreased was primarily attributable to the decline in sales of high-performance memories and hard disk drives.
- Fund management income was recognized by the Group in respect of its fund management business, which was carried out through a licensed subsidiary since the end of December 2025.

- 本集團遊戲業務產生的收入由截至二零二五年六月三十日止六個月的人民幣5.5百萬元減少約7.9%至截至二零二六年六月三十日止六個月的人民幣5.1百萬元。該減少乃主要歸因於本集團的兩款遊戲「凡人修真2」及「醉西遊」已進入其生命週期的成熟階段，所產生的收入低於上年。
- 本集團電子設備及半導體業務產生的收入由截至二零二五年六月三十日止六個月的人民幣72.5百萬元減少約38.1%至截至二零二六年六月三十日止六個月的人民幣44.9百萬元。電子設備及半導體業務產生的收入減少主要歸因於高性能內存及硬盤驅動器銷售下降。
- 本集團就其透過持牌附屬公司自二零二五年十二月底開始開展的基金管理業務確認基金管理收入。

Cost of revenue. Cost of revenue decreased by approximately 39.7% to RMB45.9 million for the six months ended 30 June 2026 from RMB76.1 million for the six months ended 30 June 2025. The decrease of cost of revenue was primarily attributable to and was in line with the decrease of revenue, particularly in revenue from sales of high-performance memories and hard disk drives.

Selling and marketing expenses. Selling and marketing expenses decreased by approximately 22.3% to RMB3.0 million for the six months ended 30 June 2026 from RMB3.9 million for the six months ended 30 June 2025. Such decrease was primarily attributable to a reduction in promotion expenses, which was in line with the revenue decline in the game business.

Administrative expenses. Administrative expenses increased by approximately 40.8% to RMB19.6 million for the six months ended 30 June 2026 from RMB14.0 million for the six months ended 30 June 2025. Such increase was primarily attributable to an increase in allowances for inventories.

Research and development expenses. Research and development expenses decreased by approximately 36.2% to RMB7.6 million for the six months ended 30 June 2026 from RMB11.9 million for the six months ended 30 June 2025. Such decrease was primarily attributable to the rigorous expense control in game business.

Other income. Other income decreased by approximately 86.6% to RMB0.1 million for the six months ended 30 June 2026 from RMB0.8 million for the six months ended 30 June 2025. Such decrease was primarily attributable to a decline in interest income from both debt investments at fair value through other comprehensive income and deposits.

Other gains – net. Other gains-net increased by approximately 104.5% to RMB9.3 million for the six months ended 30 June 2026 from RMB4.5 million for the six months ended 30 June 2025. Such increase was primarily attributable to higher net gains from investments at fair value through profit or loss.

成本。成本由截至二零二五年六月三十日止六個月的人民幣76.1百萬元減少約39.7%至截至二零二六年六月三十日止六個月的人民幣45.9百萬元。成本減少乃主要歸因於收入減少並與收入減少一致，尤其是高性能內存及硬盤驅動器銷售收入減少。

銷售及市場推廣開支。銷售及市場推廣開支由截至二零二五年六月三十日止六個月的人民幣3.9百萬元減少約22.3%至截至二零二六年六月三十日止六個月的人民幣3.0百萬元。該減少主要歸因於推廣開支減少，並與遊戲業務收入減少一致。

行政開支。行政開支由截至二零二五年六月三十日止六個月的人民幣14.0百萬元增加約40.8%至截至二零二六年六月三十日止六個月的人民幣19.6百萬元。該增加主要歸因於存貨撥備增加。

研發開支。研發開支由截至二零二五年六月三十日止六個月的人民幣11.9百萬元減少約36.2%至截至二零二六年六月三十日止六個月的人民幣7.6百萬元。該減少主要歸因於遊戲業務嚴格控制開支。

其他收益。其他收益由截至二零二五年六月三十日止六個月的人民幣0.8百萬元減少約86.6%至截至二零二六年六月三十日止六個月的人民幣0.1百萬元。該減少主要歸因於來自按公平值計入其他全面收益的債權投資及存款的利息收入減少。

其他利得淨額。其他利得淨額由截至二零二五年六月三十日止六個月的人民幣4.5百萬元增加約104.5%至截至二零二六年六月三十日止六個月的人民幣9.3百萬元。該增加主要歸因於按公平值計入損益的投資收益淨額增加。

Impairment (provision)/reversal of financial assets measured at amortised cost. Impairment provision was RMB0.5 million for the six months ended 30 June 2026 as compared to impairment reversal of RMB1.6 million for the six months ended 30 June 2025. During the six months ended 30 June 2025, the Group recovered RMB3.0 million from previously impaired corporate loans receivables.

Loss for the period. Loss for the period decreased by approximately 21.2% to RMB16.5 million for the six months ended 30 June 2026 from RMB20.9 million for the six months ended 30 June 2025.

NON-IFRSs ACCOUNTING STANDARDS MEASURES – EBITDA AND ADJUSTED EBITDA

To supplement the consolidated results of the Group which are prepared in accordance with International Financial Reporting Standards (the “IFRSs”), certain non-IFRSs Accounting Standards measures, including EBITDA (i.e. earnings before interest expense, taxes, depreciation and amortisation) and adjusted EBITDA, have been presented. These non-IFRSs financial measures should be considered in addition to, and not as a substitute for, the measures of the Group’s financial performance, which have been prepared in accordance with IFRSs. The Group’s management believes that these non-IFRSs financial measures provide investors with useful supplementary information to assess the performance of its core operations by excluding certain non-cash and non-recurring items. The EBITDA and adjusted EBITDA are unaudited figures.

按攤餘成本計量的金融資產減值(撥備)／撥回。截至二零二六年六月三十日止六個月的減值撥備為人民幣0.5百萬元，而截至二零二五年六月三十日止六個月的減值撥回為人民幣1.6百萬元。截至二零二五年六月三十日止六個月，本集團收回先前已減值的應收企業貸款人民幣3.0百萬元。

期內虧損。期內虧損由截至二零二五年六月三十日止六個月的人民幣20.9百萬元減少約21.2%至截至二零二六年六月三十日止六個月的人民幣16.5百萬元。

非國際財務報告準則會計準則計量 – EBITDA及經調整EBITDA

為補充本集團根據國際財務報告準則(「國際財務報告準則」)編製的合併業績，已呈列若干非國際財務報告準則會計準則計量(包括EBITDA(即未計利息開支、稅項、折舊及攤銷前的盈利)及經調整EBITDA)。此等非國際財務報告準則財務計量應被視為根據國際財務報告準則編製的本集團財務業績的補充而非替代計量。本集團管理層認為，此等非國際財務報告準則財務計量為投資者提供有用的補充資料，藉撇除若干非現金及非經常性項目，評估本集團核心業務的表現。EBITDA及經調整EBITDA為未經審核數據。

FINANCIAL POSITION

As at 30 June 2026, the total equity of the Group amounted to RMB398.7 million, as compared to RMB421.5 million as at 31 December 2025. Such decrease was primarily attributable to the net loss recognized for the six months ended 30 June 2026, coupled with a reduction in currency translation differences resulting from the depreciation of the US dollar.

The Group's net current assets amounted to RMB298.3 million as at 30 June 2026, as compared to RMB317.6 million as at 31 December 2025. Such decrease was primarily attributable to the routine operating activities.

LIQUIDITY AND FINANCIAL RESOURCES

財務狀況

於二零二六年六月三十日，本集團權益總額為人民幣398.7百萬元，而於二零二五年十二月三十一日則為人民幣421.5百萬元。該減少乃主要歸因於截至二零二六年六月三十日止六個月確認淨虧損，加之美元貶值導致外幣折算差額有所減少。

於二零二六年六月三十日，本集團的流動資產淨值為人民幣298.3百萬元，而於二零二五年十二月三十一日則為人民幣317.6百萬元。該減少乃主要歸因於日常經營活動。

The Group's total cash and cash equivalents amounted to RMB95.6 million as at 30 June 2026 as compared to RMB93.8 million as at 31 December 2025. The cash balance remained largely unchanged over the period.

As at 30 June 2026, the Group's gearing ratio (calculated as bank borrowing divided by total assets) was 0% (as at 31 December 2025: 0%), which means that the Group did not have any bank borrowing balance as at 30 June 2026.

FOREIGN EXCHANGE RISK

As at 30 June 2026, RMB47.0 million of the financial resources of the Group (as at 31 December 2025: RMB44.2 million) were held as deposits denominated in non-RMB currencies. The Group will continue to actively manage its exposure to various foreign currencies and monitor its foreign exchange risk exposure to better preserve the Group's cash value.

The project's overall cumulative expenses have not exceeded its total budget of HK\$15,000,000, there has been no overspending of the total funds raised. The unutilized portion of the project funds is held in interest-bearing accounts with licensed banks and is expected to be gradually deployed in line with business progress by 31 December 2027. There was no significant subsequent event during the period from 30 June 2026 to the date of the unaudited consolidated interim results of the Group for the six months ended 30 June 2026 approved by the Board.

RISK AND HURDLES

The Group has formulated policies to ensure continuous identification, reporting, monitoring and management of significant risks that may adversely affect its business development.

As to the game business operated by the Group, the Group is mainly exposed to the following types of risks: (i) Industry policies and regulatory risks. Any changes and adjustments in policies by governmental regulatory bodies could affect the market, and the online game industry is subject to the supervision of various relevant authorities, which may have an adverse impact on its business operations; (ii) The risk that changes in player behavior and needs, coupled with the ongoing weakness in the domestic consumer market, may lead to a decline in the Company's future business performance; (iii) The risk of technological dependence, updates and changes. The rapid iteration of Artificial Intelligence technology is reshaping industry ecosystems and user habits, leading to high levels of uncertainty within the industry; and (iv) Intellectual property risk. Intellectual property disputes and maintenance costs may arise during the game research and development process.

As to the electronic device and semiconductor business, the Group is mainly exposed to the following types of risks: (i) Risks of changes in international trade policies and tariffs. Adjustments to trade policies in various countries may directly affect the cost structure and market competitiveness of electronic trade products; (ii) Supply chain stability risks. The transmission of inherent risks and delivery capabilities of upstream suppliers, fluctuations in logistics costs, and pressures related to inventory management may have an adverse impact on its business operations; and (iii) Market demand uncertainty risks. Consumer demand for electronic products is significantly influenced by the macroeconomic environment, and any slower-than-expected recovery in demand may affect the revenue performance of this business segment.

As to the Fund management business operated by the Group, the Group is mainly exposed to the following types of risks: (i) Operating scale and cost pressure risks. Currently, the scale of managed funds is relatively limited, resulting in constrained management fee income, which makes it challenging to adequately cover the various expenses of the existing team; and (ii) Financial market volatility risks. Changes in the macroeconomic environment, adjustments in monetary policies, and fluctuations in capital markets may lead to significant volatility in the fair value of the investment portfolio, thereby impacting investment returns.

FUTURE PLANS

In the second half of 2026, the global economic landscape remains fraught with uncertainty. Factors such as monetary policy adjustments, geopolitical tensions and volatility in the energy markets will continue to affect global and Chinese economic growth. The pace of domestic consumption recovery remains volatile, overall competition of the industry is intensifying, and the operating environment will remain challenging in the short term. The Group will prioritise the stable operation of its businesses to ensure the smooth progress of its existing game-related operations; it will continue to operate its electronic equipment and semiconductor businesses to maintain stable cash flow. At the same time, the Group will evaluate the timing for exploring new business segments as appropriate, optimise its financial investment operations and consolidate its diversified development framework.

In terms of technological applications, the Group will continue to focus on developments in new technologies such as artificial intelligence, assess the potential for integrating them into the Group's business at the appropriate time, consolidate its existing business scope, and stabilise revenue. The Group will strictly control its budget, rigorously manage costs and expenses, enhance operational efficiency and return on assets, and strive to improve the overall quality and efficiency of its operations.

The Group will continue to uphold the philosophy of prudent operation. Amid the current complex and volatile market environment, it is committed to safeguarding the Company's stable sound operation and financial security. The Group will closely monitor market opportunities, advance all businesses under controllable risks, pursue business optimisation, improve the overall operational standard, strive to preserve value for shareholders and deliver long term returns.

Code provision C.2.1 of the CG Code stipulates that the roles of chairman and chief executive should be separate and should not be performed by the same individual. As Mr. CUI Yuzhi serves as both the chairman of the Board and the chief executive officer, such practice deviates from the above code provision.

The Board considers that vesting the roles of both the chairman of the Board and the chief executive officer in the same person has the benefit of ensuring consistent leadership within the Company and enables more effective and efficient overall strategic planning for the Company. The Board believes that the balance of power and authority for the present arrangement will not be impaired and this structure will enable the Company to make and implement decisions promptly and efficiently. The Board shall, nevertheless, review the structure from time to time and it will consider the appropriate move to take should suitable circumstances arise.

The Board will continue to monitor and review the Company's corporate governance practices from time to time to ensure compliance with the latest statutory requirements and professional standards.

I. GENERAL INFORMATION

Forgeame Holdings Limited (the “Company”) was incorporated in the Cayman Islands on 26 July 2011 as an exempted company with limited liability. The address of its registered office is at the offices of Osiris International Cayman Limited, Suite #4-210, Governors Square, 23 Lime Tree Bay Avenue, P.O. Box 32311, Grand Cayman KY1-1209, Cayman Islands. The address of its principal place of business in Hong Kong is Unit 3, 12/F, Trust Centre, 912 Cheung Sha Wan Road, Lai Chi Kok, Kowloon, Hong Kong. The address of its headquarters is Room 1106, Block A Phase I, Innovation Technology Plaza, Tianan Digital City, Chegongmiao, Futian District, Shenzhen, China. The Company's shares in issue are listed and traded on the Main Board of The Stock Exchange of Hong Kong Limited (the “Stock Exchange”).

The Company is an investment holding company. The Company and its subsidiaries (collectively the “Group”) are principally engaged in developing and publishing domestic and overseas webgames and mobile games (the “Game Business”) and trading of electronic device and semiconductor (the “Electronic Device and Semiconductor Business”) in the People's Republic of China (the “PRC”). The Company also commenced its fund management business (the “Fund Management Business”) in Hong Kong through a licensed subsidiary from the end of December 2025.

The unaudited condensed consolidated financial statements are presented in Renminbi (the “RMB”), which is the Company's presentation currency and the functional currency of the principal operating subsidiaries of the Company.

2. BASIS OF PREPARATION

These unaudited condensed consolidated financial statements have been prepared in accordance with International Accounting Standard 34 “Interim Financial Reporting” issued by the International Accounting Standards Board and the applicable disclosures required by the Rules Governing the Listing of Securities on the Stock Exchange.

These unaudited condensed consolidated financial statements should be read in conjunction with the 2025 annual financial statements. The accounting policies and methods of computation used in the preparation of these unaudited condensed consolidated financial statements are consistent with those used in the annual financial statements for the year ended 31 December 2025.

I. 一般資料

本公司為投資控股公司。本公司及其附屬公司(統稱「本集團」)主要於中華人民共和國(「中國」)從事國內外網頁遊戲及移動遊戲的研發及發行(「遊戲業務」)以及電子設備及半導體貿易(「電子設備及半導體業務」)。本公司亦由二零二五年十二月底開始透過一間持牌附屬公司在香港開展基金管理業務(「基金管理業務」)。

未經審核簡明合併財務報表以人民幣(「人民幣」)呈列，人民幣為本公司的呈列貨幣及本公司主要營運附屬公司的功能貨幣。

3. ADOPTION OF NEW AND REVISED IFRS ACCOUNTING STANDARDS

In the current period, the Group has adopted all the new and revised IFRS Accounting Standards issued by the International Accounting Standards Board that are relevant to its operations and effective for its accounting year beginning on 1 January 2026. IFRS Accounting Standards comprise International Financial Reporting Standards ("IFRS"); International Accounting Standards ("IAS"); and Interpretations. The adoption of these new and revised IFRS Accounting Standards did not result in significant changes to the Group's accounting policies, presentation of the Group's unaudited condensed consolidated financial statements and amounts reported for the current period and prior years.

The Group has not applied the new and revised IFRS Accounting Standards that have been issued but are not yet effective. The Group has already commenced an assessment of the impact of these new and revised IFRS Accounting Standards but is not yet in a position to state whether these new and revised IFRS Accounting Standards would have a material impact on its results of operations and financial position.

4. FAIR VALUE MEASUREMENTS

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The following disclosures of fair value measurements use a fair value hierarchy that categorises into three levels based on the the inputs to valuation techniques used to measure fair value:

Level 1 inputs: quoted prices (unadjusted) in active markets for identical assets or liabilities that the Group can access at the measurement date.

Level 2 inputs: inputs other than quoted prices included within level 1 that are observable for the asset or liability, either directly or indirectly.

Level 3 inputs: unobservable inputs for the asset or liability.

The Group's policy is to recognise transfers into and transfers out of any of the three levels as of the date of the event or change in circumstances that caused the transfer.

5. REVENUE AND SEGMENT INFORMATION

The Group's business activities, for which discrete financial statements are available, are regularly reviewed and evaluated by the Chief Operating Decision Maker (the "CODM"). The CODM, who is responsible for allocating resources and assessing performance of the operating segments, has been identified as the executive directors of the Company that make strategic decisions.

During the period, the CODM reassessed the performance and operation of the Group and concluded that the Group had three operating segments as follows:

- Game Business;
- Electronic Device and Semiconductor Business; and
- Fund Management Business

The CODM assesses the performance of the operating segments mainly based on segment revenue, and adjusted earnings before interest expense, taxes, depreciation and amortisation (the "adjusted EBITDA"), of each operating segment.

Specifically, the revenues from external customers reported to the CODM are measured as segment revenue, which is the revenue derived from the customers in each segment. In addition, the adjusted EBITDA excludes the effects of significant items of income and expenditure, which may have an impact on the assessment of operating segments' results, primarily with respect to investment-related gains or losses and non-recurring event.

Other information, together with the segment information, provided to the CODM, is measured in a manner consistent with that applied in these unaudited condensed consolidated financial statements. There were no separate segment assets and segment liabilities information provided to the CODM, as the CODM does not use this information to allocate resources or to evaluate the performance of the operating segments.

5. 收入及分部資料

The Company was incorporated in the Cayman Islands as an exempted company with limited liability under the Companies Act (As Revised) of the Cayman Islands and accordingly, is exempted from the Cayman Islands income tax.

The income tax provision of the Group in respect of operations in Hong Kong was provided at 8.25% on assessable profits up to HKD2,000,000, and the applicable tax rate is 16.5% on any part of assessable profits over HKD2,000,000 based on the assessable profit for the six months ended 30 June 2026 and 2025.

The income tax provision of the Group in respect of operations in the PRC was calculated at the tax rate of 25% on the assessable profits for the six months ended 30 June 2026 and 2025, based on the existing legislation, interpretations and practices in respect thereof.

Shenzhen Xingyun Data Technology Co., Ltd. (深圳市行雲數據技術有限公司), a subsidiary of the Company, was qualified as a "High and New Technology Enterprise" under the PRC Enterprise Income Tax Law (the "EIT Law"). Thus the applicable tax rate was 15% for the six months ended 30 June 2026 and 2025.

Shenzhen Haihong Microelectronics Technology Co., Ltd. (深圳海紅微電子技術有限公司) was qualified as small and micro enterprises with an annual taxable income of RMB3.0 million or less, and is entitled to a 25% tax credit for their tax payable and at the tax rate of 20% (i.e. 5% tax rate).

According to the relevant EIT Laws jointly promulgated by the Ministry of Finance of the PRC, State Tax Bureau of the PRC and Ministry of Science of the PRC that became effective from 2018 onwards, enterprises engaging in research and development activities are entitled to claim 200% of their research and development expenses so incurred as tax deductible expenses when determining their assessable profits for that year.

According to the applicable PRC tax regulations, dividends distributed by a company established in the PRC to a foreign investor with respect to profits derived after 1 January 2008 are generally subject to a 10% PRC withholding tax ("WHT"). If a foreign investor incorporated in Hong Kong meets the conditions and requirements under the double taxation treaty arrangement entered into between the PRC and Hong Kong, the relevant WHT rate will be reduced from 10% to 5%.
