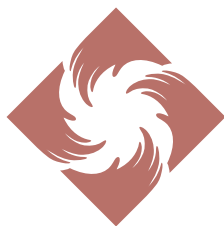

VOLUNTARY ANNOUNCEMENT
ON-MARKET SHARE BUY-BACKS

This announcement is made by YNBY International Limited (the “**Company**”) on a voluntary basis.

ON-MARKET SHARE BUY-BACKS

The board of directors (the “**Board**”) of the Company hereby announces that during the period from 16 September 2026 to the date of this announcement (both dates inclusive), the Company repurchased a total of 20,064,000 shares of the Company (the “**Shares**”) on open market transactions, to be held by the Company as treasury shares (the “**Share Buy-backs**”).

The details of the aforesaid Share Buy-backs are as follows:

The Board believes that the Share Buy-backs under the present market conditions will demonstrate the Company's confidence in its own business outlook and prospects and would, ultimately, benefit the Company and create value for the shareholders of the Company (the "**Shareholders**"). The Share Buy-backs were conducted under circumstances which the Board considers to be appropriate and in the interests of the Company and the Shareholders as a whole. The Company may further repurchase Shares as and when appropriate in compliance with all applicable laws and regulations.

The Share Buy-backs were made in accordance with the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "**Listing Rules**"), and there have been no material changes to the particulars contained in the explanatory statement as set out in the circular of the Company dated 24 April 2026.

Based on the public information available to the Company and as far as the Board is aware, following the Share Buy-backs, and as at the date of this announcement, the Company has continued to maintain sufficient public float of the issued Shares in compliance with the Listing Rules.

Shareholders and other investors are advised to exercise due caution when dealing in the securities of the Company.
