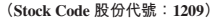

Reference is made to the announcement of China Resource Mix Lifestyle Services Limited (the "Company") dated 28 August 2026, with respect to (a) the payment of interim dividend of HK\$0.677 per share for the year ending 31 December 2026 ("2026 Interim Dividend"), (b) the payment of special interim dividend of HK\$0.452 per share ("Special Interim Dividend") and (c) the option given to the shareholders to elect to receive all or part of their dividends in Renminbi ("RMB") at the exchange rate of RMB1:0.831,1555.

茲據達華卓萬象生活有限公司(本公司)日期為二零二六年八月二十八日的公告，內容有關(a)派付截至二零二六年十二月三十一日止年度的中期股息每股港幣0.677元(「二零二六年度中期股息」)；(b)派付特別中期股息每股港幣0.452元(「特別中期股息」)；及(c)給予股東以人民幣(人民幣)收取全部或部分股息的選擇權，匯率為人民幣1.0元兌港幣1.1555元。
