PROFIT WARNING

This announcement is made by China High Precision Automation Group Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09(2)(a) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors (the “**Board**”) of the Company wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that, based on the preliminary assessment of the unaudited consolidated management accounts of the Group for the year ended 30 June 2026 and information currently available to the Board, the Group is expected to record a loss attributable to owners of the Company for the year ended 30 June 2026 in the range of approximately RMB13.0 million to RMB16.0 million, as compared to a profit attributable to the owners of the Company of approximately RMB17.4 million for the year ended 30 June 2025. Such expected loss attributable to the owners of the Company for the year ended 30 June 2026 was mainly attributable to the decrease in sales of high precision automation instrument and technology products to petroleum and petrochemical industries in light of project delay.

CAUTION STATEMENT

The Board wishes to remind investors that the Company is still in the course of preparing and finalising the annual results of the Group for the year ended 30 June 2026. The information contained in this announcement is only a preliminary assessment made by the Board based on the information currently available to it, including the unaudited consolidated management accounts of the Group for the year ended 30 June 2026 which

have not yet been reviewed or audited by the Company's auditors nor reviewed by the audit committee of the Company. The actual financial results of the Group for the year ended 30 June 2026 remain to be subject to adjustment and finalisation based on further updated information and may differ from the information disclosed herein. The annual results of the Group for the year ended 30 June 2026 is expected to be published in late September 2026.

Shareholders and potential investors of the Company are advised to exercise caution when dealing in the shares of the Company.
