Corporate Introduction

公司介紹

Mulsanne Group Holding Limited (the “**Company**”, “**Mulsanne**” or “**We**”, together with its subsidiaries, the “**Group**”) is a leading fashion menswear company based in China, which also covers unisex apparel segments. With our experience and execution capabilities in the fashion industry, we have optimized our brands to capture future market opportunities. Our founders first launched our flagship GXG branded products in 2007, and we catered to different menswear styles by introducing gxg jeans in 2010. In 2020, we launched MODE COMMUTER, a high-quality commuting apparel brand, which helped strengthen the brand portfolio of our Group. Each of our brands has a uniquely defined design identity and encompasses a range of products, offered in a variety of fits, fabrics, finishes, styles and price points intended to appeal a broad spectrum of customers.

We adopt an integrated omni-channel business model that capitalises on online and offline strengths, delivers a seamless and consistent customer experience, and increases efficiency in terms of inventory management, supply chain management, product selection and logistics. With our deep understanding of customers, we have adopted a customer-centred model to offer our customers a one-stop shopping experience. For both our online and offline channels, we provide a similar product range and unified pricing, shared inventories, as well as flexible and efficient logistics support. Moreover, by analysing the big data generated from both online channels and offline retail stores through our product lifecycle management system, we can capture the precise level of demand and quickly react to the latest market trends by adjusting our production and inventory plan, which is highly helpful for our inventory control and supply chain management. New retail has become a major trend of the apparel industry in China in recent years, and our Group is a leader in new retail integration among the major fashion apparel brands in China which have adopted the new retail business model with innovative initiatives.

我們採用一體化的全渠道商業模式，利用線上線下優勢，為顧客提供無縫和一致的購物體驗，並提升庫存管理、供應鏈管理、產品選擇及物流方面的效率。我們根據對顧客的深入了解，採取以顧客為中心的模式，為顧客提供一站式購物體驗。我們在線上和線下渠道提供類似的產品類別及統一價格、共享庫存，以及提供靈活高效的物流支援。此外，通過以產品生命週期管理系統分析來自線上渠道及線下零售店的大數據，我們可準確計算需求水平，並通過調整生產及庫存計劃，迅速回應市場最新趨勢，這對我們的庫存控制及供應鏈管理尤其重要。新零售已成為近年中國服裝行業的主要趨勢。包括我們在內的中國主要時尚服裝品牌已採用新零售商業模式，並融入創新的舉措，而在新零售整合方面，我們是眾多品牌中的領導者。

Management Discussion and Analysis

BUSINESS OVERVIEW AND OUTLOOK

In the first half of 2026, China's apparel industry continued to face development challenges amid increasingly diverse consumer demands and intensifying market competition, while structural opportunities continued to emerge. The national policy of "further expanding domestic demand and steadily boosting consumption" was steadily implemented, providing sustained momentum for the long-term development of the consumer market. During the six months ended 30 June 2026 (the "Period"), the Group actively responded to the evolving market environment and consumer trends by continuously optimizing its omni-channel strategy and multi-brand strategy. The Group also optimized the product mix and sales channel structures, and implemented various cost control measures to enhance operational efficiency, thereby mitigating the adverse impact of the external environment on its performance. The Group remains confident in the long-term prospects of China's fashion industry and consumer market. Looking ahead, the Group will continue to adopt a cautiously optimistic approach in capturing structural opportunities and will remain committed to implementing the following strategies:

- Deepening product design positioning, enhancing the precision of brand promotion and allocating brand marketing resources effectively to strengthen brand awareness and influence;
- Introducing new brands and expanding their sales share;
- Improving the product mix and increasing the omni-channel gross profit margin; and
- Actively utilizing modern AI tools to improve operational and management efficiency.

業務概覽及展望

2026年上半年，中國服裝行業在消費需求日益多元化演進與市場競爭更趨激烈的背景下，繼續面臨發展挑戰，但結構性機遇亦不斷湧現。國家「進一步擴大內需、穩步提振消費」的政策穩步實施，為消費市場長期發展注入持續動力。截至2026年6月30日止六個月內（「**本期間**」），本集團積極應對不斷變化的市場環境及消費趨勢，持續優化全渠道策略及多品牌策略。本集團亦優化產品組合及銷售渠道結構，並實施了多項成本控制措施，以提升運營效率，從而減輕外部環境對其業績的不利影響。本集團對中國時尚行業及消費市場的長期前景仍然充滿信心。展望未來，本集團將繼續以謹慎樂觀的態度把握結構性機遇，並將致力於實施以下策略：

- 深化產品設計定位，提升品牌推廣精準度，有效投放品牌宣傳資源，以提升品牌知名度及影響力；
- 引入新品牌並擴大其銷售份額；
- 改善商品結構，提高全渠道毛利率；及
- 積極運用現代AI工具，以提升營運及管理效率。

REVENUE

The Group derives its revenue primarily from the sales of its products through its self-owned stores, distributors, partners and online channels to end customers. The Group's revenue is stated as the net invoiced value of goods sold, after allowances for returns and trade discounts.

Total sales revenue for the Period was RMB948.7 million, representing a decrease of 2.1%, or RMB20.4 million, from RMB969.1 million for the same period in 2025. Such decrease was primarily because of the decline in revenue from online channels.

於本期間，總銷售收入為人民幣948.7百萬元，較2025年同期的人民幣969.1百萬元減少2.1%或人民幣20.4百萬元。有關減少乃主要由於線上渠道的收入減少。

Sales revenue from the Group's main brand, namely GXG, for the Period decreased by 1.4%, or RMB12.8 million, as compared to that for the same period in 2025, primarily due to (i) the strategic offline channels restructuring, including the closure of certain underperforming offline stores, with a view to enhance per-store sales, and (ii) the Group's optimization of its online channel sales strategy which in turn led to a further optimized channel profitability structure.

Sales revenue from gxg jeans for the Period decreased by 18.9%, or RMB9.2 million, as compared to that for the same period in 2025, primarily due to the Group's adjustments in brand positioning and business strategies.

Sales revenue from MODE COMMUTER for the Period increased by 22.5%, or RMB4.3 million, as compared to that for the same period in 2025, primarily due to per-store sales growth.

本期間，本集團的主品牌GXG的銷售收入較2025年同期減少1.4%或人民幣12.8百萬元，主要由於(i)線下渠道結構戰略性調整，包括關閉若干表現欠佳的線下店鋪，以提高單店銷售；及(ii)本集團優化線上渠道銷售策略，進而帶動渠道盈利結構進一步改善。

本期間，gxg jeans的銷售收入較2025年同期減少18.9%或人民幣9.2百萬元，主要由於本集團品牌定位及業務戰略調整。

本期間，MODE COMMUTER的銷售收入較2025年同期增加22.5%或人民幣4.3百萬元，主要由於單店銷售增長。

During the Period, the Group optimized its channel structure, (i) offline channels sales for the Period remained relatively stable at RMB608.2 million, as compared to RMB607.0 million for the same period in 2025, (ii) sales from self-owned stores for the Period increased by 6.9%, or RMB30.8 million, to RMB479.5 million, as compared to that for the same period in 2025, (iii) sales from partnership stores for the Period increased by 3.9%, or RMB1.2 million, to RMB32.0 million, as compared to that for the same period in 2025, and (iv) sales from distributor stores for the Period decreased by 24.2%, or RMB30.8 million, to RMB96.7 million, as compared to that for the same period in 2025.

Online channel sales for the Period decreased by 5.6%, or RMB20.1 million, to RMB337.9 million, as compared to that for the same period in 2025 primarily due to the Group's optimization of its online channel sales strategy through tighter promotional discounts and a stronger focus on sales quality and profitability, which in turn led to an improved gross profit margin and a further optimized channel profitability structure.

本期間內，本集團優化其渠道結構，(i)本期間的線下渠道銷售額保持相對穩定，為人民幣608.2百萬元，而2025年同期則為人民幣607.0百萬元；(ii)本期間的自營店銷售額較2025年同期增加6.9%或人民幣30.8百萬元至人民幣479.5百萬元；(iii)本期間的合夥店銷售額較2025年同期增加3.9%或人民幣1.2百萬元至人民幣32.0百萬元；及(iv)本期間的經銷店銷售額較2025年同期減少24.2%或人民幣30.8百萬元至人民幣96.7百萬元。

本期間的線上渠道銷售額較2025年同期下降5.6%或人民幣20.1百萬元至人民幣337.9百萬元，主要由於本集團優化線上渠道銷售策略，收緊促銷折扣力度，更加注重銷售質量與盈利能力，進而帶動毛利率提升，渠道盈利結構進一步改善。

Due to strategic offline channels restructuring, the Group closed its underperforming offline stores during the Period. As a result, the number of offline stores decreased from 926 as at 31 December 2025 to 854 as at 30 June 2026.

GROSS PROFIT AND GROSS PROFIT MARGIN

The Group recorded a gross profit of RMB537.0 million for the Period, representing an increase of 3.7%, or RMB19.3 million, from RMB517.7 million for the same period in 2025. Gross profit margin increased to 56.6% during the Period, as compared to 53.4% for the same period in 2025. Details of and the reasons for the changes in gross profit and gross profit margin are set out below.

The gross profit of GXG for the Period increased by RMB20.4 million, or approximately 4.2%, and the gross profit margin of GXG increased by 3.1 percentage points, as compared to that for the same period in 2025, primarily due to (i) lower discounted rates; (ii) optimization of the product mix and sales channel structures.

本期間GXG的毛利較2025年同期增加人民幣20.4百萬元或約4.2%，及GXG的毛利率較2025年同期增加3.1個百分點，主要由於(i)折扣率較低；及(ii)優化產品組合及銷售渠道結構。

The gross profit of gxg jeans for the Period decreased by RMB4.3 million, or approximately 21.7%, and the gross profit margin of gxg jeans decreased by 1.7 percentage points, as compared to that for the same period in 2025, primarily due to the Group's strategic brand adjustment to close underperforming stores as well as the increase in the proportion of selling old stocks which had higher discounted rates during the Period.

本期間gxg jeans的毛利較2025年同期減少人民幣4.3百萬元或約21.7%，及gxg jeans的毛利率較2025年同期減少1.7個百分點，主要由於本期間本集團進行戰略性品牌調整，關閉表現欠佳店舖，以及提高出售折扣率較高的舊庫存的比例。

The gross profit of MODE COMMUTER for the Period increased by RMB3.2 million, or approximately 28.6%, and the gross profit margin of MODE COMMUTER increased by 3.0 percentage points, as compared to that for the same period in 2025, primarily due to optimization of the product mix and sales channel structures.

Gross profit of self-owned stores for the Period increased by RMB35.6 million, or approximately 11.1%, as compared to that for the same period in 2025, primarily due to an increase in its revenue. Gross profit margin of self-owned stores increased by 2.9 percentage points to 74.3%, as compared to 71.4% for the same period in 2025, primarily due to (i) lower discounted rates; and (ii) optimization of the product mix and sales channel structures.

本期間自營店的毛利較2025年同期增加人民幣35.6百萬元或約11.1%，主要由於其收入增加。自營店的毛利率較2025年同期的71.4%增加2.9個百分點至74.3%，主要由於(i)折扣率較低；及(ii)優化產品組合及銷售渠道結構。

Gross profit of partnership stores for the Period increased by RMB1.3 million, or approximately 10.5%, as compared to that for the same period in 2025, primarily due to an increase in its revenue. Gross profit margin of partnership stores increased by 2.3 percentage points to 42.7%, as compared to 40.4% for the same period in 2025, primarily due to optimization of the product mix and sales channel structures.

本期間合夥店的毛利較2025年同期增加人民幣1.3百萬元或約10.5%，主要由於其收入增加。合夥店的毛利率較2025年同期的40.4%增加2.3個百分點至42.7%，主要由於優化產品組合及銷售渠道結構。

Management Discussion and Analysis

管理層討論與分析

Gross profit of distributor stores for the Period decreased by RMB13.4 million, or approximately 23.2%, as compared to that for the same period in 2025, primarily due to a decrease in its revenue. Gross profit margin of distributor stores remained relatively stable at 45.9%, as compared to 45.3% for the same period in 2025.

Gross profit of online channels for the Period decreased by RMB4.2 million, or approximately 3.3%, as compared to that for the same period in 2025, primarily due to a decrease in its revenue. Gross profit margin of online channels increased by 0.9 percentage points to 36.2%, as compared to 35.3% for the same period in 2025, primarily due to the Group's optimization of its online channel sales strategy through tighter promotional discounts and a stronger focus on sales quality and profitability, which in turn led to an improved gross profit margin and a further optimized channel profitability structure.

OTHER INCOME AND GAINS

Other income and gains for the Period were RMB7.7 million, representing a decrease of 43.0%, or RMB5.8 million, as compared to RMB13.5 million for the same period in 2025, mainly attributable to a decrease in investment income from pledged deposits and government grants.

SELLING AND DISTRIBUTION EXPENSES

Total selling and distribution expenses for the Period remained relatively stable at RMB416.7 million, as compared to RMB415.3 million for the same period in 2025.

Selling and distribution expenses as a percentage of the Group's total revenue increased to 43.9% for the Period as compared to 42.9% for the same period in 2025.

ADMINISTRATIVE EXPENSES

Total administrative expenses for the Period increased by 9.2%, or RMB7.7 million, to RMB91.0 million, as compared to RMB83.3 million for the same period in 2025. The increase was mainly due to the higher depreciation of the fit-out costs of the Group's headquarters office building, partially offset by a decrease in office rental expenses.

Total administrative expenses as a percentage of the Group's total revenue increased to 9.6% for the Period as compared to 8.6% for the same period in 2025.

本期間經銷店的毛利較2025年同期減少人民幣13.4百萬元或約23.2%，主要由於其收入減少。經銷店的毛利率保持相對穩定，為45.9%，而2025年同期則為45.3%。

本期間線上渠道的毛利較2025年同期減少人民幣4.2百萬元或約3.3%，主要由於其收入減少。線上渠道的毛利率較2025年同期的35.3%增加0.9個百分點至36.2%，主要由於本集團優化線上渠道銷售策略，收緊促銷折扣力度，更加注重銷售質量與盈利能力，進而帶動毛利率提升，渠道盈利結構進一步改善。

其他收入及收益

本期間其他收入及收益為人民幣7.7百萬元，較2025年同期的人民幣13.5百萬元減少43.0%或人民幣5.8百萬元，主要由於已抵押存款投資收入及政府補助減少所致。

銷售及經銷開支

本期間銷售及經銷開支總額保持相對穩定，為人民幣416.7百萬元，而2025年同期則為人民幣415.3百萬元。

本期間銷售及經銷開支佔本集團總收入百分比增加至43.9%，2025年同期則為42.9%。

行政開支

本期間行政開支總額較2025年同期的人民幣83.3百萬元增加9.2%或人民幣7.7百萬元至人民幣91.0百萬元。該增加主要由於本集團總部辦公樓裝修費用的折舊增加，惟部分被辦公室租金開支減少所抵銷。

本期間行政開支總額佔本集團總收入百分比增加至9.6%，2025年同期則為8.6%。

IMPAIRMENT LOSSES ON FINANCIAL ASSETS, NET

The Group recorded a reversal of impairment losses on financial assets, net of RMB0.4 million for the Period, as compared to impairment losses on financial assets, net of RMB0.8 million for the same period in 2025. This was mainly because the Group enhanced its account receivables collection and applied a more stringent credit control policy over its customers.

OTHER EXPENSES

The Group's other expenses for the Period increased by 65.4%, or RMB1.7 million, to RMB4.3 million, as compared to RMB2.6 million for the same period in 2025, mainly due to an increase in the number of closed stores during the Period, resulting in an increase in stores closure expenses.

FINANCE COSTS

Finance costs for the Period decreased by 60.2%, or RMB9.7 million, to RMB6.4 million, as compared to RMB16.1 million for the same period in 2025. The decrease was mainly due to the decrease in bank loans and effective expense control.

PROFIT BEFORE TAX

The Group's profit before tax for the Period was RMB26.7 million, representing an increase of RMB13.5 million, from RMB13.2 million for the same period in 2025. The increase was mainly due to an increase in gross profit.

INCOME TAX EXPENSE

Income tax expense for the Period was RMB4.9 million, representing an increase of RMB0.6 million, as compared to RMB4.3 million for the same period in 2025.

PROFIT FOR THE PERIOD

As a result of the foregoing factors, profit for the Period was RMB21.8 million, representing an increase of RMB12.9 million, as compared to RMB8.9 million for the same period in 2025.

金融資產之減值虧損淨額

本集團本期間錄得金融資產之減值虧損撥回淨額人民幣0.4百萬元，而2025年同期則錄得金融資產之減值虧損淨額人民幣0.8百萬元。此乃主要由於本集團加強應收賬款的催收工作，並對客戶採用更嚴格的信貸控制政策。

其他開支

本集團本期間其他開支較2025年同期的人民幣2.6百萬元增加65.4%或人民幣1.7百萬元至人民幣4.3百萬元。此乃主要由於本期間內關閉的店舖數目增加，導致店舖關閉開支增加。

財務成本

本期間財務成本較2025年同期的人民幣16.1百萬元減少60.2%或人民幣9.7百萬元至人民幣6.4百萬元。該減少主要由於銀行貸款減少及有效的開支控制。

稅前溢利

本集團本期間稅前溢利為人民幣26.7百萬元，較2025年同期的人民幣13.2百萬元增加人民幣13.5百萬元。該增加主要由於毛利增加。

所得稅開支

本期間所得稅開支為人民幣4.9百萬元，較2025年同期的人民幣4.3百萬元增加人民幣0.6百萬元。

期間溢利

由於上述因素，本期間溢利為人民幣21.8百萬元，較2025年同期的人民幣8.9百萬元增加人民幣12.9百萬元。

Management Discussion and Analysis

管理層討論與分析

OPERATING CASH FLOWS

Net operating cash inflow for the Period was RMB85.7 million, primarily due to the cash inflow from operating profit of RMB140.2 million and a decrease in working capital of RMB54.5 million. The Group's net operating cash inflow has shown an increase, as compared to net operating cash outflow of RMB61.6 million for the same period in 2025. Such increase was mainly driven by the Company's efforts to strengthen the collection of trade receivables and enhance overall working capital management, while optimizing procurement settlement arrangements and making appropriate use of settlement instruments, which led to a more balanced cash outflow schedule.

CAPITAL EXPENDITURES

The Group's capital expenditures include payments for property, plant and equipment and intangible assets. During the Period, the Group's capital expenditures amounted to RMB30.7 million, representing a decrease of 43.7%, or RMB23.8 million, from RMB54.5 million for the same period in 2025. The decrease was primarily attributable to non-recurrence in the current period of the fit-out expenditures for the Group's headquarters office building incurred in 2025, and the optimization of store renovation costs.

FINANCIAL POSITION

The Group generally funds its operations with bank and other borrowings. As at 30 June 2026, the Group had bank and other borrowings of RMB411.5 million (31 December 2025: RMB411.3 million). Bank and other borrowings were mainly denominated in RMB as at 30 June 2026. As at 30 June 2026, the Group had fixed-rate bank borrowings of RMB411.5 million (31 December 2025: RMB411.3 million). For details, please see note 19 of the "Notes to Interim Condensed Consolidated Financial Information".

The Group's cash and cash equivalents and pledged deposits totalled RMB240.2 million as at 30 June 2026, representing an increase of 17.9%, or RMB36.4 million, from RMB203.8 million as at the end of 2025. Cash and cash equivalents as at 30 June 2026 were RMB110.5 million, among which 99.1% was denominated in RMB, 0.8% in U.S. dollars, and 0.1% in Hong Kong dollars and Macau Pataca in aggregate. Pledged deposits as at 30 June 2026 were RMB129.7 million, all of which were denominated in RMB.

經營現金流量

本期間經營現金流入淨額為人民幣85.7百萬元，主要由於經營溢利產生的現金流入人民幣140.2百萬元及營運資金減少人民幣54.5百萬元所致。本集團本期間經營現金流入淨額有所增加，而2025年同期則為經營現金流出淨額人民幣61.6百萬元。該增加主要由於本公司加強貿易應收款項回收及營運資金統籌，同時優化採購結算方式，合理運用結算工具，付款節奏更加均衡。

資本開支

本集團的資本開支包括就物業、廠房及設備以及無形資產所支付的款項。於本期間，本集團的資本開支為人民幣30.7百萬元，較2025年同期的人民幣54.5百萬元減少43.7%或人民幣23.8百萬元。該減少主要由於本集團總部辦公樓於2025年產生的裝修支出於本期間不再發生，以及優化店舖裝修成本。

財務狀況

本集團一般以銀行及其他借款為其業務提供資金。於2026年6月30日，本集團的銀行及其他借款為人民幣411.5百萬元（2025年12月31日：人民幣411.3百萬元）。於2026年6月30日，銀行及其他借款主要以人民幣計值。於2026年6月30日，本集團有固定利率銀行借款人民幣411.5百萬元（2025年12月31日：人民幣411.3百萬元）。有關詳情，請參閱「中期簡明綜合財務資料附註」附註19。

本集團於2026年6月30日的現金及現金等價物及已抵押存款合計為人民幣240.2百萬元，較2025年末的人民幣203.8百萬元增加17.9%或人民幣36.4百萬元。於2026年6月30日，現金及現金等價物為人民幣110.5百萬元（其中99.1%以人民幣計值、0.8%以美元計值及合共0.1%以港元及澳門元計值）。於2026年6月30日，已抵押存款為人民幣129.7百萬元（均以人民幣計值）。

GEARING RATIO

The Group's gearing ratio is calculated by dividing the Group's total borrowings by the Group's total assets. As at 30 June 2026, the Group's gearing ratio was 21.8% (31 December 2025: 21.1%).

SIGNIFICANT INVESTMENTS HELD

For the Period, the Group did not hold any significant investments.

FUNDING AND TREASURY POLICY

The Group adopts a stable approach on its finance and treasury policy, aiming to maintain an optimal financial position, the most economic finance costs, and minimal financial risks. The Group regularly reviews its funding requirements to maintain adequate financial resources to support its current business operations as well as its future investments and expansion plans.

MATERIAL ACQUISITIONS AND FUTURE PLANS FOR MAJOR INVESTMENT

During the Period, the Group did not conduct any material investment, acquisition or disposal. While the Group has no specific plan for major investment or acquisition of major capital assets or other businesses, it will continue to identify new opportunities for business development.

EXPOSURE TO FLUCTUATIONS IN EXCHANGE RATES

The Group operates mainly in China with most of its transactions settled in RMB. However, the Group is exposed to foreign exchange risk arising mainly from debt denominated in U.S. dollars. During the Period, the Group did not use any financial instrument for hedging purpose.

資產負債率

本集團的資產負債率乃以本集團總借款除以本集團總資產計算。於2026年6月30日，本集團的資產負債率為21.8%（2025年12月31日：21.1%）。

所持重大投資

於本期間，本集團並無持有任何重大投資。

資金及庫務政策

本集團採用穩定的融資及庫務政策，旨在保持最佳財務狀況、最經濟的財務成本以及最低財務風險。本集團定期審閱其資金需求，以保持充足的財務資源，支持其當前業務運營以及其未來投資及擴展計劃。

重大收購事項及重大投資的未來計劃

於本期間，本集團並無進行任何重大投資、收購事項或出售事項。儘管本集團並無就重大投資或重大資本資產或其他業務的收購事項制定特定計劃，本集團將繼續物色業務發展的新機遇。

匯率波動風險

本集團主要於中國運營，其大部分交易以人民幣結算。然而，本集團面臨主要由美元計值的債務所產生的外匯風險。於本期間，本集團並無使用任何金融工具作對沖用途。

PLEDGE OF ASSETS

As at 30 June 2026, the Group's bank loans of RMB50.0 million were secured by the Group's pledged deposits of approximately RMB47.5 million.

As at 30 June 2026, the Group's bank loans of RMB15.0 million were secured by mortgages over the Group's buildings with a net carrying value of approximately RMB266.5 million.

As at 30 June 2026, the Group's discounted letter of credit of RMB20.0 million was secured by the Group's pledged deposits of approximately RMB20.0 million.

CONTINGENT LIABILITIES

As at 30 June 2026, the Group had no significant contingent liabilities (as at 31 December 2025: Nil).

EVENTS AFTER THE PERIOD

As at the date of this report, no material event has occurred after 30 June 2026.

HUMAN RESOURCES

As at 30 June 2026, the number of employees of the Group was 386, as compared to 404 as at 31 December 2025. In order to attract, retain and develop the knowledge, skills and quality of employees, the Group places a strong emphasis on training and development. The Group provides training periodically across operational functions, including introductory training for new employees, technical training, professional and management training, team-building and communications training. The Group also offers competitive remuneration packages, which include salaries, bonuses and other benefits. In general, the Group determines employee salaries based on each employee's qualifications, experience, position and seniority. The total cost of staff, including basic salary and wages, social insurance and bonus, for the Period was RMB52.4 million, as compared to RMB45.5 million for the same period in 2025. The increase of such total cost of staff was mainly due to the year-on-year growth in net profit for the Period, which led to a corresponding increase in the provision for employee performance bonuses. The total cost of staff for the Period increased to 5.5% of the Group's revenue, as compared to 4.7% for the same period in 2025.

RESTRICTED SHARE UNIT SCHEME

On 26 April 2019, the restricted share unit scheme of the Company (the “**RSU Scheme**”) was approved and adopted by the board of directors of the Company (the “**Board**”). The purpose of the RSU Scheme is to incentivise executives for their contribution to the Group, to motivate and retain skilled and experienced personnel to strive for the future development and expansion of the Group by providing them with the opportunity to own equity interests in the Company.

Persons eligible to receive the RSUs under the RSU Scheme are existing or past employees, Directors (whether executive or non-executive, but excluding independent non-executive Directors), consultants or officers of the Company or any of its subsidiaries. The basis of eligibility of any selected person for the grant of RSUs shall be determined by the Board from time to time on the basis of their contribution to the development and growth of the Group or such other factors as the Board may deem appropriate.

The RSU Scheme is valid and effective for a period of ten years, commencing from 27 May 2019 or until it is terminated pursuant to the RSU Scheme, whichever is earlier. The remaining life of the RSU Scheme is approximately two years and nine months.

The maximum number of RSUs that may be granted under the RSU Scheme in aggregate (excluding RSUs that have lapsed or been cancelled in accordance with the rules of the RSU Scheme) shall be such number of Shares held or to be held by the Trustee (as defined below) for the purpose of the RSU Scheme from time to time. The Company may (i) allot and issue Shares to the Trustee to be held by the Trustee and which will be used to satisfy the RSUs upon exercise and/or (ii) direct and procure the Trustee to receive existing Shares from any shareholder of the Company (the “**Shareholder(s)**”) or purchase existing Shares (either on-market or off-market) to satisfy the RSUs upon exercise.

The total number of Shares in respect of the RSUs that may be granted and to be granted to a grantee under the RSU Scheme in any 12-month period up to the date of the latest grant shall not exceed 1% of the Company's issued share capital from time to time, such grant must be separately approved by the Shareholders at a general meeting with the grantee and his/her associates abstaining from voting, the Company shall also issue a circular pursuant to the relevant provisions of Chapter 17 of the Listing Rules. For the avoidance of doubt, the RSU Scheme currently only composes of existing Shares.

The Board can determine the vesting criteria, conditions and the time schedule when the RSUs will vest and such criteria, conditions and time schedule shall be stated in the letter granting such RSUs. Within a reasonable time after the vesting criteria, conditions and time schedule have been reached, fulfilled, satisfied or waived, the Board shall send a vesting notice (the "**Vesting Notice**") to each of the relevant RSU participants. The Vesting Notice will confirm the extent to which the vesting criteria, conditions and time schedule have been reached, fulfilled, satisfied or waived, and the number of Shares (and, if applicable, the cash or non-cash income, dividends or distributions and/or the sale proceeds of non-cash and non-scrip distributions in respect of those Shares) involved. The exercise price in respect of the RSUs shall be such price as the Board may in its discretion determine. The Company has appointed The Core Trust Company Limited as the trustee (the "**Trustee**") to assist with the administration and vesting of RSUs granted pursuant to the RSU Scheme.

Further details of the principal terms of the RSU Scheme are set out in the section headed "Statutory and General Information – D. Share Incentive Scheme" in Appendix IV to the Prospectus. As at 1 January 2026 and 30 June 2026, an aggregate of 27,000,000 Shares were held by the Trustee and available for grant under the RSU Scheme respectively, representing approximately 2.84% of the Shares in issue as at the date of this report. As at 30 June 2026, RSUs in respect of an aggregate of 10,500,000 Shares, representing approximately 1.1% of the Shares in issue as at the date of this report, had been granted to 10 RSU participants pursuant to the RSU Scheme.

1. CORPORATE INFORMATION

The Company is a limited liability company incorporated in the Cayman Islands. The registered address of the Company is Cricket Square, Hutchins Drive, PO Box 2681, Grand Cayman KY1-1111, Cayman Islands. The principal place of business in China is located at No. 628 Jinyuan Road, Yinzhou District, Ningbo, Zhejiang Province, People's Republic of China (the "PRC").

The Company is an investment holding company. During the reporting period, the Company's subsidiaries were principally engaged in the design, marketing and sale of apparel products.

In the opinion of the directors, the Company does not have an immediate holding company or ultimate holding company. Great World Glory Pte. Ltd. and L Capital Asia 2 Pte. Ltd., which were both incorporated in Singapore, are the controlling shareholders of the Company, as defined in the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

2. BASIS OF PREPARATION

The interim condensed consolidated financial information for the six months ended 30 June 2026 has been prepared in accordance with International Accounting Standard ("IAS") 34 *Interim Financial Reporting*. The interim condensed consolidated financial information does not include all the information and disclosures required in the annual financial statements, and should be read in conjunction with the Group's annual consolidated financial statements for the year ended 31 December 2025.

The unaudited interim condensed consolidated financial information has been prepared under the historical cost convention, except for equity investment designated at fair value through other comprehensive income, which has been measured at fair value. The interim condensed consolidated financial information is presented in Renminbi ("RMB") and all values are rounded to the nearest thousand except when otherwise indicated.

1. 公司資料

本公司為於開曼群島註冊成立的有限公司。本公司的註冊辦事處位於 Cricket Square, Hutchins Drive, PO Box 2681, Grand Cayman KY1-1111, Cayman Islands。於中國的主要營業地點位於中華人民共和國（「中國」）浙江省寧波市鄞州區金源路628號。

本公司為投資控股公司。於報告期間，本公司的附屬公司主要從事於設計、營銷及銷售服裝產品。

董事認為，本公司並無直接控股公司或最終控股公司。Great World Glory Pte. Ltd.及L Capital Asia 2 Pte. Ltd.為香港聯合交易所有限公司證券上市規則定義之本公司控股股東，均為新加坡註冊成立的有限公司。

2. 編製基準

截至2026年6月30日止六個月之中期簡明綜合財務資料已根據國際會計準則（「國際會計準則」）第34號*中期財務報告*編製。中期簡明綜合財務資料並無包含年度財務報表要求的全部資料及披露，且應同本集團截至2025年12月31日止年度之年度綜合財務報表一併閱讀。

未經審核中期簡明綜合財務資料乃根據歷史成本法編製，惟指定按公平值計入其他全面收益的股權投資則按公平值計量。中期簡明綜合財務資料以人民幣（「人民幣」）呈列，除另有指明外，所有價值均約整至最接近的千位數。

The amendments also include additional disclosures for investments in equity instruments designated at fair value through other comprehensive income and financial instruments with contingent features. Since the Group's accounting policy for the derecognition of financial assets and liabilities in prior years aligned with the amendments and the Group did not have the financial assets that were addressed by the amendments, the amendments did not have any impact on the interim condensed consolidated financial information. The Group will provide additional disclosures for its equity investments designated at fair value through other comprehensive income in the Group's consolidated financial statements for the year ending 31 December 2026.

3. 會計政策變更及披露（續）

4. OPERATING SEGMENT INFORMATION

The Group is mainly engaged in the sale of apparel products. Additionally, the Group also sells other products to partnership stores and distributors, such as decorations for stores and packaging materials for products. The Group manages its main business of the sale of apparel products by sales channels. There are two operating segments for the sale of apparel products: offline channels and online channels. Offline channels refer to the offline network of retail outlets including self-owned stores and partnership stores, and the offline network of distributors, and online channels refer to online retail platforms, such as Tmall.com, Taobao, Vipshop, TikTok and WeChat Mini Programs.

The Group's chief operating decision maker is the chief executive officer, who reviews revenue and results of offline channels for the sale of apparel products, online channels for the sale of apparel products and the sale of other products separately for the purpose of making decisions about resource allocation and assessment of segment performance. Segment result is evaluated based on gross profit. No analysis of the Group's assets and liabilities by operating segment is disclosed as it is not regularly provided to the chief operating decision maker for review.

4. 經營分部資料

本集團主要從事服裝產品銷售。此外，本集團亦向合夥店及經銷店銷售其他產品，如店舖裝飾品及產品包裝材料。本集團透過銷售渠道以管理其服裝產品銷售之主要業務。服裝產品銷售共有兩個經營分部：線下渠道及線上渠道。線下渠道指零售店線下網絡，包括自營店和合夥店以及線下經銷店網絡，而線上渠道指線上零售平台，例如天貓、淘寶、唯品會、抖音及微信小程序。

本集團的主要運營決策人為首席執行官，彼分別審閱服裝產品銷售線下渠道、服裝產品銷售線上渠道及其他產品銷售的收入和業績，以作出有關資源分配及分部表現評估的決定。分部業績根據毛利進行評估。概無披露本集團按經營分部劃分的資產及負債分析，原因是並無定期向主要運營決策人提供有關分析以供審閱。
