- (2) to receive the printed English version of all future Corporate Communications only; or
- (3) to receive the printed Chinese version of all future Corporate Communications only; or
- (4) to receive both the printed English and Chinese versions of all future Corporate Communications.

You are entitled at any time by reasonable prior notice (of not less than 7 days) in writing to the Company (sent to the Share Registrar at the above address or by email at shenzhen604-ecom@vistra.com) to change your choice of the means of receipt (in printed form or by electronic means through the Company’s website) and/or the language (in English language only, in Chinese language only or in both English and Chinese languages) of the Corporate Communications. Even if you have chosen (or are deemed to have consented) to receive the Website Version of all Corporate Communications, but for any reason, you have difficulty in accessing the Corporate Communications, or wish to receive printed copies, the Company will promptly upon your request, in writing by post to the Share Registrar or by email at shenzhen604-ecom@vistra.com, send you the Corporate Communications in printed form free of charge.
